Auto-renewal of consent to establish (CTE) under the Water (Prevention & Control of Pollution)

Act, 1974 and the Air ((Prevention & Control of Pollution) Act, 1981.

The auto-renewal of Consent to Establish for the industries based on self-certification shall be applicable only in those cases where there is no increase in production capacity and/or load. The auto-renewal can be made for a maximum of half of the period for which the original Consent to Establish was granted. Self-certification shall be submitted by the authorized official of the industry duly authorized by owner/board of directors.

The industry shall, however, apply online for renewal of Consent to Establish with requisite fee in case of the following:

- (i) If there is increase in the production capacity and/or pollution load; and
- (ii) If there is increase in capital investment.

This will come into force with immediate effect.
