

Elections For Township Committee

Before taking a stand on the Springfield municipal elections, the Leader feels that a brief look at the campaign itself is in order. On the whole, and despite some lapses, this year's campaign has centered on issues and not on personali-ties. All six candidates for the Township Committee, and local Republican and Democratic officials, can share the credit for-what has essentially been a constructive campaign. This was perhaps the most urgent need this year, since the level of previous electioneering had made a-number of qualified citizens hesitate to enter the political arena.

'Let Us Continue'

The American people have 12 more days in which to decide who their President will be for the next four years.

We believe that Senator Goldwater was right when he said that if he were nominated the American public would have a clear choice.

There is a clear choice. It has been made clear by the philosophies of the two candidates, by their records in office, by their campaign statements - and certainly by the issue of hip-shooting extremism.

We cast our lot with Lyndon B. Johnson, who over the last year has proved his ability to rally his country about him in days of national crisis when his chief was assassinated, to stand the test of international crisis as he did with immediate and meaningful action in the Gulf of Tonkin, to place/forward-looking legisla-tion on the books, and to lead — not merely tolerate — the fight for equal rights whatever the cost in votes.

There is a compelling temptation to make this not so much an endorsement of Johnson as a rejection of Goldwater. So bé

In this rejection, we join the company of many good Republicans we respect, Re. publicans who are the real stalwarts in the preservation of the two-party system. Our own-courageous Sen. Clifford Case, who is rumored to be the next GOP candidate for governor, is a prime example. It will be men of Case's integrity and stawho will face the job of rebuilding the Republican party from the shambles we believe it may become after Nov. 3.

Goldwater's own statements discredit his candidacy more than do the utterances of his opponents. Attempting to quote from Goldwater is a sorry game in which one gets stuck-in the muck of words spoken differently each time. "Don't print what he says, print what he means," is a statement attributed to a Goldwater aide during the primary campaign. But the saddest thing is that the words are mouthed . . . or revised . . . or explained or re-interpreted by a candidate for

Whether he did or didn't say that field commanders should be able to decide about the firing of tactical nuclear weapons, his position on such a vital question is so fuzzy as to be frightening. On the other hand, President Johnson,

while not compromising America's position in the world, has shown that he will continue the realistic philosophy of "we shall never negotiate ou tof fear, but we shall never fear to negotiate."

Yes, Johnson is a shrewd, calculating politician. Yes, his short term in office has been soiled by the Bobby Baker and Walter Jenkins cases. But where disunity kas been the product of his desperate opponent's campaign, national unity has been the abiding ambition of the incumbent.

He is a man working hard at the job of becoming a great president — and with his ambition he may make it. In Hubert Humphrey, he has chosen a running mate who, like himself, is well qualified and schooled by long service in the Congress
