

The Council of the American Clan Gregor Society was called to order at 11:00 A. M., on Friday, October 20, 1950, by the Chieftain, Douglas Neil Magruder. The minutes of the last meeting were read and approved.

Miss Virginia Diedel took over from Miss Hill the presentation of the Report of the Rules Committee in the form of the proposed changes and additions to the Rules of the Society, which had been duly signed by sixteen members of the Clan.

After a lengthy discussion, item by item, a motion was made to present the proposed changes and additions to the Rules as amended, to the General Session of the Society.

Commodore John Holmes Magruder reported for the Committee on Membership Pin. The pins are ready and on sale for \$3.00. Mrs. Rosalind G. Magruder gave the report as Treasurer of the Committee for Future Planning.

In the absence of the secretary, Forrest S. Holmes was asked to act as secretary pro tem. Those present were: Commodore John Holmes Magruder, Jr., Douglas Neil Magruder, Mrs. Rosalind G. Magruder, Henry Magruder Taylor, William Marion Magruder, Mrs. Annesly Baugh, Miss Virginia Diedel, Miss Regina Magruder Hill, Mr. J. Franklin Adams, and Forrest S. Holmes.

The treasurer's report, which is appended hereto, shows a balance as of this date of \$388.62. Upon motion of Henry M. Taylor, duly seconded, the report was accepted as read.

The minutes of the 1949 meeting of the committee were read and approved.

A discussion of the possibility of securing a permanent home for the Society followed, the opinion of those present being that such a home could not be expected in the foreseeable future.

Attention was called to the narrow margin of profit expected from the luncheons and buffet supper, whereupon Miss Diedel suggested the possibility of having a registration fee for future Gatherings. No definite action followed this discussion.

Miss Hill stated that an additional steel file case would be needed soon for the historian's work. Douglas Neil Magruder offered to get such a file for the committee at a wholesale price, and the offer was accepted with thanks.

The 41st Annual Gathering of the American Clan Gregor Society, Incorporated was called to order on October the 20th at 2:10 P. M., by the Chieftain, Douglas Neil Magruder.

The meeting was opened with a prayer by the Chaplain, Rev. Enoch Magruder Thompson, followed by the Salute to The Flag in recitation by the group led by Mrs. Rex Hays Rhoades. This was followed by group singing of "Comin' Thru The Rye".

The Minutes for the year 1949-50 were read and approved.

The report of the Committee for Future Planning was given by the chairman, Commodore John Holmes Magruder, Jr. Headquarters, and what had been done on the work of the Archives were stressed in this report.

The Registrar, Mrs. O. O. van den Berg, reported 18 new members. The average does not come up to last year there being only three new members per month. Mrs. van den Berg appealed to all members for their cooperation in securing new members. Detailed report will be printed in the Year Book.

The Treasurer, Mr. Henry Magruder Taylor, made his report which will be printed in full in the Year Book.

The Historian, Miss Regina Magruder Hill, reported 6 Births, 12 Deaths, and 7 Marriages. Detailed report will be in the Year Book.

The Chaplain, Rev. Enoch Magruder Thompson, reported that none of the Clan had called on him for his services. He told of a few interesting personal experiences.

The Chancellor and Deputy Scribe had no report.

It was moved and seconded that the minutes of the Council meeting and of the Committee for Future Planning be dispensed with as items of importance in these reports will be taken up under new business. Motion carried.

The report of Mrs. Rosalind Geddes Magruder, Treasurer of the Committee for Future Planning, was read and accepted and will appear in the Year Book.

Under new business, came the revision of "Rules and Regulations" as recommended by the Council. Each change was taken up separately, discussed, and voted upon. This is a brief sketch of what happened, the changes will be published in their entirety later in the Year Book.

The first change was in regard to admitting Septs of the MacGregors other than those already mentioned in the Rules for membership. Acceptance moved by Rev. Enoch Magruder Thompson, seconded by Miss Regina M. Hill and carried. Second change was in regard to order of Officers on application blanks. Acceptance moved by William Marion Magruder, seconded by John Holmes Magruder and carried.

Third change was to go back to the original rules in regard to the name of the Chieftain. Acceptance moved by Miss Virginia Diedel, seconded by Rev. Enoch Magruder Thompson, and Carried.

Fourth change was to go back to the original rules in regard to the name of the Deputy Chieftain. Acceptance moved by Rev. Enoch Magruder Thompson, seconded by Mrs. Frederick Baugh, and Carried.

Fifth change was an addition to the Rules, that the term of office for the Chieftain and Deputy Chieftain be for two years. Acceptance moved by Rev. Enoch Magruder Thompson, seconded by Miss Regina M. Hill, and Carried.

Sixth change. A Nominating Committee to be appointed at each Annual Gathering so that they may have a whole year in which to work. Acceptance moved by Henry Magruder Taylor, seconded by William Marion Magruder, and Carried.

Seventh change was an additional, that an Editorial Committee be appointed. Acceptance moved by Mr. Edward Passano, seconded by Mrs. Frederick Baugh, and Carried.

The official pin was shown and announcement made that they were for sale at the price of \$3 each.

The suggestion was made by the Chieftain that Mrs. Thomas Garland Magruder be made Assistant Editor. The suggestion was presented in form of a motion, and adopted.

The meeting adjourned at 4:00 P. M.

EVENING MEETING

Many of the Clansmen gathered in the Lobby of the Hotel before the Buffet Supper and the Pipers appeared in their Kilts and mingled with the crowd, meeting old friends and making new ones, before entering the Burgundy Room. Each table was numbered with a hostess assigned. These gracious young ladies helped the guests and later served the plates from the buffet table. All guests were assigned to tables as reservations were made. This made a very pleasant arrangement.

After the guests were seated, the pipes sounded and there were Pipers Garrioch and Galloway followed by two waiters; one very sedately carrying the Haggis, the other, with an amused look (fearful that it might be upset, being held

high over his head) carrying the Traditional Scotch. They paraded down center and around the room after which the Haggis and Scotch were served the waiting Clansmen.

The evening session was called to order by the Chieftain, Douglas Neil Magruder, at 8:55, at which time the group joined in singing "Loch Lomond".

The names of the Absentee Patrons and greetings from Lauch Magruder, Herbert Thomas Magruder, and Guy Russell Henderson were read.

The Chieftain made his annual address which was most inspiring and will be published in full in the Year Book.

As usual when Commodore John Holmes Magruder introduced the Guest Speaker we were treated to a taste of his keen sense of humor. Byrnes, Bevin, Molotov and General Marshall speak at these conferences. Since 1948 he has been Information Officer at the British Embassy. He is married to a Welch girl and has three sons. Mr. Gaydon's address was timely and most interesting.

Mrs. Frances Griffin Villaret, an accomplished concert pianist, rendered several groups of selections for the piano. In one group she substituted for the vocalist who was unable to be present. It is indeed a treat to hear Mrs. Villaret perform.

Surprise next came forth in the person of Mr. John Alaster McGregor of Stafford, Virginia, who was brought to the Gathering by his son Charles. Although one of the early members, Mr. McGregor had not attended a meeting for some time. The group enjoyed hearing him reminisce. He is a real old timer and stirred the Clansmen with his rendition of a song he had written especially for the Clan, called "At The Close of Day". This he said was written for the members who were on the Shady Side of Life.

Mr. William Young, Secretary of The St. Andrews Society, was presented and asked to bring us greetings.

The Chieftain, going out of office this year, thanked all officers serving with him for their cooperation and help. The incoming Chieftain was called to the platform and presented with the Medallion given by the Society to each Chieftain. Commodore John Holmes Magruder accepted it with a few well chosen words. The new Ranking Deputy Chieftain, General Marshall Magruder, was called on for a short talk.

The meeting adjourned with all present joining hands and singing "Auld Lang Syne".

SATURDAY, OCTOBER 21, 1950

Saturday dawned bright and clear. The Pilgrimage was not far this year, just to Southeast Washington and near-by Maryland to the West. First we went to the Chapel of The Nativity where our Chaplain is the Rector. There a simple service was conducted by Rev. Enoch Magruder Thompson, after which he told us about the history of his little Chapel and the improvements they were making.

At the completion of the church service we were taken to the Parish Hall where two motion pictures were shown. The first one was "The Press Rehearsal of the Telephone Hour", featuring Don Vohees Orchestra with guest soloists Ezia Pinza and Blanch Thebault. The second picture was a Savings Bonds picture entitled "Power Behind the Nation" and told of the industries of our United States. This picture was in color and very beautiful. We were then invited to the basement where a delicious luncheon was served by the ladies of the Church.

Luncheon over, the group left for Great Falls on the Potomac River and the Chesapeake and Ohio Canal where they were met by members of the Montgomery County Maryland Historical Society at the Tavern and Lock Keepers House. Mrs. Frank Pelham Stone, our Clanswoman and founder of the Historical Society, greeted the Clan group. Mr. T. Sutton Jett, special assistant to the Superintendent of National Parks, conducted a tour of the Tavern and explained its construction. The Montgomery County Historical Society has been loaned a room in the Tavern to be used for their Museum.

Thus ended another delightful Gathering of our Clan.

ADDRESS OF THE CHIEFTAIN

DOUGLAS NEIL MAGRUDER

MY CLANSMEN AND DISTINGUISHED GUESTS:

It seems only a few weeks ago since last we met, yet I am reminded that a full year has passed and again I welcome you to the Annual Gathering of Clan Gregor.

The three years I have served as your Chieftain shall always be a source of sweet memories to me as other years roll by. The many kindnesses shown me; the pleasant associations; the fellowship, and the comradeship of my Clansmen will remain with me so long as I may live.

It is a long way from Mississippi to Washington. For many years I looked forward to attending one of these Gatherings. I was not prompted by idle curiosity, I assure you, but it was a sincere desire on my part to meet and to know my kins-

men from the other parts of the country. I was not disappointed, nor was I surprised when I found you to be the same kind of folks we Magruders are down in Mississippi, Louisiana, and other parts of the deep South.

And so, from the very beginning, I have felt at home among you. I wish that every member, and every eligible member, of this Society could have the opportunity of attending these Gatherings. I am sure they, too, would want to return again and again.

As you know, every society such as ours, in order to be successful, must have Clan Gregor Society set out four excellent reasons; purposes to which we are still an objective in view; a reason for its existence. The Founders of the American dedicated after more than forty years. Let me repeat them here:

- 1. To gather kindred together in Clanship.
- 2. To induce cordiality among its members.
- 3. To foster home ties.
- 4. To collect and record genealogical and historical records.

To these I would like to add a fifth reason; though not set out in our By-Laws, it is implied never-the-less. And that is, to preserve the ideals, the integrity and the traditions of MacGregor.

Unfortunately a great majority of our membership is unable to attend our Annual Gatherings and are thus deprived of the pleasures and benefits of our first two objectives. Why, then, do they cling to their membership? I believe it is because of this fifth objective which I have just given.

What are these ideals? What are these traditions that are a very part of us? I would not attempt to express them in words but I would like to relate a personal experience, which, to me, explains it far better than any vocabulary.

There is a newspaper editor in my home town who is an old time, straight-laced Methodist—and I mean no reflection on the Religion. But I always felt that this man considered my father to be a very evil person because he liked to play cards; he liked to dance; he even enjoyed his whiskey toddy when he came home evenings from the office; and he enjoyed taking us kids swimming on Sunday afternoons.

Some years after my father's death I was visiting my sister when I met this man on the street. He greeted me with the observation that I reminded him more of my father every day, and I replied that I only hoped to be half as good a man as I considered my father to be. And then he said this: "You know Neil, your father and I did not agree on many things, but there was one thing I always admired in him. You could always put your finger on him."

"You can always put your finger on him." How many men are there in your community; how many men are there in your acquaintance of whom it can be said without equivocation, "You can always put your finger on him"?

If we had more such men in our country today who said what they actually believed; and who acted according to that belief; if there were more such men guiding the destinies of other great Nations of this world, then truly the strife and turmoil we are now experiencing would soon disappear.

But God did not intend it that way. There is evil, and there is good; there is vanity, and there is meekness; there is greed, and there is humbleness; we have

our choice. Too often the path to glory is a short cut studded with lies and deception; double talk and chicanery. Those who travel this path would have us blinded by the brilliance of their own accomplishments, yet they know not the true meaning of Freedom because they are bound and shackled by the recollections of their own misdeeds.

True Freedom is found only in the hearts and minds and souls of people. True Liberty is enjoyed only by those who have no retrospects. We MacGregors prefer our Liberty. I like to believe, and I do believe, that every MacGregor wants it to be said of himself, "You can always put your finger on him".

So long as MacGregor strives for these objectives; so long as we live up to these ideals and traditions, then so long will this Society live. Should we fail, those who follow us will hear no more of MacGregor. The responsibility is ours, today. Let us never, never forget it.

CHANGES IN RULES OF THE AMERICAN CLAN GREGOR SOCIETY, INCORPORATED

Miss Virginia Diedel, Chancellor, presented the report of the Rules Committee to the Council setting forth the proposed changes in the Rules of the Society and moved that they be presented to the Clan in general session, for their adoption.

The changes were taken up one by one, discussed, and accepted by the Council with the recommendation that they be presented to the Clan at its business session for adoption.

CHANGES IN RULES

The Certificate of Incorporation takes care of the old Rules No. One and Two as printed in the Rules in the 1919 Year Book and in the Rules pamphlet. Therefore all Rules beginning with No. *Three* will be moved up two numbers, thus Rule THREE will become Rule ONE, Rule FOUR will become Rule TWO, etc. *Rule I*—Members (formerly Rule III)—

Add after the last word "Gregorson" the following: "and those who can prove their descent from any one of the Clan Septs and Dependents of Clan MacGregor and are entitled to wear the MacGregor Tartans as provided in the book 'The Scottish Clans and Their Tartans' published by the W. & A. K. Johnston, Ltd., Edinburgh and London, 1945." Final adoption of this change is held open until the Chieftain has a reply from our Hereditary Chieftain, Sir Malcolm MacGregor, whether or not he is willing for this to be added as a requirement of membership in the American Clan.

Rule II-Application for Membership (formerly Rule IV)-

In line 1, change the word "Scribe" to "Registrar".

Change the order of the acceptances of Applications to read: "1st, Registrar; 2nd, Historian; 3rd, Scribe; 4th, Chieftain".

Rule VIII-Chieftain (formerly Rule X)-

In line 3, insert after the word "age" the following: "and shall bear one of the surnames contained in Section 2 of Rule I." The Motion on this change read: "That we rescind the motion voted and passed in 1939, and insert after the word "age" the words "and shall bear one of the surnames contained in Section 2 of Rule I."

In line 3 following the words "Rule I" add: "He shall be elected to a two year term of office".

Add as last line following the word "Council", "He shall be ex-officio a member of all committees".

Rule IV-Ranking Deputy Chieftain (formerly Rule XI)-

In line 3 after the word "age" add the following: "He shall be elected to a two year term of office".

Add a new Rule to be known as-

Rule XXIX-Nominating Committee.

There shall be a nominating committee of a chairman anw two members. This committee shall be appointed by the Council at each Annual Gathering. It shall be the duty of this committee to nominate a candidate for each office where the incumbent's term of office will expire at the following Gathering. This committee shall receive all acceptances for nomination. A list of the candidates when completed shall be sent to the Council in advance of the Gathering.

Add a new Rule to be known as-

Rule XXX-Editorial Committee.

The Chieftain shall appoint an Editorial Committee which shall consist of the Editor, the Registrar, the Historian and one other person who shall reside in the same city or town, or near the place of residence of the Editor.

The Registrar and Historian shall check all data presented for publication for accuracy in lines and dates and general correctness. The Editor and the third member of the Committee shall be responsible for editing the data sent them from the Historian, for the purpose of compiling the material into book form and reading of all proof, and perform all work in connection with the publication of the Year Book as outlined in Rule XIII Editor, formerly Rule XV.

Funeral services were conducted by Rev. John F. Chalker, rector of the Vienna Episcopal Church and burial was at the Flint Hill Cemetery, Vienna, Virginia.

MRS. RICHMOND IRVING BOWIE

(Effie Gwynn)

1869-1950

The death of Mrs. Richmond Irving Bowie on June 22, 1950, marked not only the passing of another lifelong resident and respected citizen of the community, but the now too rapidly thinning of the ranks of those who have represented a way of cultured life which is disappearing from the contemporary scene.

Mrs. Bowie was born Effie Augusta Gwynn on February 20, 1869, the daughter of Andrew Jackson Gwynn, Captain, Confederate States Army, and Marie Louise (Keene) Gwynn, his wife. She received her formal education at Mount Saint Agnes Academy, Mount Washington, Maryland, where she distinguished herself in literature, music and art, graduating with high honors at an early age. On July 11th, 1894 she married Richmond Irving Bowie, son of William Benjamin Bowie and Ann Hall Clark, his wife.

Throughout her long life she was active in the religious, civic and social affairs of Prince George's County and her interests were many and varied. In the early days of woman suffrage she was elected one of the two first women to serve on the Democratic State Central Committee. During the First World War she was appointed District Leader, Melwood District, Woman's Division of the Maryland Council of Defense, and was later appointed by Governor Harrington a delegate to the Maryland State Convention for the League of Nations. She was a member of the Colonial Dames of America; and organizer and President of the Woman's Club of Melwood District, and was active in the State Federation of Women's Club; an organizer and first Regent of Court Bishop Carroll, Catholic Daughters

of America, and later, State Regent of the organization; first President of the Andrew Jackson Gwynn Chapter, United Daughters of the Confederacy and, later, President of the Maryland Division of this organization; and a member of her family society, the American Clan Gregor Society.

Born and always living in an environment which tended to instill in her a profound respect and an abiding love for the best traditions of her native Maryland, she was always interested in, and a student of, its history and the lives of those who helped make it great. This lifelong interest and study culminated in the recent publication of her 900-page book, "Across the Years in Prince George's County," a laborious task to which she devoted the greater part of twenty of the latter years of her already full and busy life—a labor of love undertaken with no thought of material gain, but only that the lore in which she was steeped might be preserved for posterity.

A great and gracious lady—beloved and respected citizen, author, artist and musician, devoted mother and faithful servant of God—has passed on to the ultimate reward of those who earn it.

She is survived by three sons, Andrew Gwynn Bowie, State's Attorney of Prince George's County; Benjamin H. C. Bowie and Dr. Andrew Keene Bowie; three daughters, Mrs. Frank M. Hall, Mrs. Frederick Melchoir and Mrs. Allen Weber; a step-son, Henry Addison Bowie; a brother, Monsignor Andrew K. Gwynn, P. A.; a sister, Mrs. C. C. F. Hammond and a large number of grand-children and great-grandchildren.

Those who survive her have received the priceless heritage of a forebear whose memory will ever be honored and respected in the community, County and State to which she contributed so much. With this heritage, however, goes the great responsibility of carrying on the traditions and cultured way of life she has bequeathed them.

JAMES TRUMAN WATSON

1896-1950

James Truman Watson was born near Thomson, McDuffie County, Georgia, January 6, 1896 and died at his home near Thomson, April 29, 1950. He was the son of the late William Augustin Watson and Catherine Drane Watson and a nephew of the late United States Senator, Thomas E. Watson, author and statesman of Georgia. He was the grandson of John Smith Watson and Eliza Watson. His paternal grandparents were: General Hamilton Stephen Drane and Susan Hambrick

Drane. His paternal great-grandmother was Cassandra Magruder Drane, daughter of Ninian Beall Magruder of Maryland. The Magruders and the Dranes were among the early pioneers from Maryland who established their homes in Columbia County, Georgia soon after the American Revolution.

Truman was educated in the public schools of Thomson, Georgia. After his graduation from high school he was called to the service of his country in World War I, and was assigned to Aberdeen Proving Grounds, Maryland, where he tested and proved rifles for the armed forces overseas. He received an honorable discharge from the army in 1919.

He was married in 1920 to Miss Mary Craven of Macon, Georgia, and to them one son, William Craven Watson, was born.

In 1921 James Truman Watson became associated with his father, William Augustin Watson of Thomson, in growing the famous Tom Watson melon and other farm products. They conducted a successful seed business and were widely known as producers of melon seed for commercial growers throughout the Southeast and other melon growing regions of the country. This firm, which became known as William A. Watson's Sons, was established by the father more than forty years ago. After his father's death in 1937, Truman Watson carried on the business successfully until his death in 1950; then it passed into the hands of his son, William Craven Watson.

Truman Watson was prominent in agricultural and civic affairs throughout Georgia and was active in the American Legion. At the time of his death he was a member of the Soil Conservation Committee for the State of Georgia, having been appointed to this position in 1949 by the Governor of Georgia. He also served his local conservation district as supervisor; was president of the McDuffie Chapter of the Farm Bureau Federation, and was a member of the McDuffie Board of Trade. He had served as Commander of the American Legion Post at Thomson and as adjutant. He was a member of the State Guard during World War II and served on the McDuffie County Selective Service Board. He was a member of the Methodist Church, the Forty and Eight, the Junior Order of American Mechanics and the Woodmen of the World.

Truman was possessed of a delightful personality. His mind was brilliant, his sense of humor keen. He was sincere, gracious, kind and generous. He was a person whose presence brought brightness and warmth to others. His family loved nothing better than to be with him in his home. Frequent trips to Thomson to spend the week-end with their brother meant great happiness for the two sisters in Columbia, S. C., and they always looked forward joyfully to these visits. Truman had scores of friends in all walks of life and when he passed away, many of them said again and again "I have lost the best friend I had."

He is survived by one son, William Craven Watson; a grandson, William Craig Watson, both of Thomson, Georgia; two sisters, Mrs. C. Clark Collins and Miss Eleanor Leigh Watson of Columbia, S. C.; a brother, Stephen Boyce Watson of Macon, Georgia, and an aunt, Mrs. W. B. Reynolds (Susie Drane) of Arlington, Virginia.

Miriam, youngest daughter of Hiram Walter Drane and his second wife Sarah Anne Hayward (Drane) was born at Love Station, De Soto County, Mississippi, on January 7, 1893.

In 1903 the family moved to Memphis where she finished high school with honor. She attended Randolph-Macon Woman's College and the University of Tennessee. After graduating from the University she taught science in the public schools and the University Dental College at Memphis.

Thinking she could be of more service to mankind, she entered the University of Tennessee College of Medicine, from which she was graduated with first honor in 1926. For several years she was associated with the Dr. I. Rudner Clinic. Later she maintained her own office in the Starrick Building until seven years ago when she moved to St. Petersburg, Florida, for her health. Here she practiced her profession until her death.

She was a member of the Methodist Church, the American Clan Gregor Society, the D. A. R., and the Medical Association as well as social organizations. Her latch string was always on the outside.

She never did things by halves but by her father's motto "If a thing is worth doing, it is worth doing well."

Before going to her office on November 28th, 1950, while looking after her flower beds, she suddenly became ill and at three-thirty that afternoon she had crossed the bar. She was interred in the Clearwater, Florida, cemetery where Mr. John L. Hopkins, to whom she was married in 1937, is buried.

She served her clan faithfully on the Reception Committee, the Committee for Decoration of the Hall and other committees for many years, and as a member of the Council from 1927 until the time of her death.

Mrs. Sheriff was a member of Magruder Chapter D. C. D. A. R. which she served as Treasurer, Corresponding Secretary, Vice-Regent and Regent. She was a very active member serving on many committees in her chapter and on the House Committee at the National Congress of the D. A. R. State Conference in March, the Regent of Magruder Chapter will read a memorial and light a candle in her honor as a past Regent of her Chapter. She will also place a white Carnation in the Memorial Wreath which later will be placed on the grave of Mrs. John M. Beavers.

On Saturday afternoon, September 16, 1950, the members of the Magruder

Chapter assembled at the home of their ex-Regent, to greet her and offer their congratulations to her on having rounded out ninety years of life well spent. Although she had been quite ill for some months, she stood to receive her guests and joined quite gaily in the chatter around her. The parlor and hall were decked with flowers sent by her good friends, and the mantle and tables were loaded with an array of "Cards" some of which came from her Chapter sisters as far away as California, Michigan, Texas, and Missouri.

A delicious birthday cake decorated with pink roses and the figures "90" outlined with pink candles, a personal gift of the Magruder Chapter Regent, Miss Irene M. Pistorio, was a thing of beauty, which together with the pink and white ice cream made a delectable refreshment, served to perfection by "Nannie's" three nieces, Mrs. Charlotte McCormick Pitts, Mrs. Mary Brightwell Stack and Mrs. Mary Brooks Duvall.

Those who were present besides the Regent were: Miss Jane Beall Magruder and her nieces Mrs. Elizabeth Magruder Bubb and Miss Elsie Woolf; Mrs. Elizabeth Magruder Ericson and her daughter, Mrs. Anna Ericson Wheeler; Miss Regina Magruder Hill, Mrs. Miriam McDonnell Holmes, Mrs. Susie May van den Berg and of course Mrs. Sheriff's sisters, the Misses Ida and Lucy McCormick, gracious and cordial as always. Those members of the Chapter who were not able to be present sent special messages of congratulations and the hope that Mrs. Sheriff's improved health would continue.

In 1890 Walter Ann McCormick married Philip Hill Sheriff of the well-known Hill and Magruder families of Prince George's County, Maryland. Two daughters predeceased her, Susan, Mrs. George Calvert Bowie; and Helen, Mrs. J. Rupert Mohler. Mr. Sheriff died in 1928. A brother, the late Rear Admiral Alexander Hugh McCormick, U. S. N., was Commandant of the Navy Yard in Washington, D. C., from 1898 to 1900.

Mrs. Sheriff is survived by two sisters, the Misses Ida and Lucy McCormick who made their home with "Nannie"; a grandson, Philip Somervell Bowie, and two grandchildren; three nieces, Mrs. Mary Brightwell Stack, Mrs. Charlotte Pitts, and Mrs. Mary Brooks Duvall; also two nephews, William McCormick Brooks and William Clarence McCormick.

Funeral Services were held at the Church of the Transfiguration, the Rev. Enoch Magruder Thompson, Chaplain of the American Clan Gregor Society, assisting the Rev. Frank Blackwelder, Rector of All Souls Memorial Church of Washington, D. C. Burial was in Rock Creek Cemetery.

MRS. ARTHUR BROWN



He was affiliated with the Washington Biologist's Field Club and the Cosmos Club. He has written numerous scientific publications.

Surviving are his widow, the former Emily Baker of Washington; a daughter, Mrs. Daniel Dillon of Kodiak, Alaska, wife of the naval port director there, and three grandchildren, Daniel Dillon IV, Peter Crawford Dillon, and John Bruce Dillon; and a sister, Miss Lillian Crawford of Washington.

Mr. Joseph F. Penkert, father of Joseph Lawrence Penkert who married Mary Sheriff who is a member of the Clan, died at his home in Seat Pleasant, Maryland, December 20, 1950. FRANK MAGRUDER

Grandson of Archibald Magruder, Kentucky Pioneer

Frank Magruder, son of Levi and Mary Straney Magruder, and grandson of Archibald Magruder, first settler of the Magruder Family in Kentucky, died June 30, 1950, at his residence at Bardstown Junction, Ky. He was born in Kentucky in 1864. Mr. Magruder is survived by his wife, Susan M. Stone Magruder, whom he married in 1888, and two sons, Curtis, of Bardstown Junction, and Onio M. of Memphis, Tennessee; three daughters, Miss Maud and Miss Grace Magruder, and Mrs. Frank Fields of Bardstown Junction. Heber and Willie had died sometime previous to their father. Two grandchildren, Joan and Charlotte Magruder, reside at Mt. Washington, Kentucky.

Mr. Magruder was the only grandson present when the Sons of the American Revolution marked the grave of Archibald Magruder as an official Soldier of the American Revolution, on July 4th, Independence Day, 1946. (There is an article on the marking of the graves in the 1947 Year Book on page 82.)

Until a few weeks previous to his death, Mr. Magruder remained active on his farm, although he had reached his 86th birthday. This farm is part of that chosen by his grandfather, Archibald Magruder, when he settled in Kentucky, in

1890, to enjoy the Free Life of the Wilds. Strange to say, this spot chosen by Archibald is now part of the Great Bernheim Wild Life Reservation.

Funeral services were held from the Hardy Funeral Home, Shepperdsville, and he was laid to rest at Mt. Washinton Cemetery, Kentucky.

EMMA LUCINDA SLAUGHTER WEAVER 1864-1950

Emma Lucinda Slaughter was the daughter of Dr. Thomas Bailey Slaughter and Kate Dorsey. She was born October 15, 1864 at the home of her grandfather, Bradley Slaughter, in Putnam County, Georgia. She was married on February 24, 1881, to Nicholas Meriwether Weaver of Cuthbert, Georgia, where they lived a long and useful life. Mr. Weaver died March 16, 1932.

She was an active member of the Cuthbert Methodist Church, for many years a teacher in the Sunday School. She was one of the organizing members of the first Woman's Missionary Society in her church and was an active member until her death.

BRIG. GEN. JAMES R. ALFONTE

Brig. Gen. James Raymond Alfonte, Retired from the Army Quartermaster Corps, died on February 8, 1951, at Walter Reed Hospital, Washington, D.C. Gen. Alfonte was the husband of our new member Mary Gates Redmond Alfonte.

Gen. Alfonte was responsible for the construction of the first cantonment at Fort Benning, Georgia, in 1939, and for the first jump tower built there in 1941. He served here as chief of the clothing and equipage branch, office of the Quartermaster General in 1942.

A native of Alfont, Indiana, he attended Purdue University in that State, and was commissioned a second lieutenant of infantry on October 7, 1911. After promotion through the several grades, he became a permanent major in 1920, when he transferred to the Quartermasters Corps. He became a brigadier general in 1942.

After various assignments as a young officer, Gen. Alfonte entered the Aviation School at San Diego, Calif., in September, 1916. He held military pilot's license No. 78.

Gen. Alfonte saw service both here and abroad. He retired on August 31, 1946, following service as commanding general of the Utah Army Service Forces Depot, at Ogden.

Surviving are his widow and a daughter, Mrs. H. L. Graham, Jr., both of Washington, D. C.; a son, Capt. James M. Alfonte, of West Point, New York,



LIEUTENANT MUNRO MAGRUDER

- Lt. Munro Magruder, son of Brig. General and Mrs. John Magruder of Virginia, was killed in action in Korea, September 3, 1950. Lt. Magruder is the first casualty reported among our Clan members during this War in Korea.
- Lt. Magruder was born in Peking, China. His parents met in China when his father was military attache at Peking and his mother's father was Minister to China. He was a graduate of St. Albans School, Washington, D. C., class of 1944 and then joined the Navy where he served as a seaman first class for a year. He then entered West Point and was graduated in 1949.
- At. St. Albans, Lt. Magruder was an outstanding athlete and student. In his senior year he was captain of the varsity baseball team and played on the varsity basketball and football teams. At his commencement he was awarded the Thomas Hyde Medal as the best all-around boy in his class. He also was an officer in the student government association.

In addition to his parents Lt. Magruder leaves his wife, Mrs. Nina Garner Magruder of Reno, Nevada, whom he married there in July, 1950; a sister, Mrs. Robert E. O'Brien, Jr., of Washington-Lee Apartments, Arlington; and a brother, Malcolm Magruder of 1051 Thomas Jefferson St., N. W., Washington, D. C.

JOHN LEVI MAGRUDER

John Levi Magruder was born on a farm near Lenore, Kentucky, August 2, 1868 and died in Moscow, Idaho May 8, 1949. Burial is beside his wife, Minnie Powell Magruder in Crown Hill Cemetery, Denver, Colorado.

He received his elementary education in the rural school near his home and his high school diploma at Pitts Point, Kentucky. He was graduated from the National Normal University at Lebanon, Ohio, in 1893.

He taught school several years. During his mothers' and brother Albert's last illnesses he farmed the home place. He served as agent for the L. and N. Railroad at Sulpher, Kentucky for a few years.

In 1908 he organized the New Washington State Bank at New Washington, Indiana. He served as cashier of this bank for nine years. Upon the advice of a Louisville physician he sold his interests in the bank and moved to Palisade, Colorado. He bought controlling interest in the First National Bank there, where he served as vice-president. He found the change of climate did not restore his health as he had hoped, so in 1919 he sold his interest in the bank and moved to Denver, Colorado. Here he lived on a small acreage and worked in real estate. In 1941 he retired and moved to Idaho.

John Levi Magruder is survived by a daughter, Lucille Magruder, a member of the American Clan Gregor Society, Associate Professor of Home Economics, University of Idaho at Moscow.

MRS. EDWARD BOTELER PASSANO

Mrs. Edward Boteler Passano nee Eleanor Phillips Isaac, was born December 25, 1871, and died December 7, 1949.

She was the daughter of William Moore Isaac and Eleanor Penny Phillips. On October 25, 1900 she and Mr. Passano were married. There are two sons, William Moore Passano, and Edward Magruder Passano who is a member of the American Clan Gregor Society. Also, three grandchildren: William Moore Passano, Jr., Susan Kemp Passano, and Edward Magruder Passano, Jr.

For years Mrs. Passano was very active in the Colonial Dames of Maryland, and was State Historian, at one time, for the Maryland Society Daughters of the American Revolution.

In later years she worked extensively in research of Maryland families, historic houses, Public Buildings and Monuments. In 1940, an "Index of the Source Records of Maryland" written by Mrs. Passano, was published, and has been most favorably received, especially by Libraries all over the United States.

Over 100,000 cards she had compiled, in preparation of a second book, are on file at the Maryland Historical Society, and provide readily available reference for thousands of historic Maryland Buildings. These cards and a metal card filing

case have been given to the Maryland Historical Society by her sons, William Moore and Edward Magruder Passano.

AN UNFORGETTABLE SUMMER

We began to make plans in September, seven whole months before sailing time, seven months of travel folders, budget calculations and wardrobe worries. April fifteenth finally arrived and we set sail on the Alcoa Pioneer, a freighter bound for Naples, carrying five passengers including ourselves and—we were to discover—one of the first shipments of military aid to Italy. The latter made our landing unusual to say the least as the Communists plotted to blow up the ship. Fortunately this scheme was thwarted!

Naples was war torn and beggar ridden but there was color everywhere: lemons ripe on the trees, wisteria and red poppies in profusion and the blue-green Mediterranean—a contrast which almost seemed to be Italy in the spring of 1950. Nothing disappointed us in Rome except the Tiber which, as Francie said, was a "flop". We were Protestants in Rome in a Holy Year and experienced what were probably typical feelings: wonderment at the resplendent and flamboyant wealth of the Roman Catholic Church, a certain amount of disappointment in the commercialism and amazement at an emotional religious attitude quite foreign to our experience. Bev had majored in Art History at college so Florence was a glorious continuation of "the grandeur that was Rome". While she wandered in a daze through the Pitti Palace, Francie, the physicist, made a personal pilgrimage to see Galileo's telescope. We gondolaed through the exotic and mystic beauty of Venice, spent a few days in the Lake region and our month in Italy was at an end.

The highlight in Switzerland was the trip from Interlaken up to the Jungfraujoch, a height of over eleven thousand feet. The railway itself is an astounding feat of engineering and the views are breath-taking.

Francie's uncle and aunt, General and Mrs. Carter B. Magruder, were very anxious for us to have a boat trip through the Rhine Gorge as they had found it fascinating when they were stationed in Germany. We spent a weekend in Heidelberg and early one morning drove to Mannheim where we boarded a small motor launch. The gorge with its ruined castles was at the same time spectacular and picturesque but equally as interesting was the life of the river itself: countless coal barges with the laundry swinging gaily above the coal, bombed bridgeheads and scenes of utter devastation.

We crossed from Ostend to Dover the day before the King's official birthday so we were in London for the ceremony of Trooping the Colour and marveled at the pageantry and stared at the Royal Family. The weather was perfect, we could understand what people said and we rejoiced at the prospect of using the same money for five whole weeks.

We were fortunate in having many friends in London and in addition to the social and sightseeing pleasure they gave us, we gained some small insight into

the dull intricacy and monotony of their lives. Gas had only come off ration a few weeks before our arrival. Eleven years on that commodity alone! poignant and rather awful about a gap in a group of row-houses, but when one

The extent of the bombed out areas in the old part of greater London is fantastic and difficult to comprehend even when one sees it. There is something sees blocks and blocks of what look like overgrown fields surrounded by neat stone walls, it is incredible that there not long ago stood solid masses of buildings.

As we headed north to Scotland, one weekend was spent with friends of Bev's in Suffolk, where the children of the house asked us to "speak American"! We attended services in York Minister, seated in old choir stalls whose extreme discomfort made us envy the spiritual fortitude of the monks of old. Durham Cathedral enchanted us and we went to the regatta there. Some of the participants invited us to tea and had quite a few acid comments to make about that American institution, the "nahsty" tea bag.

Scotland! Our first week was spent in Edinburgh, far too short a time for that enchanting city. It took us three days to traverse the Royal Mile from the Castle to Holyrood. We bought tartan cloth by the yard and Francie even purchased an umbrella in the MacGregor tartan! We went to Peebles for the weekend and for the first time saw and danced "The Gay Gordons" and "The Dashing White Sergeant".

On our arrival in Perth our train was met by Mrs. Ernest Pendleton Magruder, a friend and cousin by marriage of Mrs. van den Berg, who had kindly written her of our coming. Mrs. Magruder, picnic baskets in hand, had plans for a most fascinating day. A friend of hers joined us for lunch and then all four of us drove to Blair Castle via Pitlochry and through the Pass of Killiecrankie. It was thrilling to go through one of the "stately homes" with two ladies who had known the place when it was not open to the public and had so many personal recollections of the people whose portraits hung on the walls. We were particularly intrigued with the collection of arms and the dozens of antlers which contrasted with exquisite china and delicate embroidery. It was raining, quite a heavy "Scottish mist", so we had our picnic tea in the car, our spirits not dampened in the least as Mrs. Magruder is perfectly delightful with a sparkling sense of humor and a keen wit. That evening she telephoned her brother, Sir Malcolm Mac-Gregor of MacGregor, Bt., C.B., C.M.G., Re. R.N., with the result that we were invited to tea with him the following afternoon.

Sir Malcolm sent a car to our hotel in Lochearnhead at three and we drove to "Edinchip". Unfortunately Lady MacGregor was in Glasgow so we did not have the pleasure of meeting her. But Sir Malcolm himself was a most charming host and to our delight greeted us at the door wearing his Rob Roy kilt. "Edinchip" is a relatively new stone house on a hill overlooking Loch Earn. To one side is a formal garden in which lupens were blooming magnificently. Beyond was an extensive informal garden of azalea and rhododendron in luxuriant profusion which we viewed by proceeding along a narrow, winding path single file, Rob Roy leading his forces among the crags with two west highland terriers as outriders!

The house itself was filled with family treasures, the most interesting of

which Sir Malcolm graciously showed us as he knew of our interest in the Mac-Gregor clan. One item in particular was a dirk given by Bonnie Prince Charlie to his aide, a MacGregor ancestor. We had a delicious and abundant tea in the dining room and were genuinely sorry when the time came for our leave taking.

After visiting Glasgow, the Scottish Lochs and the English lakes we went to the International Eisteddfod in Llangollen, Wales. We were there for the folkmusic and dancing, for which the participants wore their native costumes and were a riot of color and rythym. Our final expedition in the British Isles was to Stratford, to see one of Shakespeare's plays done in the proper setting.

We crossed the channel for Bastille Day in Paris and, except for brief, weekand excursions to Mont St. Michel and to Tours and the Chateaux of the Loire,
all our time in France was spent in that magic city. We wandered first in one
part of Paris, then in another, enchanted with every street corner, with the
magnificence of the architectural remains of so many periods of French glory,
with the flowers and the kaleidoscopic crowds. It was July, the height of the
tourist season and though we had small sympathy for those Americans who lived
in the Ritz Bar, the crowds added a flavor of their own.

August first came all too soon. Bev sailed for home and Francie returned to Scotland for the Highland Games at Strathallen and a flying visit to Mallaig and Skye. The Queen Elizabeth provided for both a luxurious ending to an unforgettable summer.

It is therefore believed to be a good idea to have a Question Department in the Year Book where genealogical questions which come up at Headquarters may be asked, and we hope answers obtained to them.

It may also be that some member or prospective member will want information on his Magruder line. Headquarters will be glad to do this research for which a small fee of \$5 will be charged. This money will go into the Planning Fund to be used for research work.

In sending in questions please state the information desired very clearly giving all the data you may have, with full names and the maiden name of wives, as in many cases the secret lies in the maiden name of the wife. Questions on any Magruder-MacGregor or allied line, may be sent to the Historian at the Head-quarters address, The Highlands, Apartment 803, Washington 9, D. C.

The following information is desired at Headquarters where anyone knowing anything on these lines may send their information:

MAGRUDER-SELBY: Wanted: the children of William Selby who is said to have married Sarah Magruder, daughter of Samuel Magruder (1660-1711) and

his wife Sarah Beall, both of Maryland. Sarah Beall made a will in 1734 naming among others William, son of William Selby, but gives no relationship. From this it has evidently been thought that her daughter Sarah married William Selby, and it is so given in the list of the children of Samuel and Sarah in the Year Book of the Clan for 1929, page 89. We have the will of a William Selby, made in Maryland, 1732, in which he names his wife Elizabeth and a son William Magruder Selby. His home was "Leith" and his overseer was John Magruder. Five of the children mentioned in his will have Magruder family names; William Magruder, Sarah, Susannah, John and Samuel. Did William Selby, who made the will in 1732, marry twice and was his first wife Sarah Magruder, thereby accounting for his children's names, especially William Magruder Selby? Who were the parents of his wife Elizabeth?

MAGRUDER-STANFORD-SUBLETT: Wanted: the parents of Zepheniah Magruder of Maryland who had a son Wade S. Magruder who married Polly Stanford, daughter of David Stanford of Virginia. Wade S. Magruder had a son James born in Virginia in 1816, and who went to Indiana and then to Johnson County, Iowa. We have the line from then on.

James Magruder of Maryland, born 1699, and his wife Barbara Coombs, had a son Zepheniah who is said to have died young. Did he marry and have this son Wade S.? He still could have died young, if this were his only child. There is a marriage of a Zepheniah Magruder and Frances Sublet on November 3, 1792, registered in Chesterfield County, Virginia. Who was this Zepheniah Magruder, and who were the parents of Frances Sublet?

MAGRUDER-DUKE-JONES: Dr. Alexander Brown Duke of Albemarle County, Va., who died in Savannah, Georgia, married Elizabeth Kennon Garrett and their daughter Sue Duke married before 1875, Maj. Horace Walker Jones of Charlottesville, Virginia. He was the son of Dr. Basil Jones who married Lucy Magruder. Who were the parents of Lucy Magruder?

MAGRUDER-BUTLER: Wanted any information available on Sarah Magruder, daughter of Alexander Magruder II, son of Alexander Magruder, Immigrant, who is said to have married a Mr. Butler.

MAGRUDER-RANTER: Wanted any information available on Mary Magruder, daughter of Alexander Magruder II and his wife Susannah Busey, he son of Alexander the immigrant; said Mary said to have married Nathaniel Ranter after 1750.

MAGRUDER-McPHERSON: Wanted any information available on Elizabeth Magruder daughter of Alexander II, son of Alexander the Immigrant, who is said to have married after 1748, Mark McPherson.

MAGRUDER-HARWOOD: Wanted: The parents of James Magruder who married on November 23, 1807, Eleanor Harwood. Their son Rufus King Magruder, married on October 22, 1850, America Pritchard and their son R. Harwood Magruder was born at the Magruder homestead in Frederick, Maryland.



NOT A PRETTY PICTURE

In the May, 1950, issue of the Quarterly News Bulletin of the Maryland Historical Society there is a picture showing the ravages of time, mice, silver fish and dampness on an old and valuable Diary lately acquired by the Society, and valuable in the genealogical data contained in its pages, now well-nigh unreadable. This might happen to priceless materials now stored in cellar or attic of old houses or otherwise improperly cared for. Fire, too, may destroy your precious papers, for it is well known that Court Houses, Churches and other depositaries of records have gone up in smoke carrying with it records which never again can be gathered together. Some such disaster, or neglect, may deprive future generations of information contained in YOUR papers.

This appalling thought has prompted us to make an earnest appeal to all members of "Our Clan" who may have records; no matter how few or many, to make at least three copies of them, and send these copies to the Headquarters Office of the American Clan Gregor Society. The original typed copy will be filed at Headquarters for research and reference purposes, and the two carbons will be sent along with other Clan material of like matter to several safe places where the Clan records are stored.

You may wish to give the Clan your original copy of a will, deed, land grant, etc. In this case three copies of the original will be made and distributed as above mentioned and the original which you gave to the Clan will be stored with the other Clan material.

Look now among your family papers for Wills, Land Grants, Marriage Bonds, Diaries, Bible Records, copies of Census and Church Records, and letters of any date which may have in them genealogical items, or family history, and copy these verbatum, type them if possible. Please leave one full inch clear on each side of paper and one and a half at top and bottom. Also use only one side of each sheet of paper.

We are doing our best at Headquarters to have typed the material now on hand which is being indexed and bound in loose leaf binders. Such material as the above is constantly coming to us and we welcome every scrap. Incidently, newspaper notices of births, marriages, deaths or items of interest to Clan mem-

bers are valuable and appreciated especially when accompanied by title and date of newspaper in which they appear, cut from the paper. Please send us whatever you can. It is for your descendants this material is being collected.

IMPORTANT MARYLAND RECORDS AT ANNAPOLIS

Readers of the Year Book are advised that certain records they have believed were destroyed can be had at the Hall of Records and the Land Office (in the same building), Annapolis, Maryland, especially wills and deeds relating to Calvert County, whose original records were mostly destroyed in a fire in 1882. The copies of these records, or most of them, are still available.

Many of the States require that copies of county records be deposited with the Secretary of State at the Capitol. The reason the records of Gloucester County, Virginia, exist only in fragment form is that the courthouse at Gloucester was burned in 1820 and the copies at Richmond were not generally recopied, so when the State Capitol was burned in the Civil War, the destruction was fairly complete. However, Mrs. Polly Cary Mason has very well managed to put the Gloucester records together again, and in a foreword to her work, Dr. Earl G. Swem, author of Swem's Index of Virginia Publications, bids fact seekers to get off the beaten highways and search in the Tidewater region, where, he agrees with Mrs. Mason, exists mountains of valuable data. For the concentrated county records, though, the Land Office (Mrs. Nell Marion Nugent), the Capitol, Richmond, is the best source.

On page 21, of the Year Book of the American Clan Gregor Society for 1923, Chieftain Edward May Magruder stated in his annual address: "Alexander Magruder died in 1677 and his will was probated January 25, 1677 . . . There is a copy of this will in its original quaint wording and spelling in the Land Office in Annapolis, Maryland, Liber V, Folio 269, which contains copies of all the wills of all counties of Maryland. (C. C. M. Jr., authority). In this will he mentions wife Elizabeth."

This casual mention of available records in a study of Alexander Magruder was not calculated to send many fact seekers speeding to Annapolis. Indeed, since 1923 we have read several times expressions to the effect that Calvert was a "near blackout" for information. By example, this from the excellent article by Attorney Alexander H. Bell of Washington, D. C., which starts on page 91 of the Yearbook for 1938, in his discussion of the Trumans, Dents, Magruders and their Maryland kin: "Unfortunately, due to the destruction of the Calvert County records, there can not be any check-up on the indicated line of Magruders . . . "

The American Clan Gregor Society is making an effort to avoid the possibility of its records being totally destroyed and has recently had copies of certain data made and their plan is to deposit these copies, the original Application Blanks and a set of the Year Books in several different places. In time all material of recognized value will be so copied.

GIFTS TO THE CLAN

Booklet: Twelve Generations in America, by Wilhoite Carpenter Barrickman, our member from Austin, Texas. This booklet is bound in the Clan Plaid in color and carries on the line of Archibald Magruder and Cassandra Offutt. This booklet is dedicated as follows: "IN MEMORY OF MARION MYRL HARRISON (1890-1946)

whose diligent study and many years of patient research as the "Family Historian" of Archibald Magruder's descendants in Kentucky, made this little book possible."

More than 375 families are included in this record, and 1100 children, all descendants of Alexander Magruder, through his great-great-grandson, Archibald. Besides the Magruder families in the male lines, are many families in the female lines.

Among these are Abell, Ash, Aud, Barrall, Barrickman, Barnes, Beard, Berry, Blackstock, Bradshaw, Bridgewater, Bridwell, Brown, Carpenter, Cassell, Crenshaw, Criswell, Combs, Carroll, Christian, Deacon, Dent, Downs, Ewing, Field, Fields, Funk, Gatten, Garth, Goff, Graves, Gering, Harris, Hagan, Hall, Haley, Hibbs, Hume, Henderson, Harrison, Hardesty, Hoover, Jenkins, Jones, Lutes, Lee, Lloyd, McCarty, McAfee, Maraman, Masden, Medley, Meredith, Mathis, Menakee, Miranda, Morgan, Milam, Myers, Nusz, Nutt, Overall, Parrish, Page, Roby, Rouse, Riggs, Reynolds, Ripy, Rudd, Riddle, Samuels, Sales, Scott, Sherman, Sheriff, Shackelford, Spencer, Stark, Stovall, Troutman, Tinnell, Walker, Watkins, Weaver, Wells, Wheeler, Winkler, Wise, Williamson, Yeiser, Zimmerman, and others.

Most lines extend through the 9th, 10th and 11th generations; some are in the 12th, and a few are found only as far as the 7th and 8th generations, because the necessary information has not been available, or because by letters of inquiry not being replied to.

This is a valuable booklet for researchers.

Congratulations to Mr. Barrickman on this splendid piece of work.

The History of the Cresaps, compiled by Rev. Joseph Ord Cresap and Bernarr Cresap.

During a research trip to Cumberland, Maryland, during my vacation time last summer I, as your Historian, collected some data on the Beall-Magruder family of Cumberland, particularly on the descendants of Verlinda Magruder, daughter of Samuel and Sarah, who married John Beall. The Postmaster at Cumberland put me in touch with Colonel Frank E. Powell, retired, from the Eastern Shore of Maryland, who had married a descendant of this marriage. I have had some interesting correspondence with him. Colonel Powell attended the Cresap Society, he being of that line, and he came to see us at Headquarters on his way home from Cumberland. In talking about the Society and the Clan he told us of this book on the Cresaps and said he would ask the authors to send us a copy for our Archives. We received the book and a very nice letter from Rev. Mr. Cresap. He is also sending the Clan the Cresap Bulletin which is issued several times a year.

The Genealogical section of this book is well arranged and easy to follow and is well indexed. On page 312 is the line of Mary Cresap who married John T. Singleton. Our Clansman, Mrs. Blanche Boyce Meyers, is a descendant of this marriage.

Another descendant of Verlinda Magruder and John Beall is Mr. William Wallace McKaig of Cumberland. Both Mr. McKaig and Colonel Powell have been asked to contribute an article on this Beall-Magruder line.

Book—River of No Return. A Historical Story of Idaho, by Robert G. Bailey, Lewiston, Idaho. It is the story of the Salmon River country and is a most delightful book. On page 124 starts a most interesting account of the Murder of Lloyd Magruder in October 1863. He was the son of Lloyd Magruder and Ann Holmes. There are many references to Thomas B. or J., Beall, a pioneer of Lewiston and his picture is given on several pages. He went to Lewiston in 1858 as a Scout with Col. Steptoe, and died there about 1925. He has a son who is a successful farmer near Lewiston. We would like to know more about Mr. Beall.

This book, which has been autographed by the Author, has been presented to the Clan by Miss Lucile Magruder, our member from Moscow, Idaho, in memory of her father, John Levi Magruder. A Memorial sketch to Mr. Magruder will be found in another section of this book.

Pictures—Owen Magruder. Miss Gertrude Owen Pendleton of Pilot Grove, Missouri, has given to the Clan two pictures of her great grandfather, Owen Magruder who was born in Oldham County, Missouri in 1804. He was the son of Aquilla Magruder, he being the son of Nathaniel son of Alexander and his wife, Ann Wade.
