- 1) AGENDA Motion D. Thompson, second Olson to approve the Amended Agenda as presented. Motion carried by a unanimous vote.

- 4) EXECUTIVE DIRECTOR REPORT
  - A. Monthly Program Statistics for April and May 2018 were presented as attached.
  - B. Bank account balances as of 04/30/18 were presented as attached. Discussion on re-investing funds currently held in two CD's at Visionbank with maturity date of 5/29/18. Motion P. ### 5) OTHER BUSINESS

- A. April 2018 financials were presented as attached.
- B. CIRHA is in the beginning phase of a project to remodel the office reception area.
- C. CIRHA By-Laws state that 25% of the Board of Commissioners are needed for a quorum at CIRHA's Annual Meeting, not 50% as previously communicated.
- D. Ms. Conner presented a written report on the Legislative Conference she attended in Washington DC.
- E. Ms. Conner presented a written report on the NCRC Conference she attended in Fort Wayne, Indiana.

- F. A complaint has been filed with the Iowa Civil Rights Commission against CIRHA and Rochelle Meister-CIRHA Housing Coordinator. This matter has been turned over to CIRHA's insurance company, AHRMA.
- G. The City of Urbandale, Iowa may enter into a 28E Agreement with CIRHA. This would allow CIRHA to administer low income housing in that city.
- H. The Executive Committee was satisfied with the training provided at the Commissioner Retreat held in March 2018. Ms. Olson commented that future correspondence should specify between the Executive Committee and/or Board of Commissioners.
