What is Using the Environment as an Integrating Context for Learning (EIC)?

A school improvement process designed by the State Education and Environment Roundtable, a partnership of 16 states' education agencies (www.seer.org).

Data collected in 60 schools in 13 states, since 1996, indicates that EIC has significant positive effects on academic achievement, classroom behavior and instructional practices. EIC students exhibit:

- ✓ Improved performance on standardized tests in reading, writing, math, science and social studies.
- ✓ In 92% of the schools, students in EIC programs academically outperformed their peers in traditional programs.
- ✓ Reduced discipline and classroom management problems in some cases by as much as 95%.
- ✓ Increased engagement and enthusiasm for learning, resulting in substantially improved attendance: and.
- \checkmark Heightened contributions to their communities through effective service-learning projects.
