John Biedermann resigned as President of the Board and all other obligations effective immediately. The Board accepted this resignation. Acting President will put a letter out thanking John for his commitment to the association.

Because we do not have a Director of Upper House, the Director of Lower House would be the next in line to fill in for the President, however he does not want that position, and he made a nomination for John Lenzmeier to be brought back onto the Board in the capacity of Director of Upper House. John Lenzmeier will resign his position on the CAHA Board and accept the nomination for Director of Upper House. A motion was made and seconded to put John Lenzmeier back on the Board as Director of Upper House. Voted and affirmed.

- Player development for squirt-bantam

- Not CHL teams-leaving open to see if competitive teams in CHL - otherwise independent

- Stipend $\$ 2500$ plus expenses (to be capped)

A motion was made and seconded to accept the above travel proposal. All in favor voted and motion was affirmed.

Administration:

Ice Contracts

- Extend to a 3 year term
- First right of refusal during prime time
- Confidentiality Agreement - Can't share with other providers
- Contracts have gone out to Cary, Wake Forest and Garner
- Will begin negotiations with RecZone immediately

House timeline (I think Steve Henley wanted a timeline for house)

- Based on ice requirements used last fall and spring
- Standardized schedule for house programs
- All ended by mid-February
- Spring evaluations first weekend in March

A motion was made and seconded to accept the ice agreement as proposed. Voted and affirmed.

Finance:

- Director of Finance made a presentation including Profit and Loss, Balance Sheet, and Statement of Cash flow fiscal year to date from Quick Books and where we stand today financially.
- Per the bylaws $\$ 1,000$ per expenditure can be done without Board approval.
- Administrator is to send the Director of Finance an updated summary of where we stand in one week on credits \& fees outstanding from the fall season.
- Set up a guideline for refunds: injury; 48 hours refund consideration; moving
- A committee was formed to create a policy for refunds and then bring it to the Board for review. MJ, Andy, Jerry and Danny.

Other:
Bylaws:

- RYHA, Inc. Bylaws model could be a good model but it was decided to move ahead with the originally distributed bylaws.
- How many board members do we want to go forward with?
- It was decided that a 7 member board would be best from 2007-2008 onward; President, Director of House, Director of Travel/Tier 1 Appointee, Director of Finance; Director of Fundraising; Director of Girls; and Director of PR/Marketing/Website. One cycle this year, president, director of travel and director of fundraiser; next cycle following year, director house, finance, director of girls and director of pr/marketing/website administrator on a two year cycle. Girls and pr/marketing will go on ballot for 07 for a one year program and then again on the ballot for 08 for a two year program.
- Director of Independent teams will continue working on the bylaws with Raleigh Youth Hockey Association with the linkage to RYHA, Inc.
- Get terms of board structure and new by laws to attorney for review and guidance.
- Get the roles and responsibilities, board structure together and obtain nominations \& get the ballots out there.
