Directions for Domestic Use

Controls egg stages of pests present in domestic system and scale insects, moths and mealybugs on normal shrubs (e.g., roses), evergreens, woody plants, fruit trees and shade trees. Thoroughly wet the dormant plants or trees.

Toxic Ingredients

Oil removes the glaucous (blue) bloom from such evergreens as Colorado blue spruce and Koster spruce. Use caution on blooms and buds and on oil sensitive plants such as Chamaecyparis, Cupressus, Japanese Holly, Red Cedar and Smoke tree. If concerned about sensitivity of plants, test spray a portion of the plant and wait several days to determine if burn occurs before spraying larger areas.

Do not apply within 21 days of a sulfur application.
Do not use Garden Sale® Brand Houseplant & Garden Insect Spray when temperatures are above 90°F.

STORAGE AND DISPOSAL
