

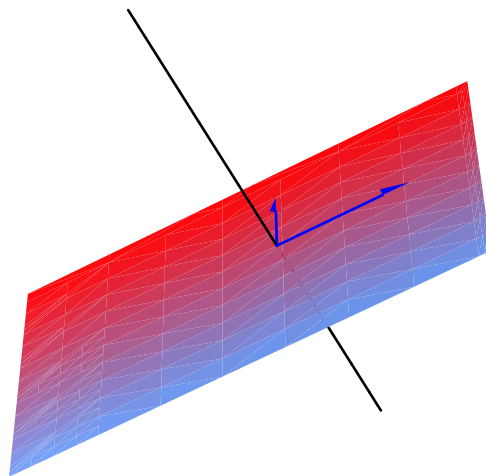

Chapter 1

What is Linear Algebra?

1.1 Introduction to MAT 67

This class may well be one of your first mathematics classes that bridges the gap between the mainly computation-oriented lower division classes and the abstract mathematics encountered in more advanced mathematics courses. The goal of this class is threefold:

1. You will learn **Linear Algebra**, which is one of the most widely used mathematical theories around. Linear Algebra finds applications in virtually every area of mathematics, including Multivariate Calculus, Differential Equations, and Probability Theory. It is also widely applied in fields like physics, chemistry, economics, psychology, and engineering. You are even relying on methods from Linear Algebra every time you use an Internet search like Google, the Global Positioning System (GPS), or a cellphone.
2. You will acquire **computational skills** to solve linear systems of equations, perform operations on matrices, calculate eigenvalues, and find determinants of matrices.
3. In the setting of Linear Algebra, you will be introduced to **abstraction**. We will develop the theory of Linear Algebra together, and you will learn to write proofs.

The lectures will mainly develop the theory of Linear Algebra, and the discussion sessions will focus on the computational aspects. The lectures and the discussion sections go hand in hand, and it is important that you attend both. The exercises for each Chapter are divided into more computation-oriented exercises and exercises that focus on proof-writing. There

are also some very short webwork homework sets to make sure you have some basic skills. You can already try the first one that introduces some logical concepts by clicking below:

Background Webwork Problems

1.2 What is Linear Algebra?

Linear Algebra is the branch of mathematics aimed at solving systems of linear equations with a finite number of unknowns. In particular, one would like to obtain answers to the following questions:

- **Characterization of solutions:** Are there solutions to a given system of linear equations? How many solutions are there?
- **Finding solutions:** How does the solution set look? What are the solutions?

Linear Algebra is a systematic theory regarding the solutions of systems of linear equations.

Example 1.2.1. Let us take the following system of two linear equations in the two unknowns x_1 and x_2 :

$$\left. \begin{array}{l} 2x_1 + x_2 = 0 \\ x_1 - x_2 = 1 \end{array} \right\}.$$

This system has a **unique solution** for $x_1, x_2 \in \mathbb{R}$, namely $x_1 = \frac{1}{3}$ and $x_2 = -\frac{2}{3}$.

This solution can be found in several different ways. One approach is to first solve for one of the unknowns in one of the equations and then to substitute the result into the other equation. Here, for example, we might solve to obtain

$$x_1 = 1 + x_2$$

from the second equation. Then, substituting this in place of x_1 in the first equation, we have

$$2(1 + x_2) + x_2 = 0.$$

From this, $x_2 = -2/3$. Then, by further substitution,

$$x_1 = 1 + \left(-\frac{2}{3}\right) = \frac{1}{3}.$$

Alternatively, we can take a more systematic approach in eliminating variables. Here, for example, we can subtract 2 times the second equation from the first equation in order to obtain $3x_2 = -2$. It is then immediate that $x_2 = -\frac{2}{3}$ and, by substituting this value for x_2 in the first equation, that $x_1 = \frac{1}{3}$.

Example 1.2.2. Take the following system of two linear equations in the two unknowns x_1 and x_2 :

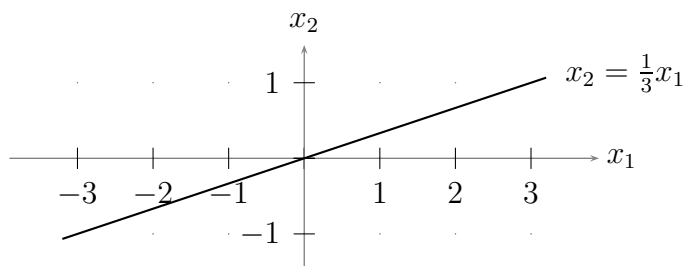
$$\left. \begin{aligned} x_1 + x_2 &= 1 \\ 2x_1 + 2x_2 &= 1 \end{aligned} \right\}.$$

Here, we can eliminate variables by adding -2 times the first equation to the second equation, which results in $0 = -1$. This is obviously a contradiction, and hence this system of equations has **no solution**.

Example 1.2.3. Let us take the following system of one linear equation in the two unknowns x_1 and x_2 :

$$x_1 - 3x_2 = 0.$$

In this case, there are **infinitely many** solutions given by the set $\{x_2 = \frac{1}{3}x_1 \mid x_1 \in \mathbb{R}\}$. You can think of this solution set as a line in the Euclidean plane \mathbb{R}^2 :



In general, a **system of m linear equations in n unknowns** x_1, x_2, \dots, x_n is a collection of equations of the form

$$\left. \begin{aligned} a_{11}x_1 + a_{12}x_2 + \cdots + a_{1n}x_n &= b_1 \\ a_{21}x_1 + a_{22}x_2 + \cdots + a_{2n}x_n &= b_2 \\ &\vdots \\ a_{m1}x_1 + a_{m2}x_2 + \cdots + a_{mn}x_n &= b_m \end{aligned} \right\}, \quad (1.1)$$

where the a_{ij} 's are the coefficients (usually real or complex numbers) in front of the unknowns x_j , and the b_i 's are also fixed real or complex numbers. A **solution** is a set of numbers

s_1, s_2, \dots, s_n such that, substituting $x_1 = s_1, x_2 = s_2, \dots, x_n = s_n$ for the unknowns, all of the equations in System (1.1) hold. Linear Algebra is a theory that concerns the solutions and the structure of solutions for linear equations. As this course progresses, you will see that there is a lot of subtlety in fully understanding the solutions for such equations.

1.3 Systems of linear equations

1.3.1 Linear equations

Before going on, let us reformulate the notion of a system of linear equations into the language of functions. This will also help us understand the adjective “linear” a bit better. A **function** f is a map

$$f : X \rightarrow Y \tag{1.2}$$

from a set X to a set Y . The set X is called the **domain** of the function, and the set Y is called the **target space** or **codomain** of the function. An **equation** is

$$f(x) = y, \tag{1.3}$$

where $x \in X$ and $y \in Y$. (If you are not familiar with the abstract notions of sets and functions, then please consult Appendix A.)

Example 1.3.1. Let $f : \mathbb{R} \rightarrow \mathbb{R}$ be the function $f(x) = x^3 - x$. Then $f(x) = x^3 - x = 1$ is an equation. The domain and target space are both the set of real numbers \mathbb{R} in this case.

In this setting, a system of equations is just another kind of equation.

Example 1.3.2. Let $X = Y = \mathbb{R}^2 = \mathbb{R} \times \mathbb{R}$ be the Cartesian product of the set of real numbers. Then define the function $f : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ as

$$f(x_1, x_2) = (2x_1 + x_2, x_1 - x_2), \tag{1.4}$$

and set $y = (0, 1)$. Then the equation $f(x) = y$, where $x = (x_1, x_2) \in \mathbb{R}^2$, describes the system of linear equations of Example 1.2.1.

The next question we need to answer is, “what is a linear equation?” Building on the definition of an equation, a **linear equation** is any equation defined by a “linear” function

f that is defined on a “linear” space (a.k.a. a **vector space** as defined in Section 4.1). We will elaborate on all of this in future lectures, but let us demonstrate the main features of a “linear” space in terms of the example \mathbb{R}^2 . Take $x = (x_1, x_2), y = (y_1, y_2) \in \mathbb{R}^2$. There are two “linear” operations defined on \mathbb{R}^2 , namely addition and scalar multiplication:

$$x + y := (x_1 + y_1, x_2 + y_2) \quad (\text{vector addition}) \quad (1.5)$$

$$cx := (cx_1, cx_2) \quad (\text{scalar multiplication}). \quad (1.6)$$

A “linear” function on \mathbb{R}^2 is then a function f that interacts with these operations in the following way:

$$f(cx) = cf(x) \quad (1.7)$$

$$f(x + y) = f(x) + f(y). \quad (1.8)$$

You should check for yourself that the function f in Example 1.3.2 has these two properties.

1.3.2 Non-linear equations

(Systems of) Linear equations are a very important class of (systems of) equations. You will learn techniques in this class that can be used to solve any systems of linear equations. Non-linear equations, on the other hand, are significantly harder to solve. An example is a **quadratic equation** such as

$$x^2 + x - 2 = 0, \quad (1.9)$$

which, for no completely obvious reason, has exactly two solutions $x = -2$ and $x = 1$. Contrast this with the equation

$$x^2 + x + 2 = 0, \quad (1.10)$$

which has no solutions within the set \mathbb{R} of real numbers. Instead, it has two complex solutions $\frac{1}{2}(-1 \pm i\sqrt{7}) \in \mathbb{C}$, where $i = \sqrt{-1}$. (Complex numbers are discussed in more detail in Chapter 2.) In general, recall that the quadratic equation $x^2 + bx + c = 0$ has the two solutions

$$x = -\frac{b}{2} \pm \sqrt{\frac{b^2}{4} - c}.$$

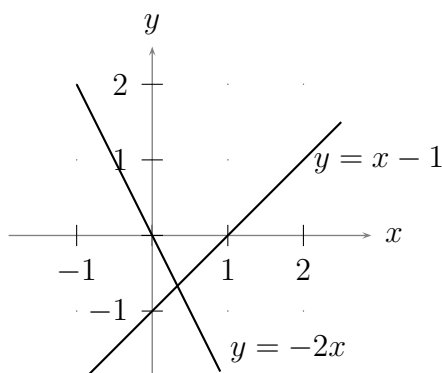
1.3.3 Linear transformations

The set \mathbb{R}^2 can be viewed as the Euclidean plane. In this context, linear functions of the form $f : \mathbb{R}^2 \rightarrow \mathbb{R}$ or $f : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ can be interpreted geometrically as “motions” in the plane and are called **linear transformations**.

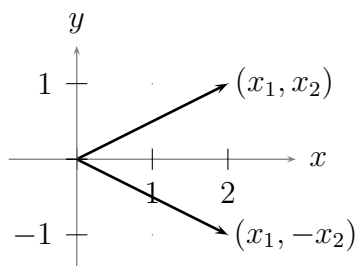
Example 1.3.3. Recall the following linear system from Example 1.2.1:

$$\left. \begin{array}{l} 2x_1 + x_2 = 0 \\ x_1 - x_2 = 1 \end{array} \right\}.$$

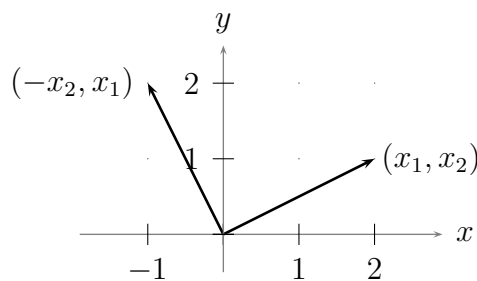
Each equation can be interpreted as a straight line in the plane, with solutions (x_1, x_2) to the linear system given by the set of all points that simultaneously lie on both lines. In this case, the two lines meet in only one location, which corresponds to the unique solution to the linear system as illustrated in the following figure:



Example 1.3.4. The linear map $f(x_1, x_2) = (x_1, -x_2)$ describes the “motion” of reflecting a vector across the x -axis, as illustrated in the following figure:



Example 1.3.5. The linear map $f(x_1, x_2) = (-x_2, x_1)$ describes the “motion” of rotating a vector by 90° counterclockwise, as illustrated in the following figure:



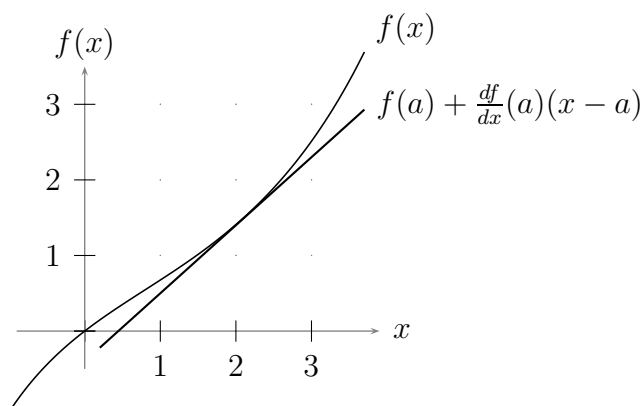
This example can easily be generalized to rotation by any arbitrary angle using Lemma 2.3.2. In particular, when points in \mathbb{R}^2 are viewed as complex numbers, then we can employ the so-called polar form for complex numbers in order to model the “motion” of rotation. (Cf. Proof-Writing Exercise 5 on page 25.)

1.3.4 Applications of linear equations

Linear equations pop up in many different contexts. For example, you can view the derivative $\frac{df}{dx}(x)$ of a differentiable function $f : \mathbb{R} \rightarrow \mathbb{R}$ as a linear approximation of f . This becomes apparent when you look at the Taylor series of the function $f(x)$ centered around the point $x = a$ (as seen in a course like MAT 21C):

$$f(x) = f(a) + \frac{df}{dx}(a)(x - a) + \dots \quad (1.11)$$

In particular, we can graph the linear part of the Taylor series versus the original function, as in the following figure:



Since $f(a)$ and $\frac{df}{dx}(a)$ are merely real numbers, $f(a) + \frac{df}{dx}(a)(x - a)$ is a linear function in the single variable x .

Similarly, if $f : \mathbb{R}^n \rightarrow \mathbb{R}^m$ is a multivariate function, then one can still view the derivative of f as a form of a linear approximation for f (as seen in a course like MAT 21D).

What if there are infinitely many variables x_1, x_2, \dots ? In this case, the system of equations has the form

$$\left. \begin{aligned} a_{11}x_1 + a_{12}x_2 + \cdots &= y_1 \\ a_{21}x_1 + a_{22}x_2 + \cdots &= y_2 \\ \cdots & \end{aligned} \right\}.$$

Hence, the sums in each equation are infinite, and so we would have to deal with infinite series. This, in particular, means that questions of convergence arise, where convergence depends upon the infinite sequence $x = (x_1, x_2, \dots)$ of variables. These questions will not occur in this course since we are only interested in finite systems of linear equations in a finite number of variables. Other subjects in which these questions do arise, though, include

- Differential Equations (as in a course like MAT 22B or MAT 118AB);
- Fourier Analysis (as in a course like MAT 129);
- Real and Complex Analysis (as in a course like MAT 125AB, MAT 185AB, MAT 201ABC, or MAT 202).

In courses like MAT 150ABC and MAT 250ABC, Linear Algebra is also seen to arise in the study of such things as symmetries, linear transformations, and Lie Algebra theory.

Computational Exercises

1. Try some webwork problems:

Linear Systems Webwork Problems

2. Solve the following systems of linear equations and characterize their solution sets. (I.e., determine whether there is a unique solution, no solution, etc.) Also, write each system of linear equations as an equation for a single function $f : \mathbb{R}^n \rightarrow \mathbb{R}^m$ for appropriate choices of $m, n \in \mathbb{Z}_+$.

- (a) System of 3 equations in the unknowns x, y, z, w :

$$\left. \begin{aligned} x + 2y - 2z + 3w &= 2 \\ 2x + 4y - 3z + 4w &= 5 \\ 5x + 10y - 8z + 11w &= 12 \end{aligned} \right\}.$$

- (b) System of 4 equations in the unknowns x, y, z :

$$\left. \begin{aligned} x + 2y - 3z &= 4 \\ x + 3y + z &= 11 \\ 2x + 5y - 4z &= 13 \\ 2x + 6y + 2z &= 22 \end{aligned} \right\}.$$

- (c) System of 3 equations in the unknowns x, y, z :

$$\left. \begin{aligned} x + 2y - 3z &= -1 \\ 3x - y + 2z &= 7 \\ 5x + 3y - 4z &= 2 \end{aligned} \right\}.$$

3. Find all pairs of real numbers x_1 and x_2 that satisfy the system of equations

$$x_1 + 3x_2 = 2, \tag{1.12}$$

$$x_1 - x_2 = 1. \tag{1.13}$$

Proof-Writing Exercises

1. Let a, b, c , and d be real numbers, and consider the system of equations given by

$$ax_1 + bx_2 = 0, \tag{1.14}$$

$$cx_1 + dx_2 = 0. \tag{1.15}$$

Note that $x_1 = x_2 = 0$ is a solution for any choice of a, b, c , and d . Prove that if $ad - bc \neq 0$, then $x_1 = x_2 = 0$ is the only solution.

Chapter 2

Introduction to Complex Numbers

Let \mathbb{R} denote the set of **real numbers**, which should be a familiar collection of numbers to anyone who has studied Calculus. In this chapter, we use \mathbb{R} to build the equally important set of so-called complex numbers.

2.1 Definition of complex numbers

We begin with the following definition.

Definition 2.1.1. The set of **complex numbers** \mathbb{C} is defined as

$$\mathbb{C} = \{(x, y) \mid x, y \in \mathbb{R}\}.$$

Given a complex number $z = (x, y)$, we call $\text{Re}(z) = x$ the **real part** of z and $\text{Im}(z) = y$ the **imaginary part** of z .

In other words, we are defining a new collection of numbers z by taking every possible ordered pair (x, y) of real numbers $x, y \in \mathbb{R}$, and x is called the real part of the ordered pair (x, y) in order to imply that the set \mathbb{R} of real numbers should be identified with the subset $\{(x, 0) \mid x \in \mathbb{R}\} \subset \mathbb{C}$. It is also common to use the term **purely imaginary** for any complex number of the form $(0, y)$, where $y \in \mathbb{R}$. In particular, the complex number $i = (0, 1)$ is special, and it is called the **imaginary unit**. (The use of i is standard when denoting this complex number, though j is sometimes used if i means something else. E.g., i is used to denote electric current in Electrical Engineering.)

Note that if we write $1 = (1, 0)$, then we can express $z = (x, y) \in \mathbb{C}$ as

$$z = (x, y) = x(1, 0) + y(0, 1) = x1 + yi = x + yi.$$

It is often significantly easier to perform arithmetic operations on complex numbers when written in this form, as we illustrate in the next section.

2.2 Operations on complex numbers

Even though we have formally defined \mathbb{C} as the set of all ordered pairs of real numbers, we can nonetheless extend the usual arithmetic operations on \mathbb{R} so that they also make sense on \mathbb{C} . We discuss such extensions in this section, along with several other important operations on complex numbers.

2.2.1 Addition and subtraction of complex numbers

Addition of complex numbers is performed component-wise, meaning that the real and imaginary parts are simply combined.

Definition 2.2.1. Given two complex numbers $(x_1, y_1), (x_2, y_2) \in \mathbb{C}$, we define their (**complex**) **sum** to be

$$(x_1, y_1) + (x_2, y_2) = (x_1 + x_2, y_1 + y_2).$$

Example 2.2.2. $(3, 2) + (17, -4.5) = (3 + 17, 2 - 4.5) = (20, -2.5)$.

As with the real numbers, subtraction is defined as addition with the so-called **additive inverse**, where the additive inverse of $z = (x, y)$ is defined as $-z = (-x, -y)$.

Example 2.2.3. $(\pi, \sqrt{2}) - (\pi/2, \sqrt{19}) = (\pi, \sqrt{2}) + (-\pi/2, -\sqrt{19})$, where

$$(\pi, \sqrt{2}) + (-\pi/2, -\sqrt{19}) = (\pi - \pi/2, \sqrt{2} - \sqrt{19}) = (\pi/2, \sqrt{2} - \sqrt{19}).$$

The addition of complex numbers shares many of the same properties as the addition of real numbers, including associativity, commutativity, the existence and uniqueness of an additive identity, and the existence and uniqueness of additive inverses. We summarize these properties in the following theorem, which you should prove for your own practice.

Theorem 2.2.4. *Let $z_1, z_2, z_3 \in \mathbb{C}$ be any three complex numbers. Then the following statements are true.*

1. *(Associativity) $(z_1 + z_2) + z_3 = z_1 + (z_2 + z_3)$.*
2. *(Commutativity) $z_1 + z_2 = z_2 + z_1$.*
3. *(Additive Identity) There is a unique complex number, denoted 0 , such that, given any complex number $z \in \mathbb{C}$, $0 + z = z$. Moreover, $0 = (0, 0)$.*
4. *(Additive Inverses) Given any complex number $z \in \mathbb{C}$, there is a unique complex number, denoted $-z$, such that $z + (-z) = 0$. Moreover, if $z = (x, y)$ with $x, y \in \mathbb{R}$, then $-z = (-x, -y)$.*

The proof of this theorem is straightforward and relies solely on the definition of complex addition along with the familiar properties of addition for real numbers. For example, to check commutativity, let $z_1 = (x_1, y_1)$ and $z_2 = (x_2, y_2)$ be complex numbers with $x_1, x_2, y_1, y_2 \in \mathbb{R}$. Then

$$z_1 + z_2 = (x_1 + x_2, y_1 + y_2) = (x_2 + x_1, y_2 + y_1) = z_2 + z_1.$$

2.2.2 Multiplication and division of complex numbers

The definition of multiplication for two complex numbers is at first glance somewhat less straightforward than that of addition.

Definition 2.2.5. Given two complex numbers $(x_1, y_1), (x_2, y_2) \in \mathbb{C}$, we define their **(complex) product** to be

$$(x_1, y_1)(x_2, y_2) = (x_1x_2 - y_1y_2, x_1y_2 + x_2y_1).$$

According to this definition, $i^2 = -1$. In other words, i is a solution of the polynomial equation $z^2 + 1 = 0$, which does not have solutions in \mathbb{R} . Solving such otherwise unsolvable equations was largely the main motivation behind the introduction of complex numbers. Note that the relation $i^2 = -1$ and the assumption that complex numbers can be multiplied like real numbers is sufficient to arrive at the general rule for multiplication of complex

numbers:

$$\begin{aligned}(x_1 + y_1i)(x_2 + y_2i) &= x_1x_2 + x_1y_2i + x_2y_1i + y_1y_2i^2 \\ &= x_1x_2 + x_1y_2i + x_2y_1i - y_1y_2 \\ &= x_1x_2 - y_1y_2 + (x_1y_2 + x_2y_1)i.\end{aligned}$$

As with addition, the basic properties of complex multiplication are easy enough to prove using the definition. We summarize these properties in the following theorem, which you should also prove for your own practice.

Theorem 2.2.6. *Let $z_1, z_2, z_3 \in \mathbb{C}$ be any three complex numbers. Then the following statements are true.*

1. (*Associativity*) $(z_1z_2)z_3 = z_1(z_2z_3)$.
2. (*Commutativity*) $z_1z_2 = z_2z_1$.
3. (*Multiplicative Identity*) There is a unique complex number, denoted 1 , such that, given any $z \in \mathbb{C}$, $1z = z$. Moreover, $1 = (1, 0)$.
4. (*Distributivity of Multiplication over Addition*) $z_1(z_2 + z_3) = z_1z_2 + z_1z_3$.

Just as is the case for real numbers, any non-zero complex number z has a unique multiplicative inverse, which we may denote by either z^{-1} or $1/z$.

Theorem 2.2.6 (continued).

5. (*Multiplicative Inverses*) Given $z \in \mathbb{C}$ with $z \neq 0$, there is a unique complex number, denoted z^{-1} , such that $zz^{-1} = 1$. Moreover, if $z = (x, y)$ with $x, y \in \mathbb{R}$, then

$$z^{-1} = \left(\frac{x}{x^2 + y^2}, \frac{-y}{x^2 + y^2} \right).$$

Proof. (Uniqueness.) A complex number w is an inverse of z if $zw = 1$ (by the commutativity of complex multiplication this is equivalent to $wz = 1$). We will first prove that if w and v are two complex numbers such that $zw = 1$ and $zv = 1$, then we necessarily have $w = v$.

This will then imply that any $z \in \mathbb{C}$ can have at most one inverse. To see this, we start from $zv = 1$. Multiplying both sides by w , we obtain $wzv = w1$. Using the fact that 1 is the multiplicative unit, that the product is commutative, and the assumption that w is an inverse, we get $zwv = v = w$.

(*Existence.*) Now assume $z \in \mathbb{C}$ with $z \neq 0$, and write $z = x + yi$ for $x, y \in \mathbb{R}$. Since $z \neq 0$, at least one of x or y is not zero, and so $x^2 + y^2 > 0$. Therefore, we can define

$$w = \left(\frac{x}{x^2 + y^2}, \frac{-y}{x^2 + y^2} \right),$$

and one can check that $zw = 1$. □

Now, we can define the **division** of a complex number z_1 by a non-zero complex number z_2 as the product of z_1 and z_2^{-1} . Explicitly, for two complex numbers $z_1 = x_1 + iy_1$ and $z_2 = x_2 + iy_2$, we have that their **(complex) quotient** is

$$\frac{z_1}{z_2} = \frac{x_1x_2 + y_1y_2 + (x_2y_1 - x_1y_2)i}{x_2^2 + y_2^2}.$$

Example 2.2.7. We illustrate the above definition with the following example:

$$\frac{(1, 2)}{(3, 4)} = \left(\frac{1 \cdot 3 + 2 \cdot 4}{3^2 + 4^2}, \frac{3 \cdot 2 - 1 \cdot 4}{3^2 + 4^2} \right) = \left(\frac{3 + 8}{9 + 16}, \frac{6 - 4}{9 + 16} \right) = \left(\frac{11}{25}, \frac{2}{25} \right).$$

2.2.3 Complex conjugation

Complex conjugation is an operation on \mathbb{C} that will turn out to be very useful because it allows us to manipulate only the imaginary part of a complex number. In particular, when combined with the notion of modulus (as defined in the next section), it is one of the most fundamental operations on \mathbb{C} .

The definition and most basic properties of complex conjugation are as follows. (As in the previous sections, you should provide a proof of the theorem below for your own practice.)

Definition 2.2.8. Given a complex number $z = (x, y) \in \mathbb{C}$ with $x, y \in \mathbb{R}$, we define the **(complex) conjugate** of z to be the complex number

$$\bar{z} = (x, -y).$$

Theorem 2.2.9. *Given two complex numbers $z_1, z_2 \in \mathbb{C}$,*

1. $\overline{z_1 + z_2} = \overline{z_1} + \overline{z_2}$.
2. $\overline{z_1 z_2} = \overline{z_1} \overline{z_2}$.
3. $\overline{1/z_1} = 1/\overline{z_1}$, for all $z_1 \neq 0$.
4. $\overline{z_1} = z_1$ if and only if $\text{Im}(z_1) = 0$.
5. $\overline{\overline{z_1}} = z_1$.
6. *the real and imaginary parts of z_1 can be expressed as*

$$\text{Re}(z_1) = \frac{1}{2}(z_1 + \overline{z_1}) \quad \text{and} \quad \text{Im}(z_1) = \frac{1}{2i}(z_1 - \overline{z_1}).$$

2.2.4 The modulus (a.k.a. norm, length, or magnitude)

In this section, we introduce yet another operation on complex numbers, this time based upon a generalization of the notion of **absolute value** of a real number. To motivate the definition, it is useful to view the set of complex numbers as the two-dimensional Euclidean plane, i.e., to think of $\mathbb{C} = \mathbb{R}^2$ being equal as sets. The **modulus**, or **length**, of $z \in \mathbb{C}$ is then defined as the Euclidean distance between z , as a point in the plane, and the origin $0 = (0, 0)$. This is the content of the following definition.

Definition 2.2.10. Given a complex number $z = (x, y) \in \mathbb{C}$ with $x, y \in \mathbb{R}$, the **modulus** of z is defined to be

$$|z| = \sqrt{x^2 + y^2}.$$

In particular, given $x \in \mathbb{R}$, note that

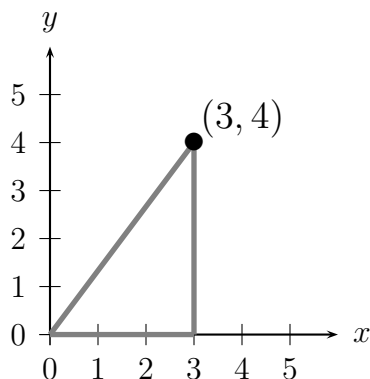
$$|(x, 0)| = \sqrt{x^2 + 0} = |x|$$

under the convention that the square root function takes on its principal positive value.

Example 2.2.11. Using the above definition, we see that the modulus of the complex number $(3, 4)$ is

$$|(3, 4)| = \sqrt{3^2 + 4^2} = \sqrt{9 + 16} = \sqrt{25} = 5.$$

To see this geometrically, construct a figure in the Euclidean plane, such as



and apply the Pythagorean theorem to the resulting right triangle in order to find the distance from the origin to the point $(3, 4)$.

The following theorem lists the fundamental properties of the modulus, and especially as it relates to complex conjugation. You should provide a proof for your own practice.

Theorem 2.2.12. *Given two complex numbers $z_1, z_2 \in \mathbb{C}$,*

1. $|z_1 z_2| = |z_1| \cdot |z_2|$.
2. $\left| \frac{z_1}{z_2} \right| = \frac{|z_1|}{|z_2|}$, assuming that $z_2 \neq 0$.
3. $|\overline{z_1}| = |z_1|$.
4. $|\operatorname{Re}(z_1)| \leq |z_1|$ and $|\operatorname{Im}(z_1)| \leq |z_1|$.
5. (*Triangle Inequality*) $|z_1 + z_2| \leq |z_1| + |z_2|$.
6. (*Another Triangle Inequality*) $|z_1 - z_2| \geq ||z_1| - |z_2||$.
7. (*Formula for Multiplicative Inverse*) $z_1 \overline{z_1} = |z_1|^2$, from which

$$z_1^{-1} = \frac{\overline{z_1}}{|z_1|^2}$$

when we assume that $z_1 \neq 0$.

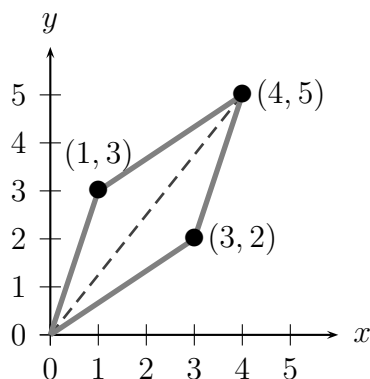
2.2.5 Complex numbers as vectors in \mathbb{R}^2

When complex numbers are viewed as points in the Euclidean plane \mathbb{R}^2 , several of the operations defined in Section 2.2 can be directly visualized as if they were operations on **vectors**.

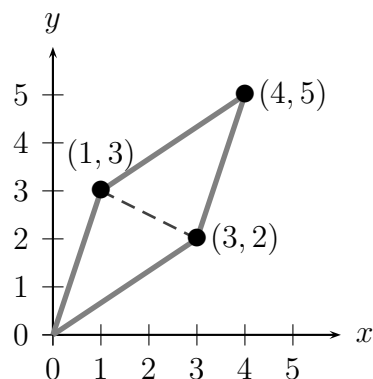
For the purposes of this chapter, we think of vectors as directed line segments that start at the origin and end at a specified point in the Euclidean plane. These line segments may also be moved around in space as long as the direction (which we will call the **argument** in Section 2.3.1 below) and the length (a.k.a. the modulus) are preserved. As such, the distinction between points in the plane and vectors is merely a matter of convention as long as we at least implicitly think of each vector as having been translated so that it starts at the origin.

As we saw in Example 2.2.11 above, the modulus of a complex number can be viewed as the length of the hypotenuse of a certain right triangle. The sum and difference of two vectors can also each be represented geometrically as the lengths of specific diagonals within a particular parallelogram that is formed by copying and appropriately translating the two vectors being combined.

Example 2.2.13. We illustrate the sum $(3, 2) + (1, 3) = (4, 5)$ as the main, dashed diagonal of the parallelogram in the left-most figure below. The difference $(3, 2) - (1, 3) = (2, -1)$ can also be viewed as the shorter diagonal of the same parallelogram, though we would properly need to insist that this shorter diagonal be translated so that it starts at the origin. The latter is illustrated in the right-most figure below.

of Parallelogram



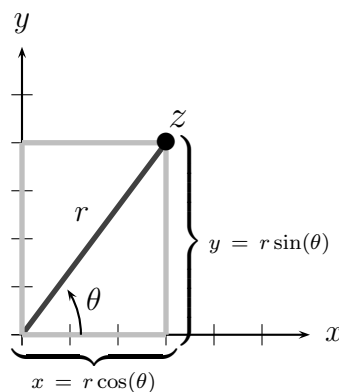
Vector Difference as Minor Diagonal

2.3 Polar form and geometric interpretation for \mathbb{C}

As mentioned above, \mathbb{C} coincides with the plane \mathbb{R}^2 when viewed as a set of ordered pairs of real numbers. Therefore, we can use **polar coordinates** as an alternate way to uniquely identify a complex number. This gives rise to the so-called **polar form** for a complex number, which often turns out to be a convenient representation for complex numbers.

2.3.1 Polar form for complex numbers

The following diagram summarizes the relations between cartesian and polar coordinates in \mathbb{R}^2 :



We call the ordered pair (x, y) the **rectangular coordinates** for the complex number z .

We also call the ordered pair (r, θ) the **polar coordinates** for the complex number z . The radius $r = |z|$ is called the **modulus** of z (as defined in Section 2.2.4 above), and the angle $\theta = \text{Arg}(z)$ is called the **argument** of z . Since the argument of a complex number describes an angle that is measured relative to the x -axis, it is important to note that θ is only well-defined up to adding multiples of 2π . As such, we restrict $\theta \in [0, 2\pi)$ and add or subtract multiples of 2π as needed (e.g., when multiplying two complex numbers so that their arguments are added together) in order to keep the argument within this range of values.

It is straightforward to transform polar coordinates into rectangular coordinates using the equations

$$x = r \cos(\theta) \quad \text{and} \quad y = r \sin(\theta). \quad (2.1)$$

In order to transform rectangular coordinates into polar coordinates, we first note that $r = \sqrt{x^2 + y^2}$ is just the complex modulus. Then, θ must be chosen so that it satisfies the

bounds $0 \leq \theta < 2\pi$ in addition to the simultaneous equations (2.1) where we are assuming that $z \neq 0$.

Summarizing:

$$z = x + yi = r \cos(\theta) + r \sin(\theta)i = r(\cos(\theta) + \sin(\theta)i).$$

Part of the utility of this expression is that the size $r = |z|$ of z is explicitly part of the very definition since it is easy to check that $|\cos(\theta) + \sin(\theta)i| = 1$ for any choice of $\theta \in \mathbb{R}$.

Closely related is the **exponential form** for complex numbers, which does nothing more than replace the expression $\cos(\theta) + \sin(\theta)i$ with $e^{i\theta}$. The real power of this definition is that this exponential notation turns out to be completely consistent with the usual usage of exponential notation for real numbers.

Example 2.3.1. The complex number i in polar coordinates is expressed as $e^{i\pi/2}$, whereas the number -1 is given by $e^{i\pi}$.

2.3.2 Geometric multiplication for complex numbers

As discussed in Section 2.3.1 above, the general exponential form for a complex number z is an expression of the form $re^{i\theta}$ where r is a non-negative real number and $\theta \in [0, 2\pi)$. The utility of this notation is immediately observed when multiplying two complex numbers:

Lemma 2.3.2. *Let $z_1 = r_1e^{i\theta_1}$, $z_2 = r_2e^{i\theta_2} \in \mathbb{C}$ be complex numbers in exponential form. Then*

$$z_1z_2 = r_1r_2e^{i(\theta_1+\theta_2)}.$$

Proof. By direct computation,

$$\begin{aligned} z_1z_2 &= (r_1e^{i\theta_1})(r_2e^{i\theta_2}) = r_1r_2e^{i\theta_1}e^{i\theta_2} \\ &= r_1r_2(\cos \theta_1 + i \sin \theta_1)(\cos \theta_2 + i \sin \theta_2) \\ &= r_1r_2[(\cos \theta_1 \cos \theta_2 - \sin \theta_1 \sin \theta_2) + i(\sin \theta_1 \cos \theta_2 + \cos \theta_1 \sin \theta_2)] \\ &= r_1r_2[\cos(\theta_1 + \theta_2) + i \sin(\theta_1 + \theta_2)] = r_1r_2e^{i(\theta_1+\theta_2)}, \end{aligned}$$

where we have used the usual formulas for the sine and cosine of the sum of two angles. \square

In particular, Lemma 2.3.2 shows that the modulus $|z_1 z_2|$ of the product is the product of the moduli r_1 and r_2 and that the argument $\text{Arg}(z_1 z_2)$ of the product is the sum of the arguments $\theta_1 + \theta_2$.

2.3.3 Exponentiation and root extraction

Another important use for the polar form of a complex number is in exponentiation. The simplest possible situation here involves the use of a positive integer as a power, in which case exponentiation is nothing more than repeated multiplication. Given the observations in Section 2.3.2 above and using some trigonometric identities, one quickly obtains the following fundamental result.

Theorem 2.3.3 (de Moivre's Formula). *Let $z = r(\cos(\theta) + \sin(\theta)i)$ be a complex number in polar form and $n \in \mathbb{Z}_+$ be a positive integer. Then*

1. *the exponentiation $z^n = r^n(\cos(n\theta) + \sin(n\theta)i)$ and*

2. *the n^{th} roots of z are given by the n complex numbers*

$$z_k = r^{1/n} \left[\cos \left(\frac{\theta}{n} + \frac{2\pi k}{n} \right) + \sin \left(\frac{\theta}{n} + \frac{2\pi k}{n} \right) i \right] = r^{1/n} e^{\frac{i}{n}(\theta + 2\pi k)},$$

where $k = 0, 1, 2, \dots, n - 1$.

Note, in particular, that we are not only always guaranteed the existence of an n^{th} root for any complex number, but that we are also always guaranteed to have exactly n of them. This level of completeness in root extraction contrasts very sharply with the delicate care that must be taken when one wishes to extract roots of real numbers without the aid of complex numbers.

An important special case of de Moivre's Formula yields an infinite family of well-studied numbers called the **roots of unity**. By **unity**, we just mean the complex number $1 = 1 + 0i$,

and by the n^{th} **roots of unity**, we mean the n numbers

$$\begin{aligned} z_k &= 1^{1/n} \left[\cos \left(\frac{0}{n} + \frac{2\pi k}{n} \right) + \sin \left(\frac{0}{n} + \frac{2\pi k}{n} \right) i \right] \\ &= \cos \left(\frac{2\pi k}{n} \right) + \sin \left(\frac{2\pi k}{n} \right) i \\ &= e^{2\pi i(k/n)}, \end{aligned}$$

where $k = 0, 1, 2, \dots, n-1$. These numbers have many interesting properties and important applications despite how simple they might appear to be.

Example 2.3.4. To find all solutions of the equation $z^3 + 8 = 0$ for $z \in \mathbb{C}$, we may write $z = re^{i\theta}$ in polar form with $r > 0$ and $\theta \in [0, 2\pi)$. Then the equation $z^3 + 8 = 0$ becomes $z^3 = r^3 e^{i3\theta} = -8 = 8e^{i\pi}$ so that $r = 2$ and $3\theta = \pi + 2\pi k$ for $k = 0, 1, 2$. This means that there are three distinct solutions when $\theta \in [0, 2\pi)$, namely $\theta = \frac{\pi}{3}$, $\theta = \pi$, and $\theta = \frac{5\pi}{3}$.

2.3.4 Some complex elementary functions

We conclude these notes by defining three of the basic elementary functions that take complex arguments. In this context, “elementary function” is used as a technical term and essentially means something like “one of the most common forms of functions encountered when beginning to learn Calculus.” The most basic elementary functions include the familiar polynomial and algebraic functions, such as the n^{th} root function, in addition to the somewhat more sophisticated exponential function, the trigonometric functions, and the logarithmic function. For the purposes of these notes, we will now define the complex exponential function and two complex trigonometric functions. Definitions for the remaining basic elementary functions can be found in any book on Complex Analysis.

The basic groundwork for defining the **complex exponential function** was already put into place in Sections 2.3.1 and 2.3.2 above. In particular, we have already defined the expression $e^{i\theta}$ to mean the sum $\cos(\theta) + \sin(\theta)i$ for any real number θ . Historically, this equivalence is a special case of the more general **Euler’s formula**

$$e^{x+yi} = e^x(\cos(y) + \sin(y)i),$$

which we here take as our definition of the complex exponential function applied to any

complex number $x + yi$ for $x, y \in \mathbb{R}$.

Given this exponential function, one can then define the **complex sine function** and the **complex cosine function** as

$$\sin(z) = \frac{e^{iz} - e^{-iz}}{2i} \quad \text{and} \quad \cos(z) = \frac{e^{iz} + e^{-iz}}{2}.$$

Remarkably, these functions retain many of their familiar properties, which should be taken as a sign that the definitions — however abstract — have been well thought-out. We summarize a few of these properties as follows.

Theorem 2.3.5. *Given $z_1, z_2 \in \mathbb{C}$,*

1. $e^{z_1+z_2} = e^{z_1}e^{z_2}$ and $e^z \neq 0$ for any choice of $z \in \mathbb{C}$.
2. $\sin^2(z_1) + \cos^2(z_1) = 1$.
3. $\sin(z_1 + z_2) = \sin(z_1) \cdot \cos(z_2) + \cos(z_1) \cdot \sin(z_2)$.
4. $\cos(z_1 + z_2) = \cos(z_1) \cdot \cos(z_2) - \sin(z_1) \cdot \sin(z_2)$.

Chapter 3

The Fundamental Theorem of Algebra and Factoring Polynomials

The similarities and differences between \mathbb{R} and \mathbb{C} can be described as elegant and intriguing, but why are complex numbers important? One possible answer to this question is the **Fundamental Theorem of Algebra**. It states that every polynomial equation in one variable with complex coefficients has at least one complex solution. In other words, polynomial equations formed over \mathbb{C} can always be solved over \mathbb{C} . This amazing result has several equivalent formulations in addition to a myriad of different proofs, one of the first of which was given by the eminent mathematician Carl Gauss in his doctoral thesis.

3.1 The Fundamental Theorem of Algebra

The aim of this section is to provide a proof of the Fundamental Theorem of Algebra using concepts that should be familiar to you from your study of Calculus, and so we begin by providing an explicit formulation.

Theorem 3.1.1 (Fundamental Theorem of Algebra). *Given any positive integer $n \in \mathbb{Z}_+$ and any choice of complex numbers $a_0, a_1, \dots, a_n \in \mathbb{C}$ with $a_n \neq 0$, the polynomial equation*

$$a_n z^n + \cdots + a_1 z + a_0 = 0 \tag{3.1}$$

has at least one solution $z \in \mathbb{C}$.

This is a remarkable statement. No analogous result holds for guaranteeing that a real solution exists to Equation (3.1) if we restrict the coefficients a_0, a_1, \dots, a_n to be real numbers. E.g., there does not exist a real number x satisfying an equation as simple as $\pi x^2 + e = 0$. Similarly, the consideration of polynomial equations having integer (resp. rational) coefficients quickly forces us to consider solutions that cannot possibly be integers (resp. rational numbers). Thus, the complex numbers are special in this respect.

The statement of the Fundamental Theorem of Algebra can also be read as follows: Any non-constant complex polynomial function defined on the complex plane \mathbb{C} (when thought of as \mathbb{R}^2) has at least one root, i.e., vanishes in at least one place. It is in this form that we will provide a proof for Theorem 3.1.1.

Given how long the Fundamental Theorem of Algebra has been around, you should not be surprised that there are many proofs of it. There have even been entire books devoted solely to exploring the mathematics behind various distinct proofs. Different proofs arise from attempting to understand the statement of the theorem from the viewpoint of different branches of mathematics. This quickly leads to many non-trivial interactions with such fields of mathematics as Real and Complex Analysis, Topology, and (Modern) Abstract Algebra. The diversity of proof techniques available is yet another indication of how fundamental and deep the Fundamental Theorem of Algebra really is.

To prove the Fundamental Theorem of Algebra using Differential Calculus, we will need the **Extreme Value Theorem** for real-valued functions of two real variables, which we state without proof. In particular, we formulate this theorem in the restricted case of functions defined on the **closed disk** D of radius $R > 0$ and centered at the origin, i.e.,

$$D = \{(x_1, x_2) \in \mathbb{R}^2 \mid x_1^2 + x_2^2 \leq R^2\}.$$

Theorem 3.1.2 (Extreme Value Theorem). *Let $f : D \rightarrow \mathbb{R}$ be a continuous function on the closed disk $D \subset \mathbb{R}^2$. Then f is bounded and attains its minimum and maximum values on D . In other words, there exist points $x_m, x_M \in D$ such that*

$$f(x_m) \leq f(x) \leq f(x_M)$$

for every possible choice of point $x \in D$.

If we define a polynomial function $f : \mathbb{C} \rightarrow \mathbb{C}$ by setting $f(z) = a_n z^n + \dots + a_1 z + a_0$ as in

Equation (3.1), then note that we can regard $(x, y) \mapsto |f(x + iy)|$ as a function $\mathbb{R}^2 \rightarrow \mathbb{R}$. By a mild abuse of notation, we denote this function by $|f(\cdot)|$ or $|f|$. As it is a composition of continuous functions (polynomials and the square root), we see that $|f|$ is also continuous.

Lemma 3.1.3. *Let $f : \mathbb{C} \rightarrow \mathbb{C}$ be any polynomial function. Then there exists a point $z_0 \in \mathbb{C}$ where the function $|f|$ attains its minimum value in \mathbb{R} .*

Proof. If f is a constant polynomial function, then the statement of the Lemma is trivially true since $|f|$ attains its minimum value at every point in \mathbb{C} . So choose, e.g., $z_0 = 0$.

If f is not constant, then the degree of the polynomial defining f is at least one. In this case, we can denote f explicitly as in Equation (3.1). That is, we set

$$f(z) = a_n z^n + \cdots + a_1 z + a_0$$

with $a_n \neq 0$. Now, assume $z \neq 0$, and set $A = \max\{|a_0|, \dots, |a_{n-1}|\}$. We can obtain a lower bound for $|f(z)|$ as follows:

$$\begin{aligned} |f(z)| &= |a_n| |z|^n \left| 1 + \frac{a_{n-1}}{a_n} \frac{1}{z} + \cdots + \frac{a_0}{a_n} \frac{1}{z^n} \right| \\ &\geq |a_n| |z|^n \left(1 - \frac{A}{|a_n|} \sum_{k=1}^{\infty} \frac{1}{|z|^k} \right) = |a_n| |z|^n \left(1 - \frac{A}{|a_n|} \frac{1}{|z| - 1} \right). \end{aligned}$$

For all $z \in \mathbb{C}$ such that $|z| \geq 2$, we can further simplify this expression and obtain

$$|f(z)| \geq |a_n| |z|^n \left(1 - \frac{2A}{|a_n| |z|} \right).$$

It follows from this inequality that there is an $R > 0$ such that $|f(z)| > |f(0)|$, for all $z \in \mathbb{C}$ satisfying $|z| > R$. Let $D \subset \mathbb{R}^2$ be the disk of radius R centered at 0, and define a function $g : D \rightarrow \mathbb{R}$, by

$$g(x, y) = |f(x + iy)|.$$

Since g is continuous, we can apply Theorem 3.1.2 in order to obtain a point $(x_0, y_0) \in D$ such that g attains its minimum at (x_0, y_0) . By the choice of R we have that for $z \in \mathbb{C} \setminus D$, $|f(z)| > |g(0, 0)| \geq |g(x_0, y_0)|$. Therefore, $|f|$ attains its minimum at $z = x_0 + iy_0$. \square

We now prove the Fundamental Theorem of Algebra.

Proof of Theorem 3.1.1. For our argument, we rely on the fact that the function $|f|$ attains its minimum value by Lemma 3.1.3. Let $z_0 \in \mathbb{C}$ be a point where the minimum is attained. We will show that if $f(z_0) \neq 0$, then z_0 is *not* a minimum, thus proving by contraposition that the minimum value of $|f(z)|$ is zero. Therefore, $f(z_0) = 0$.

If $f(z_0) \neq 0$, then we can define a new function $g : \mathbb{C} \rightarrow \mathbb{C}$ by setting

$$g(z) = \frac{f(z + z_0)}{f(z_0)}, \text{ for all } z \in \mathbb{C}.$$

Note that g is a polynomial of degree n , and that the minimum of $|f|$ is attained at z_0 if and only if the minimum of $|g|$ is attained at $z = 0$. Moreover, it is clear that $g(0) = 1$.

More explicitly, g is given by a polynomial of the form

$$g(z) = b_n z^n + \cdots + b_k z^k + 1,$$

with $n \geq 1$ and $b_k \neq 0$, for some $1 \leq k \leq n$. Let $b_k = |b_k|e^{i\theta}$, and consider z of the form

$$z = r|b_k|^{-1/k} e^{i(\pi-\theta)/k}, \tag{3.2}$$

with $r > 0$. For z of this form we have

$$g(z) = 1 - r^k + r^{k+1}h(r),$$

where h is a polynomial. Then, for $r < 1$, we have by the triangle inequality that

$$|g(z)| \leq 1 - r^k + r^{k+1}|h(r)|.$$

For $r > 0$ sufficiently small we have $r|h(r)| < 1$, by the continuity of the function $rh(r)$ and the fact that it vanishes in $r = 0$. Hence

$$|g(z)| \leq 1 - r^k(1 - r|h(r)|) < 1,$$

for some z having the form in Equation (3.2) with $r \in (0, r_0)$ and $r_0 > 0$ sufficiently small. But then the minimum of the function $|g| : \mathbb{C} \rightarrow \mathbb{R}$ cannot possibly be equal to 1. \square

3.2 Factoring polynomials

In this section, we present several fundamental facts about polynomials, including an equivalent form of the Fundamental Theorem of Algebra. While these facts should be familiar to you, they nonetheless require careful formulation and proof. Before stating these results, though, we first present a review of the main concepts needed in order to more carefully work with polynomials.

Let $n \in \mathbb{Z}_+ \cup \{0\}$ be a non-negative integer, and let $a_0, a_1, \dots, a_n \in \mathbb{C}$ be complex numbers. Then we call the expression

$$p(z) = a_n z^n + \cdots + a_1 z + a_0$$

a **polynomial** in the variable z with **coefficients** a_0, a_1, \dots, a_n . If $a_n \neq 0$, then we say that $p(z)$ has **degree** n (denoted $\deg(p(z)) = n$), and we call a_n the **leading term** of $p(z)$. Moreover, if $a_n = 1$, then we call $p(z)$ a **monic polynomial**. If, however, $n = a_0 = 0$, then we call $p(z) = 0$ the **zero polynomial** and set $\deg(0) = -\infty$.

Finally, by a **root** (a.k.a. **zero**) of a polynomial $p(z)$, we mean a complex number z_0 such that, upon setting $z = z_0$, we obtain the zero polynomial $p(z_0) = 0$. Note, in particular, that every complex number is a root of the zero polynomial.

Convention dictates that

- a degree zero polynomial be called a **constant polynomial**,
- a degree one polynomial be called a **linear polynomial**,
- a degree two polynomial be called a **quadratic polynomial**,
- a degree three polynomial be called a **cubic polynomial**,
- a degree four polynomial be called a **quadric polynomial**,
- a degree five polynomial be called a **quintic polynomial**,
- and so on.

Addition and multiplication of polynomials is a direct generalization of the addition and multiplication of real numbers, and degree interacts with these operations as follows:

Lemma 3.2.1. *Let $p(z)$ and $q(z)$ be non-zero polynomials. Then*

1. $\deg(p(z) \pm q(z)) \leq \max\{\deg(p(z)), \deg(q(z))\}$
2. $\deg(p(z)q(z)) = \deg(p(z)) + \deg(q(z))$.

Theorem 3.2.2. *Given a positive integer $n \in \mathbb{Z}_+$ and any choice of $a_0, a_1, \dots, a_n \in \mathbb{C}$ with $a_n \neq 0$, define the function $f : \mathbb{C} \rightarrow \mathbb{C}$ by setting*

$$f(z) = a_n z^n + \dots + a_1 z + a_0, \forall z \in \mathbb{C}.$$

In other words, f is a polynomial function of degree n . Then

1. *given any complex number $w \in \mathbb{C}$, we have that $f(w) = 0$ if and only if there exists a polynomial function $g : \mathbb{C} \rightarrow \mathbb{C}$ of degree $n - 1$ such that*

$$f(z) = (z - w)g(z), \forall z \in \mathbb{C}.$$

2. *there are at most n distinct complex numbers w for which $f(w) = 0$. In other words, f has at most n distinct roots.*
3. *(Fundamental Theorem of Algebra, restated) there exist exactly $n + 1$ complex numbers $w_0, w_1, \dots, w_n \in \mathbb{C}$ (not necessarily distinct) such that*

$$f(z) = w_0(z - w_1)(z - w_2) \cdots (z - w_n), \forall z \in \mathbb{C}.$$

In other words, every polynomial function with coefficients over \mathbb{C} can be factored into linear factors over \mathbb{C} .

Proof.

1. Let $w \in \mathbb{C}$ be a complex number.

(“ \implies ”) Suppose that $f(w) = 0$. Then, in particular, we have that

$$a_n w^n + \dots + a_1 w + a_0 = 0.$$

Since this equation is equal to zero, it follows that, given any $z \in \mathbb{C}$,

$$\begin{aligned} f(z) &= a_n z^n + \cdots + a_1 z + a_0 - (a_n w^n + \cdots + a_1 w + a_0) \\ &= a_n(z^n - w^n) + a_{n-1}(z^{n-1} - w^{n-1}) + \cdots + a_1(z - w) \\ &= a_n(z - w) \sum_{k=0}^{n-1} z^k w^{n-1-k} + a_{n-1}(z - w) \sum_{k=0}^{n-2} z^k w^{n-2-k} + \cdots + a_1(z - w) \\ &= (z - w) \sum_{m=1}^n \left(a_m \sum_{k=0}^{m-1} z^k w^{m-1-k} \right). \end{aligned}$$

Thus, upon setting

$$g(z) = \sum_{m=1}^n \left(a_m \sum_{k=0}^{m-1} z^k w^{m-1-k} \right), \forall z \in \mathbb{C},$$

we have constructed a degree $n - 1$ polynomial function g such that

$$f(z) = (z - w)g(z), \forall z \in \mathbb{C}.$$

(“ \Leftarrow ”) Suppose that there exists a polynomial function $g : \mathbb{C} \rightarrow \mathbb{C}$ of degree $n - 1$ such that

$$f(z) = (z - w)g(z), \forall z \in \mathbb{C}.$$

Then it follows that $f(w) = (w - w)g(w) = 0$, as desired.

2. We use induction on the degree n of f .

If $n = 1$, then $f(z) = a_1 z + a_0$ is a linear function, and the equation $a_1 z + a_0 = 0$ has the unique solution $z = -a_0/a_1$. Thus, the result holds for $n = 1$.

Now, suppose that the result holds for $n - 1$. In other words, assume that every polynomial function of degree $n - 1$ has at most $n - 1$ roots. Using the Fundamental Theorem of Algebra (Theorem 3.1.1), we know that there exists a complex number $w \in \mathbb{C}$ such that $f(w) = 0$. Moreover, from Part 1 above, we know that there exists a polynomial function g of degree $n - 1$ such that

$$f(z) = (z - w)g(z), \forall z \in \mathbb{C}.$$

It then follows by the induction hypothesis that g has at most $n - 1$ distinct roots, and so f must have at most n distinct roots.

3. This part follows from an induction argument on n that is virtually identical to that of Part 2, and so the proof is left as an exercise to the reader.

□

Exercises for Chapter 3

Computational Exercises

- Let $n \in \mathbb{Z}_+$ be a positive integer, let $w_0, w_1, \dots, w_n \in \mathbb{C}$ be distinct complex numbers, and let $z_0, z_1, \dots, z_n \in \mathbb{C}$ be any complex numbers. Then one can prove that there is a unique polynomial $p(z)$ of degree at most n such that, for each $k \in \{0, 1, \dots, n\}$, $p(w_k) = z_k$.
 - Find the unique polynomial of degree at most 2 that satisfies $p(0) = 0$, $p(1) = 1$, and $p(2) = 2$.
 - Can your result in Part (a) be easily generalized to find the unique polynomial of degree at most n satisfying $p(0) = 0$, $p(1) = 1$, \dots , $p(n) = n$?
- Given any complex number $\alpha \in \mathbb{C}$, show that the coefficients of the polynomial

$$(z - \alpha)(z - \bar{\alpha})$$

are real numbers.

Proof-Writing Exercises

- Let $m, n \in \mathbb{Z}_+$ be positive integers with $m \leq n$. Prove that there is a degree n polynomial $p(z)$ with complex coefficients such that $p(z)$ has exactly m distinct roots.
- Given a polynomial $p(z) = a_n z^n + \dots + a_1 z + a_0$ with complex coefficients, define the **conjugate** of $p(z)$ to be the new polynomial

$$\bar{p}(z) = \bar{a}_n z^n + \dots + \bar{a}_1 z + \bar{a}_0.$$

- Prove that $\overline{p(z)} = \bar{p}(\bar{z})$.
- Prove that $p(z)$ has real coefficients if and only if $\bar{p}(z) = p(z)$.
- Given polynomials $p(z)$, $q(z)$, and $r(z)$ such that $p(z) = q(z)r(z)$, prove that $\bar{p}(z) = \bar{q}(z)\bar{r}(z)$.

3. Let $p(z)$ be a polynomial with real coefficients, and let $\alpha \in \mathbb{C}$ be a complex number. Prove that $p(\alpha) = 0$ if and only $p(\bar{\alpha}) = 0$.

Chapter 4

Vector Spaces

Now that important background has been developed, we are finally ready to begin the study of Linear Algebra by introducing vector spaces. To get a sense of how important vector spaces are, try flipping to a random page in these notes. There is very little chance that you will flip to a page that does not have at least one vector space on it.

4.1 Definition of vector spaces

As we have seen in Chapter 1, a vector space is a set V with two operations defined upon it: addition of vectors and multiplication by scalars. These operations must satisfy certain properties, which we are about to discuss in more detail. The scalars are taken from a field \mathbb{F} , where for the remainder of these notes \mathbb{F} stands either for the real numbers \mathbb{R} or for the complex numbers \mathbb{C} . The sets \mathbb{R} and \mathbb{C} are examples of fields. The abstract definition of a field along with further examples can be found in Appendix B.

Vector addition can be thought of as a function $+: V \times V \rightarrow V$ that maps two vectors $u, v \in V$ to their sum $u + v \in V$. **Scalar multiplication** can similarly be described as a function $\mathbb{F} \times V \rightarrow V$ that maps a scalar $a \in \mathbb{F}$ and a vector $v \in V$ to a new vector $av \in V$. (More information on these kinds of functions, also known as binary operations, can be found in Appendix B.) It is when we place the right conditions on these operations that we turn V into a vector space.

Definition 4.1.1. A **vector space** over \mathbb{F} is a set V together with the operations of addition $V \times V \rightarrow V$ and scalar multiplication $\mathbb{F} \times V \rightarrow V$ satisfying each of the following properties.

1. **Commutativity:** $u + v = v + u$ for all $u, v \in V$;
2. **Associativity:** $(u + v) + w = u + (v + w)$ and $(ab)v = a(bv)$ for all $u, v, w \in V$ and $a, b \in \mathbb{F}$;
3. **Additive identity:** There exists an element $0 \in V$ such that $0 + v = v$ for all $v \in V$;
4. **Additive inverse:** For every $v \in V$, there exists an element $w \in V$ such that $v + w = 0$;
5. **Multiplicative identity:** $1v = v$ for all $v \in V$;
6. **Distributivity:** $a(u + v) = au + av$ and $(a + b)u = au + bu$ for all $u, v \in V$ and $a, b \in \mathbb{F}$.

A vector space over \mathbb{R} is usually called a **real vector space**, and a vector space over \mathbb{C} is similarly called a **complex vector space**. The elements $v \in V$ of a vector space are called **vectors**.

Even though Definition 4.1.1 may appear to be an extremely abstract definition, vector spaces are fundamental objects in mathematics because there are countless examples of them. You should expect to see many examples of vector spaces throughout your mathematical life.

Example 4.1.2. Consider the set \mathbb{F}^n of all n -tuples with elements in \mathbb{F} . This is a vector space with addition and scalar multiplication defined componentwise. That is, for $u = (u_1, u_2, \dots, u_n)$, $v = (v_1, v_2, \dots, v_n) \in \mathbb{F}^n$ and $a \in \mathbb{F}$, we define

$$\begin{aligned} u + v &= (u_1 + v_1, u_2 + v_2, \dots, u_n + v_n), \\ au &= (au_1, au_2, \dots, au_n). \end{aligned}$$

It is easy to check that each property of Definition 4.1.1 is satisfied. In particular, the additive identity $0 = (0, 0, \dots, 0)$, and the additive inverse of u is $-u = (-u_1, -u_2, \dots, -u_n)$.

An important case of Example 4.1.2 is \mathbb{R}^n , especially when $n = 2$ or $n = 3$. We have already seen in Chapter 1 that there is a geometric interpretation for elements of \mathbb{R}^2 and \mathbb{R}^3 as points in the Euclidean plane and Euclidean space, respectively.

Example 4.1.3. Let \mathbb{F}^∞ be the set of all sequences over \mathbb{F} , i.e.,

$$\mathbb{F}^\infty = \{(u_1, u_2, \dots) \mid u_j \in \mathbb{F} \text{ for } j = 1, 2, \dots\}.$$

Addition and scalar multiplication are defined as expected, namely,

$$\begin{aligned}(u_1, u_2, \dots) + (v_1, v_2, \dots) &= (u_1 + v_1, u_2 + v_2, \dots), \\ a(u_1, u_2, \dots) &= (au_1, au_2, \dots).\end{aligned}$$

You should verify that \mathbb{F}^∞ becomes a vector space under these operations.

Example 4.1.4. Verify that $V = \{0\}$ is a vector space! (Here, 0 denotes the zero vector in any vector space.)

Example 4.1.5. Let $\mathbb{F}[z]$ be the set of all polynomial functions $p : \mathbb{F} \rightarrow \mathbb{F}$ with coefficients in \mathbb{F} . As discussed in Chapter 3, $p(z)$ is a polynomial if there exist $a_0, a_1, \dots, a_n \in \mathbb{F}$ such that

$$p(z) = a_n z^n + a_{n-1} z^{n-1} + \dots + a_1 z + a_0. \quad (4.1)$$

Addition and scalar multiplication on $\mathbb{F}[z]$ are defined pointwise as

$$\begin{aligned}(p + q)(z) &= p(z) + q(z), \\ (ap)(z) &= ap(z),\end{aligned}$$

where $p, q \in \mathbb{F}[z]$ and $a \in \mathbb{F}$. For example, if $p(z) = 5z + 1$ and $q(z) = 2z^2 + z + 1$, then $(p + q)(z) = 2z^2 + 6z + 2$ and $(2p)(z) = 10z + 2$.

It can be easily verified that, under these operations, $\mathbb{F}[z]$ forms a vector space over \mathbb{F} . The additive identity in this case is the zero polynomial, for which all coefficients are equal to zero, and the additive inverse of $p(z)$ in Equation (4.1) is $-p(z) = -a_n z^n - a_{n-1} z^{n-1} - \dots - a_1 z - a_0$.

Example 4.1.6. Extending Example 4.1.5, let $D \subset \mathbb{R}$ be a subset of \mathbb{R} , and let $\mathcal{C}(D)$ denote the set of all continuous functions with domain D and codomain \mathbb{R} . Then, under the same operations of pointwise addition and scalar multiplication, one can show that $\mathcal{C}(D)$ also forms a vector space.

4.2 Elementary properties of vector spaces

We are going to prove several important, yet simple, properties of vector spaces. From now on, V will denote a vector space over \mathbb{F} .

Proposition 4.2.1. *Every vector space has a unique additive identity.*

Proof. Suppose there are two additive identities 0 and $0'$. Then

$$0' = 0 + 0' = 0,$$

where the first equality holds since 0 is an identity and the second equality holds since $0'$ is an identity. Hence $0 = 0'$, proving that the additive identity is unique. \square

Proposition 4.2.2. *Every $v \in V$ has a unique additive inverse.*

Proof. Suppose w and w' are additive inverses of v so that $v + w = 0$ and $v + w' = 0$. Then

$$w = w + 0 = w + (v + w') = (w + v) + w' = 0 + w' = w'.$$

Hence $w = w'$, as desired. \square

Since the additive inverse of v is unique, as we have just shown, it will from now on be denoted by $-v$. We also define $w - v$ to mean $w + (-v)$. We will, in fact, show in Proposition 4.2.5 below that $-v = -1v$.

Proposition 4.2.3. $0v = 0$ for all $v \in V$.

Note that the 0 on the left-hand side in Proposition 4.2.3 is a scalar, whereas the 0 on the right-hand side is a vector.

Proof. For $v \in V$, we have by distributivity that

$$0v = (0 + 0)v = 0v + 0v.$$

Adding the additive inverse of $0v$ to both sides, we obtain

$$0 = 0v - 0v = (0v + 0v) - 0v = 0v.$$

\square

Proposition 4.2.4. $a0 = 0$ for every $a \in \mathbb{F}$.

Proof. As in the proof of Proposition 4.2.3, if $a \in \mathbb{F}$, then

$$a0 = a(0 + 0) = a0 + a0.$$

Adding the additive inverse of $a0$ to both sides, we obtain $0 = a0$, as desired. \square

Proposition 4.2.5. $(-1)v = -v$ for every $v \in V$.

Proof. For $v \in V$, we have

$$v + (-1)v = 1v + (-1)v = (1 + (-1))v = 0v = 0,$$

which shows that $(-1)v$ is the additive inverse $-v$ of v . \square

4.3 Subspaces

As mentioned in the last section, there are countless examples of vector spaces. One particularly important source of new vector spaces comes from looking at subsets of a set that is already known to be a vector space.

Definition 4.3.1. Let V be a vector space over \mathbb{F} , and let $U \subset V$ be a subset of V . Then we call U a **subspace** of V if U is a vector space over \mathbb{F} under the same operations that make V into a vector space over \mathbb{F} .

To check that a subset $U \subset V$ is a subspace, it suffices to check only a few of the conditions of a vector space.

Lemma 4.3.2. *Let $U \subset V$ be a subset of a vector space V over \mathbb{F} . Then U is a subspace of V if and only if the following three conditions hold.*

1. **additive identity:** $0 \in U$;
2. **closure under addition:** $u, v \in U$ implies $u + v \in U$;
3. **closure under scalar multiplication:** $a \in \mathbb{F}$, $u \in U$ implies that $au \in U$.

Proof. Condition 1 implies that the additive identity exists. Condition 2 implies that vector addition is well-defined and, Condition 3 ensures that scalar multiplication is well-defined. All other conditions for a vector space are inherited from V since addition and scalar multiplication for elements in U are the same when viewed as elements in either U or V . \square

Remark 4.3.3. Note that if we require $U \subset V$ to be a *nonempty* subset of V , then condition 1 of Lemma 4.3.2 already follows from condition 3 since $0u = 0$ for $u \in U$.

Example 4.3.4. In every vector space V , the subsets $\{0\}$ and V are easily verified to be subspaces. We call these the **trivial subspaces** of V .

Example 4.3.5. $\{(x_1, 0) \mid x_1 \in \mathbb{R}\}$ is a subspace of \mathbb{R}^2 .

Example 4.3.6. $U = \{(x_1, x_2, x_3) \in \mathbb{F}^3 \mid x_1 + 2x_2 = 0\}$ is a subspace of \mathbb{F}^3 . To see this, we need to check the three conditions of Lemma 4.3.2.

The zero vector $(0, 0, 0) \in \mathbb{F}^3$ is in U since it satisfies the condition $x_1 + 2x_2 = 0$. To show that U is closed under addition, take two vectors $v = (v_1, v_2, v_3)$ and $u = (u_1, u_2, u_3)$. Then, by the definition of U , we have $v_1 + 2v_2 = 0$ and $u_1 + 2u_2 = 0$. Adding these two equations, it is not hard to see that the vector $v + u = (v_1 + u_1, v_2 + u_2, v_3 + u_3)$ satisfies $(v_1 + u_1) + 2(v_2 + u_2) = 0$. Hence $v + u \in U$. Similarly, to show closure under scalar multiplication, take $u = (u_1, u_2, u_3) \in U$ and $a \in \mathbb{F}$. Then $au = (au_1, au_2, au_3)$ satisfies the equation $au_1 + 2au_2 = a(u_1 + 2u_2) = 0$, and so $au \in U$.

Example 4.3.7. $U = \{p \in \mathbb{F}[z] \mid p(3) = 0\}$ is a subspace of $\mathbb{F}[z]$. Again, to check this, we need to verify the three conditions of Lemma 4.3.2.

Certainly the zero polynomial $p(z) = 0z^n + 0z^{n-1} + \dots + 0z + 0$ is in U since $p(z)$ evaluated at 3 is 0. If $f(z), g(z) \in U$, then $f(3) = g(3) = 0$ so that $(f+g)(3) = f(3) + g(3) = 0 + 0 = 0$. Hence $f + g \in U$, which proves closure under addition. Similarly, $(af)(3) = af(3) = a0 = 0$ for any $a \in \mathbb{F}$, which proves closure under scalar multiplication.

Example 4.3.8. As in Example 4.1.6, let $D \subset \mathbb{R}$ be a subset of \mathbb{R} , and let $\mathcal{C}^\infty(D)$ denote the set of all smooth (a.k.a. continuously differentiable) functions with domain D and codomain \mathbb{R} . Then, under the same operations of pointwise addition and scalar multiplication, one can show that $\mathcal{C}^\infty(D)$ is a subspace of $\mathcal{C}(D)$.

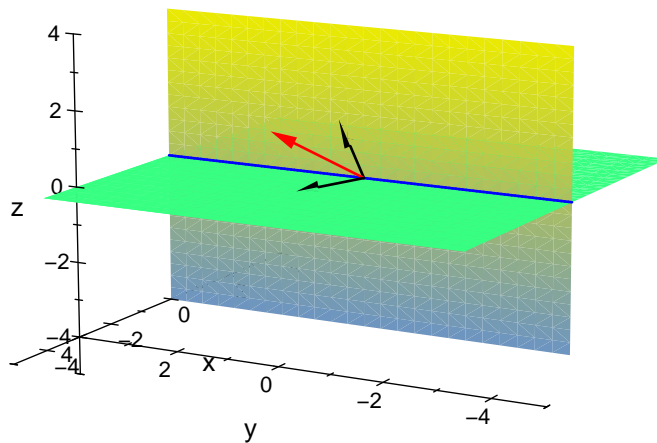


Figure 4.1: The intersection $U \cap U'$ of two subspaces is a subspace

Example 4.3.9. The subspaces of \mathbb{R}^2 consist of $\{0\}$, all lines through the origin, and \mathbb{R}^2 itself. The subspaces of \mathbb{R}^3 are $\{0\}$, all lines through the origin, all planes through the origin, and \mathbb{R}^3 . In fact, these exhaust all subspaces of \mathbb{R}^2 and \mathbb{R}^3 , respectively. To prove this, we will need further tools such as the notion of bases and dimensions to be discussed soon. In particular, this shows that lines and planes that do not pass through the origin are not subspaces (which is not so hard to show!).

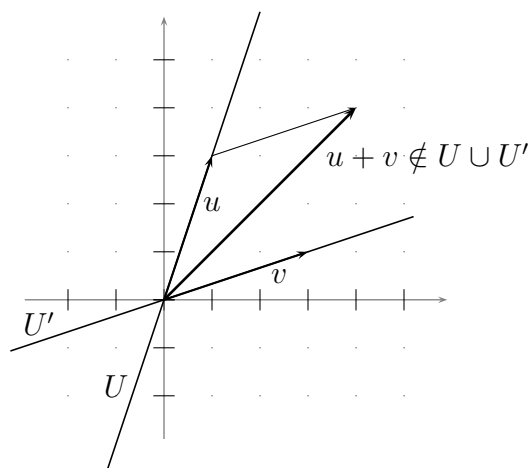


Figure 4.2: The union $U \cup U'$ of two subspaces is not necessarily a subspace

Note that if U and U' are subspaces of V , then their intersection $U \cap U'$ is also a subspace (see Proof-writing Exercise 2 on page 47 and Figure 4.1). However, the union of two subspaces is not necessarily a subspace. Think, for example, of the union of two lines in \mathbb{R}^2 , as in Figure 4.2.

4.4 Sums and direct sums

Throughout this section, V is a vector space over \mathbb{F} , and $U_1, U_2 \subset V$ denote subspaces.

Definition 4.4.1. Let $U_1, U_2 \subset V$ be subspaces of V . Define the **(subspace) sum** of U_1

and U_2 to be the set

$$U_1 + U_2 = \{u_1 + u_2 \mid u_1 \in U_1, u_2 \in U_2\}.$$

Check as an exercise that $U_1 + U_2$ is a subspace of V . In fact, $U_1 + U_2$ is the smallest subspace of V that contains both U_1 and U_2 .

Example 4.4.2. Let

$$\begin{aligned} U_1 &= \{(x, 0, 0) \in \mathbb{F}^3 \mid x \in \mathbb{F}\}, \\ U_2 &= \{(0, y, 0) \in \mathbb{F}^3 \mid y \in \mathbb{F}\}. \end{aligned}$$

Then

$$U_1 + U_2 = \{(x, y, 0) \in \mathbb{F}^3 \mid x, y \in \mathbb{F}\}. \quad (4.2)$$

If, alternatively, $U_2 = \{(y, y, 0) \in \mathbb{F}^3 \mid y \in \mathbb{F}\}$, then Equation (4.2) still holds.

If $U = U_1 + U_2$, then, for any $u \in U$, there exist $u_1 \in U_1$ and $u_2 \in U_2$ such that $u = u_1 + u_2$. If it so happens that u can be *uniquely* written as $u_1 + u_2$, then U is called the **direct sum** of U_1 and U_2 .

Definition 4.4.3. Suppose every $u \in U$ can be uniquely written as $u = u_1 + u_2$ for $u_1 \in U_1$ and $u_2 \in U_2$. Then we use

$$U = U_1 \oplus U_2$$

to denote the **direct sum** of U_1 and U_2 .

Example 4.4.4. Let

$$U_1 = \{(x, y, 0) \in \mathbb{R}^3 \mid x, y \in \mathbb{R}\},$$

$$U_2 = \{(0, 0, z) \in \mathbb{R}^3 \mid z \in \mathbb{R}\}.$$

Then $\mathbb{R}^3 = U_1 \oplus U_2$. However, if instead

$$U_2 = \{(0, w, z) \mid w, z \in \mathbb{R}\},$$

then $\mathbb{R}^3 = U_1 + U_2$ but is not the direct sum of U_1 and U_2 .

Example 4.4.5. Let

$$U_1 = \{p \in \mathbb{F}[z] \mid p(z) = a_0 + a_2z^2 + \cdots + a_{2m}z^{2m}\},$$

$$U_2 = \{p \in \mathbb{F}[z] \mid p(z) = a_1z + a_3z^3 + \cdots + a_{2m+1}z^{2m+1}\}.$$

Then $\mathbb{F}[z] = U_1 \oplus U_2$.

Proposition 4.4.6. *Let $U_1, U_2 \subset V$ be subspaces. Then $V = U_1 \oplus U_2$ if and only if the following two conditions hold:*

1. $V = U_1 + U_2$;
2. If $0 = u_1 + u_2$ with $u_1 \in U_1$ and $u_2 \in U_2$, then $u_1 = u_2 = 0$.

Proof.

(“ \implies ”) Suppose $V = U_1 \oplus U_2$. Then Condition 1 holds by definition. Certainly $0 = 0 + 0$, and, since by uniqueness this is the only way to write $0 \in V$, we have $u_1 = u_2 = 0$.

(“ \impliedby ”) Suppose Conditions 1 and 2 hold. By Condition 1, we have that, for all $v \in V$, there exist $u_1 \in U_1$ and $u_2 \in U_2$ such that $v = u_1 + u_2$. Suppose $v = w_1 + w_2$ with $w_1 \in U_1$ and $w_2 \in U_2$. Subtracting the two equations, we obtain

$$0 = (u_1 - w_1) + (u_2 - w_2),$$

where $u_1 - w_1 \in U_1$ and $u_2 - w_2 \in U_2$. By Condition 2, this implies $u_1 - w_1 = 0$ and $u_2 - w_2 = 0$, or equivalently $u_1 = w_1$ and $u_2 = w_2$, as desired. \square

Proposition 4.4.7. *Let $U_1, U_2 \subset V$ be subspaces. Then $V = U_1 \oplus U_2$ if and only if the following two conditions hold:*

1. $V = U_1 + U_2$;
2. $U_1 \cap U_2 = \{0\}$.

Proof.

(“ \implies ”) Suppose $V = U_1 \oplus U_2$. Then Condition 1 holds by definition. If $u \in U_1 \cap U_2$, then $0 = u + (-u)$ with $u \in U_1$ and $-u \in U_2$ (why?). By Proposition 4.4.6, we have $u = 0$ and $-u = 0$ so that $U_1 \cap U_2 = \{0\}$.

(“ \impliedby ”) Suppose Conditions 1 and 2 hold. To prove that $V = U_1 \oplus U_2$ holds, suppose that

$$0 = u_1 + u_2, \quad \text{where } u_1 \in U_1 \text{ and } u_2 \in U_2. \quad (4.3)$$

By Proposition 4.4.6, it suffices to show that $u_1 = u_2 = 0$. Equation (4.3) implies that $u_1 = -u_2 \in U_2$. Hence $u_1 \in U_1 \cap U_2$, which in turn implies that $u_1 = 0$. It then follows that $u_2 = 0$ as well. \square

Everything in this section can be generalized to m subspaces U_1, U_2, \dots, U_m , with the notable exception of Proposition 4.4.7. To see, this consider the following example.

Example 4.4.8. Let

$$\begin{aligned} U_1 &= \{(x, y, 0) \in \mathbb{F}^3 \mid x, y \in \mathbb{F}\}, \\ U_2 &= \{(0, 0, z) \in \mathbb{F}^3 \mid z \in \mathbb{F}\}, \\ U_3 &= \{(0, y, y) \in \mathbb{F}^3 \mid y \in \mathbb{F}\}. \end{aligned}$$

Then certainly $\mathbb{F}^3 = U_1 + U_2 + U_3$, but $\mathbb{F}^3 \neq U_1 \oplus U_2 \oplus U_3$ since, for example,

$$(0, 0, 0) = (0, 1, 0) + (0, 0, 1) + (0, -1, -1).$$

But $U_1 \cap U_2 = U_1 \cap U_3 = U_2 \cap U_3 = \{0\}$ so that the analog of Proposition 4.4.7 does not hold.

Exercises for Chapter 4

Computational Exercises

1. For each of the following sets, either show that the set is a vector space or explain why it is not a vector space.
 - (a) The set \mathbb{R} of real numbers under the usual operations of addition and multiplication.
 - (b) The set $\{(x, 0) \mid x \in \mathbb{R}\}$ under the usual operations of addition and multiplication on \mathbb{R}^2 .
 - (c) The set $\{(x, 1) \mid x \in \mathbb{R}\}$ under the usual operations of addition and multiplication on \mathbb{R}^2 .
 - (d) The set $\{(x, 0) \mid x \in \mathbb{R}, x \geq 0\}$ under the usual operations of addition and multiplication on \mathbb{R}^2 .
 - (e) The set $\{(x, 1) \mid x \in \mathbb{R}, x \geq 0\}$ under the usual operations of addition and multiplication on \mathbb{R}^2 .
 - (f) The set $\left\{ \begin{bmatrix} a & a+b \\ a+b & a \end{bmatrix} \mid a, b \in \mathbb{R} \right\}$ under the usual operations of addition and multiplication on $\mathbb{R}^{2 \times 2}$.
 - (g) The set $\left\{ \begin{bmatrix} a & a+b+1 \\ a+b & a \end{bmatrix} \mid a, b \in \mathbb{R} \right\}$ under the usual operations of addition and multiplication on $\mathbb{R}^{2 \times 2}$.

Chapter 5

Span and Bases

Intuition probably tells you that the plane \mathbb{R}^2 is of dimension two and that the space we live in \mathbb{R}^3 is of dimension three. You have probably also learned in physics that space-time has dimension four and that string theories are models that can live in ten dimensions. In this chapter we will give a mathematical definition of the dimension of a vector space. For this we will first need the notions of linear span, linear independence, and the basis of a vector space.

5.1 Linear span

As before, let V denote a vector space over \mathbb{F} . Given vectors $v_1, v_2, \dots, v_m \in V$, a vector $v \in V$ is a **linear combination** of (v_1, \dots, v_m) if there exist scalars $a_1, \dots, a_m \in \mathbb{F}$ such that

$$v = a_1v_1 + a_2v_2 + \cdots + a_mv_m.$$

Definition 5.1.1. The **linear span** (or simply **span**) of (v_1, \dots, v_m) is defined as

$$\text{span}(v_1, \dots, v_m) := \{a_1v_1 + \cdots + a_mv_m \mid a_1, \dots, a_m \in \mathbb{F}\}.$$

Lemma 5.1.2. *Let V be a vector space and $v_1, v_2, \dots, v_m \in V$. Then*

1. $v_j \in \text{span}(v_1, v_2, \dots, v_m)$.
2. $\text{span}(v_1, v_2, \dots, v_m)$ is a subspace of V .

3. If $U \subset V$ is a subspace such that $v_1, v_2, \dots, v_m \in U$, then $\text{span}(v_1, v_2, \dots, v_m) \subset U$.

Proof. Property 1 is obvious. For Property 2, note that $0 \in \text{span}(v_1, v_2, \dots, v_m)$ and that $\text{span}(v_1, v_2, \dots, v_m)$ is closed under addition and scalar multiplication. For Property 3, note that a subspace U of a vector space V is closed under addition and scalar multiplication. Hence, if $v_1, \dots, v_m \in U$, then any linear combination $a_1v_1 + \dots + a_mv_m$ must also be an element of U . \square

Lemma 5.1.2 implies that $\text{span}(v_1, v_2, \dots, v_m)$ is the smallest subspace of V containing each of v_1, v_2, \dots, v_m .

Definition 5.1.3. If $\text{span}(v_1, \dots, v_m) = V$, then we say that (v_1, \dots, v_m) **spans** V and we call V **finite-dimensional**. A vector space that is not finite-dimensional is called **infinite-dimensional**.

Example 5.1.4. The vectors $e_1 = (1, 0, \dots, 0)$, $e_2 = (0, 1, 0, \dots, 0)$, \dots , $e_n = (0, \dots, 0, 1)$ span \mathbb{F}^n . Hence \mathbb{F}^n is finite-dimensional.

Example 5.1.5. The vectors $v_1 = (1, 1, 0)$ and $v_2 = (1, -1, 0)$ span a subspace of \mathbb{R}^3 . More precisely, if we write the vectors in \mathbb{R}^3 as 3-tuples of the form (x, y, z) , then $\text{span}(v_1, v_2)$ is the xy -plane in \mathbb{R}^3 .

Example 5.1.6. Recall that if $p(z) = a_mz^m + a_{m-1}z^{m-1} + \dots + a_1z + a_0 \in \mathbb{F}[z]$ is a polynomial with coefficients in \mathbb{F} such that $a_m \neq 0$, then we say that $p(z)$ has **degree** m . By convention, the degree of the zero polynomial $p(z) = 0$ is $-\infty$. We denote the degree of $p(z)$ by $\deg(p(z))$. Define

$$\mathbb{F}_m[z] = \text{set of all polynomials in } \mathbb{F}[z] \text{ of degree at most } m.$$

Then $\mathbb{F}_m[z] \subset \mathbb{F}[z]$ is a subspace since $\mathbb{F}_m[z]$ contains the zero polynomial and is closed under addition and scalar multiplication. In fact, $\mathbb{F}_m[z]$ is a finite-dimensional subspace of $\mathbb{F}[z]$ since

$$\mathbb{F}_m[z] = \text{span}(1, z, z^2, \dots, z^m).$$

At the same time, though, note that $\mathbb{F}[z]$ itself is infinite-dimensional. To see this, assume the contrary, namely that

$$\mathbb{F}[z] = \text{span}(p_1(z), \dots, p_k(z))$$

for a finite set of k polynomials $p_1(z), \dots, p_k(z)$. Let $m = \max(\deg p_1(z), \dots, \deg p_k(z))$. Then $z^{m+1} \in \mathbb{F}[z]$, but $z^{m+1} \notin \text{span}(p_1(z), \dots, p_k(z))$.

5.2 Linear independence

We are now going to define the notion of linear independence of a list of vectors. This concept will be extremely important in the sections that follow, and especially when we introduce bases and the dimension of a vector space.

Definition 5.2.1. A list of vectors (v_1, \dots, v_m) is called **linearly independent** if the only solution for $a_1, \dots, a_m \in \mathbb{F}$ to the equation

$$a_1v_1 + \cdots + a_mv_m = 0$$

is $a_1 = \cdots = a_m = 0$. In other words, the zero vector can only trivially be written as a linear combination of (v_1, \dots, v_m) .

Definition 5.2.2. A list of vectors (v_1, \dots, v_m) is called **linearly dependent** if it is not linearly independent. That is, (v_1, \dots, v_m) is linear dependent if there exist $a_1, \dots, a_m \in \mathbb{F}$, not all zero, such that

$$a_1v_1 + \cdots + a_mv_m = 0.$$

Example 5.2.3. The vectors (e_1, \dots, e_m) of Example 5.1.4 are linearly independent. To see this, note that the only solution to the vector equation

$$0 = a_1e_1 + \cdots + a_me_m = (a_1, \dots, a_m)$$

is $a_1 = \cdots = a_m = 0$. Alternatively, we can reinterpret this vector equation as the homogeneous linear system

$$\left. \begin{array}{rcl} a_1 & & = 0 \\ a_2 & & = 0 \\ & \ddots & \vdots \\ & & a_m = 0 \end{array} \right\},$$

which clearly has only the trivial solution. (See Section 12.3.2 for the appropriate definitions.)

Example 5.2.4. The vectors $v_1 = (1, 1, 1)$, $v_2 = (0, 1, -1)$, and $v_3 = (1, 2, 0)$ are linearly

dependent. To see this, we need to consider the vector equation

$$\begin{aligned} a_1v_1 + a_2v_2 + a_3v_3 &= a_1(1, 1, 1) + a_2(0, 1, -1) + a_3(1, 2, 0) \\ &= (a_1 + a_3, a_1 + a_2 + 2a_3, a_1 - a_2) = (0, 0, 0). \end{aligned}$$

Solving for a_1, a_2 , and a_3 , we see, for example, that $(a_1, a_2, a_3) = (1, 1, -1)$ is a nonzero solution. Alternatively, we can reinterpret this vector equation as the homogeneous linear system

$$\left. \begin{array}{rcl} a_1 & + & a_3 = 0 \\ a_1 + a_2 + 2a_3 & = & 0 \\ a_1 - a_2 & = & 0 \end{array} \right\}.$$

Using the techniques of Section 12.3, we see that solving this linear system is equivalent to solving the following linear system:

$$\left. \begin{array}{rcl} a_1 & + & a_3 = 0 \\ a_2 + a_3 & = & 0 \end{array} \right\}.$$

Note that this new linear system clearly has infinitely many solutions. In particular, the set of all solutions is given by

$$N = \{(a_1, a_2, a_3) \in \mathbb{F}^n \mid a_1 = a_2 = -a_3\} = \text{span}((1, 1, -1)).$$

Example 5.2.5. The vectors $(1, z, \dots, z^m)$ in the vector space $\mathbb{F}_m[z]$ are linearly independent. Requiring that

$$a_01 + a_1z + \dots + a_mz^m = 0$$

means that the polynomial on the left should be zero for all $z \in \mathbb{F}$. This is only possible for $a_0 = a_1 = \dots = a_m = 0$.

An important consequence of the notion of linear independence is the fact that any vector in the span of a given list of linearly independent vectors can be uniquely written as a linear combination.

Lemma 5.2.6. *The list of vectors (v_1, \dots, v_m) is linearly independent if and only if every $v \in \text{span}(v_1, \dots, v_m)$ can be uniquely written as a linear combination of (v_1, \dots, v_m) .*

Proof.

(“ \implies ”) Assume that (v_1, \dots, v_m) is a linearly independent list of vectors. Suppose there are two ways of writing $v \in \text{span}(v_1, \dots, v_m)$ as a linear combination of the v_i :

$$v = a_1v_1 + \cdots + a_mv_m,$$

$$v = a'_1v_1 + \cdots + a'_mv_m.$$

Subtracting the two equations yields $0 = (a_1 - a'_1)v_1 + \cdots + (a_m - a'_m)v_m$. Since (v_1, \dots, v_m) is linearly independent, the only solution to this equation is $a_1 - a'_1 = 0, \dots, a_m - a'_m = 0$, or equivalently $a_1 = a'_1, \dots, a_m = a'_m$.

(“ \impliedby ”) Now assume that, for every $v \in \text{span}(v_1, \dots, v_m)$, there are unique $a_1, \dots, a_m \in \mathbb{F}$ such that

$$v = a_1v_1 + \cdots + a_mv_m.$$

This implies, in particular, that the only way the zero vector $v = 0$ can be written as a linear combination of v_1, \dots, v_m is with $a_1 = \cdots = a_m = 0$. This shows that (v_1, \dots, v_m) are linearly independent. \square

It is clear that if (v_1, \dots, v_m) is a list of linearly independent vectors, then the list (v_1, \dots, v_{m-1}) is also linearly independent.

For the next lemma, we introduce the following notation: If we want to drop a vector v_j from a given list (v_1, \dots, v_m) of vectors, then we indicate the dropped vector by a hat. I.e., we write

$$(v_1, \dots, \hat{v}_j, \dots, v_m) = (v_1, \dots, v_{j-1}, v_{j+1}, \dots, v_m).$$

Lemma 5.2.7 (Linear Dependence Lemma). *If (v_1, \dots, v_m) is linearly dependent and $v_1 \neq 0$, then there exists an index $j \in \{2, \dots, m\}$ such that the following two conditions hold.*

1. $v_j \in \text{span}(v_1, \dots, v_{j-1})$.
2. If v_j is removed from (v_1, \dots, v_m) , then $\text{span}(v_1, \dots, \hat{v}_j, \dots, v_m) = \text{span}(v_1, \dots, v_m)$.

Proof. Since (v_1, \dots, v_m) is linearly dependent there exist $a_1, \dots, a_m \in \mathbb{F}$ not all zero such that $a_1v_1 + \cdots + a_mv_m = 0$. Since by assumption $v_1 \neq 0$, not all of a_2, \dots, a_m can be zero.

Let $j \in \{2, \dots, m\}$ be largest such that $a_j \neq 0$. Then we have

$$v_j = -\frac{a_1}{a_j}v_1 - \dots - \frac{a_{j-1}}{a_j}v_{j-1}, \quad (5.1)$$

which implies Part 1.

Let $v \in \text{span}(v_1, \dots, v_m)$. This means, by definition, that there exist scalars $b_1, \dots, b_m \in \mathbb{F}$ such that

$$v = b_1v_1 + \dots + b_mv_m.$$

The vector v_j that we determined in Part 1 can be replaced by Equation (5.1) so that v is written as a linear combination of $(v_1, \dots, \hat{v}_j, \dots, v_m)$. Hence, $\text{span}(v_1, \dots, \hat{v}_j, \dots, v_m) = \text{span}(v_1, \dots, v_m)$. \square

Example 5.2.8. The list $(v_1, v_2, v_3) = ((1, 1), (1, 2), (1, 0))$ of vectors spans \mathbb{R}^2 . To see this, take any vector $v = (x, y) \in \mathbb{R}^2$. We want to show that v can be written as a linear combination of $(1, 1), (1, 2), (1, 0)$, i.e., that there exist scalars $a_1, a_2, a_3 \in \mathbb{F}$ such that

$$v = a_1(1, 1) + a_2(1, 2) + a_3(1, 0),$$

or equivalently that

$$(x, y) = (a_1 + a_2 + a_3, a_1 + 2a_2).$$

Clearly $a_1 = y$, $a_2 = 0$, and $a_3 = x - y$ form a solution for any choice of $x, y \in \mathbb{R}$, and so $\mathbb{R}^2 = \text{span}((1, 1), (1, 2), (1, 0))$. However, note that

$$2(1, 1) - (1, 2) - (1, 0) = (0, 0), \quad (5.2)$$

which shows that the list $((1, 1), (1, 2), (1, 0))$ is linearly dependent. The Linear Dependence Lemma 5.2.7 thus states that one of the vectors can be dropped from $((1, 1), (1, 2), (1, 0))$ and that the resulting list of vectors will still span \mathbb{R}^2 . Indeed, by Equation (5.2),

$$v_3 = (1, 0) = 2(1, 1) - (1, 2) = 2v_1 - v_2,$$

and so $\text{span}((1, 1), (1, 2), (1, 0)) = \text{span}((1, 1), (1, 2))$.

The next result shows that linearly independent lists of vectors that span a finite-

dimensional vector space are the smallest possible spanning sets.

Theorem 5.2.9. *Let V be a finite-dimensional vector space. Suppose that (v_1, \dots, v_m) is a linearly independent list of vectors that spans V , and let (w_1, \dots, w_n) be any list that spans V . Then $m \leq n$.*

Proof. The proof uses the following iterative procedure: start with an arbitrary list of vectors $\mathcal{S}_0 = (w_1, \dots, w_n)$ such that $V = \text{span}(\mathcal{S}_0)$. At the k^{th} step of the procedure, we construct a new list \mathcal{S}_k by replacing some vector w_{j_k} by the vector v_k such that \mathcal{S}_k still spans V . Repeating this for all v_k then produces a new list \mathcal{S}_m of length n that contains each of v_1, \dots, v_m , which then proves that $m \leq n$. Let us now discuss each step in this procedure in detail.

Step 1. Since (w_1, \dots, w_n) spans V , adding a new vector to the list makes the new list linearly dependent. Hence (v_1, w_1, \dots, w_n) is linearly dependent. By Lemma 5.2.7, there exists an index j_1 such that

$$w_{j_1} \in \text{span}(v_1, w_1, \dots, w_{j_1-1}).$$

Hence $\mathcal{S}_1 = (v_1, w_1, \dots, \hat{w}_{j_1}, \dots, w_n)$ spans V . In this step, we added the vector v_1 and removed the vector w_{j_1} from \mathcal{S}_0 .

Step k . Suppose that we already added v_1, \dots, v_{k-1} to our spanning list and removed the vectors $w_{j_1}, \dots, w_{j_{k-1}}$. It is impossible that we have reached the situation where all of the vectors w_1, \dots, w_n have been removed from the spanning list at this step if $k \leq m$ because then we would have $V = \text{span}(v_1, \dots, v_{k-1})$ which would allow v_k to be expressed as a linear combination of v_1, \dots, v_{k-1} (in contradiction with the assumption of linear independence of v_1, \dots, v_m).

Now, call the list reached at this step \mathcal{S}_{k-1} , and note that $V = \text{span}(\mathcal{S}_{k-1})$. Add the vector v_k to \mathcal{S}_{k-1} . By the same arguments as before, adjoining the extra vector v_k to the spanning list \mathcal{S}_{k-1} yields a list of linearly dependent vectors. Hence, by Lemma 5.2.7, there exists an index j_k such that \mathcal{S}_{k-1} with v_k added and w_{j_k} removed still spans V . The fact that (v_1, \dots, v_k) is linearly independent ensures that the vector removed is indeed among the w_j . Call the new list \mathcal{S}_k , and note that $V = \text{span}(\mathcal{S}_k)$.

The final list \mathcal{S}_m is \mathcal{S}_0 but with each v_1, \dots, v_m added and each w_{j_1}, \dots, w_{j_m} removed. Moreover, note that \mathcal{S}_m has length n and still spans V . It follows that $m \leq n$. \square

5.3 Bases

A basis of a finite-dimensional vector space is a spanning list that is also linearly independent. We will see that all bases for finite-dimensional vector spaces have the same length. This length will then be called the **dimension** of our vector space.

Definition 5.3.1. A list of vectors (v_1, \dots, v_m) is a **basis** for the finite-dimensional vector space V if (v_1, \dots, v_m) is linearly independent and $V = \text{span}(v_1, \dots, v_m)$.

If (v_1, \dots, v_m) forms a basis of V , then, by Lemma 5.2.6, every vector $v \in V$ can be uniquely written as a linear combination of (v_1, \dots, v_m) .

Example 5.3.2. (e_1, \dots, e_n) is a basis of \mathbb{F}^n . There are, of course, other bases. For example, $((1, 2), (1, 1))$ is a basis of \mathbb{F}^2 . Note that the list $((1, 1))$ is also linearly independent, but it does not span \mathbb{F}^2 and hence is not a basis.

Example 5.3.3. $(1, z, z^2, \dots, z^m)$ is a basis of $\mathbb{F}_m[z]$.

Theorem 5.3.4 (Basis Reduction Theorem). *If $V = \text{span}(v_1, \dots, v_m)$, then either (v_1, \dots, v_m) is a basis of V or some v_i can be removed to obtain a basis of V .*

Proof. Suppose $V = \text{span}(v_1, \dots, v_m)$. We start with the list $\mathcal{S} = (v_1, \dots, v_m)$ and iteratively run through all vectors v_k for $k = 1, 2, \dots, m$ to determine whether to keep or remove them from \mathcal{S} :

Step 1. If $v_1 = 0$, then remove v_1 from \mathcal{S} . Otherwise, leave \mathcal{S} unchanged.

Step k . If $v_k \in \text{span}(v_1, \dots, v_{k-1})$, then remove v_k from \mathcal{S} . Otherwise, leave \mathcal{S} unchanged.

The final list \mathcal{S} still spans V since, at each step, a vector was only discarded if it was already in the span of the previous vectors. The process also ensures that no vector is in the span of the previous vectors. Hence, by the Linear Dependence Lemma 5.2.7, the final list \mathcal{S} is linearly independent. It follows that \mathcal{S} is a basis of V . \square

Example 5.3.5. To see how Basis Reduction Theorem 5.3.4 works, consider the list of vectors

$$\mathcal{S} = ((1, -1, 0), (2, -2, 0), (-1, 0, 1), (0, -1, 1), (0, 1, 0)).$$

This list does not form a basis for \mathbb{R}^3 as it is not linearly independent. However, it is clear that $\mathbb{R}^3 = \text{span}(\mathcal{S})$ since any arbitrary vector $v = (x, y, z) \in \mathbb{R}^3$ can be written as the following linear combination over \mathcal{S} :

$$v = (x + z)(1, -1, 0) + 0(2, -2, 0) + (z)(-1, 0, 1) + 0(0, -1, 1) + (x + y + z)(0, 1, 0).$$

In fact, since the coefficients of $(2, -2, 0)$ and $(0, -1, 1)$ in this linear combination are both zero, it suggests that they add nothing to the span of the subset

$$\mathcal{B} = ((1, -1, 0), (-1, 0, 1), (0, 1, 0))$$

of \mathcal{S} . Moreover, one can show that \mathcal{B} is a basis for \mathbb{R}^3 , and it is exactly the basis produced by applying the process from the proof of Theorem 5.3.4 (as you should be able to verify).

Corollary 5.3.6. *Every finite-dimensional vector space has a basis.*

Proof. By definition, a finite-dimensional vector space has a spanning list. By the Basis Reduction Theorem 5.3.4, any spanning list can be reduced to a basis. \square

Theorem 5.3.7 (Basis Extension Theorem). *Every linearly independent list of vectors in a finite-dimensional vector space V can be extended to a basis of V .*

Proof. Suppose V is finite-dimensional and that (v_1, \dots, v_m) is linearly independent. Since V is finite-dimensional, there exists a list (w_1, \dots, w_n) of vectors that spans V . We wish to adjoin some of the w_k to (v_1, \dots, v_m) in order to create a basis of V .

Step 1. If $w_1 \in \text{span}(v_1, \dots, v_m)$, then let $\mathcal{S} = (v_1, \dots, v_m)$. Otherwise, $\mathcal{S} = (v_1, \dots, v_m, w_1)$.

Step k . If $w_k \in \text{span}(\mathcal{S})$, then leave \mathcal{S} unchanged. Otherwise, adjoin w_k to \mathcal{S} .

After each step, the list \mathcal{S} is still linearly independent since we only adjoined w_k if w_k was not in the span of the previous vectors. After n steps, $w_k \in \text{span}(\mathcal{S})$ for all $k = 1, 2, \dots, n$. Since (w_1, \dots, w_n) was a spanning list, \mathcal{S} spans V so that \mathcal{S} is indeed a basis of V . \square

Example 5.3.8. Take the two vectors $v_1 = (1, 1, 0, 0)$ and $v_2 = (1, 0, 1, 0)$ in \mathbb{R}^4 . One may easily check that these two vectors are linearly independent, but they do not form a basis of \mathbb{R}^4 . We know that (e_1, e_2, e_3, e_4) spans \mathbb{R}^4 . (In fact, it is even a basis.) Following the

algorithm outlined in the proof of the Basis Extension Theorem, we see that $e_1 \notin \text{span}(v_1, v_2)$. Hence, we adjoin e_1 to obtain $\mathcal{S} = (v_1, v_2, e_1)$. Note that now

$$e_2 = (0, 1, 0, 0) = 1v_1 + 0v_2 + (-1)e_1$$

so that $e_2 \in \text{span}(v_1, v_2, e_1)$, and so we leave \mathcal{S} unchanged. Similarly,

$$e_3 = (0, 0, 1, 0) = 0v_1 + 1v_2 + (-1)e_1,$$

and hence $e_3 \in \text{span}(v_1, v_2, e_1)$, which means that we again leave \mathcal{S} unchanged. Finally, $e_4 \notin \text{span}(v_1, v_2, e_1)$, and so we adjoin it to obtain a basis (v_1, v_2, e_1, e_4) of \mathbb{R}^4 .

5.4 Dimension

We now come to the important definition of the dimension of a finite-dimensional vector space. Intuitively, we know that \mathbb{R}^2 has dimension 2, that \mathbb{R}^3 has dimension 3, and, more generally, that \mathbb{R}^n has dimension n . This is precisely the length of every basis for each of these vector spaces, which prompts the following definition.

Definition 5.4.1. We call the length of any basis for V (which is well-defined by Theorem 5.4.2 below) the **dimension** of V , and we denote this by $\dim(V)$.

Note that Definition 5.4.1 only makes sense if, in fact, every basis for a given finite-dimensional vector space has the same length. This is true by the following theorem.

Theorem 5.4.2. *Let V be a finite-dimensional vector space. Then any two bases of V have the same length.*

Proof. Let (v_1, \dots, v_m) and (w_1, \dots, w_n) be two bases of V . Both span V . By Theorem 5.2.9, we have $m \leq n$ since (v_1, \dots, v_m) is linearly independent. By the same theorem, we also have $n \leq m$ since (w_1, \dots, w_n) is linearly independent. Hence $n = m$, as asserted. \square

Example 5.4.3. $\dim(\mathbb{F}^n) = n$ and $\dim(\mathbb{F}_m[z]) = m + 1$. Note that $\dim(\mathbb{C}^n) = n$ as a complex vector space, whereas $\dim(\mathbb{C}^n) = 2n$ as a real vector space. This comes from the fact that we can view \mathbb{C} itself as a real vector space of dimension 2 with basis $(1, i)$.

Theorem 5.4.4. *Let V be a finite-dimensional vector space with $\dim(V) = n$. Then:*

1. *If $U \subset V$ is a subspace of V , then $\dim(U) \leq \dim(V)$.*
2. *If $V = \text{span}(v_1, \dots, v_n)$, then (v_1, \dots, v_n) is a basis of V .*
3. *If (v_1, \dots, v_n) is linearly independent in V , then (v_1, \dots, v_n) is a basis of V .*

Point 1 implies, in particular, that every subspace of a finite-dimensional vector space is finite-dimensional. Points 2 and 3 show that if the dimension of a vector space is known to be n , then, to check that a list of n vectors is a basis, it is enough to check whether it spans V (resp. is linearly independent).

Proof. To prove Point 1, first note that U is necessarily finite-dimensional (otherwise we could find a list of linearly independent vectors longer than $\dim(V)$). Therefore, by Corollary 5.3.6, U has a basis (u_1, \dots, u_m) (say). This list is linearly independent in both U and V . By the Basis Extension Theorem 5.3.7, we can extend (u_1, \dots, u_m) to a basis for V , which is of length n since $\dim(V) = n$. This implies that $m \leq n$, as desired.

To prove Point 2, suppose that (v_1, \dots, v_n) spans V . Then, by the Basis Reduction Theorem 5.3.4, this list can be reduced to a basis. However, every basis of V has length n ; hence, no vector needs to be removed from (v_1, \dots, v_n) . It follows that (v_1, \dots, v_n) is already a basis of V .

Point 3 is proven in a very similar fashion. Suppose (v_1, \dots, v_n) is linearly independent. By the Basis Extension Theorem 5.3.7, this list can be extended to a basis. However, every basis has length n ; hence, no vector needs to be added to (v_1, \dots, v_n) . It follows that (v_1, \dots, v_n) is already a basis of V . \square

We conclude this chapter with some additional interesting results on bases and dimensions. The first one combines the concepts of basis and direct sum.

Theorem 5.4.5. *Let $U \subset V$ be a subspace of a finite-dimensional vector space V . Then there exists a subspace $W \subset V$ such that $V = U \oplus W$.*

Proof. Let (u_1, \dots, u_m) be a basis of U . By Theorem 5.4.4(1), we know that $m \leq \dim(V)$. Hence, by the Basis Extension Theorem 5.3.7, (u_1, \dots, u_m) can be extended to a basis $(u_1, \dots, u_m, w_1, \dots, w_n)$ of V . Let $W = \text{span}(w_1, \dots, w_n)$.

To show that $V = U \oplus W$, we need to show that $V = U + W$ and $U \cap W = \{0\}$. Since $V = \text{span}(u_1, \dots, u_m, w_1, \dots, w_n)$ where (u_1, \dots, u_m) spans U and (w_1, \dots, w_n) spans W , it is clear that $V = U + W$.

To show that $U \cap W = \{0\}$, let $v \in U \cap W$. Then there exist scalars $a_1, \dots, a_m, b_1, \dots, b_n \in \mathbb{F}$ such that

$$v = a_1u_1 + \cdots + a_mu_m = b_1w_1 + \cdots + b_nw_n,$$

or equivalently that

$$a_1u_1 + \cdots + a_mu_m - b_1w_1 - \cdots - b_nw_n = 0.$$

Since $(u_1, \dots, u_m, w_1, \dots, w_n)$ forms a basis of V and hence is linearly independent, the only solution to this equation is $a_1 = \cdots = a_m = b_1 = \cdots = b_n = 0$. Hence $v = 0$, proving that indeed $U \cap W = \{0\}$. \square

Theorem 5.4.6. *If $U, W \subset V$ are subspaces of a finite-dimensional vector space, then*

$$\dim(U + W) = \dim(U) + \dim(W) - \dim(U \cap W).$$

Proof. Let (v_1, \dots, v_n) be a basis of $U \cap W$. By the Basis Extension Theorem 5.3.7, there exist (u_1, \dots, u_k) and (w_1, \dots, w_ℓ) such that $(v_1, \dots, v_n, u_1, \dots, u_k)$ is a basis of U and $(v_1, \dots, v_n, w_1, \dots, w_\ell)$ is a basis of W . It suffices to show that

$$\mathcal{B} = (v_1, \dots, v_n, u_1, \dots, u_k, w_1, \dots, w_\ell)$$

is a basis of $U + W$ since then

$$\dim(U + W) = n + k + \ell = (n + k) + (n + \ell) - n = \dim(U) + \dim(W) - \dim(U \cap W).$$

Clearly $\text{span}(v_1, \dots, v_n, u_1, \dots, u_k, w_1, \dots, w_\ell)$ contains U and W , and hence $U + W$. To show that \mathcal{B} is a basis, it remains to show that \mathcal{B} is linearly independent. Suppose

$$a_1v_1 + \cdots + a_nv_n + b_1u_1 + \cdots + b_ku_k + c_1w_1 + \cdots + c_\ellw_\ell = 0, \quad (5.3)$$

and let $u = a_1v_1 + \cdots + a_nv_n + b_1u_1 + \cdots + b_ku_k \in U$. Then, by Equation (5.3), we also have that $u = -c_1w_1 - \cdots - c_\ellw_\ell \in W$, which implies that $u \in U \cap W$. Hence, there

exist scalars $a'_1, \dots, a'_n \in \mathbb{F}$ such that $u = a'_1 v_1 + \dots + a'_n v_n$. Since there is a unique linear combination of the linearly independent vectors $(v_1, \dots, v_n, u_1, \dots, u_k)$ that describes u , we must have $b_1 = \dots = b_k = 0$ and $a_1 = a'_1, \dots, a_n = a'_n$. Since $(v_1, \dots, v_n, w_1, \dots, w_\ell)$ is also linearly independent, it further follows that $a_1 = \dots = a_n = c_1 = \dots = c_\ell = 0$. Hence, Equation (5.3) only has the trivial solution, which implies that \mathcal{B} is a basis. \square

Exercises for Chapter 5

Computational Exercises

1. Show that the vectors $v_1 = (1, 1, 1)$, $v_2 = (1, 2, 3)$, and $v_3 = (2, -1, 1)$ are linearly independent in \mathbb{R}^3 . Write $v = (1, -2, 5)$ as a linear combination of v_1 , v_2 , and v_3 .

2. Consider the complex vector space $V = \mathbb{C}^3$ and the list (v_1, v_2, v_3) of vectors in V , where

$$v_1 = (i, 0, 0), \quad v_2 = (i, 1, 0), \quad v_3 = (i, i, -1).$$

(a) Prove that $\text{span}(v_1, v_2, v_3) = V$.

(b) Prove or disprove: (v_1, v_2, v_3) is a basis for V .

3. Determine the dimension of each of the following subspaces of \mathbb{F}^4 .

(a) $\{(x_1, x_2, x_3, x_4) \in \mathbb{F}^4 \mid x_4 = 0\}$.

(b) $\{(x_1, x_2, x_3, x_4) \in \mathbb{F}^4 \mid x_4 = x_1 + x_2\}$.

(c) $\{(x_1, x_2, x_3, x_4) \in \mathbb{F}^4 \mid x_4 = x_1 + x_2, x_3 = x_1 - x_2\}$.

(d) $\{(x_1, x_2, x_3, x_4) \in \mathbb{F}^4 \mid x_4 = x_1 + x_2, x_3 = x_1 - x_2, x_3 + x_4 = 2x_1\}$.

(e) $\{(x_1, x_2, x_3, x_4) \in \mathbb{F}^4 \mid x_1 = x_2 = x_3 = x_4\}$.

$$(v_1 - v_2, v_2 - v_3, v_3 - v_4, \dots, v_{n-2} - v_{n-1}, v_{n-1} - v_n, v_n)$$

also spans V .

3. Let V be a vector space over \mathbb{F} , and suppose that (v_1, v_2, \dots, v_n) is a linearly independent list of vectors in V . Given any $w \in V$ such that

$$(v_1 + w, v_2 + w, \dots, v_n + w)$$

is a linearly dependent list of vectors in V , prove that $w \in \text{span}(v_1, v_2, \dots, v_n)$.

Chapter 6

Linear Maps

As discussed in Chapter 1, one of the main goals of Linear Algebra is the characterization of solutions to a system of m linear equations in n unknowns x_1, \dots, x_n ,

$$\left. \begin{array}{rcl} a_{11}x_1 + \cdots + a_{1n}x_n & = & b_1 \\ & \vdots & \vdots \\ a_{m1}x_1 + \cdots + a_{mn}x_n & = & b_m \end{array} \right\},$$

where each of the coefficients a_{ij} and b_i is in \mathbb{F} . Linear maps and their properties give us insight into the characteristics of solutions to linear systems.

6.1 Definition and elementary properties

Throughout this chapter, V and W denote vector spaces over \mathbb{F} . We are going to study functions from V into W that have the special properties given in the following definition.

Definition 6.1.1. A function $T : V \rightarrow W$ is called **linear** if

$$T(u + v) = T(u) + T(v), \quad \text{for all } u, v \in V, \quad (6.1)$$

$$T(av) = aT(v), \quad \text{for all } a \in \mathbb{F} \text{ and } v \in V. \quad (6.2)$$

The set of all linear maps from V to W is denoted by $\mathcal{L}(V, W)$. We also write Tv for $T(v)$.

Moreover, if $V = W$, then we write $\mathcal{L}(V, V) = \mathcal{L}(V)$ and call $T \in \mathcal{L}(V)$ a **linear operator** on V .

Example 6.1.2.

1. The **zero map** $0 : V \rightarrow W$ mapping every element $v \in V$ to $0 \in W$ is linear.
2. The **identity map** $I : V \rightarrow V$ defined as $Iv = v$ is linear.
3. Let $T : \mathbb{F}[z] \rightarrow \mathbb{F}[z]$ be the **differentiation map** defined as $Tp(z) = p'(z)$. Then, for two polynomials $p(z), q(z) \in \mathbb{F}[z]$, we have

$$T(p(z) + q(z)) = (p(z) + q(z))' = p'(z) + q'(z) = T(p(z)) + T(q(z)).$$

Similarly, for a polynomial $p(z) \in \mathbb{F}[z]$ and a scalar $a \in \mathbb{F}$, we have

$$T(ap(z)) = (ap(z))' = ap'(z) = aT(p(z)).$$

Hence T is linear.

4. Let $T : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ be the map given by $T(x, y) = (x - 2y, 3x + y)$. Then, for $(x, y), (x', y') \in \mathbb{R}^2$, we have

$$\begin{aligned} T((x, y) + (x', y')) &= T(x + x', y + y') = (x + x' - 2(y + y'), 3(x + x') + y + y') \\ &= (x - 2y, 3x + y) + (x' - 2y', 3x' + y') = T(x, y) + T(x', y'). \end{aligned}$$

Similarly, for $(x, y) \in \mathbb{R}^2$ and $a \in \mathbb{F}$, we have

$$T(a(x, y)) = T(ax, ay) = (ax - 2ay, 3ax + ay) = a(x - 2y, 3x + y) = aT(x, y).$$

Hence T is linear. More generally, any map $T : \mathbb{F}^n \rightarrow \mathbb{F}^m$ defined by

$$T(x_1, \dots, x_n) = (a_{11}x_1 + \dots + a_{1n}x_n, \dots, a_{m1}x_1 + \dots + a_{mn}x_n)$$

with $a_{ij} \in \mathbb{F}$ is linear.

5. Not all functions are linear! For example, the exponential function $f(x) = e^x$ is not linear since $e^{2x} \neq 2e^x$ in general. Also, the function $f : \mathbb{F} \rightarrow \mathbb{F}$ given by $f(x) = x - 1$ is not linear since $f(x + y) = (x + y) - 1 \neq (x - 1) + (y - 1) = f(x) + f(y)$.

An important result is that linear maps are already completely determined if their values on basis vectors are specified.

Theorem 6.1.3. *Let (v_1, \dots, v_n) be a basis of V and (w_1, \dots, w_n) be an arbitrary list of vectors in W . Then there exists a unique linear map*

$$T : V \rightarrow W \quad \text{such that } T(v_i) = w_i, \forall i = 1, 2, \dots, n.$$

Proof. First we verify that there is at most one linear map T with $T(v_i) = w_i$. Take any $v \in V$. Since (v_1, \dots, v_n) is a basis of V there are unique scalars $a_1, \dots, a_n \in \mathbb{F}$ such that $v = a_1v_1 + \dots + a_nv_n$. By linearity, we have

$$T(v) = T(a_1v_1 + \dots + a_nv_n) = a_1T(v_1) + \dots + a_nT(v_n) = a_1w_1 + \dots + a_nw_n, \quad (6.3)$$

and hence $T(v)$ is completely determined. To show existence, use Equation (6.3) to define T . It remains to show that this T is linear and that $T(v_i) = w_i$. These two conditions are not hard to show and are left to the reader. \square

The set of linear maps $\mathcal{L}(V, W)$ is itself a vector space. For $S, T \in \mathcal{L}(V, W)$ addition is defined as

$$(S + T)v = Sv + Tv, \quad \text{for all } v \in V.$$

For $a \in \mathbb{F}$ and $T \in \mathcal{L}(V, W)$, scalar multiplication is defined as

$$(aT)(v) = a(Tv), \quad \text{for all } v \in V.$$

You should verify that $S + T$ and aT are indeed linear maps and that all properties of a vector space are satisfied.

In addition to the operations of vector addition and scalar multiplication, we can also define the **composition of linear maps**. Let V, U, W be vector spaces over \mathbb{F} . Then, for $S \in \mathcal{L}(U, V)$ and $T \in \mathcal{L}(V, W)$, we define $T \circ S \in \mathcal{L}(U, W)$ by

$$(T \circ S)(u) = T(S(u)), \quad \text{for all } u \in U.$$

The map $T \circ S$ is often also called the **product** of T and S denoted by TS . It has the following properties:

1. **Associativity:** $(T_1T_2)T_3 = T_1(T_2T_3)$, for all $T_1 \in \mathcal{L}(V_1, V_0)$, $T_2 \in \mathcal{L}(V_2, V_1)$ and $T_3 \in \mathcal{L}(V_3, V_2)$.
2. **Identity:** $TI = IT = T$, where $T \in \mathcal{L}(V, W)$ and where I in TI is the identity map in $\mathcal{L}(V, V)$ whereas the I in IT is the identity map in $\mathcal{L}(W, W)$.
3. **Distributive property:** $(T_1 + T_2)S = T_1S + T_2S$ and $T(S_1 + S_2) = TS_1 + TS_2$, where $S, S_1, S_2 \in \mathcal{L}(U, V)$ and $T, T_1, T_2 \in \mathcal{L}(V, W)$.

Note that the product of linear maps is not always commutative. For example, if we take $T \in \mathcal{L}(\mathbb{F}[z], \mathbb{F}[z])$ to be the differentiation map $Tp(z) = p'(z)$ and $S \in \mathcal{L}(\mathbb{F}[z], \mathbb{F}[z])$ to be the map $Sp(z) = z^2p(z)$, then

$$(ST)p(z) = z^2p'(z) \quad \text{but} \quad (TS)p(z) = z^2p'(z) + 2zp(z).$$

6.2 Null spaces

Definition 6.2.1. Let $T : V \rightarrow W$ be a linear map. Then the **null space** (a.k.a. **kernel**) of T is the set of all vectors in V that are mapped to zero by T . I.e.,

$$\text{null}(T) = \{v \in V \mid Tv = 0\}.$$

Example 6.2.2. Let $T \in \mathcal{L}(\mathbb{F}[z], \mathbb{F}[z])$ be the differentiation map $Tp(z) = p'(z)$. Then

$$\text{null}(T) = \{p \in \mathbb{F}[z] \mid p(z) \text{ is constant}\}.$$

Example 6.2.3. Consider the linear map $T(x, y) = (x - 2y, 3x + y)$ of Example 6.1.2. To determine the null space, we need to solve $T(x, y) = (0, 0)$, which is equivalent to the system of linear equations

$$\left. \begin{array}{l} x - 2y = 0 \\ 3x + y = 0 \end{array} \right\}.$$

We see that the only solution is $(x, y) = (0, 0)$ so that $\text{null}(T) = \{(0, 0)\}$.

Proposition 6.2.4. Let $T : V \rightarrow W$ be a linear map. Then $\text{null}(T)$ is a subspace of V .

Proof. We need to show that $0 \in \text{null}(T)$ and that $\text{null}(T)$ is closed under addition and scalar multiplication. By linearity, we have

$$T(0) = T(0 + 0) = T(0) + T(0)$$

so that $T(0) = 0$. Hence $0 \in \text{null}(T)$. For closure under addition, let $u, v \in \text{null}(T)$. Then

$$T(u + v) = T(u) + T(v) = 0 + 0 = 0,$$

and hence $u + v \in \text{null}(T)$. Similarly, for closure under scalar multiplication, let $u \in \text{null}(T)$ and $a \in \mathbb{F}$. Then

$$T(au) = aT(u) = a0 = 0,$$

and so $au \in \text{null}(T)$. □

Definition 6.2.5. The linear map $T : V \rightarrow W$ is called **injective** if, for all $u, v \in V$, the condition $Tu = Tv$ implies that $u = v$. In other words, different vectors in V are mapped to different vectors in W .

Proposition 6.2.6. *Let $T : V \rightarrow W$ be a linear map. Then T is injective if and only if $\text{null}(T) = \{0\}$.*

Proof.

(“ \implies ”) Suppose that T is injective. Since $\text{null}(T)$ is a subspace of V , we know that $0 \in \text{null}(T)$. Assume that there is another vector $v \in V$ that is in the kernel. Then $T(v) = 0 = T(0)$. Since T is injective, this implies that $v = 0$, proving that $\text{null}(T) = \{0\}$.

(“ \impliedby ”) Assume that $\text{null}(T) = \{0\}$, and let $u, v \in V$ be such that $Tu = Tv$. Then $0 = Tu - Tv = T(u - v)$ so that $u - v \in \text{null}(T)$. Hence $u - v = 0$, or, equivalently, $u = v$. This shows that T is indeed injective. □

Example 6.2.7.

1. The differentiation map $p(z) \mapsto p'(z)$ is not injective since $p'(z) = q'(z)$ implies that $p(z) = q(z) + c$, where $c \in \mathbb{F}$ is a constant.
2. The identity map $I : V \rightarrow V$ is injective.

3. The linear map $T : \mathbb{F}[z] \rightarrow \mathbb{F}[z]$ given by $T(p(z)) = z^2p(z)$ is injective since it is easy to verify that $\text{null}(T) = \{0\}$.
4. The linear map $T(x, y) = (x - 2y, 3x + y)$ is injective since $\text{null}(T) = \{(0, 0)\}$, as we calculated in Example 6.2.3.

6.3 Ranges

Definition 6.3.1. Let $T : V \rightarrow W$ be a linear map. The **range** of T , denoted by $\text{range}(T)$, is the subset of vectors in W that are in the image of T . I.e.,

$$\text{range}(T) = \{Tv \mid v \in V\} = \{w \in W \mid \text{there exists } v \in V \text{ such that } Tv = w\}.$$

Example 6.3.2. The range of the differentiation map $T : \mathbb{F}[z] \rightarrow \mathbb{F}[z]$ is $\text{range}(T) = \mathbb{F}[z]$ since, for every polynomial $q \in \mathbb{F}[z]$, there is a $p \in \mathbb{F}[z]$ such that $p' = q$.

Example 6.3.3. The range of the linear map $T(x, y) = (x - 2y, 3x + y)$ is \mathbb{R}^2 since, for any $(z_1, z_2) \in \mathbb{R}^2$, we have $T(x, y) = (z_1, z_2)$ if $(x, y) = \frac{1}{7}(z_1 + 2z_2, -3z_1 + z_2)$.

Proposition 6.3.4. Let $T : V \rightarrow W$ be a linear map. Then $\text{range}(T)$ is a subspace of W .

Proof. We need to show that $0 \in \text{range}(T)$ and that $\text{range}(T)$ is closed under addition and scalar multiplication. We already showed that $T0 = 0$ so that $0 \in \text{range}(T)$.

For closure under addition, let $w_1, w_2 \in \text{range}(T)$. Then there exist $v_1, v_2 \in V$ such that $Tv_1 = w_1$ and $Tv_2 = w_2$. Hence

$$T(v_1 + v_2) = Tv_1 + Tv_2 = w_1 + w_2,$$

and so $w_1 + w_2 \in \text{range}(T)$.

For closure under scalar multiplication, let $w \in \text{range}(T)$ and $a \in \mathbb{F}$. Then there exists a $v \in V$ such that $Tv = w$. Thus

$$T(av) = aTv = aw,$$

and so $aw \in \text{range}(T)$. □

Definition 6.3.5. A linear map $T : V \rightarrow W$ is called **surjective** if $\text{range}(T) = W$. A linear map $T : V \rightarrow W$ is called **bijective** if T is both injective and surjective.

Example 6.3.6.

1. The differentiation map $T : \mathbb{F}[z] \rightarrow \mathbb{F}[z]$ is surjective since $\text{range}(T) = \mathbb{F}[z]$. However, if we restrict ourselves to polynomials of degree at most m , then the differentiation map $T : \mathbb{F}_m[z] \rightarrow \mathbb{F}_m[z]$ is not surjective since polynomials of degree m are not in the range of T .
2. The identity map $I : V \rightarrow V$ is surjective.
3. The linear map $T : \mathbb{F}[z] \rightarrow \mathbb{F}[z]$ given by $T(p(z)) = z^2p(z)$ is not surjective since, for example, there are no linear polynomials in the range of T .
4. The linear map $T(x, y) = (x - 2y, 3x + y)$ is surjective since $\text{range}(T) = \mathbb{R}^2$, as we calculated in Example 6.3.3.

6.4 Homomorphisms

It should be mentioned that linear maps between vector spaces are also called **vector space homomorphisms**. Instead of the notation $\mathcal{L}(V, W)$, one often sees the convention

$$\text{Hom}_{\mathbb{F}}(V, W) = \{T : V \rightarrow W \mid T \text{ is linear}\}.$$

A homomorphism $T : V \rightarrow W$ is also often called

- **Monomorphism** iff T is injective;
- **Epimorphism** iff T is surjective;
- **Isomorphism** iff T is bijective;
- **Endomorphism** iff $V = W$;
- **Automorphism** iff $V = W$ and T is bijective.

6.5 The dimension formula

The next theorem is the key result of this chapter. It relates the dimension of the kernel and range of a linear map.

Theorem 6.5.1. *Let V be a finite-dimensional vector space and $T : V \rightarrow W$ be a linear map. Then $\text{range}(T)$ is a finite-dimensional subspace of W and*

$$\dim(V) = \dim(\text{null}(T)) + \dim(\text{range}(T)). \quad (6.4)$$

Proof. Let V be a finite-dimensional vector space and $T \in \mathcal{L}(V, W)$. Since $\text{null}(T)$ is a subspace of V , we know that $\text{null}(T)$ has a basis (u_1, \dots, u_m) . This implies that $\dim(\text{null}(T)) = m$. By the Basis Extension Theorem, it follows that (u_1, \dots, u_m) can be extended to a basis of V , say $(u_1, \dots, u_m, v_1, \dots, v_n)$, so that $\dim(V) = m + n$.

The theorem will follow by showing that (Tv_1, \dots, Tv_n) is a basis of $\text{range}(T)$ since this would imply that $\text{range}(T)$ is finite-dimensional and $\dim(\text{range}(T)) = n$, proving Equation (6.4).

Since $(u_1, \dots, u_m, v_1, \dots, v_n)$ spans V , every $v \in V$ can be written as a linear combination of these vectors; i.e.,

$$v = a_1u_1 + \dots + a_mu_m + b_1v_1 + \dots + b_nv_n,$$

where $a_i, b_j \in \mathbb{F}$. Applying T to v , we obtain

$$Tv = b_1Tv_1 + \dots + b_nTv_n,$$

where the terms Tu_i disappeared since $u_i \in \text{null}(T)$. This shows that (Tv_1, \dots, Tv_n) indeed spans $\text{range}(T)$.

To show that (Tv_1, \dots, Tv_n) is a basis of $\text{range}(T)$, it remains to show that this list is linearly independent. Assume that $c_1, \dots, c_n \in \mathbb{F}$ are such that

$$c_1Tv_1 + \dots + c_nTv_n = 0.$$

By linearity of T , this implies that

$$T(c_1v_1 + \cdots + c_nv_n) = 0,$$

and so $c_1v_1 + \cdots + c_nv_n \in \text{null}(T)$. Since (u_1, \dots, u_m) is a basis of $\text{null}(T)$, there must exist scalars $d_1, \dots, d_m \in \mathbb{F}$ such that

$$c_1v_1 + \cdots + c_nv_n = d_1u_1 + \cdots + d_mu_m.$$

However, by the linear independence of $(u_1, \dots, u_m, v_1, \dots, v_n)$, this implies that all coefficients $c_1 = \cdots = c_n = d_1 = \cdots = d_m = 0$. Thus, (Tv_1, \dots, Tv_n) is linearly independent, and we are done. \square

Example 6.5.2. Recall that the linear map $T : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ defined by $T(x, y) = (x - 2y, 3x + y)$ has $\text{null}(T) = \{0\}$ and $\text{range}(T) = \mathbb{R}^2$. It follows that

$$\dim(\mathbb{R}^2) = 2 = 0 + 2 = \dim(\text{null}(T)) + \dim(\text{range}(T)).$$

Corollary 6.5.3. *Let $T \in \mathcal{L}(V, W)$.*

1. *If $\dim(V) > \dim(W)$, then T is not injective.*
2. *If $\dim(V) < \dim(W)$, then T is not surjective.*

Proof. By Theorem 6.5.1, we have that

$$\begin{aligned} \dim(\text{null}(T)) &= \dim(V) - \dim(\text{range}(T)) \\ &\geq \dim(V) - \dim(W) > 0. \end{aligned}$$

Since T is injective if and only if $\dim(\text{null}(T)) = 0$, T cannot be injective.

Similarly,

$$\begin{aligned} \dim(\text{range}(T)) &= \dim(V) - \dim(\text{null}(T)) \\ &\leq \dim(V) < \dim(W), \end{aligned}$$

and so $\text{range}(T)$ cannot be equal to W . Hence, T cannot be surjective. \square

6.6 The matrix of a linear map

Now we will see that every linear map $T \in \mathcal{L}(V, W)$, with V and W finite-dimensional vector spaces, can be encoded by a matrix, and, vice versa, every matrix defines such a linear map.

Let V and W be finite-dimensional vector spaces, and let $T : V \rightarrow W$ be a linear map. Suppose that (v_1, \dots, v_n) is a basis of V and that (w_1, \dots, w_m) is a basis for W . We have seen in Theorem 6.1.3 that T is uniquely determined by specifying the vectors $Tv_1, \dots, Tv_n \in W$. Since (w_1, \dots, w_m) is a basis of W , there exist unique scalars $a_{ij} \in \mathbb{F}$ such that

$$Tv_j = a_{1j}w_1 + \dots + a_{mj}w_m \quad \text{for } 1 \leq j \leq n. \quad (6.5)$$

We can arrange these scalars in an $m \times n$ matrix as follows:

$$M(T) = \begin{bmatrix} a_{11} & \dots & a_{1n} \\ \vdots & & \vdots \\ a_{m1} & \dots & a_{mn} \end{bmatrix}.$$

Often, this is also written as $A = (a_{ij})_{1 \leq i \leq m, 1 \leq j \leq n}$. As in Section 12.1.1, the set of all $m \times n$ matrices with entries in \mathbb{F} is denoted by $\mathbb{F}^{m \times n}$.

Remark 6.6.1. It is important to remember that $M(T)$ not only depends on the linear map T but also on the choice of the basis (v_1, \dots, v_n) for V and the choice of basis (w_1, \dots, w_m) for W . The j^{th} column of $M(T)$ contains the coefficients of the j^{th} basis vector v_j when expanded in terms of the basis (w_1, \dots, w_m) , as in Equation (6.5).

Example 6.6.2. Let $T : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ be the linear map given by $T(x, y) = (ax + by, cx + dy)$ for some $a, b, c, d \in \mathbb{R}$. Then, with respect to the canonical basis of \mathbb{R}^2 given by $((1, 0), (0, 1))$, the corresponding matrix is

$$M(T) = \begin{bmatrix} a & b \\ c & d \end{bmatrix}$$

since $T(1, 0) = (a, c)$ gives the first column and $T(0, 1) = (b, d)$ gives the second column.

More generally, suppose that $V = \mathbb{F}^n$ and $W = \mathbb{F}^m$, and denote the standard basis for V by (e_1, \dots, e_n) and the standard basis for W by (f_1, \dots, f_m) . Here, e_i (resp. f_i) is the n -tuple (resp. m -tuple) with a one in position i and zeroes everywhere else. Then the matrix

$M(T) = (a_{ij})$ is given by

$$a_{ij} = (Te_j)_i,$$

where $(Te_j)_i$ denotes the i^{th} component of the vector Te_j .

Example 6.6.3. Let $T : \mathbb{R}^2 \rightarrow \mathbb{R}^3$ be the linear map defined by $T(x, y) = (y, x + 2y, x + y)$. Then, with respect to the standard basis, we have $T(1, 0) = (0, 1, 1)$ and $T(0, 1) = (1, 2, 1)$ so that

$$M(T) = \begin{bmatrix} 0 & 1 \\ 1 & 2 \\ 1 & 1 \end{bmatrix}.$$

However, if alternatively we take the bases $((1, 2), (0, 1))$ for \mathbb{R}^2 and $((1, 0, 0), (0, 1, 0), (0, 0, 1))$ for \mathbb{R}^3 , then $T(1, 2) = (2, 5, 3)$ and $T(0, 1) = (1, 2, 1)$ so that

$$M(T) = \begin{bmatrix} 2 & 1 \\ 5 & 2 \\ 3 & 1 \end{bmatrix}.$$

Example 6.6.4. Let $S : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ be the linear map $S(x, y) = (y, x)$. With respect to the basis $((1, 2), (0, 1))$ for \mathbb{R}^2 , we have

$$S(1, 2) = (2, 1) = 2(1, 2) - 3(0, 1) \quad \text{and} \quad S(0, 1) = (1, 0) = 1(1, 2) - 2(0, 1),$$

and so

$$M(S) = \begin{bmatrix} 2 & 1 \\ -3 & -2 \end{bmatrix}.$$

Given vector spaces V and W of dimensions n and m , respectively, and given a fixed choice of bases, note that there is a one-to-one correspondence between linear maps in $\mathcal{L}(V, W)$ and matrices in $\mathbb{F}^{m \times n}$. If we start with the linear map T , then the matrix $M(T) = A = (a_{ij})$ is defined via Equation (6.5). Conversely, given the matrix $A = (a_{ij}) \in \mathbb{F}^{m \times n}$, we can define a linear map $T : V \rightarrow W$ by setting

$$Tv_j = \sum_{i=1}^m a_{ij}w_i.$$

Recall that the set of linear maps $\mathcal{L}(V, W)$ is a vector space. Since we have a one-to-one

correspondence between linear maps and matrices, we can also make the set of matrices $\mathbb{F}^{m \times n}$ into a vector space. Given two matrices $A = (a_{ij})$ and $B = (b_{ij})$ in $\mathbb{F}^{m \times n}$ and given a scalar $\alpha \in \mathbb{F}$, we define the **matrix addition** and **scalar multiplication** componentwise:

$$\begin{aligned} A + B &= (a_{ij} + b_{ij}), \\ \alpha A &= (\alpha a_{ij}). \end{aligned}$$

Next, we show that the **composition** of linear maps imposes a product on matrices, also called **matrix multiplication**. Suppose U, V, W are vector spaces over \mathbb{F} with bases (u_1, \dots, u_p) , (v_1, \dots, v_n) and (w_1, \dots, w_m) , respectively. Let $S : U \rightarrow V$ and $T : V \rightarrow W$ be linear maps. Then the product is a linear map $T \circ S : U \rightarrow W$.

Each linear map has its corresponding matrix $M(T) = A$, $M(S) = B$ and $M(TS) = C$. The question is whether C is determined by A and B . We have, for each $j \in \{1, 2, \dots, p\}$, that

$$\begin{aligned} (T \circ S)u_j &= T(b_{1j}v_1 + \dots + b_{nj}v_n) = b_{1j}Tv_1 + \dots + b_{nj}Tv_n \\ &= \sum_{k=1}^n b_{kj}Tv_k = \sum_{k=1}^n b_{kj} \left(\sum_{i=1}^m a_{ik}w_i \right) \\ &= \sum_{i=1}^m \left(\sum_{k=1}^n a_{ik}b_{kj} \right) w_i. \end{aligned}$$

Hence, the matrix $C = (c_{ij})$ is given by

$$c_{ij} = \sum_{k=1}^n a_{ik}b_{kj}. \quad (6.6)$$

Equation (6.6) can be used to define the $m \times p$ matrix C as the product of a $m \times n$ matrix A and a $n \times p$ matrix B , i.e.,

$$C = AB. \quad (6.7)$$

Our derivation implies that the correspondence between linear maps and matrices respects the product structure.

Proposition 6.6.5. *Let $S : U \rightarrow V$ and $T : V \rightarrow W$ be linear maps. Then*

$$M(TS) = M(T)M(S).$$

Example 6.6.6. With notation as in Examples 6.6.3 and 6.6.4, you should be able to verify that

$$M(TS) = M(T)M(S) = \begin{bmatrix} 2 & 1 \\ 5 & 2 \\ 3 & 1 \end{bmatrix} \begin{bmatrix} 2 & 1 \\ -3 & -2 \end{bmatrix} = \begin{bmatrix} 1 & 0 \\ 4 & 1 \\ 3 & 1 \end{bmatrix}.$$

Given a vector $v \in V$, we can also associate a matrix $M(v)$ to v as follows. Let (v_1, \dots, v_n) be a basis of V . Then there are unique scalars b_1, \dots, b_n such that

$$v = b_1v_1 + \cdots + b_nv_n.$$

The matrix of v is then defined to be the $n \times 1$ matrix

$$M(v) = \begin{bmatrix} b_1 \\ \vdots \\ b_n \end{bmatrix}.$$

Example 6.6.7. The matrix of a vector $x = (x_1, \dots, x_n) \in \mathbb{F}^n$ in the standard basis (e_1, \dots, e_n) is the column vector or $n \times 1$ matrix

$$M(x) = \begin{bmatrix} x_1 \\ \vdots \\ x_n \end{bmatrix}$$

since $x = (x_1, \dots, x_n) = x_1e_1 + \cdots + x_ne_n$.

The next result shows how the notion of a matrix of a linear map $T : V \rightarrow W$ and the matrix of a vector $v \in V$ fit together.

Proposition 6.6.8. *Let $T : V \rightarrow W$ be a linear map. Then, for every $v \in V$,*

$$M(Tv) = M(T)M(v).$$

Proof. Let (v_1, \dots, v_n) be a basis of V and (w_1, \dots, w_m) be a basis for W . Suppose that, with respect to these bases, the matrix of T is $M(T) = (a_{ij})_{1 \leq i \leq m, 1 \leq j \leq n}$. This means that,

for all $j \in \{1, 2, \dots, n\}$,

$$Tv_j = \sum_{k=1}^m a_{kj} w_k.$$

The vector $v \in V$ can be written uniquely as a linear combination of the basis vectors as

$$v = b_1 v_1 + \dots + b_n v_n.$$

Hence,

$$\begin{aligned} Tv &= b_1 Tv_1 + \dots + b_n Tv_n \\ &= b_1 \sum_{k=1}^m a_{k1} w_k + \dots + b_n \sum_{k=1}^m a_{kn} w_k \\ &= \sum_{k=1}^m (a_{k1} b_1 + \dots + a_{kn} b_n) w_k. \end{aligned}$$

This shows that $M(Tv)$ is the $m \times 1$ matrix

$$M(Tv) = \begin{bmatrix} a_{11}b_1 + \dots + a_{1n}b_n \\ \vdots \\ a_{m1}b_1 + \dots + a_{mn}b_n \end{bmatrix}.$$

It is not hard to check, using the formula for matrix multiplication, that $M(T)M(v)$ gives the same result. \square

Example 6.6.9. Take the linear map S from Example 6.6.4 with basis $((1, 2), (0, 1))$ of \mathbb{R}^2 . To determine the action on the vector $v = (1, 4) \in \mathbb{R}^2$, note that $v = (1, 4) = 1(1, 2) + 2(0, 1)$. Hence,

$$M(Sv) = M(S)M(v) = \begin{bmatrix} 2 & 1 \\ -3 & -2 \end{bmatrix} \begin{bmatrix} 1 \\ 2 \end{bmatrix} = \begin{bmatrix} 4 \\ -7 \end{bmatrix}.$$

This means that

$$Sv = 4(1, 2) - 7(0, 1) = (4, 1),$$

which is indeed true.

6.7 Invertibility

Definition 6.7.1. A map $T : V \rightarrow W$ is called **invertible** if there exists a map $S : W \rightarrow V$ such that

$$TS = I_W \quad \text{and} \quad ST = I_V,$$

where $I_V : V \rightarrow V$ is the identity map on V and $I_W : W \rightarrow W$ is the identity map on W . We say that S is an **inverse** of T .

Note that if the map T is invertible, then the inverse is unique. Suppose S and R are inverses of T . Then

$$\begin{aligned} ST &= I_V = RT, \\ TS &= I_W = TR. \end{aligned}$$

Hence,

$$S = S(TR) = (ST)R = R.$$

We denote the unique inverse of an invertible map T by T^{-1} .

Proposition 6.7.2. *A map $T : V \rightarrow W$ is invertible if and only if T is injective and surjective.*

Proof.

(“ \implies ”) Suppose T is invertible.

To show that T is injective, suppose that $u, v \in V$ are such that $Tu = Tv$. Apply the inverse T^{-1} of T to obtain $T^{-1}Tu = T^{-1}Tv$ so that $u = v$. Hence T is injective.

To show that T is surjective, we need to show that, for every $w \in W$, there is a $v \in V$ such that $Tv = w$. Take $v = T^{-1}w \in V$. Then $T(T^{-1}w) = w$. Hence T is surjective.

(“ \impliedby ”) Suppose that T is injective and surjective. We need to show that T is invertible. We define a map $S \in \mathcal{L}(W, V)$ as follows. Since T is surjective, we know that, for every $w \in W$, there exists a $v \in V$ such that $Tv = w$. Moreover, since T is injective, this v is uniquely determined. Hence, define $Sw = v$.

We claim that S is the inverse of T . Note that, for all $w \in W$, we have $TSw = Tv = w$ so that $TS = I_W$. Similarly, for all $v \in V$, we have $STv = Sw = v$ so that $ST = I_V$. \square

Now we specialize to invertible *linear* maps.

Proposition 6.7.3. *Let $T \in \mathcal{L}(V, W)$ be invertible. Then $T^{-1} \in \mathcal{L}(W, V)$.*

Proof.

Certainly $T^{-1} : W \rightarrow V$ so we only need show that T^{-1} is a linear map. For all $w_1, w_2 \in W$, we have

$$T(T^{-1}w_1 + T^{-1}w_2) = T(T^{-1}w_1) + T(T^{-1}w_2) = w_1 + w_2,$$

and so $T^{-1}w_1 + T^{-1}w_2$ is the unique vector v in V such that $Tv = w_1 + w_2 = w$. Hence,

$$T^{-1}w_1 + T^{-1}w_2 = v = T^{-1}w = T^{-1}(w_1 + w_2).$$

The proof that $T^{-1}(aw) = aT^{-1}w$ is similar. For $w \in W$ and $a \in \mathbb{F}$, we have

$$T(aT^{-1}w) = aT(T^{-1}w) = aw$$

so that $aT^{-1}w$ is the unique vector in V that maps to aw . Hence, $T^{-1}(aw) = aT^{-1}w$. \square

Example 6.7.4. The linear map $T(x, y) = (x - 2y, 3x + y)$ is both injective, since $\text{null}(T) = \{0\}$, and surjective, since $\text{range}(T) = \mathbb{R}^2$. Hence, T is invertible by Proposition 6.7.2.

Definition 6.7.5. Two vector spaces V and W are called **isomorphic** if there exists an invertible linear map $T \in \mathcal{L}(V, W)$.

Theorem 6.7.6. *Two finite-dimensional vector spaces V and W over \mathbb{F} are isomorphic if and only if $\dim(V) = \dim(W)$.*

Proof.

(“ \implies ”) Suppose V and W are isomorphic. Then there exists an invertible linear map $T \in \mathcal{L}(V, W)$. Since T is invertible, it is injective and surjective, and so $\text{null}(T) = \{0\}$ and $\text{range}(T) = W$. Using the Dimension Formula, this implies that

$$\dim(V) = \dim(\text{null}(T)) + \dim(\text{range}(T)) = \dim(W).$$

(“ \impliedby ”) Suppose that $\dim(V) = \dim(W)$. Let (v_1, \dots, v_n) be a basis of V and (w_1, \dots, w_n) be a basis of W . Define the linear map $T : V \rightarrow W$ as

$$T(a_1v_1 + \dots + a_nv_n) = a_1w_1 + \dots + a_nw_n.$$

Since the scalars $a_1, \dots, a_n \in \mathbb{F}$ are arbitrary and (w_1, \dots, w_n) spans W , this means that $\text{range}(T) = W$ and T is surjective. Also, since (w_1, \dots, w_n) is linearly independent, T is injective (since $a_1 w_1 + \dots + a_n w_n = 0$ implies that all $a_1 = \dots = a_n = 0$ and hence only the zero vector is mapped to zero). It follows that T is both injective and surjective; hence, by Proposition 6.7.2, T is invertible. Therefore, V and W are isomorphic. \square

We close this chapter by considering the case of linear maps having equal domain and codomain. As in Definition 6.1.1, a linear map $T \in \mathcal{L}(V, V)$ is called a **linear operator** on V . As the following remarkable theorem shows, the notions of injectivity, surjectivity, and invertibility of a linear operator T are the same — as long as V is finite-dimensional. A similar result does not hold for infinite-dimensional vector spaces. For example, the set of all polynomials $\mathbb{F}[z]$ is an infinite-dimensional vector space, and we saw that the differentiation map on $\mathbb{F}[z]$ is surjective but not injective.

Theorem 6.7.7. *Let V be a finite-dimensional vector space and $T : V \rightarrow V$ be a linear map. Then the following are equivalent:*

1. T is invertible.
2. T is injective.
3. T is surjective.

Proof. By Proposition 6.7.2, Part 1 implies Part 2.

Next we show that Part 2 implies Part 3. If T is injective, then we know that $\text{null}(T) = \{0\}$. Hence, by the Dimension Formula, we have

$$\dim(\text{range}(T)) = \dim(V) - \dim(\text{null}(T)) = \dim(V).$$

Since $\text{range}(T) \subset V$ is a subspace of V , this implies that $\text{range}(T) = V$, and so T is surjective.

Finally, we show that Part 3 implies Part 1. Since T is surjective by assumption, we have $\text{range}(T) = V$. Thus, by again using the Dimension Formula,

$$\dim(\text{null}(T)) = \dim(V) - \dim(\text{range}(T)) = 0,$$

and so $\text{null}(T) = \{0\}$, from which T is injective. By Proposition 6.7.2, an injective and surjective linear map is invertible. \square

Exercises for Chapter 6

Computational Exercises

1. Define the map $T : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ by $T(x, y) = (x + y, x)$.
 - (a) Show that T is linear.
 - (b) Show that T is surjective.
 - (c) Find $\dim(\text{null}(T))$.
 - (d) Find the matrix for T with respect to the canonical basis of \mathbb{R}^2 .
 - (e) Find the matrix for T with respect to the canonical basis for the domain \mathbb{R}^2 and the basis $((1, 1), (1, -1))$ for the target space \mathbb{R}^2 .
 - (f) Show that the map $F : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ given by $F(x, y) = (x + y, x + 1)$ is not linear.
2. Let $T \in \mathcal{L}(\mathbb{R}^2)$ be defined by

$$T \begin{pmatrix} x \\ y \end{pmatrix} = \begin{pmatrix} y \\ -x \end{pmatrix}, \quad \text{for all } \begin{pmatrix} x \\ y \end{pmatrix} \in \mathbb{R}^2.$$

6. Show that no linear map $T : \mathbb{F}^5 \rightarrow \mathbb{F}^2$ can have as its null space the set

7. Describe the set of solutions $x = (x_1, x_2, x_3) \in \mathbb{R}^3$ of the system of equations

- Let V and W be vector spaces over \mathbb{F} with V finite-dimensional, and let U be any subspace of V . Given a linear map $S \in \mathcal{L}(U, W)$, prove that there exists a linear map $T \in \mathcal{L}(V, W)$ such that, for every $u \in U$, $S(u) = T(u)$.
- Let V and W be vector spaces over \mathbb{F} , and suppose that $T \in \mathcal{L}(V, W)$ is injective. Given a linearly independent list (v_1, \dots, v_n) of vectors in V , prove that the list $(T(v_1), \dots, T(v_n))$ is linearly independent in W .
- Let U , V , and W be vector spaces over \mathbb{F} , and suppose that the linear maps $S \in \mathcal{L}(U, V)$ and $T \in \mathcal{L}(V, W)$ are both injective. Prove that the composition map $T \circ S$ is injective.

Chapter 7

Eigenvalues and Eigenvectors

In this chapter we study linear operators $T : V \rightarrow V$ on a finite-dimensional vector space V . We are interested in understanding when there is a basis B for V such that the matrix $M(T)$ of T with respect to B has a particularly nice form. In particular, we would like $M(T)$ to be either upper triangular or diagonal. This quest leads us to the notions of eigenvalues and eigenvectors of a linear operator, which is one of the most important concepts in Linear Algebra and beyond. For example, quantum mechanics is largely based upon the study of eigenvalues and eigenvectors of operators on infinite-dimensional vector spaces.

7.1 Invariant subspaces

To begin our study, we will look at subspaces U of V that have special properties under an operator $T \in \mathcal{L}(V, V)$.

Definition 7.1.1. Let V be a finite-dimensional vector space over \mathbb{F} with $\dim(V) \geq 1$, and let $T \in \mathcal{L}(V, V)$ be an operator in V . Then a subspace $U \subset V$ is called an **invariant subspace under T** if

$$Tu \in U \quad \text{for all } u \in U.$$

That is, U is invariant under T if the image of every vector in U under T remains within U . We denote this as $TU = \{Tu \mid u \in U\} \subset U$.

Example 7.1.2. The subspaces $\text{null}(T)$ and $\text{range}(T)$ are invariant subspaces under T . To see this, let $u \in \text{null}(T)$. This means that $Tu = 0$. But, since $0 \in \text{null}(T)$, this implies that

$Tu = 0 \in \text{null}(T)$. Similarly, let $u \in \text{range}(T)$. Since $Tv \in \text{range}(T)$ for all $v \in V$, we certainly also have that $Tu \in \text{range}(T)$.

Example 7.1.3. Take the linear operator $T : \mathbb{R}^3 \rightarrow \mathbb{R}^3$ corresponding to the matrix

$$\begin{bmatrix} 1 & 2 & 0 \\ 1 & 1 & 0 \\ 0 & 0 & 2 \end{bmatrix}$$

with respect to the basis (e_1, e_2, e_3) . Then $\text{span}(e_1, e_2)$ and $\text{span}(e_3)$ are both invariant subspaces under T .

An important special case is the case of Definition 7.1.1 involves one-dimensional invariant subspaces under an operator $T \in \mathcal{L}(V, V)$. If $\dim(U) = 1$, then there exists a nonzero vector $u \in V$ such that

$$U = \{au \mid a \in \mathbb{F}\}.$$

In this case, we must have

$$Tu = \lambda u \quad \text{for some } \lambda \in \mathbb{F}.$$

This motivates the definitions of eigenvectors and eigenvalues of a linear operator, as given in the next section.

7.2 Eigenvalues

Definition 7.2.1. Let $T \in \mathcal{L}(V, V)$. Then $\lambda \in \mathbb{F}$ is an **eigenvalue** of T if there exists a nonzero vector $u \in V$ such that

$$Tu = \lambda u.$$

The vector u is called an **eigenvector** of T **corresponding to** the eigenvalue λ .

Finding the eigenvalues and eigenvectors of a linear operator is one of the most important problems in Linear Algebra. We will see later that this so-called “eigen-information” has many uses and applications. (As an example, quantum mechanics is based upon understanding the eigenvalues and eigenvectors of operators on specifically defined vector spaces. These vector spaces are often infinite-dimensional, though, and so we do not consider them further in these notes.)

Example 7.2.2.

1. Let T be the zero map defined by $T(v) = 0$ for all $v \in V$. Then every vector $u \neq 0$ is an eigenvector of T with eigenvalue 0.
2. Let I be the identity map defined by $I(v) = v$ for all $v \in V$. Then every vector $u \neq 0$ is an eigenvector of T with eigenvalue 1.
3. The projection map $P : \mathbb{R}^3 \rightarrow \mathbb{R}^3$ defined by $P(x, y, z) = (x, y, 0)$ has eigenvalues 0 and 1. The vector $(0, 0, 1)$ is an eigenvector with eigenvalue 0, and both $(1, 0, 0)$ and $(0, 1, 0)$ are eigenvectors with eigenvalue 1.
4. Take the operator $R : \mathbb{F}^2 \rightarrow \mathbb{F}^2$ defined by $R(x, y) = (-y, x)$. When $\mathbb{F} = \mathbb{R}$, R can be interpreted as counterclockwise rotation by 90° . From this interpretation, it is clear that no non-zero vector in \mathbb{R}^2 is mapped to a scalar multiple of itself. Hence, for $\mathbb{F} = \mathbb{R}$, the operator R has no eigenvalues.

For $\mathbb{F} = \mathbb{C}$, though, the situation is significantly different! In this case, $\lambda \in \mathbb{C}$ is an eigenvalue of R if

$$R(x, y) = (-y, x) = \lambda(x, y)$$

so that $y = -\lambda x$ and $x = \lambda y$. This implies that $y = -\lambda^2 y$, i.e., that $\lambda^2 = -1$. The solutions are hence $\lambda = \pm i$. One can check that $(1, -i)$ is an eigenvector with eigenvalue i and that $(1, i)$ is an eigenvector with eigenvalue $-i$.

Eigenspaces are important examples of invariant subspaces. Let $T \in \mathcal{L}(V, V)$, and let $\lambda \in \mathbb{F}$ be an eigenvalue of T . Then

$$V_\lambda = \{v \in V \mid Tv = \lambda v\}$$

is called an **eigenspace** of T . Equivalently,

$$V_\lambda = \text{null}(T - \lambda I).$$

Note that $V_\lambda \neq \{0\}$ since λ is an eigenvalue if and only if there exists a nonzero vector $u \in V$ such that $Tu = \lambda u$. We can reformulate this as follows:

- $\lambda \in \mathbb{F}$ is an eigenvalue of T if and only if the operator $T - \lambda I$ is not injective.

Since the notion of injectivity, surjectivity, and invertibility are equivalent for operators on a finite-dimensional vector space, we can equivalently say either of the following:

- $\lambda \in \mathbb{F}$ is an eigenvalue of T if and only if the operator $T - \lambda I$ is not surjective.
- $\lambda \in \mathbb{F}$ is an eigenvalue of T if and only if the operator $T - \lambda I$ is not invertible.

We close this section with two fundamental facts about eigenvalues and eigenvectors.

Theorem 7.2.3. *Let $T \in \mathcal{L}(V, V)$, and let $\lambda_1, \dots, \lambda_m \in \mathbb{F}$ be m distinct eigenvalues of T with corresponding nonzero eigenvectors v_1, \dots, v_m . Then (v_1, \dots, v_m) is linearly independent.*

Proof. Suppose that (v_1, \dots, v_m) is linearly dependent. Then, by the Linear Dependence Lemma, there exists an index $k \in \{2, \dots, m\}$ such that

$$v_k \in \text{span}(v_1, \dots, v_{k-1})$$

and such that (v_1, \dots, v_{k-1}) is linearly independent. This means that there exist scalars $a_1, \dots, a_{k-1} \in \mathbb{F}$ such that

$$v_k = a_1 v_1 + \dots + a_{k-1} v_{k-1}. \quad (7.1)$$

Applying T to both sides yields, using the fact that v_j is an eigenvector with eigenvalue λ_j ,

$$\lambda_k v_k = a_1 \lambda_1 v_1 + \dots + a_{k-1} \lambda_{k-1} v_{k-1}.$$

Subtracting λ_k times Equation (7.1) from this, we obtain

$$0 = (\lambda_k - \lambda_1) a_1 v_1 + \dots + (\lambda_k - \lambda_{k-1}) a_{k-1} v_{k-1}.$$

Since (v_1, \dots, v_{k-1}) is linearly independent, we must have $(\lambda_k - \lambda_j) a_j = 0$ for all $j = 1, 2, \dots, k-1$. By assumption, all eigenvalues are distinct, so $\lambda_k - \lambda_j \neq 0$, which implies that $a_j = 0$ for all $j = 1, 2, \dots, k-1$. But then, by Equation (7.1), $v_k = 0$, which contradicts the assumption that all eigenvectors are nonzero. Hence (v_1, \dots, v_m) is linearly independent. \square

Corollary 7.2.4. *Any operator $T \in \mathcal{L}(V, V)$ has at most $\dim(V)$ distinct eigenvalues.*

Proof. Let $\lambda_1, \dots, \lambda_m$ be distinct eigenvalues of T , and let v_1, \dots, v_m be corresponding nonzero eigenvectors. By Theorem 7.2.3, the list (v_1, \dots, v_m) is linearly independent. Hence $m \leq \dim(V)$. \square

7.3 Diagonal matrices

Note that if T has $n = \dim(V)$ distinct eigenvalues, then there exists a basis (v_1, \dots, v_n) of V such that

$$Tv_j = \lambda_j v_j, \quad \text{for all } j = 1, 2, \dots, n.$$

Then any $v \in V$ can be written as a linear combination $v = a_1 v_1 + \dots + a_n v_n$ of v_1, \dots, v_n . Applying T to this, we obtain

$$Tv = \lambda_1 a_1 v_1 + \dots + \lambda_n a_n v_n.$$

Hence the vector

$$M(v) = \begin{bmatrix} a_1 \\ \vdots \\ a_n \end{bmatrix}$$

is mapped to

$$M(Tv) = \begin{bmatrix} \lambda_1 a_1 \\ \vdots \\ \lambda_n a_n \end{bmatrix}.$$

This means that the matrix $M(T)$ for T with respect to the basis of eigenvectors (v_1, \dots, v_n) is **diagonal**, and so we call T **diagonalizable**:

$$M(T) = \begin{bmatrix} \lambda_1 & & 0 \\ & \ddots & \\ 0 & & \lambda_n \end{bmatrix}.$$

We summarize the results of the above discussion in the following Proposition.

Proposition 7.3.1. *If $T \in \mathcal{L}(V, V)$ has $\dim(V)$ distinct eigenvalues, then $M(T)$ is diagonal with respect to some basis of V . Moreover, V has a basis consisting of eigenvectors of T .*

7.4 Existence of eigenvalues

In what follows, we want to study the question of when eigenvalues exist for a given operator T . To answer this question, we will use polynomials $p(z) \in \mathbb{F}[z]$ evaluated on operators $T \in \mathcal{L}(V, V)$ (or, equivalently, on square matrices $A \in \mathbb{F}^{n \times n}$). More explicitly, given a polynomial

$$p(z) = a_0 + a_1z + \cdots + a_kz^k$$

we can associate the operator

$$p(T) = a_0I_V + a_1T + \cdots + a_kT^k.$$

Note that, for $p(z), q(z) \in \mathbb{F}[z]$, we have

$$(pq)(T) = p(T)q(T) = q(T)p(T).$$

The results of this section will be for complex vector spaces. This is because the proof of the existence of eigenvalues relies on the Fundamental Theorem of Algebra from Chapter 3, which makes a statement about the existence of zeroes of polynomials over \mathbb{C} .

Theorem 7.4.1. *Let $V \neq \{0\}$ be a finite-dimensional vector space over \mathbb{C} , and let $T \in \mathcal{L}(V, V)$. Then T has at least one eigenvalue.*

Proof. Let $v \in V$ with $v \neq 0$, and consider the list of vectors

$$(v, Tv, T^2v, \dots, T^n v),$$

where $n = \dim(V)$. Since the list contains $n + 1$ vectors, it must be linearly dependent. Hence, there exist scalars $a_0, a_1, \dots, a_n \in \mathbb{C}$, not all zero, such that

$$0 = a_0v + a_1Tv + a_2T^2v + \cdots + a_nT^n v.$$

Let m be largest index for which $a_m \neq 0$. Since $v \neq 0$, we must have $m > 0$ (but possibly $m = n$). Consider the polynomial

$$p(z) = a_0 + a_1z + \cdots + a_mz^m.$$

By Theorem 3.2.2 (3) it can be factored as

$$p(z) = c(z - \lambda_1) \cdots (z - \lambda_m),$$

where $c, \lambda_1, \dots, \lambda_m \in \mathbb{C}$ and $c \neq 0$.

Therefore,

$$\begin{aligned} 0 &= a_0v + a_1Tv + a_2T^2v + \cdots + a_nT^nv = p(T)v \\ &= c(T - \lambda_1I)(T - \lambda_2I) \cdots (T - \lambda_mI)v, \end{aligned}$$

and so at least one of the factors $T - \lambda_jI$ must be noninjective. In other words, this λ_j is an eigenvalue of T . \square

Note that the proof of Theorem 7.4.1 only uses basic concepts about linear maps, which is the same approach as in a popular textbook called *Linear Algebra Done Right* by Sheldon Axler. Many other textbooks rely on significantly more difficult proofs using concepts like the determinant and characteristic polynomial of a matrix. At the same time, it is often preferable to use the characteristic polynomial of a matrix in order to compute eigen-information of an operator; we discuss this approach in Chapter 8.

Note also that Theorem 7.4.1 does not hold for real vector spaces. E.g., as we saw in Example 7.2.2, the rotation operator R on \mathbb{R}^2 has no eigenvalues.

7.5 Upper triangular matrices

As before, let V be a complex vector space.

Let $T \in \mathcal{L}(V, V)$ and (v_1, \dots, v_n) be a basis for V . Recall that we can associate a matrix $M(T) \in \mathbb{C}^{n \times n}$ to the operator T . By Theorem 7.4.1, we know that T has at least one eigenvalue, say $\lambda \in \mathbb{C}$. Let $v_1 \neq 0$ be an eigenvector corresponding to λ . By the Basis Extension Theorem, we can extend the list (v_1) to a basis of V . Since $Tv_1 = \lambda v_1$, the first

column of $M(T)$ with respect to this basis is

$$\begin{bmatrix} \lambda \\ 0 \\ \vdots \\ 0 \end{bmatrix}.$$

What we will show next is that we can find a basis of V such that the matrix $M(T)$ is **upper triangular**.

Definition 7.5.1. A matrix $A = (a_{ij}) \in \mathbb{F}^{n \times n}$ is called **upper triangular** if $a_{ij} = 0$ for $i > j$.

Schematically, an upper triangular matrix has the form

$$\begin{bmatrix} * & & * \\ & \ddots & \\ 0 & & * \end{bmatrix},$$

where the entries $*$ can be anything and every entry below the main diagonal is zero.

Some of the reasons why upper triangular matrices are so fantastic are that

1. the eigenvalues are on the diagonal (as we will see later);
2. it is easy to solve the corresponding system of linear equations by back substitution (as discussed in Section 12.3).

The next proposition tells us what upper triangularity means in terms of linear operators and invariant subspaces.

Proposition 7.5.2. *Suppose $T \in \mathcal{L}(V, V)$ and that (v_1, \dots, v_n) is a basis of V . Then the following statements are equivalent:*

1. *the matrix $M(T)$ with respect to the basis (v_1, \dots, v_n) is upper triangular;*
2. *$Tv_k \in \text{span}(v_1, \dots, v_k)$ for each $k = 1, 2, \dots, n$;*
3. *$\text{span}(v_1, \dots, v_k)$ is invariant under T for each $k = 1, 2, \dots, n$.*

Proof. The equivalence of Condition 1 and Condition 2 follows easily from the definition since Condition 2 implies that the matrix elements below the diagonal are zero.

Obviously, Condition 3 implies Condition 2. To show that Condition 2 implies Condition 3, note that any vector $v \in \text{span}(v_1, \dots, v_k)$ can be written as $v = a_1v_1 + \dots + a_kv_k$. Applying T , we obtain

$$Tv = a_1Tv_1 + \dots + a_kTv_k \in \text{span}(v_1, \dots, v_k)$$

since, by Condition 2, each $Tv_j \in \text{span}(v_1, \dots, v_j) \subset \text{span}(v_1, \dots, v_k)$ for $j = 1, 2, \dots, k$ and since the span is a subspace of V . \square

The next theorem shows that complex vector spaces indeed have some basis for which the matrix of a given operator is upper triangular.

Theorem 7.5.3. *Let V be a finite-dimensional vector space over \mathbb{C} and $T \in \mathcal{L}(V, V)$. Then there exists a basis B for V such that $M(T)$ is upper triangular with respect to B .*

Proof. We proceed by induction on $\dim(V)$. If $\dim(V) = 1$, then there is nothing to prove.

Hence, assume that $\dim(V) = n > 1$ and that we have proven the result of the theorem for all $T \in \mathcal{L}(W, W)$, where W is a complex vector space with $\dim(W) \leq n - 1$. By Theorem 7.4.1, T has at least one eigenvalue λ . Define

$$U = \text{range}(T - \lambda I),$$

and note that

1. $\dim(U) < \dim(V) = n$ since λ is an eigenvalue of T and hence $T - \lambda I$ is not surjective;
2. U is an invariant subspace of T since, for all $u \in U$, we have

$$Tu = (T - \lambda I)u + \lambda u,$$

which implies that $Tu \in U$ since $(T - \lambda I)u \in \text{range}(T - \lambda I) = U$ and $\lambda u \in U$.

Therefore, we may consider the operator $S = T|_U$, which is the operator obtained by restricting T to the subspace U . By the induction hypothesis, there exists a basis (u_1, \dots, u_m)

of U with $m \leq n - 1$ such that $M(S)$ is upper triangular with respect to (u_1, \dots, u_m) . This means that

$$Tu_j = Su_j \in \text{span}(u_1, \dots, u_j), \quad \text{for all } j = 1, 2, \dots, m.$$

Extend this to a basis $(u_1, \dots, u_m, v_1, \dots, v_k)$ of V . Then

$$Tv_j = (T - \lambda I)v_j + \lambda v_j, \quad \text{for all } j = 1, 2, \dots, k.$$

Since $(T - \lambda I)v_j \in \text{range}(T - \lambda I) = U = \text{span}(u_1, \dots, u_m)$, we have that

$$Tv_j \in \text{span}(u_1, \dots, u_m, v_1, \dots, v_j), \quad \text{for all } j = 1, 2, \dots, k.$$

Hence, T is upper triangular with respect to the basis $(u_1, \dots, u_m, v_1, \dots, v_k)$. □

The following are two very important facts about upper triangular matrices and their associated operators.

Proposition 7.5.4. *Suppose $T \in \mathcal{L}(V, V)$ is a linear operator and that $M(T)$ is upper triangular with respect to some basis of V . Then*

1. *T is invertible if and only if all entries on the diagonal of $M(T)$ are nonzero.*
2. *The eigenvalues of T are precisely the diagonal elements of $M(T)$.*

Proof of Proposition 7.5.4, Part 1. Let (v_1, \dots, v_n) be a basis of V such that

$$M(T) = \begin{bmatrix} \lambda_1 & & * \\ & \ddots & \\ 0 & & \lambda_n \end{bmatrix}$$

is upper triangular. The claim is that T is invertible if and only if $\lambda_k \neq 0$ for all $k = 1, 2, \dots, n$. Equivalently, this can be reformulated as follows: T is not invertible if and only if $\lambda_k = 0$ for at least one $k \in \{1, 2, \dots, n\}$.

Suppose $\lambda_k = 0$. We will show that this implies the non-invertibility of T . If $k = 1$, this is obvious since then $Tv_1 = 0$, which implies that $v_1 \in \text{null}(T)$ so that T is not injective and hence not invertible. So assume that $k > 1$. Then

$$Tv_j \in \text{span}(v_1, \dots, v_{k-1}), \quad \text{for all } j \leq k,$$

since T is upper triangular and $\lambda_k = 0$. Hence, we may define $S = T|_{\text{span}(v_1, \dots, v_k)}$ to be the restriction of T to the subspace $\text{span}(v_1, \dots, v_k)$ so that

$$S : \text{span}(v_1, \dots, v_k) \rightarrow \text{span}(v_1, \dots, v_{k-1}).$$

The linear map S is not injective since the dimension of the domain is larger than the dimension of its codomain, i.e.,

$$\dim(\text{span}(v_1, \dots, v_k)) = k > k - 1 = \dim(\text{span}(v_1, \dots, v_{k-1})).$$

Hence, there exists a vector $0 \neq v \in \text{span}(v_1, \dots, v_k)$ such that $Sv = Tv = 0$. This implies that T is also not injective and therefore also not invertible.

Now suppose that T is not invertible. We need to show that at least one $\lambda_k = 0$. The linear map T not being invertible implies that T is not injective. Hence, there exists a vector $0 \neq v \in V$ such that $Tv = 0$, and we can write

$$v = a_1v_1 + \cdots + a_kv_k$$

for some k , where $a_k \neq 0$. Then

$$0 = Tv = (a_1Tv_1 + \cdots + a_{k-1}Tv_{k-1}) + a_kTv_k. \quad (7.2)$$

Since T is upper triangular with respect to the basis (v_1, \dots, v_n) , we know that $a_1Tv_1 + \cdots + a_{k-1}Tv_{k-1} \in \text{span}(v_1, \dots, v_{k-1})$. Hence, Equation (7.2) shows that $Tv_k \in \text{span}(v_1, \dots, v_{k-1})$, which implies that $\lambda_k = 0$. \square

Proof of Proposition 7.5.4, Part 2. Recall that $\lambda \in \mathbb{F}$ is an eigenvalue of T if and only if the operator $T - \lambda I$ is not invertible. Let (v_1, \dots, v_n) be a basis such that $M(T)$ is upper triangular. Then

$$M(T - \lambda I) = \begin{bmatrix} \lambda_1 - \lambda & & * \\ & \ddots & \\ 0 & & \lambda_n - \lambda \end{bmatrix}.$$

Hence, by Proposition 7.5.4(1), $T - \lambda I$ is not invertible if and only if $\lambda = \lambda_k$ for some k . \square

7.6 Diagonalization of 2×2 matrices and Applications

Let $A = \begin{bmatrix} a & b \\ c & d \end{bmatrix} \in \mathbb{F}^{2 \times 2}$, and recall that we can define a linear operator $T \in \mathcal{L}(\mathbb{F}^2)$ on \mathbb{F}^2 by setting $T(v) = Av$ for each $v = \begin{bmatrix} v_1 \\ v_2 \end{bmatrix} \in \mathbb{F}^2$.

One method for finding the eigen-information of T is to analyze the solutions of the matrix equation $Av = \lambda v$ for $\lambda \in \mathbb{F}$ and $v \in \mathbb{F}^2$. In particular, using the definition of eigenvector and eigenvalue, v is an eigenvector associated to the eigenvalue λ if and only if $Av = T(v) = \lambda v$.

A simpler method involves the equivalent matrix equation $(A - \lambda I)v = 0$, where I denotes the identity map on \mathbb{F}^2 . In particular, $0 \neq v \in \mathbb{F}^2$ is an eigenvector for T associated to the eigenvalue $\lambda \in \mathbb{F}$ if and only if the system of linear equations

$$\left. \begin{aligned} (a - \lambda)v_1 + \quad \quad \quad bv_2 &= 0 \\ \quad \quad \quad cv_1 + (d - \lambda)v_2 &= 0 \end{aligned} \right\} \quad (7.3)$$

has a non-trivial solution. Moreover, System (7.3) has a non-trivial solution if and only if the polynomial $p(\lambda) = (a - \lambda)(d - \lambda) - bc$ evaluates to zero. (See see Proof-writing Exercise 12 on page 101.)

In other words, the eigenvalues for T are exactly the $\lambda \in \mathbb{F}$ for which $p(\lambda) = 0$, and the eigenvectors for T associated to an eigenvalue λ are exactly the non-zero vectors $v = \begin{bmatrix} v_1 \\ v_2 \end{bmatrix} \in \mathbb{F}^2$ that satisfy System (7.3).

Example 7.6.1. Let $A = \begin{bmatrix} -2 & -1 \\ 5 & 2 \end{bmatrix}$. Then $p(\lambda) = (-2 - \lambda)(2 - \lambda) - (-1)(5) = \lambda^2 + 1$, which is equal to zero exactly when $\lambda = \pm i$. Moreover, if $\lambda = i$, then the System (7.3) becomes

$$\left. \begin{aligned} (-2 - i)v_1 - \quad \quad \quad v_2 &= 0 \\ \quad \quad \quad 5v_1 + (2 - i)v_2 &= 0 \end{aligned} \right\},$$

which is satisfied by any vector $v = \begin{bmatrix} v_1 \\ v_2 \end{bmatrix} \in \mathbb{C}^2$ such that $v_2 = (-2 - i)v_1$. Similarly, if

$\lambda = -i$, then the System (7.3) becomes

$$\left. \begin{aligned} (-2 + i)v_1 - v_2 &= 0 \\ 5v_1 + (2 + i)v_2 &= 0 \end{aligned} \right\},$$

which is satisfied by any vector $v = \begin{bmatrix} v_1 \\ v_2 \end{bmatrix} \in \mathbb{C}^2$ such that $v_2 = (-2 + i)v_1$.

It follows that, given $A = \begin{bmatrix} -2 & -1 \\ 5 & 2 \end{bmatrix}$, the linear operator on \mathbb{C}^2 defined by $T(v) = Av$ has eigenvalues $\lambda = \pm i$, with associated eigenvectors as described above.

Example 7.6.2. Take the rotation $R_\theta : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ by an angle $\theta \in [0, 2\pi)$ given by the matrix

$$R_\theta = \begin{bmatrix} \cos \theta & -\sin \theta \\ \sin \theta & \cos \theta \end{bmatrix}$$

Then we obtain the eigenvalues by solving the polynomial equation

$$\begin{aligned} p(\lambda) &= (\cos \theta - \lambda)^2 + \sin^2 \theta \\ &= \lambda^2 - 2\lambda \cos \theta + 1 = 0, \end{aligned}$$

where we have used the fact that $\sin^2 \theta + \cos^2 \theta = 1$. Solving for λ in \mathbb{C} , we obtain

$$\lambda = \cos \theta \pm \sqrt{\cos^2 \theta - 1} = \cos \theta \pm \sqrt{-\sin^2 \theta} = \cos \theta \pm i \sin \theta = e^{\pm i\theta}.$$

We see that, as an operator over the real vector space \mathbb{R}^2 , the operator R_θ only has eigenvalues when $\theta = 0$ or $\theta = \pi$. However, if we interpret the vector $\begin{bmatrix} x_1 \\ x_2 \end{bmatrix} \in \mathbb{R}^2$ as a complex number $z = x_1 + ix_2$, then z is an eigenvector if $R_\theta : \mathbb{C} \rightarrow \mathbb{C}$ maps $z \mapsto \lambda z = e^{\pm i\theta} z$. Moreover, from Section 2.3.2, we know that multiplication by $e^{\pm i\theta}$ corresponds to rotation by the angle $\pm\theta$.

Exercises for Chapter 7

Computational Exercises

1. Let $T \in \mathcal{L}(\mathbb{F}^2, \mathbb{F}^2)$ be defined by

$$T(u, v) = (v, u)$$

for every $u, v \in \mathbb{F}$. Compute the eigenvalues and associated eigenvectors for T .

2. Let $T \in \mathcal{L}(\mathbb{F}^3, \mathbb{F}^3)$ be defined by

$$T(u, v, w) = (2v, 0, 5w)$$

for every $u, v, w \in \mathbb{F}$. Compute the eigenvalues and associated eigenvectors for T .

3. Let $n \in \mathbb{Z}_+$ be a positive integer and $T \in \mathcal{L}(\mathbb{F}^n, \mathbb{F}^n)$ be defined by

$$T(x_1, \dots, x_n) = (x_1 + \dots + x_n, \dots, x_1 + \dots + x_n)$$

for every $x_1, \dots, x_n \in \mathbb{F}$. Compute the eigenvalues and associated eigenvectors for T .

4. Find eigenvalues and associated eigenvectors for the linear operators on \mathbb{F}^2 defined by each given 2×2 matrix.

$$\begin{array}{lll} \text{(a)} \begin{bmatrix} 3 & 0 \\ 8 & -1 \end{bmatrix} & \text{(b)} \begin{bmatrix} 10 & -9 \\ 4 & -2 \end{bmatrix} & \text{(c)} \begin{bmatrix} 0 & 3 \\ 4 & 0 \end{bmatrix} \\ \text{(d)} \begin{bmatrix} -2 & -7 \\ 1 & 2 \end{bmatrix} & \text{(e)} \begin{bmatrix} 0 & 0 \\ 0 & 0 \end{bmatrix} & \text{(f)} \begin{bmatrix} 1 & 0 \\ 0 & 1 \end{bmatrix} \end{array}$$

Hint: Use the fact that, given a matrix $A = \begin{bmatrix} a & b \\ c & d \end{bmatrix} \in \mathbb{F}^{2 \times 2}$, $\lambda \in \mathbb{F}$ is an eigenvalue for A if and only if $(a - \lambda)(d - \lambda) - bc = 0$.

5. For each matrix A below, find eigenvalues for the induced linear operator T on \mathbb{F}^n without performing any calculations. Then describe the eigenvectors $v \in \mathbb{F}^n$ associated to each eigenvalue λ by looking at solutions to the matrix equation $(A - \lambda I)v = 0$,

where I denotes the identity map on \mathbb{F}^n .

$$(a) \begin{bmatrix} -1 & 6 \\ 0 & 5 \end{bmatrix}, \quad (b) \begin{bmatrix} -\frac{1}{3} & 0 & 0 & 0 \\ 0 & -\frac{1}{3} & 0 & 0 \\ 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & \frac{1}{2} \end{bmatrix}, \quad (c) \begin{bmatrix} 1 & 3 & 7 & 11 \\ 0 & \frac{1}{2} & 3 & 8 \\ 0 & 0 & 0 & 4 \\ 0 & 0 & 0 & 2 \end{bmatrix}$$

$$(a) \begin{bmatrix} 4 & -1 \\ 2 & 1 \end{bmatrix}, \quad (b) \begin{bmatrix} 0 & 1 \\ -1 & 0 \end{bmatrix}, \quad (c) \begin{bmatrix} 2 & 3 \\ 0 & 2 \end{bmatrix}, \quad (d) \begin{bmatrix} 1 & 0 \\ 0 & 0 \end{bmatrix}$$

7. Let $T \in \mathcal{L}(\mathbb{R}^2)$ be defined by

$$T \begin{pmatrix} x \\ y \end{pmatrix} = \begin{pmatrix} y \\ x + y \end{pmatrix}, \quad \text{for all } \begin{pmatrix} x \\ y \end{pmatrix} \in \mathbb{R}^2.$$

Define two real numbers λ_+ and λ_- as follows:

$$\lambda_+ = \frac{1 + \sqrt{5}}{2}, \quad \lambda_- = \frac{1 - \sqrt{5}}{2}.$$

- (a) Find the matrix of T with respect to the canonical basis for \mathbb{R}^2 (both as the domain and the codomain of T ; call this matrix A).
- (b) Verify that λ_+ and λ_- are eigenvalues of T by showing that v_+ and v_- are eigenvectors, where

$$v_+ = \begin{pmatrix} 1 \\ \lambda_+ \end{pmatrix}, \quad v_- = \begin{pmatrix} 1 \\ \lambda_- \end{pmatrix}.$$

Proof-Writing Exercises

1. Let V be a finite-dimensional vector space over \mathbb{F} with $T \in \mathcal{L}(V, V)$, and let U_1, \dots, U_m be subspaces of V that are invariant under T . Prove that $U_1 + \dots + U_m$ must then also be an invariant subspace of V under T .
2. Let V be a finite-dimensional vector space over \mathbb{F} with $T \in \mathcal{L}(V, V)$, and suppose that U_1 and U_2 are subspaces of V that are invariant under T . Prove that $U_1 \cap U_2$ is also an invariant subspace of V under T .
3. Let V be a finite-dimensional vector space over \mathbb{F} with $T \in \mathcal{L}(V, V)$ invertible and $\lambda \in \mathbb{F} \setminus \{0\}$. Prove λ is an eigenvalue for T if and only if λ^{-1} is an eigenvalue for T^{-1} .
4. Let V be a finite-dimensional vector space over \mathbb{F} , and suppose that $T \in \mathcal{L}(V, V)$ has the property that every $v \in V$ is an eigenvector for T . Prove that T must then be a scalar multiple of the identity function on V .

Claim. Let V be a finite-dimensional vector space over \mathbb{F} , and let $T \in \mathcal{L}(V)$ be a linear operator on V . If the matrix for T with respect to some basis on V has all non-zero elements on the diagonal, then T is invertible.

10. Let V be a finite-dimensional vector space over \mathbb{F} , and let $S, T \in \mathcal{L}(V)$ be linear operators on V . Suppose that T has $\dim(V)$ distinct eigenvalues and that, given any eigenvector $v \in V$ for T associated to some eigenvalue $\lambda \in \mathbb{F}$, v is also an eigenvector for S associated to some (possibly distinct) eigenvalue $\mu \in \mathbb{F}$. Prove that $T \circ S = S \circ T$.
11. Let V be a finite-dimensional vector space over \mathbb{F} , and suppose that the linear operator $P \in \mathcal{L}(V)$ has the property that $P^2 = P$. Prove that $V = \text{null}(P) \oplus \text{range}(P)$.
12. (a) Let $a, b, c, d \in \mathbb{F}$ and consider the system of equations given by

$$ax_1 + bx_2 = 0 \tag{7.4}$$

$$cx_1 + dx_2 = 0. \tag{7.5}$$

Note that $x_1 = x_2 = 0$ is a solution for any choice of a, b, c , and d . Prove that this system of equations has a non-trivial solution if and only if $ad - bc = 0$.

Chapter 8

Permutations and the Determinant of a Square Matrix

There are many operations that can be applied to a square matrix. This chapter is devoted to one particularly important operation called the **determinant**. In effect, the determinant can be thought of as a single number that is used to check for many of the different properties that a matrix might possess.

In order to define the determinant operation, we will first need to define permutations.

8.1 Permutations

Permutations appear in many different mathematical concepts, and so we give a general introduction to them in this section.

8.1.1 Definition of permutations

Given a positive integer $n \in \mathbb{Z}_+$, a **permutation** of an (ordered) list of n distinct objects is any reordering of this list. When describing the reorderings themselves, though, the nature of the objects involved is more or less irrelevant. E.g., we can imagine interchanging the second and third items in a list of five distinct objects — no matter what those items are — and this defines a particular permutation that can be applied to any list of five objects.

Since the nature of the objects being rearranged (i.e., permuted) is immaterial, it is common to use the integers $1, 2, \dots, n$ as the standard list of n objects. Alternatively, one

can also think of these integers as labels for the items in any list of n distinct elements. This gives rise to the following definition.

Definition 8.1.1. A **permutation** π of n elements is a one-to-one and onto function having the set $\{1, 2, \dots, n\}$ as both its domain and codomain.

In other words, a permutation is a function $\pi : \{1, 2, \dots, n\} \rightarrow \{1, 2, \dots, n\}$ such that, for every integer $i \in \{1, \dots, n\}$, there exists exactly one integer $j \in \{1, \dots, n\}$ for which $\pi(j) = i$. We will usually denote permutations by Greek letters such as π (pi), σ (sigma), and τ (tau). The set of all permutations of n elements is denoted by \mathcal{S}_n and is typically referred to as the **symmetric group of degree n** . (In particular, the set \mathcal{S}_n forms a group under function composition as discussed in Section 8.1.2.)

Given a permutation $\pi \in \mathcal{S}_n$, there are several common notations used for specifying how π permutes the integers $1, 2, \dots, n$. The important thing to keep in mind when working with these different notations is that π is a function defined on the finite set $\{1, 2, \dots, n\}$, with notation being used as a convenient short-hand for keeping track of how π permutes the elements in this set.

Definition 8.1.2. Given a **permutation** $\pi \in \mathcal{S}_n$, denote $\pi_i = \pi(i)$ for each $i \in \{1, \dots, n\}$. Then the **two-line notation** for π is given by the $2 \times n$ matrix

$$\pi = \begin{pmatrix} 1 & 2 & \cdots & n \\ \pi_1 & \pi_2 & \cdots & \pi_n \end{pmatrix}.$$

In other words, given a permutation $\pi \in \mathcal{S}_n$ and an integer $i \in \{1, \dots, n\}$, we are denoting the image of i under π by π_i instead of using the more conventional function notation $\pi(i)$. Then, in order to specify the image of each integer $i \in \{1, \dots, n\}$ under π , we list these images in a two-line array as shown above. (One can also use so-called **one-line notation** for π , which is given by simply ignoring the top row and writing $\pi = \pi_1\pi_2 \cdots \pi_n$.)

It is important to note that, although we represent permutations as $2 \times n$ matrices, you *should not* think of permutations as linear transformations from an n -dimensional vector space into a two-dimensional vector space. Moreover, the composition operation on permutation that we describe in Section 8.1.2 below *does not* correspond to matrix multiplication. The use of matrix notation in denoting permutations is merely a matter of convenience.

Example 8.1.3. Suppose that we have a set of five distinct objects and that we wish to describe the permutation that places the first item into the second position, the second item into the fifth position, the third item into the first position, the fourth item into the third position, and the fifth item into the fourth position. Then, using the notation developed above, we have the permutation $\pi \in \mathcal{S}_5$ such that

$$\pi_1 = \pi(1) = 3, \quad \pi_2 = \pi(2) = 1, \quad \pi_3 = \pi(3) = 4, \quad \pi_4 = \pi(4) = 5, \quad \pi_5 = \pi(5) = 2.$$

In two-line notation, we would write π as

$$\pi = \begin{pmatrix} 1 & 2 & 3 & 4 & 5 \\ 3 & 1 & 4 & 5 & 2 \end{pmatrix}.$$

It is relatively straightforward to find the number of permutations of n elements, i.e., to determine cardinality of the set \mathcal{S}_n . To construct an arbitrary permutation of n elements, we can proceed as follows: First, choose an integer $i \in \{1, \dots, n\}$ to put into the first position. Clearly, we have exactly n possible choices. Next, choose the element to go in the second position. Since we have already chosen one element from the set $\{1, \dots, n\}$, there are now exactly $n - 1$ remaining choices. Proceeding in this way, we have $n - 2$ choices when choosing the third element from the set $\{1, \dots, n\}$, then $n - 3$ choices when choosing the fourth element, and so on until we are left with exactly one choice for the n^{th} element. This proves the following theorem.

Theorem 8.1.4. *The number of elements in the symmetric group \mathcal{S}_n is given by*

$$|\mathcal{S}_n| = n \cdot (n - 1) \cdot (n - 2) \cdot \dots \cdot 3 \cdot 2 \cdot 1 = n!$$

We conclude this section with several examples, including a complete description of the one permutation in \mathcal{S}_1 , the two permutations in \mathcal{S}_2 , and the six permutations in \mathcal{S}_3 . For your own practice, you should (patiently) attempt to list the $4! = 24$ permutations in \mathcal{S}_4 .

Example 8.1.5.

1. Given any positive integer $n \in \mathbb{Z}_+$, the identity function $\text{id} : \{1, \dots, n\} \longrightarrow \{1, \dots, n\}$ given by $\text{id}(i) = i, \forall i \in \{1, \dots, n\}$, is a permutation in \mathcal{S}_n . This function can be

thought of as the trivial reordering that does not change the order at all, and so we call it the **trivial** or **identity** permutation.

2. If $n = 1$, then, by Theorem 8.1.4, $|\mathcal{S}_n| = 1! = 1$. Thus, \mathcal{S}_1 contains only the identity permutation.
3. If $n = 2$, then, by Theorem 8.1.4, $|\mathcal{S}_n| = 2! = 2 \cdot 1 = 2$. Thus, there is only one non-trivial permutation π in \mathcal{S}_2 , namely the transformation interchanging the first and the second elements in a list. As a function, $\pi(1) = 2$ and $\pi(2) = 1$, and, in two-line notation,

$$\pi = \begin{pmatrix} 1 & 2 \\ \pi_1 & \pi_2 \end{pmatrix} = \begin{pmatrix} 1 & 2 \\ 2 & 1 \end{pmatrix}.$$

4. If $n = 3$, then, by Theorem 8.1.4, $|\mathcal{S}_n| = 3! = 3 \cdot 2 \cdot 1 = 6$. Thus, there are five non-trivial permutations in \mathcal{S}_3 . Using two-line notation, we have that

$$\mathcal{S}_3 = \left\{ \begin{pmatrix} 1 & 2 & 3 \\ 1 & 2 & 3 \end{pmatrix}, \begin{pmatrix} 1 & 2 & 3 \\ 1 & 3 & 2 \end{pmatrix}, \begin{pmatrix} 1 & 2 & 3 \\ 2 & 1 & 3 \end{pmatrix}, \begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix}, \begin{pmatrix} 1 & 2 & 3 \\ 3 & 1 & 2 \end{pmatrix}, \begin{pmatrix} 1 & 2 & 3 \\ 3 & 2 & 1 \end{pmatrix} \right\}$$

Keep in mind the fact that each element in \mathcal{S}_3 is simultaneously both a function and a reordering operation. E.g., the permutation

$$\pi = \begin{pmatrix} 1 & 2 & 3 \\ \pi_1 & \pi_2 & \pi_3 \end{pmatrix} = \begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix}$$

can be read as defining the reordering that, with respect to the original list, places the second element in the first position, the third element in the second position, and the first element in the third position. This permutation could equally well have been identified by describing its action on the (ordered) list of letters a, b, c . In other words,

$$\begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix} = \begin{pmatrix} a & b & c \\ b & c & a \end{pmatrix},$$

regardless of what the letters a, b, c might happen to represent.

8.1.2 Composition of permutations

Let $n \in \mathbb{Z}_+$ be a positive integer and $\pi, \sigma \in \mathcal{S}_n$ be permutations. Then, since π and σ are both functions from the set $\{1, \dots, n\}$ to itself, we can compose them to obtain a new function $\pi \circ \sigma$ (read as “*pi after sigma*”) that takes on the values

$$(\pi \circ \sigma)(1) = \pi(\sigma(1)), \quad (\pi \circ \sigma)(2) = \pi(\sigma(2)), \quad \dots \quad (\pi \circ \sigma)(n) = \pi(\sigma(n)).$$

In two-line notation, we can write $\pi \circ \sigma$ as

$$\begin{pmatrix} 1 & 2 & \cdots & n \\ \pi(\sigma(1)) & \pi(\sigma(2)) & \cdots & \pi(\sigma(n)) \end{pmatrix} \text{ or } \begin{pmatrix} 1 & 2 & \cdots & n \\ \pi_{\sigma(1)} & \pi_{\sigma(2)} & \cdots & \pi_{\sigma(n)} \end{pmatrix} \text{ or } \begin{pmatrix} 1 & 2 & \cdots & n \\ \pi_{\sigma_1} & \pi_{\sigma_2} & \cdots & \pi_{\sigma_n} \end{pmatrix}.$$

Example 8.1.6. From \mathcal{S}_3 , suppose that we have the permutations π and σ given by

$$\pi(1) = 2, \quad \pi(2) = 3, \quad \pi(3) = 1 \quad \text{and} \quad \sigma(1) = 1, \quad \sigma(2) = 3, \quad \sigma(3) = 2.$$

Then note that

$$(\pi \circ \sigma)(1) = \pi(\sigma(1)) = \pi(1) = 2,$$

$$(\pi \circ \sigma)(2) = \pi(\sigma(2)) = \pi(3) = 1,$$

$$(\pi \circ \sigma)(3) = \pi(\sigma(3)) = \pi(2) = 3.$$

In other words,

$$\begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix} \circ \begin{pmatrix} 1 & 2 & 3 \\ 1 & 3 & 2 \end{pmatrix} = \begin{pmatrix} 1 & 2 & 3 \\ \pi(1) & \pi(3) & \pi(2) \end{pmatrix} = \begin{pmatrix} 1 & 2 & 3 \\ 2 & 1 & 3 \end{pmatrix}.$$

Similar computations (which you should check for your own practice) yield compositions such as

$$\begin{pmatrix} 1 & 2 & 3 \\ 1 & 3 & 2 \end{pmatrix} \circ \begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix} = \begin{pmatrix} 1 & 2 & 3 \\ \sigma(2) & \sigma(3) & \sigma(1) \end{pmatrix} = \begin{pmatrix} 1 & 2 & 3 \\ 3 & 2 & 1 \end{pmatrix},$$

$$\begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix} \circ \begin{pmatrix} 1 & 2 & 3 \\ 1 & 2 & 3 \end{pmatrix} = \begin{pmatrix} 1 & 2 & 3 \\ \sigma(1) & \sigma(2) & \sigma(3) \end{pmatrix} = \begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix},$$

and

$$\begin{pmatrix} 1 & 2 & 3 \\ 1 & 2 & 3 \end{pmatrix} \circ \begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix} = \begin{pmatrix} 1 & 2 & 3 \\ \text{id}(2) & \text{id}(3) & \text{id}(1) \end{pmatrix} = \begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix}.$$

In particular, note that the result of each composition above is a permutation, that composition is not a commutative operation, and that composition with id leaves a permutation unchanged. Moreover, since each permutation π is a bijection, one can always construct an inverse permutation π^{-1} such that $\pi \circ \pi^{-1} = \text{id}$. E.g.,

$$\begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix} \circ \begin{pmatrix} 1 & 2 & 3 \\ 3 & 1 & 2 \end{pmatrix} = \begin{pmatrix} 1 & 2 & 3 \\ \pi(3) & \pi(1) & \pi(2) \end{pmatrix} = \begin{pmatrix} 1 & 2 & 3 \\ 1 & 2 & 3 \end{pmatrix}.$$

We summarize the basic properties of composition on the symmetric group in the following theorem.

Theorem 8.1.7. *Let $n \in \mathbb{Z}_+$ be a positive integer. Then the set \mathcal{S}_n has the following properties.*

1. *Given any two permutations $\pi, \sigma \in \mathcal{S}_n$, the composition $\pi \circ \sigma \in \mathcal{S}_n$.*
2. *(Associativity of Composition) Given any three permutations $\pi, \sigma, \tau \in \mathcal{S}_n$,*

$$(\pi \circ \sigma) \circ \tau = \pi \circ (\sigma \circ \tau).$$

3. *(Identity Element for Composition) Given any permutation $\pi \in \mathcal{S}_n$,*

$$\pi \circ \text{id} = \text{id} \circ \pi = \pi.$$

4. *(Inverse Elements for Composition) Given any permutation $\pi \in \mathcal{S}_n$, there exists a unique permutation $\pi^{-1} \in \mathcal{S}_n$ such that*

$$\pi \circ \pi^{-1} = \pi^{-1} \circ \pi = \text{id}.$$

In other words, the set \mathcal{S}_n forms a group under composition.

Note that the composition of permutations is not commutative in general. In particular, for $n \geq 3$, it is easy to find permutations π and σ such that $\pi \circ \sigma \neq \sigma \circ \pi$.

8.1.3 Inversions and the sign of a permutation

Let $n \in \mathbb{Z}_+$ be a positive integer. Then, given a permutation $\pi \in \mathcal{S}_n$, it is natural to ask how “out of order” π is in comparison to the identity permutation. One method for quantifying this is to count the number of so-called **inversion pairs** in π as these describe pairs of objects that are out of order relative to each other.

Definition 8.1.8. Let $\pi \in \mathcal{S}_n$ be a permutation. Then an **inversion pair** (i, j) of π is a pair of positive integers $i, j \in \{1, \dots, n\}$ for which $i < j$ but $\pi(i) > \pi(j)$.

Note, in particular, that the components of an inversion pair are the **positions** where the two “out of order” elements occur.

Example 8.1.9. We classify all inversion pairs for elements in \mathcal{S}_3 :

- $\text{id} = \begin{pmatrix} 1 & 2 & 3 \\ 1 & 2 & 3 \end{pmatrix}$ has no inversion pairs since no elements are “out of order”.
- $\pi = \begin{pmatrix} 1 & 2 & 3 \\ 1 & 3 & 2 \end{pmatrix}$ has the single inversion pair $(2, 3)$ since $\pi(2) = 3 > 2 = \pi(3)$.
- $\pi = \begin{pmatrix} 1 & 2 & 3 \\ 2 & 1 & 3 \end{pmatrix}$ has the single inversion pair $(1, 2)$ since $\pi(1) = 2 > 1 = \pi(2)$.
- $\pi = \begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix}$ has the two inversion pairs $(1, 3)$ and $(2, 3)$ since we have that both $\pi(1) = 2 > 1 = \pi(3)$ and $\pi(2) = 3 > 1 = \pi(3)$.
- $\pi = \begin{pmatrix} 1 & 2 & 3 \\ 3 & 1 & 2 \end{pmatrix}$ has the two inversion pairs $(1, 2)$ and $(1, 3)$ since we have that both $\pi(1) = 3 > 1 = \pi(2)$ and $\pi(1) = 3 > 2 = \pi(3)$.
- $\pi = \begin{pmatrix} 1 & 2 & 3 \\ 3 & 2 & 1 \end{pmatrix}$ has the three inversion pairs $(1, 2)$, $(1, 3)$, and $(2, 3)$, as you can check.

Example 8.1.10. As another example, for each $i, j \in \{1, \dots, n\}$ with $i < j$, we define the **transposition** $t_{ij} \in \mathcal{S}_n$ by

$$t_{ij} = \begin{pmatrix} 1 & 2 & \cdots & i & \cdots & j & \cdots & n \\ 1 & 2 & \cdots & j & \cdots & i & \cdots & n \end{pmatrix}.$$

In other words, t_{ij} is the permutation that interchanges i and j while leaving all other integers fixed in place. One can check that the number of inversion pairs in t_{ij} is exactly $2(j-i) - 1$. Thus, the number of inversions in a transposition is always odd. E.g.,

$$t_{13} = \begin{pmatrix} 1 & 2 & 3 & 4 \\ 3 & 2 & 1 & 4 \end{pmatrix}$$

has inversion pairs $(1, 2)$, $(1, 3)$, and $(2, 3)$.

For the purposes of using permutations in Linear Algebra, the significance of inversion pairs is mainly due to the following fundamental definition.

Definition 8.1.11. Let $\pi \in \mathcal{S}_n$ be a permutation. Then the **sign** of π , denoted by $\text{sign}(\pi)$, is defined by

$$\text{sign}(\pi) = (-1)^{\# \text{ of inversion pairs in } \pi} = \begin{cases} +1, & \text{if the number of inversions in } \pi \text{ is even} \\ -1, & \text{if the number of inversions in } \pi \text{ is odd} \end{cases}.$$

We call π an **even permutation** if $\text{sign}(\pi) = +1$, whereas π is called an **odd permutation** if $\text{sign}(\pi) = -1$.

Example 8.1.12. Based upon the computations in Example 8.1.9 above, we have that

$$\text{sign} \begin{pmatrix} 1 & 2 & 3 \\ 1 & 2 & 3 \end{pmatrix} = \text{sign} \begin{pmatrix} 1 & 2 & 3 \\ 2 & 3 & 1 \end{pmatrix} = \text{sign} \begin{pmatrix} 1 & 2 & 3 \\ 3 & 1 & 2 \end{pmatrix} = +1$$

and that

$$\text{sign} \begin{pmatrix} 1 & 2 & 3 \\ 1 & 3 & 2 \end{pmatrix} = \text{sign} \begin{pmatrix} 1 & 2 & 3 \\ 2 & 1 & 3 \end{pmatrix} = \text{sign} \begin{pmatrix} 1 & 2 & 3 \\ 3 & 2 & 1 \end{pmatrix} = -1.$$

Similarly, from Example 8.1.10, it follows that any transposition is an odd permutation.

We summarize some of the most basic properties of the sign operation on the symmetric group in the following theorem.

Theorem 8.1.13. Let $n \in \mathbb{Z}_+$ be a positive integer. Then,

1. for $id \in \mathcal{S}_n$ the identity permutation,

$$\text{sign}(id) = +1.$$

2. for $t_{ij} \in \mathcal{S}_n$ a transposition with $i, j \in \{1, \dots, n\}$ and $i < j$,

$$\text{sign}(t_{ij}) = -1. \quad (8.1)$$

3. given any two permutations $\pi, \sigma \in \mathcal{S}_n$,

$$\text{sign}(\pi \circ \sigma) = \text{sign}(\pi) \text{sign}(\sigma), \quad (8.2)$$

$$\text{sign}(\pi^{-1}) = \text{sign}(\pi). \quad (8.3)$$

4. the number of even permutations in \mathcal{S}_n , when $n \geq 2$, is exactly $\frac{1}{2}n!$.

5. the set A_n of even permutations in \mathcal{S}_n forms a group under composition.

8.2 Determinants

Now that we have developed the appropriate background material on permutations, we are finally ready to define the determinant and explore its many important properties.

8.2.1 Summations indexed by the set of all permutations

Given a positive integer $n \in \mathbb{Z}_+$, we begin with the following definition:

Definition 8.2.1. Given a square matrix $A = (a_{ij}) \in \mathbb{F}^{n \times n}$, the **determinant** of A is defined to be

$$\det(A) = \sum_{\pi \in \mathcal{S}_n} \text{sign}(\pi) a_{1,\pi(1)} a_{2,\pi(2)} \cdots a_{n,\pi(n)}, \quad (8.4)$$

where the sum is over all permutations of n elements (i.e., over the symmetric group).

Note that each permutation in the summand of (8.4) permutes the n columns of the $n \times n$ matrix.

Example 8.2.2. Suppose that $A \in \mathbb{F}^{2 \times 2}$ is the 2×2 matrix

$$A = \begin{bmatrix} a_{11} & a_{12} \\ a_{21} & a_{22} \end{bmatrix}.$$

To calculate the determinant of A , we first list the two permutations in S_2 :

$$\text{id} = \begin{pmatrix} 1 & 2 \\ 1 & 2 \end{pmatrix} \quad \text{and} \quad \sigma = \begin{pmatrix} 1 & 2 \\ 2 & 1 \end{pmatrix}.$$

The permutation id has sign 1, and the permutation σ has sign -1 . Thus, the determinant of A is given by

$$\det(A) = a_{11}a_{22} - a_{12}a_{21}.$$

Were one to attempt to compute determinants directly using Equation (8.4), then one would need to sum up $n!$ terms, where each summand is itself a product of n factors. This is an incredibly inefficient method for finding determinants since $n!$ increases in size very rapidly as n increases. E.g., $10! = 3628800$. Thus, even if you could compute one summand per second without stopping, it would still take you well over a month to compute the determinant of a 10×10 matrix using Equation (8.4). Fortunately, there are properties of the determinant (as summarized in Section 8.2.2 below) that can be used to greatly reduce the size of such computations. These properties of the determinant follow from general properties that hold for any summation taken over the symmetric group, which are in turn themselves based upon properties of permutations and the fact that addition and multiplication are commutative operations in the field \mathbb{F} (which, as usual, we take to be either \mathbb{R} or \mathbb{C}).

Let $T : \mathcal{S}_n \rightarrow V$ be a function defined on the symmetric group \mathcal{S}_n that takes values in some vector space V . E.g., $T(\pi)$ could be the term corresponding to the permutation π in Equation 8.4. Then, since the sum

$$\sum_{\pi \in \mathcal{S}_n} T(\pi)$$

is finite, we are free to reorder the summands. In other words, the sum is independent of the order in which the terms are added, and so we are free to permute the term order without affecting the value of the sum. Some commonly used reorderings of such sums are

the following:

$$\sum_{\pi \in \mathcal{S}_n} T(\pi) = \sum_{\pi \in \mathcal{S}_n} T(\sigma \circ \pi) \quad (8.5)$$

$$= \sum_{\pi \in \mathcal{S}_n} T(\pi \circ \sigma) \quad (8.6)$$

$$= \sum_{\pi \in \mathcal{S}_n} T(\pi^{-1}), \quad (8.7)$$

where σ is a fixed permutation.

Equation (8.5) follows from the fact that, if π runs through each permutation in \mathcal{S}_n exactly once, then $\sigma \circ \pi$ similarly runs through each permutation but in a potentially different order. I.e., the action of σ upon something like Equation (8.4) is that σ merely permutes the permutations that index the terms. Put another way, there is a one-to-one correspondence between permutations in general and permutations composed with σ .

Similar reasoning holds for Equations (8.6) and (8.7).

8.2.2 Properties of the determinant

We summarize some of the most basic properties of the determinant below. The proof of the following theorem uses properties of permutations, properties of the sign function on permutations, and properties of sums over the symmetric group as discussed in Section 8.2.1 above. In thinking about these properties, it is useful to keep in mind that, using Equation (8.4), the determinant of an $n \times n$ matrix A is the sum over all possible ways of selecting n entries of A , where exactly one element is selected from each row and from each column of A .

Theorem 8.2.3 (Properties of the Determinant). *Let $n \in \mathbb{Z}_+$ be a positive integer, and suppose that $A = (a_{ij}) \in \mathbb{F}^{n \times n}$ is an $n \times n$ matrix. Then*

1. $\det(0_{n \times n}) = 0$ and $\det(I_n) = 1$, where $0_{n \times n}$ denotes the $n \times n$ zero matrix and I_n denotes the $n \times n$ identity matrix.
2. $\det(A^T) = \det(A)$, where A^T denotes the transpose of A .
3. denoting by $A^{(\cdot,1)}, A^{(\cdot,2)}, \dots, A^{(\cdot,n)} \in \mathbb{F}^n$ the columns of A , $\det(A)$ is a linear function

of column $A^{(\cdot,i)}$, for each $i \in \{1, \dots, n\}$. In other words, if we denote

$$A = [A^{(\cdot,1)} \mid A^{(\cdot,2)} \mid \dots \mid A^{(\cdot,n)}]$$

then, given any scalar $z \in \mathbb{F}$ and any vectors $a_1, a_2, \dots, a_n, c, b \in \mathbb{F}^n$,

$$\begin{aligned} \det [a_1 \mid \dots \mid a_{i-1} \mid za_i \mid \dots \mid a_n] &= z \det [a_1 \mid \dots \mid a_{i-1} \mid a_i \mid \dots \mid a_n], \\ \det [a_1 \mid \dots \mid a_{i-1} \mid b + c \mid \dots \mid a_n] &= \det [a_1 \mid \dots \mid b \mid \dots \mid a_n] + \det [a_1 \mid \dots \mid c \mid \dots \mid a_n]. \end{aligned}$$

4. $\det(A)$ is an antisymmetric function of the columns of A . In other words, given any positive integers $1 \leq i < j \leq n$ and denoting $A = [A^{(\cdot,1)} \mid A^{(\cdot,2)} \mid \dots \mid A^{(\cdot,n)}]$,

$$\det(A) = -\det [A^{(\cdot,1)} \mid \dots \mid A^{(\cdot,j)} \mid \dots \mid A^{(\cdot,i)} \mid \dots \mid A^{(\cdot,n)}].$$

5. if A has two identical columns, $\det(A) = 0$.

6. if A has a column of zero's, $\det(A) = 0$.

7. Properties 3–6 also hold when rows are used in place of columns.

8. given any other matrix $B \in \mathbb{F}^{n \times n}$,

$$\det(AB) = \det(A) \det(B).$$

9. if A is either upper triangular or lower triangular,

$$\det(A) = a_{11}a_{22} \cdots a_{nn}.$$

Proof. First, note that Properties 1, 3, 6, and 9 follow directly from the sum given in Equation (8.4). Moreover, Property 5 follows directly from Property 4, and Property 7 follows directly from Property 2. Thus, we only need to prove Properties 2, 4, and 8.

Proof of 2. Since the entries of A^T are obtained from those of A by interchanging the

row and column indices, it follows that $\det(A^T)$ is given by

$$\det(A^T) = \sum_{\pi \in \mathcal{S}_n} \text{sign}(\pi) a_{\pi(1),1} a_{\pi(2),2} \cdots a_{\pi(n),n}.$$

Using the commutativity of the product in \mathbb{F} and Equation (8.3), we see that

$$\det(A^T) = \sum_{\pi \in \mathcal{S}_n} \text{sign}(\pi^{-1}) a_{1,\pi^{-1}(1)} a_{2,\pi^{-1}(2)} \cdots a_{n,\pi^{-1}(n)},$$

which equals $\det(A)$ by Equation (8.7).

Proof of 4. Let $B = [A^{(\cdot,1)} \mid \cdots \mid A^{(\cdot,j)} \mid \cdots \mid A^{(\cdot,i)} \mid \cdots \mid A^{(\cdot,n)}]$ be the matrix obtained from A by interchanging the i th and the j th column. Then note that

$$\det(B) = \sum_{\pi \in \mathcal{S}_n} \text{sign}(\pi) a_{1,\pi(1)} \cdots a_{j,\pi(i)} \cdots a_{i,\pi(j)} \cdots a_{n,\pi(n)}.$$

Define $\tilde{\pi} = \pi \circ t_{ij}$, and note that $\pi = \tilde{\pi} \circ t_{ij}$. In particular, $\pi(i) = \tilde{\pi}(j)$ and $\pi(j) = \tilde{\pi}(i)$, from which

$$\det(B) = \sum_{\pi \in \mathcal{S}_n} \text{sign}(\tilde{\pi} \circ t_{ij}) a_{1,\tilde{\pi}(1)} \cdots a_{i,\tilde{\pi}(i)} \cdots a_{j,\tilde{\pi}(j)} \cdots a_{n,\tilde{\pi}(n)}.$$

It follows from Equations (8.2) and (8.1) that $\text{sign}(\tilde{\pi} \circ t_{ij}) = -\text{sign}(\tilde{\pi})$. Thus, using Equation (8.6), we obtain $\det(B) = -\det(A)$.

Proof of 8. Using the standard expression for the matrix entries of the product AB in terms of the matrix entries of $A = (a_{ij})$ and $B = (b_{ij})$, we have that

$$\begin{aligned} \det(AB) &= \sum_{\pi \in \mathcal{S}_n} \text{sign}(\pi) \sum_{k_1=1}^n \cdots \sum_{k_n=1}^n a_{1,k_1} b_{k_1,\pi(1)} \cdots a_{n,k_n} b_{k_n,\pi(n)} \\ &= \sum_{k_1=1}^n \cdots \sum_{k_n=1}^n a_{1,k_1} \cdots a_{n,k_n} \sum_{\pi \in \mathcal{S}_n} \text{sign}(\pi) b_{k_1,\pi(1)} \cdots b_{k_n,\pi(n)}. \end{aligned}$$

Note that, for fixed $k_1, \dots, k_n \in \{1, \dots, n\}$, the sum $\sum_{\pi \in \mathcal{S}_n} \text{sign}(\pi) b_{k_1,\pi(1)} \cdots b_{k_n,\pi(n)}$ is the determinant of a matrix composed of rows k_1, \dots, k_n of B . Thus, by property 5, it follows that this expression vanishes unless the k_i are pairwise distinct. In other words, the sum over all choices of k_1, \dots, k_n can be restricted to those sets of indices $\sigma(1), \dots, \sigma(n)$ that are

labeled by a permutation $\sigma \in \mathcal{S}_n$. In other words,

$$\det(AB) = \sum_{\sigma \in \mathcal{S}_n} a_{1,\sigma(1)} \cdots a_{n,\sigma(n)} \sum_{\pi \in \mathcal{S}_n} \text{sign}(\pi) b_{\sigma(1),\pi(1)} \cdots b_{\sigma(n),\pi(n)}.$$

Now, proceeding with the same arguments as in the proof of Property 4 but with the role of t_{ij} replaced by an arbitrary permutation σ , we obtain

$$\det(AB) = \sum_{\sigma \in \mathcal{S}_n} \text{sign}(\sigma) a_{1,\sigma(1)} \cdots a_{n,\sigma(n)} \sum_{\pi \in \mathcal{S}_n} \text{sign}(\pi \circ \sigma^{-1}) b_{1,\pi \circ \sigma^{-1}(1)} \cdots b_{n,\pi \circ \sigma^{-1}(n)}.$$

Using Equation (8.6), this last expression then becomes $(\det(A))(\det(B))$. □

Note that Properties 3 and 4 of Theorem 8.2.3 effectively summarize how multiplication by an Elementary Matrix interacts with the determinant operation. These Properties together with Property 9 facilitate numerical computation of determinants for very large matrices.

8.2.3 Further properties and applications

There are many applications of Theorem 8.2.3. We conclude these notes with a few consequences that are particularly useful when computing with matrices. In particular, we use the determinant to list several characterizations for matrix invertibility, and, as a corollary, give a method for using determinants to calculate eigenvalues. You should provide a proof of these results for your own benefit.

Theorem 8.2.4. *Let $n \in \mathbb{Z}_+$ and $A \in \mathbb{F}^{n \times n}$. Then the following statements are equivalent:*

1. *A is invertible.*

2. *denoting $x = \begin{bmatrix} x_1 \\ \vdots \\ x_n \end{bmatrix}$, the matrix equation $Ax = 0$ has only the trivial solution $x = 0$.*

3. *denoting $x = \begin{bmatrix} x_1 \\ \vdots \\ x_n \end{bmatrix}$, the matrix equation $Ax = b$ has a solution for all $b = \begin{bmatrix} b_1 \\ \vdots \\ b_n \end{bmatrix} \in \mathbb{F}^n$.*

4. A can be factored into a product of elementary matrices.
5. $\det(A) \neq 0$.
6. the rows (or columns) of A form a linearly independent set in \mathbb{F}^n .
7. zero is not an eigenvalue of A .
8. the linear operator $T : \mathbb{F}^n \rightarrow \mathbb{F}^n$ defined by $T(x) = Ax$, for every $x \in \mathbb{F}^n$, is bijective.

Moreover, should A be invertible, then $\det(A^{-1}) = \frac{1}{\det(A)}$.

Given a matrix $A \in \mathbb{C}^{n \times n}$ and a complex number $\lambda \in \mathbb{C}$, the expression

$$P(\lambda) = \det(A - \lambda I_n)$$

is called the **characteristic polynomial** of A . Note that $P(\lambda)$ is a basis independent polynomial of degree n . Thus, as with the determinant, we can consider $P(\lambda)$ to be associated with the linear map that has matrix A with respect to some basis. Since the eigenvalues of A are exactly those $\lambda \in \mathbb{C}$ such that $A - \lambda I$ is not invertible, the following is then an immediate corollary.

Corollary 8.2.5. *The roots of the polynomial $P(\lambda) = \det(A - \lambda I)$ are exactly the eigenvalues of A .*

8.2.4 Computing determinants with cofactor expansions

As noted in Section 8.2.1, it is generally impractical to compute determinants directly with Equation (8.4). In this section, we briefly describe the so-called *cofactor expansions* of a determinant. When properly applied, cofactor expansions are particularly useful for computing determinants by hand.

Definition 8.2.6. Let $n \in \mathbb{Z}_+$ and $A \in \mathbb{F}^{n \times n}$. Then, for each $i, j \in \{1, 2, \dots, n\}$, the *i - j minor* of A , denoted M_{ij} , is defined to be the determinant of the matrix obtained by

removing the i^{th} row and j^{th} column from A . Moreover, the i - j cofactor of A is defined to be

$$A_{ij} = (-1)^{i+j} M_{ij}.$$

Cofactors themselves, though, are not terribly useful unless put together in the right way.

Definition 8.2.7. Let $n \in \mathbb{Z}_+$ and $A = (a_{ij}) \in \mathbb{F}^{n \times n}$. Then, for each $i, j \in \{1, 2, \dots, n\}$, the i^{th} row (resp. j^{th} column) cofactor expansion of A is the sum $\sum_{j=1}^n a_{ij} A_{ij}$ (resp. $\sum_{i=1}^n a_{ij} A_{ij}$).

Theorem 8.2.8. Let $n \in \mathbb{Z}_+$ and $A \in \mathbb{F}^{n \times n}$. Then every row and column factor expansion of A is equal to the determinant of A .

Since the determinant of a matrix is equal to every row or column cofactor expansion, one can compute the determinant using a convenient choice of expansions until the calculation is reduced to one or more 2×2 determinants. We close with an example.

Example 8.2.9. By first expanding along the second column, we obtain

$$\begin{vmatrix} 1 & 2 & -3 & 4 \\ -4 & 2 & 1 & 3 \\ 3 & 0 & 0 & -3 \\ 2 & 0 & -2 & 3 \end{vmatrix} = (-1)^{1+2}(2) \begin{vmatrix} -4 & 1 & 3 \\ 3 & 0 & -3 \\ 2 & -2 & 3 \end{vmatrix} + (-1)^{2+2}(2) \begin{vmatrix} 1 & -3 & 4 \\ 3 & 0 & -3 \\ 2 & -2 & 3 \end{vmatrix}.$$

Then, each of the resulting 3×3 determinants can be computed by further expansion:

$$\begin{vmatrix} -4 & 1 & 3 \\ 3 & 0 & -3 \\ 2 & -2 & 3 \end{vmatrix} = (-1)^{1+2}(1) \begin{vmatrix} 3 & -3 \\ 2 & 3 \end{vmatrix} + (-1)^{3+2}(-2) \begin{vmatrix} -4 & 3 \\ 3 & -3 \end{vmatrix} = -15 + 6 = -9.$$

$$\begin{vmatrix} 1 & -3 & 4 \\ 3 & 0 & -3 \\ 2 & -2 & 3 \end{vmatrix} = (-1)^{2+1}(3) \begin{vmatrix} -3 & 4 \\ -2 & 3 \end{vmatrix} + (-1)^{2+3}(-3) \begin{vmatrix} 1 & -3 \\ 2 & -2 \end{vmatrix} = 3 + 12 = 15.$$

It follows that the original determinant is then equal to $-2(-9) + 2(15) = 48$.

Exercises for Chapter 8

Computational Exercises

1. Let $A \in \mathbb{C}^{3 \times 3}$ be given by

$$A = \begin{bmatrix} 1 & 0 & i \\ 0 & 1 & 0 \\ -i & 0 & -1 \end{bmatrix}.$$

- (a) Calculate $\det(A)$.
- (b) Find $\det(A^4)$.
2. (a) For each permutation $\pi \in \mathcal{S}_3$, compute the number of inversions in π , and classify π as being either an even or an odd permutation.
- (b) Use your result from Part (a) to construct a formula for the determinant of a 3×3 matrix.
3. (a) For each permutation $\pi \in \mathcal{S}_4$, compute the number of inversions in π , and classify π as being either an even or an odd permutation.
- (b) Use your result from Part (a) to construct a formula for the determinant of a 4×4 matrix.
4. Solve for the variable x in the following expression:

$$\det \left(\begin{bmatrix} x & -1 \\ 3 & 1-x \end{bmatrix} \right) = \det \left(\begin{bmatrix} 1 & 0 & -3 \\ 2 & x & -6 \\ 1 & 3 & x-5 \end{bmatrix} \right).$$

5. Prove that the following determinant does not depend upon the value of θ :

$$\det \left(\begin{bmatrix} \sin(\theta) & \cos(\theta) & 0 \\ -\cos(\theta) & \sin(\theta) & 0 \\ \sin(\theta) - \cos(\theta) & \sin(\theta) + \cos(\theta) & 1 \end{bmatrix} \right)$$

6. Given scalars $\alpha, \beta, \gamma \in \mathbb{F}$, prove that the following matrix is not invertible:

$$\begin{bmatrix} \sin^2(\alpha) & \sin^2(\beta) & \sin^2(\gamma) \\ \cos^2(\alpha) & \cos^2(\beta) & \cos^2(\gamma) \\ 1 & 1 & 1 \end{bmatrix}$$

Hint: Compute the determinant.

Proof-Writing Exercises

1. Let $a, b, c, d, e, f \in \mathbb{F}$ be scalars, and suppose that A and B are the following matrices:

$$A = \begin{bmatrix} a & b \\ 0 & c \end{bmatrix} \quad \text{and} \quad B = \begin{bmatrix} d & e \\ 0 & f \end{bmatrix}.$$

Prove that $AB = BA$ if and only if $\det \left(\begin{bmatrix} b & a - c \\ e & d - f \end{bmatrix} \right) = 0$.

2. Given a square matrix A , prove that A is invertible if and only if $A^T A$ is invertible.
3. Prove or give a counterexample: For any $n \geq 1$ and $A, B \in \mathbb{R}^{n \times n}$, one has

$$\det(A + B) = \det(A) + \det(B).$$

4. Prove or give a counterexample: For any $r \in \mathbb{R}$, $n \geq 1$ and $A \in \mathbb{R}^{n \times n}$, one has

$$\det(rA) = r \det(A).$$

Chapter 9

Inner Product Spaces

The abstract definition of a vector space only takes into account algebraic properties for the addition and scalar multiplication of vectors. For vectors in \mathbb{R}^n , for example, we also have geometric intuition involving the length of a vector or the angle formed by two vectors. In this chapter we discuss inner product spaces, which are vector spaces with an inner product defined upon them. Inner products are what allow us to abstract notions such as the length of a vector. We will also abstract the concept of angle via a condition called orthogonality.

9.1 Inner product

In this section, V is a finite-dimensional, nonzero vector space over \mathbb{F} .

Definition 9.1.1. An **inner product** on V is a map

$$\begin{aligned}\langle \cdot, \cdot \rangle : V \times V &\rightarrow \mathbb{F} \\ (u, v) &\mapsto \langle u, v \rangle\end{aligned}$$

with the following four properties.

1. **Linearity in first slot:** $\langle u + v, w \rangle = \langle u, w \rangle + \langle v, w \rangle$ and $\langle au, v \rangle = a\langle u, v \rangle$ for all $u, v, w \in V$ and $a \in \mathbb{F}$;
2. **Positivity:** $\langle v, v \rangle \geq 0$ for all $v \in V$;
3. **Positive definiteness:** $\langle v, v \rangle = 0$ if and only if $v = 0$;

4. **Conjugate symmetry:** $\langle u, v \rangle = \overline{\langle v, u \rangle}$ for all $u, v \in V$.

Remark 9.1.2. Recall that every real number $x \in \mathbb{R}$ equals its complex conjugate. Hence, for real vector spaces, conjugate symmetry of an inner product becomes actual symmetry.

Definition 9.1.3. An **inner product space** is a vector space over \mathbb{F} together with an inner product $\langle \cdot, \cdot \rangle$.

Example 9.1.4. Let $V = \mathbb{F}^n$ and $u = (u_1, \dots, u_n), v = (v_1, \dots, v_n) \in \mathbb{F}^n$. Then we can define an inner product on V by setting

$$\langle u, v \rangle = \sum_{i=1}^n u_i \bar{v}_i.$$

For $\mathbb{F} = \mathbb{R}$, this reduces to the usual dot product, i.e.,

$$u \cdot v = u_1 v_1 + \dots + u_n v_n.$$

Example 9.1.5. Let $V = \mathbb{F}[z]$ be the space of polynomials with coefficients in \mathbb{F} . Given $f, g \in \mathbb{F}[z]$, we can define their inner product to be

$$\langle f, g \rangle = \int_0^1 f(z) \overline{g(z)} dz,$$

where $\overline{g(z)}$ is the complex conjugate of the polynomial $g(z)$.

For a fixed vector $w \in V$, one can define a map $T : V \rightarrow \mathbb{F}$ by setting $Tv = \langle v, w \rangle$. Note that T is linear by Condition 1 of Definition 9.1.1. This implies, in particular, that $\langle 0, w \rangle = 0$ for every $w \in V$. By conjugate symmetry, we also have $\langle w, 0 \rangle = 0$.

Lemma 9.1.6. *The inner product is anti-linear in the second slot, that is, $\langle u, v + w \rangle = \langle u, v \rangle + \langle u, w \rangle$ and $\langle u, av \rangle = \bar{a} \langle u, v \rangle$ for all $u, v, w \in V$ and $a \in \mathbb{F}$.*

Proof. For additivity, note that

$$\begin{aligned} \langle u, v + w \rangle &= \overline{\langle v + w, u \rangle} = \overline{\langle v, u \rangle + \langle w, u \rangle} \\ &= \overline{\langle v, u \rangle} + \overline{\langle w, u \rangle} = \langle u, v \rangle + \langle u, w \rangle. \end{aligned}$$

Similarly, for anti-homogeneity, note that

$$\langle u, av \rangle = \overline{\langle av, u \rangle} = \overline{a \langle v, u \rangle} = \bar{a} \overline{\langle v, u \rangle} = \bar{a} \langle u, v \rangle.$$

□

We close this section by noting that the convention in physics is often the exact opposite of what we have defined above. In other words, an inner product in physics is traditionally linear in the second slot and anti-linear in the first slot.

9.2 Norms

The norm of a vector in an arbitrary inner product space is the analog of the length or magnitude of a vector in \mathbb{R}^n . We formally define this concept as follows.

Definition 9.2.1. Let V be a vector space over \mathbb{F} . A map

$$\begin{aligned} \|\cdot\| : V &\rightarrow \mathbb{R} \\ v &\mapsto \|v\| \end{aligned}$$

is a **norm** on V if the following three conditions are satisfied.

1. **Positive definiteness:** $\|v\| = 0$ if and only if $v = 0$;
2. **Positive Homogeneity:** $\|av\| = |a| \|v\|$ for all $a \in \mathbb{F}$ and $v \in V$;
3. **Triangle inequality:** $\|v + w\| \leq \|v\| + \|w\|$ for all $v, w \in V$.

Remark 9.2.2. Note that, in fact, $\|v\| \geq 0$ for each $v \in V$ since

$$0 = \|v - v\| \leq \|v\| + \|-v\| = 2\|v\|.$$

Next we want to show that a norm can always be defined from an inner product $\langle \cdot, \cdot \rangle$ via the formula

$$\|v\| = \sqrt{\langle v, v \rangle} \quad \text{for all } v \in V. \tag{9.1}$$

Properties 1 and 2 follow easily from Conditions 1 and 3 of Definition 9.1.1. The triangle inequality requires more careful proof, though, which we give in Theorem 9.3.4 below.

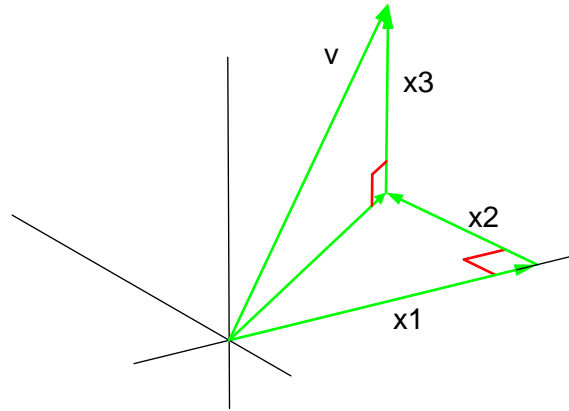


Figure 9.1: The length of a vector in \mathbb{R}^3 via Equation 9.2

If we take $V = \mathbb{R}^n$, then the norm defined by the usual dot product is related to the usual notion of length of a vector. Namely, for $v = (x_1, \dots, x_n) \in \mathbb{R}^n$, we have

$$\|v\| = \sqrt{x_1^2 + \dots + x_n^2}. \quad (9.2)$$

We illustrate this for the case of \mathbb{R}^3 in Figure 9.1.

While it is always possible to start with an inner product and use it to define a norm, the converse requires more care. In particular, one can prove that a norm can be used to define an inner product via the Equation (9.1) if and only if the norm satisfies the Parallelogram Law (Theorem 9.3.6).

9.3 Orthogonality

Using the inner product, we can now define the notion of orthogonality, prove that the Pythagorean theorem holds in any inner product space, and use the Cauchy-Schwarz inequality to prove the triangle inequality. In particular, this will show that $\|v\| = \sqrt{\langle v, v \rangle}$ does indeed define a norm.

Definition 9.3.1. Two vectors $u, v \in V$ are **orthogonal** (denoted $u \perp v$) if $\langle u, v \rangle = 0$.

Note that the zero vector is the only vector that is orthogonal to itself. In fact, the zero vector is orthogonal to every vector $v \in V$.

Theorem 9.3.2 (Pythagorean Theorem). *If $u, v \in V$, an inner product space, with $u \perp v$, then $\|\cdot\|$ defined by $\|v\| := \sqrt{\langle v, v \rangle}$ obeys*

$$\|u + v\|^2 = \|u\|^2 + \|v\|^2.$$

Proof. Suppose $u, v \in V$ such that $u \perp v$. Then

$$\begin{aligned} \|u + v\|^2 &= \langle u + v, u + v \rangle = \|u\|^2 + \|v\|^2 + \langle u, v \rangle + \langle v, u \rangle \\ &= \|u\|^2 + \|v\|^2. \end{aligned}$$

□

Note that the converse of the Pythagorean Theorem holds for real vector spaces since, in that case, $\langle u, v \rangle + \langle v, u \rangle = 2\operatorname{Re}\langle u, v \rangle = 0$.

Given two vectors $u, v \in V$ with $v \neq 0$, we can uniquely decompose u into two pieces: one piece parallel to v and one piece orthogonal to v . This is called an **orthogonal decomposition**. More precisely, we have

$$u = u_1 + u_2,$$

where $u_1 = av$ and $u_2 \perp v$ for some scalar $a \in \mathbb{F}$. To obtain such a decomposition, write $u_2 = u - u_1 = u - av$. Then, for u_2 to be orthogonal to v , we need

$$0 = \langle u - av, v \rangle = \langle u, v \rangle - a\|v\|^2.$$

Solving for a yields $a = \langle u, v \rangle / \|v\|^2$ so that

$$u = \frac{\langle u, v \rangle}{\|v\|^2}v + \left(u - \frac{\langle u, v \rangle}{\|v\|^2}v \right). \quad (9.3)$$

This decomposition is particularly useful since it allows us to provide a simple proof for the Cauchy-Schwarz inequality.

Theorem 9.3.3 (Cauchy-Schwarz Inequality). *Given any $u, v \in V$, we have*

$$|\langle u, v \rangle| \leq \|u\| \|v\|.$$

Furthermore, equality holds if and only if u and v are linearly dependent, i.e., are scalar multiples of each other.

Proof. If $v = 0$, then both sides of the inequality are zero. Hence, assume that $v \neq 0$, and consider the orthogonal decomposition

$$u = \frac{\langle u, v \rangle}{\|v\|^2} v + w$$

where $w \perp v$. By the Pythagorean theorem, we have

$$\|u\|^2 = \left\| \frac{\langle u, v \rangle}{\|v\|^2} v \right\|^2 + \|w\|^2 = \frac{|\langle u, v \rangle|^2}{\|v\|^2} + \|w\|^2 \geq \frac{|\langle u, v \rangle|^2}{\|v\|^2}.$$

Multiplying both sides by $\|v\|^2$ and taking the square root then yields the Cauchy-Schwarz inequality.

Note that we get equality in the above arguments if and only if $w = 0$. But, by Equation (9.3), this means that u and v are linearly dependent. \square

The Cauchy-Schwarz inequality has many different proofs. Here is another one.

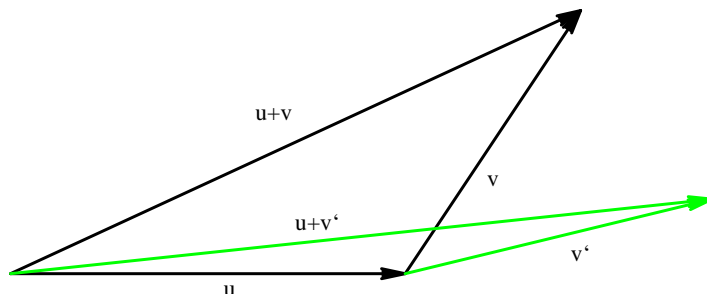
Alternate proof of Theorem 9.3.3. Given $u, v \in V$, consider the norm square of the vector $u + re^{i\theta}v$:

$$0 \leq \|u + re^{i\theta}v\|^2 = \|u\|^2 + r^2\|v\|^2 + 2\operatorname{Re}(re^{i\theta}\langle u, v \rangle).$$

Since $\langle u, v \rangle$ is a complex number, one can choose θ so that $e^{i\theta}\langle u, v \rangle$ is real. Hence, the right hand side is a parabola $ar^2 + br + c$ with real coefficients. It will lie above the real axis, i.e. $ar^2 + br + c \geq 0$, if it does not have any real solutions for r . This is the case when the discriminant satisfies $b^2 - 4ac \leq 0$. In our case this means

$$4|\langle u, v \rangle|^2 - 4\|u\|^2\|v\|^2 \leq 0.$$

Moreover, equality only holds if r can be chosen such that $u + re^{i\theta}v = 0$, which means that u and v are scalar multiples. \square

Figure 9.2: The triangle inequality in \mathbb{R}^2

Now that we have proven the Cauchy-Schwarz inequality, we are finally able to verify the triangle inequality. This is the final step in showing that $\|v\| = \sqrt{\langle v, v \rangle}$ does indeed define a norm. We illustrate the triangle inequality in Figure 9.2.

Theorem 9.3.4 (Triangle Inequality). *For all $u, v \in V$ we have*

$$\|u + v\| \leq \|u\| + \|v\|.$$

Proof. By a straightforward calculation, we obtain

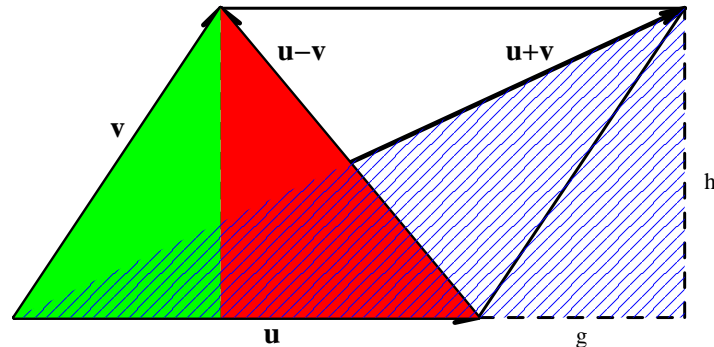
$$\begin{aligned} \|u + v\|^2 &= \langle u + v, u + v \rangle = \langle u, u \rangle + \langle v, v \rangle + \langle u, v \rangle + \langle v, u \rangle \\ &= \langle u, u \rangle + \langle v, v \rangle + \langle u, v \rangle + \overline{\langle u, v \rangle} = \|u\|^2 + \|v\|^2 + 2\operatorname{Re}\langle u, v \rangle. \end{aligned}$$

Note that $\operatorname{Re}\langle u, v \rangle \leq |\langle u, v \rangle|$ so that, using the Cauchy-Schwarz inequality, we obtain

$$\|u + v\|^2 \leq \|u\|^2 + \|v\|^2 + 2\|u\|\|v\| = (\|u\| + \|v\|)^2.$$

Taking the square root of both sides now gives the triangle inequality. \square

Remark 9.3.5. Note that equality holds for the triangle inequality if and only if $v = ru$ or $u = rv$ for some $r \geq 0$. Namely, equality in the proof happens only if $\langle u, v \rangle = \|u\|\|v\|$, which is equivalent to u and v being scalar multiples of one another.

Figure 9.3: The parallelogram law in \mathbb{R}^2

Theorem 9.3.6 (Parallelogram Law). *Given any $u, v \in V$, we have*

$$\|u + v\|^2 + \|u - v\|^2 = 2(\|u\|^2 + \|v\|^2).$$

Proof. By direct calculation,

$$\begin{aligned} \|u + v\|^2 + \|u - v\|^2 &= \langle u + v, u + v \rangle + \langle u - v, u - v \rangle \\ &= \|u\|^2 + \|v\|^2 + \langle u, v \rangle + \langle v, u \rangle + \|u\|^2 + \|v\|^2 - \langle u, v \rangle - \langle v, u \rangle \\ &= 2(\|u\|^2 + \|v\|^2). \end{aligned}$$

□

Remark 9.3.7. We illustrate the parallelogram law in Figure 9.3.

9.4 Orthonormal bases

We now define the notions of orthogonal basis and orthonormal basis for an inner product space. As we will see later, orthonormal bases have many special properties that allow us to simplify various calculations.

Definition 9.4.1. Let V be an inner product space with inner product $\langle \cdot, \cdot \rangle$. A list of nonzero vectors (e_1, \dots, e_m) in V is called **orthogonal** if

$$\langle e_i, e_j \rangle = 0, \quad \text{for all } 1 \leq i \neq j \leq m.$$

The list (e_1, \dots, e_m) is called **orthonormal** if

$$\langle e_i, e_j \rangle = \delta_{i,j}, \quad \text{for all } i, j = 1, \dots, m,$$

where δ_{ij} is the Kronecker delta symbol. I.e., $\delta_{ij} = 1$ if $i = j$ and is zero otherwise.

Proposition 9.4.2. *Every orthogonal list of nonzero vectors in V is linearly independent.*

Proof. Let (e_1, \dots, e_m) be an orthogonal list of vectors in V , and suppose that $a_1, \dots, a_m \in \mathbb{F}$ are such that

$$a_1 e_1 + \dots + a_m e_m = 0.$$

Then

$$0 = \|a_1 e_1 + \dots + a_m e_m\|^2 = |a_1|^2 \|e_1\|^2 + \dots + |a_m|^2 \|e_m\|^2$$

Note that $\|e_k\| > 0$, for all $k = 1, \dots, m$, since every e_k is a nonzero vector. Also, $|a_k|^2 \geq 0$. Hence, the only solution to $a_1 e_1 + \dots + a_m e_m = 0$ is $a_1 = \dots = a_m = 0$. \square

Definition 9.4.3. An **orthonormal basis** of a finite-dimensional inner product space V is a list of orthonormal vectors that is basis for V .

Clearly, any orthonormal list of length $\dim(V)$ is an orthonormal basis for V .

Example 9.4.4. The canonical basis for \mathbb{F}^n is an orthonormal basis.

Example 9.4.5. The list $((\frac{1}{\sqrt{2}}, \frac{1}{\sqrt{2}}), (\frac{1}{\sqrt{2}}, -\frac{1}{\sqrt{2}}))$ is an orthonormal basis for \mathbb{R}^2 .

The next theorem allows us to use inner products to find the coefficients of a vector $v \in V$ in terms of an orthonormal basis. This result highlights how much easier it is to compute with an orthonormal basis.

Theorem 9.4.6. *Let (e_1, \dots, e_n) be an orthonormal basis for V . Then, for all $v \in V$, we have*

$$v = \langle v, e_1 \rangle e_1 + \dots + \langle v, e_n \rangle e_n$$

and $\|v\|^2 = \sum_{k=1}^n |\langle v, e_k \rangle|^2$.

Proof. Let $v \in V$. Since (e_1, \dots, e_n) is a basis for V , there exist unique scalars $a_1, \dots, a_n \in \mathbb{F}$ such that

$$v = a_1 e_1 + \cdots + a_n e_n.$$

Taking the inner product of both sides with respect to e_k then yields $\langle v, e_k \rangle = a_k$. \square

9.5 The Gram-Schmidt orthogonalization procedure

We now come to a fundamentally important algorithm, which is called the **Gram-Schmidt orthogonalization procedure**. This algorithm makes it possible to construct, for each list of linearly independent vectors (resp. basis), a corresponding orthonormal list (resp. orthonormal basis).

Theorem 9.5.1. *If (v_1, \dots, v_m) is a list of linearly independent vectors in V , then there exists an orthonormal list (e_1, \dots, e_m) such that*

$$\text{span}(v_1, \dots, v_k) = \text{span}(e_1, \dots, e_k), \quad \text{for all } k = 1, \dots, m. \quad (9.4)$$

Proof. The proof is constructive, that is, we will actually construct vectors e_1, \dots, e_m having the desired properties. Since (v_1, \dots, v_m) is linearly independent, $v_k \neq 0$ for each $k = 1, 2, \dots, m$. Set $e_1 = \frac{v_1}{\|v_1\|}$. Then e_1 is a vector of norm 1 and satisfies Equation (9.4) for $k = 1$. Next, set

$$e_2 = \frac{v_2 - \langle v_2, e_1 \rangle e_1}{\|v_2 - \langle v_2, e_1 \rangle e_1\|}.$$

This is, in fact, the normalized version of the orthogonal decomposition Equation (9.3). I.e.,

$$w = v_2 - \langle v_2, e_1 \rangle e_1,$$

where $w \perp e_1$. Note that $\|e_2\| = 1$ and $\text{span}(e_1, e_2) = \text{span}(v_1, v_2)$.

Now, suppose that e_1, \dots, e_{k-1} have been constructed such that (e_1, \dots, e_{k-1}) is an orthonormal list and $\text{span}(v_1, \dots, v_{k-1}) = \text{span}(e_1, \dots, e_{k-1})$. Then define

$$e_k = \frac{v_k - \langle v_k, e_1 \rangle e_1 - \langle v_k, e_2 \rangle e_2 - \cdots - \langle v_k, e_{k-1} \rangle e_{k-1}}{\|v_k - \langle v_k, e_1 \rangle e_1 - \langle v_k, e_2 \rangle e_2 - \cdots - \langle v_k, e_{k-1} \rangle e_{k-1}\|}.$$

Since (v_1, \dots, v_k) is linearly independent, we know that $v_k \notin \text{span}(v_1, \dots, v_{k-1})$. Hence, we

also know that $v_k \notin \text{span}(e_1, \dots, e_{k-1})$. It follows that the norm in the definition of e_k is not zero, and so e_k is well-defined (i.e., we are not dividing by zero). Note that a vector divided by its norm has norm 1 so that $\|e_k\| = 1$. Furthermore,

$$\begin{aligned} \langle e_k, e_i \rangle &= \left\langle \frac{v_k - \langle v_k, e_1 \rangle e_1 - \langle v_k, e_2 \rangle e_2 - \dots - \langle v_k, e_{k-1} \rangle e_{k-1}}{\|v_k - \langle v_k, e_1 \rangle e_1 - \langle v_k, e_2 \rangle e_2 - \dots - \langle v_k, e_{k-1} \rangle e_{k-1}\|}, e_i \right\rangle \\ &= \frac{\langle v_k, e_i \rangle - \langle v_k, e_i \rangle}{\|v_k - \langle v_k, e_1 \rangle e_1 - \langle v_k, e_2 \rangle e_2 - \dots - \langle v_k, e_{k-1} \rangle e_{k-1}\|} = 0, \end{aligned}$$

for each $1 \leq i < k$. Hence, (e_1, \dots, e_k) is orthonormal.

From the definition of e_k , we see that $v_k \in \text{span}(e_1, \dots, e_k)$ so that $\text{span}(v_1, \dots, v_k) \subset \text{span}(e_1, \dots, e_k)$. Since both lists (e_1, \dots, e_k) and (v_1, \dots, v_k) are linearly independent, they must span subspaces of the same dimension and therefore are the same subspace. Hence Equation (9.4) holds. \square

Example 9.5.2. Take $v_1 = (1, 1, 0)$ and $v_2 = (2, 1, 1)$ in \mathbb{R}^3 . The list (v_1, v_2) is linearly independent (as you should verify!). To illustrate the Gram-Schmidt procedure, we begin by setting

$$e_1 = \frac{v_1}{\|v_1\|} = \frac{1}{\sqrt{2}}(1, 1, 0).$$

Next, set

$$e_2 = \frac{v_2 - \langle v_2, e_1 \rangle e_1}{\|v_2 - \langle v_2, e_1 \rangle e_1\|}.$$

The inner product $\langle v_2, e_1 \rangle = \frac{1}{\sqrt{2}} \langle (1, 1, 0), (2, 1, 1) \rangle = \frac{3}{\sqrt{2}}$, so

$$u_2 = v_2 - \langle v_2, e_1 \rangle e_1 = (2, 1, 1) - \frac{3}{2}(1, 1, 0) = \frac{1}{2}(1, -1, 2).$$

Calculating the norm of u_2 , we obtain $\|u_2\| = \sqrt{\frac{1}{4}(1 + 1 + 4)} = \frac{\sqrt{6}}{2}$. Hence, normalizing this vector, we obtain

$$e_2 = \frac{u_2}{\|u_2\|} = \frac{1}{\sqrt{6}}(1, -1, 2).$$

The list (e_1, e_2) is therefore orthonormal and has the same span as (v_1, v_2) .

Corollary 9.5.3. *Every finite-dimensional inner product space has an orthonormal basis.*

Proof. Let (v_1, \dots, v_n) be any basis for V . This list is linearly independent and spans V . Apply the Gram-Schmidt procedure to this list to obtain an orthonormal list (e_1, \dots, e_n) ,

which still spans V by construction. By Proposition 9.4.2, this list is linearly independent and hence a basis of V . \square

Corollary 9.5.4. *Every orthonormal list of vectors in V can be extended to an orthonormal basis of V .*

Proof. Let (e_1, \dots, e_m) be an orthonormal list of vectors in V . By Proposition 9.4.2, this list is linearly independent and hence can be extended to a basis $(e_1, \dots, e_m, v_1, \dots, v_k)$ of V by the Basis Extension Theorem. Now apply the Gram-Schmidt procedure to obtain a new orthonormal basis $(e_1, \dots, e_m, f_1, \dots, f_k)$. The first m vectors do not change since they already are orthonormal. The list still spans V and is linearly independent by Proposition 9.4.2 and therefore forms a basis. \square

Recall Theorem 7.5.3: given an operator $T \in \mathcal{L}(V, V)$ on a complex vector space V , there exists a basis B for V such that the matrix $M(T)$ of T with respect to B is upper triangular. We would like to extend this result to require the additional property of orthonormality.

Corollary 9.5.5. *Let V be an inner product space over \mathbb{F} and $T \in \mathcal{L}(V, V)$. If T is upper-triangular with respect to some basis, then T is upper-triangular with respect to some orthonormal basis.*

Proof. Let (v_1, \dots, v_n) be a basis of V with respect to which T is upper-triangular. Apply the Gram-Schmidt procedure to obtain an orthonormal basis (e_1, \dots, e_n) , and note that

$$\text{span}(e_1, \dots, e_k) = \text{span}(v_1, \dots, v_k), \quad \text{for all } 1 \leq k \leq n.$$

We proved before that T is upper-triangular with respect to a basis (v_1, \dots, v_n) if and only if $\text{span}(v_1, \dots, v_k)$ is invariant under T for each $1 \leq k \leq n$. Since these spans are unchanged by the Gram-Schmidt procedure, T is still upper triangular for the corresponding orthonormal basis. \square

9.6 Orthogonal projections and minimization problems

Definition 9.6.1. Let V be a finite-dimensional inner product space and $U \subset V$ be a subset (but not necessarily a subspace) of V . Then the **orthogonal complement** of U is defined

to be the set

$$U^\perp = \{v \in V \mid \langle u, v \rangle = 0 \text{ for all } u \in U\}.$$

Note that, in fact, U^\perp is always a subspace of V (as you should check!) and that

$$\{0\}^\perp = V \quad \text{and} \quad V^\perp = \{0\}.$$

In addition, if U_1 and U_2 are subsets of V satisfying $U_1 \subset U_2$, then $U_2^\perp \subset U_1^\perp$.

Remarkably, if $U \subset V$ is a subspace of V , then we can say quite a bit more about U^\perp .

Theorem 9.6.2. *If $U \subset V$ is a subspace of V , then $V = U \oplus U^\perp$.*

Proof. We need to show two things:

1. $V = U + U^\perp$.
2. $U \cap U^\perp = \{0\}$.

To show Condition 1 holds, let (e_1, \dots, e_m) be an orthonormal basis of U . Then, for all $v \in V$, we can write

$$v = \underbrace{\langle v, e_1 \rangle e_1 + \dots + \langle v, e_m \rangle e_m}_u + v - \underbrace{\langle v, e_1 \rangle e_1 - \dots - \langle v, e_m \rangle e_m}_w. \quad (9.5)$$

The vector $u \in U$, and

$$\langle w, e_j \rangle = \langle v, e_j \rangle - \langle v, e_j \rangle = 0, \quad \text{for all } j = 1, 2, \dots, m,$$

since (e_1, \dots, e_m) is an orthonormal list of vectors. Hence, $w \in U^\perp$. This implies that $V = U + U^\perp$.

To prove that Condition 2 also holds, let $v \in U \cap U^\perp$. Then v has to be orthogonal to every vector in U , including to itself, and so $\langle v, v \rangle = 0$. However, this implies $v = 0$ so that $U \cap U^\perp = \{0\}$. \square

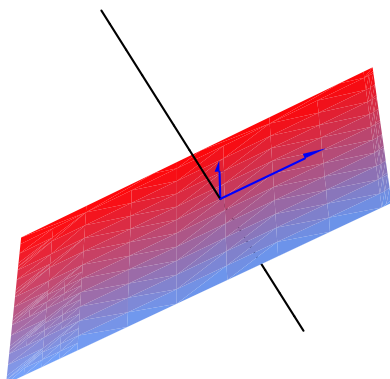


Figure 9.4: \mathbb{R}^3 as a direct sum of a plane and a line, as in Example 9.6.3

Example 9.6.3. \mathbb{R}^2 is the direct sum of any two orthogonal lines, and \mathbb{R}^3 is the direct sum of any plane and any line orthogonal to the plane (as illustrated in Figure 9.4). For example,

$$\begin{aligned} \mathbb{R}^2 &= \{(x, 0) \mid x \in \mathbb{R}\} \oplus \{(0, y) \mid y \in \mathbb{R}\}, \\ \mathbb{R}^3 &= \{(x, y, 0) \mid x, y \in \mathbb{R}\} \oplus \{(0, 0, z) \mid z \in \mathbb{R}\}. \end{aligned}$$

Another fundamental fact about the orthogonal complement of a subspace is as follows.

Theorem 9.6.4. *If $U \subset V$ is a subspace of V , then $U = (U^\perp)^\perp$.*

Proof. First we show that $U \subset (U^\perp)^\perp$. Let $u \in U$. Then, for all $v \in U^\perp$, we have $\langle u, v \rangle = 0$. Hence, $u \in (U^\perp)^\perp$ by the definition of $(U^\perp)^\perp$.

Next we show that $(U^\perp)^\perp \subset U$. Suppose $0 \neq v \in (U^\perp)^\perp$ such that $v \notin U$, and decompose v according to Theorem 9.6.2, i.e., as

$$v = u_1 + u_2 \in U \oplus U^\perp$$

with $u_1 \in U$ and $u_2 \in U^\perp$. Then $u_2 \neq 0$ since $v \notin U$. Furthermore, $\langle u_2, v \rangle = \langle u_2, u_2 \rangle \neq 0$. But then v is not in $(U^\perp)^\perp$, which contradicts our initial assumption. Hence, we must have that $(U^\perp)^\perp \subset U$. \square

By Theorem 9.6.2, we have the decomposition $V = U \oplus U^\perp$ for every subspace $U \subset V$. This allows us to define the **orthogonal projection** P_U of V onto U .

Definition 9.6.5. Let $U \subset V$ be a subspace of a finite-dimensional inner product space. Every $v \in V$ can be uniquely written as $v = u + w$ where $u \in U$ and $w \in U^\perp$. Define

$$\begin{aligned} P_U : V &\rightarrow V, \\ v &\mapsto u. \end{aligned}$$

Note that P_U is called a projection operator since it satisfies $P_U^2 = P_U$. Further, since we also have

$$\begin{aligned}\text{range}(P_U) &= U, \\ \text{null}(P_U) &= U^\perp,\end{aligned}$$

it follows that $\text{range}(P_U) \perp \text{null}(P_U)$. Therefore, P_U is called an orthogonal projection.

The decomposition of a vector $v \in V$ as given in Equation (9.5) yields the formula

$$P_U v = \langle v, e_1 \rangle e_1 + \cdots + \langle v, e_m \rangle e_m, \quad (9.6)$$

where (e_1, \dots, e_m) is any orthonormal basis of U . Equation (9.6) is a particularly useful tool for computing such things as the matrix of P_U with respect to the basis (e_1, \dots, e_m) .

Let us now apply the inner product to the following minimization problem: Given a subspace $U \subset V$ and a vector $v \in V$, find the vector $u \in U$ that is closest to the vector v . In other words, we want to make $\|v - u\|$ as small as possible. The next proposition shows that $P_U v$ is the closest point in U to the vector v and that this minimum is, in fact, unique.

Proposition 9.6.6. *Let $U \subset V$ be a subspace of V and $v \in V$. Then*

$$\|v - P_U v\| \leq \|v - u\| \quad \text{for every } u \in U.$$

Furthermore, equality holds if and only if $u = P_U v$.

Proof. Let $u \in U$ and set $P := P_U$ for short. Then

$$\begin{aligned}\|v - P v\|^2 &\leq \|v - P v\|^2 + \|P v - u\|^2 \\ &= \|(v - P v) + (P v - u)\|^2 = \|v - u\|^2,\end{aligned}$$

where the second line follows from the Pythagorean Theorem 9.3.2 since $v - P v \in U^\perp$ and $P v - u \in U$. Furthermore, equality holds only if $\|P v - u\|^2 = 0$, which is equivalent to $P v = u$. \square

Example 9.6.7. Consider the plane $U \subset \mathbb{R}^3$ through 0 and perpendicular to the vector $u = (1, 1, 1)$. Using the standard norm on \mathbb{R}^3 , we can calculate the distance of the point $v = (1, 2, 3)$ to U using Proposition 9.6.6. In particular, the distance d between v and U

is given by $d = \|v - P_U v\|$. Let $(\frac{1}{\sqrt{3}}u, u_1, u_2)$ be a basis for \mathbb{R}^3 such that (u_1, u_2) is an orthonormal basis of U . Then, by Equation (9.6), we have

$$\begin{aligned} v - P_U v &= \left(\frac{1}{3}\langle v, u \rangle u + \langle v, u_1 \rangle u_1 + \langle v, u_2 \rangle u_2\right) - (\langle v, u_1 \rangle u_1 + \langle v, u_2 \rangle u_2) \\ &= \frac{1}{3}\langle v, u \rangle u \\ &= \frac{1}{3}\langle (1, 2, 3), (1, 1, 1) \rangle (1, 1, 1) \\ &= (2, 2, 2). \end{aligned}$$

Hence, $d = \|(2, 2, 2)\| = 2\sqrt{3}$.

Exercises for Chapter 9

Computational Exercises

1. Let (e_1, e_2, e_3) be the canonical basis of \mathbb{R}^3 , and define

$$f_1 = e_1 + e_2 + e_3$$

$$f_2 = e_2 + e_3$$

$$f_3 = e_3.$$

- (a) Apply the Gram-Schmidt process to the basis (f_1, f_2, f_3) .
- (b) What do you obtain if you instead applied the Gram-Schmidt process to the basis (f_3, f_2, f_1) ?
2. Let $\mathcal{C}[-\pi, \pi] = \{f : [-\pi, \pi] \rightarrow \mathbb{R} \mid f \text{ is continuous}\}$ denote the inner product space of continuous real-valued functions defined on the interval $[-\pi, \pi] \subset \mathbb{R}$, with inner product given by

$$\langle f, g \rangle = \int_{-\pi}^{\pi} f(x)g(x)dx, \text{ for every } f, g \in \mathcal{C}[-\pi, \pi].$$

Then, given any positive integer $n \in \mathbb{Z}_+$, verify that the set of vectors

$$\left\{ \frac{1}{\sqrt{2\pi}}, \frac{\sin(x)}{\sqrt{\pi}}, \frac{\sin(2x)}{\sqrt{\pi}}, \dots, \frac{\sin(nx)}{\sqrt{\pi}}, \frac{\cos(x)}{\sqrt{\pi}}, \frac{\cos(2x)}{\sqrt{\pi}}, \dots, \frac{\cos(nx)}{\sqrt{\pi}} \right\}$$

is orthonormal.

3. Let $\mathbb{R}_2[x]$ denote the inner product space of polynomials over \mathbb{R} having degree at most two, with inner product given by

$$\langle f, g \rangle = \int_0^1 f(x)g(x)dx, \text{ for every } f, g \in \mathbb{R}_2[x].$$

Apply the Gram-Schmidt procedure to the standard basis $\{1, x, x^2\}$ for $\mathbb{R}_2[x]$ in order to produce an orthonormal basis for $\mathbb{R}_2[x]$.

4. Let $v_1, v_2, v_3 \in \mathbb{R}^3$ be given by $v_1 = (1, 2, 1)$, $v_2 = (1, -2, 1)$, and $v_3 = (1, 2, -1)$. Apply the Gram-Schmidt procedure to the basis (v_1, v_2, v_3) of \mathbb{R}^3 , and call the resulting orthonormal basis (u_1, u_2, u_3) .
5. Let $P \subset \mathbb{R}^3$ be the plane containing 0 perpendicular to the vector $(1, 1, 1)$. Using the standard norm, calculate the distance of the point $(1, 2, 3)$ to P .
6. Give an orthonormal basis for $\text{null}(T)$, where $T \in \mathcal{L}(\mathbb{C}^4)$ is the map with canonical matrix

$$\begin{pmatrix} 1 & 1 & 1 & 1 \\ 1 & 1 & 1 & 1 \\ 1 & 1 & 1 & 1 \\ 1 & 1 & 1 & 1 \end{pmatrix}.$$

Proof-Writing Exercises

1. Let V be a finite-dimensional inner product space over \mathbb{F} . Given any vectors $u, v \in V$, prove that the following two statements are equivalent:
 - (a) $\langle u, v \rangle = 0$
 - (b) $\|u\| \leq \|u + \alpha v\|$ for every $\alpha \in \mathbb{F}$.
2. Let $n \in \mathbb{Z}_+$ be a positive integer, and let $a_1, \dots, a_n, b_1, \dots, b_n \in \mathbb{R}$ be any collection of $2n$ real numbers. Prove that

$$\left(\sum_{k=1}^n a_k b_k \right)^2 \leq \left(\sum_{k=1}^n k a_k^2 \right) \left(\sum_{k=1}^n \frac{b_k^2}{k} \right)$$

3. Prove or disprove the following claim:

Claim. *There is an inner product $\langle \cdot, \cdot \rangle$ on \mathbb{R}^2 whose associated norm $\|\cdot\|$ is given by the formula*

$$\|(x_1, x_2)\| = |x_1| + |x_2|$$

for every vector $(x_1, x_2) \in \mathbb{R}^2$, where $|\cdot|$ denotes the absolute value function on \mathbb{R} .

4. Let V be a finite-dimensional inner product space over \mathbb{R} . Given $u, v \in V$, prove that

$$\langle u, v \rangle = \frac{\|u + v\|^2 - \|u - v\|^2}{4}.$$

5. Let V be a finite-dimensional inner product space over \mathbb{C} . Given $u, v \in V$, prove that

$$\langle u, v \rangle = \frac{\|u + v\|^2 - \|u - v\|^2}{4} + \frac{\|u + iv\|^2 - \|u - iv\|^2}{4}i.$$

6. Let V be a finite-dimensional inner product space over \mathbb{F} , and let U be a subspace of V . Prove that the orthogonal complement U^\perp of U with respect to the inner product $\langle \cdot, \cdot \rangle$ on V satisfies

$$\dim(U^\perp) = \dim(V) - \dim(U).$$

7. Let V be a finite-dimensional inner product space over \mathbb{F} , and let U be a subspace of V . Prove that $U = V$ if and only if the orthogonal complement U^\perp of U with respect to the inner product $\langle \cdot, \cdot \rangle$ on V satisfies $U^\perp = \{0\}$.

8. Let V be a finite-dimensional inner product space over \mathbb{F} , and suppose that $P \in \mathcal{L}(V)$ is a linear operator on V having the following two properties:

- (a) Given any vector $v \in V$, $P(P(v)) = P(v)$. I.e., $P^2 = P$.
- (b) Given any vector $u \in \text{null}(P)$ and any vector $v \in \text{range}(P)$, $\langle u, v \rangle = 0$.

Prove that P is an orthogonal projection.

9. Prove or give a counterexample: For any $n \geq 1$ and $A \in \mathbb{C}^{n \times n}$, one has

$$\text{null}(A) = (\text{range}(A))^\perp.$$

10. Prove or give a counterexample: The Gram-Schmidt process applied to an orthonormal list of vectors reproduces that list unchanged.

Chapter 10

Change of Bases

In Section 6.6, we saw that linear operators on an n -dimensional vector space are in one-to-one correspondence with $n \times n$ matrices. This correspondence, however, depends upon the choice of basis for the vector space. In this chapter we address the question of how the matrix for a linear operator changes if we change from one orthonormal basis to another.

10.1 Coordinate vectors

Let V be a finite-dimensional inner product space with inner product $\langle \cdot, \cdot \rangle$ and dimension $\dim(V) = n$. Then V has an orthonormal basis $e = (e_1, \dots, e_n)$, and, according to Theorem 9.4.6, every $v \in V$ can be written as

$$v = \sum_{i=1}^n \langle v, e_i \rangle e_i.$$

This induces a map

$$[\cdot]_e : V \rightarrow \mathbb{F}^n$$
$$v \mapsto \begin{bmatrix} \langle v, e_1 \rangle \\ \vdots \\ \langle v, e_n \rangle \end{bmatrix},$$

which maps the vector $v \in V$ to the $n \times 1$ column vector of its coordinates with respect to the basis e . The column vector $[v]_e$ is called the **coordinate vector** of v with respect to the basis e .

Example 10.1.1. Recall that the vector space $\mathbb{R}_1[x]$ of polynomials over \mathbb{R} of degree at most 1 is an inner product space with inner product defined by

$$\langle f, g \rangle = \int_0^1 f(x)g(x)dx.$$

Then $e = (1, \sqrt{3}(-1 + 2x))$ forms an orthonormal basis for $\mathbb{R}_1[x]$. The coordinate vector of the polynomial $p(x) = 3x + 2 \in \mathbb{R}_1[x]$ is, e.g.,

$$[p(x)]_e = \frac{1}{2} \begin{bmatrix} 7 \\ \sqrt{3} \end{bmatrix}.$$

Note also that the map $[\cdot]_e$ is an isomorphism (meaning that it is an injective and surjective linear map) and that it is also inner product preserving. Denote the usual inner product on \mathbb{F}^n by

$$\langle x, y \rangle_{\mathbb{F}^n} = \sum_{k=1}^n x_k \bar{y}_k.$$

Then

$$\langle v, w \rangle_V = \langle [v]_e, [w]_e \rangle_{\mathbb{F}^n}, \quad \text{for all } v, w \in V,$$

since

$$\begin{aligned} \langle v, w \rangle_V &= \sum_{i,j=1}^n \langle \langle v, e_i \rangle e_i, \langle w, e_j \rangle e_j \rangle = \sum_{i,j=1}^n \langle v, e_i \rangle \overline{\langle w, e_j \rangle} \langle e_i, e_j \rangle \\ &= \sum_{i,j=1}^n \langle v, e_i \rangle \overline{\langle w, e_j \rangle} \delta_{ij} = \sum_{i=1}^n \langle v, e_i \rangle \overline{\langle w, e_i \rangle} = \langle [v]_e, [w]_e \rangle_{\mathbb{F}^n}. \end{aligned}$$

It is important to remember that the map $[\cdot]_e$ depends on the choice of basis $e = (e_1, \dots, e_n)$.

10.2 Change of basis transformation

Recall that we can associate a matrix $A \in \mathbb{F}^{n \times n}$ to every operator $T \in \mathcal{L}(V, V)$. More precisely, the j^{th} column of the matrix $A = M(T)$ with respect to a basis $e = (e_1, \dots, e_n)$ is obtained by expanding Te_j in terms of the basis e . If the basis e is orthonormal, then the coefficient of e_i is just the inner product of the vector with e_i . Hence,

$$M(T) = (\langle Te_j, e_i \rangle)_{1 \leq i, j \leq n},$$

where i is the row index and j is the column index of the matrix.

Conversely, if $A \in \mathbb{F}^{n \times n}$ is a matrix, then we can associate a linear operator $T \in \mathcal{L}(V, V)$ to A by setting

$$\begin{aligned} Tv &= \sum_{j=1}^n \langle v, e_j \rangle Te_j = \sum_{j=1}^n \sum_{i=1}^n \langle Te_j, e_i \rangle \langle v, e_j \rangle e_i \\ &= \sum_{i=1}^n \left(\sum_{j=1}^n a_{ij} \langle v, e_j \rangle \right) e_i = \sum_{i=1}^n (A[v]_e)_i e_i, \end{aligned}$$

where $(A[v]_e)_i$ denotes the i^{th} component of the column vector $A[v]_e$. With this construction, we have $M(T) = A$. The coefficients of Tv in the basis (e_1, \dots, e_n) are recorded by the column vector obtained by multiplying the $n \times n$ matrix A with the $n \times 1$ column vector $[v]_e$ whose components $([v]_e)_j = \langle v, e_j \rangle$.

Example 10.2.1. Given

$$A = \begin{bmatrix} 1 & -i \\ i & 1 \end{bmatrix},$$

we can define $T \in \mathcal{L}(V, V)$ with respect to the canonical basis as follows:

$$T \begin{bmatrix} z_1 \\ z_2 \end{bmatrix} = \begin{bmatrix} 1 & -i \\ i & 1 \end{bmatrix} \begin{bmatrix} z_1 \\ z_2 \end{bmatrix} = \begin{bmatrix} z_1 - iz_2 \\ iz_1 + z_2 \end{bmatrix}.$$

Suppose that we want to use another orthonormal basis $f = (f_1, \dots, f_n)$ for V . Then, as

before, we have $v = \sum_{i=1}^n \langle v, f_i \rangle f_i$. Comparing this with $v = \sum_{j=1}^n \langle v, e_j \rangle e_j$, we find that

$$v = \sum_{i,j=1}^n \langle \langle v, e_j \rangle e_j, f_i \rangle f_i = \sum_{i=1}^n \left(\sum_{j=1}^n \langle e_j, f_i \rangle \langle v, e_j \rangle \right) f_i.$$

Hence,

$$[v]_f = S[v]_e,$$

where

$$S = (s_{ij})_{i,j=1}^n \quad \text{with } s_{ij} = \langle e_j, f_i \rangle.$$

The j^{th} column of S is given by the coefficients of the expansion of e_j in terms of the basis $f = (f_1, \dots, f_n)$. The matrix S describes a linear map in $\mathcal{L}(\mathbb{F}^n)$, which is called the **change of basis transformation**.

We may also interchange the role of bases e and f . In this case, we obtain the matrix $R = (r_{ij})_{i,j=1}^n$, where

$$r_{ij} = \langle f_j, e_i \rangle.$$

Then, by the uniqueness of the expansion in a basis, we obtain

$$[v]_e = R[v]_f$$

so that

$$RS[v]_e = [v]_e, \quad \text{for all } v \in V.$$

Since this equation is true for all $[v]_e \in \mathbb{F}^n$, it follows that either $RS = I$ or $R = S^{-1}$. In particular, S and R are invertible. We can also check this explicitly by using the properties of orthonormal bases. Namely,

$$\begin{aligned} (RS)_{ij} &= \sum_{k=1}^n r_{ik} s_{kj} = \sum_{k=1}^n \langle f_k, e_i \rangle \langle e_j, f_k \rangle \\ &= \sum_{k=1}^n \langle e_j, f_k \rangle \overline{\langle e_i, f_k \rangle} = \langle [e_j]_f, [e_i]_f \rangle_{\mathbb{F}^n} = \delta_{ij}. \end{aligned}$$

Matrix S (and similarly also R) has the interesting property that its columns are orthonormal to one another. This follows from the fact that the columns are the coordinates of

orthonormal vectors with respect to another orthonormal basis. A similar statement holds for the rows of S (and similarly also R).

Example 10.2.2. Let $V = \mathbb{C}^2$, and choose the orthonormal bases $e = (e_1, e_2)$ and $f = (f_1, f_2)$ with

$$\begin{aligned} e_1 &= \begin{bmatrix} 1 \\ 0 \end{bmatrix}, & e_2 &= \begin{bmatrix} 0 \\ 1 \end{bmatrix}, \\ f_1 &= \frac{1}{\sqrt{2}} \begin{bmatrix} 1 \\ 1 \end{bmatrix}, & f_2 &= \frac{1}{\sqrt{2}} \begin{bmatrix} -1 \\ 1 \end{bmatrix}. \end{aligned}$$

Then

$$S = \begin{bmatrix} \langle e_1, f_1 \rangle & \langle e_2, f_1 \rangle \\ \langle e_1, f_2 \rangle & \langle e_2, f_2 \rangle \end{bmatrix} = \frac{1}{\sqrt{2}} \begin{bmatrix} 1 & 1 \\ -1 & 1 \end{bmatrix}$$

and

$$R = \begin{bmatrix} \langle f_1, e_1 \rangle & \langle f_2, e_1 \rangle \\ \langle f_1, e_2 \rangle & \langle f_2, e_2 \rangle \end{bmatrix} = \frac{1}{\sqrt{2}} \begin{bmatrix} 1 & -1 \\ 1 & 1 \end{bmatrix}.$$

One can then check explicitly that indeed

$$RS = \frac{1}{2} \begin{bmatrix} 1 & -1 \\ 1 & 1 \end{bmatrix} \begin{bmatrix} 1 & 1 \\ -1 & 1 \end{bmatrix} = \begin{bmatrix} 1 & 0 \\ 0 & 1 \end{bmatrix} = I.$$

So far we have only discussed how the coordinate vector of a given vector $v \in V$ changes under the change of basis from e to f . The next question we can ask is how the matrix $M(T)$ of an operator $T \in \mathcal{L}(V)$ changes if we change the basis. Let A be the matrix of T with respect to the basis $e = (e_1, \dots, e_n)$, and let B be the matrix for T with respect to the basis $f = (f_1, \dots, f_n)$. How do we determine B from A ? Note that

$$[Tv]_e = A[v]_e$$

so that

$$[Tv]_f = S[Tv]_e = SA[v]_e = SAR[v]_f = SAS^{-1}[v]_f.$$

This implies that

$$B = SAS^{-1}.$$

Example 10.2.3. Continuing Example 10.2.2, let

$$A = \begin{bmatrix} 1 & 1 \\ 1 & 1 \end{bmatrix}$$

be the matrix of a linear operator with respect to the basis e . Then the matrix B with respect to the basis f is given by

$$B = SAS^{-1} = \frac{1}{2} \begin{bmatrix} 1 & 1 \\ -1 & 1 \end{bmatrix} \begin{bmatrix} 1 & 1 \\ 1 & 1 \end{bmatrix} \begin{bmatrix} 1 & -1 \\ 1 & 1 \end{bmatrix} = \frac{1}{2} \begin{bmatrix} 1 & 1 \\ -1 & 1 \end{bmatrix} \begin{bmatrix} 2 & 0 \\ 2 & 0 \end{bmatrix} = \begin{bmatrix} 2 & 0 \\ 0 & 0 \end{bmatrix}.$$

Exercises for Chapter 10

Computational Exercises

1. Consider \mathbb{R}^3 with two orthonormal bases: the canonical basis $e = (e_1, e_2, e_3)$ and the basis $f = (f_1, f_2, f_3)$, where

$$f_1 = \frac{1}{\sqrt{3}}(1, 1, 1), \quad f_2 = \frac{1}{\sqrt{6}}(1, -2, 1), \quad f_3 = \frac{1}{\sqrt{2}}(1, 0, -1).$$

Find the matrix, S , of the change of basis transformation such that

$$[v]_f = S[v]_e, \quad \text{for all } v \in \mathbb{R}^3,$$

where $[v]_b$ denotes the column vector of v with respect to the basis b .

2. Let $v \in \mathbb{C}^4$ be the vector given by $v = (1, i, -1, -i)$. Find the matrix (with respect to the canonical basis on \mathbb{C}^4) of the orthogonal projection $P \in \mathcal{L}(\mathbb{C}^4)$ such that

$$\text{null}(P) = \{v\}^\perp.$$

3. Let U be the subspace of \mathbb{R}^3 that coincides with the plane through the origin that is perpendicular to the vector $n = (1, 1, 1) \in \mathbb{R}^3$.

(a) Find an orthonormal basis for U .

(b) Find the matrix (with respect to the canonical basis on \mathbb{R}^3) of the orthogonal projection $P \in \mathcal{L}(\mathbb{R}^3)$ onto U , i.e., such that $\text{range}(P) = U$.

4. Let $V = \mathbb{C}^4$ with its standard inner product. For $\theta \in \mathbb{R}$, let

$$v_\theta = \begin{pmatrix} 1 \\ e^{i\theta} \\ e^{2i\theta} \\ e^{3i\theta} \end{pmatrix} \in \mathbb{C}^4.$$

Find the canonical matrix of the orthogonal projection onto the subspace $\{v_\theta\}^\perp$.

Proof-Writing Exercises

1. Let V be a finite-dimensional vector space over \mathbb{F} with dimension $n \in \mathbb{Z}_+$, and suppose that $b = (v_1, v_2, \dots, v_n)$ is a basis for V . Prove that the coordinate vectors $[v_1]_b, [v_2]_b, \dots, [v_n]_b$ with respect to b form a basis for \mathbb{F}^n .
2. Let V be a finite-dimensional vector space over \mathbb{F} , and suppose that $T \in \mathcal{L}(V)$ is a linear operator having the following property: Given any two bases b and c for V , the matrix $M(T, b)$ for T with respect to b is the same as the matrix $M(T, c)$ for T with respect to c . Prove that there exists a scalar $\alpha \in \mathbb{F}$ such that $T = \alpha I_V$, where I_V denotes the identity map on V .

Chapter 11

The Spectral Theorem for Normal Linear Maps

In this chapter we come back to the question of when a linear operator on an inner product space V is diagonalizable. We first introduce the notion of the adjoint (a.k.a. hermitian conjugate) of an operator, and we then use this to define so-called normal operators. The main result of this chapter is the Spectral Theorem, which states that normal operators are diagonal with respect to an orthonormal basis. We use this to show that normal operators are “unitarily diagonalizable” and generalize this notion to finding the singular-value decomposition of an operator.

11.1 Self-adjoint or hermitian operators

Let V be a finite-dimensional inner product space over \mathbb{C} with inner product $\langle \cdot, \cdot \rangle$. A linear operator $T \in \mathcal{L}(V)$ is uniquely determined by the values of

$$\langle Tv, w \rangle, \quad \text{for all } v, w \in V.$$

This means, in particular, that if $T, S \in \mathcal{L}(V)$ and

$$\langle Tv, w \rangle = \langle Sv, w \rangle \quad \text{for all } v, w \in V,$$

then $T = S$. To see this, take w to be the elements of an orthonormal basis of V .

Definition 11.1.1. Given $T \in \mathcal{L}(V)$, the **adjoint** (a.k.a. **hermitian conjugate**) of T is defined to be the operator $T^* \in \mathcal{L}(V)$ for which

$$\langle Tv, w \rangle = \langle v, T^*w \rangle, \quad \text{for all } v, w \in V$$

Moreover, we call T **self-adjoint** (a.k.a. **hermitian**) if $T = T^*$.

The uniqueness of T^* is clear by the previous observation.

Example 11.1.2. Let $V = \mathbb{C}^3$, and let $T \in \mathcal{L}(\mathbb{C}^3)$ be defined by $T(z_1, z_2, z_3) = (2z_2 + iz_3, iz_1, z_2)$. Then

$$\begin{aligned} \langle (y_1, y_2, y_3), T^*(z_1, z_2, z_3) \rangle &= \langle T(y_1, y_2, y_3), (z_1, z_2, z_3) \rangle \\ &= \langle (2y_2 + iy_3, iy_1, y_2), (z_1, z_2, z_3) \rangle \\ &= 2y_2\bar{z}_1 + iy_3\bar{z}_1 + iy_1\bar{z}_2 + y_2\bar{z}_3 \\ &= \langle (y_1, y_2, y_3), (-iz_2, 2z_1 + z_3, -iz_1) \rangle \end{aligned}$$

so that $T^*(z_1, z_2, z_3) = (-iz_2, 2z_1 + z_3, -iz_1)$. Writing the matrix for T in terms of the canonical basis, we see that

$$M(T) = \begin{bmatrix} 0 & 2 & i \\ i & 0 & 0 \\ 0 & 1 & 0 \end{bmatrix} \quad \text{and} \quad M(T^*) = \begin{bmatrix} 0 & -i & 0 \\ 2 & 0 & 1 \\ -i & 0 & 0 \end{bmatrix}.$$

Note that $M(T^*)$ can be obtained from $M(T)$ by taking the complex conjugate of each element and then transposing. This operation is called the **conjugate transpose** of $M(T)$, and we denote it by $(M(T))^*$.

We collect several elementary properties of the adjoint operation into the following proposition. You should provide a proof of these results for your own practice.

Proposition 11.1.3. Let $S, T \in \mathcal{L}(V)$ and $a \in \mathbb{F}$.

1. $(S + T)^* = S^* + T^*$.
2. $(aT)^* = \bar{a}T^*$.

$$3. (T^*)^* = T.$$

$$4. I^* = I.$$

$$5. (ST)^* = T^*S^*.$$

$$6. M(T^*) = M(T)^*.$$

When $n = 1$, note that the conjugate transpose of a 1×1 matrix A is just the complex conjugate of its single entry. Hence, requiring A to be self-adjoint ($A = A^*$) amounts to saying that this sole entry is real. Because of the transpose, though, reality is not the same as self-adjointness when $n > 1$, but the analogy does nonetheless carry over to the eigenvalues of self-adjoint operators.

Proposition 11.1.4. *Every eigenvalue of a self-adjoint operator is real.*

Proof. Suppose $\lambda \in \mathbb{C}$ is an eigenvalue of T and that $0 \neq v \in V$ is a corresponding eigenvector such that $Tv = \lambda v$. Then

$$\begin{aligned} \lambda \|v\|^2 &= \langle \lambda v, v \rangle = \langle Tv, v \rangle = \langle v, T^*v \rangle \\ &= \langle v, Tv \rangle = \langle v, \lambda v \rangle = \bar{\lambda} \langle v, v \rangle = \bar{\lambda} \|v\|^2. \end{aligned}$$

This implies that $\lambda = \bar{\lambda}$. □

Example 11.1.5. The operator $T \in \mathcal{L}(V)$ defined by $T(v) = \begin{bmatrix} 2 & 1+i \\ 1-i & 3 \end{bmatrix} v$ is self-adjoint, and it can be checked (e.g., using the characteristic polynomial) that the eigenvalues of T are $\lambda = 1, 4$.

11.2 Normal operators

Normal operators are those that commute with their own adjoint. As we will see, this includes many important examples of operations.

Definition 11.2.1. We call $T \in \mathcal{L}(V)$ **normal** if $TT^* = T^*T$.

Given an arbitrary operator $T \in \mathcal{L}(V)$, we have that $TT^* \neq T^*T$ in general. However, both TT^* and T^*T are self-adjoint, and any self-adjoint operator T is normal. We now give a different characterization for normal operators in terms of norms.

Proposition 11.2.2. *Let V be a complex inner product space, and suppose that $T \in \mathcal{L}(V)$ satisfies*

$$\langle Tv, v \rangle = 0, \quad \text{for all } v \in V.$$

Then $T = 0$.

Proof. You should be able to verify that

$$\begin{aligned} \langle Tu, w \rangle &= \frac{1}{4} \{ \langle T(u+w), u+w \rangle - \langle T(u-w), u-w \rangle \\ &\quad + i \langle T(u+iw), u+iw \rangle - i \langle T(u-iw), u-iw \rangle \}. \end{aligned}$$

Since each term on the right-hand side is of the form $\langle Tv, v \rangle$, we obtain 0 for each $u, w \in V$. Hence $T = 0$. \square

Proposition 11.2.3. *Let $T \in \mathcal{L}(V)$. Then T is normal if and only if*

$$\|Tv\| = \|T^*v\|, \quad \text{for all } v \in V.$$

Proof. Note that

$$\begin{aligned} T \text{ is normal} &\iff T^*T - TT^* = 0 \\ &\iff \langle (T^*T - TT^*)v, v \rangle = 0, \quad \text{for all } v \in V \\ &\iff \langle TT^*v, v \rangle = \langle T^*Tv, v \rangle, \quad \text{for all } v \in V \\ &\iff \|Tv\|^2 = \|T^*v\|^2, \quad \text{for all } v \in V. \end{aligned}$$

\square

Corollary 11.2.4. *Let $T \in \mathcal{L}(V)$ be a normal operator.*

1. $\text{null}(T) = \text{null}(T^*)$.
2. If $\lambda \in \mathbb{C}$ is an eigenvalue of T , then $\bar{\lambda}$ is an eigenvalue of T^* with the same eigenvector.
3. If $\lambda, \mu \in \mathbb{C}$ are distinct eigenvalues of T with associated eigenvectors $v, w \in V$, respectively, then $\langle v, w \rangle = 0$.

Proof. Note that Part 1 follows from Proposition 11.2.3 and the positive definiteness of the norm.

To prove Part 2, first verify that if T is normal, then $T - \lambda I$ is also normal with $(T - \lambda I)^* = T^* - \bar{\lambda}I$. Therefore, by Proposition 11.2.3, we have

$$0 = \|(T - \lambda I)v\| = \|(T - \lambda I)^*v\| = \|(T^* - \bar{\lambda}I)v\|,$$

and so v is an eigenvector of T^* with eigenvalue $\bar{\lambda}$.

Using Part 2, note that

$$(\lambda - \mu)\langle v, w \rangle = \langle \lambda v, w \rangle - \langle v, \bar{\mu}w \rangle = \langle Tv, w \rangle - \langle v, T^*w \rangle = 0.$$

Since $\lambda - \mu \neq 0$ it follows that $\langle v, w \rangle = 0$, proving Part 3. \square

11.3 Normal operators and the spectral decomposition

Recall that an operator $T \in \mathcal{L}(V)$ is diagonalizable if there exists a basis B for V such that B consists entirely of eigenvectors for T . The nicest operators on V are those that are diagonalizable with respect to some orthonormal basis for V . In other words, these are the operators for which we can find an orthonormal basis for V that consists of eigenvectors for T . The Spectral Theorem for finite-dimensional complex inner product spaces states that this can be done precisely for normal operators.

Theorem 11.3.1 (Spectral Theorem). *Let V be a finite-dimensional inner product space over \mathbb{C} and $T \in \mathcal{L}(V)$. Then T is normal if and only if there exists an orthonormal basis for V consisting of eigenvectors for T .*

Proof.

(“ \implies ”) Suppose that T is normal. Combining Theorem 7.5.3 and Corollary 9.5.5, there exists an orthonormal basis $e = (e_1, \dots, e_n)$ for which the matrix $M(T)$ is upper triangular, i.e.,

$$M(T) = \begin{bmatrix} a_{11} & \cdots & a_{1n} \\ & \ddots & \vdots \\ 0 & & a_{nn} \end{bmatrix}.$$

We will show that $M(T)$ is, in fact, diagonal, which implies that the basis elements e_1, \dots, e_n are eigenvectors of T .

Since $M(T) = (a_{ij})_{i,j=1}^n$ with $a_{ij} = 0$ for $i > j$, we have $Te_1 = a_{11}e_1$ and $T^*e_1 = \sum_{k=1}^n \bar{a}_{1k}e_k$. Thus, by the Pythagorean Theorem and Proposition 11.2.3,

$$|a_{11}|^2 = \|a_{11}e_1\|^2 = \|Te_1\|^2 = \|T^*e_1\|^2 = \left\| \sum_{k=1}^n \bar{a}_{1k}e_k \right\|^2 = \sum_{k=1}^n |a_{1k}|^2,$$

from which it follows that $|a_{12}| = \dots = |a_{1n}| = 0$. Repeating this argument, $\|Te_j\|^2 = |a_{jj}|^2$ and $\|T^*e_j\|^2 = \sum_{k=j}^n |a_{jk}|^2$ so that $a_{ij} = 0$ for all $2 \leq i < j \leq n$. Hence, T is diagonal with respect to the basis e , and e_1, \dots, e_n are eigenvectors of T .

(“ \Leftarrow ”) Suppose there exists an orthonormal basis (e_1, \dots, e_n) for V that consists of eigenvectors for T . Then the matrix $M(T)$ with respect to this basis is diagonal. Moreover, $M(T^*) = M(T)^*$ with respect to this basis must also be a diagonal matrix. It follows that $TT^* = T^*T$ since their corresponding matrices commute:

$$M(TT^*) = M(T)M(T^*) = M(T^*)M(T) = M(T^*T).$$

□

The following corollary is the best possible decomposition of a complex vector space V into subspaces that are invariant under a normal operator T . On each subspace $\text{null}(T - \lambda_i I)$, the operator T acts just like multiplication by scalar λ_i . In other words,

$$T|_{\text{null}(T - \lambda_i I)} = \lambda_i I_{\text{null}(T - \lambda_i I)}.$$

Corollary 11.3.2. *Let $T \in \mathcal{L}(V)$ be a normal operator, and denote by $\lambda_1, \dots, \lambda_m$ the distinct eigenvalues of T .*

1. $V = \text{null}(T - \lambda_1 I) \oplus \dots \oplus \text{null}(T - \lambda_m I)$.
2. If $i \neq j$, then $\text{null}(T - \lambda_i I) \perp \text{null}(T - \lambda_j I)$.

As we will see in the next section, we can use Corollary 11.3.2 to decompose the canonical matrix for a normal operator into a so-called “unitary diagonalization”.

11.4 Applications of the Spectral Theorem: diagonalization

Let $e = (e_1, \dots, e_n)$ be a basis for an n -dimensional vector space V , and let $T \in \mathcal{L}(V)$. In this section we denote the matrix $M(T)$ of T with respect to basis e by $[T]_e$. This is done to emphasize the dependency on the basis e . In other words, we have that

$$[Tv]_e = [T]_e[v]_e, \quad \text{for all } v \in V,$$

where

$$[v]_e = \begin{bmatrix} v_1 \\ \vdots \\ v_n \end{bmatrix}$$

is the coordinate vector for $v = v_1e_1 + \dots + v_ne_n$ with $v_i \in \mathbb{F}$.

The operator T is diagonalizable if there exists a basis e such that $[T]_e$ is diagonal, i.e., if there exist $\lambda_1, \dots, \lambda_n \in \mathbb{F}$ such that

$$[T]_e = \begin{bmatrix} \lambda_1 & & 0 \\ & \ddots & \\ 0 & & \lambda_n \end{bmatrix}.$$

The scalars $\lambda_1, \dots, \lambda_n$ are necessarily eigenvalues of T , and e_1, \dots, e_n are the corresponding eigenvectors. We summarize this in the following proposition.

Proposition 11.4.1. *$T \in \mathcal{L}(V)$ is diagonalizable if and only if there exists a basis (e_1, \dots, e_n) consisting entirely of eigenvectors of T .*

We can reformulate this proposition using the change of basis transformations as follows. Suppose that e and f are bases of V such that $[T]_e$ is diagonal, and let S be the change of basis transformation such that $[v]_e = S[v]_f$. Then $S[T]_fS^{-1} = [T]_e$ is diagonal.

Proposition 11.4.2. *$T \in \mathcal{L}(V)$ is diagonalizable if and only if there exists an invertible*

matrix $S \in \mathbb{F}^{n \times n}$ such that

$$S[T]_f S^{-1} = \begin{bmatrix} \lambda_1 & & 0 \\ & \ddots & \\ 0 & & \lambda_n \end{bmatrix},$$

where $[T]_f$ is the matrix for T with respect to a given arbitrary basis $f = (f_1, \dots, f_n)$.

On the other hand, the Spectral Theorem tells us that T is diagonalizable with respect to an orthonormal basis if and only if T is normal. Recall that

$$[T^*]_f = [T]_f^*$$

for any orthonormal basis f of V . As before,

$$A^* = (\bar{a}_{ji})_{i,j=1}^n, \quad \text{for } A = (a_{ij})_{i,j=1}^n,$$

is the conjugate transpose of the matrix A . When $\mathbb{F} = \mathbb{R}$, note that $A^* = A^T$ is just the transpose of the matrix, where $A^T = (a_{ji})_{i,j=1}^n$.

The change of basis transformation between two orthonormal bases is called **unitary** in the complex case and **orthogonal** in the real case. Let $e = (e_1, \dots, e_n)$ and $f = (f_1, \dots, f_n)$ be two orthonormal bases of V , and let U be the change of basis matrix such that $[v]_f = U[v]_e$, for all $v \in V$. Then

$$\langle e_i, e_j \rangle = \delta_{ij} = \langle f_i, f_j \rangle = \langle Ue_i, Ue_j \rangle.$$

Since this holds for the basis e , it follows that U is unitary if and only if

$$\langle Uv, Uw \rangle = \langle v, w \rangle \quad \text{for all } v, w \in V. \quad (11.1)$$

This means that unitary matrices preserve the inner product. Operators that preserve the inner product are often also called **isometries**. Orthogonal matrices also define isometries.

By the definition of the adjoint, $\langle Uv, Uw \rangle = \langle v, U^*Uw \rangle$, and so Equation 11.1 implies that isometries are characterized by the property

$$\begin{aligned} U^*U &= I, & \text{for the unitary case,} \\ O^TO &= I, & \text{for the orthogonal case.} \end{aligned}$$

The equation $U^*U = I$ implies that $U^{-1} = U^*$. For finite-dimensional inner product spaces, the left inverse of an operator is also the right inverse, and so

$$\begin{aligned} UU^* &= I \quad \text{if and only if} \quad U^*U = I, \\ OO^T &= I \quad \text{if and only if} \quad O^TO = I. \end{aligned} \tag{11.2}$$

It is easy to see that the columns of a unitary matrix are the coefficients of the elements of an orthonormal basis with respect to another orthonormal basis. Therefore, the columns are orthonormal vectors in \mathbb{C}^n (or in \mathbb{R}^n in the real case). By Condition (11.2), this is also true for the rows of the matrix.

The Spectral Theorem tells us that $T \in \mathcal{L}(V)$ is normal if and only if $[T]_e$ is diagonal with respect to an orthonormal basis e for V , i.e., if there exists a unitary matrix U such that

$$UTU^* = \begin{bmatrix} \lambda_1 & & 0 \\ & \ddots & \\ 0 & & \lambda_n \end{bmatrix}.$$

Conversely, if a unitary matrix U exists such that $UTU^* = D$ is diagonal, then

$$TT^* - T^*T = U^*(D\bar{D} - \bar{D}D)U = 0$$

since diagonal matrices commute, and hence T is normal.

Let us summarize some of the definitions that we have seen in this section.

Definition 11.4.3. Given a square matrix $A \in \mathbb{F}^{n \times n}$, we call

1. **symmetric** if $A = A^T$.
2. **Hermitian** if $A = A^*$.
3. **orthogonal** if $AA^T = I$.
4. **unitary** if $AA^* = I$.

Note that every type of matrix in Definition 11.4.3 is an example of a normal operator.

An example of a normal operator N that is neither Hermitian nor unitary is

$$N = i \begin{bmatrix} -1 & -1 \\ -1 & 1 \end{bmatrix}.$$

You can easily verify that $NN^* = N^*N$ and that iN is symmetric (not Hermitian).

Example 11.4.4. Consider the matrix

$$A = \begin{bmatrix} 2 & 1+i \\ 1-i & 3 \end{bmatrix}$$

from Example 11.1.5. To unitarily diagonalize A , we need to find a unitary matrix U and a diagonal matrix D such that $A = UDU^{-1}$. To do this, we need to first find a basis for \mathbb{C}^2 that consists entirely of orthonormal eigenvectors for the linear map $T \in \mathcal{L}(\mathbb{C}^2)$ defined by $Tv = Av$, for all $v \in \mathbb{C}^2$.

To find such an orthonormal basis, we start by finding the eigenspaces of T . We already determined that the eigenvalues of T are $\lambda_1 = 1$ and $\lambda_2 = 4$, so $D = \begin{bmatrix} 1 & 0 \\ 0 & 4 \end{bmatrix}$. It follows that

$$\begin{aligned} \mathbb{C}^2 &= \text{null}(T - I) \oplus \text{null}(T - 4I) \\ &= \text{span}((-1 - i, 1)) \oplus \text{span}((1 + i, 2)). \end{aligned}$$

Now apply the Gram-Schmidt procedure to each eigenspace in order to obtain the columns of U . Here,

$$\begin{aligned} A = UDU^{-1} &= \begin{bmatrix} \frac{-1-i}{\sqrt{3}} & \frac{1+i}{\sqrt{6}} \\ \frac{1}{\sqrt{3}} & \frac{2}{\sqrt{6}} \end{bmatrix} \begin{bmatrix} 1 & 0 \\ 0 & 4 \end{bmatrix} \begin{bmatrix} \frac{-1-i}{\sqrt{3}} & \frac{1+i}{\sqrt{6}} \\ \frac{1}{\sqrt{3}} & \frac{2}{\sqrt{6}} \end{bmatrix}^{-1} \\ &= \begin{bmatrix} \frac{-1-i}{\sqrt{3}} & \frac{1+i}{\sqrt{6}} \\ \frac{1}{\sqrt{3}} & \frac{2}{\sqrt{6}} \end{bmatrix} \begin{bmatrix} 1 & 0 \\ 0 & 4 \end{bmatrix} \begin{bmatrix} \frac{-1+i}{\sqrt{3}} & \frac{1}{\sqrt{3}} \\ \frac{1-i}{\sqrt{6}} & \frac{2}{\sqrt{6}} \end{bmatrix}. \end{aligned}$$

As an application, note that such diagonal decomposition allows us to easily compute powers and the exponential of matrices. Namely, if $A = UDU^{-1}$ with D diagonal, then we

have

$$A^n = (UDU^{-1})^n = UD^nU^{-1},$$

$$\exp(A) = \sum_{k=0}^{\infty} \frac{1}{k!} A^k = U \left(\sum_{k=0}^{\infty} \frac{1}{k!} D^k \right) U^{-1} = U \exp(D) U^{-1}.$$

Example 11.4.5. Continuing Example 11.4.4,

$$A^2 = (UDU^{-1})^2 = UD^2U^{-1} = U \begin{bmatrix} 1 & 0 \\ 0 & 16 \end{bmatrix} U^* = \begin{bmatrix} 6 & 5 + 5i \\ 5 - 5i & 11 \end{bmatrix},$$

$$A^n = (UDU^{-1})^n = UD^nU^{-1} = U \begin{bmatrix} 1 & 0 \\ 0 & 2^{2n} \end{bmatrix} U^* = \begin{bmatrix} \frac{2}{3}(1 + 2^{n-1}) & \frac{1+i}{3}(-1 + 2^{2n}) \\ \frac{1-i}{3}(-1 + 2^{2n}) & \frac{1}{3}(1 + 2^{2n+1}) \end{bmatrix},$$

$$\exp(A) = U \exp(D) U^{-1} = U \begin{bmatrix} e & 0 \\ 0 & e^4 \end{bmatrix} U^{-1} = \frac{1}{3} \begin{bmatrix} 2e + e^4 & e^4 - e + i(e^4 - e) \\ e^4 - e + i(e - e^4) & e + 2e^4 \end{bmatrix}.$$

11.5 Positive operators

Recall that self-adjoint operators are the operator analog for real numbers. Let us now define the operator analog for positive (or, more precisely, nonnegative) real numbers.

Definition 11.5.1. An operator $T \in \mathcal{L}(V)$ is called **positive** (denoted $T \geq 0$) if $T = T^*$ and $\langle Tv, v \rangle \geq 0$ for all $v \in V$.

(If V is a complex vector space, then the condition of self-adjointness follows from the condition $\langle Tv, v \rangle \geq 0$ and hence can be dropped).

Example 11.5.2. Note that, for all $T \in \mathcal{L}(V)$, we have $T^*T \geq 0$ since T^*T is self-adjoint and $\langle T^*Tv, v \rangle = \langle Tv, Tv \rangle \geq 0$.

Example 11.5.3. Let $U \subset V$ be a subspace of V and P_U be the orthogonal projection onto U . Then $P_U \geq 0$. To see this, write $V = U \oplus U^\perp$ and $v = u_v + u_v^\perp$ for each $v \in V$, where $u_v \in U$ and $u_v^\perp \in U^\perp$. Then $\langle P_U v, w \rangle = \langle u_v, u_w + u_w^\perp \rangle = \langle u_v, u_w \rangle = \langle u_v + u_v^\perp, u_w \rangle = \langle v, P_U w \rangle$ so that $P_U^* = P_U$. Also, setting $v = w$ in the above string of equations, we obtain $\langle P_U v, v \rangle = \langle u_v, u_v \rangle \geq 0$, for all $v \in V$. Hence, $P_U \geq 0$.

If λ is an eigenvalue of a positive operator T and $v \in V$ is an associated eigenvector, then $\langle Tv, v \rangle = \langle \lambda v, v \rangle = \lambda \langle v, v \rangle \geq 0$. Since $\langle v, v \rangle \geq 0$ for all vectors $v \in V$, it follows that $\lambda \geq 0$. This fact can be used to define \sqrt{T} by setting

$$\sqrt{T}e_i = \sqrt{\lambda_i}e_i,$$

where λ_i are the eigenvalues of T with respect to the orthonormal basis $e = (e_1, \dots, e_n)$. We know that these exist by the Spectral Theorem.

11.6 Polar decomposition

Continuing the analogy between \mathbb{C} and $\mathcal{L}(V)$, recall the polar form of a complex number $z = |z|e^{i\theta}$, where $|z|$ is the absolute value or modulus of z and $e^{i\theta}$ lies on the unit circle in \mathbb{R}^2 . In terms of an operator $T \in \mathcal{L}(V)$, where V is a complex inner product space, a unitary operator U takes the role of $e^{i\theta}$, and $|T|$ takes the role of the modulus. As in Section 11.5, $T^*T \geq 0$ so that $|T| := \sqrt{T^*T}$ exists and satisfies $|T| \geq 0$ as well.

Theorem 11.6.1. *For each $T \in \mathcal{L}(V)$, there exists a unitary U such that*

$$T = U|T|.$$

*This is called the **polar decomposition** of T .*

Sketch of proof. We start by noting that

$$\|Tv\|^2 = \||T|v\|^2,$$

since $\langle Tv, Tv \rangle = \langle v, T^*Tv \rangle = \langle \sqrt{T^*T}v, \sqrt{T^*T}v \rangle$. This implies that $\text{null}(T) = \text{null}(|T|)$. By the Dimension Formula, this also means that $\dim(\text{range}(T)) = \dim(\text{range}(|T|))$. Moreover, we can define an isometry $S : \text{range}(|T|) \rightarrow \text{range}(T)$ by setting

$$S(|T|v) = Tv.$$

The trick is now to define a unitary operator U on all of V such that the restriction of U

onto the range of $|T|$ is S , i.e.,

$$U|_{\text{range}(|T|)} = S.$$

Note that $\text{null}(|T|) \perp \text{range}(|T|)$, i.e., for $v \in \text{null}(|T|)$ and $w = |T|u \in \text{range}(|T|)$,

$$\langle w, v \rangle = \langle |T|u, v \rangle = \langle u, |T|v \rangle = \langle u, 0 \rangle = 0$$

since $|T|$ is self-adjoint.

Pick an orthonormal basis $e = (e_1, \dots, e_m)$ of $\text{null}(|T|)$ and an orthonormal basis $f = (f_1, \dots, f_m)$ of $(\text{range}(T))^\perp$. Set $\tilde{S}e_i = f_i$, and extend \tilde{S} to all of $\text{null}(|T|)$ by linearity. Since $\text{null}(|T|) \perp \text{range}(|T|)$, any $v \in V$ can be uniquely written as $v = v_1 + v_2$, where $v_1 \in \text{null}(|T|)$ and $v_2 \in \text{range}(|T|)$. Now define $U : V \rightarrow V$ by setting $Uv = \tilde{S}v_1 + Sv_2$. Then U is an isometry. Moreover, U is also unitary, as shown by the following calculation application of the Pythagorean theorem:

$$\begin{aligned} \|Uv\|^2 &= \|\tilde{S}v_1 + Sv_2\|^2 = \|\tilde{S}v_1\|^2 + \|Sv_2\|^2 \\ &= \|v_1\|^2 + \|v_2\|^2 = \|v\|^2. \end{aligned}$$

Also, note that $U|T| = T$ by construction since $U|_{\text{null}(|T|)}$ is irrelevant. \square

11.7 Singular-value decomposition

The singular-value decomposition generalizes the notion of diagonalization. To unitarily diagonalize $T \in \mathcal{L}(V)$ means to find an orthonormal basis e such that T is diagonal with respect to this basis, i.e.,

$$M(T; e, e) = [T]_e = \begin{bmatrix} \lambda_1 & & 0 \\ & \ddots & \\ 0 & & \lambda_n \end{bmatrix},$$

where the notation $M(T; e, e)$ indicates that the basis e is used both for the domain and codomain of T . The Spectral Theorem tells us that unitary diagonalization can only be

done for normal operators. In general, we can find two orthonormal bases e and f such that

$$M(T; e, f) = \begin{bmatrix} s_1 & & 0 \\ & \ddots & \\ 0 & & s_n \end{bmatrix},$$

which means that $Te_i = s_i f_i$ even if T is not normal. The scalars s_i are called **singular values** of T . If T is diagonalizable, then these are the absolute values of the eigenvalues.

Theorem 11.7.1. *All $T \in \mathcal{L}(V)$ have a singular-value decomposition. That is, there exist orthonormal bases $e = (e_1, \dots, e_n)$ and $f = (f_1, \dots, f_n)$ such that*

$$Tv = s_1 \langle v, e_1 \rangle f_1 + \dots + s_n \langle v, e_n \rangle f_n,$$

where s_i are the singular values of T .

Proof. Since $|T| \geq 0$, it is also self-adjoint. Thus, by the Spectral Theorem, there is an orthonormal basis $e = (e_1, \dots, e_n)$ for V such that $|T|e_i = s_i e_i$. Let U be the unitary matrix in the polar decomposition of T . Since e is orthonormal, we can write any vector $v \in V$ as

$$v = \langle v, e_1 \rangle e_1 + \dots + \langle v, e_n \rangle e_n,$$

and hence

$$Tv = U|T|v = s_1 \langle v, e_1 \rangle Ue_1 + \dots + s_n \langle v, e_n \rangle Ue_n.$$

Now set $f_i = Ue_i$ for all $1 \leq i \leq n$. Since U is unitary, (f_1, \dots, f_n) is also an orthonormal basis, proving the theorem. \square

Exercises for Chapter 11

Computational Exercises

1. Consider \mathbb{R}^3 with two orthonormal bases: the canonical basis $e = (e_1, e_2, e_3)$ and the basis $f = (f_1, f_2, f_3)$, where

$$f_1 = \frac{1}{\sqrt{3}}(1, 1, 1), \quad f_2 = \frac{1}{\sqrt{6}}(1, -2, 1), \quad f_3 = \frac{1}{\sqrt{2}}(1, 0, -1).$$

Find the canonical matrix, A , of the linear map $T \in \mathcal{L}(\mathbb{R}^3)$ with eigenvectors f_1, f_2, f_3 and eigenvalues $1, 1/2, -1/2$, respectively.

2. For each of the following matrices, verify that A is Hermitian by showing that $A = A^*$, find a unitary matrix U such that $U^{-1}AU$ is a diagonal matrix, and compute $\exp(A)$.

$$\begin{array}{lll} \text{(a)} \ A = \begin{bmatrix} 4 & 1-i \\ 1+i & 5 \end{bmatrix} & \text{(b)} \ A = \begin{bmatrix} 3 & -i \\ i & 3 \end{bmatrix} & \text{(c)} \ A = \begin{bmatrix} 6 & 2+2i \\ 2-2i & 4 \end{bmatrix} \\ \text{(d)} \ A = \begin{bmatrix} 0 & 3+i \\ 3-i & -3 \end{bmatrix} & \text{(e)} \ A = \begin{bmatrix} 5 & 0 & 0 \\ 0 & -1 & -1+i \\ 0 & -1-i & 0 \end{bmatrix} & \text{(f)} \ A = \begin{bmatrix} 2 & \frac{i}{\sqrt{2}} & \frac{-i}{\sqrt{2}} \\ \frac{-i}{\sqrt{2}} & 2 & 0 \\ \frac{i}{\sqrt{2}} & 0 & 2 \end{bmatrix} \end{array}$$

3. Let V be a finite-dimensional vector space over \mathbb{F} , and suppose that $T \in \mathcal{L}(V)$ satisfies $T^2 = T$. Prove that T is an orthogonal projection if and only if T is self-adjoint.
4. Let V be a finite-dimensional inner product space over \mathbb{C} , and suppose that $T \in \mathcal{L}(V)$ has the property that $T^* = -T$. (We call T a **skew Hermitian** operator on V .)
 - (a) Prove that the operator $iT \in \mathcal{L}(V)$ defined by $(iT)(v) = i(T(v))$, for each $v \in V$, is Hermitian.
 - (b) Prove that the canonical matrix for T can be unitarily diagonalized.

Supplementary Notes on Matrices and Linear Systems

As discussed in Chapter 1, there are many ways in which you might try to solve a system of linear equation involving a finite number of variables. These supplementary notes are intended to illustrate the use of Linear Algebra in solving such systems. In particular, any arbitrary number of equations in any number of unknowns — as long as both are finite — can be encoded as a single **matrix equation**. As you will see, this has many computational advantages, but, perhaps more importantly, it also allows us to better understand linear systems abstractly. Specifically, by exploiting the deep connection between matrices and so-called linear maps, one can completely determine all possible solutions to any linear system.

These notes are also intended to provide a self-contained introduction to matrices and important matrix operations. As you read the sections below, remember that a matrix is, in general, nothing more than a rectangular array of real or complex numbers. Matrices *are not* linear maps. Instead, a matrix can (and will often) be used to *define* a linear map.

12.1 From linear systems to matrix equations

We begin this section by reviewing the definition of and notation for matrices. We then review several different conventions for denoting and studying systems of linear equations, the most fundamental being as a single matrix equation. This point of view has a long history of exploration, and numerous computational devices — including several computer programming languages — have been developed and optimized specifically for analyzing matrix equations.

12.1.1 Definition of and notation for matrices

Let $m, n \in \mathbb{Z}_+$ be positive integers, and, as usual, let \mathbb{F} denote either \mathbb{R} or \mathbb{C} . Then we begin by defining an $m \times n$ **matrix** A to be a rectangular array of numbers

$$A = (a_{ij})_{i,j=1}^{m,n} = (A^{(i,j)})_{i,j=1}^{m,n} = \underbrace{\left[\begin{array}{ccc} a_{11} & \cdots & a_{1n} \\ \vdots & \ddots & \vdots \\ a_{m1} & \cdots & a_{mn} \end{array} \right]}_{n \text{ numbers}} \left. \vphantom{\left[\begin{array}{ccc} a_{11} & \cdots & a_{1n} \\ \vdots & \ddots & \vdots \\ a_{m1} & \cdots & a_{mn} \end{array} \right]} \right\} m \text{ numbers}$$

where each element $a_{ij} \in \mathbb{F}$ in the array is called an **entry** of A (specifically, a_{ij} is called the “ i, j entry”). We say that i indexes the **rows** of A as it ranges over the set $\{1, \dots, m\}$ and that j indexes the **columns** of A as it ranges over the set $\{1, \dots, n\}$. We also say that the matrix A has **size** $m \times n$ and note that it is a (finite) sequence of doubly-subscripted numbers for which the two subscripts in no way depend upon each other.

Definition 12.1.1. Given positive integers $m, n \in \mathbb{Z}_+$, we use $\mathbb{F}^{m \times n}$ to denote the set of all $m \times n$ matrices having entries over \mathbb{F}

Example 12.1.2. The matrix $A = \begin{bmatrix} 1 & 0 & 2 \\ -1 & 3 & i \end{bmatrix} \in \mathbb{C}^{2 \times 3}$, but $A \notin \mathbb{R}^{2 \times 3}$ since the “2, 3” entry of A is not in \mathbb{R} .

Given the ubiquity of matrices in both abstract and applied mathematics, a rich vocabulary has been developed for describing various properties and features of matrices. In addition, there is also a rich set of equivalent notations. For the purposes of these notes, we will use the above notation unless the size of the matrix is understood from context or is unimportant. In this case, we will drop much of this notation and denote a matrix simply as

$$A = (a_{ij}) \text{ or } A = (a_{ij})_{m \times n}.$$

To get a sense of the essential vocabulary, suppose that we have an $m \times n$ matrix $A = (a_{ij})$ with $m = n$. Then we call A a **square** matrix. The elements $a_{11}, a_{22}, \dots, a_{nn}$ in a square matrix form the **main diagonal** of A , and the elements $a_{1n}, a_{2,n-1}, \dots, a_{n1}$ form what is sometimes called the **skew main diagonal** of A . Entries not on the main diagonal are

also often called **off-diagonal** entries, and a matrix whose off-diagonal entries are all zero is called a **diagonal matrix**. It is common to call $a_{12}, a_{23}, \dots, a_{n-1,n}$ the **superdiagonal** of A and $a_{21}, a_{32}, \dots, a_{n,n-1}$ the **subdiagonal** of A . The motivation for this terminology should be clear if you create a sample square matrix and trace the entries within these particular subsequences of the matrix.

Square matrices are important because they are fundamental to applications of Linear Algebra. In particular, virtually every use of Linear Algebra either involves square matrices directly or employs them in some indirect manner. In addition, virtually every usage also involves the notion of **vector**, where here we mean either an $m \times 1$ matrix (a.k.a. a **row vector**) or a $1 \times n$ matrix (a.k.a. a **column vector**).

Example 12.1.3. Suppose that $A = (a_{ij})$, $B = (b_{ij})$, $C = (c_{ij})$, $D = (d_{ij})$, and $E = (e_{ij})$ are the following matrices over \mathbb{F} :

$$A = \begin{bmatrix} 3 \\ -1 \\ 1 \end{bmatrix}, B = \begin{bmatrix} 4 & -1 \\ 0 & 2 \end{bmatrix}, C = [1, 4, 2], D = \begin{bmatrix} 1 & 5 & 2 \\ -1 & 0 & 1 \\ 3 & 2 & 4 \end{bmatrix}, E = \begin{bmatrix} 6 & 1 & 3 \\ -1 & 1 & 2 \\ 4 & 1 & 3 \end{bmatrix}.$$

Then we say that A is a 3×1 matrix (a.k.a. a column vector), B is a 2×2 square matrix, C is a 1×3 matrix (a.k.a. a row vector), and both D and E are square 3×3 matrices. Moreover, only B is an upper-triangular matrix (as defined below), and none of the matrices in this example are diagonal matrices.

We can discuss individual entries in each matrix. E.g.,

- the 2th row of D is $d_{21} = -1$, $d_{22} = 0$, and $d_{23} = 1$.
- the main diagonal of D is the sequence $d_{11} = 1$, $d_{22} = 0$, $d_{33} = 4$.
- the skew main diagonal of D is the sequence $d_{13} = 2$, $d_{22} = 0$, $d_{31} = 3$.
- the off-diagonal entries of D are (by row) d_{12} , d_{13} , d_{21} , d_{23} , d_{31} , and d_{32} .
- the 2th column of E is $e_{12} = e_{22} = e_{32} = 1$.
- the superdiagonal of E is the sequence $e_{12} = 1$, $e_{23} = 2$.
- the subdiagonal of E is the sequence $e_{21} = -1$, $e_{32} = 1$.

A square matrix $A = (a_{ij}) \in \mathbb{F}^{n \times n}$ is called **upper triangular** (resp. **lower triangular**) if $a_{ij} = 0$ for each pair of integers $i, j \in \{1, \dots, n\}$ such that $i > j$ (resp. $i < j$). In other words, A is triangular if it has the form

$$\begin{bmatrix} a_{11} & a_{12} & a_{13} & \cdots & a_{1n} \\ 0 & a_{22} & a_{23} & \cdots & a_{2n} \\ 0 & 0 & a_{33} & \cdots & a_{3n} \\ \vdots & \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & 0 & \cdots & a_{nn} \end{bmatrix} \quad \text{or} \quad \begin{bmatrix} a_{11} & 0 & 0 & \cdots & 0 \\ a_{21} & a_{22} & 0 & \cdots & 0 \\ a_{31} & a_{32} & a_{33} & \cdots & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots \\ a_{n1} & a_{n2} & a_{n3} & \cdots & a_{nn} \end{bmatrix}.$$

Note that a diagonal matrix is simultaneously both an upper triangular matrix and a lower triangular matrix.

Two particularly important examples of diagonal matrices are defined as follows: Given any positive integer $n \in \mathbb{Z}_+$, we can construct the **identity matrix** I_n and the **zero matrix** $0_{n \times n}$ by setting

$$I_n = \begin{bmatrix} 1 & 0 & 0 & \cdots & 0 & 0 \\ 0 & 1 & 0 & \cdots & 0 & 0 \\ 0 & 0 & 1 & \cdots & 0 & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots & \vdots \\ 0 & 0 & 0 & \cdots & 1 & 0 \\ 0 & 0 & 0 & \cdots & 0 & 1 \end{bmatrix} \quad \text{and} \quad 0_{n \times n} = \begin{bmatrix} 0 & 0 & 0 & \cdots & 0 & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots & \vdots \\ 0 & 0 & 0 & \cdots & 0 & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 \end{bmatrix},$$

where each of these matrices is understood to be a square matrix of size $n \times n$. The zero matrix $0_{m \times n}$ is analogously defined for any $m, n \in \mathbb{Z}_+$ and has size $m \times n$. I.e.,

$$0_{m \times n} = \underbrace{\left. \begin{bmatrix} 0 & 0 & 0 & \cdots & 0 & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots & \vdots \\ 0 & 0 & 0 & \cdots & 0 & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 \end{bmatrix} \right\}}_{n \text{ columns}} \left. \vphantom{\begin{bmatrix} 0 & 0 & 0 & \cdots & 0 & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots & \vdots \\ 0 & 0 & 0 & \cdots & 0 & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 \end{bmatrix}} \right\} m \text{ rows},$$

12.1.2 Using matrices to encode linear systems

Let $m, n \in \mathbb{Z}_+$ be positive integers. Then a **system of m linear equations in n unknowns** x_1, \dots, x_n looks like

$$\left. \begin{aligned} a_{11}x_1 + a_{12}x_2 + a_{13}x_3 + \cdots + a_{1n}x_n &= b_1 \\ a_{21}x_1 + a_{22}x_2 + a_{23}x_3 + \cdots + a_{2n}x_n &= b_2 \\ a_{31}x_1 + a_{32}x_2 + a_{33}x_3 + \cdots + a_{3n}x_n &= b_3 \\ &\vdots \\ a_{m1}x_1 + a_{m2}x_2 + a_{m3}x_3 + \cdots + a_{mn}x_n &= b_m \end{aligned} \right\}, \quad (12.3)$$

where each $a_{ij}, b_i \in \mathbb{F}$ is a scalar for $i = 1, 2, \dots, m$ and $j = 1, 2, \dots, n$. In other words, each scalar $b_1, \dots, b_m \in \mathbb{F}$ is being written as a linear combination of the unknowns x_1, \dots, x_n using coefficients from the field \mathbb{F} . To **solve** System (12.3) means to describe the set of all possible values for x_1, \dots, x_n (when thought of as scalars in \mathbb{F}) such that each of the m equations in System (12.3) is satisfied simultaneously.

Rather than dealing directly with a given linear system, it is often convenient to first encode the system using less cumbersome notation. Specifically, System (12.3) can be summarized using exactly three matrices. First, we collect the coefficients from each equation into the $m \times n$ matrix $A = (a_{ij}) \in \mathbb{F}^{m \times n}$, which we call the **coefficient matrix** for the linear system. Similarly, we assemble the unknowns x_1, x_2, \dots, x_n into an $n \times 1$ column vector $x = (x_i) \in \mathbb{F}^n$, and the right-hand sides b_1, b_2, \dots, b_m of the equation are used to form an $m \times 1$ column vector $b = (b_i) \in \mathbb{F}^m$. In other words,

$$A = \begin{bmatrix} a_{11} & a_{12} & \cdots & a_{1n} \\ a_{21} & a_{22} & \cdots & a_{2n} \\ \vdots & \vdots & \ddots & \vdots \\ a_{m1} & a_{m2} & \cdots & a_{mn} \end{bmatrix}, \quad x = \begin{bmatrix} x_1 \\ x_2 \\ \vdots \\ x_n \end{bmatrix}, \quad \text{and} \quad b = \begin{bmatrix} b_1 \\ b_2 \\ \vdots \\ b_m \end{bmatrix}.$$

Then the left-hand side of the i^{th} equation in System (12.3) can be recovered by taking the **dot product** (a.k.a. **Euclidean inner product**) of x with the i^{th} row in A :

$$\begin{bmatrix} a_{i1} & a_{i2} & \cdots & a_{in} \end{bmatrix} \cdot x = \sum_{j=1}^n a_{ij}x_j = a_{i1}x_1 + a_{i2}x_2 + a_{i3}x_3 + \cdots + a_{in}x_n.$$

In general, we can extend the dot product between two vectors in order to form the product of any two matrices (as in Section 12.2.2). For the purposes of this section, though, it suffices to simply define the product of the matrix $A \in \mathbb{F}^{m \times n}$ and the vector $x \in \mathbb{F}^n$ to be

$$Ax = \begin{bmatrix} a_{11} & a_{12} & \cdots & a_{1n} \\ a_{21} & a_{22} & \cdots & a_{2n} \\ \vdots & \vdots & \ddots & \vdots \\ a_{m1} & a_{m2} & \cdots & a_{mn} \end{bmatrix} \begin{bmatrix} x_1 \\ x_2 \\ \vdots \\ x_n \end{bmatrix} = \begin{bmatrix} a_{11}x_1 + a_{12}x_2 + \cdots + a_{1n}x_n \\ a_{21}x_1 + a_{22}x_2 + \cdots + a_{2n}x_n \\ \vdots \\ a_{m1}x_1 + a_{m2}x_2 + \cdots + a_{mn}x_n \end{bmatrix}. \quad (12.4)$$

Then, since each entry in the resulting $m \times 1$ column vector $Ax \in \mathbb{F}^m$ corresponds exactly to the left-hand side of each equation in System 12.3, we have effectively encoded System (12.3) as the single **matrix equation**

$$Ax = \begin{bmatrix} a_{11}x_1 + a_{12}x_2 + \cdots + a_{1n}x_n \\ a_{21}x_1 + a_{22}x_2 + \cdots + a_{2n}x_n \\ \vdots \\ a_{m1}x_1 + a_{m2}x_2 + \cdots + a_{mn}x_n \end{bmatrix} = \begin{bmatrix} b_1 \\ \vdots \\ b_m \end{bmatrix} = b. \quad (12.5)$$

Example 12.1.4. The linear system

$$\left. \begin{array}{rcl} x_1 + 6x_2 & + & 4x_5 - 2x_6 = 14 \\ & x_3 & + 3x_5 + x_6 = -3 \\ & x_4 & + 5x_5 + 2x_6 = 11 \end{array} \right\}.$$

has three equations and involves the six variables x_1, x_2, \dots, x_6 . One can check that possible solutions to this system include

$$\begin{bmatrix} x_1 \\ x_2 \\ x_3 \\ x_4 \\ x_6 \\ x_6 \end{bmatrix} = \begin{bmatrix} 14 \\ 0 \\ -3 \\ 11 \\ 0 \\ 0 \end{bmatrix} \quad \text{and} \quad \begin{bmatrix} x_1 \\ x_2 \\ x_3 \\ x_4 \\ x_6 \\ x_6 \end{bmatrix} = \begin{bmatrix} 6 \\ 1 \\ -9 \\ -5 \\ 2 \\ 3 \end{bmatrix}.$$

Note that, in describing these solutions, we have used the six unknowns x_1, x_2, \dots, x_6 to

form the 6×1 column vector $x = (x_i) \in \mathbb{F}^6$. We can similarly form the coefficient matrix $A \in \mathbb{F}^{3 \times 6}$ and the 3×1 column vector $b \in \mathbb{F}^3$, where

$$A = \begin{bmatrix} 1 & 6 & 0 & 0 & 4 & -2 \\ 0 & 0 & 1 & 0 & 3 & 1 \\ 0 & 0 & 0 & 1 & 5 & 2 \end{bmatrix} \quad \text{and} \quad \begin{bmatrix} b_1 \\ b_2 \\ b_3 \end{bmatrix} = \begin{bmatrix} 14 \\ -3 \\ 11 \end{bmatrix}.$$

You should check that, given these matrices, each of the solutions given above satisfies Equation (12.5).

We close this section by mentioning another common conventions for encoding linear systems. Specifically, rather than attempt to solve Equation (12.3) directly, one can instead look at the equivalent problem of describing all coefficients $x_1, \dots, x_n \in \mathbb{F}$ for which the following **vector equation** is satisfied:

$$x_1 \begin{bmatrix} a_{11} \\ a_{21} \\ a_{31} \\ \vdots \\ a_{m1} \end{bmatrix} + x_2 \begin{bmatrix} a_{12} \\ a_{22} \\ a_{32} \\ \vdots \\ a_{m2} \end{bmatrix} + x_3 \begin{bmatrix} a_{13} \\ a_{23} \\ a_{33} \\ \vdots \\ a_{m3} \end{bmatrix} + \cdots + x_n \begin{bmatrix} a_{1n} \\ a_{2n} \\ a_{3n} \\ \vdots \\ a_{mn} \end{bmatrix} = \begin{bmatrix} b_1 \\ b_2 \\ b_3 \\ \vdots \\ b_m \end{bmatrix}. \quad (12.6)$$

This approach emphasizes analysis of the so-called **column vectors** $A^{(:,j)}$ ($j = 1, \dots, n$) of the coefficient matrix A in the matrix equation $Ax = b$. (See in Section 12.2 for more details about how Equation (12.6) is formed). Conversely, it is also common to directly encounter Equation (12.6) when studying certain questions about vectors in \mathbb{F}^n .

It is important to note that System (12.3) differs from Equations (12.5) and (12.6) only in terms of notation. The common aspect of these different representations is that the left-hand side of each equation in System (12.3) is a linear sum. Because of this, it is also common to rewrite System (12.3) using more compact notation such as

$$\sum_{k=1}^n a_{1k}x_k = b_1, \quad \sum_{k=1}^n a_{2k}x_k = b_2, \quad \sum_{k=1}^n a_{3k}x_k = b_3, \quad \dots, \quad \sum_{k=1}^n a_{mk}x_k = b_m.$$

12.2 Matrix arithmetic

In this section, we examine algebraic properties of the set $\mathbb{F}^{m \times n}$ (where $m, n \in \mathbb{Z}_+$). Specifically, $\mathbb{F}^{m \times n}$ forms a vector space under the operations of component-wise addition and scalar multiplication, and it is isomorphic to \mathbb{F}^{mn} as a vector space.

We also define a multiplication operation between matrices of compatible size and show that this multiplication operation interacts with the vector space structure on $\mathbb{F}^{m \times n}$ in a natural way. In particular, $\mathbb{F}^{n \times n}$ forms an algebra over \mathbb{F} with respect to these operations. (See Section B.3 for the definition of an algebra.)

12.2.1 Addition and scalar multiplication

Let $A = (a_{ij})$ and $B = (b_{ij})$ be $m \times n$ matrices over \mathbb{F} (where $m, n \in \mathbb{Z}_+$), and let $\alpha \in \mathbb{F}$. Then **matrix addition** $A+B = ((a+b)_{ij})_{m \times n}$ and **scalar multiplication** $\alpha A = ((\alpha a)_{ij})_{m \times n}$ are both defined component-wise, meaning

$$(a+b)_{ij} = a_{ij} + b_{ij} \quad \text{and} \quad (\alpha a)_{ij} = \alpha a_{ij}.$$

Equivalently, $A+B$ is the $m \times n$ matrix given by

$$\begin{bmatrix} a_{11} & \cdots & a_{1n} \\ \vdots & \ddots & \vdots \\ a_{m1} & \cdots & a_{mn} \end{bmatrix} + \begin{bmatrix} b_{11} & \cdots & b_{1n} \\ \vdots & \ddots & \vdots \\ b_{m1} & \cdots & b_{mn} \end{bmatrix} = \begin{bmatrix} a_{11} + b_{11} & \cdots & a_{1n} + b_{1n} \\ \vdots & \ddots & \vdots \\ a_{m1} + b_{m1} & \cdots & a_{mn} + b_{mn} \end{bmatrix},$$

and αA is the $m \times n$ matrix given by

$$\alpha \begin{bmatrix} a_{11} & \cdots & a_{1n} \\ \vdots & \ddots & \vdots \\ a_{m1} & \cdots & a_{mn} \end{bmatrix} = \begin{bmatrix} \alpha a_{11} & \cdots & \alpha a_{1n} \\ \vdots & \ddots & \vdots \\ \alpha a_{m1} & \cdots & \alpha a_{mn} \end{bmatrix}.$$

Example 12.2.1. With notation as in Example 12.1.3,

$$D + E = \begin{bmatrix} 7 & 6 & 5 \\ -2 & 1 & 3 \\ 7 & 3 & 7 \end{bmatrix},$$

and no two other matrices from Example 12.1.3 can be added since their sizes are not compatible. Similarly, we can make calculations like

$$D - E = D + (-1)E = \begin{bmatrix} -5 & 4 & -1 \\ 0 & -1 & -1 \\ -1 & 1 & 1 \end{bmatrix} \quad \text{and} \quad 0D = 0E = \begin{bmatrix} 0 & 0 & 0 \\ 0 & 0 & 0 \\ 0 & 0 & 0 \end{bmatrix} = 0_{3 \times 3}.$$

It is important to note that, while these are not the only ways of defining addition and scalar multiplication operations on $\mathbb{F}^{m \times n}$, the above operations have the advantage of endowing $\mathbb{F}^{m \times n}$ with a reasonably natural vector space structure. As a vector space, $\mathbb{F}^{m \times n}$ is seen to have dimension mn since we can build the **standard basis matrices**

$$E_{11}, E_{12}, \dots, E_{1n}, E_{21}, E_{22}, \dots, E_{2n}, \dots, E_{m1}, E_{m2}, \dots, E_{mn}$$

by analogy to the standard basis for \mathbb{F}^{mn} . That is, each $E_{k\ell} = ((e^{(k,\ell)})_{ij})$ satisfies

$$(e^{(k,\ell)})_{ij} = \begin{cases} 1, & \text{if } i = k \text{ and } j = \ell \\ 0, & \text{otherwise} \end{cases}.$$

This allows us to build a vector space isomorphism $\mathbb{F}^{m \times n} \rightarrow \mathbb{F}^{mn}$ using a bijection that simply “lays each matrix out flat”. In other words, given $A = (a_{ij}) \in \mathbb{F}^{m \times n}$,

$$\begin{bmatrix} a_{11} & \cdots & a_{1n} \\ \vdots & \ddots & \vdots \\ a_{m1} & \cdots & a_{mn} \end{bmatrix} \mapsto (a_{11}, a_{12}, \dots, a_{1n}, a_{21}, a_{22}, \dots, a_{2n}, \dots, a_{m1}, a_{m2}, \dots, a_{mn}) \in \mathbb{F}^{mn}.$$

Example 12.2.2. The vector space $\mathbb{R}^{2 \times 3}$ of 2×3 matrices over \mathbb{R} has standard basis

$$\left\{ E_{11} = \begin{bmatrix} 1 & 0 & 0 \\ 0 & 0 & 0 \end{bmatrix}, E_{12} = \begin{bmatrix} 0 & 1 & 0 \\ 0 & 0 & 0 \end{bmatrix}, E_{13} = \begin{bmatrix} 0 & 0 & 1 \\ 0 & 0 & 0 \end{bmatrix}, \right. \\ \left. E_{21} = \begin{bmatrix} 0 & 0 & 0 \\ 1 & 0 & 0 \end{bmatrix}, E_{22} = \begin{bmatrix} 0 & 0 & 0 \\ 0 & 1 & 0 \end{bmatrix}, E_{23} = \begin{bmatrix} 0 & 0 & 0 \\ 0 & 0 & 1 \end{bmatrix} \right\},$$

which is seen to naturally correspond with the standard basis $\{e_1, \dots, e_6\}$ for \mathbb{R}_6 , where

$$e_1 = (1, 0, 0, 0, 0, 0), e_2 = (0, 1, 0, 0, 0, 0), \dots, e_6 = (0, 0, 0, 0, 0, 1).$$

Of course, it is not enough to just assert that $\mathbb{F}^{m \times n}$ is a vector space since we have yet to verify that the above defined operations of addition and scalar multiplication satisfy the vector space axioms. The proof of the following theorem is straightforward and something that you should work through for practice with matrix notation.

Theorem 12.2.3. *Given positive integers $m, n \in \mathbb{Z}_+$ and the operations of matrix addition and scalar multiplication as defined above, the set $\mathbb{F}^{m \times n}$ of all $m \times n$ matrices satisfies each of the following properties.*

1. (associativity of matrix addition) Given any three matrices $A, B, C \in \mathbb{F}^{m \times n}$,

$$(A + B) + C = A + (B + C).$$

2. (additive identity for matrix addition) Given any matrix $A \in \mathbb{F}^{m \times n}$,

$$A + 0_{m \times n} = 0_{m \times n} + A = A.$$

3. (additive inverses for matrix addition) Given any matrix $A \in \mathbb{F}^{m \times n}$, there exists a matrix $-A \in \mathbb{F}^{m \times n}$ such that

$$A + (-A) = (-A) + A = 0_{m \times n}.$$

4. (commutativity of matrix addition) Given any two matrices $A, B \in \mathbb{F}^{m \times n}$,

$$A + B = B + A.$$

5. (associativity of scalar multiplication) Given any matrix $A \in \mathbb{F}^{m \times n}$ and any two scalars $\alpha, \beta \in \mathbb{F}$,

$$(\alpha\beta)A = \alpha(\beta A).$$

6. (multiplicative identity for scalar multiplication) Given any matrix $A \in \mathbb{F}^{m \times n}$ and denoting by 1 the multiplicative identity of \mathbb{F} ,

$$1A = A.$$

7. (distributivity of scalar multiplication) Given any two matrices $A, B \in \mathbb{F}^{m \times n}$ and any two scalars $\alpha, \beta \in \mathbb{F}$,

$$(\alpha + \beta)A = \alpha A + \beta A \quad \text{and} \quad \alpha(A + B) = \alpha A + \alpha B.$$

In other words, $\mathbb{F}^{m \times n}$ forms a vector space under the operations of matrix addition and scalar multiplication.

As a consequence of Theorem 12.2.3, every property that holds for an arbitrary vector space can be taken as a property of $\mathbb{F}^{m \times n}$ specifically. We highlight some of these properties in the following corollary to Theorem 12.2.3.

Corollary 12.2.4. *Given positive integers $m, n \in \mathbb{Z}_+$ and the operations of matrix addition and scalar multiplication as defined above, the set $\mathbb{F}^{m \times n}$ of all $m \times n$ matrices satisfies each of the following properties:*

1. Given any matrix $A \in \mathbb{F}^{m \times n}$, given any scalar $\alpha \in \mathbb{F}$, and denoting by 0 the additive identity of \mathbb{F} ,

$$0A = A \quad \text{and} \quad \alpha 0_{m \times n} = 0_{m \times n}.$$

2. Given any matrix $A \in \mathbb{F}^{m \times n}$ and any scalar $\alpha \in \mathbb{F}$,

$$\alpha A = 0 \implies \text{either } \alpha = 0 \text{ or } A = 0_{m \times n}.$$

3. Given any matrix $A \in \mathbb{F}^{m \times n}$ and any scalar $\alpha \in \mathbb{F}$,

$$-(\alpha A) = (-\alpha)A = \alpha(-A).$$

In particular, the additive inverse $-A$ of A is given by $-A = (-1)A$, where -1 denoted the additive inverse for the additivity identity of \mathbb{F} .

While one could prove Corollary 12.2.4 directly from definitions, the point of recognizing $\mathbb{F}^{m \times n}$ as a vector space is that you get to use these results without worrying about their proof. Moreover, there is no need to separately prove for each of $\mathbb{R}^{m \times n}$ and $\mathbb{C}^{m \times n}$.

12.2.2 Multiplying and matrices

Let $r, s, t \in \mathbb{Z}_+$ be positive integers, $A = (a_{ij}) \in \mathbb{F}^{r \times s}$ be an $r \times s$ matrix, and $B = (b_{ij}) \in \mathbb{F}^{s \times t}$ be an $s \times t$ matrix. Then **matrix multiplication** $AB = ((ab)_{ij})_{r \times t}$ is defined by

$$(ab)_{ij} = \sum_{k=1}^s a_{ik} b_{kj}.$$

In particular, note that the “ i, j entry” of the matrix product AB involves a summation over the positive integer $k = 1, \dots, s$, where s is both the number of columns in A and the number of rows in B . Thus, this multiplication is only defined when the “middle” dimension of each matrix is the same:

$$\begin{aligned} (a_{ij})_{r \times s} (b_{ij})_{s \times t} &= r \left\{ \underbrace{\begin{bmatrix} a_{11} & \cdots & a_{1s} \\ \vdots & \ddots & \vdots \\ a_{r1} & \cdots & a_{rs} \end{bmatrix}}_s \underbrace{\begin{bmatrix} b_{11} & \cdots & b_{1t} \\ \vdots & \ddots & \vdots \\ b_{s1} & \cdots & b_{st} \end{bmatrix}}_t \right\} \\ &= \underbrace{\begin{bmatrix} \sum_{k=1}^s a_{1k} b_{k1} & \cdots & \sum_{k=1}^s a_{1k} b_{kt} \\ \vdots & \ddots & \vdots \\ \sum_{k=1}^s a_{rk} b_{k1} & \cdots & \sum_{k=1}^s a_{rk} b_{kt} \end{bmatrix}}_t \right\} r \end{aligned}$$

Alternatively, if we let $n \in \mathbb{Z}_+$ be a positive integer, then another way of viewing matrix multiplication is through the use of the standard inner product on $\mathbb{F}^n = \mathbb{F}^{1 \times n} = \mathbb{F}^{n \times 1}$. In particular, we define the **dot product** (a.k.a. **Euclidean inner product**) of the row vector

$x = (x_{1j}) \in \mathbb{F}^{1 \times n}$ and the column vector $y = (y_{i1}) \in \mathbb{F}^{n \times 1}$ to be

$$x \cdot y = \begin{bmatrix} x_{11} & \cdots & x_{1n} \end{bmatrix} \cdot \begin{bmatrix} y_{11} \\ \vdots \\ y_{n1} \end{bmatrix} = \sum_{k=1}^n x_{1k} y_{k1} \in \mathbb{F}.$$

We can then decompose matrices $A = (a_{ij})_{r \times s}$ and $B = (b_{ij})_{s \times t}$ into their constituent **row vectors** by fixing a positive integer $k \in \mathbb{Z}_+$ and setting

$$A^{(k,\cdot)} = \begin{bmatrix} a_{k1} & \cdots & a_{ks} \end{bmatrix} \in \mathbb{F}^{1 \times s} \quad \text{and} \quad B^{(k,\cdot)} = \begin{bmatrix} b_{k1} & \cdots & b_{kt} \end{bmatrix} \in \mathbb{F}^{1 \times t}.$$

Similarly, fixing $\ell \in \mathbb{Z}_+$, we can also decompose A and B into the **column vectors**

$$A^{(\cdot,\ell)} = \begin{bmatrix} a_{1\ell} \\ \vdots \\ a_{r\ell} \end{bmatrix} \in \mathbb{F}^{r \times 1} \quad \text{and} \quad B^{(\cdot,\ell)} = \begin{bmatrix} b_{1\ell} \\ \vdots \\ b_{s\ell} \end{bmatrix} \in \mathbb{F}^{s \times 1}.$$

It follows that the product AB is the following matrix of dot products:

$$AB = \begin{bmatrix} A^{(1,\cdot)} \cdot B^{(\cdot,1)} & \cdots & A^{(1,\cdot)} \cdot B^{(\cdot,t)} \\ \vdots & \ddots & \vdots \\ A^{(r,\cdot)} \cdot B^{(\cdot,1)} & \cdots & A^{(r,\cdot)} \cdot B^{(\cdot,t)} \end{bmatrix} \in \mathbb{F}^{r \times t}.$$

Example 12.2.5. With notation as in Example 12.1.3, you should sit down and use the above definitions in order to verify that the following matrix products hold.

$$AC = \begin{bmatrix} 3 \\ -1 \\ 1 \end{bmatrix} \begin{bmatrix} 1 & 4 & 2 \end{bmatrix} = \begin{bmatrix} 3 & 12 & 6 \\ -1 & -4 & -2 \\ 1 & 4 & 2 \end{bmatrix} \in \mathbb{F}^{3 \times 3},$$

$$CA = \begin{bmatrix} 1 & 4 & 2 \end{bmatrix} \cdot \begin{bmatrix} 3 \\ -1 \\ 1 \end{bmatrix} = 3 - 4 + 2 = 1 \in \mathbb{F},$$

$$B^2 = BB = \begin{bmatrix} 4 & -1 \\ 0 & 2 \end{bmatrix} \begin{bmatrix} 4 & -1 \\ 0 & 2 \end{bmatrix} = \begin{bmatrix} 16 & -6 \\ 0 & 4 \end{bmatrix} \in \mathbb{F}^{2 \times 2},$$

$$CE = \begin{bmatrix} 1, & 4, & 2 \end{bmatrix} \begin{bmatrix} 6 & 1 & 3 \\ -1 & 1 & 2 \\ 4 & 1 & 3 \end{bmatrix} = \begin{bmatrix} 10, & 7, & 17 \end{bmatrix} \in \mathbb{F}^{1 \times 3}, \text{ and}$$

$$DA = \begin{bmatrix} 1 & 5 & 2 \\ -1 & 0 & 1 \\ 3 & 2 & 4 \end{bmatrix} \begin{bmatrix} 3 \\ -1 \\ 1 \end{bmatrix} = \begin{bmatrix} 0 \\ -2 \\ 11 \end{bmatrix} \in \mathbb{F}^{3 \times 1}.$$

Note, though, that B cannot be multiplied by any of the other matrices, nor does it make sense to try to form the products AD , AE , DC , and EC due to the inherent size mismatches.

As illustrated in Example 12.2.5 above, matrix multiplication is not a commutative operation (since, e.g., $AC \in \mathbb{F}^{3 \times 3}$ while $CA \in \mathbb{F}^{1 \times 1}$). Nonetheless, despite the complexity of its definition, the matrix product otherwise satisfies many familiar properties of a multiplication operation. We summarize the most basic of these properties in the following theorem.

Theorem 12.2.6. *Let $r, s, t, u \in \mathbb{Z}_+$ be positive integers.*

1. *(associativity of matrix multiplication) Given $A \in \mathbb{F}^{r \times s}$, $B \in \mathbb{F}^{s \times t}$, and $C \in \mathbb{F}^{t \times u}$,*

$$A(BC) = (AB)C.$$

2. *(distributivity of matrix multiplication) Given $A \in \mathbb{F}^{r \times s}$, $B, C \in \mathbb{F}^{s \times t}$, and $D \in \mathbb{F}^{t \times u}$,*

$$A(B + C) = AB + AC \quad \text{and} \quad (B + C)D = BD + CD.$$

3. *(compatibility with scalar multiplication) Given $A \in \mathbb{F}^{r \times s}$, $B \in \mathbb{F}^{s \times t}$, and $\alpha \in \mathbb{F}$,*

$$\alpha(AB) = (\alpha A)B = A(\alpha B).$$

Moreover, given any positive integer $n \in \mathbb{Z}_+$, $\mathbb{F}^{n \times n}$ is an algebra over \mathbb{F} .

As with Theorem 12.2.3, you should work through a proof of each part of Theorem 12.2.6 (and especially of the first part) in order to practice manipulating the indices of entries correctly. We state and prove a useful followup to Theorems 12.2.3 and 12.2.6 as an illustration.

Theorem 12.2.7. *Let $A, B \in \mathbb{F}^{n \times n}$ be upper triangular matrices and $c \in \mathbb{F}$ be any scalar. Then each of the following properties hold:*

1. cA is upper triangular.
2. $A + B$ is upper triangular.
3. AB is upper triangular.

In other words, the set of all $n \times n$ upper triangular matrices forms an algebra over \mathbb{F} .

Moreover, each of the above statements still holds when upper triangular is replaced by lower triangular.

Proof. The proofs of Parts 1 and 2 are straightforward and follow directly from the appropriate definitions. Moreover, the proof of the case for lower triangular matrices follows from the fact that a matrix A is upper triangular if and only if A^T is lower triangular, where A^T denotes the transpose of A . (See Section 12.5.1 for the definition of transpose.)

To prove Part 3, we start from the definition of the matrix product. Denoting $A = (a_{ij})$ and $B = (b_{ij})$, note that $AB = ((ab)_{ij})$ is an $n \times n$ matrix having “ i - j entry” given by

$$(ab)_{ij} = \sum_{k=1}^n a_{ik}b_{kj}.$$

Since A and B are upper triangular, we have that $a_{ik} = 0$ when $i > k$ and that $b_{kj} = 0$ when $k > j$. Thus, to obtain a non-zero summand $a_{ik}b_{kj} \neq 0$, we must have both $a_{ik} \neq 0$, which implies that $i \leq k$, and $b_{kj} \neq 0$, which implies that $k \leq j$. In particular, these two conditions are simultaneously satisfiable only when $i \leq j$. Therefore, $(ab)_{ij} = 0$ when $i > j$, from which AB is upper triangular. \square

At the same time, you should be careful not to blithely perform operations on matrices as you would with numbers. The fact that matrix multiplication is not a commutative operation should make it clear that significantly more care is required with matrix arithmetic. As another example, given a positive integer $n \in \mathbb{Z}_+$, the set $\mathbb{F}^{n \times n}$ has what are called **zero divisors**. That is, there exist non-zero matrices $A, B \in \mathbb{F}^{n \times n}$ such that $AB = 0_{n \times n}$:

$$\begin{bmatrix} 0 & 1 \\ 0 & 0 \end{bmatrix}^2 = \begin{bmatrix} 0 & 1 \\ 0 & 0 \end{bmatrix} \begin{bmatrix} 0 & 1 \\ 0 & 0 \end{bmatrix} = \begin{bmatrix} 0 & 0 \\ 0 & 0 \end{bmatrix} = 0_{2 \times 2}.$$

Moreover, note that there exist matrices $A, B, C \in \mathbb{F}^{n \times n}$ such that $AB = AC$ but $B \neq C$:

$$\begin{bmatrix} 0 & 1 \\ 0 & 0 \end{bmatrix} \begin{bmatrix} 1 & 0 \\ 0 & 0 \end{bmatrix} = 0_{2 \times 2} = \begin{bmatrix} 0 & 1 \\ 0 & 0 \end{bmatrix} \begin{bmatrix} 0 & 1 \\ 0 & 0 \end{bmatrix}.$$

As a result, we say that the set $\mathbb{F}^{n \times n}$ fails to have the so-called **cancellation property**. This failure is a direct result of the fact that there are non-zero matrices in $\mathbb{F}^{n \times n}$ that have no multiplicative inverse. We discuss matrix invertibility at length in the next section and define a special subset $GL(n, \mathbb{F}) \subset \mathbb{F}^{n \times n}$ upon which the cancellation property does hold.

12.2.3 Invertibility of square matrices

In this section, we explore the opposite of matrix multiplication. More specifically, we characterize square matrices for which multiplicative inverses exist.

Definition 12.2.8. Given a positive integer $n \in \mathbb{Z}_+$, we say that the square matrix $A \in \mathbb{F}^{n \times n}$ is **invertible** (a.k.a. **nonsingular**) if there exists a square matrix $B \in \mathbb{F}^{n \times n}$ such that

$$AB = BA = I_n.$$

We use $GL(n, \mathbb{F})$ to denote the set of all invertible $n \times n$ matrices having entries from \mathbb{F} .

One can prove that, if the multiplicative inverse of a matrix exists, then the inverse is unique. As such, we will usually denote the so-called **inverse matrix** of $A \in GL(n, \mathbb{F})$ by A^{-1} . Even though this notation is analogous to the notation for the multiplicative inverse of a scalar, you should not take this to mean that it is possible to “divide” by a matrix. Moreover, note that the zero matrix $0_{n \times n} \notin GL(n, \mathbb{F})$. This means that $GL(n, \mathbb{F})$ is *not* a vector subspace of $\mathbb{F}^{n \times n}$.

Since matrix multiplication is not a commutative operation, care must be taken when working with the multiplicative inverses of invertible matrices. In particular, many of the algebraic properties for multiplicative inverses of scalars, when properly modified, continue to hold. We summarize the most basic of these properties in the following theorem.

Theorem 12.2.9. Let $n \in \mathbb{Z}_+$ be a positive integer and $A, B \in GL(n, \mathbb{F})$. Then

1. the inverse matrix $A^{-1} \in GL(n, \mathbb{F})$ and satisfies $(A^{-1})^{-1} = A$.

2. the matrix power $A^m \in GL(n, \mathbb{F})$ and satisfies $(A^m)^{-1} = (A^{-1})^m$, where $m \in \mathbb{Z}_+$ is any positive integer.
3. the matrix $\alpha A \in GL(n, \mathbb{F})$ and satisfies $(\alpha A)^{-1} = \alpha^{-1}A^{-1}$, where $\alpha \in \mathbb{F}$ is any non-zero scalar.
4. the product $AB \in GL(n, \mathbb{F})$ and has inverse given by the formula

$$(AB)^{-1} = B^{-1}A^{-1}.$$

Moreover, $GL(n, \mathbb{F})$ has the **cancellation property**. In other words, given any three matrices $A, B, C \in GL(n, \mathbb{F})$, if $AB = AC$, then $B = C$.

At the same time, it is important to note that the zero matrix is not the only non-invertible matrix. As an illustration of the subtlety involved in understanding invertibility, we give the following theorem for the 2×2 case.

Theorem 12.2.10. Let $A = \begin{bmatrix} a_{11} & a_{12} \\ a_{21} & a_{22} \end{bmatrix} \in \mathbb{F}^{2 \times 2}$. Then A is invertible if and only if A satisfies

$$a_{11}a_{22} - a_{12}a_{21} \neq 0.$$

Moreover, if A is invertible, then

$$A^{-1} = \begin{bmatrix} \frac{a_{22}}{a_{11}a_{22} - a_{12}a_{21}} & \frac{-a_{12}}{a_{11}a_{22} - a_{12}a_{21}} \\ \frac{-a_{21}}{a_{11}a_{22} - a_{12}a_{21}} & \frac{a_{11}}{a_{11}a_{22} - a_{12}a_{21}} \end{bmatrix}.$$

A more general theorem holds for larger matrices, but its statement requires substantially more machinery than could reasonably be included here. We nonetheless state this result for completeness and refer the reader to Chapter 8 for the definition of the determinant.

Theorem 12.2.11. Let $n \in \mathbb{Z}_+$ be a positive integer, and let $A = (a_{ij}) \in \mathbb{F}^{n \times n}$ be an $n \times n$ matrix. Then A is invertible if and only if $\det(A) \neq 0$. Moreover, if A is invertible, then the “ i, j entry” of A^{-1} is $A_{ji}/\det(A)$. Here, $A_{ij} = (-1)^{i+j}M_{ij}$, and M_{ij} is the determinant of the matrix obtained when both the i^{th} row and j^{th} column are removed from A .

We close this section by noting that the set $GL(n, \mathbb{F})$ of all invertible $n \times n$ matrices over \mathbb{F} is often called the **general linear group**. This set has so many important uses in mathematics that there are many equivalent notations for it, including $GL_n(\mathbb{F})$ and $GL(\mathbb{F}^n)$, and sometimes simply $GL(n)$ or GL_n if it is not important to emphasize the dependence on \mathbb{F} . Note, moreover, that the usage of the term “group” in the name “general linear group” is highly technical. This is because $GL(n, \mathbb{F})$ forms a nonabelian group under matrix multiplication. (See Section B.2 for the definition of a group.)

12.3 Solving linear systems by factoring the coefficient matrix

There are many ways in which you might try to solve a given system of linear equations. This section is primarily devoted to describing two particularly popular techniques, both of which involve factoring the coefficient matrix for the system into a product of simpler matrices. These techniques are also at the heart of many frequently used numerical (i.e., computer-assisted) applications of Linear Algebra.

You should note that the factorization of complicated objects into simpler components is an extremely common problem solving technique in mathematics. E.g., we will often factor a given polynomial into several polynomials of lower degree, and one can similarly use the prime factorization for an integer in order to simplify certain numerical computations.

12.3.1 Factorizing matrices using Gaussian elimination

In this section, we discuss a particularly significant factorization for matrices known as **Gaussian elimination** (a.k.a. **Gauss-Jordan elimination**). Gaussian elimination can be used to express any matrix as a product involving one matrix in so-called **reduced row-echelon form** and one or more so-called **elementary matrices**. Then, once such a factorization has been found, we can immediately solve any linear system that has the factorized matrix as its coefficient matrix. Moreover, the underlying technique for arriving at such a factorization is essentially an extension of the techniques already familiar to you for solving small systems of linear equations by hand.

Let $m, n \in \mathbb{Z}_+$ denote positive integers, and suppose that $A \in \mathbb{F}^{m \times n}$ is an $m \times n$ matrix

over \mathbb{F} . Then, following Section 12.2.2, we will make extensive use of $A^{(i,\cdot)}$ and $A^{(\cdot,j)}$ to denote the row vectors and column vectors of A , respectively.

Definition 12.3.1. Let $A \in \mathbb{F}^{m \times n}$ be an $m \times n$ matrix over \mathbb{F} . Then we say that A is in **row-echelon form** (abbreviated **REF**) if the rows of A satisfy the following conditions:

- (1) either $A^{(1,\cdot)}$ is the zero vector or the first non-zero entry in $A^{(1,\cdot)}$ (when read from left to right) is a one.
- (2) for $i = 1, \dots, m$, if any row vector $A^{(i,\cdot)}$ is the zero vector, then each subsequent row vector $A^{(i+1,\cdot)}, \dots, A^{(m,\cdot)}$ is also the zero vector.
- (3) for $i = 2, \dots, m$, if some $A^{(i,\cdot)}$ is not the zero vector, then the first non-zero entry (when read from left to right) is a one and occurs to the right of the initial one in $A^{(i-1,\cdot)}$.

The initial leading one in each non-zero row is called a **pivot**. We furthermore say that A is in **reduced row-echelon form** (abbreviated **RREF**) if

- (4) for each column vector $A^{(\cdot,j)}$ containing a pivot ($j = 2, \dots, n$), the pivot is the only non-zero element in $A^{(\cdot,j)}$.

The motivation behind Definition 12.3.1 is that matrix equations having their coefficient matrix in RREF (and, in some sense, also REF) are particularly easy to solve. Note, in particular, that the only square matrix in RREF without zero rows is the identity matrix.

Example 12.3.2. The following matrices are all in REF:

$$A_1 = \begin{bmatrix} 1 & 1 & 1 & 1 \\ 0 & 1 & 1 & 1 \\ 0 & 0 & 1 & 1 \end{bmatrix}, \quad A_2 = \begin{bmatrix} 1 & 1 & 1 & 0 \\ 0 & 1 & 1 & 0 \\ 0 & 0 & 1 & 0 \end{bmatrix}, \quad A_3 = \begin{bmatrix} 1 & 1 & 0 & 1 \\ 0 & 1 & 1 & 0 \\ 0 & 0 & 0 & 1 \end{bmatrix}, \quad A_4 = \begin{bmatrix} 1 & 1 & 0 & 0 \\ 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 1 \end{bmatrix},$$

$$A_5 = \begin{bmatrix} 1 & 0 & 1 & 0 \\ 0 & 0 & 0 & 1 \\ 0 & 0 & 0 & 0 \end{bmatrix}, \quad A_6 = \begin{bmatrix} 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 1 \\ 0 & 0 & 0 & 0 \end{bmatrix}, \quad A_7 = \begin{bmatrix} 0 & 0 & 0 & 1 \\ 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 \end{bmatrix}, \quad A_8 = \begin{bmatrix} 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 \end{bmatrix}.$$

However, only A_4 through A_8 are in RREF, as you should verify. Moreover, if we take the transpose of each of these matrices (as defined in Section 12.5.1), then only A_6^T , A_7^T , and A_8^T are in RREF.

Example 12.3.3.

1. Consider the following matrix in RREF:

$$A = \begin{bmatrix} 1 & 0 & 0 & 0 \\ 0 & 1 & 0 & 0 \\ 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 1 \end{bmatrix}.$$

Given any vector $b = (b_i) \in \mathbb{F}^4$, the matrix equation $Ax = b$ corresponds to the system of equations

$$\left. \begin{array}{rcl} x_1 & & = b_1 \\ & x_2 & = b_2 \\ & & x_3 = b_3 \\ & & & x_4 = b_4 \end{array} \right\}.$$

Since A is in RREF (in fact, $A = I_4$ is the 4×4 identity matrix), we can immediately conclude that the matrix equation $Ax = b$ has the solution $x = b$ for any choice of b .

Moreover, as we will see in Section 12.4.2, $x = b$ is the only solution to this system.

2. Consider the following matrix in RREF:

$$A = \begin{bmatrix} 1 & 6 & 0 & 0 & 4 & -2 \\ 0 & 0 & 1 & 0 & 3 & 1 \\ 0 & 0 & 0 & 1 & 5 & 2 \\ 0 & 0 & 0 & 0 & 0 & 0 \end{bmatrix}.$$

Given any vector $b = (b_i) \in \mathbb{F}^4$, the matrix equation $Ax = b$ corresponds to the system of equations

$$\left. \begin{array}{rcl} x_1 + 6x_2 & & + 4x_5 - 2x_6 = b_1 \\ & x_3 & + 3x_5 + x_6 = b_2 \\ & & x_4 + 5x_5 + 2x_6 = b_3 \\ & & & 0 = b_4 \end{array} \right\}.$$

Since A is in RREF, we can immediately conclude a number of facts about solutions

to this system. First of all, solutions exist if and only if $b_4 = 0$. Moreover, by “solving for the pivots”, we see that the system reduces to

$$\left. \begin{aligned} x_1 &= b_1 - 6x_2 - 4x_5 + 2x_6 \\ x_3 &= b_2 - 3x_5 - x_6 \\ x_4 &= b_3 - 5x_5 - 2x_6 \end{aligned} \right\},$$

and so there is only enough information to specify values for x_1 , x_3 , and x_4 in terms of the otherwise arbitrary values for x_2 , x_5 , and x_6 .

In this context, x_1 , x_3 , and x_4 are called **leading variables** since these are the variable corresponding to the pivots in A . We similarly call x_2 , x_5 , and x_6 **free variables** since the leading variables have been expressed in terms of these remaining variable. In particular, given any scalars $\alpha, \beta, \gamma \in \mathbb{F}$, it follows that the vector

$$x = \begin{bmatrix} x_1 \\ x_2 \\ x_3 \\ x_4 \\ x_5 \\ x_6 \end{bmatrix} = \begin{bmatrix} b_1 - 6\alpha - 4\beta + 2\gamma \\ \alpha \\ b_2 - 3\beta - \gamma \\ b_3 - 5\beta - 2\gamma \\ \beta \\ \gamma \end{bmatrix} = \begin{bmatrix} b_1 \\ 0 \\ b_2 \\ b_3 \\ 0 \\ 0 \end{bmatrix} + \begin{bmatrix} -6\alpha \\ \alpha \\ 0 \\ 0 \\ 0 \\ 0 \end{bmatrix} + \begin{bmatrix} -4\beta \\ 0 \\ -3\beta \\ -5\beta \\ \beta \\ 0 \end{bmatrix} + \begin{bmatrix} 2\gamma \\ 0 \\ -\gamma \\ -2\gamma \\ 0 \\ \gamma \end{bmatrix}$$

must satisfy the matrix equation $Ax = b$. One can also verify that every solution to the matrix equation must be of this form. It then follows that the set of all solutions should somehow be “three dimensional”.

As the above examples illustrate, a matrix equation having coefficient matrix in RREF corresponds to a system of equations that can be solved with only a small amount of computation. Somewhat amazingly, any matrix can be factored into a product that involves exactly one matrix in RREF and one or more of the matrices defined as follows.

Definition 12.3.4. A square matrix $E \in \mathbb{F}^{m \times m}$ is called an **elementary matrix** if it has one of the following forms:

1. (row exchange, a.k.a. “row swap”, matrix) E is obtained from the identity matrix I_m by interchanging the row vectors $I_m^{(r,\cdot)}$ and $I_m^{(s,\cdot)}$ for some particular choice of positive

integers $r, s \in \{1, 2, \dots, m\}$. I.e., in the case that $r < s$,

$$E = \begin{bmatrix} 1 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ 0 & 1 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ 0 & 0 & 1 & \cdots & 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & 0 & \cdots & 1 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 & 1 & 0 & \cdots & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 & 1 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 1 & 0 & 0 & \cdots & 0 \\ 0 & 0 & 0 & \cdots & 0 & 1 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 & 0 & 1 & \cdots & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 1 \end{bmatrix} \begin{array}{l} \\ \\ \\ \\ \leftarrow r^{\text{th}} \text{ row} \\ \\ \\ \leftarrow s^{\text{th}} \text{ row.} \\ \\ \\ \end{array}$$

2. (row scaling matrix) E is obtained from the identity matrix I_m by replacing the row vector $I_m^{(r,\cdot)}$ with $\alpha I_m^{(r,\cdot)}$ for some choice of non-zero scalar $0 \neq \alpha \in \mathbb{F}$ and some choice of positive integer $r \in \{1, 2, \dots, m\}$. I.e.,

$$E = I_m + (\alpha - 1)E_{rr} = \begin{bmatrix} 1 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ 0 & 1 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & \cdots & 1 & 0 & 0 & \cdots & 0 \\ 0 & 0 & \cdots & 0 & \alpha & 0 & \cdots & 0 \\ 0 & 0 & \cdots & 0 & 0 & 1 & \cdots & 0 \\ \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 1 \end{bmatrix} \leftarrow r^{\text{th}} \text{ row,}$$

where E_{rr} is the matrix having “ r, r entry” equal to one and all other entries equal to zero. (Recall that E_{rr} was defined in Section 12.2.1 as a standard basis vector for the vector space $\mathbb{F}^{m \times m}$.)

3. (row combination, a.k.a. “row sum”, matrix) E is obtained from the identity matrix I_m by replacing the row vector $I_m^{(r,\cdot)}$ with $I_m^{(r,\cdot)} + \alpha I_m^{(s,\cdot)}$ for some choice of scalar $\alpha \in \mathbb{F}$ and some choice of positive integers $r, s \in \{1, 2, \dots, m\}$. I.e., in the case that $r < s$,

$$E = I_m + \alpha E_{rs} = \begin{bmatrix} 1 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ 0 & 1 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ 0 & 0 & 1 & \cdots & 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & 0 & \cdots & 1 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ 0 & 0 & 0 & \cdots & 0 & 1 & 0 & \cdots & 0 & \alpha & 0 & \cdots & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 & 1 & \cdots & 0 & 0 & 0 & \cdots & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 1 & 0 & 0 & \cdots & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 & 1 & 0 & \cdots & 0 \\ 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 & 0 & 1 & \cdots & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 0 & 0 & 0 & \cdots & 1 \end{bmatrix} \leftarrow r^{\text{th}} \text{ row}$$

↑
 s^{th} column

where E_{rs} is the matrix having “ r, s entry” equal to one and all other entries equal to zero. (E_{rs} was also defined in Section 12.2.1 as a standard basis vector for $\mathbb{F}^{m \times m}$.)

The “elementary” in the name “elementary matrix” comes from the correspondence between these matrices and so-called “elementary operations” on systems of equations. In particular, each of the elementary matrices is clearly invertible (in the sense defined in Section 12.2.3), just as each “elementary operation” is itself completely reversible. We illustrate this correspondence in the following example.

Example 12.3.5. Define A , x , and b by

$$A = \begin{bmatrix} 2 & 5 & 3 \\ 1 & 2 & 3 \\ 1 & 0 & 8 \end{bmatrix}, \quad x = \begin{bmatrix} x_1 \\ x_2 \\ x_3 \end{bmatrix}, \quad \text{and} \quad b = \begin{bmatrix} 4 \\ 5 \\ 9 \end{bmatrix}.$$

We illustrate the correspondence between elementary matrices and “elementary” operations on the system of linear equations corresponding to the matrix equation $Ax = b$, as follows.

<u>System of Equations</u>	<u>Corresponding Matrix Equation</u>
$2x_1 + 5x_2 + 3x_3 = 5$	$Ax = b$
$x_1 + 2x_2 + 3x_3 = 4$	
$x_1 + 8x_3 = 9$	

To begin solving this system, one might want to either multiply the first equation through by $1/2$ or interchange the first equation with one of the other equations. From a computational perspective, it is preferable to perform an interchange since multiplying through by $1/2$ would unnecessarily introduce fractions. Thus, we choose to interchange the first and second equation in order to obtain

<u>System of Equations</u>	<u>Corresponding Matrix Equation</u>
$x_1 + 2x_2 + 3x_3 = 4$	$E_0Ax = E_0b$, where $E_0 = \begin{bmatrix} 0 & 1 & 0 \\ 1 & 0 & 0 \\ 0 & 0 & 1 \end{bmatrix}$.
$2x_1 + 5x_2 + 3x_3 = 5$	
$x_1 + 8x_3 = 9$	

Another reason for performing the above interchange is that it now allows us to use more convenient “row combination” operations when eliminating the variable x_1 from all but one of the equations. In particular, we can multiply the first equation through by -2 and add it to the second equation in order to obtain

<u>System of Equations</u>	<u>Corresponding Matrix Equation</u>
$x_1 + 2x_2 + 3x_3 = 4$	$E_1E_0Ax = E_1E_0b$, where $E_1 = \begin{bmatrix} 1 & 0 & 0 \\ -2 & 1 & 0 \\ 0 & 0 & 1 \end{bmatrix}$.
$x_2 - 3x_3 = -3$	
$x_1 + 8x_3 = 9$	

Similarly, in order to eliminate the variable x_1 from the third equation, we can next multiply the first equation through by -1 and add it to the third equation in order to obtain

System of EquationsCorresponding Matrix Equation

$$\begin{array}{rcl}
 x_1 + 2x_2 + 3x_3 & = & 4 \\
 x_2 - 3x_3 & = & -3 \\
 -2x_2 + 5x_3 & = & 5
 \end{array}
 \quad E_2E_1E_0Ax = E_2E_1E_0b, \text{ where } E_2 = \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ -1 & 0 & 1 \end{bmatrix}.$$

Now that the variable x_1 only appears in the first equation, we can somewhat similarly isolate the variable x_2 by multiplying the second equation through by 2 and adding it to the third equation in order to obtain

System of EquationsCorresponding Matrix Equation

$$\begin{array}{rcl}
 x_1 + 2x_2 + 3x_3 & = & 4 \\
 x_2 - 3x_3 & = & -3 \\
 -x_3 & = & -1
 \end{array}
 \quad E_3 \cdots E_0Ax = E_3 \cdots E_0b, \text{ where } E_3 = \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 2 & 1 \end{bmatrix}.$$

Finally, in order to complete the process of transforming the coefficient matrix into REF, we need only rescale row three by -1 . This corresponds to multiplying the third equation through by -1 in order to obtain

System of EquationsCorresponding Matrix Equation

$$\begin{array}{rcl}
 x_1 + 2x_2 + 3x_3 & = & 4 \\
 x_2 - 3x_3 & = & -3 \\
 x_3 & = & 1
 \end{array}
 \quad E_4 \cdots E_0Ax = E_4 \cdots E_0b, \text{ where } E_4 = \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & -1 \end{bmatrix}.$$

Now that the coefficient matrix is in REF, we can already solve for the variables x_1 , x_2 , and x_3 using a process called **back substitution**. In other words, it should be clear from the third equation that $x_3 = 1$. Using this value and solving for x_2 in the second equation, it then follows that

$$x_2 = -3 + 3x_3 = -3 + 3 = 0.$$

Similarly, by solving the first equation for x_1 , it follows that

$$x_1 = 4 - 2x_2 - 3x_3 = 4 - 3 = 1.$$

From a computational perspective, this process of back substitution can be applied to solve any system of equations when the coefficient matrix of the corresponding matrix equation is in REF. However, from an algorithmic perspective, it is often more useful to continue “row reducing” the coefficient matrix in order to produce a coefficient matrix in full RREF.

Here, there are several next natural steps that we could now perform in order to move toward RREF. Since we have so far worked “from the top down, from left to right”, we choose to now work “from bottom up, from right to left”. In other words, we now multiply the third equation through by 3 and then add it to the second equation in order to obtain

<u>System of Equations</u>	<u>Corresponding Matrix Equation</u>
$\begin{aligned} x_1 + 2x_2 + 3x_3 &= 4 \\ x_2 &= 0 \\ x_3 &= 1 \end{aligned}$	$E_5 \cdots E_0 Ax = E_5 \cdots E_0 b, \text{ where } E_5 = \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 3 \\ 0 & 0 & 1 \end{bmatrix}.$

Next, we can multiply the third equation through by -3 and add it to the first equation in order to obtain

<u>System of Equations</u>	<u>Corresponding Matrix Equation</u>
$\begin{aligned} x_1 + 2x_2 &= 1 \\ x_2 &= 0 \\ x_3 &= 1 \end{aligned}$	$E_6 \cdots E_0 Ax = E_6 \cdots E_0 b, \text{ where } E_6 = \begin{bmatrix} 1 & 0 & -3 \\ 0 & 1 & 0 \\ 0 & 0 & 1 \end{bmatrix}.$

Finally, we can multiply the second equation through by -2 and add it to the first equation in order to obtain

<u>System of Equations</u>	<u>Corresponding Matrix Equation</u>
$\begin{aligned} x_1 &= 1 \\ x_2 &= 0 \\ x_3 &= 1 \end{aligned}$	$E_7 \cdots E_0 Ax = E_7 \cdots E_0 b, \text{ where } E_7 = \begin{bmatrix} 1 & -2 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & 1 \end{bmatrix}.$

Now it should be extremely clear that we obtained a correct solution when using back

substitution on the linear system

$$E_4 \cdots E_0 Ax = E_4 \cdots E_0 b.$$

However, in many applications, it is not enough to merely find *a solution*. Instead, it is important to describe *every solution*. As we will see in the remaining sections of these notes, this requires the machinery of Linear Algebra. In particular, we will need the theory of vector spaces and linear maps.

To close this section, we take a closer look at the following expression obtained from the above analysis:

$$E_7 E_6 \cdots E_1 E_0 A = I_3.$$

Because of the way in which we have defined elementary matrices, it should be clear that each of the matrices E_0, E_1, \dots, E_7 is invertible. Thus, we can use Theorem 12.2.9 in order to “solve” for A :

$$A = (E_7 E_6 \cdots E_1 E_0)^{-1} I_3 = E_0^{-1} E_1^{-1} \cdots E_7^{-1} I_3.$$

In effect, since the inverse of an elementary matrix is itself easily seen to be an elementary matrix, this has factored A into the product of eight elementary matrices (namely, $E_0^{-1}, E_1^{-1}, \dots, E_7^{-1}$) and one matrix in RREF (namely, I_3). Moreover, because each elementary matrix is invertible, we can conclude that x solves $Ax = b$ if and only if x solves

$$(E_7 E_6 \cdots E_1 E_0 A) x = (I_3) x = (E_7 E_6 \cdots E_1 E_0) b.$$

Consequently, given any linear system, one can use Gaussian elimination in order to reduce the problem to solving a linear system whose coefficient matrix is in RREF.

Similarly, we can conclude that the inverse of A is

$$A^{-1} = E_7 E_6 \cdots E_1 E_0 = \begin{bmatrix} 13 & -5 & -3 \\ -40 & 16 & 9 \\ 5 & -2 & 1 \end{bmatrix}.$$

Having computed this product, one could essentially “reuse” much of the above computation in order to solve the matrix equation $Ax = b'$ for several different right-hand sides $b' \in \mathbb{F}^3$. The process of “resolving” a linear system is a common practice in applied mathematics.

12.3.2 Solving homogenous linear systems

In this section, we study the solutions for an important special class of linear systems. As we will see in the next section, though, solving any linear system is fundamentally dependent upon knowing how to solve these so-called **homogeneous systems**.

As usual, we use $m, n \in \mathbb{Z}_+$ to denote arbitrary positive integers.

Definition 12.3.6. The system of linear equations, System (12.3), is called a **homogeneous system** if the right-hand side of each equation is zero. In other words, a homogeneous system corresponds to a matrix equation of the form

$$Ax = 0,$$

where $A \in \mathbb{F}^{m \times n}$ is an $m \times n$ matrix and x is an n -tuple of unknowns. We also call the set

$$N = \{v \in \mathbb{F}^n \mid Av = 0\}$$

the **solution space** for the homogeneous system corresponding to $Ax = 0$.

When describing the solution space for a homogeneous linear system, there are three important cases to keep in mind:

Definition 12.3.7. The system of linear equations System (12.3) is called

1. **overdetermined** if $m > n$.
2. **square** if $m = n$.
3. **underdetermined** if $m < n$.

In particular, we can say a great deal about underdetermined homogeneous systems, which we state as a corollary to the following more general result.

Theorem 12.3.8. *Let N be the solution space for the homogeneous linear system corresponding to the matrix equation $Ax = 0$, where $A \in \mathbb{F}^{m \times n}$. Then*

1. *the zero vector $0 \in N$.*
2. *N is a subspace of the vector space \mathbb{F}^n .*

This is an amazing theorem. Since N is a subspace of \mathbb{F}^n , we know that either N will contain exactly one element (namely, the zero vector) or N will contain infinitely many elements.

Corollary 12.3.9. *Every homogeneous system of linear equations is solved by the zero vector. Moreover, every underdetermined homogeneous system has infinitely many solutions.*

We call the zero vector the **trivial solution** for a homogeneous linear system. The fact that every homogeneous linear system has the trivial solution thus reduces solving such a system to determining if solutions other than the trivial solution exist.

One method for finding the solution space of a homogeneous system is to first use Gaussian elimination (as demonstrated in Example 12.3.5) in order to factor the coefficient matrix of the system. Then, because the original linear system is homogeneous, the homogeneous system corresponding to the resulting RREF matrix will have the same solutions as the original system. In other words, if a given matrix A satisfies

$$E_k E_{k-1} \cdots E_0 A = A_0,$$

where each E_i is an elementary matrix and A_0 is an RREF matrix, then the matrix equation $Ax = 0$ has the exact same solution set as $A_0x = 0$ since $E_0^{-1} E_1^{-1} \cdots E_k^{-1} 0 = 0$.

Example 12.3.10. In the following examples, we illustrate the process of determining the solution space for a homogeneous linear system having coefficient matrix in RREF.

1. Consider the matrix equation $Ax = 0$, where A is the matrix given by

$$A = \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & 1 \\ 0 & 0 & 0 \end{bmatrix}.$$

This corresponds to an overdetermined homogeneous system of linear equations. Moreover, since there are no free variables (as defined in Example 12.3.3), it should be clear that this system has only the trivial solution. Thus, $N = \{0\}$.

2. Consider the matrix equation $Ax = 0$, where A is the matrix given by

$$A = \begin{bmatrix} 1 & 0 & 1 \\ 0 & 1 & 1 \\ 0 & 0 & 0 \\ 0 & 0 & 0 \end{bmatrix}.$$

This corresponds to an overdetermined homogeneous system of linear equations. Unlike the above example, we see that x_3 is a free variable for this system, and so we would expect the solution space to contain more than just the zero vector. As in Example 12.3.3, we can solve for the leading variables in terms of the free variable in order to obtain

$$\left. \begin{aligned} x_1 &= -x_3 \\ x_2 &= -x_3 \end{aligned} \right\},$$

It follows that, given any scalar $\alpha \in \mathbb{F}$, every vector of the form

$$x = \begin{bmatrix} x_1 \\ x_2 \\ x_3 \end{bmatrix} = \begin{bmatrix} -\alpha \\ -\alpha \\ \alpha \end{bmatrix} = \alpha \begin{bmatrix} -1 \\ -1 \\ 1 \end{bmatrix}$$

is a solution to $Ax = 0$. Therefore,

$$N = \{(x_1, x_2, x_3) \in \mathbb{F}^3 \mid x_1 = -x_3, x_2 = -x_3\} = \text{span}((-1, -1, 1)).$$

3. Consider the matrix equation $Ax = 0$, where A is the matrix given by

$$A = \begin{bmatrix} 1 & 1 & 1 \\ 0 & 0 & 0 \\ 0 & 0 & 0 \end{bmatrix}.$$

This corresponds to a square homogeneous system of linear equations with two free variables. Thus, using the same technique as in the previous example, we can solve for the leading variable in order to obtain $x_1 = -x_2 - x_3$. It follows that, given any

scalars $\alpha, \beta \in \mathbb{F}$, every vector of the form

$$x = \begin{bmatrix} x_1 \\ x_2 \\ x_3 \end{bmatrix} = \begin{bmatrix} -\alpha - \beta \\ \alpha \\ \beta \end{bmatrix} = \alpha \begin{bmatrix} -1 \\ 1 \\ 0 \end{bmatrix} + \beta \begin{bmatrix} -1 \\ 0 \\ 1 \end{bmatrix}$$

is a solution to $Ax = 0$. Therefore,

$$N = \{(x_1, x_2, x_3) \in \mathbb{F}^3 \mid x_1 + x_2 + x_3 = 0\} = \text{span}((-1, 1, 0), (-1, 0, 1)).$$

12.3.3 Solving inhomogeneous linear systems

In this section, we demonstrate the relationship between arbitrary linear systems and homogeneous linear systems. Specifically, we will see that it takes little more work to solve a general linear system than it does to solve the homogeneous system associated to it.

As usual, we use $m, n \in \mathbb{Z}_+$ to denote arbitrary positive integers.

Definition 12.3.11. The system of linear equations System (12.3) is called an **inhomogeneous system** if the right-hand side of at least one equation is not zero. In other words, an inhomogeneous system corresponds to a matrix equation of the form

$$Ax = b,$$

where $A \in \mathbb{F}^{m \times n}$ is an $m \times n$ matrix, x is an n -tuple of unknowns, and $b \in \mathbb{F}^m$ is a vector having at least one non-zero component. We also call the set

$$U = \{v \in \mathbb{F}^n \mid Av = b\}$$

the **solution set** for the linear system corresponding to $Ax = b$.

As illustrated in Example 12.3.3, the zero vector cannot be a solution for an inhomogeneous system. Consequently, the solution set U for an inhomogeneous linear system will never be a subspace of any vector space. Instead, it will be a related algebraic structure as described in the following theorem.

Theorem 12.3.12. *Let U be the solution space for the inhomogeneous linear system corresponding to the matrix equation $Ax = b$, where $A \in \mathbb{F}^{m \times n}$ and $b \in \mathbb{F}^m$ is a vector having at least one non-zero component. Then, given any element $u \in U$, we have that*

$$U = u + N = \{u + n \mid n \in N\},$$

where N is the solution space to $Ax = 0$. In other words, if $B = (n^{(1)}, n^{(2)}, \dots, n^{(k)})$ is a list of vectors forming a basis for N , then every element of U can be written in the form

$$u + \alpha_1 n^{(1)} + \alpha_2 n^{(2)} + \dots + \alpha_k n^{(k)}$$

for some choice of scalars $\alpha_1, \alpha_2, \dots, \alpha_k \in \mathbb{F}$.

As a consequence of this theorem, we can conclude that inhomogeneous linear systems behave a lot like homogeneous systems. The main difference is that inhomogeneous systems are not necessarily solvable. This, then, creates three possibilities: an inhomogeneous linear system will either have no solution, a unique solution, or infinitely many solutions. An important special case is as follows.

Corollary 12.3.13. *Every overdetermined inhomogeneous linear system will necessarily be unsolvable for some choice of values for the right-hand sides of the equations.*

The solution set U for an inhomogeneous linear system is called an **affine subspace** of \mathbb{F}^n since it is a genuine subspace of \mathbb{F}^n that has been “offset” by a vector $u \in \mathbb{F}^n$. Any set having this structure might also be called a **coset** (when used in the context of Group Theory) or a **linear manifold** (when used in a geometric context such as a discussion of intersection hyperplanes).

In order to actually find the solution set for an inhomogeneous linear system, we rely on Theorem 12.3.12. Given an $m \times n$ matrix $A \in \mathbb{F}^{m \times n}$ and a non-zero vector $b \in \mathbb{F}^m$, we call $Ax = 0$ the **associated homogeneous matrix equation** to the inhomogeneous matrix equation $Ax = b$. Then, according to Theorem 12.3.12, U can be found by first finding the solution space N for the associated equation $Ax = 0$ and then finding any so-called **particular solution** $u \in \mathbb{F}^n$ to $Ax = b$.

As with homogeneous systems, one can first use Gaussian elimination in order to factorize A , and so we restrict the following examples to the special case of RREF matrices.

Example 12.3.14. The following examples use the same matrices as in Example 12.3.10.

1. Consider the matrix equation $Ax = b$, where A is the matrix given by

$$A = \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & 1 \\ 0 & 0 & 0 \end{bmatrix}$$

and $b \in \mathbb{F}^4$ has at least one non-zero component. Then $Ax = b$ corresponds to an overdetermined inhomogeneous system of linear equations and will not necessarily be solvable for all possible choices of b .

In particular, note that the bottom row $A^{(4,\cdot)}$ of A corresponds to the equation

$$0 = b_4,$$

from which $Ax = b$ has no solution unless the fourth component of b is zero. Furthermore, the remaining rows of A correspond to the equations

$$x_1 = b_1, \quad x_2 = b_2, \quad \text{and} \quad x_3 = b_3.$$

It follows that, given any vector $b \in \mathbb{F}^n$ with fourth component zero, $x = b$ is the only solution to $Ax = b$. In other words, $U = \{b\}$.

2. Consider the matrix equation $Ax = b$, where A is the matrix given by

$$A = \begin{bmatrix} 1 & 0 & 1 \\ 0 & 1 & 1 \\ 0 & 0 & 0 \\ 0 & 0 & 0 \end{bmatrix}$$

and $b \in \mathbb{F}^4$. This corresponds to an overdetermined inhomogeneous system of linear equations. Note, in particular, that the bottom two rows of the matrix corresponds to the equations $0 = b_3$ and $0 = b_4$, from which $Ax = b$ has no solution unless the third and fourth component of the vector b are both zero. Furthermore, we conclude from

the remaining rows of the matrix that x_3 is a free variable for this system and that

$$\left. \begin{aligned} x_1 &= b_1 - x_3 \\ x_2 &= b_2 - x_3 \end{aligned} \right\}.$$

It follows that, given any scalar $\alpha \in \mathbb{F}$, every vector of the form

$$x = \begin{bmatrix} x_1 \\ x_2 \\ x_3 \end{bmatrix} = \begin{bmatrix} b_1 - \alpha \\ b_2 - \alpha \\ \alpha \end{bmatrix} = \begin{bmatrix} b_1 \\ b_2 \\ 0 \end{bmatrix} + \alpha \begin{bmatrix} -1 \\ -1 \\ 1 \end{bmatrix} = u + \alpha n$$

is a solution to $Ax = b$. Recall from Example 12.3.10 that the solution space for the associated homogeneous matrix equation $Ax = 0$ is

$$N = \{(x_1, x_2, x_3) \in \mathbb{F}^3 \mid x_1 = -x_3, x_2 = -x_3\} = \text{span}((-1, -1, 1)).$$

Thus, in the language of Theorem 12.3.12, we have that u is a particular solution for $Ax = b$ and that (n) is a basis for N . Therefore, the solution set for $Ax = b$ is

$$U = (b_1, b_2, 0) + N = \{(x_1, x_2, x_3) \in \mathbb{F}^3 \mid x_1 = b_1 - x_3, x_2 = b_2 - x_3\}.$$

3. Consider the matrix equation $Ax = b$, where A is the matrix given by

$$A = \begin{bmatrix} 1 & 1 & 1 \\ 0 & 0 & 0 \\ 0 & 0 & 0 \end{bmatrix}$$

and $b \in \mathbb{F}^4$. This corresponds to a square inhomogeneous system of linear equations with two free variables. As above, this system has no solutions unless $b_2 = b_3 = 0$, and, given any scalars $\alpha, \beta \in \mathbb{F}$, every vector of the form

$$x = \begin{bmatrix} x_1 \\ x_2 \\ x_3 \end{bmatrix} = \begin{bmatrix} b_1 - \alpha - \beta \\ \alpha \\ \beta \end{bmatrix} = \begin{bmatrix} b_1 \\ 0 \\ 0 \end{bmatrix} + \alpha \begin{bmatrix} -1 \\ 1 \\ 0 \end{bmatrix} + \beta \begin{bmatrix} -1 \\ 0 \\ 1 \end{bmatrix} = u + \alpha n^{(1)} + \beta n^{(2)}$$

is a solution to $Ax = b$. Recall from Example 12.3.10, that the solution space for the

associated homogeneous matrix equation $Ax = 0$ is

$$N = \{(x_1, x_2, x_3) \in \mathbb{F}^3 \mid x_1 + x_2 + x_3 = 0\} = \text{span}((-1, 1, 0), (-1, 0, 1)).$$

Thus, in the language of Theorem 12.3.12, we have that u is a particular solution for $Ax = b$ and that $(n^{(1)}, n^{(2)})$ is a basis for N . Therefore, the solution set for $Ax = b$ is

$$U = (b_1, 0, 0) + N = \{(x_1, x_2, x_3) \in \mathbb{F}^3 \mid x_1 + x_2 + x_3 = b_1\}.$$

12.3.4 Solving linear systems with LU-factorization

Let $n \in \mathbb{Z}_+$ be a positive integer, and suppose that $A \in \mathbb{F}^{n \times n}$ is an upper triangular matrix and that $b \in \mathbb{F}^n$ is a column vector. Then, in order to solve the matrix equation $Ax = b$, there is no need to apply Gaussian elimination. Instead, we can exploit the triangularity of A in order to directly obtain a solution.

Using the notation in System (12.3), note that the last equation in the linear system corresponding to $Ax = b$ can only involve the single unknown x_n , and so we can obtain the solution

$$x_n = \frac{b_n}{a_{nn}}$$

as long as $a_{nn} \neq 0$. If $a_{nn} = 0$, then we must be careful to distinguish between the two cases in which $b_n = 0$ or $b_n \neq 0$. Thus, for reasons that will become clear below, we assume that the diagonal elements of A are all nonzero. Under this assumption, there is no ambiguity in substituting the solution for x_n into the penultimate (a.k.a. second-to-last) equation. Since A is upper triangular, the penultimate equation involves only the single unknown x_{n-1} , and so we obtain the solution

$$x_{n-1} = \frac{b_{n-1} - a_{n-1,n}x_n}{a_{n-1,n-1}}.$$

We can then similarly substitute the solutions for x_n and x_{n-1} into the ante penultimate (a.k.a. third-to-last) equation in order to solve for x_{n-2} , and so on until a complete solution is found. In particular,

$$x_1 = \frac{b_1 - \sum_{k=2}^n a_{1k}x_k}{a_{11}}.$$

As in Example 12.3.5, we call this process **back substitution**. Given an arbitrary linear system, back substitution essentially allows us to halt the Gaussian elimination procedure

and immediately obtain a solution for the system as soon as an upper triangular matrix (possibly in REF or even RREF) has been obtained from the coefficient matrix.

A similar procedure can be applied when A is lower triangular. Again using the notation in System (12.3), the first equation contains only x_1 , and so

$$x_1 = \frac{b_1}{a_{11}}.$$

We are again assuming that the diagonal entries of A are all nonzero. Then, acting similarly to back substitution, we can substitute the solution for x_1 into the second equation in order to obtain

$$x_2 = \frac{b_2 - a_{21}x_1}{a_{22}}.$$

Continuing this process, we have created a **forward substitution** procedure. In particular,

$$x_n = \frac{b_n - \sum_{k=1}^{n-1} a_{nk}x_k}{a_{nn}}.$$

More generally, suppose that $A \in \mathbb{F}^{n \times n}$ is an arbitrary square matrix for which there exists a lower triangular matrix $L \in \mathbb{F}^{n \times n}$ and an upper triangular matrix $U \in \mathbb{F}^{n \times n}$ such that $A = LU$. When such matrices exist, we call $A = LU$ an **LU-factorization** (a.k.a. **LU-decomposition**) of A . The benefit of such a factorization is that it allows us to exploit the triangularity of L and U when solving linear systems having coefficient matrix A .

To see this, suppose that $A = LU$ is an LU-factorization for the matrix $A \in \mathbb{F}^{n \times n}$ and that $b \in \mathbb{F}^n$ is a column vector. (As above, we also assume that the none of the diagonal entries in either L or U is zero.) Furthermore, set $y = Ux$, where x is the as yet unknown solution of $Ax = b$. Then, by substitution, y must satisfy

$$Ly = b,$$

and so, since L is lower triangular, we can immediately solve for y via forward substitution. In other words, we are using the associative of matrix multiplication (cf. Theorem 12.2.6) in order to conclude that

$$(A)x = (LU)x = L(Ux) = L(y)$$

Then, once we have obtained $y \in \mathbb{F}^n$, we can apply back substitution in order to solve for x

in the matrix equation

$$Ux = y.$$

In general, one can only obtain an LU-factorization for a matrix $A \in \mathbb{F}^{n \times n}$ when there exist elementary “row combination” matrices $E_1, E_2, \dots, E_k \in \mathbb{F}^{n \times n}$ and an upper triangular matrix U such that

$$E_k E_{k-1} \cdots E_1 A = U.$$

There are various generalizations of LU-factorization that allow for more than just elementary “row combinations” matrices in this product, but we do not mention them here. Instead, we provide a detailed example that illustrates how to obtain an LU-factorization and then how to use such a factorization in solving linear systems.

Example 12.3.15. Consider the matrix $A \in \mathbb{F}^{3 \times 3}$ given by

$$A = \begin{bmatrix} 2 & 3 & 4 \\ 4 & 5 & 10 \\ 4 & 8 & 2 \end{bmatrix}.$$

Using the techniques illustrated in Example 12.3.5, we have the following matrix product:

$$\begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 2 & 1 \end{bmatrix} \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ -2 & 0 & 1 \end{bmatrix} \begin{bmatrix} 1 & 0 & 0 \\ -2 & 1 & 0 \\ 0 & 0 & 1 \end{bmatrix} \begin{bmatrix} 2 & 3 & 4 \\ 4 & 5 & 10 \\ 4 & 8 & 2 \end{bmatrix} = \begin{bmatrix} 2 & 3 & 4 \\ 0 & -1 & 3 \\ 0 & 0 & -2 \end{bmatrix} = U.$$

In particular, we have found three elementary “row combination” matrices, which, when multiplied by A , produce an upper triangular matrix U .

Now, in order to produce a lower triangular matrix L such that $A = LU$, we rely on two facts about lower triangular matrices. First of all, any lower triangular matrix with entirely no-zero diagonal is invertible, and, second, the product of lower triangular matrices is always lower triangular. (Cf. Theorem 12.2.7.) More specifically, we have that

$$\begin{bmatrix} 2 & 3 & 4 \\ 4 & 5 & 10 \\ 4 & 8 & 2 \end{bmatrix} = \begin{bmatrix} 1 & 0 & 0 \\ -2 & 1 & 0 \\ 0 & 0 & 1 \end{bmatrix}^{-1} \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ -2 & 0 & 1 \end{bmatrix}^{-1} \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 2 & 1 \end{bmatrix}^{-1} \begin{bmatrix} 2 & 3 & 4 \\ 0 & -1 & 3 \\ 0 & 0 & -2 \end{bmatrix}.$$

where

$$\begin{aligned} \begin{bmatrix} 1 & 0 & 0 \\ -2 & 1 & 0 \\ 0 & 0 & 1 \end{bmatrix}^{-1} \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ -2 & 0 & 1 \end{bmatrix}^{-1} \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 2 & 1 \end{bmatrix}^{-1} &= \begin{bmatrix} 1 & 0 & 0 \\ 2 & 1 & 0 \\ 0 & 0 & 1 \end{bmatrix} \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 2 & 0 & 1 \end{bmatrix} \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & -2 & 1 \end{bmatrix} \\ &= \begin{bmatrix} 1 & 0 & 0 \\ 2 & 1 & 0 \\ 2 & -2 & 1 \end{bmatrix}. \end{aligned}$$

We call the resulting lower triangular matrix L and note that $A = LU$, as desired.

Now, define x , y , and b by

$$x = \begin{bmatrix} x_1 \\ x_2 \\ x_3 \end{bmatrix}, y = \begin{bmatrix} y_1 \\ y_2 \\ y_3 \end{bmatrix}, \text{ and } b = \begin{bmatrix} 6 \\ 16 \\ 2 \end{bmatrix}.$$

Applying forward substitution to $Ly = b$, we obtain the solution

$$\left. \begin{aligned} y_1 &= b_1 &&= 6 \\ y_2 &= b_2 - 2y_1 &&= 4 \\ y_3 &= b_3 - 2y_1 + 2y_2 &&= -2 \end{aligned} \right\}.$$

Then, given this unique solution y to $Ly = b$, we can apply backward substitution to $Ux = y$ in order to obtain

$$\left. \begin{aligned} 2x_1 &= y_1 - 3x_2 - 4x_3 &&= 8 \\ -1x_2 &= y_2 - 2x_3 &&= 2 \\ -2x_3 &= y_3 &&= -2 \end{aligned} \right\}.$$

It follows that the unique solution to $Ax = b$ is

$$\left. \begin{aligned} x_1 &= 4 \\ x_2 &= -2 \\ x_3 &= 1 \end{aligned} \right\}.$$

In summary, we have given an algorithm for solving any matrix equation $Ax = b$ in which $A = LU$, where L is lower triangular, U is upper triangular, and both L and U have nothing

but non-zero entries along their diagonals.

We note in closing that the simple procedures of back and forward substitution can also be used for computing the inverses of lower and upper triangular matrices. E.g., the inverse $U = (u_{ij})$ of the matrix

$$U^{-1} = \begin{bmatrix} 2 & 3 & 4 \\ 0 & -1 & 3 \\ 0 & 0 & -2 \end{bmatrix}$$

must satisfy

$$\begin{bmatrix} 2u_{11} + 3u_{21} + 4u_{31} & 2u_{12} + 3u_{22} + 4u_{32} & 2u_{13} + 3u_{23} + 4u_{33} \\ -u_{21} + 3u_{31} & -u_{22} + 3u_{32} & -u_{23} + 3u_{33} \\ -2u_{31} & -2u_{32} & -2u_{33} \end{bmatrix} = U^{-1}U = I_3 = \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & 1 \end{bmatrix},$$

from which we obtain the linear system

$$\left. \begin{array}{rcccccc} 2u_{11} & & +3u_{21} & & +4u_{31} & & = 1 \\ & 2u_{12} & & +3u_{22} & & +4u_{32} & = 0 \\ & & 2u_{13} & & +3u_{23} & & +4u_{33} = 0 \\ & & & -u_{21} & & +3u_{31} & = 0 \\ & & & & -u_{22} & & +3u_{32} = 1 \\ & & & & & -u_{23} & & +3u_{33} = 0 \\ & & & & & & -2u_{31} & = 0 \\ & & & & & & & -2u_{32} = 0 \\ & & & & & & & & -2u_{33} = 1 \end{array} \right\}$$

in the nine variables $u_{11}, u_{12}, \dots, u_{33}$. Since this linear system has upper triangular coefficient matrix, we can apply back substitution in order to directly solve for the entries in U .

The only condition we imposed upon our triangular matrices above was that all diagonal entries were non-zero. It should be clear to you that this non-zero diagonal restriction is a necessary and sufficient condition for a triangular matrix to be non-singular. Moreover, once the inverses of both L and U in an LU-factorization have been obtained, then we can immediately calculate the inverse for $A = LU$ by applying Theorem 12.2.9(4):

$$A^{-1} = (LU)^{-1} = U^{-1}L^{-1}.$$

12.4 Matrices and linear maps

As discussed in Chapter 1, the machinery of Linear Algebra can be used to solve systems of linear equations involving a finite number of unknowns. This section is devoted to illustrating how linear maps are one of the most fundamental tools for gaining insight into the solutions to such systems.

Moreover, by involving these special functions, we are able to work in an arbitrarily high number of dimensions with little more work than that required for two dimensions.

12.4.1 The canonical matrix of a linear map

Let $m, n \in \mathbb{Z}_+$ be positive integers. Then, given a choice of bases for the vector spaces \mathbb{F}^n and \mathbb{F}^m , there is a duality between matrices and linear maps. In other words, as discussed in Section 6.6, every linear map in the set $\mathcal{L}(\mathbb{F}^n, \mathbb{F}^m)$ uniquely corresponds to exactly one $m \times n$ matrix in $\mathbb{F}^{m \times n}$. However, you should not take this to mean that matrices and linear maps are interchangeable or indistinguishable ideas. By itself, a matrix in the set $\mathbb{F}^{m \times n}$ is nothing more than a collection of mn scalars that have been arranged in a rectangular shape. It is only when a matrix appears as part of some larger context that the theory of linear maps becomes applicable. In particular, one can gain insight into the solutions of matrix equations when the coefficient matrix is viewed as the matrix associated to a linear map under a convenient choice of bases for \mathbb{F}^n and \mathbb{F}^m .

Given a positive integer, $k \in \mathbb{Z}_+$, one particularly convenient choice of basis for \mathbb{F}^k is the so-called **standard basis** (a.k.a. the **canonical basis**) e_1, e_2, \dots, e_k , where each e_i is the k -tuple having zeros for each of its component other than in the i^{th} position:

$$e_i = (0, 0, \dots, 0, 1, 0, \dots, 0).$$

\uparrow
 i

Then, taking the vector spaces \mathbb{F}^n and \mathbb{F}^m under their canonical bases, we say that the matrix $A \in \mathbb{F}^{m \times n}$ associated to the linear map $T \in \mathcal{L}(\mathbb{F}^n, \mathbb{F}^m)$ is the **canonical matrix** for T . One reason for this choice of basis is that it gives us the particularly nice formula

$$T(x) = Ax, \forall x \in \mathbb{F}^n. \tag{12.7}$$

In other words, one can compute the action of the linear map upon any vector in \mathbb{F}^n by simply multiplying the vector by the associated canonical matrix A . There are many circumstances in which one might wish to use non-standard bases for either \mathbb{F}^n or \mathbb{F}^m , but the trade-off is that Equation (12.7) will no longer hold as stated. (To modify Equation (12.7) for use with non-standard bases, one needs to use coordinate vectors as described in Chapter 10.)

The utility of Equation (12.7) cannot be overly emphasized. To get a sense of this, consider once again the generic matrix equation (Equation (12.5))

$$Ax = b,$$

which involves a given matrix $A = (a_{ij}) \in \mathbb{F}^{m \times n}$, a given vector $b \in \mathbb{F}^m$, and the n -tuple of unknowns x . To provide a solution to this equation means to provide a vector $x \in \mathbb{F}^n$ for which the matrix product Ax is exactly the vector b . In light of Equation (12.7), the question of whether such a vector $x \in \mathbb{F}^n$ exists is equivalent to asking whether or not the vector b is in the range of the linear map T .

While the encoding of System (12.3) into Equation (12.5) might be considered a matter of mere notational equivocation, the above reinterpretation of Equation (12.5) using linear maps is a genuine change of viewpoint. Solving System (12.3) (and thus Equation (12.5)) essentially amounts to understanding how m distinct objects interact in an ambient space having n -dimensions. (In particular, solutions to System (12.3) correspond to the points of intersect of m hyperplanes in \mathbb{F}^n .) On the other hand, questions about a linear map genuinely involve understanding a single object, i.e., the linear map itself. Such a point of view is both extremely flexible and extremely fruitful, as we illustrate in the next section.

12.4.2 Using linear maps to solve linear systems

Encoding a linear system as a matrix equation is more than just a notational trick. Perhaps most fundamentally, the resulting linear map viewpoint can then be used to provide unparalleled insight into the exact structure of solutions to the original linear system. (In general, the more that can be said with absolute certainty when solving a problem, the better.) We illustrate this in the following series of revisited examples.

Example 12.4.1. Consider the following inhomogeneous linear system from Example 1.2.1:

$$\left. \begin{array}{l} 2x_1 + x_2 = 0 \\ x_1 - x_2 = 1 \end{array} \right\},$$

where x_1 and x_2 are unknown real numbers. To solve this system, we can first form the matrix $A \in \mathbb{R}^{2 \times 2}$ and the column vector $b \in \mathbb{R}^2$ such that

$$A \begin{bmatrix} x_1 \\ x_2 \end{bmatrix} = \begin{bmatrix} 2 & 1 \\ 1 & -1 \end{bmatrix} \begin{bmatrix} x_1 \\ x_2 \end{bmatrix} = \begin{bmatrix} 0 \\ 1 \end{bmatrix} = b,$$

In other words, we have reinterpreted solving the original linear system as asking when the column vector

$$\begin{bmatrix} 2 & 1 \\ 1 & -1 \end{bmatrix} \begin{bmatrix} x_1 \\ x_2 \end{bmatrix} = \begin{bmatrix} 2x_1 + x_2 \\ x_1 - x_2 \end{bmatrix}$$

is equal to the column vector b . Equivalently, this corresponds to asking what input vector results in b being an element of the range of the linear map $T : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ defined by

$$T \left(\begin{bmatrix} x_1 \\ x_2 \end{bmatrix} \right) = \begin{bmatrix} 2x_1 + x_2 \\ x_1 - x_2 \end{bmatrix}.$$

More precisely, T is the linear map having canonical matrix A .

It should be clear that b is in the range of T , since, from Example 1.2.1,

$$T \left(\begin{bmatrix} 1/3 \\ -2/3 \end{bmatrix} \right) = \begin{bmatrix} 0 \\ 1 \end{bmatrix}.$$

In addition, note that T is a bijective function. (This can be proven, for example, by noting that the canonical matrix A for T is invertible.) Since T is bijective, this means that

$$x = \begin{bmatrix} x_1 \\ x_2 \end{bmatrix} = \begin{bmatrix} 1/3 \\ -2/3 \end{bmatrix}$$

is the only possible input vector that can result in the output vector b , and so we have verified that x is the unique solution to the original linear system. Moreover, this technique can be trivially generalized to any number of equations.

Example 12.4.2. Consider the matrix A and the column vectors x and b from Example 12.3.5:

$$A = \begin{bmatrix} 2 & 5 & 3 \\ 1 & 2 & 3 \\ 1 & 0 & 8 \end{bmatrix}, \quad x = \begin{bmatrix} x_1 \\ x_2 \\ x_3 \end{bmatrix}, \quad \text{and} \quad b = \begin{bmatrix} 4 \\ 5 \\ 9 \end{bmatrix}.$$

Here, asking if the matrix equation $Ax = b$ has a solution corresponds to asking if b is an element of the range of the linear map $T : \mathbb{F}^3 \rightarrow \mathbb{F}^3$ defined by

$$T \left(\begin{bmatrix} x_1 \\ x_2 \\ x_3 \end{bmatrix} \right) = \begin{bmatrix} 2x_1 + 5x_2 + 3x_3 \\ x_1 + 2x_2 + 3x_3 \\ 2x_1 + 8x_3 \end{bmatrix}.$$

In order to answer this corresponding question regarding the range of T , we take a closer look at the following expression obtained in Example 12.3.5:

$$A = E_0^{-1} E_1^{-1} \cdots E_7^{-1},$$

Here, we have factored A into the product of eight elementary matrices. From the linear map point of view, this means that we can apply the results of Section 6.6 in order to obtain the factorization

$$T = S_0 \circ S_1 \circ \cdots \circ S_7,$$

where S_i is the (invertible) linear map having canonical matrix E_i^{-1} for $i = 0, \dots, 7$.

This factorization of the linear map T into a composition of invertible linear maps furthermore implies that T itself is invertible. In particular, T is surjective, and so b must be an element of the range of T . Moreover, T is also injective, and so b has exactly one pre-image. Thus, the solution that was found for $Ax = b$ in Example 12.3.5 is unique.

In the above examples, we used the bijectivity of a linear map in order to prove the uniqueness of solutions to linear systems. As discussed in Section 12.3, though, many linear systems that do not have unique solutions. Instead, there are exactly two other possibilities: if a linear system does not have a unique solution, then it will either have no solution or it will have infinitely many solutions. Fundamentally, this is because finding solutions to a linear system is equivalent to describing the pre-image (a.k.a. pullback) of an element in the codomain of a linear map.

In particular, based upon the discussion in Section 12.3.2, it should be clear that solving a homogeneous linear system corresponds to describing the null space of some corresponding linear map. In other words, given any matrix $A \in \mathbb{F}^{m \times n}$, finding the solution space N to the matrix equation $Ax = 0$ (as defined in Section 12.3.2) is the same thing as finding $\text{null}(T)$, where $T \in \mathcal{L}(\mathbb{F}^n, \mathbb{F}^m)$ is the linear map having canonical matrix A . (Recall from Section 6.2 that $\text{null}(T)$ is a subspace of \mathbb{F}^n .) Thus, the fact that every homogeneous linear system has the trivial solution then is equivalent to the fact that the image of the zero vector under any linear map always results in the zero vector, and determining whether or not the trivial solution is unique can be viewed as a dimensionality question about the null space of a corresponding linear map.

We close this section by illustrating this, along with the case for inhomogeneous systems, in the following examples.

Example 12.4.3. The following examples use the same matrices as in Example 12.3.10.

1. Consider the matrix equation $Ax = b$, where A is the matrix given by

$$A = \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & 1 \\ 0 & 0 & 0 \end{bmatrix}$$

and $b \in \mathbb{F}^4$ is a column vector. Here, asking if this matrix equation has a solution corresponds to asking if b is an element of the range of the linear map $T : \mathbb{F}^3 \rightarrow \mathbb{F}^4$ defined by

$$T \left(\begin{bmatrix} x_1 \\ x_2 \\ x_3 \end{bmatrix} \right) = \begin{bmatrix} x_1 \\ x_2 \\ x_3 \\ 0 \end{bmatrix}.$$

From the linear map point of view, it should be extremely clear that $Ax = b$ has a solution if and only if the fourth component of b is zero. In particular, T is not surjective, so $Ax = b$ cannot have a solution for every possible choice of b .

However, it should also be clear that T is injective, from which $\text{null}(T) = \{0\}$. Thus, when $b = 0$, the homogeneous matrix equation $Ax = 0$ has only the trivial solution,

and so we can apply Theorem 12.3.12 in order to verify that $Ax = b$ has a unique solution for any b having fourth component equal to zero.

2. Consider the matrix equation $Ax = b$, where A is the matrix given by

$$A = \begin{bmatrix} 1 & 0 & 1 \\ 0 & 1 & 1 \\ 0 & 0 & 0 \\ 0 & 0 & 0 \end{bmatrix}$$

and $b \in \mathbb{F}^4$ is a column vector. Here, asking if this matrix equation has a solution corresponds to asking if b is an element of the range of the linear map $T : \mathbb{F}^3 \rightarrow \mathbb{F}^4$ defined by

$$T \left(\begin{bmatrix} x_1 \\ x_2 \\ x_3 \end{bmatrix} \right) = \begin{bmatrix} x_1 + x_3 \\ x_2 + x_3 \\ 0 \\ 0 \end{bmatrix}.$$

From the linear map point of view, it should be extremely clear that $Ax = b$ has a solution if and only if the third and fourth components of b are zero. In particular, $2 = \dim(\text{range}(T)) < \dim(\mathbb{F}^4) = 4$ so that T cannot be surjective, and so $Ax = b$ cannot have a solution for every possible choice of b .

In addition, it should also be clear that T is not injective. E.g.,

$$T \left(\begin{bmatrix} -1 \\ -1 \\ 1 \end{bmatrix} \right) = \begin{bmatrix} 0 \\ 0 \\ 0 \\ 0 \end{bmatrix}.$$

Thus, $\{0\} \subsetneq \text{null}(T)$, and so the homogeneous matrix equation $Ax = 0$ will necessarily have infinitely many solutions since $\dim(\text{null}(T)) > 0$. Using the Dimension Formula,

$$\dim(\text{null}(T)) = \dim(\mathbb{F}^3) - \dim(\text{range}(T)) = 3 - 2 = 1,$$

and so the solution space for $Ax = 0$ is a one-dimensional subspace of \mathbb{F}^3 . Moreover,

by applying Theorem 12.3.12, we see that that $Ax = b$ must then also have infinitely many solutions for any b having third and fourth components equal to zero.

3. Consider the matrix equation $Ax = b$, where A is the matrix given by

$$A = \begin{bmatrix} 1 & 1 & 1 \\ 0 & 0 & 0 \\ 0 & 0 & 0 \end{bmatrix}$$

and $b \in \mathbb{F}^3$ is a column vector. Here, asking if this matrix equation has a solution corresponds to asking if b is an element of the range of the linear map $T : \mathbb{F}^3 \rightarrow \mathbb{F}^3$ defined by

$$T \left(\begin{bmatrix} x_1 \\ x_2 \\ x_3 \end{bmatrix} \right) = \begin{bmatrix} x_1 + x_2 + x_3 \\ 0 \\ 0 \end{bmatrix}.$$

From the linear map point of view, it should be extremely clear that $Ax = b$ has a solution if and only if the second and third components of b are zero. In particular, $1 = \dim(\text{range}(T)) < \dim(\mathbb{F}^3) = 3$ so that T cannot be surjective, and so $Ax = b$ cannot have a solution for every possible choice of b .

In addition, it should also be clear that T is not injective. E.g.,

$$T \left(\begin{bmatrix} 1/2 \\ 1/2 \\ -1 \end{bmatrix} \right) = \begin{bmatrix} 0 \\ 0 \\ 0 \end{bmatrix}.$$

Thus, $\{0\} \subsetneq \text{null}(T)$, and so the homogeneous matrix equation $Ax = 0$ will necessarily have infinitely many solution since $\dim(\text{null}(T)) > 0$. Using the Dimension Formula,

$$\dim(\text{null}(T)) = \dim(\mathbb{F}^3) - \dim(\text{range}(T)) = 3 - 1 = 2,$$

and so the solution space for $Ax = 0$ is a two-dimensional subspace of \mathbb{F}^3 . Moreover, by applying Theorem 12.3.12, we see that that $Ax = b$ must then also have infinitely many solutions for any b having second and third components equal to zero.

12.5 Special operations on matrices

In this section, we define three important operations on matrices called the transpose, conjugate transpose, and the trace. These will then be seen to interact with matrix multiplication and invertibility in order to form special classes of matrices that are extremely important to applications of Linear Algebra.

12.5.1 Transpose and conjugate transpose

Given positive integers $m, n \in \mathbb{Z}_+$ and any matrix $A = (a_{ij}) \in \mathbb{F}^{m \times n}$, we define the **transpose** $A^T = ((a^T)_{ij}) \in \mathbb{F}^{n \times m}$ and the **conjugate transpose** $A^* = ((a^*)_{ij}) \in \mathbb{F}^{n \times m}$ by

$$(a^T)_{ij} = a_{ji} \quad \text{and} \quad (a^*)_{ij} = \overline{a_{ji}},$$

where $\overline{a_{ji}}$ denotes the complex conjugate of the scalar $a_{ji} \in \mathbb{F}$. In particular, if $A \in \mathbb{R}^{m \times n}$, then note that $A^T = A^*$.

Example 12.5.1. With notation as in Example 12.1.3,

$$A^T = \begin{bmatrix} 3 & -1 & 1 \end{bmatrix}, \quad B^T = \begin{bmatrix} 4 & 0 \\ -1 & 2 \end{bmatrix}, \quad C^T = \begin{bmatrix} 1 \\ 4 \\ 2 \end{bmatrix},$$

$$D^T = \begin{bmatrix} 1 & -1 & 3 \\ 5 & 0 & 2 \\ 2 & 1 & 4 \end{bmatrix}, \quad \text{and} \quad E^T = \begin{bmatrix} 6 & -1 & 4 \\ 1 & 1 & 1 \\ 3 & 2 & 3 \end{bmatrix}.$$

One of the motivations for defining the operations of transpose and conjugate transpose is that they interact with the usual arithmetic operations on matrices in a natural manner. We summarize the most fundamental of these interactions in the following theorem.

Theorem 12.5.2. *Given positive integers $m, n \in \mathbb{Z}_+$ and any matrices $A, B \in \mathbb{F}^{m \times n}$,*

1. $(A^T)^T = A$ and $(A^*)^* = A$.
2. $(A + B)^T = A^T + B^T$ and $(A + B)^* = A^* + B^*$.

3. $(\alpha A)^T = \alpha A^T$ and $(\alpha A)^* = \bar{\alpha} A^*$, where $\alpha \in \mathbb{F}$ is any scalar.
4. $(AB)^T = B^T A^T$.
5. if $m = n$ and $A \in GL(n, \mathbb{F})$, then $A^T, A^* \in GL(n, \mathbb{F})$ with respective inverses given by

$$(A^T)^{-1} = (A^{-1})^T \quad \text{and} \quad (A^*)^{-1} = (A^{-1})^*.$$

Another motivation for defining the transpose and conjugate transpose operations is that they allow us to define several very special classes of matrices.

Definition 12.5.3. Given a positive integer $n \in \mathbb{Z}_+$, we say that the square matrix $A \in \mathbb{F}^{n \times n}$

1. is **symmetric** if $A = A^T$.
2. is **Hermitian** if $A = A^*$.
3. is **orthogonal** if $A \in GL(n, \mathbb{R})$ and $A^{-1} = A^T$. Moreover, we define the **(real) orthogonal group** to be the set $O(n) = \{A \in GL(n, \mathbb{R}) \mid A^{-1} = A^T\}$.
4. is **unitary** if $A \in GL(n, \mathbb{C})$ and $A^{-1} = A^*$. Moreover, we define the **(complex) unitary group** to be the set $U(n) = \{A \in GL(n, \mathbb{C}) \mid A^{-1} = A^*\}$.

A lot can be said about these classes of matrices. Both $O(n)$ and $U(n)$, for example, form a group under matrix multiplication. Additionally, real symmetric and complex Hermitian matrices always have real eigenvalues. Moreover, given any matrix $A \in \mathbb{R}^{m \times n}$, AA^T is a symmetric matrix with real, non-negative eigenvalues. Similarly, for $A \in \mathbb{C}^{m \times n}$, AA^* is Hermitian with real, non-negative eigenvalues.

12.5.2 The trace of a square matrix

Given a positive integer $n \in \mathbb{Z}_+$ and any square matrix $A = (a_{ij}) \in \mathbb{F}^{n \times n}$, we define the **trace** of A to be the scalar

$$\text{trace}(A) = \sum_{k=1}^n a_{kk} \in \mathbb{F}.$$

Example 12.5.4. With notation as in Example 12.1.3 above,

$$\text{trace}(B) = 4 + 2 = 6, \quad \text{trace}(D) = 1 + 0 + 4 = 5, \quad \text{and} \quad \text{trace}(E) = 6 + 1 + 3 = 10.$$

Note, in particular, that the traces of A and C are not defined since these are not square matrices.

We summarize some of the most basic properties of the trace operation in the following theorem, including its connection to the transpose operations defined in the previous section.

Theorem 12.5.5. *Given positive integers $m, n \in \mathbb{Z}_+$ and square matrices $A, B \in \mathbb{F}^{n \times n}$,*

1. $\text{trace}(\alpha A) = \alpha \text{trace}(A)$, for any scalar $\alpha \in \mathbb{F}$.
2. $\text{trace}(A + B) = \text{trace}(A) + \text{trace}(B)$.
3. $\text{trace}(A^T) = \text{trace}(A)$ and $\text{trace}(A^*) = \overline{\text{trace}(A)}$.
4. $\text{trace}(AA^*) = \sum_{k=1}^n \sum_{\ell=1}^n |a_{k\ell}|^2$. In particular, $\text{trace}(AA^*) = 0$ if and only if $A = 0_{n \times n}$.
5. $\text{trace}(AB) = \text{trace}(BA)$. More generally, given matrices $A_1, \dots, A_m \in \mathbb{F}^{n \times n}$, the trace operation has the so-called **cyclic property**, meaning that

$$\text{trace}(A_1 \cdots A_m) = \text{trace}(A_2 \cdots A_m A_1) = \cdots = \text{trace}(A_m A_1 \cdots A_{m-1}).$$

Moreover, if we define a linear map $T : \mathbb{F}^n \rightarrow \mathbb{F}^n$ by setting $T(v) = Av$ for each $v \in \mathbb{F}^n$ and

if T has distinct eigenvalues $\lambda_1, \dots, \lambda_n$, then $\text{trace}(A) = \sum_{k=1}^n \lambda_k$.

Appendix A

The Language of Sets and Functions

All of mathematics can be seen as the study of relations between collections of objects by rigorous rational arguments. More often than not the patterns in those collections and their relations are more important than the nature of the objects themselves. The power of mathematics has a lot to do with bringing patterns to the forefront and abstracting from the “real” nature of the objects. In mathematics, the collections are usually called *sets* and the objects are called the *elements* of the set. *Functions* are the most common type of relation between sets and their elements and the primary objects of study in Analysis are functions having to do with the set of real numbers. It is therefore important to develop a good understanding of sets and functions and to know the vocabulary used to define sets and functions and to discuss their properties.

A.1 Sets

A **set** is an unordered collection of distinct objects, which we call its **elements**. A set is uniquely determined by its elements. If an object a is an element of a set A , we write $a \in A$, and say that a belongs to A or that A contains a . The negation of this statement is written as $a \notin A$, i.e., a is *not* an element of A . Note that both statements cannot be true at the same time

If A and B are sets, they are identical (this means one and the same set), which we write as $A = B$, if they have exactly the same elements. In other words $A = B$ if and only if for all $a \in A$ we have $a \in B$, and for all $b \in B$ we have $b \in A$. Equivalently, $A \neq B$ if and only

if there is a difference in their elements: there exists $a \in A$ such that $a \notin B$ or there exists $b \in B$ such that $b \notin A$.

Example A.1.1. We start with the simplest examples of sets.

1. The **empty set** (a.k.a. the **null set**), is what it sounds like: the set with *no* elements. We usually denote it by \emptyset or sometimes by $\{ \}$. The empty set, \emptyset , is uniquely determined by the property that for all x we have $x \notin \emptyset$. Clearly, there is exactly one empty set.
2. Next up are the **singletons**. A singleton is a set with exactly one element. If that element is x we often write the singleton containing x as $\{x\}$. In spoken language, ‘the singleton x ’ actually means the set $\{x\}$ and should always be distinguished from the element x : $x \neq \{x\}$. A set can be an element of another set but no set is an element of itself (more precisely, we adopt this as an axiom). E.g., $\{\{x\}\}$ is the singleton of which the unique element is the singleton $\{x\}$. In particular we also have $\{x\} \neq \{\{x\}\}$.
3. One standard way of denoting sets is by listing its elements. E.g., the set $\{\alpha, \beta, \gamma\}$ contains the first three lower case Greek letters. The set is completely determined by what is in the list. The order in which the elements are listed is irrelevant. So, we have $\{\alpha, \gamma, \beta\} = \{\gamma, \beta, \alpha\} = \{\alpha, \beta, \gamma\}$, etc. Since a set cannot contain the same element twice (elements are distinct) the only reasonable meaning of something like $\{\alpha, \beta, \alpha, \gamma\}$ is that it is the same as $\{\alpha, \beta, \gamma\}$. Since $x \neq \{x\}$, $\{x, \{x\}\}$ is a set with two elements. Anything can be considered as an element of a set and there is not any kind of relation is required of the elements in a set. E.g., the word ‘apple’ and the element uranium and the planet Pluto can be the three elements of a set. There is no restriction on the number of different sets a given element can belong to, except for the rule that a set cannot be an element of itself.
4. The number of elements in a set may be infinite. E.g., \mathbb{Z} , \mathbb{R} , and \mathbb{C} , denote the sets of all integer, real, and complex numbers, respectively. It is not required that we can list all elements.

When introducing a new set (new for the purpose of the discussion at hand) it is crucial to define it unambiguously. It is not required that from a given definition of a set A , it is easy to determine what the elements of A are, or even how many there are, but it should

be clear that, in principle, there is unique and unambiguous answer to each question of the form “is x an element of A ?”. There are several common ways to define sets. Here are a few examples.

Example A.1.2.

1. The simplest way is a generalization of the list notation to infinite lists that can be described by a pattern. E.g., the set of positive integers $\mathbb{N} = \{1, 2, 3, \dots\}$. The list can be allowed to be bi-directional, as in the set of all integers $\mathbb{Z} = \{\dots, -2, -1, 0, 1, 2, \dots\}$. Note the use of triple dots \dots to indicate the continuation of the list.
2. The so-called **set builder notation** gives more options to describe the membership of a set. E.g., the set of all even integers, often denote by $2\mathbb{Z}$, is defined by

$$2\mathbb{Z} = \{2a \mid a \in \mathbb{Z}\}.$$

Instead of the vertical bar, $|$, a colon, $:$, is also commonly used. For example, the open interval of the real numbers strictly between 0 and 1 is defined by

$$(0, 1) = \{x \in \mathbb{R} : 0 < x < 1\}.$$

A.2 Subset, union, intersection, and Cartesian product

Definition A.2.1. Let A and B be sets. B is a **subset** of A , denoted by $B \subset A$, if and only if for all $b \in B$ we have $b \in A$. If $B \subset A$ and $B \neq A$, we say that B is a **proper subset** of A .

If $B \subset A$, one also says that B is **contained in** A , or that A contains B , which is sometimes denoted by $A \supset B$. The relation \subset is called **inclusion**. If B is a proper subset of A the inclusion is said to be **strict**. To emphasize that an inclusion is not necessarily strict, the notation $B \subseteq A$ can be used but note that its mathematical meaning is identical to $B \subset A$. Strict inclusion is sometimes denoted by $B \subsetneq A$, but this is less common.

Example A.2.2. The following relations between sets are easy to verify:

1. We have $\mathbb{N} \subset \mathbb{Z} \subset \mathbb{Q} \subset \mathbb{R} \subset \mathbb{C}$, and all these inclusions are strict.
2. For any set A , we have $\emptyset \subset A$, and $A \subset A$.
3. $(0, 1] \subset (0, 2)$.
4. For $0 < a \leq b$, $[-a, a] \subset [-b, b]$. The inclusion is strict if $a < b$.

In addition to constructing sets directly, sets can also be obtained from other sets by a number of standard operations. The following definition introduces the basic operations of taken the **union**, **intersection**, and **difference** of sets.

Definition A.2.3. Let A and B be sets. Then

1. The **union** of A and B , denoted by $A \cup B$, is defined by

$$A \cup B = \{x \mid x \in A \text{ or } x \in B\}.$$

2. The **intersection** of A and B , denoted by $A \cap B$, is defined by

$$A \cap B = \{x \mid x \in A \text{ and } x \in B\}.$$

3. The **set difference** of B from A , denoted by $A \setminus B$, is defined by

$$A \setminus B = \{x \mid x \in A \text{ and } x \notin B\}.$$

Often, the context provides a ‘universe’ of all possible elements pertinent to a given discussion. Suppose, we have given such a set of ‘all’ elements and let us call it U . Then, the **complement** of a set A , denoted by A^c , is defined as $A^c = U \setminus A$. In the following theorem the existence of a universe U is tacitly assumed.

Theorem A.2.4. Let A , B , and C be sets. Then

1. (*distributivity*) $A \cap (B \cup C) = (A \cap B) \cup (A \cap C)$ and $A \cup (B \cap C) = (A \cup B) \cap (A \cup C)$.
2. (*De Morgan’s Laws*) $(A \cup B)^c = A^c \cap B^c$ and $(A \cap B)^c = A^c \cup B^c$.
3. (*relative complements*) $A \setminus (B \cup C) = (A \setminus B) \cap (A \setminus C)$ and $A \setminus (B \cap C) = (A \setminus B) \cup (A \setminus C)$.

To familiarize your self with the basic properties of sets and the basic operations if sets, it is a good exercise to write proofs for the three properties stated in the theorem.

The so-called **Cartesian product** of sets is a powerful and ubiquitous method to construct new sets out of old ones.

Definition A.2.5. Let A and B be sets. Then the **Cartesian product** of A and B , denoted by $A \times B$, is the set of all ordered pairs (a, b) , with $a \in A$ and $b \in B$. In other words,

$$A \times B = \{(a, b) \mid a \in A, b \in B\}.$$

An important example of this construction is the Euclidean plane $\mathbb{R}^2 = \mathbb{R} \times \mathbb{R}$. It is not an accident that x and y in the pair (x, y) are called the *Cartesian* coordinates of the point (x, y) in the plane.

A.3 Relations

In this section we introduce two important types of relations: order relations and equivalence relations. A **relation** R between elements of a set A and elements of a set B is a subset of their Cartesian product: $R \subset A \times B$. When $A = B$, we also call R simply a relation on A .

Let A be a set and R a relation on A . Then,

- R is called **reflexive** if for all $a \in A$, $(a, a) \in R$.
- R is called **symmetric** if for all $a, b \in A$, if $(a, b) \in R$ then $(b, a) \in R$.
- R is called **antisymmetric** if for all $a, b \in A$ such that $(a, b) \in R$ and $(b, a) \in R$, $a = b$.
- R is called **transitive** if for all $a, b, c \in A$ such $(a, b) \in R$ and $(b, c) \in R$, we have $(a, c) \in R$.

Definition A.3.1. Let R be a relation on a set A . R is an **order relation** if R is *reflexive, antisymmetric, and transitive*. R is an **equivalence relation** if R is *reflexive, symmetric, and transitive*.

The notion of subset is an example of an order relation. To see this, first define the **power set** of a set A as the set of all its subsets. It is often denoted by $\mathcal{P}(A)$. So, for any

set A , $\mathcal{P}(A) = \{B : B \subset A\}$. The inclusion relation is defined as the relation R by setting

$$R = \{(B, C) \in \mathcal{P}(A) \times \mathcal{P}(A) \mid B \subset C\}$$

Important relations, such as the subset relation, are given a convenient notation of the form $a <symbol> b$, to denote $(a, b) \in R$. The symbol for the inclusion relation is \subset .

Proposition A.3.2. *Inclusion is an order relation. Explicitly,*

1. (*reflexive*) For all $B \in \mathcal{P}(A)$, $B \subset B$.
2. (*antisymmetric*) For all $B, C \in \mathcal{P}(A)$, if $B \subset C$ and $C \subset B$, then $B = C$.
3. (*transitive*) For all $B, C, D \in \mathcal{P}(A)$, if $B \subset C$ and $C \subset D$, then $B \subset D$.

Write a proof of this proposition as an exercise.

For any relation $R \subset A \times B$, the **inverse relation**, $R^{-1} \subset B \times A$, is defined by

$$R^{-1} = \{(b, a) \in B \times A \mid (a, b) \in R\}.$$

A.4 Functions

Let A and B be sets. A **function** with **domain** A and **codomain** B , denoted by $f : A \rightarrow B$, is relation between the elements of A and B satisfying the properties: for all $a \in A$, there is a *unique* $b \in B$ such that $(a, b) \in f$. The symbol used to denote a function as a relation is an arrow: $(a, b) \in f$ is written as $a \rightarrow b$ (often also $a \mapsto b$). It is not necessary, and a bit cumbersome, to remind ourselves that functions are a special kind of relation and a more convenient notation is used all the time: $f(a) = b$. If f is a function we then have, by definition, $f(a) = b$ and $f(a) = c$ implies $b = c$. In other words, for each $a \in A$, there is exactly one $b \in B$ such that $f(a) = b$. b is called the **image** of a under f . When A and B are sets of numbers, a is sometimes referred to as the **argument** of the function and $b = f(a)$ is often referred to as the **value** of f in a .

The requirement that there is an image $b \in B$ for *all* $a \in A$ is sometimes relaxed in the sense that the domain of the function is a, sometimes not explicitly specified, subset of A . It important to remember, however, that a function is not properly defined unless we have also given its domain.

When we consider the **graph** of a function, we are relying on the definition of a function as a relation. The graph G of a function $f : A \rightarrow B$ is the subset of $A \times B$ defined by

$$G = \{(a, f(a)) \mid a \in A\}.$$

The **range** of a function $f : A \rightarrow B$, denoted by $\text{range}(f)$, or also $f(A)$, is the subset of its codomain consisting of all $b \in B$ that are the image of some $a \in A$:

$$\text{range}(f) = \{b \in B \mid \text{there exists } a \in A \text{ such that } f(a) = b\}.$$

The **pre-image** of $b \in B$ is the subset of all $a \in A$ that have b as their image. This subset is often denoted by $f^{-1}(b)$.

$$f^{-1}(b) = \{a \in A \mid f(a) = b\}.$$

Note that $f^{-1}(b) = \emptyset$ if and only if $b \in B \setminus \text{range}(f)$.

Functions of various kinds are ubiquitous in mathematics and a large vocabulary has developed, some of which is redundant. The term *map* is often used as an alternative for function and when the domain and codomain coincide the term *transformation* is often used instead of function. There is large number of terms for functions in particular context with special properties. The three most basic properties are given in the following definition.

Definition A.4.1. Let $f : A \rightarrow B$ be a function. Then we call f

1. **injective** (f is an **injection**) if $f(a) = f(b)$ implies $a = b$. In other words, no two elements of the domain have the same image. An injective function is also called **one-to-one**.
2. **surjective** (f is a **surjection**) if $\text{range}(f) = B$. In other words, each $b \in B$ is the image of at least one $a \in A$. Such a function is also called **onto**.
3. **bijective** (f is a **bijection**) if f is both injective and surjective, i.e., **one-to-one and onto**. This means that f gives a one-to-one correspondence between *all* elements of A and *all* elements of B .

Let $f : A \rightarrow B$ and $g : B \rightarrow C$ be two functions so that the codomain of f coincides with the domain of g . Then, the **composition** ‘ g after f ’, denoted by $g \circ f$, is the function $g \circ f : A \rightarrow C$, defined by $a \mapsto g(f(a))$.

For every set A , we define the **identity map**, which we will denote here by id_A or id for short. $\text{id}_A : A \rightarrow A$ is defined by $\text{id}_A(a) = a$ for all $a \in A$. Clearly, id_A is a bijection.

If f is a bijection, it is invertible, i.e., the inverse relation is also a function, denoted by f^{-1} . It is the unique bijection $B \rightarrow A$ such that $f^{-1} \circ f = \text{id}_A$ and $f \circ f^{-1} = \text{id}_B$.

Proposition A.4.2. *Let $f : A \rightarrow B$ and $g : B \rightarrow C$ be bijections. Then, their composition $g \circ f$ is a bijection and*

$$(g \circ f)^{-1} = f^{-1} \circ g^{-1}.$$

Prove this proposition as an exercise.

Appendix B

Summary of Algebraic Structures Encountered

Loosely speaking, an **algebraic structure** is any set upon which “arithmetic-like” operations have been defined. The importance of such structures in abstract mathematics cannot be overstated. By recognizing a given set S as an instance of a well-known algebraic structure, *every result* that is known about that abstract algebraic structure is then automatically also known to hold for S . This utility is, in large part, the main motivation behind abstraction.

Before reviewing the algebraic structures that are most important to the study of Linear Algebra, we first carefully define what it means for an operation to be “arithmetic-like”.

B.1 Binary operations and scaling operations

When discussing an arbitrary nonempty set S , you should never assume that S has any type of “structure” (algebraic or otherwise) unless the context suggests differently. Put another way, the elements in S can only ever really be related to each other in a subjective manner. E.g., if we take $S = \{\text{Alice, Bob, Carol}\}$, then there is nothing intrinsic in the definition of S that suggests how these names should objectively be related to one another.

If, on the other hand, we take $S = \mathbb{R}$, then you have no doubt been conditioned to expect that a great deal of “structure” already exists within S . E.g., given any two real numbers $r_1, r_2 \in \mathbb{R}$, one can form the sum $r_1 + r_2$, the difference $r_1 - r_2$, the product $r_1 r_2$, the quotient r_1 / r_2 (assuming $r_2 \neq 0$), the maximum $\max\{r_1, r_2\}$, the minimum $\min\{r_1, r_2\}$, the average

$(r_1 + r_2)/2$, and so on. Each of these operations follows the same pattern: take two real numbers and “combine” (or “compare”) them in order to form a new real number.

Moreover, each of these operations imposes a sense of “structure” within \mathbb{R} by relating real numbers to each other. We can abstract this to an arbitrary nonempty set as follows:

Definition B.1.1. A **binary operation** on a nonempty set S is any function that has as its domain $S \times S$ and as its codomain S .

In other words, a binary operation on S is *any* rule $f : S \times S \rightarrow S$ that assigns exactly one element $f(s_1, s_2) \in S$ to each pair of elements $s_1, s_2 \in S$. We illustrate this definition in the following examples.

Example B.1.2.

1. Addition, subtraction, and multiplication are all examples of familiar binary operations on \mathbb{R} . Formally, one would denote these by something like

$$+ : \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}, \quad - : \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}, \quad \text{and} \quad * : \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}, \quad \text{respectively.}$$

Then, given two real numbers $r_1, r_2 \in \mathbb{R}$, we would denote their sum by $+(r_1, r_2)$, their difference by $-(r_1, r_2)$, and their product by $*(r_1, r_2)$. (E.g., $+(17, 32) = 49$, $-(17, 32) = -15$, and $*(17, 32) = 544$.) However, this level of notational formality can be rather inconvenient, and so we often resort to writing $+(r_1, r_2)$ as the more familiar expression $r_1 + r_2$, $-(r_1, r_2)$ as $r_1 - r_2$, and $*(r_1, r_2)$ as either $r_1 * r_2$ or $r_1 r_2$.

2. The division function $\div : \mathbb{R} \times (\mathbb{R} \setminus \{0\}) \rightarrow \mathbb{R}$ is *not* a binary operation on \mathbb{R} since it does not have the proper domain. However, division *is* a binary operation on $\mathbb{R} \setminus \{0\}$.
3. Other binary operations on \mathbb{R} include the maximum function $\max : \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}$, the minimum function $\min : \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}$, and the average function $(\cdot + \cdot)/2 : \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}$.
4. An example of a binary operation f on the set $S = \{\text{Alice}, \text{Bob}, \text{Carol}\}$ is given by

$$f(s_1, s_2) = \begin{cases} s_1 & \text{if } s_1 \text{ alphabetically precedes } s_2, \\ \text{Bob} & \text{otherwise.} \end{cases}$$

This is because *the only requirement* for a binary operation is that exactly one element of S is assigned to every ordered pair of elements $(s_1, s_2) \in S \times S$.

Even though one could define any number of binary operations upon a given nonempty set, we are generally only interested in operations that satisfy additional “arithmetic-like” conditions. In other words, the most interesting binary operations are those that, in some sense, abstract the salient properties of common binary operations like addition and multiplication on \mathbb{R} . We make this precise with the definition of a so-called “group” in Section B.2.

At the same time, though, binary operations can only be used to impose “structure” *within* a set. In many settings, it is equally useful to additionally impose “structure” *upon* a set. Specifically, one can define relationships between elements in an arbitrary set as follows:

Definition B.1.3. A **scaling operation** (a.k.a. **external binary operation**) on a nonempty set S is any function that has as its domain $\mathbb{F} \times S$ and as its codomain S , where \mathbb{F} denotes an arbitrary field. (As usual, you should just think of \mathbb{F} as being either \mathbb{R} or \mathbb{C}).

In other words, a scaling operation on S is *any* rule $f : \mathbb{F} \times S \rightarrow S$ that assigns exactly one element $f(\alpha, s) \in S$ to each pair of elements $\alpha \in \mathbb{F}$ and $s \in S$. This abstracts the concept of “scaling” an object in S without changing what “type” of object it already is. As such, $f(\alpha, s)$ is often written simply as αs . We illustrate this definition in the following examples.

Example B.1.4.

1. Scalar multiplication of n -tuples in \mathbb{R}^n is probably the most familiar scaling operation to you. Formally, scalar multiplication on \mathbb{R}^n is defined as the following function:

$$(\alpha, (x_1, \dots, x_n)) \mapsto \alpha(x_1, \dots, x_n) = (\alpha x_1, \dots, \alpha x_n), \forall \alpha \in \mathbb{R}, \forall (x_1, \dots, x_n) \in \mathbb{R}^n.$$

In other words, given any $\alpha \in \mathbb{R}$ and any n -tuple $(x_1, \dots, x_n) \in \mathbb{R}^n$, their scalar multiplication results in a *new n -tuple* denoted by $\alpha(x_1, \dots, x_n)$. This new n -tuple is virtually identical to the original, each component having just been “rescaled” by α .

2. Scalar multiplication of continuous functions is another familiar scaling operation. Given any real number $\alpha \in \mathbb{R}$ and any function $f \in \mathcal{C}(\mathbb{R})$, their scalar multiplication results in a *new function* that is denoted by αf , where αf is defined by the rule

$$(\alpha f)(r) = \alpha(f(r)), \forall r \in \mathbb{R}.$$

In other words, this new continuous function $\alpha f \in \mathcal{C}(\mathbb{R})$ is virtually identical to the original function f ; it just “rescales” the image of each $r \in \mathbb{R}$ under f by α .

3. The division function $\div : \mathbb{R} \times (\mathbb{R} \setminus \{0\}) \rightarrow \mathbb{R}$ is a scaling operation on $\mathbb{R} \setminus \{0\}$. In particular, given two real number $r_1, r_2 \in \mathbb{R}$ and any non-zero real number $s \in \mathbb{R} \setminus \{0\}$, we have that $\div(r_1, s) = r_1(1/s)$ and $\div(r_2, s) = r_2(1/s)$, and so $\div(r_1, s)$ and $\div(r_2, s)$ can be viewed as different “scalings” of the multiplicative inverse $1/s$ of s .

This is actually a special case of the previous example. In particular, we can define a function $f \in \mathcal{C}(\mathbb{R} \setminus \{0\})$ by $f(s) = 1/s$, for each $s \in \mathbb{R} \setminus \{0\}$. Then, given any two real numbers $r_1, r_2 \in \mathbb{R}$, the functions r_1f and r_2f can be defined by

$$r_1f(\cdot) = \div(r_1, \cdot) \quad \text{and} \quad r_2f(\cdot) = \div(r_2, \cdot), \quad \text{respectively.}$$

4. Strictly speaking, there is nothing in the definition that precludes S from equalling \mathbb{F} . Consequently, addition, subtraction, and multiplication can all be seen as examples of scaling operations on \mathbb{R} .

As with binary operations, it is easy to define any number of scaling operations upon a given nonempty set S . However, we are generally only interested in operations that are essentially like scalar multiplication on \mathbb{R}^n , and it is also quite common to additionally impose conditions for how scaling operations should interact with any binary operations that might also be defined upon S . We make this precise when we present an alternate formulation of the definition for a vector space in Section B.2.

Put another way, the definitions for binary operation and scaling operation are not particularly useful when taken as is. Since these operations are allowed to be any functions having the proper domains, there is no immediate sense of meaningful abstraction. Instead, binary and scaling operations become useful when additionally conditions are placed upon them so that they can be used to abstract “arithmetic-like” properties. In other words, we are usually only interested in operations that abstract the salient properties of familiar operations for combining things like numbers, n -tuples, and functions.

B.2 Groups, fields, and vector spaces

We begin this section with the following definition, which is unequivocally one of the most fundamental and ubiquitous notions in all of abstract mathematics.

Definition B.2.1. Let G be a nonempty set, and let $*$ be a binary operation on G . (In other words, $*$: $G \times G \rightarrow G$ is a function with $*(a, b)$ denoted by $a * b$, for each $a, b \in G$.) Then G is said to **form a group** under $*$ if the following three conditions are satisfied:

1. (associativity) Given any three elements $a, b, c \in G$,

$$(a * b) * c = a * (b * c).$$

2. (existence of an identity element) There is an element $e \in G$ such that, given any element $a \in G$,

$$a * e = e * a = a.$$

3. (existence of inverse elements) Given any element $a \in G$, there is an element $b \in G$ such that

$$a * b = b * a = e.$$

You should recognize these three conditions (which are sometimes collectively referred to as the **group axioms**) as properties that are satisfied by the operation of addition on \mathbb{R} . This is not an accident. In particular, given real numbers $\alpha, \beta \in \mathbb{R}$, the group axioms form the minimal set of assumptions needed in order to solve the equation $x + \alpha = \beta$ for the variable x , and it is in this sense that the group axioms are an abstraction of the most fundamental properties of addition of real numbers.

A similar remark holds regarding multiplication on $\mathbb{R} \setminus \{0\}$ and solving the equation $\alpha x = \beta$ for the variable x . Note, however, that this cannot be extended to all of \mathbb{R} .

Because the group axioms are so general, they are particularly useful in building more complicated algebraic structures. This is done by adding any number of additional axioms, the most fundamental of which is as follows.

Definition B.2.2. Let G be a group under binary operation $*$. Then G is called an **abelian group** (a.k.a. **commutative group**) if, given any two elements $a, b \in G$, $a * b = b * a$.

Examples of groups are everywhere in abstract mathematics. We now give some of the more important examples that occur in Linear Algebra. Please note, though, that these examples are primarily aimed at motivating the definitions of more complicated algebraic structures. (In general, groups can be much “stranger” than those below.)

Example B.2.3.

1. If $G \in \{\mathbb{Z}, \mathbb{Q}, \mathbb{R}, \mathbb{C}\}$, then G forms an abelian group under the usual definition of addition.

Note, though, that the set \mathbb{Z}_+ of positive integers does not form a group under addition since, e.g., it does not contain an additive identity element.

2. Similarly, if $G \in \{\mathbb{Q} \setminus \{0\}, \mathbb{R} \setminus \{0\}, \mathbb{C} \setminus \{0\}\}$, then G forms an abelian group under the usual definition of multiplication.

Note, though, that $\mathbb{Z} \setminus \{0\}$ does not form a group under multiplication since only ± 1 have multiplicative inverses.

3. If $m, n \in \mathbb{Z}_+$ are positive integers and \mathbb{F} denotes either \mathbb{R} or \mathbb{C} , then the set $\mathbb{F}^{m \times n}$ of all $m \times n$ matrices forms an abelian group under matrix addition.

Note, though, that $\mathbb{F}^{m \times n}$ does not form a group under matrix multiplication unless $m = n = 1$, in which case $\mathbb{F}^{1 \times 1} = \mathbb{F}$.

4. Similarly, if $n \in \mathbb{Z}_+$ is a positive integer and \mathbb{F} denotes either \mathbb{R} or \mathbb{C} , then the set $GL(n, \mathbb{F})$ of invertible $n \times n$ matrices forms a group under matrix multiplications. This group, which is often called the **general linear group**, is non-abelian when $n \geq 2$.

Note, though, that $GL(n, \mathbb{F})$ does not form a group under matrix addition for any choice of n since, e.g., the zero matrix $0_{n \times n} \notin GL(n, \mathbb{F})$.

In the above examples, you should notice two things. First of all, it is important to specify the operation under which a set might or might not be a group. Second, and perhaps more importantly, all but one example is an abelian group. Most of the important sets in Linear Algebra possess some type of algebraic structure, and abelian groups are the principal building block of virtually every one of these algebraic structures. In particular, fields and vector spaces (as defined below) and rings and algebra (as defined in Section B.3) can all be described as “abelian groups plus additional structure”.

Given an abelian group G , adding “additional structure” amounts to imposing one or more additional operation on G such that each new operations is “compatible” with the preexisting binary operation on G . As our first example of this, we add another binary operation to G in order to obtain the definition of a **field**:

Definition B.2.4. Let F be a nonempty set, and let $+$ and $*$ be binary operations on F . Then F **forms a field** under $+$ and $*$ if the following three conditions are satisfied:

1. F forms an abelian group under $+$.
2. Denoting the identity element for $+$ by 0 , $F \setminus \{0\}$ forms an abelian group under $*$.
3. ($*$ distributes over $+$) Given any three elements $a, b, c \in F$,

$$a * (b + c) = a * b + a * c.$$

You should recognize these three conditions (which are sometimes collectively referred to as the **field axioms**) as properties that are satisfied when the operations of addition and multiplication are taken together on \mathbb{R} . This is not an accident. As with the group axioms, the field axioms form the minimal set of assumptions needed in order to abstract fundamental properties of these familiar arithmetic operations. Specifically, the field axioms guarantee that, given any field F , three conditions are always satisfied:

1. Given any $a, b \in F$, the equation $x + a = b$ can be solved for the variable x .
2. Given any $a \in F \setminus \{0\}$ and $b \in F$, the equation $a * x = b$ can be solved for x .
3. The binary operation $*$ (which is like multiplication on \mathbb{R}) can be distributed over (i.e., is “compatible” with) the binary operation $+$ (which is like addition on \mathbb{R}).

Example B.2.5. It should be clear that, if $F \in \{\mathbb{Q}, \mathbb{R}, \mathbb{C}\}$, then F forms a field under the usual definitions of addition and multiplication.

Note, though, that the set \mathbb{Z} of integers does not form a field under these operations since $\mathbb{Z} \setminus \{0\}$ fails to form a group under multiplication. Similarly, none of the other sets from Example B.2.3 can be made into a field.

In some sense \mathbb{Q} , \mathbb{R} , and \mathbb{C} are the only easily describable fields. While there are many other interesting and useful examples of fields, none of them can be described using entirely familiar sets and operations. This is because the field axioms are extremely specific in describing algebraic structure. As we will see in the next section, though, we can build a much more general algebraic structure called a “ring” by still requiring that F form an abelian group under $+$ but simultaneously relaxing the requirement that F simultaneously form an abelian group under $*$.

For now, though, we close this section by taking a completely different point of view. Rather than place an additional (and multiplication-like) binary operation on an abelian group, we instead impose a special type of scaling operation called **scalar multiplication**. In essence, scalar multiplication imparts useful algebraic structure on an arbitrary nonempty set S by indirectly imposing the algebraic structure of \mathbb{F} as an abelian group under multiplication. (Recall that \mathbb{F} can be replaced with either \mathbb{R} or \mathbb{C} .)

Definition B.2.6. Let S be a nonempty set, and let $*$ be a scaling operation on S . (In other words, $*$: $\mathbb{F} \times S \rightarrow S$ is a function with $*(\alpha, s)$ denoted by $\alpha * s$ or even just αs , for every $\alpha \in \mathbb{F}$ and $s \in S$.) Then $*$ is called **scalar multiplication** if it satisfies the following two conditions:

1. (existence of a multiplicative identity element for $*$) Denote by 1 the multiplicative identity element for \mathbb{F} . Then, given any $s \in S$, $1 * s = s$.
2. (multiplication in \mathbb{F} is quasi-associative with respect to $*$) Given any $\alpha, \beta \in \mathbb{F}$ and any $s \in S$,

$$(\alpha\beta) * s = \alpha * (\beta * s).$$

Note that we choose to have the multiplicative part of \mathbb{F} “act” upon S because we are abstracting scalar multiplication as it is intuitively defined in Example B.1.4 on both \mathbb{R}^n and $\mathcal{C}(\mathbb{R})$. This is because, by also requiring a “compatible” additive structure (called **vector addition**), we obtain the following alternate formulation for the definition of a vector space.

Definition B.2.7. Let V be an abelian group under the binary operation $+$, and let $*$ be a scalar multiplication operation on V with respect to \mathbb{F} . Then V **forms a vector space** over \mathbb{F} with respect to $+$ and $*$ if the following two conditions are satisfied:

1. ($*$ distributes over $+$) Given any $\alpha \in \mathbb{F}$ and any $u, v \in V$,

$$\alpha * (u + v) = \alpha * u + \alpha * v.$$

2. ($*$ distributes over addition in \mathbb{F}) Given any $\alpha, \beta \in \mathbb{F}$ and any $v \in V$,

$$(\alpha + \beta) * v = \alpha * v + \beta * v.$$

B.3 Rings and algebras

In this section, we briefly mention two other common algebraic structures. Specifically, we first “relax” the definition of a field in order to define a **ring**, and we then combine the definitions of ring and vector space in order to define an **algebra**. In some sense, groups, rings, and fields are the most fundamental algebraic structures, with vector spaces and algebras being particularly important variants within the study of Linear Algebra and its applications.

Definition B.3.1. Let R be a nonempty set, and let $+$ and $*$ be binary operations on R . Then R forms an **(associative) ring** under $+$ and $*$ if the following three conditions are satisfied:

1. R forms an abelian group under $+$.
2. ($*$ is associative) Given any three elements $a, b, c \in R$, $a * (b * c) = (a * b) * c$.
3. ($*$ distributes over $+$) Given any three elements $a, b, c \in R$,

$$a * (b + c) = a * b + a * c \quad \text{and} \quad (a + b) * c = a * c + b * c.$$

As with the definition of group, there are many additional properties that can be added to a ring; here, each additional property makes a ring more field-like in some way.

Definition B.3.2. Let R be a ring under the binary operations $+$ and $*$. Then we call R

- **commutative** if $*$ is a commutative operation; i.e., given any $a, b \in R$, $a * b = b * a$.
- **unital** if there is an identity element for $*$; i.e., if there exists an element $i \in R$ such that, given any $a \in R$, $a * i = i * a = a$.
- a **commutative ring with identity** (a.k.a. **CRI**) if it’s both commutative and unital.

In particular, note that a commutative ring with identity is almost a field; the only thing missing is the assumption that every element has a multiplicative inverse. It is this one difference that results in many familiar sets being CRIs (or at least unital rings) but not fields. E.g., \mathbb{Z} is a CRI under the usual operations of addition and multiplication, yet, because of the lack of multiplicative inverses for all elements except ± 1 , \mathbb{Z} is not a field.

In some sense, \mathbb{Z} is the prototypical example of a ring, but there are many other familiar examples. E.g., if F is any field, then the set of polynomials $F[z]$ with coefficients from F is a CRI under the usual operations of polynomial addition and multiplication, but again, because of the lack of multiplicative inverses for every element, $F[z]$ is itself not a field. Another important example of a ring comes from Linear Algebra. Given any vector space V , the set $\mathcal{L}(V)$ of all linear maps from V into V is a unital ring under the operations of function addition and composition. However, $\mathcal{L}(V)$ is not a CRI unless $\dim(V) \in \{0, 1\}$.

Alternatively, if a ring R forms a group under $*$ (but not necessarily an abelian group), then R is sometimes called a **skew field** (a.k.a. **division ring**). Note that a skew field is also almost a field; the only thing missing is the assumption that multiplication is commutative. Unlike CRIs, though, there are no simple examples of skew fields that are not also fields.

As you can probably imagine, many other properties that can be appended to the definition of a ring, some of which are more useful than others. We close this section by defining the concept of an **algebra over a field**. In essence, an algebra is a vector space together with a “compatible” ring structure. Consequently, anything that can be done with either a ring or a vector space can also be done with an algebra.

Definition B.3.3. Let A be a nonempty set, let $+$ and \times be binary operations on A , and let $*$ be scalar multiplication on A with respect to \mathbb{F} . Then A **forms an (associative) algebra** over \mathbb{F} with respect to $+$, \times , and $*$ if the following three conditions are satisfied:

1. A forms an (associative) ring under $+$ and \times .
2. A forms a vector space over \mathbb{F} with respect to $+$ and $*$.
3. ($*$ is quasi-associative and homogeneous with respect to \times) Given any element $\alpha \in \mathbb{F}$ and any two elements $a, b \in R$,

$$\alpha * (a \times b) = (\alpha * a) \times b \quad \text{and} \quad \alpha * (a \times b) = a \times (\alpha * b).$$

Two particularly important examples of algebras were already defined above: $F[z]$ (which is unital and commutative) and $\mathcal{L}(V)$ (which is, in general, just unital). On the other hand, there are also many important sets in Linear Algebra that are not algebras. E.g., \mathbb{Z} is a ring that cannot easily be made into an algebra, and \mathbb{R}^3 is a vector space but cannot easily be made into a ring (since the cross product operation from Vector Calculus is not associative).

Appendix C

Some Common Mathematical Symbols and Abbreviations (with History)

This Appendix contains a fairly long list of common mathematical symbols as well as a list of some common Latin abbreviations and phrases. While you will not necessarily need all of the included symbols for your study of Linear Algebra, this list will hopefully nonetheless give you an idea of where much of our modern mathematical notation comes from.

Binary Relations

= (the **equals sign**) means “is the same as” and was first introduced in the 1557 book *The Whetstone of Witte* by physician and mathematician Robert Recorde (c. 1510–1558). He wrote, “I will sette as I doe often in woorke use, a paire of parralles, or Gemowe lines of one lengthe, thus: ===== , bicause noe 2 thynges can be moare equalle.” (Recorde’s equals sign was significantly longer than the one in modern usage and is based upon the idea of “Gemowe” or “identical” lines, where “Gemowe” means “twin” and comes from the same root as the name of the constellation “Gemini”.)

Robert Recorde also introduced the **plus sign**, “+”, and the **minus sign**, “–”, in *The Whetstone of Witte*.

$<$ (the **less than sign**) means “is strictly less than”, and $>$ (the **greater than sign**) means “is strictly greater than”. These first appeared in the book *Artis Analyticae Praxis ad Aequationes Algebraicas Resolvendas* (“The Analytical Arts Applied to Solving Algebraic Equations”) by mathematician and astronomer Thomas Harriot (1560–1621), which was published posthumously in 1631.

Pierre Bouguer (1698–1758) later refined these to \leq (“is less than or equals”) and \geq (“is greater than or equals”) in 1734. Bouguer is sometimes called “the father of naval architecture” due to his foundational work in the theory of naval navigation.

$:=$ (the **equal by definition sign**) means “is equal by definition to”. This is a common alternate form of the symbol “ $=_{\text{Def}}$ ”, the latter having first appeared in the 1894 book *Logica Matematica* by logician Cesare Burali-Forti (1861–1931). Other common alternate forms of the symbol “ $=_{\text{Def}}$ ” include “ $\stackrel{\text{def}}{=}$ ” and “ \equiv ”, with “ \equiv ” being especially common in applied mathematics.

\approx (the **approximately equals sign**) means “is approximately equal to” and was first introduced in the 1892 book *Applications of Elliptic Functions* by mathematician Alfred Greenhill (1847–1927).

Other modern symbols for “approximately equals” include “ \doteq ” (read as “is nearly equal to”), “ \cong ” (read as “is congruent to”), “ \simeq ” (read as “is similar to”), “ \asymp ” (read as “is asymptotically equal to”), and “ \propto ” (read as “is proportional to”). Usage varies, and these are sometimes used to denote varying degrees of “approximate equality” within a given context.

Some Symbols from Mathematical Logic

\therefore (**three dots**) means “therefore” and first appeared in print in the 1659 book *Teusche Algebra* (“Teach Yourself Algebra”) by mathematician Johann Rahn (1622–1676).

Teusche Algebra also contains the first use of the **obelus**, “ \div ”, to denote division.

\because (**upside-down dots**) means “because” and seems to have first appeared in the 1805 book *The Gentleman’s Mathematical Companion*. However, it is much more common (and less ambiguous) to just abbreviate “because” as “b/c”.

\ni (the **such that sign**) means “under the condition that” and first appeared in the 1906 edition of *Formulaire de mathématiques* by the logician Giuseppe Peano (1858–1932). However, it is much more common (and less ambiguous) to just abbreviate “such that” as “s.t.”.

There are two good reasons to avoid using “ \ni ” in place of “such that”. First of all, the abbreviation “s.t.” is significantly more suggestive of its meaning than is “ \ni ”. Perhaps more importantly, though, the symbol “ \ni ” is now commonly used to mean “contains as an element”, which is a logical extension of the usage of the unquestionably standard symbol “ \in ” to mean “is contained as an element in”.

\Rightarrow (the **implies sign**) means “logically implies that”, and \Leftarrow (the **is implied by sign**) means “is logically implied by”. Both have an unclear historical origin. (E.g., “if it’s raining, then it’s pouring” is equivalent to saying “it’s raining \Rightarrow it’s pouring.”)

\Leftrightarrow (the **iff symbol**) means “if and only if” (abbreviated “iff”) and is used to connect two logically equivalent mathematical statements. (E.g., “it’s raining iff it’s pouring” means simultaneously that “if it’s raining, then it’s pouring” and that “if it’s pouring, then it’s raining”. In other words, the statement “it’s raining \Leftrightarrow it’s pouring” means simultaneously that “it’s raining \Rightarrow it’s pouring” and “it’s raining \Leftarrow it’s pouring”.)

The abbreviation “iff” is attributed to the mathematician Paul Halmos (1916–2006).

\forall (the **universal quantifier**) means “for all” and was first used in the 1935 publication *Untersuchungen ueber das logische Schliessen* (“Investigations on Logical Reasoning”) by logician Gerhard Gentzen (1909–1945). He called it the *All-Zeichen* (“all character”) by analogy to the symbol “ \exists ”, which means “there exists”.

\exists (the **existential quantifier**) means “there exists” and was first used in the 1897 edition of *Formulaire de mathématiques* by the logician Giuseppe Peano (1858–1932).

\square (the **Halmos tombstone** or **Halmos symbol**) means “Q.E.D.”, which is an abbreviation of the Latin phrase *quod erat demonstrandum* (“which was to be proven”). “Q.E.D.” has been the most common way to symbolize the end of a logical argument for many centuries, but the modern convention of the “tombstone” is now generally preferred both because it is easier to write and because it is visually more compact.

The symbol “ \square ” was first made popular by mathematician Paul Halmos (1916–2006).

Some Notation from Set Theory

\subset (the **is included in sign**) means “is a subset of” and \supset (the **includes sign**) means “has as a subset”. Both symbols were introduced in the 1890 book *Vorlesungen über die Algebra der Logik* (“Lectures on the Algebra of the Logic”) by logician Ernst Schröder (1841–1902).

\in (the **is in sign**) means “is an element of” and first appeared in the 1895 edition of *Formulaire de mathématiques* by the logician Giuseppe Peano (1858–1932). Peano originally used the Greek letter “ ϵ ” (viz. the first letter of the Latin word *est* for “is”). The modern stylized version of this symbol was later introduced in the 1903 book *Principles of Mathematics* by logician and philosopher Bertrand Russell (1872–1970).

It is also common to use the symbol “ \ni ” to mean “contains as an element”, which is not to be confused with the more archaic usage of “ \ni ” to mean “such that”.

\cup (the **union sign**) means “take the elements that are in either set”, and \cap (the **intersection sign**) means “take the elements that the two sets have in common”. These were both introduced in the 1888 book *Calcolo geometrico secondo l’Ausdehnungslehre di H. Grassmann preceduto dalle operazioni della logica deduttiva* (“Geometric Calculus based upon the teachings of H. Grassman, preceded by the operations of deductive logic”) by logician Giuseppe Peano (1858–1932).

\emptyset (the **null set** or **empty set**) means “the set without any elements in it” and was first used in the 1939 book *Éléments de mathématique* by Nicolas Bourbaki. (Bourbaki is the collective pseudonym for a group of primarily European mathematicians who have written many mathematics books together.) It was borrowed simultaneously from the Norwegian, Danish and Faroese alphabets by group member André Weil (1906–1998).

∞ (**infinity**) denotes “a quantity or number of arbitrarily large magnitude” and first appeared in print in the 1655 publication *De Sectionibus Conicis* (“Tract on Conic Sections”) by mathematician John Wallis (1616–1703).

Possible explanations for Wallis’ choice of “ ∞ ” include its resemblance to the symbol “*oo*” (used by ancient Romans to denote the number 1000), to the final letter of the Greek alphabet ω (used symbolically to mean the “final” number), and to a simple curve called a “lemniscate”, which can be endlessly traversed with little effort.

Some Important Numbers in Mathematics

π (the **ratio of the circumference to the diameter of a circle**) denotes the number 3.141592653589..., and was first used in the 1706 book *Synopsis palmariorum mathesios* (“A New Introduction to Mathematics”) by mathematician William Jones (1675–1749). The use of π to denote this number was then popularized by the great mathematician Leonhard Euler (1707–1783) in his 1748 book *Introductio in Analysin Infinitorum*. (It is speculated that Jones chose the letter “ π ” because it is the first letter in the Greek word *perimetron*, $\pi\epsilon\rho\mu\epsilon\tau\rho\nu$, which roughly means “around”.)

$e = \lim_{n \rightarrow \infty} (1 + \frac{1}{n})^n$ (the **natural logarithm base**, also sometimes called **Euler’s number**) denotes the number 2.718281828459..., and was first used in the 1728 manuscript *Meditatio in Experimenta explosione tormentorum nuper instituta* (“Meditation on experiments made recently on the firing of cannon”) by Leonhard Euler. (It is speculated that Euler chose “ e ” because it is the first letter in the Latin word for “exponential”.)

The mathematician Edmund Landau (1877–1938) once wrote that, “The letter e may now no longer be used to denote anything other than this positive universal constant.”

$i = \sqrt{-1}$ (the **imaginary unit**) was first used in the 1777 memoir *Institutionum calculi integralis* (“Foundations of Integral Calculus”) by Leonhard Euler.

The five most important numbers in mathematics are widely considered to be (in order) 0, 1, i , π , and e . These numbers are even remarkably linked by the equation $e^{i\pi} + 1 = 0$, which the physicist Richard Feynman (1918–1988) once called “the most remarkable formula in mathematics”.

$\gamma = \lim_{n \rightarrow \infty} (\sum_{k=1}^n \frac{1}{k} - \ln n)$ (the **Euler-Mascheroni constant**, also known as just **Euler’s constant**), denotes the number 0.577215664901..., and was first used in the 1792 book *Adnotationes ad Euleri Calculum Integralelem* (“Annotations to Euler’s Integral Calculus”) by geometer Lorenzo Mascheroni (1750–1800).

The number γ is widely considered to be the sixth most important number in mathematics due to its frequent appearance in formulas from number theory and applied mathematics. However, as of this writing, it is still not even known whether or not γ is even an irrational number.

Some Common Latin Abbreviations and Phrases

- i.e.** (*id est*) means “that is” or “in other words”. (It is used to paraphrase a statement that was just made, **not** to mean “for example”, and is **always** followed by a comma.)
- e.g.** (*exempli gratia*) means “for example”. (It is usually used to give an example of a statement that was just made and is **always** followed by a comma.)
- viz.** (*videlicet*) means “namely” or “more specifically”. (It is used to clarify a statement that was just made by providing more information and is **never** followed by a comma.)
- etc.** (*et cetera*) means “and so forth” or “and so on”. (It is used to suggest that the reader should infer further examples from a list that has already been started and is **usually not** followed by a comma.)
- et al.** (*et alii*) means “and others”. (It is used in place of listing multiple authors past the first and is **never** followed by a comma.) The abbreviation “et al.” can also be used in place of *et alibi*, which means “and elsewhere”.
- cf.** (*conferre*) means “compare to” or “see also”. (It is used either to draw a comparison or to refer the reader to somewhere else that they can find more information, and it is **never** followed by a comma.)
- q.v.** (*quod vide*) means “which see” or “go look it up if you’re interested”. (It is used to cross-reference a different written work or a different part of the same written work, and it is **never** followed by a comma.) The plural form of “q.v.” is “q.q.”
- v.s.** (*vide supra*) means “see above”. (It is used to imply that more information can be found before the current point in a written work and is **never** followed by a comma.)
- N.B.** (*Nota Bene*) means “note well” or “pay attention to the following”. (It is used to imply that the wise reader will pay especially careful attention to what follows and is **never** followed by a comma. Cf. the abbreviation “verb. sap.”)
- verb. sap.** (*verbum sapienti sat est*) means “a word to the wise is enough” or “enough has already been said”. (It is used to imply that, while something may still be left unsaid, enough has been said for the reader to infer the entire meaning.)

- vs.** (*versus*) means “against” or “in contrast to”. (It is used to contrast two things and is **never** followed by a comma.) The abbreviation “vs.” is also often written as “v.”
- c.** (*circa*) means “around” or “near”. (It is used when giving an approximation, usually for a date, and is **never** followed by a comma.) The abbreviation “c.” is also commonly written as “ca.”, “cir.”, or “circ.”
- ex lib.** (*ex libris*) means “from the library of”. (It is used to indicate ownership of a book and is **never** followed by a comma.).
- *vice versa* means “the other way around” and is used to indicate that an implication can logically be reversed. (This is sometimes abbreviated as “v.v.”)
 - *a fortiori* means “from the stronger” or “more importantly”.
 - *a priori* means “from before the fact” and refers to reasoning that is done while an event still has yet to happen.
 - *a posteriori* means “from after the fact” and refers to reasoning that is done after an event has already happened.
 - *ad hoc* means “to this” and refers to reasoning that is specific to an event as it is happening. (Such reasoning is regarded as not being generalizable to other situations.)
 - *ad infinitum* means “to infinity” or “without limit”.
 - *ad nauseam* means “causing sea-sickness” or “to excessive”.
 - *mutatis mutandis* means “changing what needs changing” or “with the necessary changes having been made”.
 - *non sequitur* means “it does not follow” and refers to something that is out of place in a logical argument. (This is sometimes abbreviated as “non seq.”)
 - *Me trans mitte sursum, Caledoni!* means, “Beam me up, Scotty!”
 - *Illud Latine dici non potest* means “You can’t say that in Latin”.
 - *Quid quid latine dictum sit, altum videtur* means something like, “Anything that is said in Latin will sound profound.”

Appendix D

Summary of Notation Used

In addition to the notation for sets and functions (as reviewed in Appendix A), the notation for matrices and linear systems, and the common mathematical symbols reviewed in Appendix C, the following notation is used frequently in the study of Linear Algebra.

Special Sets

- The set of **positive integers** is denoted by $\mathbb{Z}_+ = \{1, 2, 3, 4, \dots\}$.
- The set of **integers** is denoted by $\mathbb{Z} = \{\dots, -2, -1, 0, 1, 2, \dots\}$.
- The set of **real numbers** is denoted by \mathbb{R} .
- The set of **complex numbers** is denoted by $\mathbb{C} = \{x + yi \mid x, y \in \mathbb{R}\}$.
(\mathbb{F} is often used to denote a set that can equally well be chosen as either \mathbb{R} or \mathbb{C} .)
- The set of **polynomials of degree at most n** in the variable z and with coefficients over \mathbb{F} is denoted by $\mathbb{F}_n[z] = \{a_0 + a_1z + a_2z^2 + \dots + a_nz^n \mid a_0, a_1, \dots, a_n \in \mathbb{F}\}$.
- The set of **polynomials** of all degrees in z with coefficients over \mathbb{F} is denoted by $\mathbb{F}[z]$.
- The set of **matrices** of size $m \times n$ over \mathbb{F} is denoted by $\mathbb{F}^{m \times n}$.
- The **general linear group** of $n \times n$ invertible matrices over \mathbb{F} is denoted by $GL(n, \mathbb{F})$.
- The set of **continuous functions** with domain $D \subset \mathbb{R}$ and codomain \mathbb{R} is denoted by $\mathcal{C}(D)$, and the set of **smooth** (a.k.a. **infinitely differentiable**) functions with domain $D \subset \mathbb{R}$ and codomain \mathbb{R} is denoted by $\mathcal{C}^\infty(D)$.

Complex Numbers

Given $z = x + yi \in \mathbb{C}$ with $x, y \in \mathbb{R}$, and where i denotes the **imaginary unit**, we denote

- the **additive inverse** of z by $-z = (-x) + (-y)i$.
- the **multiplicative inverse** of z by $z^{-1} = \left(\frac{x}{x^2 + y^2}\right) + \left(\frac{-y}{x^2 + y^2}\right)i$, assuming $z \neq 0$.
- the **complex conjugate** of z by $\bar{z} = x + (-y)i$.
- the **real part** of z by $\operatorname{Re}(z) = x$.
- the **imaginary part** of z by $\operatorname{Im}(z) = y$.
- the **modulus** of z by $|z| = \sqrt{x^2 + y^2}$.
- the **argument** of z by $\operatorname{Arg}(z) = \min_{\theta \geq 0} \{ \theta \mid x = \cos(\theta), y = \sin(\theta) \}$.

Vector Spaces

Let V be an arbitrary vector space, and let U_1 and U_2 be subspaces of V . Then we denote

- the **additive identity** of V by 0 .
- the **additive inverse** of each $v \in V$ by $-v$.
- the **(subspace) sum** of U_1 and U_2 by $U_1 + U_2$.
- the **direct sum** of U_1 and U_2 by $U_1 \oplus U_2$.
- the **span** of $v_1, v_2, \dots, v_n \in V$ by $\operatorname{span}(v_1, v_2, \dots, v_n)$.
- the **dimension** of V by $\dim(V)$, where

$$\dim(V) = \begin{cases} 0 & \text{if } V = \{0\} \text{ is the zero vector space,} \\ n & \text{if every basis for } V \text{ has } n \in \mathbb{Z}_+ \text{ elements in it,} \\ \infty & \text{otherwise.} \end{cases}$$

- the **change of basis map** with respect to a given basis B for V by $[\cdot]_B : V \rightarrow \mathbb{R}^n$, where V is assumed to be n -dimensional.

Linear Maps

Let U , V , and W denote vector spaces over the field \mathbb{F} . Then we denote

- the vector space of all linear maps from V into W by $\mathcal{L}(V, W)$ or $\text{Hom}_{\mathbb{F}}(V, W)$.
- the vector space of all linear operators on V by $\mathcal{L}(V)$ or $\text{Hom}_{\mathbb{F}}(V)$.
- the **composition** (a.k.a. **product**) of $S \in \mathcal{L}(U, V)$ and $T \in \mathcal{L}(V, W)$ by $T \circ S$ (or, equivalently, TS), where $(T \circ S)(u) = T(S(u))$ for each $u \in U$.
- the **null space** (a.k.a. **kernel**) of $T \in \mathcal{L}(V, W)$ by $\text{null}(T) = \{v \in V \mid T(v) = 0\}$.
- the **range** of $T \in \mathcal{L}(V, W)$ by $\text{range}(T) = \{w \in W \mid w = T(v) \text{ for some } v \in V\}$.
- the **eigenspace** of $T \in \mathcal{L}(V)$ associated to eigenvalue $\lambda \in \mathbb{C}$ by $V_{\lambda} = \text{null}(T - \lambda \text{id}_V)$, where id_V denotes the identity map on V .
- the **matrix** of $T \in \mathcal{L}(V, W)$ with respect to the basis B on V and with respect to the basis C on W by $\mathcal{M}(T, B, C)$ (or simply as $\mathcal{M}(T)$).

Inner Product Spaces

Let V be an arbitrary inner product space, and let U be a subspace of V . Then we denote

- the **inner product** on V by $\langle \cdot, \cdot \rangle$.
- the **norm** on V induced by $\langle \cdot, \cdot \rangle$ as $\| \cdot \| = \sqrt{\langle \cdot, \cdot \rangle}$.
- the **orthogonal complement** of U by $U^{\perp} = \{v \in V \mid \langle u, v \rangle = 0, \forall u \in U\}$.
- the **orthogonal projection** onto U by P_U , which, for each $v \in V$, is defined by $P_U(v) = u$ such that $v = u + w$ for $u \in U$ and $w \in U^{\perp}$.
- the **adjoint** of the operator $T \in \mathcal{L}(V)$ by T^* , where T^* satisfies $\langle T(v), w \rangle = \langle v, T^*(w) \rangle$ for each $v, w \in V$.
- the **square root** of the positive operator $T \in \mathcal{L}(V)$ by \sqrt{T} , which satisfies $T = \sqrt{T}\sqrt{T}$.
- the **positive part** of the operator $T \in \mathcal{L}(V)$ by $|T| = \sqrt{T^*T}$.

Appendix E

Movie Scripts

Script: Gaussian Elimination

Now you have seen a bunch of linear systems and written them as equations for functions $f : \mathbb{R}^n \rightarrow \mathbb{R}^m$ where n is the number of unknowns and m the number of equations. You may also have wondered whether there is a systematic way to solve these. In fact there is, its called Gaussian Elimination. Here we will show how its done using an example:

$$\begin{cases} x + 2y & z & & = -1 \\ & & z + w & = 5 \\ 2x + 4y - z & & & = 0 \\ x + 2y & & & = 1 \end{cases} \Leftrightarrow \begin{cases} f : \mathbb{R}^4 \longrightarrow \mathbb{R}^4 \\ (x, y, z, w) \xrightarrow{f} (x + 2y - z, z + w, 2x + 4y - z, x + 2y) \\ f(x, y, z, w) = (-1, 5, 0, 1). \end{cases}$$

The first step is to realize that the names of the variables (x, y, z, w) are not very important, and use a short hand for the above system known as an augmented matrix that just records the coefficients of various terms and the right hand side:

$$\left(\begin{array}{cccc|c} 1 & 2 & -1 & -1 & 0 \\ 0 & 0 & 1 & 1 & 5 \\ 2 & 4 & -1 & 0 & 0 \\ 1 & 2 & 0 & 0 & 1 \end{array} \right).$$

Next you need to develop a list of operations on rows of the augmented matrix that do not change the underlying linear system, or better said, do not change its solution set. These are the following

1. Row swap: Swap any pair of rows, since this just changes the order of equations.
2. Scalar multiply: Multiply an entire row by a non zero number, which is certainly allowed for one of our equations.
3. Row addition: Add a multiple of one row to another, which is again allowed for a pair of equations.

Now the next aim is to use these row operations to bring the augmented matrix to a form which corresponds to an easily solved linear system. There is a standard choice for these known as *reduced row echelon form* (RREF):

$$\begin{pmatrix} 1 & * & 0 & * & 0 & \cdots & 0 & b_1 \\ 0 & 1 & * & 0 & \cdots & 0 & 0 & b_2 \\ 0 & 0 & 1 & \cdots & 0 & 0 & 0 & b_3 \\ \vdots & \vdots & \vdots & & & & & \vdots \\ & & & & & & 1 & b_k \\ 0 & 0 & 0 & \cdots & 0 & 0 & 0 & 0 \\ \vdots & \vdots & \vdots & & & & \vdots & \vdots \\ 0 & 0 & 0 & \cdots & 0 & 0 & 0 & 0 \end{pmatrix}$$

The idea is that the first non-vanishing entry on each row is unity and corresponds to a so-called *pivot variable* for which we will always be able to solve. The entries above and below the pivots are always zero. So our plan is by making a sequence of row operations on our original augmented matrix A in order to achieve RREF:

$$A \sim \cdots \sim \text{RREF}$$

Note the we use a \sim , rather than equality here because the augmented matrices appearing at each step can look very different. The symbol \sim stands for row

equivalence which is an example of an equivalence relation. So lets now perform a sequence of row operations:

$$\begin{aligned}
 & \left(\begin{array}{cccc|c} 1 & 2 & -1 & -1 & 0 \\ 0 & 0 & 1 & 1 & 5 \\ 2 & 4 & -1 & 0 & 0 \\ 1 & 2 & 0 & 0 & 1 \end{array} \right) \xrightarrow{R_3-2R_1, R_4-R_1} \left(\begin{array}{cccc|c} 1 & 2 & -1 & -1 & 0 \\ 0 & 0 & 1 & 1 & 5 \\ 0 & 0 & 1 & 0 & 2 \\ 0 & 0 & 1 & 0 & 2 \end{array} \right) \\
 & \xrightarrow{R_1+R_2, R_3-R_1, R_4-R_1} \left(\begin{array}{cccc|c} 1 & 2 & 0 & 1 & 4 \\ 0 & 0 & 1 & 1 & 5 \\ 0 & 0 & 0 & 0 & -3 \\ 0 & 0 & 0 & 0 & 0 \end{array} \right) \xrightarrow{R_1+R_3, R_2+R_3, -R_3} \left(\begin{array}{cccc|c} 1 & 2 & 0 & 0 & 1 \\ 0 & 0 & 1 & 0 & 2 \\ 0 & 0 & 0 & 1 & 3 \\ 0 & 0 & 0 & 0 & 0 \end{array} \right).
 \end{aligned}$$

The last augmented matrix is in RREF, writing it back as a linear system we have

$$\begin{cases} x + 2y & = 1 \\ & z & = 2 \\ & & w & = 3. \end{cases}$$

We can always choose to solve for the pivot variables, in this case x, z, w , which leaves $y = \mu$ arbitrary. Thus we write the solution as a set

$$\{(1, 0, 2, 3) + \mu(-2, 1, 0, 0) | \mu \in \mathbb{R}\},$$

which is geometrically a line in \mathbb{R}^4 parameterized by μ .

One final comment, even though we made choices for which row operations were made along the way, no matter how it is reached, there is a unique RREF for every augmented matrix.
