## Dear Sir,

I, Nishi Jain, Practising Company Secretary, had been appointed as scrutinizer by the Committee of Administration of The Synthetic & Rayon Textiles Export Promotion Council (the Council) for the purpose of scrutinizing e-voting process in a fair and transparent manner in respect of the below mentioned resolution proposed at the Extraordinary General Meeting of the Members of the Council held on Saturday, 30th March, 2019 at 2.00 p.m. at the registered office, Resham Bhavan 78, Veer Nariman Road, Churchgate, Mumbai -400020, Maharashtra, India, submit my report as under.

- 1. In accordance with the Notice of the Extraordinary General Meeting sent to the Members on March 15<sup>th</sup>, 2019, the e-voting opened at 10.00 A.M. on 27<sup>th</sup> March, 2019 and remained open upto 5.00 P.M. on 29<sup>th</sup> March, 2019 and the NSDL e-voting platform was blocked thereafter.
- 2. The Council had availed the remote e- voting facility offered by National Securities Depository Limited (NSDL) for conducting e-voting by the Members of the Council.
- 3. At the Extraordinary General Meeting of the Council held on 30<sup>th</sup> March, 2019, the Chairman of the Council has suo motto called for NSDL representative at 11 a.m to allow the member present in the meetings who could not vote through e-voting to record their votes through e- voting with their assistance.

As the requisite Quorum was not present the Chairman adjourn the meeting for half an hour. Their after the meeting reconvene as the members present being the Quorum for the meeting.

5. I have scrutinized and reviewed the remote e-voting and votes tendered therein based on the data downloaded from the National Securities Depository Limited (NSDL) e-voting
