

On drug possession, child endangerment charges:

Mother, daughter, aunt arrested

A family of three women – a mother, her adult daughter and her sister – were arrested for drug possession and child endangerment after police discovered methamphetamine and evidence of drug sales at the home the trio shared on Taylor Drive.

Anne Elizabeth “Lisa” Wells, 59; her daughter, Lindsay Anne Overstreet, 35; and Wells’ sister, Angie Lawson, 56, were taken into

custody Friday, Feb. 15, after investigators with the Perry Police Department (PPD) executed a search warrant at the residence early that morning.

Overstreet and Lawson were each charged with possession of methamphetamine; Lawson faces an additional charge of child neglect.

Wells, who owns the home, was charged with operating a drug house,

child neglect and possession of drug paraphernalia.

Overstreet is being held on a \$25,000 bond; Lawson’s bond was set at \$89,000; and Wells’ bond was \$104,000.

“Information developed by Ptl. Chad Cannon led to a search warrant being secured for the residence at 1923 Taylor Drive. The warrant was executed at

Gas station credit card ‘skimmers’ caught in act

Area, state and federal agencies are turning their attention to two suspects arrested here Friday, Feb. 15, after they were caught attempting to install “skimming” devices at a local gas station.

The suspects were nabbed before they were able to place the skimmers inside the pumps at the Murphy Oil gas station located in front of Walmart.

“The suspects had several skimmer devices in their possession and we suspect they may be connected to devices found placed at gas pumps in Madison County,” Perry Police Department (PPD) Capt. Gene Franklin said. “We are working with investigators from Madison, as well as several other state and federal agencies.”

A concerned citizen observed the two suspects attempting to gain access to the gas panel Friday morning around 11:20 a.m.

and contacted police.

“The witness confronted the two men, and they fled as our officers arrived. One of the men fled on foot, running toward the Dollar General. The other man jumped in the truck and drove over to the Aaron’s Rent-A-Center parking lot,” Franklin said.

The men were traveling in a silver four-door truck, which they had parked at an angle in front of the gas pump to partially block the view, Franklin continued. “One of the men was attempting to gain access to the electronic panel while the other man stood beside him, not only blocking him, but also standing as a lookout.”

Once in custody, the suspects were identified as Lazaro Abel Alazo Martinez, 29, and Pedro Pablo Martinez-Ortiz, 35,

One year after 17 killed in Parkland school shooting:

Schools increase safety, security

One year after 17 people were killed and another 17 wounded during a mass shooting at Marjory Stoneman Douglas High School in Parkland, school officials are taking steps to make sure local schools are safe.

The Taylor County

School District is in the process of implementing and installing a long list of additional safety features after receiving a \$100,000 “Safety and Security of School Buildings Program” grant from the Florida Department of Education (FLDOE) on Dec. 18, 2018.

Throughout 2019 and into 2020, local schools will be

installing cameras, card-readers, a buzz-through door and additional safety features throughout the district.

Some of the safety upgrades being implemented include:

- Steinhatchee School: re-configuration of school hallway to separate from doctor’s office (\$6,000)

and purchase and install a Visitor Tracking System (\$2,500).

- Taylor County Elementary: purchase and install 20 additional cameras (\$8,500), new front office configuration (\$8,500) and purchase and install Visitor Tracking System (\$2,500),
- Taylor County Middle School: replace 45 locking

sets on classroom doors (\$18,000), purchase and install 15 additional cameras (\$8,500) and purchase and install Visitor Tracking System (\$2,500).

- Taylor County High School: install card reader and integrate with school IT network (\$5,000) and re-key all doors (\$8,000).
- Taylor Accelerated

School: install peepholes on classroom doors (\$3,000).

- Big Bend Technical College: install card readers on doors (\$4,000) and install buzz-through lock with camera on front door (\$4,000).
- District-wide: digitize all floor plans and share

New school construction cost savings help fund more parking

School officials manage to continue to find cost savings during construction of the new Perry Primary School, Facilities Director Dan Anderson told school

board members recently.

During an update on the project at a Feb. 5 workshop, Anderson reported that the most recent round of savings will allow for

additional paving that will widen the main access road and provide 130 parking spaces not included in the original construction plans.

“The paving project and

widening of the road was at the top of our priority list because it will allow us to add 130 parking

Felons can now vote

Last fall, Florida voters approved Amendment 4, which restored voting rights to certain convicted felons who have completed their sentence, including parole and probation.

The amendment went

into effect Jan. 8, and Taylor County Supervisor of Elections Dana Southerland continues to field questions about the change.

To date, Southerland said she only knows of two people who were previously

ineligible to vote that have registered locally, however she added that those registering do not have to indicate if they were once ineligible.

Southerland fielded questions about the

amendment from Taylor County Commissioners during their Jan. 22 meeting.

“The process for us hasn’t really changed,” Southerland said. “If an

individual walks in to register to vote, they're going to fill out the same voter registration application that you or I would fill out. They're going to answer the same questions, check the same boxes.

"I will not know if they are a felon who has now received the ability to register to vote from Amendment 4. There is no check-box that says 'I'm one of those (who has had their voting rights restored)'. So, I really do not know when I receive an application whether they fit into that category or not," she said.

"We process the application the same. It has been the responsibility of the state to vet that application. It is ultimately going to be their responsibility to try to determine somehow whether that individual has completed their sentence, not only probation or parole completion, but also any monetary obligation or anything like that if it was part of the sentence," Southerland said.

"You know, government works slow," Commission Chair Pam Feagle said.

"For instance, somebody came in and registered, and they thought that they had completed everything, so they vote. Because, once you get it, you're going to let them vote. The state lags around, and two or three months later, they come back and say -- after they vetted them -- that they are not (eligible), what happens then?"

"I will get a notification to begin the removal process," Southerland said. "But, let's go back to where they think that they have completed everything. It's up to the voter to know. If they're going to fill out that application, they need to know whether they have completed their sentence. There are resources they can reach out to and determine that. If they were on probation, they can reach out to the probation office. They can certainly go to the clerk of court's office wherever their felony might have been, and they can tell them if they still owe anything or if there are any other special conditions that they have to comply with."

"Is there a penalty?" Feagle asked.

"If we receive knowledge there was someone who should not have voted, we have the ability to provide

that information to the state attorney's office for them to investigate whether there was intent," Southerland said.

"Did they intentionally do something? Now, I've provided that documentation to our state attorney's office before, and in the scheme of things, that's not something they're going to spend a whole lot of time investigating. So, is there a penalty? Yes. Is it something that's going to be enforced? I don't know."

Clerk of Court Annie Mae Murphy noted that with 67 counties, each with their own records of who has completed their sentences, including financial obligations, it will be difficult for the state to determine individuals' eligibility, especially with an influx of applications expected with Amendment 4.

In response to questions from the public, Southerland has compiled a quick fact sheet to answer her most frequently asked questions:

• **What is Amendment 4?** The Voting Restoration Amendment was the fourth proposed Constitutional Amendment on the 2018 General Election ballot.

This amendment started as a citizen initiative which made ballot position through the collection of over 842,000 petition signatures. The amendment passed with 64.55% of the vote and will now be part of Florida's Constitution with an effective date of Jan. 8. Ballot Summary: This amendment restores the voting rights of Floridians with felony convictions after they complete all terms of their sentence including parole or probation. The amendment would not apply to those convicted of murder or sexual offenses, who would continue to be permanently barred from voting unless the Governor and Cabinet vote to restore their voting rights on a case by case basis.

• **What does this mean for convicted felons who were previously deemed ineligible to register to vote?** Starting on Jan. 8, 2019, certain convicted felons who have completed their sentence, including parole and probation, had their voting rights automatically restored and became eligible to register to vote. Exception: Felons convicted of murder or sexual offenses are not

eligible to register and vote unless the Governor's Clemency Review Board restores their voting rights.

• **How will the Supervisor of Elections handle voter registration applications now with Amendment 4?** The Taylor County Supervisor of Elections office will accept and process voter registration applications as usual. Applications will be accepted from individuals with prior felony convictions who are newly eligible to register pursuant to the terms of Amendment 4. Voters who have previously been removed from the voter rolls due to a felony conviction must re-register to vote starting Jan. 8.

• **My voting rights have been restored. Do I need to do anything before I can vote?** Yes. You must register to vote before you can participate in any election. State law requires all voters to be registered at least 29 days prior to Election Day. You may register: at the Supervisor of Elections Office; at a voter registration agency; by mail (visit www.taylorcountyelections.com to print the form); online at www.RegisterToVoteFlorida.gov (Requires a Florida Driver's

License or Florida ID Card); or at a voter outreach event. NOTE: The Taylor County Supervisor of Elections advises any convicted felon who wishes to register to vote to verify that they have fulfilled their court ordered sentencing obligations BEFORE registering to vote.

• **If I was removed from the voter rolls due to a felony conviction, will I automatically be re-registered to vote now?** No. If a voter's name has been removed from the voting rolls due to a felony conviction, the individual must re-register to vote. Please note that our office will not be contacting individuals regarding this issue.

• **I registered to vote – what happens now?** You should receive a new Voter Information Card from our office within a few days of registering. If you don't receive this, please contact our office to make sure we have your correct address. After registering, voters must keep their registration up to date. Voters can update their address and other information any time at taylorcountyelections.com or call or visit the office.

District working to implement changes 'as quickly as we can'

with first responders and partners (\$9,000).

Perry Primary School is still under construction and will have all of the security measures listed above installed prior to students reporting in August for the 2019-20 school year.

"We are doing everything within our power as quickly as we can to implement the new safety measures at all schools," School Employee Services Coordinator Chris Olson said.

"We have many more projects that we would like to see considered, but due to budgetary shortfalls they can not be implemented

until additional funding is provided," Olson added.

To be approved for the "Safety and Security of School Buildings Program" grant, the Taylor County School District completed a "Safety and Security Assessment" of all schools within the district in August 2018.

The assessment team, comprised of a representative from the sheriff's department, a safety specialist from the Florida School Board Insurance Trust, two district safety specialists and other stakeholders, reviewed the best safety and security practices for each school.

The team outlined security needs on each campus, along

with estimated financial costs for the purchase and installation of each safety upgrade, before submitting a formal application to the FLDOE on Nov. 28, 2018.

According to the approved application, the grant will cover 100 percent of the predicted costs.

The changes are occurring on the heels of the one-year anniversary of the Marjory Stoneman Douglas shooting on Feb. 14, 2018, when a 19-year-old opened fire inside his former high school in Parkland.

In response, the state commission investigating the shooting released a 458-page report on Jan. 2, 2019 to address a plethora of errors revealed by the scrutinization of the events of that fateful day.

The Marjory Stoneman Douglas Public Safety Commission Report details various recommendations based on the findings, and states that Florida school districts "must implement the following harm-mitigation strategies immediately," in an attempt to minimize the catastrophic impact, should this occur again.

All staff should have clearly established roles and responsibilities that are outlined in a written policy and procedure manual

provided to all personnel.

All school campus gates must remain closed and locked, and when opened for ingress and egress they should be staffed to prevent unauthorized campus access.

Doors leading to instructional classrooms or student-occupied space and for ingress/egress to campus or a specific building should remain locked during school hours and should be staffed when open.

All teachers should be able to lock doors from within the classroom, and keys should always be on their person.

Every district and school should have a written, unambiguous Code Red or similar active assailant response policy that is well known to all school personnel, parents and students.

Every school must have an effective communication system through which everyone on campus can see and/or hear—and immediately react to—a called Code Red or similar active assailant response notification.

Classrooms should establish safety measures, such as hard corners or other safe areas, and teachers should have the ability to cover door windows quickly.


at 7 a.m. Friday. Drugs and drug paraphernalia were discovered throughout the residence – in the bedrooms and common living areas. A minor child who was also living at the residence would have been able to get to the drugs. The child was at the home when the warrant was served, and was turned over

to relatives," PPD Capt. Gene Franklin said.

"Based on the evidence, it appeared it was a user's house and a (drug) sale point."

Law enforcement is familiar with all three suspects; Lawson and Wells both have past arrests associated with drug use. Overstreet, who is currently on state probation, has past arrests for drug sales.

City council re-appoints Hamby and McGrew to Doctors' Memorial board

Many times, governmental boards find themselves having to seek out candidates to fill positions on advisory councils and boards.

However, the Perry City Council faced a more enviable position last week with three volunteer candidates to fill two open seats on the Doctors' Memorial Hospital Board of Directors.

The two current board members, Glenda Hamby and Debra McGrew, both reached the end of their terms, but each expressed their willingness to continue serving.

A third candidate, Jim Mitchell, also offered himself

as a volunteer candidate. Mayor Alan Hall said it was a good thing to have three qualified candidates all seeking to serve.

The council voted to keep Hamby and McGrew as its representatives on the DMH Board, but thanked Mitchell for stepping forward. (Councilwoman Venita Woodfaulk cited a conflict and abstained from voting.)

"DMH is my employer, and Mrs. McGrew is my mother-in-law," Woodfaulk said.)

"We would like to keep you on our list for future volunteer opportunities if you don't mind," Hall said.

Later in the meeting, the

council asked if he would be willing to serve on its Community Advisory Task Force, a small group of city residents tasked with advising the city council on the city's community development needs, proposed projects to meet such needs, and suggested applications for Community Development Block Grant funds for such projects.

He agreed and was appointed unanimously.

Hamby and McGrew round out the nine-member DMH board, which includes: Isadore Rommes, Pricilla Tripp, Ken Arnold, Pat Barbaree, Bill Brynes, Mark O'Bryant and Dr. Tae Yu.

both of Hialeah. One of the men was found to be in possession of several credit cards. The second suspect had a number of "skimming" devices as well as tools to build additional devices.

Both are being held on \$100,000 bonds. They face charges of burglary, possession of burglary tools, possession of fraud equipment and possession of stolen credit cards (Ortiz).

"These skimming devices are completely undetectable until you have access to the inside panel. Even then, you wouldn't know it was there if you didn't know what to look for. They typically target pumps they think will be the ones that get the most

use. But there are things you can do - go inside to pay for your gas, regularly check your bank accounts, use a gas card instead of a credit card. These are just a few ways you can protect yourself from skimmers," Franklin said.

We're talking about dreams here, and the funny thing about dreams is that they never die. Oh, they may be put on the back-burner of your life. They may even be dismissed from your mind, but I know - and you know - they are still there.

Yep, still there, waiting to be birthed! All of my books are available at Amazon in the U.S. and in 12 countries. A future movie is in the works, and it all started with a dream!

Dreams are not at the end of the rainbow. They are inside you, so take a deep breath and go for it!



School board thanked for its support of career technical education (CTE)

In recognition of "National Career Technical Education (CTE) Month," the Taylor County School Board passed a resolution and recognized local student members of a SkillsUSA, a partnership of students, teachers and industry working together to ensure America has a skilled workforce for years to come.

Big Bend Technical College (BBTC) SkillsUSA Team President Drayton Pegg and several of his fellow officers appeared before the school board at its Feb. 5 workshop to publicly thank the school board for recognizing February as "Career and Technical Education Month" and to share information about the program.

"SkillsUSA helps each student excel by providing educational programs, events and competitions that support career and technical education – or CTE – in the nation's classrooms," Pegg told the school board.

"Our local chapter has 23 members, of which 16 will be competing in the regional contest in Pensacola. We will compete in the post-secondary Health Science Quiz Bowl, post-secondary and secondary welding and our post-secondary diesel mechanics team has already been selected as champions and will be headed to the state competition in April, where we all hope to join them to compete after

winning at regionals," Pegg added.

Pegg thanked the school board for their support of CTE programs at BBTC, Taylor County High School and Taylor County Middle School, and introduced some of his fellow SkillsUSA officers, including: Parliamentarian Ricky Hatcher, Treasurer Mara Johnson and Secretary Eunice Brown, while recognizing Reporter Krista Jones and Vice-President Samantha Lundy, who were unable to attend the meeting.

BBTC Director Jodi Tilman pointed out some of the benefits of offering CTE courses, sharing that students enrolled in CTE courses had higher average GPAs (3.08) than other high school students (2.71), were less likely to be chronically absent (8.9% compared to 15.3%), had less disciplinary actions (5.8% to 12.5%), had a far lower drop-out rate (0.2% to 1.8%) and were far more likely to earn a diploma (96.7% compared to 73.3%), according to a 2016-17 Career and Professional Academy Enrollment and Performance Report.

The proclamation passed by the school board stated in part: "Whereas, the efforts of career and technical educators, businesses and industry stimulate the growth and vitality of our local, state and national economies by preparing graduates for careers that are forecast to experience the

largest and fastest growth in the next decade; and

"Whereas, secondary schools in 67 school districts, 27 colleges, and 49 technical centers in the state of Florida offer career and technical education

courses.

"Now, therefore, be it resolved that the School Board of Taylor County does hereby observe the month of February, 2019 as Career and Technical Education Month."


Jones, an Aucilla Christian Academy graduate, is currently

New parking spaces to be shared by TCES, PPS

Anderson told the school board. "This will be a shared parking lot for the two schools (new Perry Primary School and existing Taylor County Elementary)."

"Widening the road will allow parents and the public to access the Pre-K classes from the primary school entrance. The 130 parking spots are essential because most of the 90 parking spots we have now is just enough for our staff. There is currently no extra parking

spots for parents of Perry Primary or the Pre-K staff and parents.

"This will allow all of our staff to park in the back and in the new parking lot, leaving those existing parking spots in front of the primary school for parents and Pre-K visitors," Anderson said, adding that the elementary school will get about 30 new parking spaces also.

Anderson explained that the paving would cost a total of \$240,000, but that only \$100,000 would need to come from contingency,

because the other \$140,000 is in the original budget.

According to Anderson, that will leave approximately \$57,000 in the project's contingency fund, adding that he hoped to identify another \$40,000 in savings to add to the contingency.

While that would likely raise the total in contingency to \$97,000, Anderson said that they would need to subtract the cost of an oven (\$12,000) for the kitchen, which would drop the contingency total back down to around \$85,000.

"Scott Brewer (All-State

Construction owner) has been very pleased with how much we have been able to save throughout the project," Superintendent of Schools Dr. Danny Glover said.

"We found a total of \$91,000 over the past month that we were able to save and return to our contingency fund," Anderson reported. "We hope to be able to reduce another part of the project by another \$10-20,000."

"Our water test results just came back good, showing we had plenty of good pressure even while we

had all the faucets running in one area. There were no problems," Anderson reported. "So we should be picking up \$26,000 by not needing another pump."

"We also have \$25,000 budgeted for cleaning, and it should only cost us around \$12,000, so we should be able to save another \$12,000 there," Anderson said, adding, "We should have a little left over at the end – somewhere between \$50,000 and \$100,000 – but you have no idea what we may get hit with here towards the end."

"We are still within our original total construction project cost (\$18.8 million)," Glover pointed out. "Even with this paving change order we are not adding anything to the overall project cost."

According to Anderson, the local school district received \$18.8 million in state funding and added another \$475,000 in local funds in order to be able to make a flooring upgrade, the additional parking and a few other items – bringing the total project cost to \$19.3 million.





