# Extend rubber cultivation

There is an increased demand for rubber in the international market. Personal and consumer goods have been produced using industrial raw material rubber and chemicals. So, rubber should be grown on a commerciall scale as perennial and industrial crop.

In Myanmar, the cultivation of rubber has been carried out in Mon State for years. Rubber has been cultivated most in Mon State as the state is blessed with fertile land and favourable weather.

As rubber can thrive in Taninthayi Division, Kachin State and Shan State in addition to Mon State, efforts are being made for cultivation of rubber on a commercial scale in those regions.

In 2006-2007, over 700,000 acres were put under rubber in the states and divisions. At present, work is well under way to put over 200,000 acres under rubber.

As rubber has been highly sought after in the international market, it turned out to be a commercial crop. In the meantime, Myanma rubber has strong markets for it is in high demand in neighbouring countries. Therefore, farmers and national entrepreneurs are urged to engage in extended cultivation of rubber, in the interest of the State and their own.

HAVANA, 15 Aug-Cuban leader Fidel Castro turned 81 on Monday with congratulatory messages pouring in from many nations. He did not appear for official celebrations.

In late July last year, he handed power to Raul Castro, his younger brother and the nation's Defence Minister, in order to undergo surgery for intestinal bleeding. He has not been seen in public since then, but writes regularly in the nation's newspapers on current affairs.

### Crocodiles chase Australian up a tree for a week

Sydney, 15 Aug—An Australian man tumbled into a bed of crocodiles and was forced to scurry up a tree where he stayed for seven days before being rescued by a military helicopter.

"Every night, I was stalked by two crocs who would sit at the bottom of the tree staring up at me," David George, 53, an outback cattle farmer told Reuters. "All I could see was two sets of red eyes

about six metres away from the tree."

George said he survived on two sandwiches and tied himself to the tree so he would not fall out while sleeping.

### **Detainees** held by US in Iraq at record high

Washington, 16 Aug— The US "troop surge" in Iraq have boosted the number of detainees held in US facilities in Iraq to roughly 23,000, up 5,000 from four months ago.

Army Colonel Mark Martins, the top military lawyer in Iraq confirmed it to Wednesday's The Washington Post.

That number represents an all-time high since the US occupation began in 2003. Meanwhile, Iraqi forces during the "surge" have picked up 4,052 more detainees, bringing the overall number of security detainees held in Iraqi prisons to 60,000.

## British farm sealed off, FMD suspected

London, 16 Aug—Britain set up controls around a farm in southern England on Tuesday because of a suspected case of foot and mouth disease, raising fears an outbreak of the livestock disease may not have been contained.

Animal health experts were investigating the suspected case as reported in Kent, to the east of Surrey where hundreds of animals were culled earlier this month after the highly infectious animal disease was found there, officials said.

Authorities hope they have contained the outbreak in Surrey but confirmation of a case in Kent would be a blow to Britain's agriculture industry.

"We are setting up a new temporary control zone for foot and mouth disease in Kent," said a spokeswoman for the Agriculture Ministry Defra.

"This is not unusual. We are being ultra-cautious in our response to the disease and this new temporary control zone demonstrates the need for relentless vigilance."

## Britain's biggest lottery win claimed

London, 16 Aug— Someone in Britain is a lot richer on Tuesday after claiming the country's biggest ever lottery win — 35,425,411.80 pounds (71.64 million US dollars).

The winner matched all five main numbers and both lucky star numbers, 23, 40, 42, 43, 49, plus 2 and 6, to claim the entire EuroMillions jackpot from the August 10 draw.

Camelot, which operates the British arm of the trans-European lottery, said the lucky ticket holder had now come forward and the prize had been paid out.

"It is the largest jackpot won by a British person," a spokesman said. Camelot said no further details would be given out unless the person agreed to publicity.

The amount dwarfs the previous biggest British EuroMillions win by Marion Richardson, from Gateshead, northeast England, who netted 16.8 million in April 2004.

The largest jackpot the game produced was 126 million pounds, shared between two winners from France and one from Portugal in February last year.

The previous biggest-ever non-rollover lottery win in Britain went to Paul Maddison and Mark Gardiner in June 1995 when they scooped 22.5 million pounds on the Lotto game. —MNA/Reuters

# Pakistan warns US on damage to relations

Islamabad, 16 Aug— A US law linking aid to Pakistan to progress in the fight against militancy and some comments from US politicians were detrimental to cooperation between the countries, Pakistan said on Wednesday.

The warning on relations between the United States and one of its most important allies in the fight against terrorism came in talks in Islamabad between Foreign Minister Khur-sheed Mehmood Kasuri and US Assistant Secretary of State Richard Boucher.

"The Foreign Minister ... stressed that certain recent statements were counterproductive ... (and) also expressed concern regarding the recent US legislation," the Foreign Ministry said in a statement.

The ministry did not elaborate on statements but relations with Pakistan have become a hot topic in the US presidential election campaign.

Barack Obama said this month that if elected, he would be willing to attack al-Qaeda militants inside Pakistan without the approval of its govern-

US President George W Bush described talk of such action as "unsavoury" and said he respected Pakistan's sovereignity.

But Bush also signed into law a bill on implementing the recommendations of the 11 September commission, which contained the provision tying aid to Pakistan to its progress in cracking down on al-Qaeda and Taleban Democratic candidate | militants.—MNA/Reuters

### Five US personnel killed in Iraq helicopter crash

BAGHDAD, 15 Aug — Five US service personnel were killed when a military transport helicopter crashed during a routine flight west of Baghdad on Tuesday.

The crash takes the death toll for the US military to 10 in the past two days. The US military said the CH-47 Chinook helicopter crashed near its al-Taqaddum Air Base outside Fallujah, 50 kilometres (30 miles) west of Baghdad, while conducting a "routine post-maintenance check flight".

There was no indication whether it was shot down. An investigation is under way. The deaths of the five on board the helicopter takes the total number of US military personnel killed in Iraq since the 2003 invasion to topple Saddam Hussein to at least 3,699. So far in August at least 41 US service members have died, compared with a total of 71 for July. — MNA/Reuters

Moscow, 16 Aug—A | *Interfax*. hunter and herdswoman from Arctic Russia hopes to claim the title of the world's oldest living person following new research, Interfax news agency reported on Tuesday.

Staff in the national archive in Russia's remote province of Yakutia have found church records proving that Varvara Semenni-kova was born in May 1890, which makes her 117, reported

Semennikova would be older than Japan's Yone Minagawa, who was recognized by Britain's Guinness Book of World Records as the world's oldest person.

She died on Monday at the age of 114.

# **Indian to invest \$6b** in agriculture

New Delhi, 16 Aug-Indian Prime Minister Manmohan Singh said on Wednesday that the government will invest six billion US dollars in the rain-dependent agriculture in a bid to promote the country's economy.

"We will also focus on the needs of our farmers in dry and drought prone regions. I am touring a few states to personally review the agricultural country," Singh said.

Singh, popular as the architect of India's economic reforms as its Finance Minister in the 1990s, warned against over-confidence from the booming economy as pointed to numerous challenges facing the nation. "India cannot become a nation with islands of high growth and vast areas untouched by

situation across the | development, where the benefits of growth accrue only to a few," he said.

> Singh spoke about the need for sustained growth as he pledged six billion US dollars to bolster the country's ailing farm sector. "Our growing economy and population need more food grains. I am confident as we roll out our ambitious agricultural development programme. We will see a boost in food grain production in all parts of the country, particularly in regions untouched by the first green revolution," he said.— MNA/Xinhua

# Thailand, Laos agree to boost trade

BANGKOK, 16 Aug— Thailand and Laos have joined forces to double their total trade value by 2010 and will organize an expo to promote their products at the beginning of next month.

Thai Commerce Minister Krirkkrai Jirapaet and Nam Viyaket, Lao Minister of Industry and

Commerce recently endorsed an agreement to boost the level of economy, trade, and investment between the two countries, the Thai News Agency reported on Wednesday.

The two sides plan to double the value of their mutual trade within 2010 and triple the value of Lao exports, including electricity to Thailand, in 2010.

The Thai Ministry of Commerce also plans to organize a Thai- Indochina Trade Fair 2007 beginning 31 August through 9 September at the city hall in Thailand's northeastern province of Ubon Ratchathani to promote trade between the Mekong countries.

## **CNOOC** signs sharing contracts with US Newfield in S China Sea

Beijing, 16 Aug—China National Offshore Oil Company Limited (CNOOC Ltd) announced Wednesday that its parent China National Offshore Oil Corporation (CNOOC) has signed two production sharing contracts (PSC) with US-based Newfield Exploration Company. The two contracts are for blocks numbered 22/15 and 16/05, both in the South China Sea.

Block 22/15 in the Beibu Gulf Basin in the western South China Sea covers 5,228 square kilometres, with water depth of 10 to 60 metres.

Newfield will reprocess the two-dimensional seismic data, a technical survey containing geological clues for hidden oil fields, and conduct drilling operations.

Located in the Pearl River basin, block 16/05 covers 2,064 square kilometres.

CNOOC and Newfield had signed a geophysical survey agreement on this block in 2005, under which Newfield committed to exploration drilling.

## Vietnam mulls more rice exports

Hanoi, 16 Aug—The Vietnamese Government is considering allowing additional rice export contracts to be signed next month due to the surging commodity prices in the world, local media reported Wednesday.

The government put a halt on rice exports after

official targets were met earlier this year, but the rising global commodity prices have driven the Vietnam Food Association (VFA) to ask the government to reconsider the policy, Vietnam News reported. The government has targeted a rice export volume of 4-4.5 million tons this year to ensure domestic food security. As of the end of July, the country has signed export contracts of 4.5 million tons of rice, including 1.85 million tons which will be delivered early next year, said the VFA. Vietnamese rice is now being exported at about 292-312 US

dollars per ton, up 30-40 dollars com-pared to two months ago. The VFA predicts the rice prices to continue climbing as global supply declines. The Ministry of Agricultural and Rural Development estimates that the output of paddy rice in Vietnam will reach 36 million tons this year, of which 4.9 million tons will be commercial rice for export. Asia is the main export market of Vietnamese rice, accounting for 76.6 per cent of total volume, while Africa and the United States consume about 14.3 per cent and 5.9 per cent, respectively.—MNA/Xinhua

the Panel of Chairman of the NC plenary session on the suggestions of the delegate groups.

### Esteemed delegates,

At the plenary session of the National Convention held on 6 August 2007, the Work Committee said, " The plenary session of the National Convention held on 16 September 1993 adopted the 104 State fundamental principles for the Chapter—The State fundamental principles. Based on the given adopted fundamental principles, the detailed basic principles for the remaining chapters were laid down and adopted. In other words, the fundamental principles have been adopted as the general guidance of the State to be observed and followed. The State will carry out the legislative and executive functions in accord with the fundamental principles. In doing so, the State will implement the functions in accord with the nation's prevailing situation and time. The running of the legislative and administrative machinery may face disturbances and obstacles if a lawsuit is filed against the State while taking advantage of its failure to implement the task in accord with said principles as time and situation is not ripe yet. In our view, it is necessary to adopt a detailed basic principle that will protect the State. The section 32 of the Chapter IV of



the 1947 Constitution stated "The principles set forth in this Chapter are intended for the general guidance of the State. The application of these principles in legislation and administration shall be the care of the State but shall not be enforceable in any court or law". A similar statement is also stipulated in the constitutions of some neighbouring nations."

According to the statement, it is as if that the term "State" contained in the detailed basic principle concerns only with the Chapter "Citizenship, Fundamental Rights and Duties of Citizens".

"The section (9) of the Chapter (II) of the 1947 Constitution stated "In this Chapter and in Chapters III and IV, the term 'State' means the executive or legislative authority of the Union or of the unit concerned according as the context may require." Similar stipulation can be found in the constitutions of some neighbouring countries.

"The term "State" can be found in the Chapter I "State Fundamental Principles" for many times. In our assumption, an addition should be made to the para 50 for the detailed basic principle to cover the interpretation and definition of the term "State" of the given chapter.

"The para refers only to the term "body". There may be occasions in which the legislative power and executive power are exercised by an organization or by a person. In this situation there may be a constitutional problem. They may be no reason for the occurrence of any disputes if the stipulations contained in the detailed basic principle are fully comprehensive.

"Based on my above presentation, delegates will have discuss whether or not the para 50 of the Chapter "Citizenship, Fundamental Rights and Duties of Citizens"—"In this Chapter, the term "State" means a body that exercises legislative and executive powers by this Constitution according as context may require."should be amended as follows:

"In this Chapter and Chapter 1 State Fundamental Principles, the term "State" means a body or a person that exercises legislative and executive powers by this Constitution according as context may require." Esteemed delegates,

In connection with the qualifications of the Chief Justice of the Union and Judges of the Supreme Court of the Union, the para (3) (c) (iii) states "have been an advocate of a High Court of at least 20 years' standings". The statement was to indicate the least required period for the said matter.

"In connection with the qualifications of the Chief Justice of the High Court of Region or State Chief Justice and judges of the High Court of the Region or State, the para 11 (c) (ii) states "a person who has served as advocate for 15 years". The stipulation does not state the word "at least".

"In drafting the Constitution, it should be stated "at least 15 years" to ensure a harmonious context and to prevent against occurrence of disputes in the future.


"Hence, delegates should discuss whether or not the detailed basic principle 11 (c) (ii) "a person who has served as advocate for 15 years" should be amended as "a person who has served as advocate for at least 15 years." **Esteemed delegates,**



# Sri Lanka wants UN to clarify dangerous place claim

reporters.


The government has taken strong exception to a statement made by Sir John Holmes, the UN Emergency Relief Coordinator and Under Secretary-General of Humanitarian Affairs last week to the effect that Sri Lanka was one of the world's dangerous places for aid workers. He backs his claim citing that 34 aid workers had been killed in the island since 2006.

"As for the government we only know of just 19 aid workers being killed. So we want to know how the figure of 34 had been arrived at", Rambukwella asserted.

Holmes was in the island on a three-day visit where he visited the northern Jaffna Peninsula and parts of the island's eastern province.

Holmes Press comments have drawn an angry reaction from the government.

### Roadside bombing attacks convoy of German **Embassy in Kabul**

Kabul, 16 Aug — A roadside bombing attacked a convoy of German Embassy to Afghanistan on Wednesday morning in Kabul and caused some casualties, Brenda Steele, a Press officer of the NATOled International Security Assistance Force (ISAF), told Xinhua.

The explosion killed three persons and injured one in eastern Kabul, Alishah Paktiawal, deputy Kabul police chief, told Xinhua.

He said the bombing was attacking a German convoy, but he did not say the casualties were foreigners or Afghans.

An official from the German Embassy, told Xinhua that there was "an incident" related to the embassy.

A Xinhua reporter saw that Afghan police and ISAF have blocked the road leading to the explosion site. — MNA/Xinhua

## Appeal to burglars' bellies backfires in Germany

Berlin, 16 Aug — A cottage owner in Germany tried to ward off burglars by leaving canned foods on her doorstep, but robbers found the offerings so tasty that they broke into the house to get second helpings, German police said on Tuesday.

The woman who owns the cottage and adjacent garden in Brunswick, western Germany, had left a note for potential burglars not to bother breaking into her cottage but to help themselves to the canned foods on her doorstep, police said.

"The polite appeal that they treat themselves apparently just increased the appetite of the hoodlums," the police said in a statement.

"The perpetrators not only took the canned foods but broke open the door and took cucumber salad and sausages." Petty robbery of summer cottages in Germany is not uncommon since the owners often visit them only weekends. — MNA/Reuters

### **US Army records highest** suicide rate in 26 years

WASHINGTON, 16 Aug—The US Army's suicide rate is at the highest level in 26 years, a latest military report has found.

The report, obtained by US media on Wednesday, said 99 active-duty Army soldiers killed themselves in 2006, the highest number since 1991.

Among the soldiers who committed suicide last year, nearly one fourth were serving in either Iraq or Afghanistan.

The report pointed to an apparent link between soldiers' suicides and the days they were deployed in

"Multiple deployments are a risk factor for suicide behavious," it said.

Previous reports also found more and more US soldiers developed symptoms of mental disorders after returning from Iraq. — MNA/Xinhua

### Suspected militant leader nabbed in Thai south

BANGKOK, 15 Aug— A suspected leading militant was arrested Monday after a 500-man combined government force raided his house and seized a number of guns and ammunition in Thailand's far southern province of Pattani.

Government forces before noon surrounded a village house owned by Hama Buenae in Pattani's Mayo District and seized eight guns, ammunition, electric wire and an iron pipe from his house, according to the *Thai News Agency*. Authorities believed that Hama was a key militant leader operating in the village and had taken him for interrogation at an Army camp, the report said. —MNA/Xinhua

### Italian journalist dies after Paris mugging

Paris, 16 Aug—An Italian sports journalist died in a Paris hospital from a serious head injury suffered when he was mugged at a Paris metro station, police said on Wednesday.

Sergio Vantaggiato, 40, who was pronounced brain dead shortly after his admission to St Louis Hospital on Sunday, was officially declared dead at 2155 GMT on Tuesday, a police official said.

Police are hunting two men who snatched the Italian's back pack at the Bir-Hakeim metro station near the Eiffel Tower. — MNA/Reuters



# Polish soldier killed in Afghanistan

"Polish soldiers will die in Afghanistan. But we

will not back down. We have become a serious enemy of the Taleban and we will fight back," Polish Defence Minister Aleksander Szczyglo said in an interview on Tuesday morning.

Security Assistance Force in Afghanistan.

## **Death toll from suicide bombings** in N-W Iraq rised to 500

Mosul (Iraq), 16 Aug—The death toll from four apparently coordinated suicide car bombings near Iraq's northwestern town of Sinjar late Tuesday rose dramatically to 500, while 375 others injured, hospital official told Xinhua on Wednes-

"We have received 500 corpses and 375 others injured people," said Dr Kifah Muhammad, the manager of the hospital in Sinjar, a town in western Nineveh Province.

He added that the death toll could rise further rescue workers continue to ferry the victims to the hospital.

The newly obtained figure from the hospital doubled the death toll Xinhua earlier got from a local police source, which said that 250 people were killed and 300 others

Late Tuesday, four suicide car bombs, apparently targeting residents from Iraq's Yazidi religious minority, ripped through Yazidi residential compounds in Kahtaniya and al-Jazeera near Sinjar.

The Yazidis are primarily ethnic Kurd and mostly live near Mosul, capital of Nineveh Province.—MNA/Xinhua

## Kidnapped Belgians freed in Iraq

Brussels, 16 Aug — A Belgian man and woman kidnapped in south-eastern Iran at the week-end have been released, a Belgian Foreign Ministry spokesman said on Tuesday.

An Iranian official was quoted on Monday as saying they had been abducted by a bandit group led by a man named Ismael Shahbakhsh who demanded that his jailed brother be freed in return for their release.

"The mother of one of the two people was in contact with her son this afternoon. He said he was safe and in good health, and it was the same for the other person," the Foreign Ministry spokesman said.

The spokesman said an envoy from the Belgian Embassy in Teheran would be sent as soon as possible to the city of Bam to help the two Belgians.

Iranian news reports had said the two had been travelling by car in an area between Bam and Iran's border with Afghanistan and Pakistan when they were seized.

The man's mother said the two were now in a

safe location some 150 kilo-metres (90 miles) south-west of where they were kidnapped, the spokesman Belgian

Iran signalled before the release that it would not give in to the demands of kidnappers and had tightened border controls to prevent them from being taken out of the country, Iranian media reported.

They could only meet once a year on the seventh day of the seventh month of the lunar calendar, when thousands of magpies form a bridge to allow them to cross the galaxy.

Chinese started to pray for good lives and love on the festival in the middle of Han Dynasty (202 BC to AD 220).

The proposal was made by scholars and business people at a conference held by the Chinese Folk Literature and Art Society in Beijing.

"With the rapid development of China's economy, traditional Chinese festivals such as Qixi have faded from the memories of many Chinese," said Professor Zhang Yiwu, of Peking University. —MNA/Xinhua

## Bangladesh flood death toll nears 500, thousands ill

DHAKA, 16 Aug— At least 38 more people died overnight in Bangladesh, including two from waterborne diseases, raising the death toll in the low-lying country's worst floods in recent years to nearly 500, officials said on Wednesday.

The flood waters that have also inundated large

parts of eastern India have since receded, but millions remain homeless and vulnerable to disease, aid officials said.

More than 53,000 people have contracted diarrhoea in Bangladesh, mostly caused by eating stale food and drinking impure water.

A field hospital has

been opened in the capital, Dhaka, to treat diarrhoea patients.

"The overall diarrhoea situation is grim. Everyday there is a rush of patients," said Ayesha Khatoon, a senior official at the government's health directorate. "We are trying to cope with it."



"Not only would the Revolutionary Guards not be isolated but rather it would actively continue its trend of growth with strength," the head of the political office of the Guards, named only as Javani, was quoted by the daily Jam-e Jam as saying.

"Americans have been fighting the Islamic system for 27 years and create plots against it. But the Revolutionary Guards have made defending the Islamic system its duty and will increase its capabilities in this regard day by day," he added.

Iran experts and diplomats said the squeeze on financing for the Guards also was aimed at pacifying hardliners within and outside the Bush Administration who want military action against Tehean and are frustrated that diplomatic pressure has not worked either on curbing the nuclear programme or over Iraq.— MNA/Reuters




# Progress of hydropower projects supervised
