MARRIAGES SOLEMNIZED BY GIDEON LEE, MAYOR OF NEW YORK CITY, 1833-1834

The authority to solemnize weddings in civil ceremony has been vested in both executive and judicial officers at times, but the recording of such weddings and the preservation of the records by local government was uncommon in New York State until relatively recently. Papers of most officials were considered to be their personal property and remained in their custody when they left office, whereafter their preservation or destruction became a matter of luck and personal whimsey.

Gideon Lee as Mayor of New York City from 2 January 1833, to 13 May 1834, solemnized a number of weddings which were recorded in a copybook. The book remained in Lee's possession after he left office, eventually passing with other papers from his descendants to a manuscript dealer. *The Record of Marriages*, as it is entitled, has been located among the collection of Gideon Lee Papers recently acquired by the New York State Library in Albany. Twenty weddings performed by Gideon Lee are listed. The records, including the copies of signatures, are all in the same handwriting, which is easily deciphered except that in a few instances the capital letters L and S are virtually identical in appearance.

In each entry the Mayor states that the marriage partners "were satisfactorily proven to me to be the persons described . . . that they are of sufficient age to contract Marriage and . . . there appeared no lawful impediment to such Marriage." The following abstracts include all the information concerning the marriage partners and witnesses which is given in the register.

188. John⁸ Devereux was born Dec. 15, 1819, in Raleigh, N. C., and died there April 10, 1893. For his preliminary education he was sent north to the Round Hill Academy at Northampton, Mass., and later entered Yale College from which he was graduated in 1840. On the death of his grandfather John Devereux in 1844, he inherited a large plantation called *Runeroi* in Bertie County, which was part of the original Pollock Crown grant. Like many other southerners he was first opposed to Secession, but when it became inevitable he gave himself, heart and soul, to the cause of the Confederacy. In May 1861 he was sent by Gov. John W. Ellis to purchase supplies in the eastern counties; later that year he was commissioned staff captain and assistant quartermaster and eventually became Quartermaster-General of the state. Throughout the entire period of the Civil War he acted as quartermaster of the North Carolina troops with the rank of Major and he became a close friend of Gov. Zebulon B. Vance who held office from 1862 to 1865, and they worked in hearty accord.

The Civil War ruined the southern planters; their slaves were freed and labor was hard to secure. As was the case with other families, the inherited properties of the Devereux family passed into other hands; the dikes along the Roanoke River were neglected so that the country was exposed to constant flooding, with the result that these once rich farm lands became a marshy waste, as they are today. After the War Major Devereux engaged in the general insurance business in Halifax County, but still maintained his home in Raleigh as his business took him to many parts of the state. On May 25, 1842, he married there Margaret Mordecai who was born there Oct. 1, 1825, and died there March 10, 1910, a daughter of Moses Mordecai and his second wife, Anne Willis Lane.

Moses Mordecai, the father of Mrs. Devereux, was a native of Warren County, N. C., and the third generation in descent from Moses¹ Mordecai, a cultured Jew who was born in 1707, arrived in America about 1750, and settled in Philadelphia. While still in England he married Elizabeth Whitlock who became a convert to the Jewish faith. He was one of the signers of the Non-importation Resolution against England adopted in Philadelphia, Oct. 27, 1765. His son, Jacob² Mordecai, was born there April 11, 1762, and died in Richmond, Va., Sept. 4, 1838. On June 16, 1784, he mar. (1st), Judith Myers b. May 8, 1762; d. in Richmond Jan. 9, 1796, a daughter of Myer Myers and his first wife Elkalah Cohen. On March 21, 1798, he mar. (2nd), her half sister, Rebecca Mears Myers b. April 26, 1776, in Norwalk, Conn.; d. Oct. 1, 1863, in Richmond, a daughter of Myer Myers by his second wife, Joyce Mears.

Jacob² Mordecai was first employed in the office of David Franks in Philadelphia, where he learned valuable mercantile experience, and in

1781 moved to New York City. After several years' stay there he settled at Warrenton, North Carolina, where he was at first a merchant and later became principal of the Warrenton Female Seminary. Jacob and both of his wives were buried in the Hebrew Cemetery in Richmond where their inscriptions read as follows: (a). "In memory of JACOB MORDECAI born 11th day of April 1762, Died 4th Sept. 1838"; (b). "Sacred to the memory of MRS. JUDITH, Wife of Jacob MORDECAI, who was summoned hence to receive the recompence of the Good, on the 9th of January 1796, aged 33 years"; and (c). "REBECCA MORDECAI, relict of Jacob Mordecai, Born April 26, 1776, Died October 1st, 1863." (The Hist. of the Jews of Richmond from 1769 to 1917, pp. 23-25; Myer Myers, Goldsmith, 1723-1795, pp. 60-64).

Moses³ Mordecai read law with George Fitts, Esq., and settled in Raleigh where he became one of the most able lawyers in North Carolina. He was married twice, his wives being sisters; the first was Margaret Lane, and the second Anne Willis Lane, children of Henry Lane and Mary Hinton. The latter was a daughter of John Hinton of *Clay Hill* on the Neuse River. The father of Henry Lane was Col. Joel Lane who removed from Halifax County to Wake County, prior to the Revolution. The latter was one of the wealthiest and best known men in the state of North Carolina, being a member of the Provisional Council which met at Hillsboro Aug. 21, 1775, and a State Senator from Wake County for several terms. He built a house on what is now Hillsboro Street in Raleigh, and in which the General Assembly met in 1781. Col. Lane, on April 4, 1792, conveyed 1,000 acres of land to the state of North Carolina, immediately contiguous to his home, at Wake Court House, as the spot was then known, and upon this land the present capital city of Raleigh now stands. Major John Devereux and his wife, Margaret Mordecai had two sons and six daughters:

Children: 8 (all but the 6th b. in Raleigh):

240. i. Anne Lane⁹ Devereux b. Oct. 10, 1843; d. unmar. April 26, 1912, in Raleigh. Educated at St. Mary's School there, and at Miss Haines' School on Gramercy Park, New York City, she spent all of her life in Raleigh where she taught at St. Mary's School for many years.
241. ii. Thomas Pollok⁹ Devereux b. Nov. 8, 1845; d. in Morganton, N.C., in November 1912, unmar. He was educated at the Virginia Military Institute, often known as the West Point of the Confederacy, and, at the time, under the superintendency of Gen. Francis H. Smith. In 1862 he left there and enlisted as a Private in the Forty-second Regiment of North Carolina Infantry. He was detailed as a Courier to Gen. Lucius Daniel, who was killed at Spottsylvania, and later to Gen. Bryan Grimes, under whom he went through the "Valley" Campaign. He was at the defense of Petersburg, where he personally rallied the Brigade, and took part in the last charge at Appomattox. Following Gen. Robert E. Lee's surrender and the end of the war, Mr. Devereux returned

William Thorne's share is shown elsewhere as "Laid out to the Patent Right of William Thorn Sen ye following parcells of Land, viz.,

To Robert Mitchell [description] 134 [acres]." The total of land acquired by William Thorne under patent rights was about 158 acres (Ibid.:427, 494).

On Oct. 3, 1681, William Thorne signed with his own hand a request by John Lokison for a "peace of Commons" (Ibid.:1:479 & Rec., v. 91, p. 66). He had evidently learned to write; but thereafter his wife Winnifred, his son William³, and his daughter Elizabeth³, as will presently appear, all signed with the same mark "W" that William Thorne had subscribed to the Flushing Remonstrance.

On July 21, 1682, Thomas Whitlock of Westchester assigned to William Thorne of "Mad nans Neck" a parcel of meadow in Westchester which he had bought from Thomas Vaile, and in a separate assignment of the same date released two hummocks of meadow he had bought from John Jennings. These instruments were recorded March 18 and 20, 1698/9, respectively (Westchester Co. Deeds:B:395-96). On May 20, 1683, Edmund Titus conveyed to "Will Thorne of Mad nans neck" a "lott of land on the east side of said neck in number fifty-nine and in quantity of acres thirty three as it was at the first layd out by the surveyors so appointed." As recorded on July 8, 1699, the deed is to "Wilt Thorne," written over to read "Will Thorne" (Queens Co. Deeds:A:143). The spelling "Wilt" which, as noted above, appears also in the Dutch Church records in New York City may represent a distinctive British accent, and afford a clue to the English locality from which the Thornes came.

William Thorne's modest establishment appears from:

An Account of Ye Valluation of the Estates of the Inhabbitants of ye Towne of Hampsted on Long Island: is as Followeth October 11th: 1683
William Thorne 1 head [of family] 16 [acres] of Land and meadow 02 Oxen 04 Cowes 03 three year oulds 02 two year oulds 04 years oulds 03 hoggs 02 Horses and majors [mares] (DHNY:2:523, 527).

This is clearly the inventory of a pioneer farm, not of a country gentleman's estate. Presumably the number of acres included land under cultivation or otherwise improved rather than total holdings.

Hempstead was noted for controversy in early days.

Hempsted March ye 1st 1683-4

At a Towne Court to be held by the Commissioners on Wednesday the 6th of March by his Royall Highnesses Authority:

Winnifruit Thorne Pl. enters an Action of Defamacon Against Hannah Cornwall Deff'd at the same Court Winnifruit Thorne ye wiffe of William Thorne enters an Action of ye Case against Hannah Cornwall deffendant ye wiffe of John Cornwall.

In a Cacese Depending betweene winyfruit Thorne Pla't ye wiffe of William Thorne and Hannah Cornwall ye wiffe of John Cornewall Deffe't the Court grants A Nonsuite against ye plantive with Cost of Suite (Hempstead Town Rec.:1:423).

Our English inheritance of irrational spelling and legal verbosity appears to have crossed the ocean with the earliest settlers. But perhaps the New York Dominie and the Hempstead Town Clerk spelled Winnifred Thorne's name very much as she pronounced it.

On April 26, 1685, "William Thorne: Se:" registered an earmark for his livestock (Ibid.:2:115), and on July 11, 1691, with many others, signed a petition for John Stuard who was "willing to settle amongsts you to follow ye tread of a coper as allso to practis ye art of Sergerly" and "very Redy and willing to Serve you in Ether of ye arts afore sd" (Ibid.: 110).

On June 7, 1697, "We whose names are here under written do give our consente that John Treadwell Senr. shall have liberty to joyn his land he bought of Slidwell to the land that was formerly John Hickers." The document is signed by a number of residents of Madnans Neck, including William Thorne, "Richard Thorne his mark", William Thorne Junr and "IT John Thorne his mark" (Queens Co. Deeds:B:396). Richard Thorne and William Thorne, Ju., as shown below, were sons of William Thorne. No doubt John Thorne was a son also.

The Hempstead Census of 1698 lists the Thornes as follows (Rec.:45: 54 & 62):

The first three persons are readily identified as William Thorne, his wife, and son Richard. William Wood, who has not been identified, may have been a relative, but just as probably an apprentice or hired man. The three Motts were a son-in-law, daughter, and their first child. The five Thornes at the top of the second column were William Thorne's eldest son William, the latter's wife, and their three small children. Of the remaining, Mary Danells, who signed the release to John Treadwell noted above as "o Widow Daniell her mark," appears to have been the head of a household comprising herself and three Thornes, one of whom,

She mar. by New York License dated Oct. 14, 1696, Richbell Mott, a son of Adam Mott of Hempstead and his third wife, Elizabeth Redman. On Aug. 30, 1693, Elizabeth Thorne was a witness to a certification by Josias Starr that he had "Reseved full satisfaction and pay for 12 yarges of serge yt Gorge fowler was indepted to mee," and she signed with the usual "W" that had become the mark of the Hempstead Thornes (Hempstead Town Rec.:8:230). In his will, executed Sept. 22, 1734, and proved Dec. 3, 1734, Richbell Mott of Hempstead remembered his wife Elizabeth with £20 annually, and she was to have the use of the farm on Madnan's Neck. He likewise made bequests to the children named below, except Margaret and Richbell, who presumably had died; provided for the sale of the home farm, and the distribution of £600 of the proceeds among the children; and directed that the "Irish servant boy, David, is to have at the end of his term, a good homespun suit of apparell, besides his everyday clothes, and a narrow axe... and I would have my son Richard instruct him as far as he can in his learning." Four grandsons were made residuary legatees: Richbell, son of Adam Mott; Richbell, son of Edmund Mott; Richard, son of Joseph Mott; and Joseph, son of Joseph Mott (WNYHS:3:163).

Elizabeth Mott of Hempstead in her will dated March 7, 1737, and proved April 16, 1739, named the same children as her husband, together with the heirs of her daughter Margaret; granddaughter Phebe, daughter of Stephen Wood; daughter Jemima Wood; Stephen Wood; grandson Daniel Kissam; cousin Phebe Thorne, daughter of Richard Thorne; cousin Mary Pudney; granddaughter Mary Treadwell; and granddaughter Elizabeth, daughter of Adam Mott. She added "and I desire I may be buried at Thorns burying place," and named "loving Kinsman Richard Thorne," (her nephew no. 52), as executor (Ibid.:3:260). Richbell & Elizabeth (Thorne) Mott had three sons and seven daughters:

- (a) Edmund^s Mott b. —; mar. Catharine Sands, a daughter of Capt. John & Sybil (Ray) Sands.
- (b) Margaret^s Mott b. —; d. not later than 1734.
- (c) Richbell^s Mott b. —; d. abt. 1724, probably unmar.
- (d) Richard^s Mott b. —; mar. Sarah Pearsall, a daughter of Thomas & Sarah (Underhill) Pearsall.
- (e) Elizabeth^s Mott b. —; mar. Adam Mott, a son of Adam & Mary (Stillwell) Mott.

- (f) Mary^s Mott b. —; mar. John Treadwell, a son of Thomas & Hannah (Denton) Treadwell.

10. iv. Hannah^s b. abt. 1670; d. between 1701 and 1705, possibly in New York City. She mar. before 1698, Samuel Ward b. abt. 1670; d. 1706, a son of Samuel & Hannah (Ogden) Ward of Fairfield, Conn. (Ogden Gen. 1907, p. 10; Ward Fam. 1910, p. 30, no. 30). On March 6, 1696/7, Thomas Bedient of Westchester sold to "Samuel Ward, late of Fairfield," a house and a house lot containing nine acres at Eastchester, together with "one acre of meadow in the Pines" (Westchester Co. Deeds:B:380). Eastchester is on the mainland directly across Long Island Sound from Flushing and Hempstead. Formerly a village in Westchester County it has now been absorbed in part into the Borough of the Bronx, New York City.

On Dec. 27, 1698, Samuel Ward of Eastchester and Hannah his wife sold the property, referred to above, to Joseph Drake (Ibid.:397). On Feb. 11, 1698/9, William Chadderton of Eastchester sold to Samuel Ward "a peece of upland at a place commonly called Little Ease" in Eastchester, containing ten acres (Ibid.:391). On March 13, 1698/9, William^s Thorne no. 7, as previously stated, quitclaimed to "my brother Samuel Ward of Eastchester" a meadow in Westchester, which appears from the description to have been the property which Thomas Whitlock assigned to William^s Thorne no. 2, in 1682. As previously noted, the original instrument was not recorded until March 18, 1698/9, and the quitclaim to Samuel Ward was entered two days later. Possibly William^s Thorne, as the eldest son and heir, was settling the estate of his father, who may have recently died, and was clearing title to land the latter may have transferred to his son-in-law Samuel Ward, or to his daughter Hannah.

Several other land transactions in which Samuel Ward and his wife were both involved are recorded in Westchester County Deeds during the next several years. By the last, on May 1, 1705, without a wife's signature, Samuel Ward of Eastchester sold to Edmund Ward (his brother), of the same place, "all that my 5 acres adjoining" the latter's property (Ibid.:378). Presumably Hannah (Thorne) Ward died before the above date. Samuel Ward does not appear in the New York City Census of 1703, but the "one female" in the household of John Thorne no. 8 may have been the latter's sister Hannah, rather than his mother. Samuel Ward is said to have died in 1706 (Fams. of Old Fairfield, v. 1, pp. 647-48).

The family of Samuel Ward appears in the Eastchester Census of 1698 as follows (Rec.:38:134):
