Dear Secretary Foxx:

I am writing to express my strong support for the Willmar Rail Connection and Industrial Access Project for consideration in the 2105 TIGER grant program.

Due to the dramatic increases in Bakken oil shipments and those of other commodities, rail traffic in Minnesota has grown significantly over the last few years. As a result, rail safety and improvements are one of my highest priorities. I proposed a significant investment in railway safety in the 2015 legislative session. However, partnership with the federal government will be critical to resolving these issues long-term.

The Willmar Rail project is the result of a public private partnership, including the City of Willmar, Kandiyohi County, Kandiyohi/Willmar Economic Development Commission, MnDOT and BNSF. The project will:

- Reduce the number of train trips that cause traffic delays at rail crossings in Willmar;
- Improve local and regional rail system operational efficiency, fluidity, optionality and connectivity;
- Alleviate increasing congestion and accommodate additional projected growth on the local and regional rail network; and
- Facilitate rail-served development in the Willmar Industrial Park and enable local economic development.

Currently, 10 to 14 trains travel through Willmar on a daily basis. The Willmar Rail Connection and Industrial Access Project will reroute 7 to 10 trains (14 to 20 train trips) around Willmar each day. Every train movement can block

crossings in Willmar's downtown business district for up to 30 minutes. The project will significantly improve local residents' access to Willmar's business district.

In addition, the project will improve shippers' access to rail service, providing additional and less costly shipping options. Minnesota's Department of Transportation has estimated that the project will return three times its investment in benefits to this rural community and region.

The innovative project represents the best in public/private collaboration and will enhance the safety, accessibility, efficiency, and reliability of the transportation system in Minnesota and throughout the region.

I am writing to express my strong support for the Willmar Rail Connection and Industrial Access Project's application for funding under the TIGER discretionary grant program. As detailed in the application, the project will enhance the safety, accessibility, efficiency, and reliability of the transportation system in Minnesota and throughout the region. The project's new wye and its connected rail spur would alleviate a significant bottleneck in the regional rail network, and enhance safety by reducing the likelihood of road-rail vehicle accidents.

As economic activity has increased in recent years, I have heard frequent concerns about both rail congestion and rail safety issues, and this project would help address both. A TIGER grant would leverage significant non-federal sources, including funding from its private sector beneficiaries. BNSF Railway is providing over one-third of the total project costs.

This project is the product of a long and collaborative process between the Minnesota Department of Transportation, the City of Willmar, Kandiyohi County, the regional Economic Development Commission, and BNSF. While the safety benefits would largely be felt in the Willmar area, the congestion relief would be felt across the state of Minnesotan and beyond.

I am writing in strong support of the City of Willmar, Minnesota's application for funding under the Transportation Investment Generating Economic Recovery (TIGER) Discretionary Grant Program. The proposed Willmar Rail Connector and Industrial Access Project clearly addresses the long-term standards of TIGER by resolving transportation issues that challenge the Willmar Community. First, the Willmar plan will bolster an inadequate transportation infrastructure in order to promote future industrial and economic growth. Second, community safety and livability will be improved. Finally, the plan will be environmentally sound.

These needs and the benefits provided by a successful TIGER application were identified by a five member public-private coalition, composed of the City of Willmar, Kandiyohi County, the Willmar/Kandiyohi County Economic Development Commission, the Minnesota Department of Transportation, and Burlington Northern Santa Fe (BNSF) Railway.

The Willmar Rail Connector and Industrial Access Project will solve a key deficiency in the area's rail system. Because of this, freight trains enter the downtown Willmar Rail Yard, change the direction of the train, and then depart. This procedure blocks streets and pedestrian crossings twice for every train, or they are routed elsewhere through the more congested Twin Cities of Minneapolis and St. Paul. Building the connector will reduce rail and automobile congestion in downtown Willmar, will allow for faster rail movement, and will increase efficiency at the Willmar Rail Yard. The project will also generate industrial growth and job creation by enabling the conversion of a decommissioned airport into a rail-served industrial park.

Local partners have already committed over \$118 million to address increasing transportation congestion issues in downtown Willmar. This project will facilitate future growth in the closed airport/industrial park west of Willmar's population base. The project will meet the objectives of the President's Ladders of Opportunity Initiative by attracting and retaining skilled workers in the region. In addition to projects already completed, the partners have dedicated over \$30 million in direct and in-kind contributions to construct the project and bring about positive, permanent change for the region, state, and national freight system.

BNSF Railway strongly supports the efforts of local and state leaders to secure \$15 million in TIGER funding for the Willmar Rail Connection & Industrial Spur. Originally spearheaded locally, this \$46 million project now represents a five-party collaboration of the City of Willmar, Kandiyohi County, their Economic Development Commission, Minnesota Department of Transportation, and BNSF. For its part, *BNSF pledges \$16 million in matching funds*.

This project significantly benefits local, regional, and national stakeholder groups:

- Community livability improvements from reduced train movements and crossing blockages in Willmar, enabling greater westward expansion of the City
- · Reduced air quality impacts from emissions at grade crossings
- Economic growth and family-wage job creation for this rural Minnesota city by creating opportunities for rail-served industrial development at a former airport site
- Improved rail system efficiency, flexibility, velocity, and capacity for the northern plains, particularly benefitting agricultural and industrial customers across the BNSF system

FRA provided guidance that this project is likely to receive a NEPA Categorical Exclusion, and the project partners are confident there are no significant environmental, property, or design risks to obligation of TIGER funds or construction. I am writing to express Minnesota Department of Employment and Economic Development (DEED) support for the Willmar Rail Connection and Industrial Spur application for TIGER 2015 funding. The Minnesota Department of Transportation, BNSF Railway, City of Willmar, Kandiyohi County, and Kandiyohi County and City of Willmar Economic Development Commission have formed a strong public-private partnership to develop a solution that addresses rail safety and economic development concerns in the Willmar area. These partners understand the importance of this project to the region and the State of Minnesota, and have together committed over \$30 million in contributions towards the project.

The project will make Minnesota more competitive by reducing freight congestion not only in Willmar, but around the entire State and the surrounding region. Eliminating this bottleneck in the Willmar rail yard will increase rail network fluidity and reduce congestion on other rail lines throughout the State. This letter expresses my strong support for the Willmar Rail Connector and Industrial Access application for TIGER 2015 funding. The Willmar Rail Connector and Industrial Access Project addresses some significant transportation challenges in Willmar, but I will focus on the public safety aspect.

The City of Willmar is geographically divided by the east / west rail lines through our community and also has a north / south line extending along the edge of our city limits. Due to placement of the Willmar Rail Yard, freight trains changing directions must stop and block vehicle traffic while switching tracks or attaching rail cars. Often the switching takes place with the trains having to block the crossings twice for each train, causing vehicle congestion and delay.

Within the city limits of Willmar, there are 11 separate streets that cross the railroad tracks. There are currently only two bridge crossings available within Willmar city limits for emergency vehicles to access the separate areas of town. An additional crossing is available about ¼ mile out of the city, but the limited crossings cause a delay in response by emergency services, which must often take a several block detour or routinely detour to an elevated crossing to ensure a timely response to an emergency.

The Willmar Rail Yard is also located next to a state highway and our downtown business district. The increase in trains carrying hazardous cargo through our city also creates additional concerns of security and safety to the public in those areas.

Under the proposed Willmar Rail Connector and Industrial Access application, the number of trains that could congest traffic and block intersections could be greatly reduced. The proposal also has the ability to limit the number of railcars carrying hazardous materials directly through our populated district and instead be rerouted to an industrial area. The overall benefit to our department would be the potential for decreased response times for emergency calls for service.

In support of the President's Ladders of Opportunity initiative, development locomotive power, and run around the train, place the power on the other end, and then proceed. Each such procedure can take up to 90 minutes. In addition to the crossing blockage at Wilmar twice by the same train, moving at slow speeds, this effectively reduces the capacity of the BNSF lines between Kansas City, Lincoln, Omaha and Sioux City to the mainline east west line at Wilmar. And in turn, this requires more routing of trains between Kansas City and points South and west via an already congested Galesburg, Ill classification yard and BNSF's mainline between Galesburg and the Twin at the industrial park will help attract and retain skilled workers to the region. In addition to projects already completed, the partners have dedicated more than \$30M in direct and in-kind contributions to construct the project and bring about positive and permanent change for the region, state, and national freight network.

Our own railroad has been adversely impacted by capacity constraints related to the current poor connection at Wilmar.. Presently, through trains connecting from the BNSF Lincoln – Omaha – Sioux City Lines have to pull into this yard, then cut off their Cities. We have seen our customer cars delayed several days in high peak times as a result.

In looking at the numerous benefits associated with this project, I strongly urge your favorable consideration of the Willmar Rail Connector and Industrial Access Project application for the TIGER 2015 Discretionary Grant funding program.
