Food security exists when all people, at all times, have physical, social and economic access to sufficient safe and nutritious food that meets their dietary needs and food preferences for an active and healthy life. The Food Security Committee will have three main pillars:

(i) Strategies and measures to achieve that goal shall be discussed by the Food Security Committee including:

- How to balance future demand and supply sustainably with potential focus areas on increase farm of productivity, reduction of food waste, and influence diets;
- How do we address price volatility for ag commodities with potential focus areas on volatility at the global and local level, correlation between energy and agricultural commodity prices;
- End Hunger with potential focus areas on investments in agriculture, direct interventions, revitalize movements to end hunger;
- Enable smallholders with potential focus areas on place of women, coops, technology; and
- Enhance environmental sustainability of Agriculture with potential focus on soil and water conservation,

(ii) Promoting aquatic resources as a topic in the global debate on food-related issues and how companies, government agencies, and NGOs should and can apply creative and adaptive procedures that support efforts to sustain marine and freshwater resources.

(iii) Providing input to the Food and Agricultural Organization of the United Nations on how to implement the Principles of Responsible Agricultural Investment developed and agreed upon by the UN Committee on World Food Security.



GENÈVE AÉROPORT (IATA: GVA, ICAO: LSGG)

Geneva International Airport formerly known as Cointrin Airport and officially as Genève Aéroport, is the international airport of Geneva, Switzerland. It is located 4 km (2.5 mi) northwest of the city centre and served 13,899,422 passengers and 192,944 aircraft movements in 2012. It is a hub for easyJet Switzerland and Darwin Airline as well as a focus city for Swiss International Air Lines including Swiss European Air Lines.

Its northern limit runs along the Swiss – French border and the airport can be accessed from both countries. The freight operations are also accessible from both countries, making Geneva a European Union freight hub although Switzerland is not a member of the EU. The airport is partially located within the commune of Meyrin and partially in the commune of Le Grand-Saconnex.

Terminal Operning Hours

Geneva airport has two passenger terminals, T1 and T2. Terminal 1, also known as Main terminal (M) is divided into 5 piers, A, B, C, D and F. All of the gates at Pier A, and some of the gates at Pier D, are Schengen gates. Passengers that board flights at those gates are not subject to passport checks. Gates at pier B, C, and some at pier D, are used for flights to destinations outside the Schengen area. Pier C is used primarily for widebody aircraft. Terminal 2 is used only for charter flights during the winter season. At all other times it is closed and handles no flights.

For security reasons the T1 terminal is closed from 00:00 am to 04:00 am.

The French Sector is closed from 23:00 pm to 04:30 am.

It is not allowed to stay inside during this time.



GETTING FROM THE AIRPORT TO THE HOTEL BY TRAIN

The airport offers connections to the Swiss and European rail network. The CFF airport railway station has direct access to the airport Check-in and Arrival levels. All trains stop at Geneva-Cornavin station (city centre).

Tickets can be purchased at the distributers in the train station (Swiss francs, euros or credit cards), at the station ticket wickets, at Ticket Shop CFF or – on landing in Geneva – in the baggage claim area (Arrivals level).

There are no direct trains from Geneva-Airport (GVA) to Evian-Les-Bain CGN station. But there is a combined route through Lausanne, it takes 1h 40 min to get to Evian-Les-Bain CGN station. The timetable is available on www.cff.ch

It takes 5 minutes by taxi to get from the train station to Hotel Royal Evian Resort and 10 minutes from the city centre.

Many banks in France have equipped their ATM machines with the CIRRUS or MAESTRO system. Many other French banks offer ATM machines for cash advances with your credit card. It is recommended to have a small amount of cash on hand upon arrival in Switzerland for immediate expenses, i.e. taxies, city transportation etc.

The VAT you pay on purchased goods in France is 20%. You may ask at the shops for your Global Refund Cheque and reclaim the VAT.
