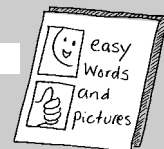

## Works Notice

### Implementation of Extended Stroud Green CPZ

Dear Resident or Trader,

You may recall our notification letter in July 2011 about the proposed extension of Stroud Green Controlled Parking Zone (CPZ). We received numerous representations from both within and outside the proposed extended area and on behalf of the Council I would like to thank all those who took the time to have their say and make their views known.

A majority of the representations received from the proposed extended area indicated support for the proposals and the Council has therefore decided to proceed with the extend Stroud Green CPZ to include the following roads:

- Denton Road
- Inderwick Road
- Mayfield Road
- Nelson Road
- Uplands Road
- Weston Park

The operating hours and days of the extended **Stroud Green CPZ** will be from **12 noon to 2pm, Monday to Friday**. **The extended CPZ will become operational on 12 December 2011** from which date a valid parking permit will be required to park in the CPZ during operational hours

A copy of the council's report with details of representations and the Council's response is available to view on our website [www.haringey.gov.uk](http://www.haringey.gov.uk) under Environment & Transport > Parking > Parking Consultations > Recent Parking Consultations.

Formal notices advising of the work will be published on **3 November 2011** and we intend starting work week commencing **7 November 2011** on line marking and installation of signs and posts. The work should take about 5 weeks to complete, weather permitting. We will make every effort to minimize traffic disruption while the work is in progress.

Double yellow line restrictions will be implemented at some locations, primarily junctions, to improve visibility for pedestrians and motorists by discouraging the inconsiderate and obstructive parking at junctions, near pedestrian crossing points and in narrow roads; which can represent a real hazard to road safety.

A parking permit application form with explanatory notes and details of charges is enclosed. All types of application forms can also be downloaded from the website. If you have more than one vehicle you will need to complete a permit application form for each additional vehicle.

Businesses requiring permits should visit [www.Haringey.gov.uk/parking](http://www.Haringey.gov.uk/parking) to see our policy on business permits and to download a business permit application form.

Please submit your permit application by post, preferably as soon as possible. Upon receipt of your application we will post an acknowledgement letter to confirm that it has been received by us. When bringing in a new zone we also need to make changes to our permit processing system and we therefore cannot physically process your application until after 19 November. You will not be able to obtain a permit from our Customer Service Centre before 19 November. Please note that if you choose to apply in person at a Customer Service Centre you may find that waiting times are far longer than normal during busy periods.

We will process all received permit applications ready for the start date of 12<sup>th</sup> December. Please do not delay submitting your application by post to us.

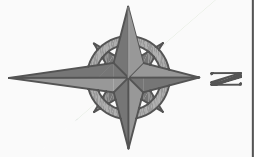

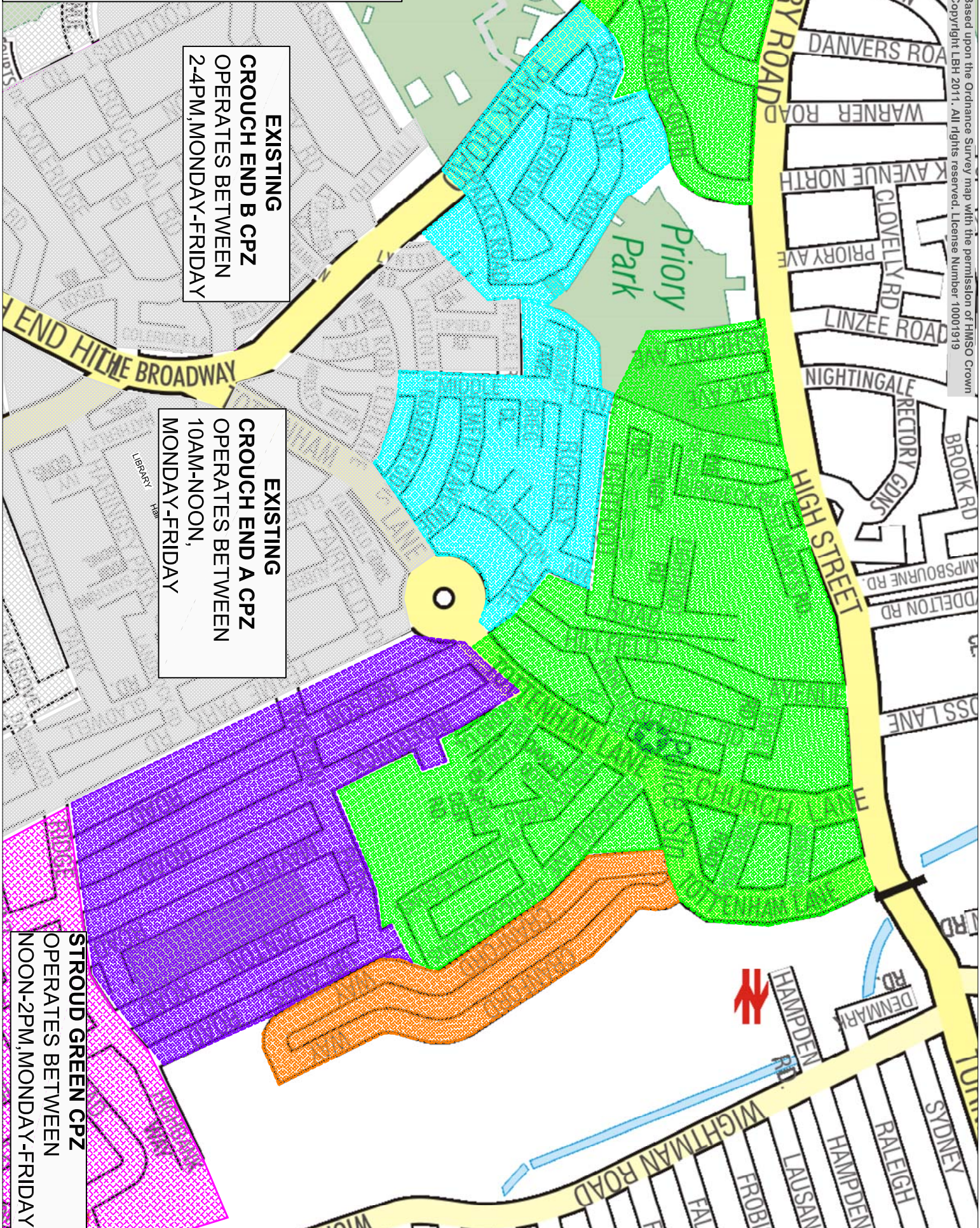
