Pi Kappa Alpha's Gold Star Heroes

In honor of those who made the ultimate sacrifice. . .

In 1944 the Fraternity's Supreme Council announced a plan to erect a War Memorial to honor those brothers who gave their lives in the service of our country. The plan included raising \$250,000 to build a national office for the Fraternity, which would house the Fraternity's professional staff and stand as a reminder of those courageous brothers who fought and died for the United States of America.

On September 5, 1954, the Pi Kappa Alpha Memorial Headquarters was dedicated in Memphis, Tennessee.

Today, the structure still stands, and throughout the building there are reminders of our brothers who were in uniform during times of conflict. These reminders include uniforms from each of the wars in which the United States took part, from the Civil War to the Vietnam War. A plaque hangs in the Gold Star Memorial Hallway, listing the names of those brothers killed prior to September 5, 1954. Scrapbooks containing news clippings, pictures and obituaries of brothers who lost their lives in World War II, the Korean conflict and the Vietnam War can be found in the museum.

On August 15, 1988, dedication ceremonies for the new Pi Kappa Alpha Memorial Headquarters will take place. The Fraternity's new home will continue the tradition set in 1954, and stand as a constant memorial to those brothers whose names make up the roster of Pi Kappa Alpha's Gold Star Heroes.

Some time has passed since the Fraternity last updated its Gold Star roster, and now, with the construction of the new Headquarters almost completed, we are appealing for information about those who *are* and *are not* listed.

A roster of the Gold Star Heroes can be found on page 26 of this issue. Please read over the list, arranged by chapter, and help us update our records.

Iota Epsilon

The installation of the Iota Epsilon chapter of Pi Kappa Alpha was the culmination of a year of intense effort by the members of the California State University-Long Beach colony. Colonized in February 1987, the small group of men grew quickly, and immediately made its presence felt on campus. Present at the installation were National President Gary E. Menchhofer, Foundation Executive Officer Louis B. Quinto, Director of Expansion Kevin G. Knaus, Chapter Consultant Todd Hittle and Iota Epsilon Advisor (and past chapter consultant) Jim Langlois. Assisting with the initiations and chartering ceremony were Theta Eta (*Loyola Marymount*), Theta Psi (*Chapman College*), and Iota Beta (*University of California-Davis*) chapters.

Two weeks after their colonization, the Pikes routed the competition during Greek Week and

took home the first place trophy. The colony's attendance at the various activities was proportionately higher than that of any other fraternity, and second place finishes in the bowling competition and the Greek Sing ensured the victory.

The diverse Pike membership is well represented on the Long Beach State campus. Several Pikes have held elected offices in the Associated Student Senate; Roger Thompson was recently elected Associated Student president. Eric P. Evans serves the University as Interfraternity Council rush chairman. Virtually every man in the group holds membership in another student organization, such as the Law Society or the Surf Club. Pike members play on the varsity football, baseball, volleyball, fencing, crew and water skiing teams.

The colony made considerable contributions

to the community through hard work and enthusiasm: In April 1987, the Pikes worked together with the women of Sigma Kappa on decorating and hiding Easter eggs for the boys and girls of Cedar House, a home for abused children. Colony members donated over thirty man hours to *A Taste of Long Beach*, a local cultural event from which proceeds went to benefit the homeless of Long Beach. During the colonization period, the Pikes staffed numerous fund raising events for the Los Angeles branch of Big Brothers of America. The Pikes' first participation in the Delta Gamma Anchor Splash provided fun and competition for everyone.

During its first week of existence, the colony teamed with Alpha Phi Sorority for participation in Greek Week and the Greek Sing. The colony's social schedule was busy during the first semester, as the group held informal exchanges with every sorority. During the winter semester, the Pikes joined Sigma Kappa for a harbor cruise, rallied Homecoming spirits with the Tri-Delts and celebrated Halloween with Alpha Phi.

In athletics, the Pikes have been characterized by their aggressive desire to succeed. The first IFC sport in which they participated was basketball. After defeating Delta Chi, Theta

Chi and Kappa Sigma, the team suffered a one point loss to Sigma Chi in the semi-final round. The Pikes' softball team met with success in intramural and IFC competition, and the soccer team won three games.

Under the dedicated leadership of the group's first SMC, Shawn Wachter, and with a corps of enthusiastic officers and members, the Pi Kappa Alpha colony at Long Beach achieved success at all levels of chapter programming. The Pikes topped all national social fraternities at Long Beach in scholarship by accumulating the highest grade point average. The colony encouraged scholastic achievement through monetary awards to those members with the highest and most improved GPAs. The Garnet and Gold Clubs were established to encourage academic excellence; members with grade point averages of 3.5 and above became Gold Club members, while those members with GPAs between 3.0 and 3.49 joined the ranks of the Garnet Club. Library hours, a hefty test file and tutoring from various members were all used to enhance the academic achievement of the entire group.

Passing inspection on February 6, 1988 was exciting for the colony, but real elation was manifested on March 17, when the members

were initiated into the bonds of Pi Kappa Alpha. The installation ceremony and the banquet took place March 19, 1988 on board the *Queen Mary* in Long Beach Harbor, culminating a year of effort and anticipation.

Iota Zeta

Randolph-Macon College in Ashland, Virginia is one of PIKA's newest homes

Iota Zeta chapter was born the weekend of April 15, 1988, when the forty-nine men of the Pi Kappa Alpha colony at Randolph-Macon College were installed as the Fraternity's youngest chapter. The chartering banquet, held at the Marriott Hotel in Richmond, Virginia, was attended by National President Gary E. Menchhofer, Founders Regional President Andy Morse, Director of Expansion Kevin Knaus, Associate Director of Expansion Kevin Virta, and colony president Jon Hughes.

COLONY HISTORY

In late 1985, Regional President Morse and other representatives of the Fraternity visited Randolph-Macon and found a group of men who desired to become part of a great national fraternity. At that time, these men composed a very small local fraternity, the remnants of

a defunct chapter of another national organization.

Pi Kappa Alpha colony was organized out of this local group, and with the help of Mike Moreland, then director of services, thirteen men pledged after the January 1986 rush.

The colony began to emerge as a powerful presence in Greek life, and as one of the leading fraternities on campus. Two colony members, Jeff Bisson and Billy Simpson, were elected presidents of the Interfraternity Council; both also received the Greek Man of the Year Award. Charity work was another priority, and the group labored to raise donations through record sales, car washes, and the coordination of the MDA Super-Dance Marathon.

In August 1986, alumni and students made much needed repairs to the house. Autumn of that year saw an organized colony, with a coherent system of committees and meetings

held according to *Robert's Rules of Order*.

A colony retreat was held that October, during which officer and committee reports were heard and future plans discussed. Objectives were set for the colony, which it would strive to meet throughout the coming year.

Over one-third of the colony members attended the 1986 Founders Regional Leadership Convention in Richmond, Virginia, and three more men were pledged in the fall of that year. Additionally, the Pikes worked to establish a good relationship with the faculty and administration of Randolph-Macon College: a faculty reception was held in 1986 which proved so popular that the event was repeated in December 1987. These receptions gave the Randolph-Macon College faculty opportunities to meet colony members, to see the improvements made to the house, and to

hear the colony's plans.

Spring semester of the 1986-87 academic year began with a well-attended Superbowl party for prospective members. Rush gained the colony twelve new members, bringing colony membership to thirty-six. The group made its presence felt on campus with a good showing in the Greek Cup Sports competition. Brother Rob Erdman represented Pi Kappa Alpha as treasurer of the Randolph-Macon Interfraternity Council. The colony held a pizza raffle fund raiser and charitable efforts continued with annual campus and civic clean-ups.

Both Rob Erdman and colony president Jon Hughes attended the Officers Leadership Academy in Memphis during summer 1987. When school reconvened in the fall, another colony retreat was held. Special consideration was given to the colony's financial situation and the target date of installation was moved to the spring of 1988. Trips to Omicron chapter (*University of Richmond*) and Gamma chapter (*William & Mary*) proved beneficial, and productive in several areas. A draft of the colony's pledge manual was finished and several new programs were added in the area of pledge education. Four men were pledged in October 1987; they attended the 1987 Founders Regional Leadership Conference in Charlottesville, Virginia, with twenty-four other colony members. The Chapter Advisor Award given at that conference went to Randolph-Macon colony advisor Ralph Straub.

The work done by Pi Kappa colony paid off in January 1988 when the colony inspection was held. The inspection team was composed of Founders Regional President Andy Morse, Associate Director of Expansion and Services Kevin Virta, and members of Gamma and Omicron chapters. After a presentation by the colony on its accomplishments and structure, the inspection team voted unanimously that the colony was ready to petition Pi Kappa Alpha for installation.

COLLEGE HISTORY

Randolph-Macon is a small, undergraduate, coeducational, liberal arts institution. Founded by the Methodist Church in 1830, Randolph-Macon was originally in Boydton, Virginia, near the North Carolina border. The destruction of local railroads during the Civil War rendered Boydton inaccessible, so in 1868 the College was moved to its present site at Ashland, Virginia, just north of Richmond. For a short time, the College was housed in the remains of an old mineral springs resort. The students themselves raised most of the funds for the first major building, Washington Franklin Hall, one of six buildings on campus listed in the National Register of Historic Landmarks.

In this century, Randolph-Macon has grown to over forty buildings on a sprawling hundred-acre campus. The curriculum offered emphasizes the liberal arts and sciences, and offers students twenty-one major fields of study. A number of special academic opportunities, such as a short January-term and study abroad, offer students exposure to specialized subjects on an in-depth basis.

Only ten percent of all colleges and universities have a Phi Beta Kappa chapter. Included in that ten percent is Randolph-Macon, exemplifying a clear commitment to excellence. Since 1920, when records started being kept, a higher percentage of Randolph-Macon alumni have gone on to earn doctorates than have the alumni of any other private college or university in Virginia.

GREEK HISTORY

The history of Greek life at Randolph-Macon began soon after the move to Ashland with the establishment of Kappa Alpha in 1869. This was followed by Phi Kappa Sigma in 1872, Phi Delta Theta in 1874, and Kappa Sigma in 1889. Expansion of the Greek system then slowed until 1906, when Sigma Phi Epsilon was established. The next two fraternities

to be founded were Lambda Chi Alpha in 1920 and Theta Chi in 1949. Sigma Alpha Epsilon was added in 1967, and Pi Kappa colony was established February 1, 1986.

The first sorority on campus was Phi Mu in 1982, eleven years after the College became coeducational. Phi Mu was followed by Kappa Alpha Theta in 1984 and, most recently, Alpha Gamma Delta in 1986.

The Interfraternity Council is the governing body of the fraternity system, while the Panhellenic Council directs the sororities. These two organizations are responsible for formulation and enforcement of policies concerning social occasions, rush, and pledging. They also initiate policies outlining Greek relations with the College and community. The IFC sponsors activities throughout the year culminating with Greek Week.

COLONY CHARTERING

After the petition from Pi Kappa colony was approved, the chapter-to-be began preparations for initiation and chartering. Thirteen men were gained in February rush, while the colony continued fund raising with car washes and doughnut sales.

The forty-nine founding fathers of Iota Zeta chapter were initiated into the bonds of Pi Kappa Alpha on Friday, April 15 by teams from Alpha, Omicron, and Gamma chapters. The next day, the officers were installed and the colony became a chapter. A banquet and dance attended by national officers, area alumni, and the men of Pi Kappa Alpha's most recent chapter crowned the evening.

The men of Iota Zeta wish to thank everyone who made chartering possible, and look forward to representing Pi Kappa Alpha on the Randolph-Macon College campus.

Expansion Update

Beta Upsilon looks forward to rechartering.

On April 30, 1988, the Beta Upsilon colony of Pi Kappa Alpha at the University of Colorado was informed that it had successfully passed inspection and could look forward to an early fall chartering, provided their petition is passed by the general Fraternity. The announcement followed a three hour presentation by the colony to the inspection team of Associate Director of Expansion & Services Kevin Virta, Rockies Regional President Gene Commander, and members of Iota Alpha (*Wyoming*) and Epsilon Theta (*Colorado State University*) chapters.

Passing inspection capped off a year of great achievement for Beta Upsilon colony. There are currently ninety-five men in the group, of whom only seven will graduate this spring. Their aggregate GPA is 2.8, the highest among the twenty fraternities on campus. The Beta Upsilon men also displayed their athletic prowess and team spirit by winning Greek Week.

Culminating an amazing first year, the colony has secured housing for the 1988-89 school term.

UNIVERSITY OF CALIFORNIA - SANTA BARBARA

Another successful year for PiKA expansion comes to a close with the addition of a colony at the University of California-Santa Barbara. Pi Kappa Alpha has sought to be recognized on this prestigious campus for the last ten years: this pursuit ended on January 22, 1988 when Pi Kappa Alpha was chosen over another national fraternity following a presentation given by Director of Expansion Kevin G. Knaus.

The colonization project began on February 21, 1988 with the arrival of Associate Director of Expansion & Services Kevin Virta and Chapter Consultant Todd Hittle. During their four week stay at the picturesque campus on the Pacific shore, they conducted the initial membership recruitment and alumni development. These efforts met with great success; forty-nine men were recruited and integrated into the colony. Within this group are eigh-

teen varsity and club athletes and several campus leaders. Their aggregate grade point average is 3.0.

The colony took the campus by storm, recruiting twenty-three men in spring rush. This was the largest pledge class on the fifteen-fraternity campus.

On April 1, 1988, the colonization process was completed as the seventy-two men were formally pledged to Pi Kappa Alpha by Zeta Omicron (*California State University-Northridge*) and Theta Psi (*Chapman College*) chapters.

MICHIGAN STATE UNIVERSITY

Fifty-two men now fill the ranks of the Michigan State colony after spring rush added sixteen members to the group. This was the most successful rush for the colony to date.

The Michigan State men are emphasizing campus involvement and promotion of a positive image for PiKA, as evinced by a second place finish (out of thirty-two fraternities) in the Delta Gamma Anchor Splash and by their undefeated basketball record.

COLUMBIA UNIVERSITY

The colony at Columbia University currently has thirty-nine members: campus leaders, athletes, and academically oriented men. This combination of talents has allowed the group to become a major factor on campus in a short period of time. Five colony members will serve on the Student Council next year, with two men holding senate seats — one of the highest undergraduate positions attainable. The colony has recently placed third in the Greek Olympics and is enjoying success on the intramural fields as well.

CALIFORNIA POLYTECHNIC SAN LUIS OBISPO

The Cal Poly colony shone on campus this quarter, recruiting fifteen men in dry rush, while other fraternities continued with wet rush. Despite this difference, the group came out with the second largest pledge class on campus. The total membership of the group is forty-three. Involved on campus and in the community since the group's inception, the members of the Cal Poly colony recently sponsored a "Good Neighbor Day" and completed a project for the American Heart Association that involved ten man hours per person. They also participated in Poly Royal Weekend and raised \$6,500 through the sale of T-shirts.

UNIVERSITY OF NEVADA - RENO

The University of Nevada-Reno has enjoyed a year of growth. Making the colony presence visible on campus, member John Schlegelmilch served as chairman for MacKay Week, the largest campus event of the year. The colony has also involved itself in the community through service with "Lil Amigos" in connection with the YMCA.

The colony currently has forty-nine men, and is stressing recruitment and pledge education in its goals for chartering.

FLORIDA SOUTHERN

A new advisory board has been developed over the course of the spring semester to help the Florida Southern group accomplish its chartering objectives. The Delta Delta colony's main focus will be on an aggressive fall rush. The members were heavily involved in community service this year, raising \$1,700 for the fight against leukemia.

Supreme Council Takes Action Against Two Chapters

Delta Lambda's charter suspended indefinitely; Delta Upsilon placed on colony status

On Wednesday, May 18, 1988, Pi Kappa Alpha's Executive Vice President Raymond L. Orians announced that the Fraternity's Supreme Council had voted to suspend Delta Lambda (*Florida State University*) chapter's charter indefinitely.

"After a thorough investigation by the national office, the Supreme Council concluded, that, at this time, the chapter was failing to act within the principles and ideals of the Fraternity," Orians reports.

In other actions, the Supreme Council also made an investigation into Delta Upsilon chapter at Stetson University. From the investigation, it was determined that because of the chapter's inability to uphold the principles and ideals of the Fraternity, the members had placed the chapter's charter in serious jeopardy. Therefore, the Supreme Council directed that Delta Upsilon be placed on "colony"

status and that the Fraternity's professional staff immediately conduct a membership review.

"We have received several letters and phone calls from alumni and parents, both good and bad, concerning the two chapters over the past two months," Orians says. "I can assure all of our members that the Supreme Council and the Fraternity's professional staff will take action when chapter conduct fails to adhere to the principles and ideals as aspired for the Fraternity. We are working to intensify educational programs at our upcoming National Convention, at our fifteen Regional Leadership Conferences and at our annual Chapter President's Conference, which will help our undergraduate brothers live up to Pi Kappa Alpha's high principles and values."

According to Orians, the suspension of Delta Lambda's charter will cost the national

Fraternity over \$15,000 in annual membership dues, initiation fees and pledge fees. In addition, the Fraternity's Housing Commission could lose rental income as the owner of the chapter house at Florida State.

"This situation has affected, and will continue to affect, the entire Fraternity for quite awhile," Orians states. "Our chapter at Florida State was the largest in the country with 170 members. Suspending a chapter is a drastic measure. Unfortunately, the circumstances left us no other alternative."

Delta Upsilon chapter, at Stetson University, did not have its charter suspended. However, a membership review was conducted by the Fraternity's professional staff and some members were required to leave the chapter and the chapter was placed on a colony status.

Chapter Notes

B The pledge program at **Beta** chapter (*Davidson College*), under the direction of senior Josh Budde, is a highly structured, new approach with emphasis on positive pledge education, and is oriented toward brother-pledge unity rather than brother-against-pledge rivalry. The chapter recently pledged twenty-seven men.

Active in community service, Beta chapter members are working with *Habitat for Humanity*, a program which constructs homes for low-income families. The brothers also coach youth T-ball and soccer.

Several Beta brothers have received noteworthy awards: SMC Sam Cutting has received the ODK award, given for leadership organization, a 3.0 or better grade point average and maintaining a position of campus leadership. Cutting also received the ODE award, which grants membership in the economics fraternity to those students who excel as economics majors and are active in campus economic events. Brett Morris, SC of Beta chapter, was elected to the Student Conduct Council and to the chairmanship of the Student Art Gallery. Beta Social Chairman Edgar Gamponia is president of the Instrumental Ensembles Group.

K **Kappa** chapter (*Transylvania University*) started off the 1987-88 year by pledging seventeen men, the successful result of a rush retreat held last summer in conjunction with the chapter's alumni. Kappa members are visible on campus as members of the student government association and the tennis, basketball, swimming, soccer and diving teams.

Pikes at Transylvania have also been active in the Lexington, Kentucky community — the brothers sponsored a community leaf raking project, and raised money for the University in the Alumni Phone-athon. The pledges collected over 300 pounds of food for the needy in an annual food drive by sponsoring a party at which canned goods were the price of admission.

ΑΓ Pikes at **Alpha Gamma** chapter (*Louisiana State University*) placed first in football, basketball and floor hockey this year, and are at work organizing the first annual Pike Open Golf Tournament. In community service, the chapter has joined the Adopt-A-Road program, in which the members committed themselves to keeping a five mile stretch of highway litter free. Alpha Gamma brothers also hold campus positions on the Greek Steering Committee and the Interfraternity Council. The building of a stronger alumni chapter began this year at the ΑΓ Founders Day celebration, under the direction of brother Robert Marks. During the celebration, B.D. Dorroh was named Alumnus of the Year for his continued support of the chapter.

ΑΝ **Alpha Nu** chapter (*University of Missouri-Columbia*) gained national recognition for its support of *Students Against Multiple Sclerosis* this semester. Senior Chris Brown, winner of the local SAMS "Rock Alike" contest, was chosen to go on to the nationally broadcast competition finals on March 19 in Daytona Beach, Florida. Brown impersonated his favorite rock star and raised \$4,638 for the charity.

In January of this year, the Alpha Nu brothers lent their assistance to the Grand Senior Center in Columbia, Missouri when that facility moved to a new address. The chapter members moved the Center and cleaned out the old location.

Scholastically, Alpha Nu finished sixth among the Greek houses on the Missouri campus for the Fall 1987 semester.

ΒΑ Steven Siegel, a brother of **Beta Alpha** chapter (*Pennsylvania State University*) was elected president of the Northeast Interfraternity Council. The NEIFC is comprised of all the IFCs in the eastern United States and eastern Canada. Siegel is the second Beta Alpha Pike to hold that position in the past three years.

ΒΝ During the winter term, **Beta Nu** chapter (*Oregon State University*) was involved in several community service programs: the Y Round Table Big Brother Picnic, a sportswear sale, and the annual Sweet Hearts Ball. The chapter raised \$1,000 for charity and contributed 395 man hours. In winter term sports, the brothers took first in the all-university wrestling and volleyball tournament. They are currently number one in all university intramural points. Brother Steve Roth has helped to found an all Greek governing board for university intramurals.

Beta Nu held its 1988 Dream Girl Formal, which was attended by seventy-two couples. Miss Cara Rennie of Alpha Phi Sorority was crowned Dream Girl and presented with a \$100 scholarship. The event was also highlighted by the presentation of a distinguished service award to chapter advisor Steve Uerlings for his many years of service to the chapter.

ΒΟ **Beta Omicron** chapter (*University of Oklahoma*) has renewed its fraternal spirit with the purchase of new Regalia and the complete renovation of its chapter room. Currently, the chapter is working on plans to construct a library/study room in the chapter house. Beta Omicron has emphasized community service this year, manning a booth for Unicef at the Oklahoma State Fair, and participating in the semi-annual "Lights On For Hunger" program in affiliation with the Hunger Coalition of Norman, Oklahoma.

ΓΔ Since the refounding of **Gamma Delta** chapter (*University of Arizona*) in late 1984, the chapter has grown from seven to 150 men. This chapter's rush program was honored last year by the National Fraternity with the National Rush Award. Last fall, Gamma Delta pledged another forty-one men, and this spring twenty-eight men accepted the bids extended by the chapter.

Gamma Delta has also reestablished its alumni association. ΓΙ Due to the efforts of Rush Chairmen Todd Underwood and John Dill, **Gamma Iota** chapter (*University of Mississippi*) recently pledged seventy-one men, the largest pledge class in Ole Miss' history.

Underwood also represented the chapter in a swing-a-thon to raise money for the Mississippi Burn Center in Greenville, Mississippi. Approximately \$6,000 was raised for that purpose. Members of Gamma Iota chapter also joined members of Kappa Kappa Gamma Sorority in collecting signatures on a petition to the governor asking for state funding for the Burn Center.

ΓΛ During the fall semester at Lehigh University, **Gamma Lambda** chapter recorded twenty-two pledges, the house's largest total in recent history. Gamma Lambda is now a

fifty-five man chapter, which puts it in the upper one-third in size of Lehigh's thirty-one fraternities. This total represents the chapter's largest number in twenty years.

ΓΡ **Gamma Rho** chapter (*Northwestern University*) celebrated Founders Day on March 7, 1988 at the Union League Club in Chicago, Illinois. Past National President William N. LaForge attended the event at which Gamma Rho alumni received a charter for a new alumni association.

Four Gamma Rho brothers have distinguished themselves academically: sophomore Timothy Lawton received the Ford Foundation scholarship in engineering, while sophomores Brian Vanderbilt and John Fingerson and junior Tim Wong had perfect 4.0 grade point averages for the fall term.

ΓΧ **Gamma Chi** chapter (*Oklahoma State University*) has restructured its pledge program to emphasize personal motivation and academic excellence. The brothers seek to "live the principles of the *Garnet & Gold*" in all respects.

In sports, Gamma Chi's volleyball team won first honors in the tough All-Greek Tournament, while the swimming team placed fourth out of twenty-four fraternities. Brothers Thad Wolgamott and Scott Hjelm placed third in All-Greek racquetball, and Clint Stockton was chosen as a member of the All-Greek soccer team.

Brother Matt Verholst served this year as Spring Sing co-director.

Working with Chi Omega Sorority once again, the chapter raised \$2,200 through a twenty-six hour dance marathon, "Make Promises Happen". The proceeds were used to sponsor weekends for handicapped children at Oklahoma Christian Camp.

ΓΤ **Gamma Tau** chapter (*Rensselaer Polytechnic Institute*) is proud to announce the initiation of thirty-three men, who constituted the largest pledge class on campus. Among them are varsity athletes, academic scholars and student government officers.

Gamma Tau sponsored a Red Cross Blood Drive this year, and rais-

ed money for Cystic Fibrosis through a 5 kilometer road race, an activity the chapter intends to repeat annually. In addition, an improved neighborhood relations program included neighborhood work days and improved communication between the chapter and the neighborhood.

The chapter was also represented this year at Congressional Founders Day in Washington, D.C.

Nineteen men have been initiated into Delta Eta chapter this year; spring rush yielded thirty-four pledges. Sixteen members of Delta Eta attended the North Atlantic Regional Leadership Conference in Hartford, Connecticut this spring, at which the chapter received awards for community service, off-campus involvement and intramurals.

The Delaware chapter is strengthening its on-campus position through involvement with the Interfraternity Council. The chapter also participated this year in a twenty-

four hour hockey marathon for the benefit of the local police department.

ΔΘ The **Delta Theta** chapter (*Arkansas State University*) of Pi Kappa Alpha has announced plans for a \$370,000 colonial-style mansion on the Arkansas State campus.

The 8,000 square foot, two story house will be constructed on Robinson Street behind the ASU Convocation Center. Twenty-four men will occupy eight single rooms and eight double rooms.

Pike alumni and undergraduates have contributed almost \$100,000 toward the house. Interim financing will be provided by Citizens Bank of Jonesboro, and a second mortgage has been approved by Pi Kappa Alpha's National Headquarters. The university has agreed to a sixty year lease for the land site.

"This fraternity house is a dream of over 1,000 Pike alumni and undergraduates from Arkansas State," said Mike Medlock, president of the Delta Theta Housing Corporation, "We didn't rush into it, and we think the final product will be worth the wait."

Completion is expected this fall, and chapter members could move into the house as early as October 1988. Tim Brown, alumnus advisor

and chairman of the Housing Corporation's fund raising committee, said that in addition to the bedrooms, the second floor of the house would include a sound-proof study room, a laundry area and shower and bathroom facilities. This first floor will have a 1,200 square foot ballroom, an alumni history library, a television room and a chapter office. A patio will be built behind the ballroom. A circle drive and forty-five parking spaces will be located in front of the red brick house, which will have four white columns added to the front and four on the back.

Delta Theta currently has eighty-five members and twenty-four pledges.

ΔΙ The fall semester at Marshall University was a strong one for **Delta Iota** chapter. After winning the award for most improved fraternity on campus in the spring of 1987, Delta Iota took its place as top fraternity in the Marshall Greek system.

Rush Chairman Christopher K. Keaton headed a rush program this year that attracted twenty-eight pledges. On a campus where only six percent of the student body is Greek, this was a clear victory for Delta Iota.

Homecoming 1987 was marked by a large alumni turnout, and the weekend was capped off by an active/alumni golf tournament, an event which Delta Iota hopes to make annual.

Members of Delta Iota are leaders in other aspects of campus life as well. Christopher Keaton is a student senator representing the Community College, and also serves on the Finance, Rules and Academic Affairs committees. Gregory Gordon is a senator representing the School of Business.

In athletics, Marshall Pikes won the softball championship, the tug-of-war, the volleyball championship, and also came out on top of the annual Pike Football Tournament.

The chapter's alumni committee releases two newsletters per semester, and through strong alumni support has been able to begin the installation of a new kitchen and renovation of the house.

ΔΟ **Delta Omicron** chapter at Drake University has established a building fund, with the goal of purchasing the current chapter house. Strong alumni support, in response to the chapter's new alumni relations program, is providing the chapter with great assistance. Delta Omicron is also proud of its academic proficiency, having received the award for most improved grade point average at the Great Plains Regional Leadership Conference.

In the area of community service, Delta Omicron was commended for its efforts last October in Drake University's Greek Program Council sponsored blood drive. SMC Jeff Adix received a Blood Center recognition plaque from Drake's director of student activities and Greek life, the second such plaque awarded to the chapter in 1987.

The response was overwhelming. ΘΠ Theta Pi chapter (*University of Alabama-Huntsville*) is gearing up for an all out effort to raise money to build a chapter house at the Alabama-Huntsville campus. The Founders Day Banquet, held on March 5, featured Memorial Foundation Executive Officer Lou Quinto, who gave the keynote speech at the event. Quinto had given a presentation earlier in the day on the Campaign for Pi Kappa Alpha, and how it directly benefits the chapter. In his speech, he explained how the Fraternity's success depends on dedicated brothers, both undergraduates and alumni. Another highlight of the banquet was the presentation of the William M. McKissack Academic/Leadership Award to brother Tim Funston. Funston has maintained a 3.0+ grade point average while serving Theta Pi as SMC, IMC, pledge educator, and currently as alumni relations chairman. This is the fourth straight

year in which a brother of Theta Pi has won that award. Also honored at the banquet were Chapter Advisor Josh Kelly, who was named Outstanding Alumnus, and IMC Wes Kendall, who won Theta Pi Pike of the Year. Kelly has spearheaded the effort to improve the chapter's financial position and build a house, while Kendall was honored for producing the best rush at Theta Pi since its founding.

ΘΥ Picture fifty men gathered for one purpose: to evaluate and expand the resources of the Fraternity chapter. Theta Upsilon chapter (*Tennessee Tech*) did just that on March 26, 1988 in a "Chapter Leadership Conference".

"In order to analyze our strengths and weaknesses, we decided to take one Saturday and discuss our entire situation, as a chapter and as individuals," said SMC Kelly McCreight.

The conference was intended to increase the strengths of the chapter and correct weaknesses through specifically outlined programs.

"We decided to take a closer look at ourselves and asked our chapter consultant, Tom Dempsey, to help us in an evaluation," McCreight said. "What Tom suggested eventually formed the agenda for the conference."

Dempsey joined the chapter officers in leading the conference, much like a mini-Regional Leadership Conference, and discussing the needs of Theta Upsilon.

Chapter members arose early on the morning following initiation and the traditional post-initiation party; the date had been chosen specifically to include the chapter's new initiates and involve them quickly in the business of the Fraternity. The sessions, which included Needs Identification, Membership, Winning Rush, Pledge and Membership Education Programs, Individual Member Commitment, study of the Pledging and Initiation Ceremonies, and a regular chapter meeting, were planned to allow interaction between members, chapter officers and local alumni.

"Some programs were more successful than others," said McCreight, "but they certainly helped the chapter realize its potential and fulfill its goals. This was the best way possible to involve the entire group in the decision-making process."

The chapter devised a list of standards for the actives to follow, a brotherhood manual to assist in day-to-day chapter operations, a definition of the model Theta Upsilon chapter member, and a mission statement: "Commitment to Excellence".

An immediate result of the conference was the directed rush that followed. The chapter pledged eight men, twice the normal amount for spring rush.

"Theta Upsilon is 'Committed to Excellence,'" said McCreight, "and the Chapter Leadership Conference identified the necessary pathways to that end."

Theta Upsilon chapter is also the proud possessor of a new pool table — courtesy of country singer Larry Gatlin. The entertainer had issued a challenge to the chapter to stay "dry" for one week. The week of March 27-April 2 was completely devoid of alcohol for the Tennessee Tech Pikes, and they ended the week richer by one pool table. Brother Steve Swanson reported that refraining from alcohol and beer wasn't as difficult a task as some might have thought: a fact the chapter plans to emphasize by having a "dry week" every year during spring semester.

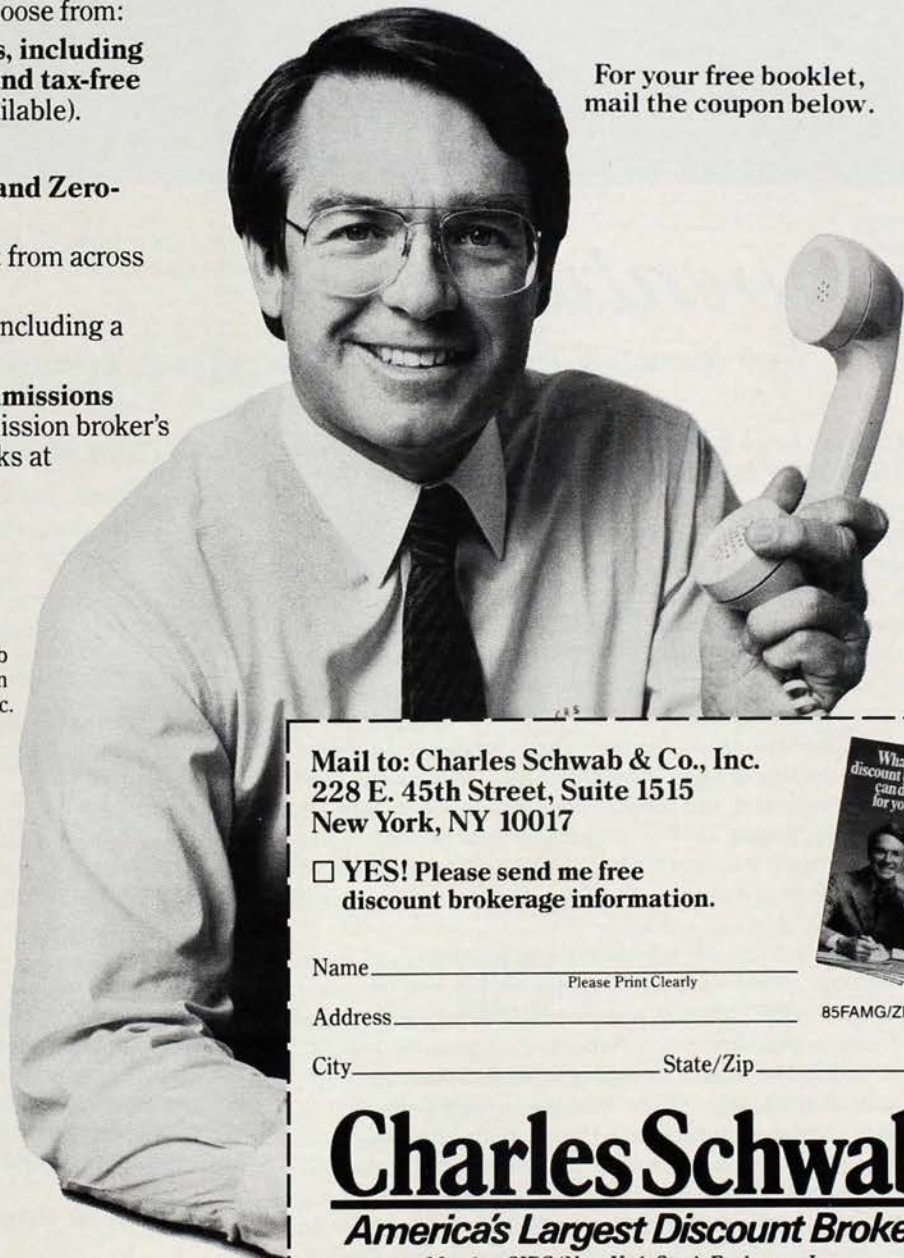

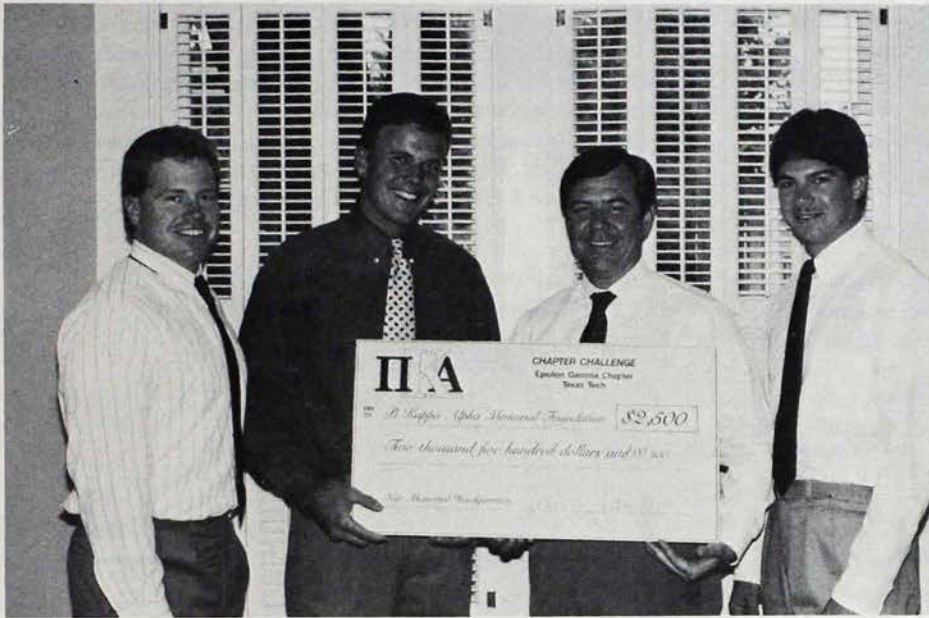

In an effort to involve the Fraternity's undergraduate chapters in the building of the new Memorial Headquarters, the Memorial Foundation recently announced the *Chapter Challenge*. The *Chapter Challenge* asks for voluntary participation in this major project from all chapters and colonies.

Each year our chapters contribute over \$500,000 to various charities and organizations. The Foundation has challenged the chapters to pledge a portion of these funds to the new Memorial Headquarters.

In 1954, when the same type of challenge was extended for the construction of the current headquarters, the chapters responded in grand style. Now, once again, response from the chapters is enthusiastic.

To date, almost \$16,000 has been pledged by the chapters. All chapters contributing to the *Chapter Challenge* will be recognized permanently within the new building, making their pledges lasting tributes to all the members of those chapters. The chapter making the highest contribution prior to the 1988 National Convention will participate in the ribbon cutting ceremony and dedication of the new Memorial Headquarters on Monday, August 15, 1988.

Gamma, Gamma Alpha, Gamma Chi, Epsilon Gamma, Zeta Epsilon, Theta Lambda and Theta Psi have already met the challenge, and the Foundation anticipates many more of the chapters to join their ranks at the upcoming Convention.

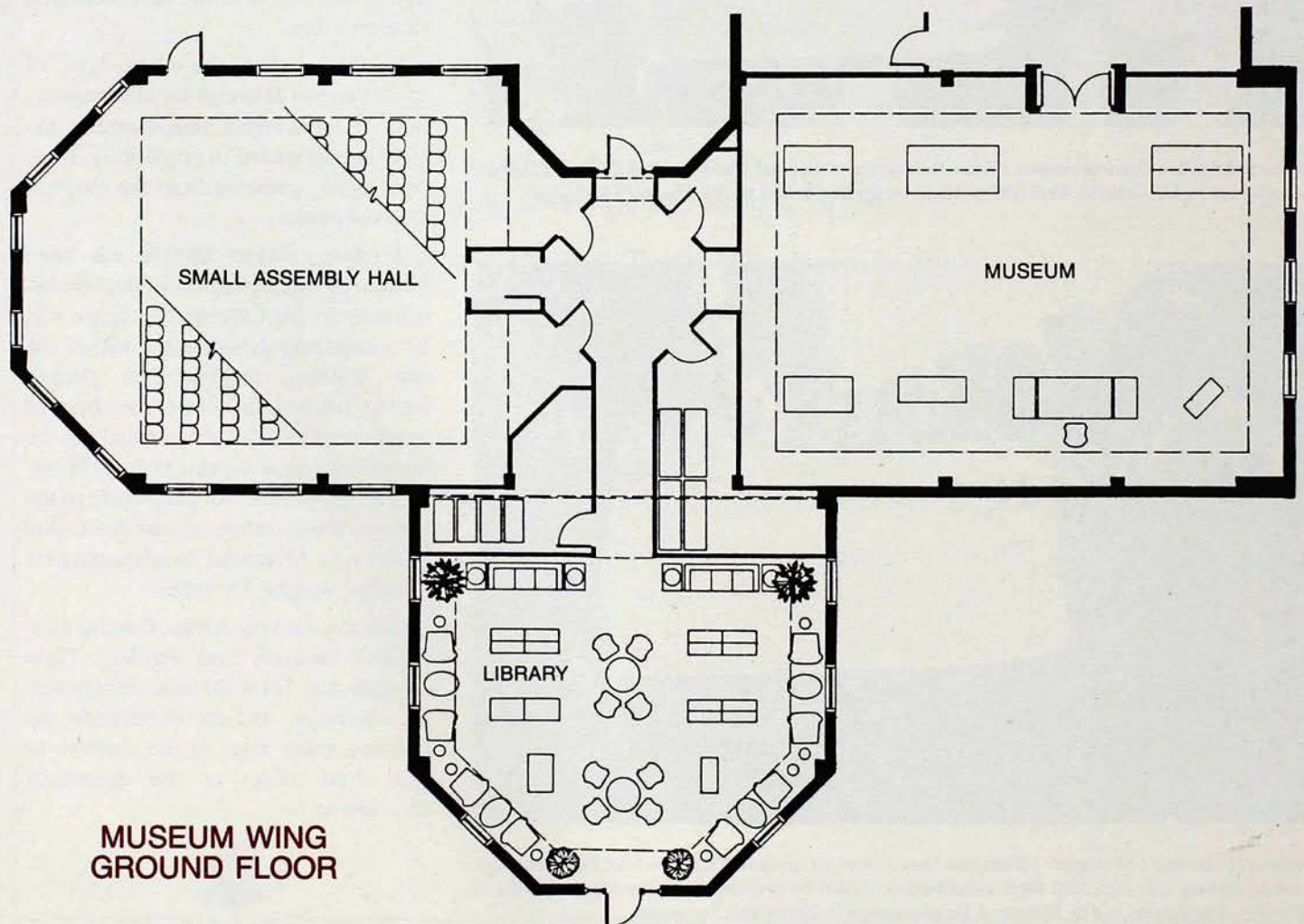
New furniture is needed for the Library, the Board Room, the Conference Room, the Assembly Hall, and the various sitting rooms. The

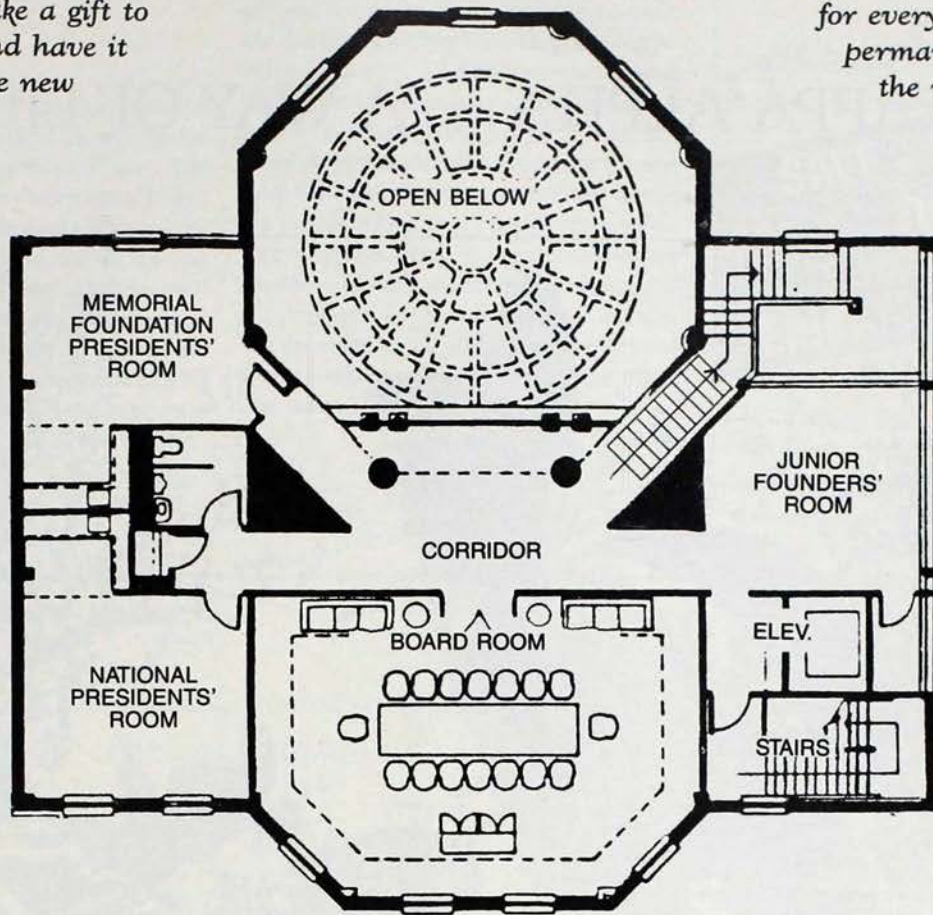

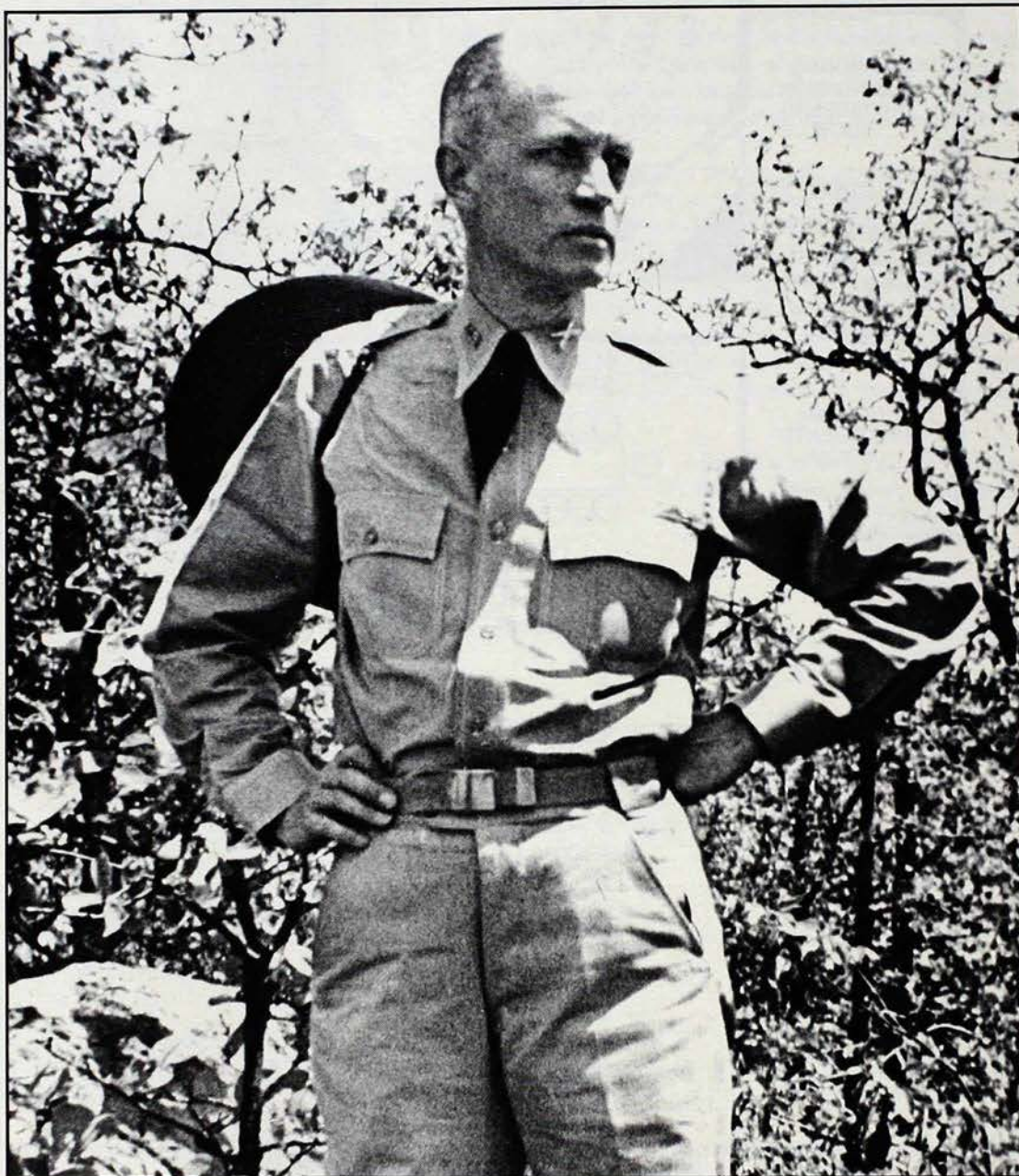

As a colony, the chapter loses possession of its charter and is monitored closely by the Fraternity's staff throughout the year. The group is also required to meet a list of objectives developed by the National Office in conjunction with the university, the alumni and the colony members. These objectives will include the establishment of sound management operations and procedures; campus and community service; and maintenance of a set grade point average. Failure to make improvement could result in a loss of the charter.

"We will continue to keep our eyes on both of these campuses. It is our goal to reinstate the charters of each of these chapters, but we will do that only when an interested student group meets the standards and the high ideals which we expect," Orians says. "I hope that every chapter has learned an important lesson from these unfortunate events and that we can put this all behind us. Pi Kappa Alpha offers a great opportunity to undergraduate men for excellent leadership training and personal development. For the sake of our Fraternity, and the entire Greek system, our chapters and their members must adhere to certain ethics and values."

One of these individuals was Dr. Wallace E. "Brick" Lowry (*Alpha Omicron '27*). Brick was a dean at Sam Houston State University and an alumnus of Alpha Omicron, my undergraduate chapter at Southwestern University.

I first met Brick when he was a regional president and I was a pledge. He impressed me as Pi Kappa Alpha's answer to Will Rogers. With his accent, his wit and his ability to get to the meat of the matter, I realized that this was a man who said what he had to say in language everyone would understand and in as few words as possible.

A year later my chapter was in trouble, and Brick was called in to meet with the University and the chapter. After meeting with the University officials, Brick met with us at a chapter meeting. We were feeling optimistic going into this meeting because "good ol' Brick" was there to take care of us. Instead, Brick stood up and said, "Boys, you've messed up. All you can do now is take your licking and go on." Then he sat down.

Needless to say, we were somewhat stunned and shocked. We took Brick's advice and reorganized our efforts. It showed, too, when we won the Robert Adger Smythe Award two years later; that was when only one chapter was awarded the honor annually.

I really began to know Brick when I attended regional and national conventions. He always had a small hospitality room which people from our region could utilize.

It was with a great deal of pleasure that I saw Brick elected to the Supreme Council at the Centennial Convention in Richmond in 1968.

Brick passed away on April 14, 1987. Words, time and space do not allow but a brief glance of the essence of the man; yet those of us whose life was touched by his presence owe him a great deal.

Alumni came from near and far to relive some old memories and offer their support to a grieving Kappa chapter.

any more strongly than it was at the graveside ceremony, when all who had gathered joined in singing *Down in Old Virginy*.

After his graduation, Jackson continued his steadfast love for Pi Kappa Alpha, and served terms as president of the Atlanta Alumni Association, president of the Alpha Mu Housing Corporation, and Supreme Council vice president for financial affairs.

An active civic leader in the Atlanta community, Jackson was involved in many areas: the Board of Trustees of the Atlanta School of Speech, the Arthritis Foundation of Georgia, the Peachbowl Association, Big Brothers of Atlanta, the Atlanta Symphony Orchestra, Warm Springs Foundation of Georgia, and the Board of Governors for Doctors Memorial Hospital of Atlanta all benefited from his selfless service. He was also president of Jackson Enterprises Incorporated, a family owned and operated business.

L.A. "Brooks" McCall

L.A. "Brooks" McCall (*Mu '32*) died on February 29, 1988, at his home in Florence, South Carolina. A 1932 initiate of Mu chapter at Presbyterian College, McCall served Pi Kappa Alpha in numerous capacities including three terms as a national vice president during 1948-1952 and 1960-62. Culminating his involvement in the Fraternity, McCall received the Loyalty Award in 1979 and was inducted into the Memorial Foundation's Order of West Range at the 1986 National Convention in Boston.

Charles W. Matthews

Charles W. Matthews (*Beta Xi '24 University of Wisconsin*), a retired engineer and decorated Army officer credited with saving thousands of civilian lives during the Battle of the Bulge, died on Tuesday, March 29, 1988. He was 83 years old.

A native of Milwaukee, Brother Matthews served with General George Patton's Third Army as a civil affairs attachment commander in England, France, Belgium and Luxembourg during the Battle of the Bulge. One of his duties in that job was evacuating civilians from towns and villages during battles, and relocating them on safer ground.

Prior to his service in Europe, Matthews was a base signal officer at Roswell, NM Army Air Field. After the Battle of the Bulge, he was military government detachment commander in Bavaria, Germany. He left the service with the rank of lieutenant colonel, four campaign medals and several decorations, including the Purple Heart.

Following the war, he moved to Cincinnati in 1945, where he was the principal associate in Ladislav Segoe & Associates engineering firm. In 1965, he went into business for himself as a consultant to firms in West Virginia, Michigan and Ohio. He closed the business in 1975.

A graduate of the University of Wisconsin at Madison, where he was a member of Beta Xi chapter of Pi Kappa Alpha, he had a graduate degree in planning from the Massachusetts Institute of Technology. Matthews was also a member of several engineering and military organizations, as well as the Masons. His biography appears in *Who's Who in America*.

Julius Tracy Jr.

Julius Aaron "Corky" Tracy Jr. (*Beta Nu '49*), of Boulder, Colorado, died Tuesday, February 23, 1988. He was 58 years old.

Tracy was an attorney with Tracy, Thorvilson & Osgood of Boulder until he retired in 1978. He had received his law degree from Southern Methodist University in 1955 and a bachelor's degree in business science from the University of Texas at Austin in 1950.

He was a former board member of the Boulder County Humane Society Boulder Savings & Loan, Majestic Savings & Loan, First S&L Bank Shares, Boulder Jaycees, Kiwanis Luncheon Club of Boulder and Red Dale Travel Club.

He attended Sacred Heart of Mary Catholic Church and was a member of the Nebraska, Texas and Colorado bar associations, the Colorado Real Estate Commission, Boulder Country Club, Boulder Dance Club and Gay Nineties Dance Club.

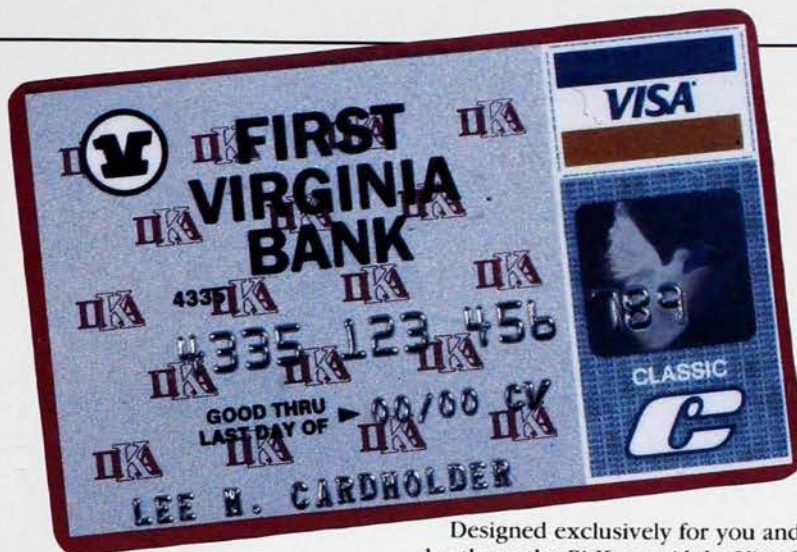
