ORDER.

This is an application under section 498 of the Code of Criminal Procedure for enlarging the accused petitioners on anticipatory bail in Nari-O-Shishu Nirjatan Case No. 33 of 2016 under Section 11(ga)/30 of the Nari-O-Shishu Nirjatan Daman Ain, 2000 (as amended 2003), now pending in the court of Nari-O-Shishu Nirjatan Daman Special Tribunal Court, Madaripur.

The accused petitioners, who have been identified by their engaged lawyer, surrender before this Court.

We have perused the application and heard the learned Advocate for the accused petitioners and the learned Deputy Attorney General representing the State who opposed the prayer for anticipatory bail.

Having considered the above submission of the learned Advocate and materials on record, we are inclined to enlarge the accused petitioners on anticipatory bail for a limited period.

Let the accused petitioner Nos. **1. Noorul Islam Padhaya, 2. Lutfor Nahar, 3. Joynob Bibi, 4. Fakrum Nesa and 5. Alauddin Kibiraj** be enlarged on anticipatory bail in the above mentioned case for a period of 8(eight) weeks from date, on furnishing bail bond subject to the satisfaction of the Chief Judicial Magistrate, Madaripur.

Before the expiry of the period of bail, the learned Judge of the Court below is at liberty to deal with the bail application, if any, of the accused petitioners on merit.

Accordingly, the application is disposed of.
