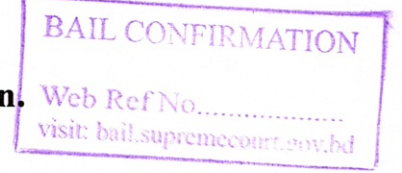

ORDER.

Let a Rule be issued calling upon the Opposite party to show cause as to why the accused Petitioners should not be enlarged on bail in Lalmohon Police Station Case No. 01 dated 02.10.2013 Corresponding to G.R. No. 214 of 2013 (Lal) under sections 143/447/448/323/ 324/ 325/326/307/302/379/380/354/427/506 of the Penal Code, now pending in the Court of learned Additional Chief Judicial Magistrate, Judicial Magistrate Court No. 1, Bhola, and/or such other or further order or orders as to this Court may seem fit and proper.

The rule is made returnable within 6(six) weeks from the date.

Let the Petitioners **1. Md. Mofizul Islam Chunnu son of late Delowar, 3. Md. Elias, 4. Md. Sabuj both sons of Tasir Ahammed and 5. Md. Hanif son of Abdul Halim** be enlarged on bail for a period of **6(six) months** from date on furnishing bail bond **subject** to the satisfaction of the learned Additional Chief Judicial Magistrate, Judicial Magistrate Court No. 1, Bhola.

Petitioner Nos. 2 and 6 is rejected.

The petitioners are hereby directed to put in requisite within 1(one) week from the date of receipt of the order, failing which the Rule shall stand discharged.
