**Order**

Let a Rule be issued calling upon the Deputy Commissioner, Kishoreganj to show cause as to why the accused petitioner should not be enlarged on bail in Kotidadi Model Police Station Case no. 29 dated 30.11.2016, corresponding to G.R No. 315(2)16, under section 19(1) Table 9(Kha) of the Madok Drobbo Niyantaran Ain, 1990, now pending in the Court of learned Senior Judicial Magistrate, Cognizance Court No. 05, Kishoreganj and/or such other or further order or orders be passed as to this court may seem fit and proper.

The Rule is made returnable within **4(four) weeks from date**.

We have perused the application for bail. The learned advocate for the accused petitioner submits that in this case allegedly recovery of **69 pieces Yeaba Tablet**.

The learned Deputy Attorney General representing the State, opposes the prayer for ad-interim bail of the accused petitioner.

Considering the submissions of the learned Advocate of the respective parties we are inclined to grant ad-interim bail to the accused petitioner.

Pending hearing of the Rule, let the accused petitioner, namely **Anowar Miah @ Anar Miah**, son of late Amir Uddin be enlarged on ad-interim bail till disposal of the Rule on furnishing bail bond to the satisfaction of the learned Senior Judicial Magistrate, Cognizance Court No. 05, Kishoreganj.

The concern Court is at liberty to cancel the bail, if the accused petitioner misuses the privilege of bail.
