Nashville Bar Association Releases Results Of Member Poll Concerning the General Session Judge Vacancy

The Nashville Bar Association today released the results of a member poll for the General Session

Judge position left vacant by the death of Judge Leon Ruben. The results of the poll are attached.

"The goal of doing the poll is to provide the media and the public with information. The purpose is

twofold: (1) to encourage the selection of qualified judges and public officials in the judicial system and

(2) to have attorneys who are likely to know these candidates, both personally and professionally,

provide an opinion on their qualifications," said Gigi Woodruff, NBA Executive Director.

A survey ballot was conducted online, with paper ballots available to NBA members without an email

address. The lawyers were asked to comment as to each of the candidates in one of four ways: "Highly

Recommend," "Recommend," "Do Not Recommend," or "No Opinion." Nine hundred twenty-four (924)

responses were received by the deadline of November 9, 2011. All bar members are polled and the

results are reported as raw ballot results with no attempt to extrapolate the results.
