

ASSESSMENT REPORT OF LINECUTTING ON THE ISLAND PROPERTY (Island 1-12, 12a & 13 Claims) HIGHLAND VALLEY AREA, KAMLOOPS M.D., B.C.

INTRODUCTION

During the intervals July 3 to July 15 and March 7 to April 20, 1980, cut lines and surveyed control lines were put in on the Island property by D. Martinson Linecutting and Staking Ltd. The linecutting is to facilitate an IP survey which will commence in August, 1980. In 1979 121 km of E-W oriented lines and 7.3 km of N-S oriented base line were flagged and blazed. In 1980, 21.5 km of E-W oriented lines were flagged and blazed and 18.8 km of N-S oriented control lines were chain sawed, picketed and surveyed. The E-W oriented lines were spaced at 400 meter intervals. No distances were marked along these lines as requested by the IP crew.

LOCATION AND ACCESS

The Island property is situated on the west side of the Guichon Creek Batholith, about 13.5 km ENE of Spences Bridge. The property extends north-south from just south of Mt. Spaist to the Highland Valley and is contiguous with the west side of the Valley Copper claims which include the Tom, B.L., Nancy, EZZ, RAF, MER, NIM, NEL, A, LUV and B. Good road access exists to most of the property via networks of dirt roads extending north from the Pimainus Lake access road or east and south from the OK Lake (Alwin-Dekalb Mine) access road.

TOPOGRAPHY AND VEGETATION

The claim area comprises moderately rolling topography locally dissected by E-W striking gulleys. The area is mostly covered by fir and Jack pine. Elevations range from about 1200 meters to 1550 meters above sea level.

OWNERSHIP

The Island property, located in the Kamloops Mining District, consits of 14 claims totalling 241 units, all 100% Cominco owned. Listed below are the claims, record numbers, numbers of units and due dates.

LINECUTTING

One baseline and two surveyed control lines, all north-south oriented, were put in as controls for the E-W oriented cross lines. The baseline coincides with the east boundaries of the Island claims 12a,1,3,5,6,8 and 10. The two control lines parallel the baseline and are located 1.8 km and 1.2 km east and west, respectively, from the baseline. The east control line is 15.5 km long. Only 5.8 km of this line is on Island property (claims 9 and 11). This portion is being applied for assessment credit on the property. The west control line is 13 km long. The baseline is 11.0 km long.

A total of 142.5 km of E-W oriented cross lines traverse the width of the property. The lines are spaced 400 meters apart. No distances were placed along the E-W lines, as requested by the geophysicists who will conduct the follow up IP survey.

The survey control lines required 46.0 man days to complete at a cost of \$135/man day. The E-W cross lines cost \$120/km.
