COMMISSIONS OF ENQUIRY ACT (Cap. 05:02)

Commission of Enquiry on the Judiciary

His Excellency the President has established a Commission of Enquiry to enquire into the rationalization, restructuring, co-ordination and possible integration of all courts in Botswana. Hereunder are the Terms of Reference -

- 1. (a) To enquire into the desirability of the restructuring of the Superior Courts of Botswana into a single Supreme Court of Botswana with an Appellate Division.
 - (b) In case a single Supreme Court is recommended, then to consider the desirability or otherwise of the establishment of Divisions of the Supreme Court not being the Appellate Division in various geographical areas of the country, and the limitations, if any, which may be placed on the substantive jurisdiction of any one or more of such Divisions.
 - (c) In the event that the Commission does not consider it desirable to create Judicial Divisions of the Supreme Court in various geographical areas as mentioned in subparagraph (b) then to consider the desirability or otherwise of the establishment of a Circuit Court System in order to provide adequate service to every part of the country.
 - (d) To examine the existing Magistrates Courts and the Customary Courts of Appeal structures, and the suitability or otherwise of increasing or widening their substantive jurisdictions, or both.
 - (e) To consider the desirability or otherwise of bringing the appointment and discipline of any or all of the judges of the Customary Courts under the jurisdiction of the Judicial Service Commission.
 - (f) To review the terms and conditions of service including retirement ages of the judges and justices whose appointments come under the jurisdiction of the Judicial Service Commission and those whose appointments are within the prerogative of the President.
 - (g) To consider the adequacy or otherwise of the Constitutional provisions relating to the Judicial Service Commission.
 - (h) To make recommendations in respect of each and every one of the terms herein mentioned. In addition the Commission shall be free to examine and make recommendations in respect of any other matters which the Commission may consider incidental to the proper execution of its recommendations in respect of such terms.


