INTERLOCAL COOPERATION AGREEMENT

This agreement is entered into this 5th day of June pursuant to the Nebraska Interlocal Cooperation Act, Chapter 13, Article 8 of the Nebraska Revised Statutes, by and between the Village of Bartley, Nebraska hereinafter referred to as the Village, and the County of Red Willow, Nebraska hereinafter referred to as the County.

In consideration of the mutual promises and covenants hereinafter made, the parties agree as follows:

1. This agreement shall be pursuant to and in conformance with the Nebraska Interlocal Cooperation Act, Neb. Rev. State. Sec. 13-801 et. Seq.
2. Each party is a duly existing and organized governmental subdivision under the laws of the State of Nebraska.
3. The parties acknowledge that the Red Willow County Sheriff has certain statutory duties and obligations imposed upon him by the laws of the State of Nebraska in regard to the enforcement of State statutes. By this agreement the County agrees to provide Police services for the Village through the office of the Red Willow County Sheriff in regard to the enforcement of municipal ordinances of the Village. Through this agreement the Red Willow County Sheriff shall assume all duties and obligations for the policing, investigation, and enforcement of the ordinances for the Village in the same manner in which said obligations and duties are imposed upon him by statute, and the Village delegates all police power and authority to the Red Willow County Sheriff.
4. In consideration of such services, the Village shall pay to the County the sum of three thousand dollars (\$3,000) payable on or before December 1, ~~2011~~ 2012 *pg*
5. The duration of this agreement is one (1) year.
6. No separate legal or administrative entity is created by this agreement. The manner of financing this cooperative undertaking is provided by the Village paying the County the sum of three thousand dollars (\$3,000) as set forth above. No property shall be acquired to accomplish the purposes of this agreement, except that the County agrees to provide a sufficient number of employees and equipment to the office of the Red Willow County Sheriff to perform the obligations for the County under this agreement. A joint board responsible for administering this joint or cooperative undertaking is hereby created. The public agencies party to this agreement are the Village and the County, and through a separate Interlocal Cooperation Agreement, the City of Indianola, Nebraska. The City of Indianola shall be represented by one (1) elected member of its City Council, the Village of Bartley shall be represented by one (1) elected member of its board and the County shall be represented by the Red Willow County Sheriff and one (1) Red Willow County Commissioner.
7. This agreement does not contemplate the acquiring, holding, and disposing of real and personal property used in the joint or cooperative undertaking.
