

**RICE COUNTY BOARD OF COMMISSIONERS

Please Take Notice: The Rice County Board of Commissioners, Drainage Authority for Rice County Ditch 7 will hold a final hearing on the Redeterminations of Benefits for Ditch 7. The viewers' report was filed with the Drainage Authority and is available for inspection at the County Auditor/Treasurer's office in the Rice County Government Services Building, 320 NW Third Street, Faribault, Minnesota. In addition, pursuant to Minnesota Statute 103E.0801 the Drainage Authority will take testimony or comments to consider the consolidation of accounting records for County Ditch 7 with County Ditch 7 Improvement. The hearing will be held on August 11th, at 9:20 a.m. in the Commissioners' room of the Rice County Government Services Building, 320 NW Third Street, Faribault, Minnesota. The Drainage Authority will accept public comment regarding the viewers' report and the determinations of benefits and damages in the report. Any party having an interest in the proceedings may appear and provide comment. Written comments will be accepted at the hearing and by mail, through the date of the hearing, at the County Auditor/Treasurer's office in the Rice County Government Services Building, 320 NW Third Street, Faribault, Minnesota 55021.
