# 45 Years of Independence

45 years ago, in a detached garage in Northern California, an idea was born — service dogs trained to assist people with physical disabilities. It started with a handful of people united by a common purpose who took a leap of faith to create something special. Now here we are, a national organization leading the way in the service dog industry, with over 6,800 teams matched, six state-of-the-art training centers across the country and thousands of volunteers, donors and staff. It's our aim to achieve greater heights, focus on innovation through cutting edge research, expand our reach by prioritizing inclusion and reduce our waiting list to serve every qualified candidate in need of assistance and a life of greater independence. None of this would be possible without the strength and adaptability from our dedicated community, and for that, we are so grateful.

In 2020, the pandemic did not slow us down. We

adapted our plans and established safety measures to protect the wellbeing of all through on-campus scheduled staffing, remote work, socially distanced Team Trainings, online events and more. Thanks to the dedication of our community and continued support of our mission, we raised over \$27 million. Through careful planning and a motivation to drive our mission forward, 378 working dog teams were placed at a time when the benefits of our mission were needed more than ever.

Our research partners continued their projects throughout the year, exploring which traits may make a service dog successful and ensuring valuable data points from long-term studies weren't missed. Internally, we introduced new technology platforms to improve communications with our volunteers and constituents, allowing us to reach our goals through more efficient software.

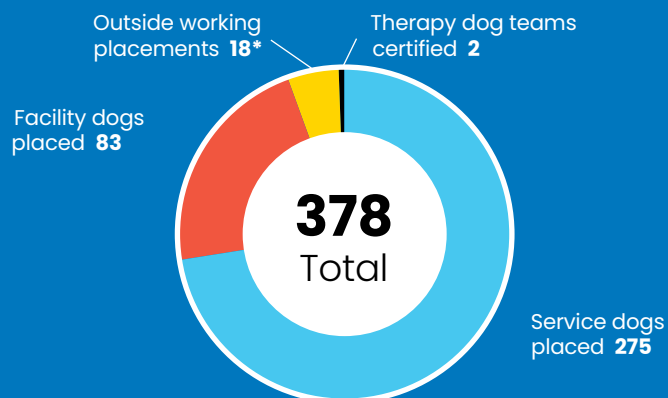

## Training through COVID-19

Canine Companions’ training staff typically have their schedules dedicated to in-person follow-up visits with clients, training dogs on our campuses and teaching numerous Team Training classes throughout the year. The restrictions caused by the coronavirus pandemic prompted a major shift to virtual follow-ups and an innovative hybrid Team Training model — lectures were

taught virtually followed by 10 days of small, socially distanced in-person classes.

Our puppy program managers also had to adjust to the unique circumstances, and they provided hundreds of virtual puppy classes for our volunteers. These collaborative efforts resulted in minimal delays for our program.

# Leading Life With Greater

At 20 years old, Alexis Holmes attends the second largest university in the country, University of Central Florida (UCF). Smart, independent and driven, Alexis lives in the dorms and is working towards a degree in biomedical science.

When she was 12 months old, Alexis was diagnosed with muscular dystrophy, a progressive, genetic disability that causes muscle weakness. Alexis learned to use a wheelchair and often had to ask her parents for help with many day-to-day tasks. In November

2007, Alexis was matched with Service Dog Persia. This life-changing partnership allowed her independent nature to flourish.

For ten years, Alexis had Persia by her side helping to decrease her reliance on the adults around her by assisting with tasks that were difficult to manage on her own. Persia would retrieve a dropped lunch box, pick up pens and pencils, reach a light switch and provide reassurance that Alexis was capable of

being independent with the support of a cold nose and a helping paw. When Persia passed away, Alexis knew another service dog would be a huge help in the next phase of her life.

Alexis began the application process for her second dog, not knowing that her perfect match was not far away. A puppy was growing and learning with Canine Companions volunteer puppy raiser Sarah Crabtree at UCF as part of the university's college puppy raising program.

Alexis and Service Dog Eada were matched in 2020.

"My parents were nervous about me going to UCF alone. They feel much more comfortable now that Eada is by my side," shares Alexis. Service Dog Eada is trained in over 40 commands to ensure Alexis can live on campus safely and independently. "I have Eada here, and I know I will be okay."

Alexis will graduate from UCF next year, and with Eada's help, she plans to move out of state for graduate school to pursue her dream of becoming a genetic counselor.

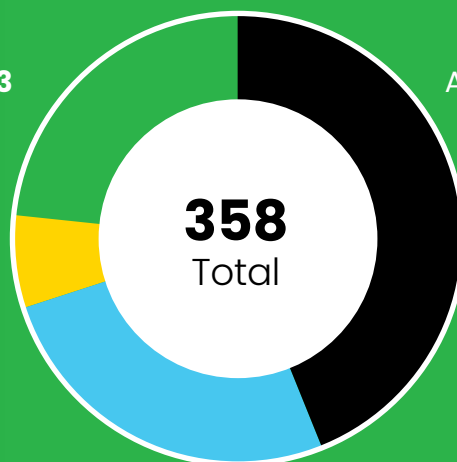

Two sons, Owen and Chris, and five puppies later, the Leipelt family has exemplified the core values of our mission in their home. "The biggest part for me is having the boys see what we do and why we do it — we're doing something good for somebody else," explains John.

Jayden says, “She is the best dog in the whole world!” And in November, the ninth puppy they raised, Emery, entered professional training at our

Northwest Region Training Center. We are so grateful to the Leipelt family and the foundation they provided to puppies they raise. The family is currently waiting for their next Canine Companions puppy – number 10!

# Groundbreaking Research Helps Shape the Service Dog Industry

## Where's the treat?

Puppies were tested at 9 weeks and 21 months on their ability to follow social cues to locate the treat. This result shows that canine-human communication is present from a young age.

In 2017, Canine Companions teamed up with long-time collaborators at Duke University and the University of Arizona. We began tracking cognitive development in 168 Canine Companions puppies, starting at approximately 9 weeks of age and continuing through adulthood. In 2020, the initial findings from our study were published in the peer-reviewed journals *Animal Behaviour* and *Animal Cognition*.

Through fun and interactive games, everything from the puppy's memory to problem solving to social cues (like following a human pointing) were put to the test. These activities have helped researchers better understand the ways puppies learn and process information.

The group of puppies came from 65 different litters, and the ability to retest the same group at 21 months allowed the research to focus on the change in their cognition over time. Ultimately, our findings show that many traits emerged early and they consistently improved with age. A prime example was impulse control – which requires time to develop, just like in humans. A few traits did not change with age, such as a puppy's preference to step first with their right or left paw. Additional findings documented that for some traits, including a puppy's tendency to initiate eye





contact with humans in social situations, a puppy's performance was consistent over time. In other words, socially attentive puppies grew into socially attentive dogs.

This one-of-a-kind study will be a major breakthrough in the service dog industry as the findings can help inform everything from breeding decisions to training techniques. Dr. Emily Bray, Canine Companions staff member and postdoctoral research associate with the Arizona Canine Cognition Center at the University of Arizona, shares, "What is exciting about this research is that it is by far the largest longitudinal study of puppy cognition, and it is our hope that these findings will be relevant not only to Canine Companions but also to service dog organizations all over the country."

The results of this research will increase our ability to understand how genetic and environmental factors play a role in service dog success. The puppy cognition study was one of nine active research studies in 2020 that focused not only on canine cognition but also the health of our dogs and the impact they have on the clients that receive them.

# Creating Community and Change

John Elliott has been a trailblazer for Black men in business since he graduated from Western Illinois University. Inspired by the important educators in his life, John pursued a degree to become a teacher. When John graduated, he had more than just a diploma, he had met a young lady who became his wife, Joann.

In 1964, John began his teaching career in Kankakee, Illinois. "I was one of two Black educators in one of the two junior high schools in town. To say the schools were integrated was a bit of a stretch, but Black and white students attended both junior highs. My early experiences were mixed," shares John. "I was a 22-year-old teacher who was well accepted by the students, Black and white, but I struggled with the attitudes of some of the older white teachers."

After leading a student walk-out, John was noticed by the superintendent and the school board president. That recognition led to John being invited to join the superintendent's staff as the district's director of student activities, the district's director of public relations, and to create and teach the first Black history course in the district.

John gained a powerful reputation from that role, leading him to meet a local real estate mogul and owner of four car dealerships, Ed Bergeron. Bergeron not only introduced John to a new career, ultimately as president and CEO of several school transportation companies, but also to one of his favorite charities in Santa Rosa, California — Canine Companions.

In 2001, at the recommendation of the Bergeron family, John and his wife Joann joined the Canine Companions national board to strengthen it and bring in a new perspective. "It didn't take long for us to recognize the tremendously positive impact Canine Companions has," John says. "I have told many that our involvement with Canine Companions has made us better human beings. Joann and I had the privilege of being able to serve on the board for almost 19 years. The board is the finest group of people we have ever had the honor to be around. The staff and all the workers at every level in Canine Companions bring a smile of gratitude to my face just knowing they are there."

Recently, John facilitated the donation of six wheelchair accessible vans for our campuses that will allow our professional training staff to transport power wheelchairs on field trips for the first time. The impact of this gift is immeasurable — Canine Companions service dogs in professional training can now be exposed to the kind of transportation they may encounter as a service dog.

John is mostly retired now, but he continues to be a donor and an active leader in the Canine Companions community. Currently, he is serving as an advisor for Canine Companions' Inclusion and Diversity Initiative, helping ensure we are accessible and inclusive to all communities in every facet of our organization.

# Finding the Light Again

“He has impacted my life in the biggest way. He has helped me be independent.”

Stephen Dillon loves writing poetry and playing his guitar. Many see him as a loving and creative person with a passion for learning, but what isn't so obvious is an invisible disability that impacts every aspect of his life.

Stephen served in the United States Marine Corps for 10 years. As a result, he now has post-traumatic stress disorder (PTSD) which impacts his day-to-day life. For people living with PTSD, small things can feel monumental. Going out in public can cause anxiety, flashbacks and feelings of being alone even in a crowd. These are just a few of the symptoms of this complex disorder.

Stephen was ready to ask for help and find solutions to better cope with his symptoms. After doing some research, he learned about Canine Companions and the incredible impact our service dogs have on the lives of veterans with PTSD.

Matched in 2020, Stephen received expertly trained Service Dog Sven. Some of the 40 commands Sven can complete include interrupting nightmares, creating a buffer in a crowd, and picking up dropped items — a task that is extremely helpful since Steven has nerve damage in his back from his military service.

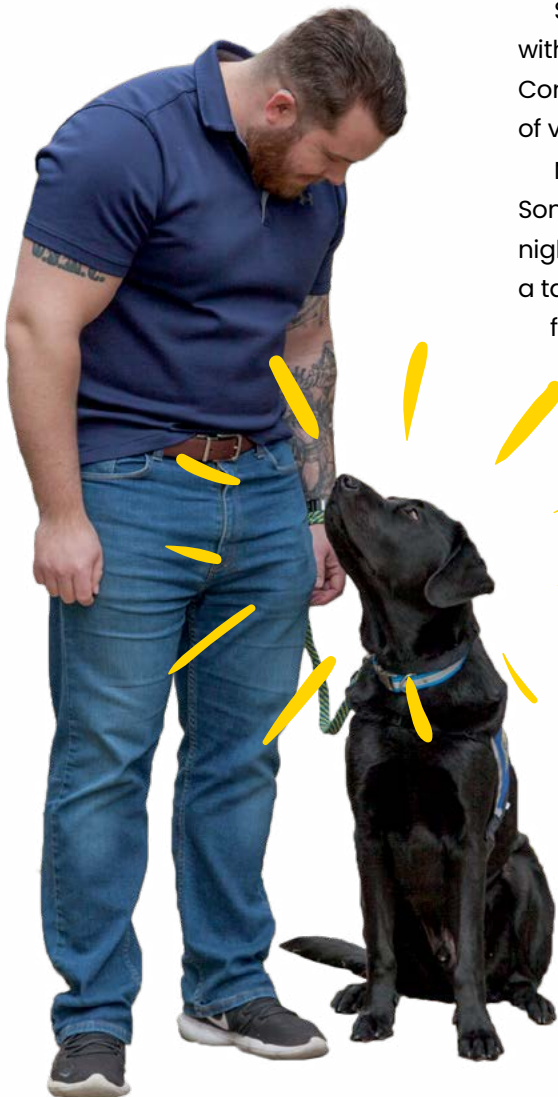
“He has impacted my life in the biggest way. He has helped me be independent. Being able to do simple things such as going to the grocery store became so hard for me,” explains Stephen.

“Because of Sven, the tasks he can do allow me to feel normal again. There are no words that can describe how happy and purposeful it makes me feel.”

Canine Companions has been serving veterans since 1975 and began training service dogs for veterans with PTSD in 2015. The program has grown, now training these life-saving service dogs in California, Texas and our Northeast Region. We have placed 100 service dogs with veterans with PTSD through 2020.

Thanks to the assistance of Canine Companions Service Dog Sven, Stephen's future is looking brighter. Stephen says, “Sven helps so much when I am feeling overwhelmed. These simple tasks help me so much. I can go anywhere now and not worry about how my reaction could cause a negative experience for my family and myself. It truly is amazing what these dogs can do.”
