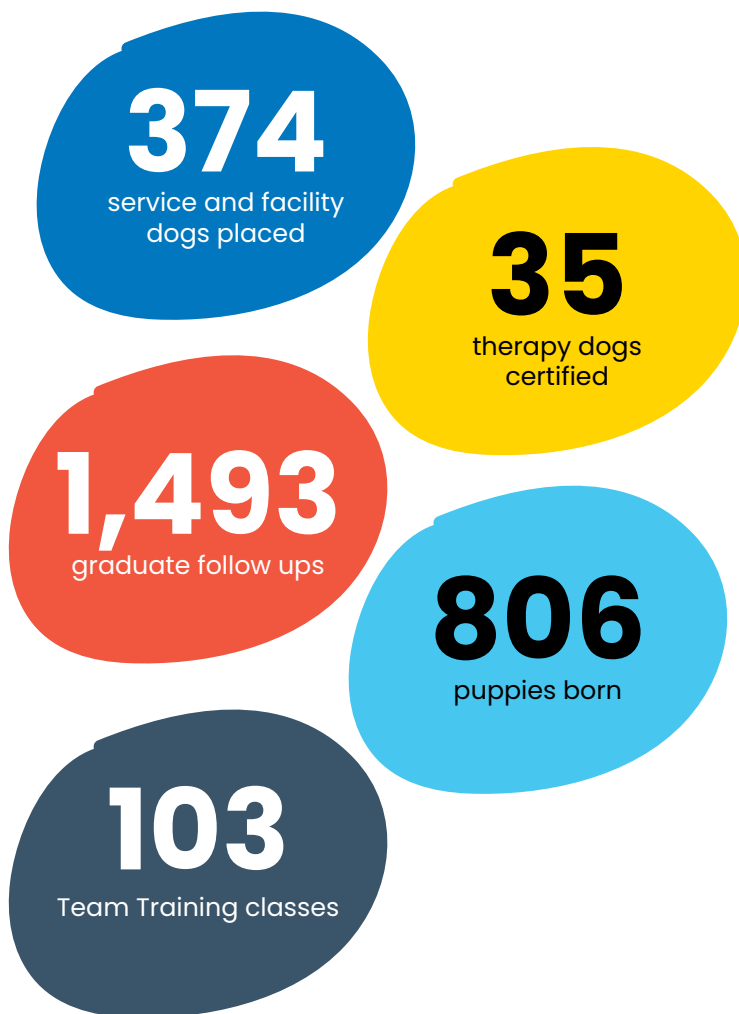

## Making Our Mission Possible

During the past year all of us again faced many challenges. But we also have witnessed the incredible impact of the strength and determination of so many people. This couldn't be clearer than at Canine Companions where the loyal support and commitment of our community has not only helped us through these difficult times but also allowed us to continue to pursue our mission and the goals of our strategic plan. The great need for our expertly trained service dogs continues for people with disabilities, especially in these hard times.

During 2021, we continued to empower people with disabilities to live with greater independence. With the commitment of our incredible staff and the support – both financial and otherwise – of our community nationwide, we were able to:

- Place 374 assistance dogs and serve 2,653 active teams.
- Hold 1,500 client follow-up meetings to ensure that our teams are functioning well.
- Reach an estimated 5.2 million people through our clients' interaction with their family, friends and community in addition to the stories we are able to share with the world.

The true impact of our supporters on our mission can be summed up in the statistics and information on every page of this report, and we encourage you to read those numbers and the unique stories of our donors, volunteers and graduate teams.

We also grew our mission in additional ways, broadening our impact:

- We expanded our PTSD and therapy dog programs.
- We continued to conduct research, often in partnership with universities, to determine ways in which we can improve the percentage of our dogs that can be successfully placed with clients.
- We applied lessons learned during the pandemic which allowed us to develop virtual and hybrid approaches for our outreach efforts, events and follow-up programs.

Of course, all of this requires your support. Thanks to the generosity of so many people, we were able to raise over \$43 million in support of our mission.

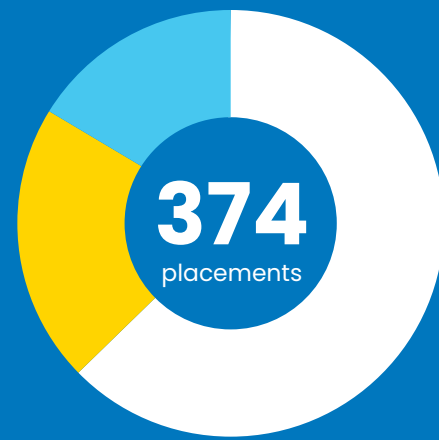

## Twice the Independence, Twice the Joy

The Copp family is blessed with two sons, Calan and Lawson. The boys are typical brothers – they joke and laugh, occasionally bicker – but they share something most brothers don’t. Calan and Lawson have a rare genetic disorder with only 20 known cases in the world that affects their mobility and cognitive development.

Calan and Lawson rely on wheelchairs to get around. It was difficult for them to navigate their world until the family received their two life-changing Canine Companions service dogs. Calan was partnered with Service Dog Jaia in 2019, and Lawson was matched with Service Dog Jolt in 2021.

“Jaia and Jolt retrieve crayons, tug open doors and help Calan and Lawson be more confident. We see our boys being more independent every day thanks to Jaia and Jolt,” Jody, the boys’ father, states.

The service dogs’ tasks are also incorporated into physical therapy to make exercises fun and provide motivation. They act as a social bridge in public and have made playtime beneficial for Lawson and Calan.

“We didn’t think about how much the boys’ motor skills were going to improve by having service dogs,” the boys’ mother, Melissa says. “They were born with no muscle tone, so building it up over time has been our number one priority. We didn’t realize that fetching balls or playing tug of war on command would be a key component to building muscle tone and the service dogs are a vital part of that.”

Melissa remarks that the brothers think it’s the coolest thing to have a dog help them with tasks throughout the day. The furry best friends help increase confidence and independence.

“Jaia and Jolt provide us with so much intangible and tangible support that we couldn’t imagine not having them in our lives,” states Melissa. “We may fill up an entire elevator and take up the whole side of an aisle in a grocery store now, but we wouldn’t have it any other way. Service Dogs Jaia and Jolt changed our family for the better and opened the world for a pair of exceptional brothers.”

## It All Starts With A Puppy

In the Indianapolis airport 25 years ago, Sharon and Bill Mosbaugh spotted a Canine Companions puppy traveling with its volunteer puppy raiser. Inspired, Sharon went on to raise two Canine Companions puppies and worked for 13 years with a facility dog in her elementary school as assistant principal.

Sharon wanted to do more for Canine Companions, so she and her husband, Bill, jumped wholeheartedly into the mission as volunteer breeder caretakers. Bill and Sharon have had 198 Canine Companions puppies born in their home. In 2021, they brought 10 more puppies into the world, from the first cry until 8 weeks old.

Their first breeder, Patina, would go on to be “grandma” to more than 100 puppies from Sharon and Bill’s four successive breeder dogs. The couple also helps breeder caretakers who need assistance.

“I love being a breeder caretaker. When I send a litter of puppies off, I feel like I’m sending love out into the world! I know, wherever they go, they spread unconditional love,” Sharon says. “These dogs have taught me how to be better at loving unconditionally.”

Bill and Sharon got even more love when they welcomed Service Dog Zari into their home. Bill, a Vietnam veteran living with Parkinson’s disease, now has Zari to tug him out of his chair and retrieve his medication bag. These jobs were previously done by Sharon, but Zari has allowed Sharon to step back and watch Bill be more independent.

“It’s amazing,” Sharon shares. “We started with a facility dog, and we knew what a service dog could do, but Zari has changed our lives. She makes life fun and she makes life easier.”

Even as they benefit from the mission of Canine Companions as a graduate team, Sharon and Bill continue to give back to help others receive life-changing service dogs, 198 times and counting.

Every morning, Trulette Clayes and her husband Jeff Partrick stroll the beach near their home in La Jolla, California. A chance encounter with volunteer puppy raiser Mary Milton and Canine Companions puppy Emmett would become a frequent high point in Trulette and Jeff's walks. The next run-in with Mary led to Trulette learning more about the life-changing mission of Canine Companions and an opportunity for an outstanding gift.

## A Walk to Remember

Trulette's Uncle Joe – a generous man who adored dogs – established the Joseph Clayes III Charitable Trust to fund organizations that work with a variety of Joseph's interests. Trulette was named as a trustee along with her uncle's longtime friend and business partner, Brendan Holmes.

"My uncle had a Golden Retriever named Toby that he was madly in love with," Trulette says fondly. "The mission of the trust was very clear that it should support organizations serving children and dogs." Joe gave Trulette and Brendan the responsibility of choosing charities to support, and after Trulette's morning chats with Mary on the beach, Canine Companions was top of mind.

"I know my uncle would have enjoyed Canine Companions' program and mission," states Trulette. "It's fabulous what Canine Companions does to help people who need assistance. Meeting Mary was just the perfect place and time."

In 2021, the Joseph Clayes III Charitable Trust generously donated a \$250,000 endowment gift to Canine Companions' Southwest Region that will help support our mission for years. As trustees, Trulette and Brendan chose to create an endowment specifically because of the ongoing support it provides and the impact it has to place service dogs free of charge. Thanks to their endowment gift, the Southwest Region's main training room is now named in Joe's honor.

"I am honored to be part of the Canine Companions family. I continue to spread the word about the mission because it is so wonderful."

Trulette and her husband continue to see Mary and her newest Canine Companions puppy on their daily walks, brightening their days and sharing in a cause they all love.

## Giving Independence and Security

Doug Erickson and his wife, Nancy, needed help. Nancy was born with myasthenia gravis and was living with progressive muscle weakness. In

1992, searching for help wasn't as easy as turning to the internet for answers. Instead, they

turned to family. Nancy's parents were friendly with Peanuts® creator, Charles Schulz, and his wife Jean, and remembered their involvement in an organization called Canine Companions.

Soon, Nancy and Doug welcomed Service Dog Nikki into their lives, allowing Nancy to live more independently and to rely less on Doug. "In the moment of meeting Nikki, Nancy was overjoyed! The connection was incredible," remembers Doug.

Nikki worked for nearly 11 years, dying one year before Nancy, herself. Although Doug had been supporting Canine Companions as a monthly donor since 1994, he was uncertain what relationship he would have with the organization when Nancy died. He decided to continue his loyal support of our mission through monthly giving.

In 2018, Nancy's father died, leaving a legacy gift in Nancy's honor to Canine Companions. After learning about the family's incredible journey with Canine Companions, our Minneapolis Volunteer Chapters reached out to Doug. The volunteers welcomed Doug as family.

Over the past 30 years, Doug has played many roles in supporting Canine Companions—family of a graduate, donor, Heritage Society member and volunteer. As an annual donor, Doug makes qualified charitable distributions directly from his IRA.

"Canine Companions impressed me as a high-quality organization with such integrity. Many aspects of the organization need funding, and I can do that! Why not find a cause you can enjoy giving to?"

Doug says the real gift was Nancy gaining a new dimension of independence and security when she was partnered with Nikki. "I am blessed to be part of the Canine Companions story. It's an honor to be able to make these gifts to keep such an outstanding organization helping others like Nancy."

## Peace of Mind for Veterans Through Innovative Research Partnerships

The Department of Veterans Affairs (VA) estimates that 20–30% of veterans live with post-traumatic stress disorder (PTSD) and approximately 18 veterans die by suicide every day. Looking for alternative therapeutic treatments, the VA established a study on the efficacy of service dogs and emotional support dogs for veterans with PTSD.

Canine Companions was selected to participate in the four-year VA study providing trained service dogs and emotional support dogs. Over the course of the study, Canine Companions placed a total of 99 dogs with veterans. In 2021, the results were released; Veterans paired with service dogs showed less suicidal ideation and more improvement in mental health than those paired with emotional support dogs.

"Service dogs provide a significant therapeutic benefit for veterans with PTSD," says Dr. Brenda S. Kennedy, Canine Companions vice president of canine health and research. "Reduced symptoms of anxiety can be seen as early as the first night of placement."

Service dogs are trained in PTSD-mitigating tasks

including creating a buffer in public, and anxiety and nightmare interruption. VA study participants were given the opportunity to transition to formal Canine Companions graduates after exiting the 18-month observation period.

VA study personnel share, "Canine Companions demonstrated the highest level of expertise in pairing service dogs with veterans and has gained extensive experience interacting with veterans with PTSD. They are a trusted leader in the service dog community."

Canine Companions has been placing task-trained service dogs for veterans living with PTSD through our Veterans Initiative™ since 2015 – expanding our PTSD training program to three of our training centers in 2021.

Looking forward, we are working with Purdue University's OHAIRE Lab in the Center for the Human-Animal Bond to further explore the impacts of task-trained service dogs on the mental health and wellness of servicemembers and their families, including severity of PTSD symptoms and social connectedness over time.

# Helping Our Veterans. Better.

"People say that freedom isn't free," Omar Domenech says. "I spent 38 months in a warzone in the U.S. Army. After that, my psychological and physical 'tanks' were empty."

Omar already had a degree in social psychology, but upon seeing the scores of other veterans who were not comfortable asking for help with post-traumatic stress disorder (PTSD), he returned to school to get a master's degree in social work. Omar began to work with other combat veterans in need of assistance as a social worker. But he still felt like something was missing that prevented him from being his whole self. In 2021, Omar was paired with Service Dog Bernard – specially trained in physical tasks including anxiety and nightmare interruption to mitigate the symptoms of PTSD.

When the PTSD program began, long-time donors Nancy and Terry McGraw knew there was a huge need for trained service dogs for veterans. They stepped up to generously provide funding to expand the program in our Northeast Region. This year, the McGraws gave significant financial support for the PTSD program for the third consecutive year.

"When veterans get to talk about how their dog has changed their life, it makes us so proud to be part of an organization that can make such a difference. There's nothing like it," Nancy says. Terry agrees. "We are so incredibly pleased to see the success and impact the PTSD program has had on these veterans' lives."

The benefits of having a service dog have been immensely helpful for Omar, even beyond the help Bernard provides for his PTSD. Bernard is by Omar's side, helping veterans heal from different traumas – memories, survivor's guilt and other effects of war. Clients can relate to Omar as a combat veteran and share more freely. Bernard's presence diffuses tension.

"I live with a lot of trauma," states Omar. "Bernard is amazing. He'll put his head on my lap during moments when I have anxiety triggers or I'm disconnected. He always brings me back. With Bernard, I can feel like myself."

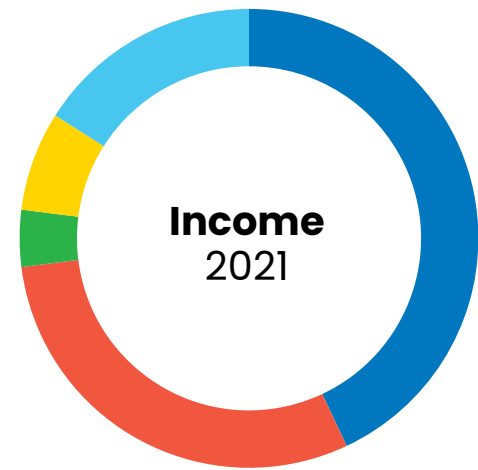

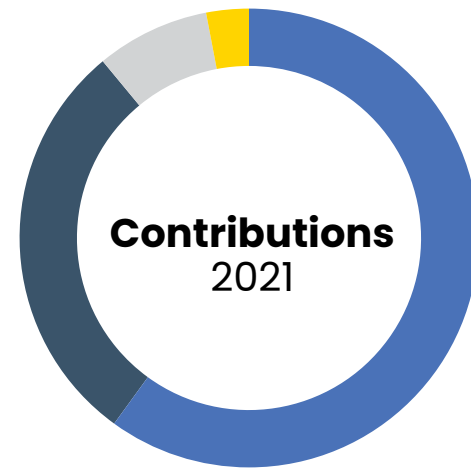

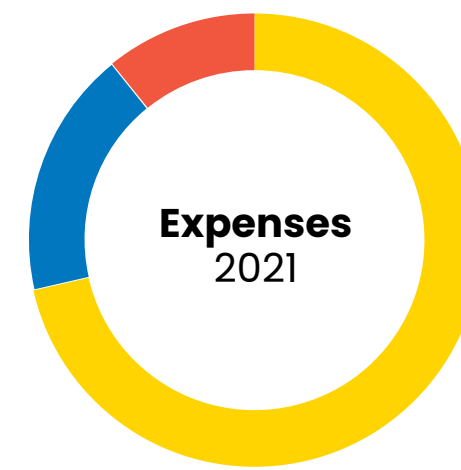

In 2008, Thida Cornes – who has a rare form of dystonia – was raising two young children with her husband, Castor. Thida learned that her best chance of being more independent could come from a Canine Companions service dog. She applied to Canine Companions, and over the years, has thrived with the assistance of her four service dogs, Hermione,

Tovi, Nakoma and Jeeves. In 2021, Thida and Service Dog Jeeves were the 7,000th graduate team placed since our doors opened in 1975.

“My partnerships with Canine Companions service dogs have transformed my entire life giving me freedom, independence and dignity I didn’t even know I was missing,” she says. “I’m honored to have been the 7,000th team.”

With the help of her service dogs, Thida has done things she says she never thought possible, like volunteering, serving on Canine

Companions’ regional board, traveling and hiking. She wanted to pay it forward so other people with disabilities could experience the transformative love and enhanced independence of a service dog.

Thida joined the Heritage Society – a dedicated group of supporters who have included Canine Companions in their estate plan. Legacy gifts are vital to our long-term financial stability. Such gifts honor the loving dogs that have been instrumental in keeping our clients safe and independent.
