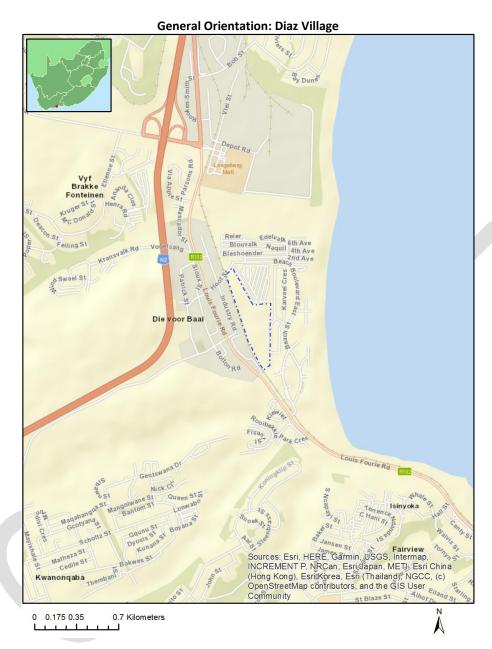

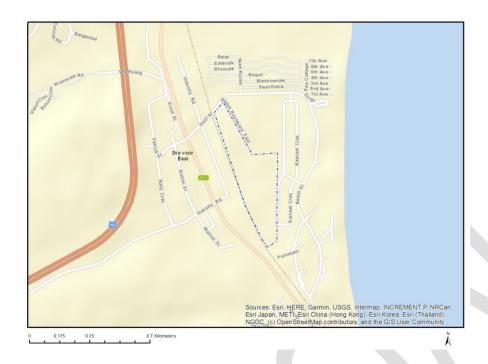

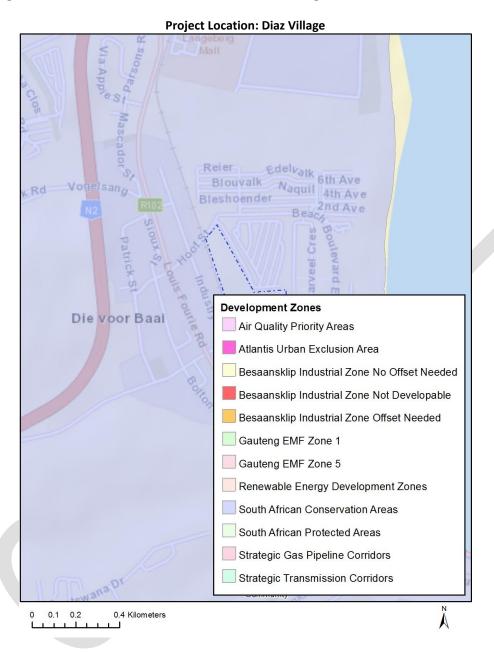

#### MAP OF RELATIVE ANIMAL SPECIES THEME SENSITIVITY

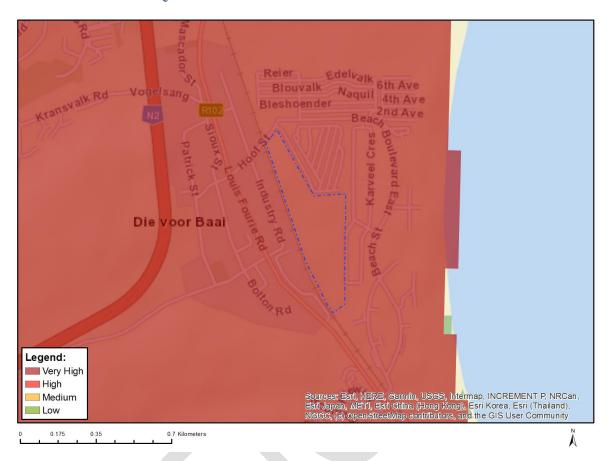

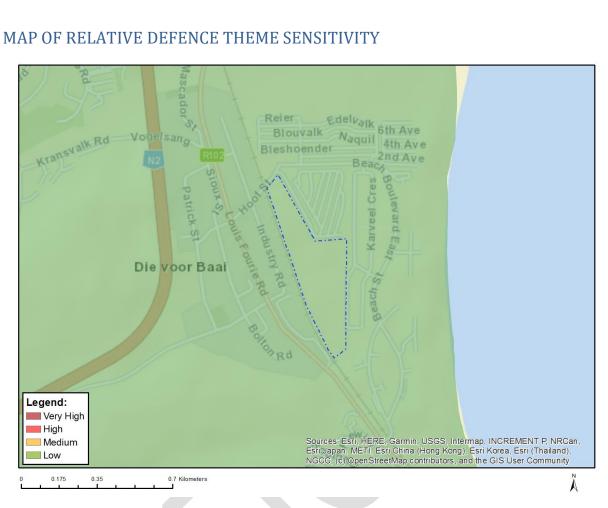
### MAP OF RELATIVE CIVIL AVIATION THEME SENSITIVITY

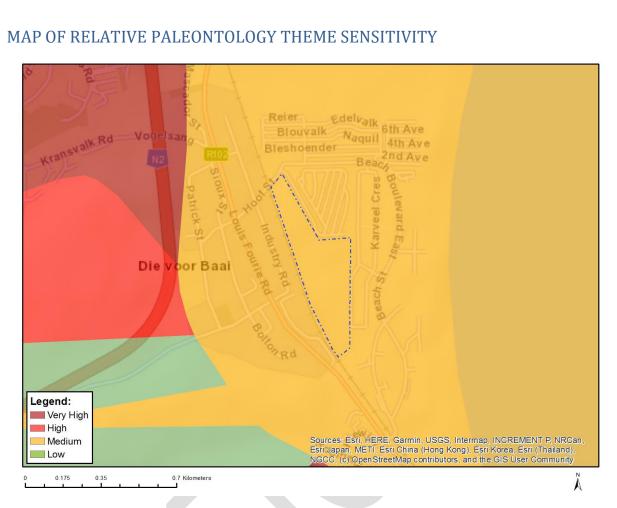
### MAP OF RELATIVE DEFENCE THEME SENSITIVITY

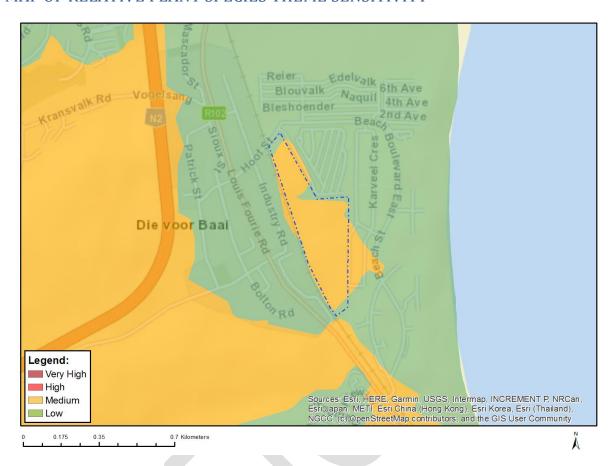
# MAP OF RELATIVE PALEONTOLOGY THEME SENSITIVITY

#### MAP OF RELATIVE PLANT SPECIES THEME SENSITIVITY



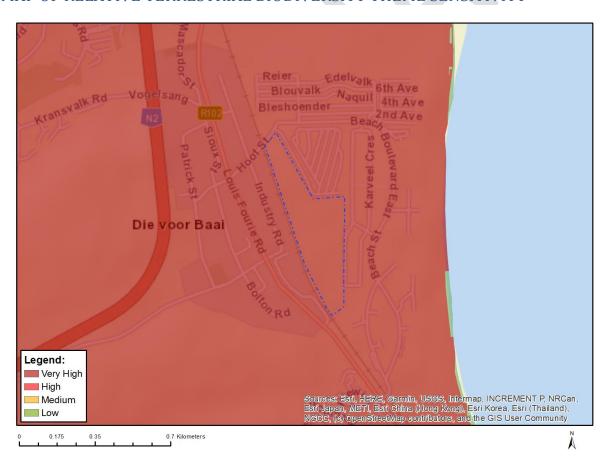
