

President's Message

Last fall, following our tremendous success with the Columbus Week Celebrations, I received a letter from His Eminence Edward Cardinal Egan in which he resolutely addressed an important matter. Cardinal Egan was aware that we had helped focus nationwide attention on the negative stereotyping of Italian-Americans in a movie for children, "Shark Tale." Cardinal Egan wrote, "The recent efforts of you, the Columbus Citizens Foundation, and many other individuals and organizations to uphold the dignity of Italian-American people and culture are most commendable. Please allow me to express my appreciation for what you have been able to



accomplish, along with my support and encouragement of the work still to be done." He continued, "We must always remember that when one group is attacked, all are attacked. The work that you have been doing is important and needed."

Cardinal Egan's letter should make each of us proud of our efforts to promote the heritage and culture of Italian-Americans and to support those in our community who have few advantages in life. Our successes are based on the generosity of our Members, and this newsletter brings everyone up to date on our efforts to fulfill our goals and mission.

The Foundation's Membership continues to grow strongly. In the past year, 33 men and women, many of them young, have joined the Foundation under the guidance of John Cioffi, Chairman of our Membership Committee. Our Members continue to consider carefully and propose leaders in a number of fields – law, medicine, business and education – who will support the Foundation's activities. Please make these new Members feel welcome by introducing yourselves when you see them at the Foundation.

Cultural events continue to be a large part of our calendar. This year, Dr. Frank Celenza hosted three Opera Nights at the Foundation, the 63rd, 64th and 65th such events he has held in the Townhouse. This year, he focused on the shift in Italian opera to the style of *verismo*, which celebrates the passions and struggles of the common man.

Another educational event took place on February 25th, when Karen Lemmey Orpianesi, the 2003 Franco Zeffirelli Scholarship for the Arts recipient, reported on her studies in Florence. She revealed that American sculptors of the 19th century often found inspiration in Italy. On their return to America, they incorporated Italian classical ideals in works that can now be seen in New York City and Washington, D.C. It was a pleasure to learn in a new forum about the cultural exchanges that have long taken place between Italy and America and to contribute to that rich tradition.


Our fund-raising efforts continue to grow dramatically. Kathryn Licata, President of the Ladies Auxiliary, reports on the success of their events of the past year, and Frank Zimbaro, President of the Young Adults Auxiliary, reports on their activities, which introduced the Foundation to hundreds of people.

This year, our scholarship and grant programs will distribute approximately \$2.1 million to 608 students from elementary school through college. This represents a three-fold increase over our scholarship programs of five years ago and a 17-fold increase over our giving of 10 years ago. This expansion includes our Elementary School Grant Program, now in its second year, which is helping to make a critical difference in the education of nearly 100 young Italian-American students. Our community is indebted to Frank Fusaro, Chairman of our Philanthropic Committee, John A. Loconsolo, Chairman of the College Scholarship Committee; Vincent M. Toscano, Chairman of the High School Scholarship Committee and Richard J. Naclerio, Chairman of the Elementary School Grant Committee.

Louis Tallarini, General Chairman of the Columbus Week Celebrations, is hard at work organizing this year's Events. He has secured Joe Piscopo as co-anchor with Maria Bartiromo for the WNBC broadcast of the Columbus Day Parade and as a guest and

Q&A with Louis Tallarini, Chairman, Columbus Week Celebrations

Louis Tallarini is currently at work organizing the Foundation's Columbus Week Celebrations for the sixth time. Since becoming Chairman, the Columbus Weekend has grown from a two-day event to a full week of celebrations. We sat down with him recently to talk about the Columbus Week Celebrations.

When did you become a Member of the Foundation?

It was in 1979, when I was 32 years old and extremely proud of my Italian heritage. My grandparents immigrated to America in the 1890s, from Rome and Bergamo on my father's side and from Calitri and Lacedonia, in Campania, on my mother's side. The Foundation was an opportunity for me to become involved in Italian-American affairs and to meet and socialize with many other successful Italian-Americans.

How did you become what was then Weekend Chairman and has recently become Columbus Week Chairman?

I had gotten more and more involved in the Foundation. I'd sponsored about 10 people for Membership and had served on the Cultural Committee. In 1999, John Loconsolo recommended me as Weekend Chairman to then Foundation President, Ambassador Charles Gargano. I was Weekend Chairman in 1999 and 2000 and from 2002 through today.

Was becoming Weekend Chairman what you expected?

My initial impression was that we weren't really taking advantage of the importance of the Columbus Weekend, and especially the Parade, which is one of New York's great cultural events. We needed to rethink how we were promoting it. Fortunately we had a lot to work with thanks to the efforts of my predecessors. When I came on board, Frank Fusaro was Parade Chairman, and he was already working to bring it to another level – it received an Emmy nomination! We needed to bring the entire Weekend up to that level. I organized the Weekend into a business venture by putting in place reporting procedures with the Chairmen of the Weekend Committees and the Foundation staff. We also set goals and budgets for all of the vital areas.

performer at our Gala Dinner at the Waldorf Astoria. (This is Maria's 10th year anchoring the Parade, and she is co-chairman of this year's Dinner with Angelo Vivolo.) Louis has also secured Salvatore Licitra, the most exciting new tenor of the Metropolitan Opera House, to sing the national anthems at the Gala and to perform at our Mass in St. Patrick's Cathedral the morning of the Parade. Please attend the Mass, but you must obtain tickets in advance through the Foundation office.

In this issue, Louis Tallarini brings us up to date on the Foundation's growth through the Columbus Week Celebrations and discusses our mission and goals. Take a minute to read Louis's insightful observations about our activities as we gear up for another highly successful week that celebrates Italian-American achievement and culture.

I am pleased to report that Supreme Court Justice Antonin Scalia has accepted our invitation to be Grand Marshal of the 2005 Columbus Day Parade. Justice Scalia is the first Italian-American to sit on the Supreme Court and the highest ranking Italian-American in our government. He is widely considered to be the best legal mind on the Supreme Court by people across the political spectrum.

Our Honorees for this year's Columbus Week Celebrations reflect our concerns about freedom, justice and security. Our Special Honored Guest from Italy is Franco Frattini, Vice-President of the European Union and its Commissioner responsible for Justice, Freedom and Security. Previously, President Frattini served as Minister of Foreign Affairs of the Republic of Italy. Honoree Pasquale J. D'Amuro has been at the forefront of America's war on terror. Since April 2005, Mr. D'Amuro has been Chief Executive Officer of Giuliani Security and Safety LLC. Previously he was Assistant Director in Charge of the Federal Bureau of Investigation in New York and Executive Assistant Director for Counterintelligence and Counterterrorism.

We are also honoring our own Frank G. Fusaro, who has been an enthusiastic and dynamic supporter of the Foundation. He is currently Vice-President and has served as Treasurer and as Chairman of the Columbus Day Parade. Perhaps most importantly, Frank conceived and implemented the Adopt-A-Scholar Program, which has raised nearly \$5 million in scholarship funds in the past four years.

I hope you enjoyed a restful and productive summer, and I look forward to reporting on what will be a series of outstanding 2005 Columbus Week Celebrations in the fall.

We also created a formal marketing program to develop data and presentations to potential sponsors, which included creating a marketing brochure and promotional DVDs. In terms of print media, we initiated the insert we now have in the New York *Post* the week before the Parade, which includes several articles about the Foundation's work, scholarship recipients, Italy and – every year – an article about pizza, which the *Post*'s editors love.

I delegated the responsibility of various aspects of the Weekend to the individual Weekend Committee Chairmen, and they came back with great ideas and we implemented them.

How did it become the Columbus Week Celebrations?

By being aggressive in pursuing sponsorships and expanding our cultural offerings, we grew. We've always had commercial Italian sponsors, like Barilla, which is in the Parade this year, but in the past few years we've really pursued sponsorships from Italy. The Italian regional and local governments realized that sponsorship was worthwhile because of the platform we can offer them. We developed a series of events that promoted our sponsors and at the same time gave the Foundation recognition. These events were also self-funding and raised funds for our scholarship programs. For instance, in 2002, we premiered Franco Zeffirelli's film, "Callas Forever" in the Ziegfeld Theater, and proceeds from the event endowed the Foundation's Franco Zeffirelli Scholarship for the Arts. In 2003, we produced two art exhibitions and hosted a concert by the Italian Navy Band aboard the Intrepid Sea, Air & Space Museum. In 2004, we produced "Mario Andretti" and "Lombardy," exhibitions at Grand Central Terminal's Vanderbilt Hall and musical and dance performances at Rockefeller Center that were seen by millions of people. And because of the support we have received from WNBC, there's been greater interest in our events and the Parade itself.

Why do we have so many Italian sponsors these days?

There's a universe of mutual friendship, good will and recognition between Italy and the Italian-American community in the United States. It's also important for the Foundation to operate on an international level so that our contributions are recognized both here at home and abroad. More importantly, Italy is the home of our ancestors and the source of our heritage. We celebrate this and instill its importance in our children. Not to mention that Italian contributions to the Foundation further our cultural and philanthropic goals.

How do you get Italian sponsorships when they are an entire ocean away?

These are relationships we have to cultivate, and one of the pleasures of being Columbus Week Chairman is going to Italy with the Foundation's President and Italian Affairs Chairman to meet with potential sponsors. These face-to-face visits are essential to forging successful relationships, even though the trips are costly for us individually: we have an official policy that Members must pay for all their own travel and travel-related expenses while conducting business on behalf of the Foundation.

How important is Columbus Week to the Foundation's goals?

It's critical. The Columbus Week Celebrations are the heart and soul of this Foundation. It's the platform through which we express our Italian heritage in New York and around the world and remind people of our great culture. It is also crucial to our fund raising efforts. Without Columbus Week, we would have been absent well over \$1 million in scholarship funds during each of the past four years. We wouldn't be able to accomplish what we do. To look at it another way, Columbus Week earnings provide over half of the funding for our scholarship programs, which means that this year well over 100 four-year scholarships can be attributed to the Columbus Week Celebrations. The scholarships are for young Italian-American students who otherwise would be unable to attend a school of their choosing and for which they are qualified.

Our growth has been dramatic. In 1999, my first year as Weekend Chairman, we awarded 39 scholarships in the amount of \$440,000. This year, we awarded 224 new scholarships that total \$2.4 million – which is more than a five-fold increase.

What is your vision for the Foundation?

We need more cultural events at the Foundation, as well as more social events and more Membership participation. Our Members have a great deal to offer each other, and we need to build platforms where exchanges can happen.

At the same time, we have very strong leadership. In the past 10 years, our Membership has doubled in spite of the normal five to seven percent rate of attrition. In addition, the average age of our Membership has decreased dramatically. We have been able to reach out to younger people who want to stay in touch with their heritage and are attracted to our philanthropic and cultural initiatives.

What is so rewarding about all the effort is that we are winning recognition for Italian-American culture and heritage on behalf of all Italian-Americans. In the process, we are building a future for our scholarship recipients. Vincent Toscano, the head of our High School Scholarship Committee, is an alumnus of our College Scholarship Program, and he is back with us helping the next generation. Recently, Richard Greco, Assistant Secretary of the Navy, became a Member of the Foundation. As a high school student, Secretary Greco participated in one of the Foundation's mentoring programs.

There is a dire need for our work to support financially disadvantaged Italian-Americans who have nowhere else to turn for assistance. We are building futures.

Verismo Celebrated in Opera Nights

hree exceptional productions lit up the Townhouse this past year. The November 12th production of "La Boheme," by Giacomo Puccini, featured Jose Carreras and Teresa Stratas with the Metropolitan Opera under the direction of James Levine. On February 18th, I presented the Franco Zeffirelli production of "Cavalleria Rusticana," by Pietro Mascagni, featuring Placido Domingo and Elena Obraztsova in performances conducted by Georges Pretre. The season ended on June 10th with Placido Domingo, Juan Pons and Teresa Stratas in Zeffirelli's production of "Pagliacci," by Ruggero Leoncavallo, also conducted by Georges Pretre. The June 10th event marked our 65th Opera Night at the Foundation.

These three operas represent the beginning of change in opera construction and style known as *verismo*, which emerged during the 1890s. The word itself translates as "realism" or, more tellingly, "true to life." Previous Italian operas told the stories of myths and well-known figures from literature or history, such as "Otello" and "Falstaff." These works, however, tell the stories of the lives of far less exalted characters yet still find poignancy and beauty in their commonplace struggles.

Keeping with a tradition I started in the days when opera nights were informal affairs held in my home, the events began with champagne and hors d'oeuvres, and courses from the evenings' gourmet dinners were served between acts. The spirit of the Foundation's Opera Nights was captured on the sold-out evening of June 10th, when Member Licia Albanese – an outstanding soprano – led a rendition of Happy Anniversary in honor of Members Cesar and Theresa Taormina, who were celebrating 50 wonderful years of marriage. •

American Sculptors in Italy Brought Old World Beauty to New World Art

Lecture Reveals Italian Inspiration in American Monuments

veryone knows that Italy has inspired artists throughout the ages. Few people realize that several noteworthy American landmarks and works of art took shape because of the sculptors' experiences while living and studying there.

The subject of Italian influence on the work of American artists who lived in Italy was explored in "19th Century American Sculptors in Florence," a lecture given by Karen Lemmey Orpianesi at the Townhouse on the evening of Friday, February 25th.

Throughout her presentation, Ms. Lemmey Orpianesi illustrated the link between Italy and American sculpture, which she explained reflects the post-Revolutionary War American dream to emulate the art and architecture of ancient Rome. American

expatriates of the 19th century returned from Florence and Italy inspired by Classical ideals of proportion and symmetry. Ms. Lemmey Orpianesi presented slides of the doors of the United States Capitol building's rotunda, which were created by Randolph Rogers and depict Columbus's life and the founding of America. She also illustrated the startling resemblance between one of the first bronze monuments fashioned in America – George Washington, by Henry Kirk Brown, in New York City's Union Square – and the ancient statue Marcus Aurelius found in Michelangelo's Piazza del Campidoglio. Other works of art presented by Ms. Lemmey Orpianesi illustrated the pervasive influence of Italy's rich history and abundant material resources on American sculpture.

Ms. Lemmey Orpianesi, a doctoral candidate at the City University of New York Graduate Center, was the recipient of

the Foundation's 2004 Franco Zeffirelli Scholarship for the Arts, which enabled her to pursue her studies at the British Institute of Florence. Of her own experience in Florence, Ms. Lemmey Orpianesi stated, "You don't need to look for art – it surrounds you."

In comments before the lecture, Foundation President Lawrence Auriana said, "The Foundation is proud to support the students of the arts, who are often overlooked and may have the most difficult time finding the financial resources to meet their goals."

In a statement read at the event, Mr. Zeffirelli said, "You cannot imagine how much joy and pride I feel at the news that a wonderful [scholar] has gloriously used my contribution to her education."




