RECOMMENDED ITEM FROM PLANNING COMMITTEE – 11TH MARCH, 2009

791. MARKLAND AND HOLLINHILL GRIPS CONSERVATION AREA APPRAISAL AND MANAGEMENT PLAN – OUTCOME OF PUBLIC PARTICIPATION AND PROPOSED ADOPTION

The Head of Planning presented the report which informed the Committee of the outcome of the public participation exercise on the draft Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan and the consultation exercise on the suggested extensions and proposed change to the boundary of the conservation area; sought support for the proposed change to the boundary of the conservation area to exclude the Clowne sewage treatment works from the conservation area and also sought support for the proposed adoption of the revised Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan by the Council as a material consideration that will be taken into account when a determination is to be made under the Planning Acts.

Further information was contained in the supplementary report.

Councillor McGregor expressed his thanks to the Planning Officers for a full and detailed conservation area appraisal and management plan.

Moved by Councillor D. McGregor, seconded by Councillor J.A. Clifton.

RECOMMENDED that (1) the Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan Adoption Draft be approved.

> (2) that the area shown on the plan in Appendix 2 be deleted from the Markland and Hollinhill Conservation Area, with the amendment relating to this deletion to be known as Markland and Hollinhill Conservation Area Amendment No. 1.

> (3) the Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan be adopted as a material consideration that will be taken into account when a determination is to be made under the planning Acts.

> (4) the Head of Planning be delegated to make any minor amendments necessary to the document prior to publication.

(5) the Head of Planning makes the necessary changes to the Historic Environment Scheme Work Programme to reflect the management plan actions contained within the Adoption Draft Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan.

RELEVANT CORPORATE AIMS

Environment - Promoting and enhancing a clean and sustainable environment.

One of the Council's priorities for its aim for the environment is to protect, enhance and improve the natural and built environment in a sustainable way.

The proposed Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan seeks to ensure that the historic environment of the Markland and Hollinhill Grips Conservation Area is preserved and enhanced by defining its special character and appearance and by setting out appropriate policies and proposals. As a result, the document will form an extremely important policy tool in the Council's efforts to protect, enhance and improve the built and natural environment in a sustainable way.

TARGETS

Achieving the milestones set in the Historic Environment Scheme by March 2011 is a specific target in the Corporate Plan. Within this target, preparing and adopting the Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan by April 2009 will achieve one of the milestones.

VALUE FOR MONEY

Preparing and adopting Conservation Area Appraisals and Management Plans aids efforts for a more efficient planning determination process as the additional guidance they contain enables applicants to better prepare their proposals, which in turn reduces the need for amendments, and enables the district to gain better developments.

In addition to this, the Conservation Area Appraisals and Management Plans contain proposals for enhancement that aids efforts to secure external funding for the district.

PURPOSE OF THE REPORT

Firstly, to inform the Committee of the outcome of the public participation exercise on the draft Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan and the consultation exercise on the suggested extensions and proposed change to the boundary of the conservation area.

Secondly, to seek Committee support for the proposed change to the boundary of the conservation area to exclude the Clowne sewage treatment works from the conservation area.

Thirdly, to seek Committee support for the proposed adoption of the revised Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan by the Council as a material consideration that will be taken into account when a determination is to be made under the planning Acts.

THE REPORT

Members will be aware that the draft Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan was approved by the Committee on 8th October 2008 for the basis of a public participation exercise. It was also resolved that a separate public participation exercise on several suggested changes to the conservation area boundary be undertaken in parallel.

In accordance with these resolutions, the public participation exercise ran from Monday 13th October 2008 to Friday 7th November 2008, with the required public meeting held at the Creswell Social Centre, Creswell on 29th October 2008. The public meeting was attended by ten people.

In addition, property owners in the suggested extension areas were consulted to seek their views on the suggested changes because designation as a conservation area changes the planning status of that land. Severn Trent Water, as owner of the sewage treatment works, was also contacted and informed of the proposal to amend the conservation area boundary to exclude the sewage works from the conservation area.

Outcome of the Consultation Exercise

Ten representations were received - two from the same respondent. A summary of the comments made by the respondents, the recommended response to the representation and, where necessary proposed changes to the document is attached as Appendix 1 to this report.

No objections to the draft Conservation Area Appraisal and Management Plan were received. However, the following significant issues were raised:

- balancing public access to the area whilst protecting the existing features and habitats of recognised interest
- improving the quality and management of access throughout the designated area
- provision of interpretation facilities of archaeological and geological sites
- flooding at Boler's Corner/Lower Mill
- incomplete infilling of part of the former railway line to the east of Markland Grips and the longevity of operations
- suggested boundary changes

The respondents were divided over the focus of their concerns or comments regarding the draft appraisal and management plan – this is understandable considering the range of overlapping interests in the area and highlights the need for any management schemes arising through the document to be inclusive of all relevant stakeholders.

Several responses were received which referred specifically to the suggested boundary changes to the conservation area. Some respondents supported the suggested extensions and the proposed removal of the sewage works from the conservation area. However, two respondents objected specifically to the suggested extension of the conservation area to include additional land to the east of Boler's Corner.

In general, the public participation exercise has shown support for the draft Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan. Where issues have been raised these have led, where necessary, to revisions to the Appraisal and Management Plan.

ISSUES FOR CONSIDERATION

Conservation Area designation issues

The Markland and Hollinhill Grips Conservation Area was designated in 1991 and the boundary has remained unchanged since. The conservation area was designated to delineate those areas of special archaeological, historic, landscape and ecological interest.

The Council is under a continuing duty to consider whether it should designate new conservation areas, or extend existing ones. The principal concern in considering whether to designate a conservation area is whether the local planning authority considers the area to be of special architectural or historic interest the character or appearance of which it is desirable to preserve or enhance.

Planning Policy Guidance Note 15 (Planning and the Historic Environment) further advises that: "Authorities should bear in mind that it is important that conservation areas are seen to justify their status and that the concept is not devalued by the designation of areas lacking any special interest."

In this case, the three suggested extensions to the boundary of the Markland and Hollinhill Grips Conservation Area were suggested by stakeholders during the initial stakeholder consultation exercise. These are:

- 'Sheepwash' site, Hollinhill Lane
- Former railway line, Markland Grips
- Land east of Boler's Corner

Given the statutory duty to review the boundary of existing conservation areas from time to time, the merits of these areas and their appropriateness for designation as extensions to the Markland and Hollinhill Grips Conservation Area have been considered. It is considered that the suggested extensions should not be pursued. A brief summary of the assessment of each area is given below.

Land adjacent Hollinhill Lane - 'sheepwash' site

This small site is located some distance to the west of the existing conservation area and lies on the eastern outskirts of Clowne. It comprises a small body of water supplied through an outfall passing under Hollinhill Lane. The pond is heavily vegetated with limited access.

The site was referred to by some stakeholders as a former sheepwash, although during the consultation exercise no evidence came to light to substantiate the claim. Examination of Ordnance Survey map evidence indicates that the feature was constructed sometime between 1875-77 and 1898. Map evidence also reveals that there was a former sewage works to the west of Hollinhill Lane which was constructed during the same period. It is therefore considered that the site was more likely constructed as an outfall from the earlier sewage works rather than a sheepwash.

On this basis it is considered that there is insufficient historical interest in the site to justify designating it as a conservation area. It is proposed therefore that the suggested extension area is not designated as part of the Markland and Hollinhill Grips Conservation Area.

Former railway line, Markland Grips

It was suggested that the full route of the former railway line between Clowne and Creswell be included as an extension to the conservation area. The central section of this route passes through the conservation area and is therefore already covered by the designation.

Whilst the historical interest of the former line has been noted in the appraisal it is considered that the special character of the Markland and Hollinhill Grips Conservation Area is derived from its landscape setting, its archaeological and historical interest, its ecological and geological interest and the contribution made by the limited number of historic buildings.

Whilst a small stretch of the former railway line is contained within the conservation area, it is considered that the railway line possesses a character that is distinct from the existing area and, as a result it is considered to be inappropriate to extend the conservation area to include the full stretch of the route between Clowne and Creswell.

Despite this, the potential of the former railway line to be developed as a dedicated amenity trail has been recognised in the Appraisal and Management Plan and reflects the policy stance outlined in the Bolsover District Local Plan. It is considered that this scheme would be pursued through the proposed Enhancement Scheme to develop amenity trails in the wider Crags and Limestone Area.

Land east of Boler's Corner

A number of buildings at the intersection of Hazelmere Road and the A616, known locally as Boler's Corner, are already included in the present conservation area which recognises their architectural and historic contribution to the character and appearance of the conservation area.

Stakeholders suggested that the conservation area should be extended to the east to incorporate the continuation of Millwood Brook towards Creswell and several properties situated along Sheffield Road some 100m to 500m from Boler's Corner.

Whilst it is recognised that the area and buildings display some historic and local architectural interest, it is considered that this area is too separate, both geographically and visually, from the small cluster of buildings at Boler's Corner that are related to historic mill activity.

Therefore, it is considered to be inappropriate to extend the conservation area to include the land east of Boler's Corner.

Proposed Boundary Change

In addition, it has been proposed that the boundary of the conservation area is realigned to exclude the Clowne sewage treatment works. Some support for this proposal was received from several respondents during the public consultation exercise. No objections to the proposal were received.

The sewage treatment works lies on the outskirts of Clowne and was partially included within the conservation area in 1991. The reason for including the sewage treatment works in the original designation of the conservation area is unclear. It is considered that the site is not a particularly attractive or complementary use to the aims and objectives of conservation area designation. On this basis it is considered appropriate to realign the boundary of the conservation area to exclude the sewage works in its entirety.

Conclusion

It is therefore concluded that the current boundary of the Markland and Hollinhill Grips Conservation Area sufficiently recognises and delineates the core historic, architectural and other interests of Markland and Hollinhill Grips. On this basis it is recommended that none of the suggested extensions should be pursued.

It is recommended that the boundary of the Markland and Hollinhill Grips Conservation Area be realigned to exclude the Clowne sewage treatment works. The proposed amendment to the conservation area boundary is shown on the plan in Appendix 2 attached to this report.

Conservation Area Appraisal and Management Plan issues

The public participation exercise raised a number of issues relating to the appraisal and management plan and in particular how some of the management plan actions would be taken forward.

The most significant issue raised is the incomplete infilling of part of the former railway line to the east of Markland Grips and the longevity of operations and one representation requested that this aspect of the development of amenity trails be brought forward to aim for completion within a year of adoption.

The remaining issues have been considered and where appropriate the appraisal and management plan has been amended accordingly.

In addition to these issues, given that the Markland and Hollinhill Grips Conservation Area is one of the pilot sites within the Creswell Crags Limestone Heritage Area Management Action Plan, it is considered appropriate to add to the document a new Enhancement Scheme that will identify the need to prepare an Interpretation and Development Plan for the area and so reflect the Enhancement Scheme included within the recently adopted Pleasley Park and Vale Conservation Area Appraisal and Management Plan.

Based on this assessment, it is recommended that the Adoption Draft Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan is approved by the Committee and also that the Committee recommend to the Council that the document be adopted as a material consideration that will be taken into account when a determination is to be made under the planning Acts. Alongside this, it is recommended that the Committee recommend to the Council that the Head of Planning be delegated to make any minor amendments necessary to the document prior to publication.

The proposed Adoption Draft Markland and Hollinhill Grips Conservation Area and Management Plan are attached as Appendix 3 to this report.

Implications for the Historic Environment Scheme

The Adoption Draft Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan contains a number of actions for further conservation related work. Generally, the identified threats are prioritised over opportunities, as resources permit.

It is considered that a number of the actions contained in the Management Plan, such as pursuing the completion of the infilling of part of the former railway line to the east of Markland Grips and trying to reduce the threat of flooding at Lower Mill, should be given a high degree of priority. As a result this investigatory work is proposed to commence in April 2009 and June 2009 respectively and it is considered that this should not affect the existing programme significantly. However, it should be noted that implementing permanent solutions to these problems is likely to take a longer period.

Regarding the new Enhancement Scheme to prepare an Interpretation and Development Plan for the area, it is considered that this work would take place alongside the Pleasley Park and Vale Conservation Area Appraisal and Management Plan action and so it is considered appropriate to prioritise this for December 2010.

The dates for the other new management plan actions, such as the interpretation of archaeology in the conservation area and improving public access and amenity trails, are generally considered to be less urgent despite being desirable. Therefore, these are prioritised after those management plan actions already listed in the Historic Environment Scheme Work Programme.

Based on this assessment, it is recommended that the Historic Environment Scheme Work Programme should be amended to reflect the management plan actions contained within the Adoption Draft Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan.

IMPLICATIONS

- Financial The cost of printing and advertisement can be met within existing budgets.
- Legal The removal of an area of land from a conservation area changes the planning status of that land.

Human Resources - The Historic Environment Scheme Work Programme sets out the work of the Planning Conservation Team based on the current level of resources available.

RECOMMENDATIONS

That (1) the Committee approves the Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan Adoption Draft;

(2) the Committee recommends to the Council that the area shown on the plan in Appendix 2 be deleted from the Markland and Hollinhill Conservation Area, with the amendment relating to this deletion to be known as Markland and Hollinhill Conservation Area Amendment No. 1.

(3) the Committee recommends to the Council that the Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan be adopted as a material consideration that will be taken into account when a determination is to be made under the planning Acts;

(4) the Committee recommends to the Council that the Head of Planning be delegated to make any minor amendments necessary to the document prior to publication;

(5) the Head of Planning makes the necessary changes to the Historic Environment Scheme Work Programme to reflect the management plan actions contained within the Adoption Draft Markland and Hollinhill Grips Conservation Area Appraisal and Management Plan.
