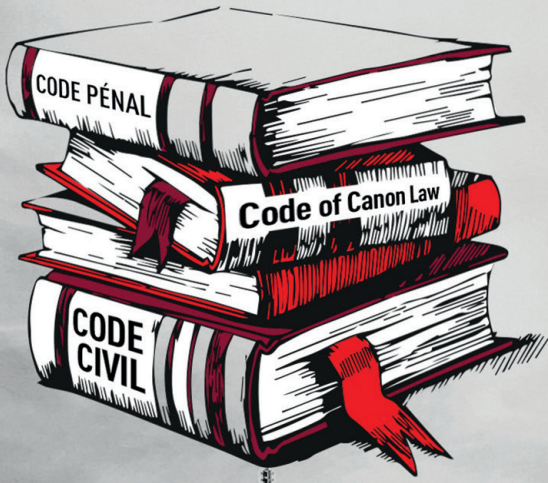

## Person, right and justice: the contribution of canon law in contemporary legal experience

Whatever the place of canon law may be, concerning civil rights it may encounter (from Concordat recognition or simple recognition of internal regulations), it proposes a space of reflexion for contemporary juridical experience. From the notion of person, law and justice, canon law wishes to offer an answer to the art of what is just for to-day, amongst universal principles (theological, philosophical, juridical, and sociological) and particular norms, (historical, and positive laws) in a constant dialogue with secular laws ( even with other sacred laws?)

It is in this background that the conference will study, between the foundations of law and other normative deliberations, the positioning of canon law in it's theory and practice. This positioning will confront itself and reply, in a constantly perfectible discussion, to the experience of the subjects of living rights, in a de facto juridical pluralism, as citizens and members of the Church.
