

SCHOOL BOARD PROCEEDINGS

The Avoyelles Parish School Board met in regular session Tuesday, June 7, 2011, at 5:00 p.m. at the School Board Office with the following members present:

Van Kojis, President; Carlos A. Mayeux, Jr., Vice-President; Freeman Ford, Darrell Wiley, James Gauthier, Shelia Blackman-Dupas, Michael Lacombe, Rev. Mary Hayward-Jones, and Cynthia "Cindy" Hill.

Absent: None.

An Invocation was offered by Board Member Rev. Mary Hayward-Jones.

The meeting opened with the Pledge of Allegiance to the flag of the United States of America led by Board Member Darrell Wiley.

1. On motion of James Gauthier, seconded by Darrell Wiley, the Board adopted the minutes of the special Board meeting held Tuesday, May 31, 2011, as printed and mailed to Board members and published in The Weekly News, official journal of the Board. MOTION CARRIED.

2. Vice-President Carlos A. Mayeux, Jr. read a resolution of respect to the late Cleothile Dewailly, former teacher.

3. Mr. Darrell Wiley, Board Member, read a resolution of respect to the late Irene Smith, former teacher.

4. Superintendent Dwayne Lemoine recognized and commended students for their outstanding achievements, as follows:

- 1) Louisiana School for the Agricultural Sciences: Megan Moreau, ninth grade student, placed third in the State Junior Beta Spelling Bee and is eligible to compete at the national Beta Convention.
- 2) Marksville High School: Emily Ryan and Austin Bordelon have been selected to membership on the statewide Louisiana Legislative Youth Advisory Council. Both Emily and Austin will have the responsibility of representing the voices and perspectives of all youth in Congressional District 5 on issues that are important to teens. (It is very rare to have two students selected from the same school to represent the entire district).

- 4) Avoyelles High School: Avoyelles High School won second place in the Rapides Foundation Get Healthy Cenla Video Challenge. They are now \$5000 richer.

On behalf of the Board, President Van Kojis commended the students on their outstanding achievements.

5. Mr. Howard Desselle addressed the Board regarding renting of the Bunkie Middle School facility. The Board advised that they have met with legal counsel and that the facility cannot be legally leased unless payment is made or they offer in-kind services that offer a value to the community. The interested parties have provided a number of services that they want to offer, but a value needs to be placed on these items and presented to the Board for approval to pay for the lease of the gym. This Board is actively seeking leases on Section 16 properties.

6. Mr. Wilfred Ducote, Sales Tax Collector, reported that sales tax collections for the month of April, 2011 totaled \$576,054.09. Mr. Ducote stated that of this amount the 1% sales tax generated \$384,036.06 and the ½% sales tax generated \$192,018.03.

Also, Mr. Ducote stated that sales tax collections for the month of May, 2011 totaled \$507,423.58. Mr. Ducote stated that of this amount the 1% sales tax generated \$338,282.39 and the ½% sales tax generated \$169,141.19.

2. Mr. Steve Marcotte, Maintenance Supervisor, presented a bid-opening committee report on leasing of Mansura and Bunkie Middle School gymnasiums. Mr. Marcotte stated that the bid-opening committee recommended to refer the bids to Assistant District Attorney James Lee for clarification and legality issues.

Upon motion by Darrell Wiley, seconded by Rev. Mary Hayward-Jones, the Building and Lands Committee recommended to accept Mr. Marcotte's recommendation. MOTION CARRIED.

3. Mr. Steve Marcotte, Maintenance Supervisor, presented a bid-opening committee report on the construction of the Pre-K building at Plaucheville Elementary School. Mr. Marcotte stated that the committee acknowledged receipt of the following bids:

Cottonport Building Supply, \$189,400; F. Phillips Construction, \$179,000; Larwood Construction, \$200,250; Rusk Construction, \$147,200; Scallan Contractors, \$171,444; and Petron LLC, \$211,400.

Upon motion by Cindy Hill, seconded by Darrell Wiley, the Building and Lands Committee recommended that the Board accept the low bid submitted by Rusk Construction in the amount of \$147,200 and defer the additional funding needs to the Finance Committee. MOTION CARRIED.

4. Upon motion by Darrell Wiley, seconded by Cindy Hill, the Building and Lands Committee approved Change Order Number 4 from URS Corporation, Architects; The Migues Deloach Company, LLC for renovations at Bunkie Elementary School in the increased amount of \$11,542.00 and that funding for the increased amount be sent to the Needs Assessment Committee for approval. 1. Upon motion by Cindy Hill, seconded by Michael Lacombe, the Board approved requests for overnight travel as presented by Superintendent Lemoine. MOTION CARRIED.
2. Mr. Tom Hudson with Norris Insurance Consultants presented the quotation submitted for property insurance for the 2011-2012 fiscal year.

Mr. Hudson informed the Board that the two most competitive bids were received from Risk Services of Louisiana, First Insurance and Earl Lemoine Agencies. After review of the quotes, Mr. Hudson recommended the purchase of First Insurance quote with the option of \$40,000,000 per occurrence coverage for a reduced premium to \$150,762 and to include terrorism coverage for an additional premium of \$5000.

Upon motion by Michael Lacombe, seconded by Shelia Blackman-Dupas, the Finance Committee recommended to accept the bid submitted by First Insurance in the amount of \$150,762 for property insurance coverage. MOTION CARRIED.

Upon motion by Michael Lacombe, seconded by Shelia Blackman-Dupas, the Finance Committee recommended to include terrorism insurance for an additional \$5000 for fiscal year 2011-2012. MOTION CARRIED.

Mr. Hudson also reviewed the renewal casualty premium for 2011-2012 with the committee.

Upon motion by Michael Lacombe, seconded by Cindy Hill, the Finance Committee recommended to approve the 2011-2012 casualty premium renewal with First Insurance for \$424,007 plus an agency fee of \$20,000 totaling \$444,007. MOTION CARRIED.

Mr. Lacombe stated that he felt the \$20,000 agency fee was excessive.

Upon motion by Cindy Hill, seconded by Michael Lacombe, the Finance Committee recommended to purchase additional liability coverage for law enforcement activities from PCAL for 2011-2012 at a premium of \$4704. MOTION CARRIED.

Upon motion by Michael Lacombe, seconded by Cindy Hill, the Finance Committee recommended to reject uninsured motorist coverage for 2011-2012. MOTION CARRIED.

Upon motion by Michael Lacombe, seconded by Cindy Hill, the Finance Committee recommended to appoint Mary Bonnette, Finance Director, to represent the Board with regard to insurance matters. MOTION CARRIED.

June 7, 2011

Mr. Mike Desoto of First Insurance informed the committee that a dividend will be received from PCAL by July totaling approximately \$20,000 due to recent renewals with PCAL.

Mrs. Bonnette stated that quotes and renewals for the 2011-2012 fiscal year have generated a savings of \$55,182 from the 2010-2011 year.

3. Upon motion by Shelia Blackman-Dupas, seconded by Cindy Hill, the Finance Committee recommended to grant exemption from sales tax for the purpose of construction of the Pre-K building at Plaucheville Elementary School and the LaSAS multi-purpose gymnasium. MOTION CARRIED.

4. Upon motion by Shelia Blackman-Dupas, seconded by Cindy Hill, the Finance Committee recommended to advertise for fiscal auditor for the year ending June 30, 2011. MOTION CARRIED.

5. Mrs. Mary Bonnette, Director of Finance, reviewed the Title XIX Budget for fiscal year ending June 30, 2012. Mrs. Bonnette stated that estimated revenues were \$568,600 and expenditures totaled \$539,320 resulting in an estimated surplus of \$29,280. This will enable the Board to maintain current staffing and the conversion of two (2) contracted nurses to employee status.

6. Mrs. Mary Bonnette, Director of Finance, reviewed the LaSAS budget. Mrs. Bonnette reviewed estimated revenues of \$2,382,646 and expenditures of \$2,266,455. Indirect cost to the Avoyelles Parish School Board includes \$69,000 with an estimated surplus of \$47,191.

7. Mrs. Mary Bonnette, Director of Finance, explained to the committee that Parsons Benefit Services has provided the Board with an analysis of premiums versus benefits earlier this year and the recommendation was that the Board remain with OGB based upon this comparison. Recent changes to OGB, however, such as notification of a short plan year and recent state budget cuts have projected further inquiries regarding insurance.

Mrs. Bonnette recommended to the committee to hire Parsons to accumulate data in order to obtain health insurance quotes. The fee required to begin this process is \$8500, as outlined in the contract.

Upon motion by Shelia Blackman-Dupas, seconded by Cindy Hill, the Finance Committee recommended to contract with Parsons Benefits Services. MOTION CARRIED.

8. Mrs. Mary Bonnette, Director of Finance, reviewed the results of the MFP simulation prepared by the Louisiana Department of Education. She informed the committee that a net MFP level increase of \$294,599 as a result of the recent proposed sales/ad valorem tax proposed will be added to the proposed tax amount of approximately \$1,800,000.

9. The Finance Committee discussed additional funding for Pre-K building at Plaucheville Elementary School as well as a funding source for asbestos abatement for Marksville

WHEREAS, PreK - 12 public education has endured a series of continued budget cuts at the state and federal level that affect services to students; and,

WHEREAS, at the state level, the MFP (Minimum Foundation Program) will not be fully funded with the 2.75% growth factor for three consecutive budget cycles; and,

WHEREAS, at this time, Louisiana is involved with a pending transition to national, common educational standards and assessments that will affect accountability requirements; and,

WHEREAS, at this time, the Elementary and Secondary Education Act (commonly referred to as No Child Left Behind) is pending reauthorization that will affect statewide accountability measures; and,

WHEREAS, the State's ultimate and primary responsibility is to support and fund public education first in a way that is accountable to the tax payers, and, unless and until the State can meet this obligation, the proliferation of Type 1, 2, 3 and 5 Charter Schools is contrary to that purpose and goal; now,

THEREFORE, BE IT RESOLVED, that the Avoyelles Parish School Board does hereby support legislation that would enact a moratorium regarding "Letter-Grade Labeling of Schools" and "Value-Added Employee Evaluations" and approval of any additional Charter Schools other than Type 4 charters; and,

BE IT FURTHER RESOLVED, that copies of this resolution be forwarded to the Louisiana School Boards Association, to the Governor of Louisiana, members of the Avoyelles Legislative Delegation, the State Superintendent of Public Education, to the State Board of Elementary and Secondary Education, and all Superintendents throughout the state.
