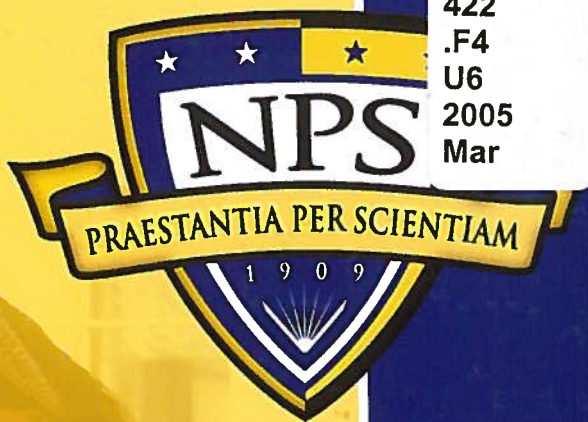

The Naval Postgraduate School

The Naval Postgraduate School provides relevant and unique advanced education and research programs in order to increase the combat effectiveness of United States and allied forces and enhance the security of the United States.

The Naval Postgraduate School was opened in Annapolis in 1909 and later transferred to the Monterey Peninsula in 1952. Since its beginning, the school has conferred over 43,000 degrees.

Enrollment at the Naval Postgraduate School has grown to nearly 1,500 resident students. Nearly 50 percent are from the United States Navy or Marine Corps, 25 percent are from other United States armed services, and the remaining 25 percent are from allied countries. Officers are obliged to remain in service for about three years after they complete their schooling.

Students are engaged in intensive studies leading to a master's degree in one of 42 different curricula split between the School of International Graduate Studies, and the Graduate Schools of Operational and Information Sciences, Engineering and Applied Science, and the School of Business and Public Policy. Each curriculum is tailored to provide the academic requirements for accredited advanced degrees and meet the additional educational skill requirements necessary for subsequent assignments.

The Naval Postgraduate School has long been a testing ground for the Navy's most advanced research. The Naval Postgraduate School develops cutting edge technologies for numeric meteorological predictive sciences, oceanographic vehicles, and ultra-high complexity computer model simulations for Department of Defense use. Over 60 million dollars of research is conducted or administered annually at the school.

The Naval Postgraduate School is accredited by the Western Association of Schools & Colleges, the Accreditation Board for Engineering & Technology, the Association to Advance Collegiate Schools of Business and the National Association of Schools of Public Affairs & Administration. The North Atlantic Treaty Organization has recognized NPS as an Alliance-wide Partnership for Peace Education and Training Center.

Rear Admiral Dunne graduated from the Naval Academy in 1972 with a Bachelor of Science degree in Mathematics. He has a Master of Science degree in Mathematics from the Naval Postgraduate School and is a graduate of the Navy's Nuclear Power training.

Rear Adm. Dunne's service at sea includes tours on USS Nathanael Greene (SSBN 636) (Blue), operating out of Holy Loch, Scotland; USS Batfish (SSN 681) homeported in Charleston, S.C.; and USS Baton Rouge (SSN 689), homeported in Norfolk, Va. He commanded USS Baltimore (SSN 704) in Norfolk, and USS Frank Cable (AS 40) in Charleston.

His shore assignments include Material Officer on the staff of Submarine Squadron Eight and Naval Aide to President Reagan. Rear Adm. Dunne was also the Special Assistant to the Chief of Naval Operations for Joint Chiefs of Staff Matters/Navy Planner. During three separate tours in the Navy's Office of Legislative Affairs, he was the Congressional Liaison Officer for Submarine Programs; the Director, Naval Programs; and Deputy Chief of Legislative Affairs.

Selected for Flag Rank in 2001, Rear Adm. Dunne's initial flag assignment was U.S. Pacific Command Representative Guam/Commonwealth of the Northern Mariana Islands/Federated States of Micronesia/Republic of Palau and Commander, U.S. Naval Forces Marianas.

Rear Adm. Dunne's awards include two Defense Superior Service Medals, four Legions of Merit, two Meritorious Service Medals, five Navy Commendation Medals, two Navy Achievement Medals, a Humanitarian Service Medal and various unit awards



**Admiral Edmund P. Giambastiani, Jr.

Admiral Giambastiani serves as NATO's Supreme Allied Commander Transformation (SACT) and the commander of the United States Joint Forces Command (CDRUSJFCOM). Both headquarters are located in Norfolk, Va.

As one of two NATO strategic commanders, Adm. Giambastiani leads the transformation of NATO military structures, forces, capabilities and doctrines to improve the military effectiveness of the Alliance. As CDRUSJFCOM, Adm. Giambastiani is responsible for maximizing future and present military capabilities of the United States by leading the transformation of joint forces through enhanced joint concept development and experimentation, identifying joint requirements, advancing interoperability, conducting joint training and providing ready U.S. forces and capabilities — all in support of U.S. combatant commanders around the world.

Adm. Giambastiani's assignments have included several in which he was responsible for development of new technologies and experimental processes, as well as four previous tours in command. He commanded Submarine NR-1, the Navy's only nuclear powered deep diving ocean engineering and research submarine. He also led Submarine Development Squadron Twelve, an attack submarine squadron that serves as the Navy's Warfare Center of Excellence for submarine doctrine and tactics. Established in 1949, Submarine Development Squadron Twelve is the oldest experimental unit of its kind in the U.S. military. The admiral also served as the first director of strategy and concepts at the Naval Doctrine Command.

In addition, Adm. Giambastiani commanded the nuclear-powered attack submarine *USS Richard B. Russell* (SSN 687). He also served as the commander of Atlantic Fleet Submarine Force, commander of NATO's Submarines Allied Command Atlantic and commander Anti-Submarine and Reconnaissance Forces Atlantic in Norfolk, Va.

Adm. Giambastiani's other shore and staff assignments include duties as an enlisted program manager on the staff of the Navy Recruiting Command Headquarters, Washington, D.C., in the early days of the all volunteer force; special assistant to the deputy director for intelligence, Central Intelligence Agency; and, a one-year fellowship with the Chief of Naval Operations' Strategic Studies Group. As a flag officer, he served as the deputy chief of staff for resources, warfare requirements and assessments for the commander of the U.S. Pacific Fleet; director of the Submarine Warfare Division on the staff of the Chief of Naval Operations; and finally as the Deputy Chief of Naval Operations for Resources, Requirements, and Assessments (OPNAV N8).

Prior to his current assignment, he served as senior military assistant to Secretary of Defense Donald H. Rumsfeld.

A native of Canastota, N.Y., Adm. Giambastiani graduated from the U.S. Naval Academy with leadership distinction in 1970. His decorations include the Defense and the Navy Distinguished Service Medals.

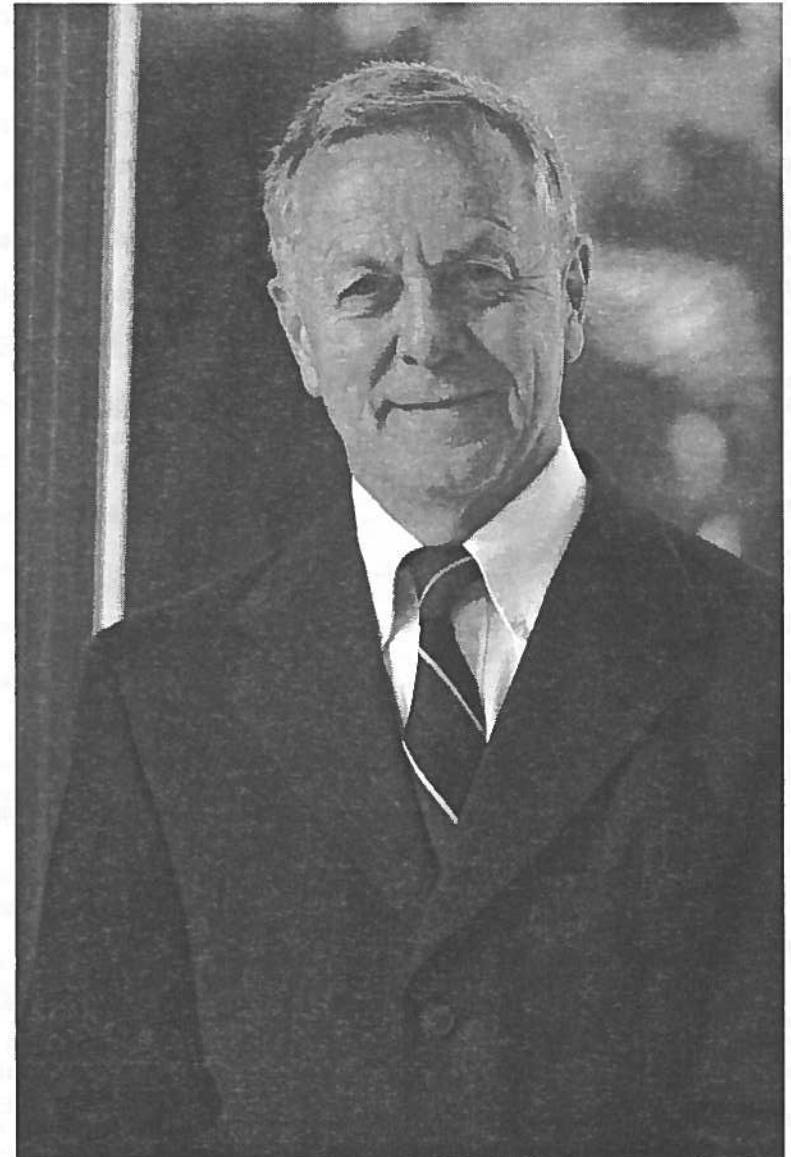
Richard Elster was born on 3 December 1939. He attended the University of Minnesota in Minneapolis where he received the degrees of Bachelor of Arts, Master of Arts, and Doctor of Philosophy in Industrial Organizational Psychology.

In January of 1969, he joined the faculty of the Naval Postgraduate School. His teaching focused on DoD manpower, personnel and training policies. From 1 July 1975 to 1 July 1978, he was on leave from the Naval Postgraduate School. During that period, he worked in the Office of the Assistant Secretary of Defense (Manpower and Reserve Affairs), and as Senior Scientific Advisor to the Deputy Chief of Naval Operations (Manpower)/Chief of Naval Personnel, Admiral James D. Watkins.

On 1 October 1979, he was promoted to Professor in the Department of Administrative Sciences at the Naval Postgraduate School. In July of 1983, he became Chairman of the Department of Administrative Sciences.

During the period of 1984-1988, he served as Deputy Assistant Secretary of the Navy for Manpower. Additionally, he was Acting Assistant Secretary of the Navy (Manpower & Reserve Affairs) during the period 7 April - 28 June 1988.

In 1989, he filled the Chief of Naval Operation's manpower chair at the Naval Postgraduate School. During January-September 1990, he was Deputy Assistant Secretary of Defense for Resource Management and Support. He was named Dean of Instruction at the Naval Postgraduate School in September 1990, where he served in this role until June 1995. On July 1, 1995 he was named Provost/Academic Dean of the Naval Postgraduate School by the Secretary of the Navy. He was appointed to a second five-year term in July of 2000.

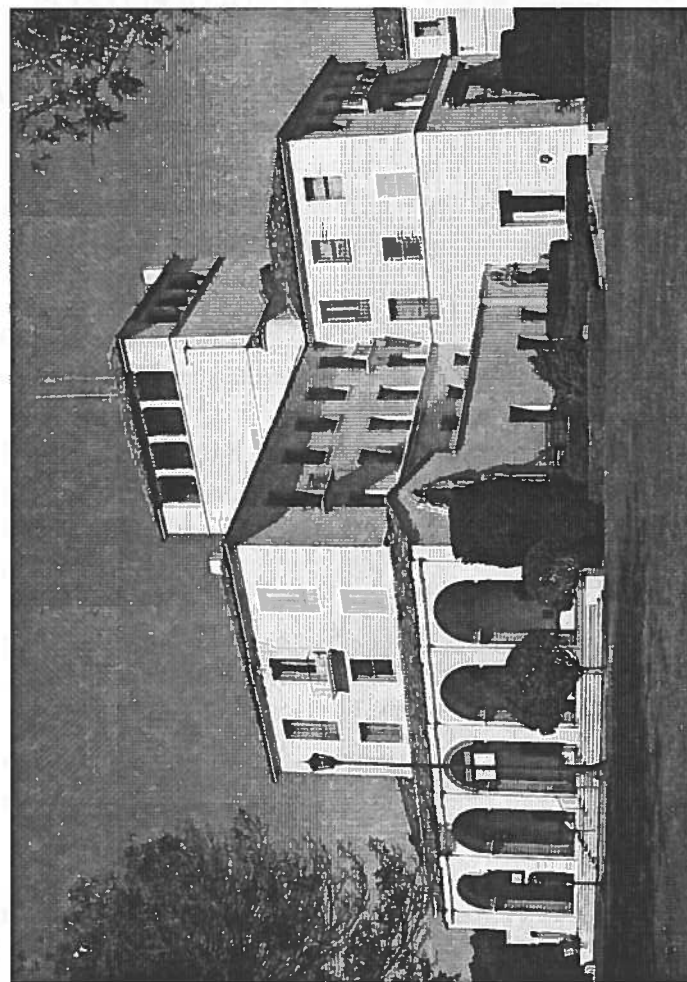
