Our Historic Merger

At the end of 2020, we announced the intended merger of the former Foodshare and the former Connecticut Food Bank. It was and is our sincere belief that together we can better serve the people of Connecticut and make greater strides towards ending food insecurity. Following months of intense work addressing the significant increase in need as a result of the COVID-19 pandemic, we knew that we had a responsibility to do whatever was necessary to address those needs.

We are now Connecticut Foodshare, serving a statewide network of 700 partner programs, over 8,000 volunteers and more than 100 staff working to meet the needs of our neighbors in Connecticut struggling with food insecurity - and continuing to find new ways to address root causes of hunger and long-term solutions. When I think back on the last year, the consistent theme of partnership sits at the forefront of my mind. We hosted vaccine clinics and voter registration drives at our mobile food pantries and emergency drive-thru distributions, and provided nearly 47 million meals of food. None of this would have been possible without partnership - among our merged staff and volunteers, our incredible network, with other non-profits, elected officials, and with our dedicated supporters. We faced insurmountable odds - but together we have accomplished so much, and I look forward to seeing where these partnerships will lead us.

On behalf of myself and the Connecticut Foodshare Board of Directors, I am proud to share the impact of our work with you, and I am so grateful for your continued support to make everything possible. This is only the beginning of our next chapter.

Nearly 47 Million Meals

Providing food for our community has been our mission for nearly 40 years. Last year, we distributed enough food to help provide nearly 47 million meals from our facilities in Wallingford, Bloomfield, and Bridgeport through a network of 700 partner food pantries, meal programs and mobile food distribution sites all across Connecticut. One-third of that food was nutritious produce.





Volunteers

More than 3,700 volunteers help power the work of Connecticut Foodshare; providing nearly 62,000 hours of service in a variety of roles across the organization.




Retail Food Rescue

We rescued 10 million pounds of food from over 300 local grocery stores in Connecticut with the help of about 250 volunteers and partner agency representatives.



Mobile Pantries

Our food pantry-on-wheels visits over 100 sites throughout the state, bringing much needed pantry staples, meat, dairy, and produce directly into neighborhoods and towns.



Institute for Hunger Research & Solutions

The Connecticut Foodshare Institute for Hunger Research & Solutions conducted research to understand barriers to food access to help inform future programming. This research revealed increases in pre-existing disparities in food insecurity among communities of color and households with children. The Institute created a pilot program, in partnership with Feeding America and two other food banks, to help connect families to coaching and resources.





Thanksgiving

Distributed over 50,000 turkeys to Connecticut families for Thanksgiving meals.



Recognition

Our work was recognized by and honored with awards from multiple community organizations.



Outreach

SNAP Outreach volunteers helped more than 1,400 households apply for SNAP.



Advocacy

We worked with members of Congress to continue to protect and strengthen federal nutrition programs. We invigorated our partnerships and collaborated creatively at the state level with the offices of the Governor and Lieutenant Governor, the State Legislature and multiple state departments to ensure that the people of Connecticut who struggle with food insecurity received the support that they needed.






Communities
