\$5000.00 FOR AN ATHLETIC FUND

Co-operative Plan by which Money is to be Raised for the Benefit of the University of Iowa Athletic Union

I have always been interested in athletics and became quite enthusiastic in the days of Williams, Watters and Edson and it wounded my state pride and vanity very much in later years to have Michigan and Minnesota do such woeful things to "Iowa's finest." It seemed about time that a call was made for "all hands to repel boarders.'

I believe atheletics should not depend entirely upon donations. Of course I know they do not entirely depend upon donations now but I am sure they should be put on a more independent basis. I believe the participants in the sports would feel better if they knew the funds required for the support of atheletics had been earned by the individual efforts of the student. I believe further that there are hundred of students who are unable to uphold or uplift the standard of athletics at our university by individual prowess, but who would hail with delight an opportunity to lend a helping hand otherwise, if the chance only offered.

It occured to me that the Puritan Mfg. Company would like to join hands with such students in an endeavor to make the Atheletic Union of University of Iowa self supporting. This can be done at practically no expense to us and with but little individual effort on the part of every one of the students. Merchants Agreement For The Co-operative Athletic Fund

For the purpose of furthering the interests of the Athletic Union of the University of Iowa and in order to establish a Co-opertative Athletic Fund, The Puritan Manufacturing Company of Iowa City, Iowa, has agreed to furnish jewelry of their manufacture to the Athletic Union of the State University at the cost of manufacture and to donate what would be profit to this Athletic Fuud.

The Puritan Manufacturing Company make this agreement on the condition that the students and alumni of the the university will sell the jewelry to the merchants throughout the state and that they will donate what would usually amount to the regular salesman's commission to the Athletic Fund.

Merchants may order jewelry in any quanity over and above \$15.00 worth at a time, and the Puritan Manufacturing Company agree to ship to the undersigned merchant, jewelry of up-to-date patterns covered by ample warranty as to quality, consisting of scarf pins, cuff buttons, shirt waist sets, watch fobs, lace pins, etc., to the amount of \$15.00 market price, unless a larger amount is herein specified.

It is further agreed that, if this jewelry is not satisfactory to the merchant, he may return same to the Puritan Manufacturing Company and his money will be returned to him without any question whatever.

It is agreed that the \$15.00 accompanying this order is to be sent to the President of the Athletic Union who will turn over to the Athletic Union Fund, out of each \$15.00 order, \$5.25; the other \$9.75 to be paid to the Puritan Manufacturing Company, subject to the return of the jewelry by the undersigned merchant, providing same is not satisfactory

The purpose of this proposition is to free the the Athletic Union from debt and to establish a fund for the expenses of the University Football and Track Teams, which will enable the manager of Athletics to procure more efficient training facilities and to more readily provide for the necessary money to pay for professional coaches and trainers.

It is agreed by the undersigned merchant the terms on this \$15.00 order are cash with the order.

To the President of the Athletic Union, Iowa City, Iowa: You may place my order with the Puritan Manufacturing Company for \$15.00 worth of jewelry, as per the above contract, to be shipped me on the terms and conditions of this contract and no others.

It is expressly understood and agreed that if this jewelry is not entirely satisfactory to me, I may return same within ten days of its receipt and that you are to return me the \$15.00 attached hereto.

Each succeeding athletic season for the past few years has left the union a little deeper in debt.It has not been the fault of the managers or the students. It has been the result of peculiar fortunate and unfortunate circumstances. Fortunately the state university of Iowa has turned out faster and stronger athletic teams that has been expected for an institution of its size. Unfortunately the conditions surrounding the teams have not changed in the proportion that the teams have grown. Hence Iowa has been left to support a big team in a little field. Iowa City is not a big city so that large crowds can be brought out to see a game here. Private subscriptions were resorted to in order to make up the deficien but these were not sufficient to meet the demands. Other means have been tried to make up the deficiency but they have proyed

inadequate.

Now for another and better scheme-one which depends upon the push and enterprise of the students of the university. It is not a scheme for a few to carry out but rather one for every one who has any interest in the welfare of the university and her athletic future. It is this.

are interested in the athletic welfare of the university. It is a co-operative scheme. The student contributes work and the Puritan Mfg. Company contributes its salesman's commission and net profits. It asks that the members of the athletic union act in the capacity of its regular salesmen throughout Iowa. It asks that the students here take upon themselves the work of selling one or more cases of its product to their home merchants with whom they are liable to have a great deal of influence-The student does not take any risk. He does not lose anything. The merchant who buys the prouct does not take any risk neither does he lose anything. He takes the goods subject to the conditions of the contract printed in this

What is the student getting? Through the agency of the Puritan Mfg. Company he has the opportunity of doing a couple of hours work for the Athletic Union. He gives the Athletic Union the sum of \$5.25 in return for his work and he gives the Puritan Mfg. a little wholesome advertising-exactly what it is a good proposition it is for the athletic union one man went out in Iowa City yesterday and sold three of the fifteen dollar lots to Iowa City merchants, thus making almost sixteen dollars for the Athletic Union in less than an hour. They are naturally interested in the wel-fare of Iowa athletics and would not put their indorsement upon this scheme if they did not think it were meritorious. 
