AN ACT TO AMEND THE CONSTITUTION.

WHEREAS by virtue of Article 46 of the Constitution any provision 5 of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 40 of the Constitution:

1.—Article 40 of the Constitution is hereby amended as follows:

shall be added to section 3 of the Irish text,

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS 10 FOLLOWS:

(a) the subsection set out in Part I of the Schedule to this Act

(b) the subsection set out in Part II of the Schedule to this Act 15

Amendment of Article 40 of the Constitution.

Citation.

2.—(1) The amendment of the Constitution effected by this Act shall be called the Eighth Amendment of the Constitution.
