That all the Tithes within the said Parish are all paid in kind except the moiety of the Township of Tyvos, and that all other Tithes whatsoever within the said Parish are all paid in kind, except the two tenements of Branas Ucha and Branas issa in seaven and twentie years time during the residence of the present Vicar thereof claimed a modi decimandi for all that time, and during the memory of man as is commonly sayd for all their corne and hey only paying yearely at St Petter's Feast for the same the sume of flive pownds in each of the sayd tenements.

Extract from the Terrier of the Sinecure Rectory & Vicarage of Llandrillo in Edernion dated 1st May 1743

The Parish of Llandrillo containeth eleven small Townships [viz] Vaerdre isa, Vaerdre ucha, Moelyskedwii, Garthian, Pennant, Dinan, Llan, Kilan, Serior, Branes and Tyvos - all these Townships pay Tithes Corn Grain and Hay in kind excepting the Township of Branas where they have a modus decimandi for their Tithe Corn and Hay to pay in Lieu thereof ten pounds a year; There is also another piece or parcel of ground in the Township of Kilan known by the name of Gwern y Crhthor which pays Tithe Corn and Hay to Branas Ucha and not to the Parson and Vicar of the Parishm and half the Tithe Corn and Hay, Lambs, Wool, Lactuals, Eggs, Honey, Hemp, Flax, Pigs and Geese issuing out of the Township of Tyvos goes to Gwyddelwern Parish, Easter Dues only excepted, The Parson's share of all the above mentioned Tithes both great and small and also of the Easter dues is two thirds, the other third going to the Vicar

Dear Sir,

...... John Evans of Branas Ucha also pays 5 I modus for hay and grain and he receives from Robt Foulks of Tyn y ffordd from 8-10s ... as tithes of a meadow called Gwerny Crythor the sum varies according to the crop he is also exempted from paying tythes for Pwl Gwgan that is in his own holding. Both those pieces were in the property of the Duke of Ancaster. Gwern y Crythor was lately purchased by Sir Edw Lloyd [? Mostyn] and Pwll Gwgan by Mr Evans of Bodwenni which piece he wished to arrange to this modus also exempt from payg tithes a field and a piece of field in the holding of Hugh Edward Sir W's tenant at Tyn y Graig. This is all claimed under this modus John Evans of Branas says this field and the part of a field in the holding of the tenant of Tyn y graig are a part of Branas Ucha farm and a few years ago.

This field and the piece were let by Sir Watkin's tenant of Branas to the tenant of Tyn y Graig with the tyth included but abt 7 years ago the then agent took this field and piece from Branas farm and added them to Tyn y Graig Tithe and all, and no tithe have been paid from these grounds.

John Evans says that he can oath that he heard an old man in that neighbourhood say that Gwern y Crythor and Pull Gwgan was part of Branas Uchsa farm but the owner getting poor sold them to get money before he sold the whole of the farm and he thinks that those pieces and farm were sold by Morgan Branas abt eight score years since. But what he has heard I suppose can't be an evidence

Dear Sir

I got Robt Lloyd late of Tyn y Maes now Ty Ucha to make the foregoing valuation he has gathered the Tythes of Llandrillo for eight years last past and he says that he could not be more exact had he been upon oath as to the value, all the pastures except those written rough pastures have been one time or the other plowed

A farm holder in this parish pays nothing for herbage but 1d per cow that caved 2d for each mare that drops a fole. Branas Isa have sowed abt the same quantity of grain this year as they used to do and greazed abt the quantity of land as usual – Branas Ucha sowed less this year of about 157 acres of oats less than usual and greazed more of nearly ... as Ddol Fawr, for they keep 3 cows more than they have most years – I have not costed up nor brought forward sums each piece amounts to for I did not know wd it be of used to be accurate as to the pence and farthings.

Mr Evans of Bodwenni I have seen today he has not had the valuation he promised he had not seen the man but the person that attended Mr Robt Edwards told Robt Cadwalader's son that Branas Isa valued to £17.16s.6d and that Branas Ucha from £12-13 but if you wish to know before Mr Evans will let you, give me a line & I will ... Mr Edwards for the valuation. I think he will not refuse me. I am sorry to so bad an account of Sir Watkin's health I hope he is better. Will you give my respectful complements to Mr Evans when you see him. I am dear sir


