Cotecna operates a global network of inspection teams and state-of-the-art accredited minerals testing laboratories in selected trade markets in addition to operating on-site testing facilities for top mining and industrial players.

Samples are collected from the cargo flows by our teams of dedicated and experienced inspectors for preparation and testing at accredited facilities or under our direct supervision. We provide services at mining sites, beneficiation and processing plants, storage and land transport facilities, and load/discharge ports.

We also specialise in the inspection of fertilisers, scrap metal, steel and other metal products in key emerging markets.


