Dear Mr. Greenewald:

This responds to your Freedom of Information Act (FOIA) request, dated September 13, 2012, that you submitted to the Defense Intelligence Agency (DIA) for information concerning FOIA Case Logs for the calendar years 2010 and 2011. I apologize for the delay in responding to your request. DIA continues its efforts to eliminate the large backlog of pending FOIA requests.

A search of DIA's systems of records located two documents (71 pages) responsive to your request.

Upon review, I have determined that some portions of the FOIA Logs must be withheld in part from disclosure pursuant to the FOIA. The withheld portions are exempt from release pursuant to Exemptions 3 and 6 of the FOIA, 5 U.S.C. § 552 (b)(3) and (b)(6). Exemption 3 applies to information specifically exempted by a statute establishing particular criteria for withholding. The applicable statutes are 10 U.S.C. § 424 and 50 U.S.C. § 403-1(i). Statute 10 U.S.C. § 424 protects the identity of DIA employees, the organizational structure of the agency, and any function of DIA. Statute 50 U.S.C. § 3024(i) protects intelligence sources and methods. Exemption 6 applies to information which if released would constitute an unwarranted invasion of the personal privacy of other individuals.

If you are not satisfied with my response to your request, you may exercise your right to file an administrative appeal by writing to the address below and referring to case number 0428-2012. Your appeal must be postmarked no later than 60 days after the date of this letter.
