FBI FOIPA Addendum

As referenced in our letter responding to your Freedom of Information/Privacy Acts (FOIPA) request, the FBI FOIPA Addendum provides information applicable to your request. Part 1 of the Addendum includes standard responses that apply to all requests. Part 2 includes standard responses that apply to requests for records about individuals to the extent your request seeks the listed information. Part 3 includes general information about FBI records, searches, and programs.

Part 1: The standard responses below apply to all requests:

- (i) **5 U.S.C. § 552(c).** Congress excluded three categories of law enforcement and national security records from the requirements of the FOIPA [5 U.S.C. § 552(c)]. FBI responses are limited to those records subject to the requirements of the FOIPA. Additional information about the FBI and the FOIPA can be found on the www.fbi.gov/foia website.
- (ii) **Intelligence Records.** To the extent your request seeks records of intelligence sources, methods, or activities, the FBI can neither confirm nor deny the existence of records pursuant to FOIA exemptions (b)(1), (b)(3), and as applicable to requests for records about individuals, PA exemption (j)(2) [5 U.S.C. §§ 552/552a (b)(1), (b)(3), and (j)(2)]. The mere acknowledgment of the existence or nonexistence of such records is itself a classified fact protected by FOIA exemption (b)(1) and/or would reveal intelligence sources, methods, or activities protected by exemption (b)(3) [50 USC § 3024(i)(1)]. - (iii) **Requests for Criminal History Records or Rap Sheets.** The Criminal Justice Information Services (CJIS) Division provides Identity History Summary Checks – often referred to as a criminal history record or rap sheet. These criminal history records are not the same as material in an investigative “FBI file.” An Identity History Summary Check is a listing of information taken from fingerprint cards and documents submitted to the FBI in connection with arrests, federal employment, naturalization, or military service. - (iv) **National Name Check Program (NNCP).** The mission of NNCP is to analyze and report information in response to name check requests received from federal agencies, for the purpose of protecting the United States from foreign and domestic threats to national security. Please be advised that this is a service provided to other federal agencies. Private Citizens cannot request a name check.

EXPLANATION OF EXEMPTIONS

SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552

- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;
- (b)(2) related solely to the internal personnel rules and practices of an agency;
- (b)(3) specifically exempted from disclosure by statute (other than section 552b of this title), provided that such statute (A) requires that the matters be withheld from the public in such a manner as to leave no discretion on issue, or (B) establishes particular criteria for withholding or refers to particular types of matters to be withheld;
- (b)(4) trade secrets and commercial or financial information obtained from a person and privileged or confidential;
- (b)(5) inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency;
- (b)(6) personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy;
- (b)(7) records or information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information (A) could reasonably be expected to interfere with enforcement proceedings, (B) would deprive a person of a right to a fair trial or an impartial adjudication, (C) could reasonably be expected to constitute an unwarranted invasion of personal privacy, (D) could reasonably be expected to disclose the identity of confidential source, including a State, local, or foreign agency or authority or any private institution which furnished information on a confidential basis, and, in the case of record or information compiled by a criminal law enforcement authority in the course of a criminal investigation, or by an agency conducting a lawful national security intelligence investigation, information furnished by a confidential source, (E) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law, or (F) could reasonably be expected to endanger the life or physical safety of any individual;
- (b)(8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for the regulation or supervision of financial institutions; or
- (b)(9) geological and geophysical information and data, including maps, concerning wells.

- (k)(2) investigatory material compiled for law enforcement purposes, other than criminal, which did not result in loss of a right, benefit or privilege under Federal programs, or which would identify a source who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(3) material maintained in connection with providing protective services to the President of the United States or any other individual pursuant to the authority of Title 18, United States Code, Section 3056;
- (k)(4) required by statute to be maintained and used solely as statistical records;
- (k)(5) investigatory material compiled solely for the purpose of determining suitability, eligibility, or qualifications for Federal civilian employment or for access to classified information, the disclosure of which would reveal the identity of the person who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(6) testing or examination material used to determine individual qualifications for appointment or promotion in Federal Government service the release of which would compromise the testing or examination process;
- (k)(7) material used to determine potential for promotion in the armed services, the disclosure of which would reveal the identity of the person who furnished the material pursuant to a promise that his/her identity would be held in confidence.

For the information of the Bureau, there is a letterhead memorandum captioned as above relative to information received from LEONARD H. STRINGFIELD on September 25, 1961, and on October 2, 1961, by SA GEORGE J. MC QUAD. One copy of letterhead memorandum has been disseminated locally to OSI, Cincinnati, Ohio.

Flying Saucers

For completion of the Bureau's file concerning matters relating to LEONARD H. STRINGFIELD, the following is set forth:

A newspaper article captioned "Death and Funerals, L.R. "PAT" STRINGFIELD; decorated war hero", appeared in the Cincinnati Enquirer, a newspaper of general circulation in the Greater Cincinnati, Ohio, area, dated June 15, 1960, reflects that LEONARD R. "PAT" STRINGFIELD, a much decorated veteran of World War I, and one of the chapter members of Chapter 1 of the disabled American Veterans in Cincinnati, died at his home, 2495 Harrison Avenue, at age 62.

This article further reflects that one of his sons, LEONARD H. STRINGFIELD, Mariemont, is known nationally for his researches into the study of unidentified flying objects, and holds views on the subject which have attracted the attention of the Federal Government. The article identified Mr.

Stringfield as an Advertising Executive of the DuBois Chemical Company, and further shows that his study of reports on flying saucers, however, have convinced him they are from other planets.

Additionally, a news article appeared in the Cincinnati Post and Times Star, a daily newspaper of general circulation in the Cincinnati, Ohio, area, under date of June 4, 1960, page 5, captioned, "Tell Secrets on Saucers, Expert Says", which article is set forth verbatim as follows:

"Leonard Stringfield, Cincinnati's flying saucer expert, believes the United States could take the space spotlight away from Russia by opening up secret files on unidentified flying objects.

'It could be the start of co-operation among all governments of the world,' he says. 'If all governments would pool their information on unidentified flying objects and work in unison on this it would help to ease world tensions.'

Stringfield, advertising manager for DuBois Chemicals, Inc., believes the unidentified flying objects are from outer space and that they are controlled by intelligent beings who are observing earth.

'I don't believe there is any hostile intent,' he said. 'I believe they have been using planets in our solar system for bases, even the moon. Astronomers for years have observed shifting spots on the moon.'

Stringfield said he believes U.S. Air Force secret files contain evidence 'or near evidence' that the objects are from outer space, but that officials are afraid that it would cause panic if released.

Foreign governments, too, have such evidence, he said, but are keeping it secret for the same reason.

Stringfield, who heads Cincinnati's Unidentified Flying Object Society, became interested in unidentified flying objects in 1945 while in the Air Force. He said

he saw a formation of them from a bomber.

Since then he has served as a spotter for the Air Defense Command, published a magazine about the objects, and written a book on them."

Leonard H. Stringfield, Advertising Manager, DuBois Chemical Company, Inc., 7th and Broadway, Cincinnati, Ohio, residence, 4412 Grove Avenue, Mariemont, Cincinnati, Ohio, advised on September 25, 1961, that he is active in unidentified flying objects research, that he has published a bulletin concerning these matters, that he is well known in this field, and that he has worked with the Air Defense Command concerning matters relating to unidentified flying objects.

Mr. Stringfield advised that he recently appeared on a television program known as Impact News on television station WCPO-TV, Cincinnati, Ohio, appearing on Sunday, September 10, 1961, at which time he was questioned by a panel of three members concerning matters relating to unidentified flying objects.

Mr. Stringfield advised that at approximately 9:00 A.M. on September 25, 1961, he had received an anonymous telephone call, being male caller, whose voice he described as firm, clear, and who spoke good English. The caller related that he had very important information to relate to Mr. Stringfield, whom he asked for by name in his call, relating to unidentified flying objects. Mr. Stringfield related that the caller

stated in effect, "We are calling all key and responsible people on this matter", after the caller had established that he was speaking with Mr. Stringfield, which call was placed to Mr. Stringfield's place of employment, mentioned above, telephone GA 1-5100. The caller would not identify himself, and in the phone call alerted Mr. Stringfield to expect, "the biggest flurry of unidentified flying objects sightings as a result of Russian nuclear explosions in the one hundred megaton range". Mr. Stringfield advised that the caller said to be prepared when confusion begins resulting from these sightings. The caller related that these sightings would be seen between certain dates, and that to the best of Mr. Stringfield's recollection, the caller stated, "Mark these dates, October 15 to October 19, during which will be the greatest incident in UFO (Unidentified Flying Objects) activity over the years". According to Mr. Stringfield, the caller remarked further, "I'll remain in touch with you, and will call back after the nineteenth".

Mr. Stringfield advised that the caller refused to identify himself, and according to Mr. Stringfield seemed to speak intelligently in the message he had to relate to Mr. Stringfield.

Mr. Stringfield advised that he was concerned about this telephone call in that if there were any truth in the matter, and if such sightings should occur, that it may cause panic among the populous in this country, and that further, that the caller seemed to speak very seriously, and there was no indication in the caller's voice or message to indicate that it was a joke or a prank.

Mr. Stringfield advised that it is not unusual that he receives telephone calls concerning unidentified objects, inasmuch as he, Stringfield, is authorized to report sightings of unidentified objects to the headquarters, Air Defense Command, at Columbus, Ohio. He stated further that it is not unusual that he might receive such a call inasmuch as he is publicly known as a person who is interested in matters relating to unidentified flying objects.

Mr. Stringfield advised that he is an advisor to the National Investigations Committee on aerial phenomena, which committee is located on Connecticut

Street, Washington, D.C., Major Donald Keyhoe, Director. Mr. Stringfield noted that the personnel of this committee are made up of civilian personnel.

On October 2, 1961, Mr. Stringfield advised the Cincinnati Office, FBI, Cincinnati, Ohio, that he had noted an article in the Sunday edition of the Cincinnati Enquirer, October 1, 1961, on page 1, section E, under the caption, "Offbeat Washington", which contained one paragraph, "Some Defense Department bigwigs are apprehensive that Russia will climax its campaign of intimidation by a spectacular explosion in space--an immense nuclear blast visible to hundreds of millions of people. These officials believe that the Soviet Union has the capability of setting off such an explosion 200 miles or so above the earth where it could be seen from many countries."

Mr. Stringfield advised that the above paragraph was printed as a reprint from the Herald Tribune News Service, Washington, D.C., and that this article seemed to tie in well with what the caller had related to Mr. Stringfield in the anonymous telephone call on September 25, 1961.

Bufiles reflect that Eva Reich is the daughter of Dr. Wilhelm Reich, M.D., Director of the Wilhelm Reich Institute, aka., The Orgone Institute Research Laboratories, Inc., at Rangeley, Maine. Dr. Wilhelm Reich, following extensive investigation by the Food and Drug Administration, United States Department of Health, Education and Welfare, in May, 1956, was found guilty of contempt of court following the issuance of an injunction barring interstate shipment of devices, literature and promotional material regarding treatments by Reich of cancer and other serious diseases, said devices having been described as worthless by the Food and Drug Administration. Following unsuccessful appeal efforts, Reich was imprisoned on March 12, 1957. Since early 1957, as well as previous thereto, Wilhelm Reich, Eva Reich, William Moise and other members of Reich's staff have directed voluminous correspondence to the Bureau, to various Bureau divisions, and other United States Government agencies and officials. None of the material reviewed at the Bureau has indicated any violations within the investigative jurisdiction of this Bureau.

It is noted that Dr. Eva Reich (Mrs. William S. Moise) was recently interviewed by Special Agents of the Richmond Office assigned to the Alexandria, Virginia, Resident Agency at which time she furnished information in essence comparable with that set forth in her letter to Stringfield. She also indicated at that time that she had addressed similar information to the office of United States Senator Margaret Chase Smith and had contacted Assistant United States Attorney General William Tompkins. At that time Eva Reich, a naturalized citizen of the United States, also made certain derogatory comments relating to justice

and government administration in the United States, representing possible admissions against interest. This information was furnished by the Bureau to Assistant Attorney General Tompkins and the Director of the Immigration and Naturalization Service.

In view of the above information and in the absence of any indication that matters related by Eva Reich in her letter to Stringfield are within the Bureau's jurisdiction, Richmond should disregard the lead set out in the last paragraph of referenced Cincinnati letter.

There is enclosed herewith for the Richmond Office an Autostat of Eva Reich's letter to Leonard Stringfield, Cincinnati, Ohio, dated March 19, 1957. In view of Eva Reich's vague threatened use of force (set forth in the last paragraph of her letter to Stringfield), Richmond Division should promptly make this information available to appropriate local officials in Alexandria, Virginia.

FLYING SAUCERS

On March 25, 1957, LEONARD H. STRINGFIELD appeared at the Cincinnati Office for the purpose of calling attention to a letter dated March 19, 1957, which he had received from EVA REICH, M.D. (Mrs. WILLIAM S. MOISE, Route 1, P.O. Box 721, Alexandria, Virginia, telephone South 5-7081).

For the information of the Bureau and the Norfolk Office, Mr. STRINGFIELD is presently the Advertising Manager for Dubois Company, Inc., 1120 W. Front Street, Cincinnati, Ohio. According to STRINGFIELD, he has been interested in flying discs or objects for a number of years and has cooperated with the United States Air Force to the extent of furnishing the Air Force with any information on flying objects coming to his attention. Mr. STRINGFIELD was also the publisher of a paper called the "Orbit", which carried the following heading: "The official publication of Civilian Research, Interplanetary Flying Objects". The "Orbit" was a monthly publication which carried information and intelligence research by STRINGFIELD on flying objects. According to STRINGFIELD, the "Orbit" had a limited circulation.

In connection with Dr. REICH's letter, STRINGFIELD stated that prior to the receipt of the letter he received a long distance telephone call from Dr. REICH on March 12, 1957. This call was received by him in the early morning prior to his departure for work. He related that Dr. REICH was a subscriber to the "Orbit" and that during the phone conversation she made reference to some of his reports which he had published in the "Orbit" and for the most part spoke on matters that were "over his head" and things that he did not understand. According to STRINGFIELD, she concluded the conversation by stating she would write him a letter, which letter was the reason for his call on the FBI.

Mr. STRINGFIELD furnished the letter to this office but desired the same be returned to him and it should be noted that Dr. REICH speaks of STRINGFIELD testifying before some Congressional committee in connection with flying saucers and his publication. She further speaks of events designated "OROP Desert Ea" which STRINGFIELD knows nothing about.

In the first paragraph of page 2 in speaking of the above event, she makes reference that there is evidence for espionage against this work and later adds that the FBI so far has declined to investigate as the subject is "not within their jurisdiction". It is further noted that she also speaks of the evidence of the "orgone energy motor", which STRINGFIELD has no knowledge of. Dr. REICH mentions a number of people as being former members on the staff of the expedition "OROP Desert Ea".

For the information of the Bureau and Norfolk, persons mentioned by Dr. REICH in her letter have been checked through the Cincinnati indices with negative results.

There are attached hereto two autostatic copies of Dr. REICH's letter to Mr. STRINGFIELD dated March 19, 1957, for the Bureau, and one copy for the Norfolk Office. The Norfolk Office is requested to check their indices on Dr. REICH and furnish the Bureau with any identifiable data concerning her and persons mentioned in her letter of March 19, 1957. This office is returning the original to Mr. STRINGFIELD and is not maintaining a copy of the same in this office.

Dear Mr. Stringfield:

This letter is to confirm and elaborate the contents of our telephone conversation on March 12, 1957. At that time I called you on my own initiative, acting as a planetary and U.S. citizen, who was a witness to a series of facts and events designated "OROP Desert Ea". It was my aim to find out whether you would be willing to testify about the facts known to you concerning UFO sighting reports made by the civilian public in the USA and elsewhere, which as Editor of CRIFO Orbit you have collected and filed over several years. I also wanted to know whether under oath you would reveal what you know in your official capacity as former USAF Intelligence officer (This information about you was gleaned from Edward J. Ruppelt's book "The UFO Story"). I finally based my call on the title of your publication "The official Publication of Civilian Research, Interplanetary Flying Objects" as distinguished from the mystics who dabble in the unknown.

I informed you that staffmembers of Expedition Orop Desert Ea, Arizona , 1954-1955 had lodged a charge of treason, fraud, perjury and conspiracy against certain government officials through the office of Senator Margaret Chase Smith on March 1, 1957. That these men had obstructed vital civilian research on the space problem, and have now apparently succeeded in their treacherous attack through defrauding the US court as to the nature of the work carried on during Expedition Orop Desert Ea; the discoverer of Life Energy, Dr. Wilhelm Reich being consequently imprisoned on March 12, 1957. The staff members of Expedition Orop Desert Ea wish to stress that in making their charges they are acting strictly on their own, on the basis of the respective facts known to each one. An investigation by the United States Congress has therefore been requested by us, concerning the underlying facts in this unique scandal. What has to be opened up is the entire field of UFO phenomena, the Undue Secrecy by Airforce headquarters , and the suppression of public news concerning the subject. Evidence points to the existence of a widespread conspiracy of those who want to maintain the status quo of the present world view, the atomic-mechanistic empty space hypothesis, the THEY in the background who want to kill all new knowledge by criminal means. Our evidence shows that "they" are in control of apparently all branches of the government. I feel personally unsure whether there exists at this point any bona fide honest constitutional government. After the events of March 11, 1957 the constitution is dead, Law and rational order has failed. I am basing this statement on the fact that in spite of the evidence on court record the sentence against the Discovery of the Life Energy was executed. For reference you have to go to the nearest US District Court where you will find Volume V Record Appendix to Briefs for Appellants, Case No. 5160, Supreme court Number 688, Secret and Suppressed Evidence, Orop Desert Ea, 1954-1955. The Title of the Report is "Contact with Space", Oranur, Second Report, 1951 - 1956, By Wilhelm Reich. Dr. Reich was found guilty of Contempt of Court for disobeying an UNLAWFUL and Fraudulently obtained order against his work (1954) and for stating at trial that he had to continue with his work for reasons of national security.

We, the staff members of this expedition are factual witnesses to some aspects of the work such as : Oranur experiment, Orur (Denatured Nuclear material - in other words "Atoms for Peace") , the Cloud-buster, Cloudbuster plus Orur equals "Spacegun", Disabled Ea (Epsilon alpha Dr. Reich's designation of Space craft)

Conferences with ATIC, notification of government officials in responsible positions, Conferences with CIA; DOR clouds and effects, DOR removal (Smog so called, also appears as smoky substance subsequent to UFO sightings as you know); DOR as Deadly Orgone Energy; Orene; Oranur Weather control: Rainmaking, also over deserts, Hurricane dissipation; Transportation of Orur including "queering of Radar"; Breakdown (Hemiplegia) of spacegun operator while drawing from Ea, - And many further detailed aspects of OROP Desert Ea work such as the "energetic nodes found experimentally", etc., etc.... There is no shortage of facts, observations, and evidence. But the Truth has so far not yet been heard, which is all it needs to win.

Furthermore there is evidence for espionage against this work: Tapped radio, opened mail etc. Since to date UFO's are officially "nonexistent" The FBI has so far declined to investigate as the subject is "not within their Jurisdiction". I am personally witness to the fact of the existence of the Orgone Energy Motor, and letters, documents, etc., describing the mysterious disappearance of one William Washington who came into possession of much knowledge concerning "orgonometry, mathematical, and the Motor principle," and who has disappeared since 1949. I am sure any investigating agency could locate his whereabouts in a short time. It is clear that the powerful Oil interests in this country are out to keep their predominance in the field of power and income, and are involved in keeping the Orgone Energy Motor problem suppressed.

These points are mentioned to give you a hint how necessary a bona fide, courageous, forthright investigation has become. I am appending a bibliography for your convenience where you may find some of the printed evidence for our charges.

If no investigation is forthcoming within a reasonably short time we are forced to use force; - to use the scientific power of the Energy which we have learnt to trigger (storms, floods etc.)

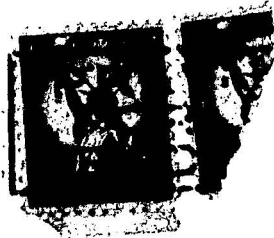
