Congressman Peter G. Torkildsen of Danvers, Massachusetts was elected to the U.S. House of Representatives in 1992. In January 1993, Torkildsen was appointed to the House Armed Services and Small Business Committees. In May 1993, he received a waiver to serve on a third committee, the House Merchant Marine and Fisheries Committee.

Since his election, Congressman Torkildsen has quickly earned a reputation as an independent Republican, working hard to bring real change and reform to Congress. Shortly after being sworn in, Torkildsen was elected co-chairman of the Freshman Republican Congressional Reform Task Force, which has proposed 19 specific reforms to open and streamline the process on Capitol Hill and to reduce spending on Congress.

Torkildsen is an original cosponsor of President Clinton's National Service Plan. However, Torkildsen voted against Clinton's tax increase proposal.

Congressman Torkildsen supports limiting terms, eliminating Political Action Committee contributions, and requiring that Congress obey the same laws that private citizens and employers must obey. To help reduce the deficit, he has been fighting to cut federal spending wherever possible. Torkildsen was ranked number 17 out of all 435 House members in proposing the most net spending cuts. He is also opposed to tax increases.

Prior to being elected to the U.S. House of Representatives, Congressman Torkildsen served in the Massachusetts State Legislature from 1984 to 1990. In 1991, Governor William Weld appointed him Commissioner of the Massachusetts Department of Labor and Industries.

Congressman Torkildsen has a master's degree in public administration from the J.F.K. School of Government at Harvard University and a bachelor's degree in political science from the University of Massachusetts at Amherst. Torkildsen is the first graduate of UMass-Amherst ever to serve in Congress.

As you know Peter was the Massachusetts coordinator for Dole in '88. I've enclosed some clips about him and the race and a recent bio.

We're trying to convey three things about Peter.

1. He's honest and has integrity. In his last election, Peter beat then-indicted and later convicted Nick Mavroules. There was a cloud over the sixth district, and electing Peter restored integrity to the seat.

He's worked hard for Congressional reform (I've attached the 19 reforms proposed by the Freshman Republican Task Force on Congressional Reform, which Peter co-chairs with Tillie Fowler of Florida), and quickly established himself as a leader in Congress.

2. He's hardworking. Peter serves on three committees, rather than the standard two. He petitioned for a waiver to sit on Merchant Marine and Fisheries, crucial to our district because Gloucester is the #1 port on the East Coast in terms of tonnage of fish landed.

He built the coalition that saved the FA/18 fighter, manufactured here in Lynn by GE, not just to save jobs for the district but also because it's the right thing to do for national defense.

3. He's independent, and a moderate. His district has a 3 to 1 ratio of Democrats to Republicans. His opponents are trying to run two themes -- first that a Democrat could get things done and second that Peter, having voted for Gingrich for leader, is a right-wing partisan.

In this category, we've taken a hit on Peter's recent vote in opposition to the assault rifle ban. It wouldn't hurt if the Senator said something like, "Peter thinks every issue through and votes his conscience, and I haven't always agreed with him. For instance, he voted in favor of the Brady Bill. But it's just another example of Peter's integrity at work."

As to the race, there are four Democrat contenders. Two stand out -- Jeff Hayward, a state rep from Lynn, and John Tierney, a lawyer from Salem.

Hayward is an ultra-partisan, worked hard for Mavroules. Tierney is an ultraliberal.

Presidents can, of course, and sometimes do, go over the heads of Congress to take their cases to the people in the hopes that they, in turn, will press their district's representative to support the president's case. Bill Clinton did that with NAFTA, and he and his wife, Hillary, have been doing that with regards to their health care package.

But that practice has its limits. Congress still controls the purse, and it is the purse, after all, that contains the real power.

That is why Torkildsen's performance has real meaning to all residents of this 6th Congressional District.

What he has earned, from all accounts off the Hill, is the respect of his colleagues of both parties. What that implies is opportunity to grow through more powerful committee assignments, and a larger role within his own party's congressional decision-making process.

## Not above reproach

The indictment of Dan Rostenkowski, the former chairman of the House Ways and Means Committee, on 17 felony counts - he stands accused of bilking the taxpayer out of \$500,000 over 20 years of corruption in Congress - raises the question of what should be done with congressmen brought up on criminal charges.

In America there has to be a presumption of innocence until proven guilty. President Clinton was right to say that "like all Americans, Chairman Rostenkowski has the right to contest the charges made against him and have his day in court." That is exactly what he is doing, having rejected the advice of his lawyers to accept a plea bargain and a short jail sentence. But there is also a matter of public trust.

Rostenkowski has relinquished his committee chairmanship, as is required under Democratic Party rules. The Republicans have a similar rule thanks to Rep. Peter Torkildsen, as he explains in a letter elsewhere on this page. "Efforts to reform Congress must apply to Republicans and Democrats alike," Torkildsen says. Torkildsen's rule for the GOP came into effect only last August. It should now be applied retroactively to remove Rep. Joseph McDade, the ranking Republican on the Appropriations Committee, who was indicted for bribery two years ago.

Furthermore, McDade and Rostenkowski should be asked to step down from their committees until their day in court has come and gone. This would remove any perception that indicted congressmen are manipulating their committees behind the scenes even though they no longer hold leadership positions.

There has been a serious erosion of public trust in Congress in recent years. Particularly offensive is the suggestion that somehow good old Rosty, 36 years in the House, was doing no more than others have done - a lovable old dinosaur caught in a newage morality tar pit.

Spiro Agnew tried to make the same case when bribe-taking drove him from the vice presidency: He said he was a victim of a new morality. Until these charges have been cleared, McDade and Rostenkowski should stay off their committees.

# Congress should follow Torkildsen's example

During his 1992 campaign for Congress, Peter Torkildsen promised to save 10 percent of his staff budget during his first year in office.

He did far more than that.

According to reports for 1993, Congressman Torkildsen saved 21 percent of the nearly \$1 million Congress allots to each of its members.

Torkildsen spent \$200,000 less than his annual \$941,230 budget to run his five offices in Washington, D.C., and Salem, Lynn, Haverhill and Burlington, Mass. That budget did not include his \$133,000 salary, \$4,000 of which he donated to charity because he objected to the cost-of-living raise Congress gave itself.

But all of Torkildsen's efforts to cut back on his spending may not save taxpayers a dime.

The \$200,000 he saved will automatically go to the account of House Speaker Thomas Foley. And Foley can use the money as he pleases.

Torkildsen is supporting legislation that would require that those dollars be returned to the U.S. Treasury and be used to reduce the \$234 billion national deficit.

The idea makes a lot of sense.

Torkildsen's biggest savings were in the category of free mailings known as the congressional frank. Congress allotted Torkildsen about \$180,000 for franking privileges.

Torkildsen's office spent \$33,000 for targeted mailings and responses to letters from constituents.

Torkildsen's predecessor, former U.S. Rep. Nicholas Mavroules, had used the money to send out two or more glossy, four-page newsletters each year. The newsletters showed the congressman shaking hands with business and union leaders, listing his upcoming appearances, and telling of all he had accomplished for his constituents.

There was nothing illegal about that. Mayroules was simply doing what most of his colleagues were doing then and continue to do now.

Many political reformers consider the frank nothing more than campaign literature aimed at getting congressmen re elected at taxpayers' expense.

Torkildsen wants to do something about that. too.

The congressman has not sent out mass mailings or newsletters to constituents. His only mailings were sent to residents of the cities and towns where Torkildsen planned to hold town meetings.

Other areas of savings came from paying staff lower-than-average salaries (saving \$34,000) and conserving and cutting back on purchases of supplies.

Torkildson sets a good example, but change comes slowly in Congress, especially when it goes against the self-interest of its members. Not many of Torkildsen's colleagues will come running to his cause, especially during a re-election year.

But, while, \$200,000 is a more drop in the bucket of the nation's trillion deficit, it is an important drop. It sends a message that law-" makers need to get their own house in order before the public will believe they are able - and willing - to do anything about the nation's bigger budget problems.

## Ethics violation eyed for presence of on-duty cops

SALEM — U.S. Rep. Peter G. Torkildsen's campaign manager cried foul Tuesday over Democratic challenger Jeffery Hayward's use of on-duty Lynn police officers and assault weapons from the police evidence locker during a press conference the Lynn legislator held in Salem Tuesday.

Hayward staged the appear-

ance to attack the incumbent for his vote against a ban on assault weapons.

State officials, contacted by the Salem News Tuesday afternoon, said they may examine whether Hayward violated any ethics or conflict-of-interest laws.

And a high-ranking officer of the Lynn Police Department, who authorized the weapons release,

said Tuesday he was misled by Hayward to believe the press conference was intended only as a rally in support of a state ban on assault weapons — not a campaign attack on Torkildsen.

Hayward, one of several Democrats vying to unseat Torkildsen, used the weapons as props during the press conference, in which he criticized Torkildsen for his vote last week against a federal ban on

#### assault weapons.

Hayward also used the event to publicize an amendment to the state budget he filed Monday that would ban the sale of 40 types of assault weapons in Massachusetts (See related story). The deputy chief said he was not made aware of the location of the press conference — in front of Torkildsen's district office on Washington Street - until minutes before it was scheduled to begin.

By 10 a.m., when the conference was set to get under way, a table and podium had been set up in front of Torkildsen's office, but Hayward was across the street talking on a portable phone, and pacing in front of a parked Lynn police cruiser.

Minutes later, with no explanation, the location was switched. and the table and podium was moved to the front of Salem City Hall, where the press conference proceeded with about a dozen Hayward campaign staffers and supporters on hand, including his campaign manager, state Rep. Thomas P. Waish, D-Peabody.

Suslak said it was he who was talking with Hayward on the phone minutes before the press conference started. "Quite frankly, I was not aware this was going to take place in front of Torkildsen's office, and I told him (Hayward) I had a problem with that," he said.

Still believing the event was intended only as a rally for a state ban on assault weapons, which police support, Suslak said he allowed Hayward to use the weapons, provided the location be changed, thus explaining the lastminute shuffle to the front of City Hall

Suslak said use of the weapons and participation by Lynn police officers in the press conference should in no way be construed as an endorsement by Lynn police of Hayward's candidacy for Congress.

"It is not the policy of Lynn police to become actively involved in political races, but it seems we were inadvertently put in that position," he said. "I hope this is not interpreted as a political endorsement by Lynn police. That was certainly not our intention."

Torkildsen campaign manager Wendy Wakeman expressed an-ger over the affair Tuesday af ternoon and questioned whether Hayward violated campaign laws by using on-duty police officers and assault weapons in custody of municipal authorities for an event at least partly intended to bolster his candidacy for Congress.

"The fact that a city employee from the city of Lynn participated in a political press conference, on city time and at city expense, and with a city of Lynn police cruiser, is outrageous," Wakeman said Tuesday afternoon. "I think it's pretty clear that this is stepping over the line in terms of what city employees should be doing.

Salem Police Capt. Paul Tucker said, since Lynn police were present to watch over the assault apons, he does not believe

there were any city ordinances violated by the sidewalk display.

State officials, however, said they plan to look into the matter to determine whether an ethics violation was committed by the congressional candidate.

Steve Gordon, assistant counsel for the Office of Campaign and Political Finance, said: "Police officers on duty should not be participating in any kind of political activity.

A spokesman from the State Ethics Commission expressed interest in researching the matter. as well, specifically whether Hayward violated Section 23 of the Conflict of Interest Law, which states, in part: "No current officer or employee of the state, county. or municipal agency shall knowingly use or attempt to use his official position to secure for himself or for others unwarranted privileges ...

Also prohibited, according to campaign finance law, is "use of public resources of substantial value (\$50 or more), available by virtue of one's public employment, for the purpose of conducting or supporting a political cam-paign."

The Ethics Commission source. who did not want to be identified. questioned whether Hayward was able to secure use of the police and weapons for the press conference through his relationship with police as Lynn's state representative.

Since Suslak maintains he was unaware of the content of Hayward's press conference, Gordon said he does not believe Lynn police were at fault.

But whether Hayward committed any sort of ethics violation, he said. would take time to determine.

Hayward expressed little concern over the issue in interviews Tuesday afternoon, saying the allegation of an ethics violation is an attempt by the Torkildsen Committee "to distort the real issue," referring to Torkildsen's vote last week in opposition to the federal ban on assault weapons.

Agreeing with Hayward, Cos-tello said childhood education and family values are the strongest tools to prevent crime. "Having raised five sons, I never allowed a toy gun in my home," he said.

Monahan was not present for the gun control question.

Asked whether they would accept contributions from political action committees, each of the candidates said they would not, and spoke of the need for campaign finance reform.

"We should limit the total amount that can be spent on a campaign; do away with PACs (political action committees) and reduce the amount of individual contributions," Tierney said.

Hayward said he was a strong advocate on Beacon Hill for campaign finance reform and caps on campaign spending.

Costello said Torkildsen "stands to make a lot of money (from the gun lobby) with his vote the other day." adding laws should be in plan that limit PAC contributions. He noted, however, the original inteni of PACs "was so the average working peo-phy (by buckny their recomment to get their candidate elected as the rich."

Monahan said he would decline PAC money and, if elected, represent his constituents rather than the special interest groups.

The candidates were asked several questions about how they would address the social problems that lead to crime.

Monahan noted, as mayor, "I supported Project RAP (a counseling program in Beverly) in good times and bad." He said he would fight for more money for. anti-drug and crime education, as well as funding for self hclp groups and substance abuse programs.

Monahan said he would also fight for an increase in the federal minimum wage and "to offer something better to families living on public assistance."

Costello said he believes most of the people on welfare "would rather not be," and one of the primary reasons they are on welfare is because of health care. He said the threat of losing health coverage keeps people on welfare who would otherwise be out working.

"We can't resolve the welfare situation until we have real health care reform," he said.

Hayward also said he would strive to create more job opportunities for young adults and support programs "liat give kids a sumee of belonging." He siso said prolitize reforms are injented so mothers on longe. have to choose between falling a job or

Tierney also said job creation and education are paramount is addressing the social problem that lead to crime. He said chil dren "need a place to go afte: school, not just to hang around but somewhere to learn socia skills and conflict resolution."

Asked where they stand on the issue of legalizing drugs, Tierney was the only candidate not to speak in vehement opposition.

'We should study the issue," Tierney said. "The traditional approaches (to combating drug addiction) obviously are not working.'

Tierney said prosecutors and detense lawyers alike "are fed up" with seeing the same people in court on drug charges. "The defendants think it's a joke," he said.

In addition to truth-in-sentencing guidelines, Tierney said making drugs legal is something that should at least be studied as an alternative solution.

Hayward said he is not only opposed to legalizing drugs, but opposed to needle exchange programs as well. He said addicts discard used needles on streets and in yards, noting "my 8-yearold son picked one of them up yesterday."

All of the candidates said they would support a ban on smoking in public areas, but not in bars and inverns. Dur Costelio said he thinks non-shokers "are going a little los fat" in their field and TOTAL P.12

enifer Duryea worked for Barbara Hildt in her 1992 campaign to heat Nick Mayroules.

There are a lot of reasons why Hildt lost that election, but it will always stay with the people in her campaign that the came within about

700 votes of becoming the Democratic nominec for Congress.

And, in their opinion, within 700 votes of being elected to the House of Representatives.

Though Hilds was certainly not a shoo-in for Congress, she could undoubledly have put up a better fight than Mavroules, who was well on his way to prison by the time the election rolled around. Those 700 votes were a wake up call to area Democrais.

And, as freshman Congressman Peter Torkildsen left for Washington, they began considering the situation facing them

With a formerly secure seat now back in the hands of a Republican, they found themselves looking to take the seat away rather than simply hold onto it.

Membership in labor unions, which traditionally supplied plenty of push for the Democratic campaigns, has declined.

And the state and national pasties have atrophied, leaving local candidates to their own devices when it comes to building campaigns. All of this change was easy to ignore while Mavroules swept into office time and again. So it sort of crept up on local Democrats.

With Mavroules gone now, the party has to address some of these problems. Toward that end, local Democrats have put together a district-wide organization called Network 6 to take back the seat. In addition, they're trying, to reform the state party to make it more attractive to new members.

"We're spending about half our time on elections and half on rebuilding party membership," says Duryea, vice president of Network 6. As the congressional race heats up, she expects the election will become a priority, though.

Right now the group is staying neutral while the three Democrats in the race — Jeff Hayward of Lynn, John Tierney of Salem and Nick Costello of Amesbury — fight it out to win the nomination. After that, they intend to offer their help for the final election.

Torkildsen, they say, may have slipped into office while they weren't paying enough attention. But he won't stay in there without a fight.

#### Wide open?

Handicapping elections by looking at past results is a foolish pastime, says Michael Goldman, a consultant to Tierney.

But, politicians are learning some lessons from past campaigns, including Hildt's failed bid to win the congressional primary in 1992.

Hildt entered the race with very little money, and very little name recognition because her political base was Amesbury, the northernmost town in the district.

She had the advantage, however, of running against Mavroules, who was already the subject of the criminal corruption investigation that ultimately landed him in prison.

When the votes were counted, Hildt lost a very tight race.

"Her field operation suffered because she needed (to use her) dough to raise her name recognition," Goldmah says.

Though the decision to spend more on name recognition was planned, the results of that election still bother people.

But Goldman says a similar race will not emerge this time, since no one will have to overcome the type of name recognition that Mayroules had.

Hence, he says, the race is wide open

But what about the general election? "There is no doubt in my mind that the person who wins the Democratic primary will win the election," Goldman says. "All three candidates have the talent, the

Naturally, not everyone agrees.

Catharine Sibble. Torkildsen's campaign manager, says she sees several indicators to suggest the Republicans can hold the seat.

"If you look at it historically, it has been a Republican seat," she says. And, though it was held by a Democrat for the 20 years prior to Torkildsen. Sibble says the times have changed for Republicans in the state.

"The election of Governor Weld was the dawn of a new resurgence of Republicans in Massachusetts," she says. "The party is attracting votes from independents that it didn't used to."

And, she says, Torkildsen fits Weld's moderate mold that appeals to voters.

Democrats, meanwhile, don't put much stock in the Weld election. He was, after all, running against ornery John Silber.

"In that race, I think a lot of it came down to the individual personalities who were candidates," says Tom Walsh, manager of Democrat Jeff Hayward's campaign.

Democrats would rather point to the Clinton/Bush election as an indicator of voter sentiment in the Sixth District.

In that race, Clinton won the district. And voters are likely to be reminded of that throughout this election. regardless of which candidate wins the primary to run against Torkildsen. A vote for a Democrat, they will say, is a vote for the Clinton agenda.

On this point, the Torkildsen camp is quick to point out that Torkildsen voted with Clinton 60 percent of the time in his first year.

Meanwhile, at the other end of the spectruin, they've got Republican Paul McCanthy taking shots at them.

McCarthy, who is not seen as a serious challenger to Torkildsen, is talking about running as a conservative alternative to Torkildsen. This gives the Torkildsen campaign a perfect opportunity to highlight their man's moderate record.

"You've got Paul McCarthy calling him a

liberal and John Tierney calling him a rabid conservative," Sibble says. The effect of that, she hopes, is that voters will see Torkildsen as a moderate.

#### **Correct flip-flops**

The comparison that immediately springs to Michael Goldman's mind when he thinks of Peter Torkildsen is Richard Nixon. He'd probably say Albert DiSalvo, except not everyone would recognize the name as the Boston Strangler.

Torkildsen's likeness to Nixon is based on Nixon's proclivity for changing his opinions, Goldman says.

Torkildsen has been known for the same trait on issues like abortion and whether or not to accept Political Action Committee contributions.

The problem for Democrats is that Torkildsen's flip-flops have been in the right direction, politically speaking.

Running in a pro-choice district, he's now pro-choice. Running in a reform-minded era, he's now anti-PAC.

The challenge to Democrats is to try to hammer Torkildsen for both his old positions and his new ones.

And how that will sell with the voters is difficult to judge, since its never been tried on Torkildsen before.

The fact is, Torkildsen as a congressman has never faced a serious election campaign.

In winning the Republican primary in 1992, he was well organized. And, while his opponent had a base of support in Lynn, Torkildsen had the suburbs, which is where the Republicans are.

With only 50,000 Republicans in the district, and a hotly contested Democratic primary that drew many of the independents into that race. Torkildsen was able to win the nomination by carefully targeting his supporters and turning them out on election day.

By the time the general election rolled around, with 350,000 registered voters in the pool, Mavroules was effectively a dead candidate. All Torkildsen needed to do in that election was avoid doing anything disastrons.

This time, he's got to sell himself to the voters.

Sibble is confident that she's got something to sell. Torkildsen now has a record as a congressman to rum on, which Sibble see as a definite advantage.

Instead of merely saying what he supports. Torkildsen can point to votes that show what he supports.

"We are happy to put Peter's record up against anyone," she says.

#### **Clinton** coattails

Whoever wins the primary, Duryea and Network 6 President Gary Harris sny they're optimistic about a Democrat's chances in the district.

One big reason why? The Clinton election.

"We've got to get suburban and city Democrats working together," he says, "They tend to be a bit distrustful of each other, and if we allow that to continue, we're likely to lose.

"When those two segments of

the party pull together, we win," he says.

The Clinton election, he says, pulled together those two wings of the party.

"He was the first Democrat to, carry Marblehead since Grover Cleveland," he says. Now that Democrats have had a taste of the success they get from pulling together, he thinks Clinton's election can begin a trend.

Duryea agrees

Network 6, she says, already got a workout in a recent special election. That's the first of more grassroots organizing efforts to come.

And, Duryea says, she's also pushing for some reform within the Democratic Party.

For example, she wants the party's issues convention to be opened up to input from more members through regional conventions prior to the actual issues convention.

And, she'd like to see 10-year party delegates given lifetime status as delegates to free up more positions for young party members, who right now can not actively participate in the conventions.

These changes, she says, would help involve more people in the party, and hopefully create a bigger pool of committed volunteers at election time.

"I don't say these things as criticisms of the party," she says. "I don't think anyone has intentionally let things slide.

"This is a cyclical thing. Right now there are regional groups starting up all over the state," she says. "Eventually, we'll outlive our usefulness and someone will come along and boot us in the rear, too." #### **REPUBLICAN RACE UPDATE:**

1. The Massachusetts Republican Party held its convention on May 13 and 14 in Springfield. As expected, businessman Mitt Romney won an overwhelming endorsement by carrying 68% of the 3,100 delegates. Businessman and 1982 GOP gubernatorial primary candidate John Lakian picked-up 16.3% of the delegate votes; a candidate needs a minimum of 15% to appear on the September 20 primary ballot. None of the other four announced candidates -- including former talk show host Janet Jeghelian -- achieved over 10% of the vote.

2. With the party's endorsement and because of his fundraising potential, Romney has clearly taken the front-runner status, reporting \$329,920 in cash-on-hand from the \$458,916 he raised through the first quarter of the year. Lakian raised \$88,592, has loaned his campaign \$544,256, spent \$524,853 and reports \$21,153 on-hand.

3. Following the convention, Lakian was encouraged by Governor Weld to remain in the race, citing that a primary helped him to organize his successful 1990 gubernatorial campaign. Others, however, have not been as supportive of Lakian's bid and during the convention, State Treasurer and 1988 GOP Senate candidate Joe Malone publicly endorsed Romney.

Recent developments include:

• Democrats have raised questions about a Romney ad that featured police officers and a police cruiser from the City of Belmont. A complaint has been filed with the state ethics commission citing a rule that says "a public employee's use of his official position to promote political or campaign related matters is unwarranted where such political activity falls outside the scope of his official duties." However, the police officers were not on duty at the time that the commercial was filmed, and the police cruiser was not moved specifically for this purpose.

• Lakian recently had to pay a sizable cash settlement to avoid legal action by federal bank regulators over his role in the 1990 failure of a Boston bank. The liability settlement forestalls a threatened federal lawsuit against 13 ex-bank officials who were being investigated for making millions of dollars in improper loans during the late 1980s.

Further, another controversy erupted when it was reported that Lakian used a home in New York as his address when contributing to the campaign of Mayor Rudolph Giuliani, thereby qualifying his contribution for matching funds. He now says that a vacation home in Woods Hole, Mass. is his permanent address, and his family recently moved there full time.

• Romney has come under fire by Lakian for his Mormon church ties and contradictions between church teachings and some of Romney's political views, including his pro-choice position (the Mormon church is staunchly pro-life). Romney has not helped himself by appearing uninformed on certain issues, and Kennedy has already begun attacking Romney as a right-wing extremist.

• The Boston Herald reported an April 22 poll that showed Kennedy's favorable/unfavorable dropping to 38% / 36%, as compared to his 67% / 26% in a poll taken February 3. The poll also showed that the Republican candidates still have a very low name I.D. (PLEASE SEE THE RESULTS IN LATEST POLLING INFORMATION AT THE END OF THIS BRIEF)

#### **KENNEDY:**

Kennedy won the '88 election with 65% of the vote Joe Malone. Malone was greatly outspent by Kennedy (\$587,323 against Kennedy's \$2,702,865), but his '88 Senate race set the stage for his '90 victory in the Treasurer's race.

Kennedy accepted his party's endorsement at the Massachusetts Democratic State Convention on June 3 and 4. Tying himself very closely with Clinton, Kennedy touted himself as a "formidable champion of the state's interests in Washington," casting himself as the top target of the GOP far right, saying that "those who most fiercely oppose President Clinton have made me their number one target in 1994."

Ultimately, voters seem to have grown weary of Kennedy, with concerns over his personal life as well as his extended stay in the Senate. In the *Globe* poll, 31% of those polled said that they would be less likely to vote for Kennedy because of his past personal behavior; 42% who identified themselves as independents shared that view.

#### POLITICAL ENVIRONMENT:

It would be simplistic, at best, to narrowly define the political environment in Massachusetts as unpredictable, but it would be a fair assessment. Politics in Massachusetts for years has been a kind of cultural war, between Yankee Republicans and Irish Democrats, an argument not over the distribution of income or the provision of services, as over whose vision of Massachusetts should be honored and whose mores regarded as the norm.

Over the years, the percentage of Irish and Catholics has risen. While many old line Massachusetts families have left the state or intermarried, the Irish mostly stayed put, raised large families, and slowly moved Massachusetts from being one of the most Republican states to one of the most Democratic. Historically, local Irish Democrats were conservative on cultural issues, hostile to liberal internationalism, and receptive to anti-communism. However, the expanding high-skill population, attracted initially by Massachusetts's many universities and colleges, was very liberal and combined their Democratic vote to ensure large majorities for candidates like the Kennedys, George McGovern, and Michael Dukakis.

1989 and 1990 marked the rapid decline in support for Massachusetts liberalism when Governor William Weld, a tax cutting, moderate Republican was elected along with State Treasurer Joe Malone, the first Republican wins for state office since 1970. Republicans won a majority of votes in contested races for the Governor's Council, and gained eight seats in the state Senate and eight in the House, even though many seats were left uncontested. Furthermore, Republicans picked up two congressional seats and seriously contested three others in 1992.



#### BIOGRAPHY

Peter Blute, 38, a Congressman representing Massachusetts' Third Congressional District, is currently serving his first term in the U.S. House of Representatives.

Congressman Blute was elected in November, 1992, one of only two Republicans to defeat a Democrat in the entire state that year, and was sworn into the 103rd Congress on January 5, 1993.

One of eleven children and a lifetime resident of Massachusetts, Peter Blute attended St. John's High School in Shrewsbury and won a full football scholarship to Boston College, graduating with a Bachelor of Arts in Political Science and cum laude honors.

Congressman Blute entered politics in 1984 as a staffer on the campaign of Elliot Richardson for United States Senate. He ran successfully for Massachusetts State Representative in 1986, beating an incumbent Democrat and winning re-election in 1988 and 1990.

While serving in the Massachusetts House of Representatives, Peter Blute took the lead in exposing the problems of the troubled Hynes Convention Center in Boston, a longtime Democratic patronage haven often criticized for mismanagement. Legislation he filed to privatize the Convention Center received widespread public support as well as praise from many editorial boards. In 1990, he exposed a major scandal at the Boston Common Parking Garage, owned by the Convention Center Authority, which led to the conviction of several employees and to a vote by the Convention Center Authority Board to sell the garage to the private sector.


In 1991, Representative Blute was the chief sponsor of legislation which repealed a 5% sales tax on services proposed by the lame-duck Dukakis Administration. The "Blute Amendment" prevented the tax from going into effect, protecting thousands of jobs in the state's growing service industry.

Congressman Blute currently sits on the House Committee on Public Works and Transportation, as well as the Committee on Science, Space and Technology. He is also a member of the Surface Transportation; Economic Development; Technology, Environment and Aviation; and Science Subcommittees. Additionally, Blute serves as a co-chair of the Republican Study Committee's Line-Item Veto Task Force.

During his brief time in Congress, Congressman Blute, along with many other freshman members has led several reform efforts such as the elimination of the House Select Committees and the drive to give the President a full line item veto.

Congressman Blute and his wife Robi live in Shrewsbury with their son James, born June 29, 1993.

One of two freshman Republicans in the Massachusetts delegation who had the good fortune to run against scandal-tured incumbents in 1992, Blute defeated veteran Rep. Joe Early (D), whose red-faced defense of his 140 overdrafts at the House Bank became a national symbol for anti-incumbency.

Blute immediately became one of the Democrats' top 1994 targets. His district, the redrawn 3rd, stretches from Worcester in the north to Fall River in the south — two bastions of blue-collar Democratic politics. Clinton won here with 45 percent in 1992, but Blute has largely voted the GOP line since taking office. An energetic campaigner, Blute will nevertheless have a very tough time keeping this seat in GOP hands.

Four candidates are running for the Democratic nod, but two of them, physician John Walsh and Oxfurn official James Arena

DcRosa, aren't likely to make it to a primary. That leaves state Rep. Kevin O'Sullivan and Congressional staffer Jim McGovern as the two strongest candidates for the nod. Both have political bases in Wornester, which means the outlying areas of the district will be crucial in the primary voting.

McGovern can count on help from his longtime boss, Massachusetts Rep. Joe Moakley, and is touting his Washington credentials as a way to bring jobs to the district.

O'Sullivan has served in the state legislature since 1987 and has a slight fundraising edge: hc's raised \$120,900 to McGovern's \$104,200. Each candidate had in excess of \$55,000 in the bank on March 31.

Blutc has been raising funds at a good clip — he took in more than \$300,000 in the last half of 1993 — and will be able to collect even more before the late Democratic primary is over. He'll need it all.

# Dems aim to oust GOP rookies in Cong

a 1982, Republican candldates Peter Torkildsen and Peter Blute faced off against the kind of incambents most candidates can only dream about.

The North Shore ath district's incumbent Democrat, Nicholas Mavroules (D-Peabody) had been indicted on tax evasion and corruption charges.

In the Worcester-based 3rd District, Democrat Joseph Early had been heavily battered by the press and primary challengers for his role in the congressional checkbouncing scandal.

As 1994 begins, a pack of Democratic candidates smelling blood - has begun to circle first-term congressmen Torkildsen (R-Danvers) and Blute (R-Shrewsbury). Both are seen by Democrats as highly vulnerable in districts that traditionally have been heavily Democratic and are cargeted by the state and national Democratic parties for recapture.

in contrast, the state's Democratic freshman, Martin T. Mechan (D-Lowell) has no opponents yet. Among the state's seven veteran Demo-

"Clearly two of the best opportunities for the Democrats in the country are those two sents," said Michael Meehan of the Democratic Cosgressional Campeign Committee. who said Blute and Torkildsen's seats are "In the top 10" seats that Democrats believe they can take from Republi-CRUSS.

"Peter Tortildsen was in the right place at the right time." said state Rep. Jeff Hayward (D-Lynn), who has jumped into the 6th district's Democratic primary race with former state Sen. Nick Costello of Amesbury and Salem lawyer John Tierney.

## U.S. House panel OKs transport bill

## By Scott S. Greenberger

WASHINGTON - Legislation that includes \$20 million to convert Worcester's Union Station into a modern transport center cleared a House subcommittee yesterday.

The bill, which aims to improve the nation's transportation network, would funnel \$24 million to Worcester, of which \$2.4 million would go to the city's Gateway Project. The legislation, called the National Highway System Authorization Act, also designates-several vital roads in Central Massachusetts as part of the National Highway System, making them eligible for a larger pool of federal funds.

cording to Rep. Peter I. Blute, R-Shrewsbury, a member of the surface transportation subcommittee of the Public Works and Transportation Committee.

"The inclusion of many of our highways and specific projects in the bill will spur economic growth," Blute added.

The nearly 159,000-mile National Highway System is part of a broader federal intitiative to create a National Transportation System, which would integrate airports, ports, waterways, rail, intercity bus lines, and local transit systems with regional and national impact

"A comprehensive National Transportation System will help us meet the challenges of the 21st-century global economy by enhancing all our different modes of transportation and their links - increasing the efficiency and productivity of our nation," according to Transportation Secretary Federico Pena.

The legislation designates various routes in southcastern and Central Massachusetts as part of the National Highway System, including Routes 9, 20, 122, 122A and 146. That would guarantee federal funds for repairs and expansion of those roads. The measure directs \$1.4 billion to other transportation projects nationwide, including the \$20 million for Union Station.

The Union Station project, which would integrate rail, taxi and bus service in Worcester, was halled by Blute as a "classic example of intermodalism."

"This bill is great news for Worcester," said David Forsberg, Worcester's chief development officer. "it's the first step toward finally realizing some federal recognition of the Union Station project, and the \$20 million will go a long way toward the effort to renovate the station into an intermodal transportation center."

The Gateway project, which would get \$2.4 million, would spur economic growth by improving access to downtown, city planners say. "The Gateway is a vital link in the economic development agenda of the city," Forsberg said.

#### 4 MILES OF ROUTE 146

The bill also would give the Massachusetts Department of Transportation \$16 million for the Route 146-Mass Pike interchange project, which includes improving four miles of Route 146 between the Mass Pike and Interstate 290.

"Connecting Worcester to the

Mass Pike opens up opportunities for Worcester commercially and transportation-wise that weren't there before," said Chrysa Meyers, speaking for the Massachusetts Highway Department.

The Public Works and Transportation Committee is notorious for doling out "pork-barrel" projects to the districts of its members. But Blute insisted that each project funded by the bill has been "scrutinized carefully," and that all are consistent with the overall vision of the NTS.

That view was echoed by Rep. Norman Minets, D-Calif., chairman of the committee.

"I want to emphasize that all the projects in this bill ... have gone through a rigorous process, including response to 18 detailed questions and the opportunity for input from state or local government," Mineta said.

"The days of casually tossing a project into a bill are over."

Union Station to benefit from pending bill

The new National Highway System Authorization Act has provided Worcestar's Union Station restoration project with its first official federal endorsement. It comes in the form a \$24 million provision in the transportation bill currently threading its way through Congress.

Of that amount, \$20 million would be federal funding to turn Union Station into a multi-use



transportation center, accommodating trains, busce, taxis and transit to the sirport.

Another \$2.4 million would go to the city's gateway project, designed to improve access and highway aesthetics in downtown. The remaining \$1.6 million would go to the vital Route 146-Massachusetts Turupike Connector.

U.S. Rep. Peter I. Blute has worked effectively to shepherd that critical funding through the initial stages of the legislative process.

Now, it is important for Sens. Edward M. Kennedy and John F. Kerry to get behind this muchneeded infusion for the area's transportation infrastructure.

With more than \$500 million in new downtown development in progress, strong transportation links will be essential for success.

Bay State lawmakers should keep the pressure on until the transportation bill is signed into law.

#### BACKGROUND

Rep. Peter Blute's race is a DCCC targeted race. The antiincumbent mood of the electorate was strong in 1992 when Rep. Peter Blute defeated incumbent Joe Early (D) who had held office there since 1974. Early had bounced 140 checks in the House bank, he protested to five judges and 25 lawyers a one-year jail sentence given to a bookie, and his two children received scholarships from an aerospace PAC - just some of the issues which brought about Early's defeat.

This is another DCCC targeted candidate - the 5th most vulnerable Republican candidate.

BACKGROUND AND ISSUES OF MASSACHUSETTS' 6TH CONGRESSIONAL DISTRICT

The 6th Congressional district has a total of 36 towns and is 3 to 1 democrats. The party breakdown is 36% Democrats, 12% Republicans, and 50+% Independents. There has been an increase in the registration of Independents in Massachusetts - over 80% of the new voters register as Independents. This is a victory for the Republican Party of MA as it is a switch from the historical Democratic stronghold over the state. Now voters are leaning away from the Democratic party.

You will also recall, that Torkildsen defeated Nicholas Mavroules who was indicted in August of 1992 on bribery, extortion and tax evasion charges. In April of 1993, Mavroules plead guilty to 15 of the 17 charges against him.


