**NOTICE IS HEREBY GIVEN THAT** Windsor Ridgecrest, LLC / Ridgecrest Community Healthcare, LLC (the "Assignor", or the "Company") executed a General Assignment for the benefit of its creditors (the "General Assignment") in favor of a special purpose assignee entity formed to undertake the General Assignment (the "Assignee") on March 14, 2023.

General Assignments are a recognized means to liquidate insolvent companies and are an alternative to filing a bankruptcy proceeding. General Assignments are generally considered to be a more cost-effective manner of liquidation and administration than other alternatives and generally results in a more expedited recovery for creditors.

The Assignor was a provider of long-term healthcare and rehabilitation services. The Assignee is advised that due to certain economic and other pressures, the existing operation by the Assignor was no longer feasible to provide optimal services for their patients, staff and community. Based on the foregoing, in early March 2023, prior to the General Assignment, the Assignor entered into agreement(s) for a new operator to take over operations of the Assignor.
