NEW CHURCH MAN ACCUSED IN SHOOTING DEATH OF STEPSON

A New Church man has been accused of the April 1 shooting death of his stepson at their home.

Lonnie Galen Medlin, 67, of Silverthorne Road, was charged with second-degree murder and use of a firearm in the death, according to documents filed in Accomack's Juvenile and Domestic Relations Court. He is being held in Accomack County Jail without bond.

The victim was 44-year-old Patrick O'Neil Wescott.

The "accused was cooperative with (the) magistrate and (the) law enforcement officer," the bond determination record stated. It also noted "the weight of evidence was sufficient" and that Medlin was convicted of battery in Maryland in 1989.

Medlin has lived in the community for 18 years and works at a trucking company in Pocomoke, Md., also according to the record. His arraignment was canceled Tuesday morning because he hired lawyer Carl Bundick of Accomack to defend him. A preliminary hearing was scheduled for May.

Investigator Edward Perry of the Accomack County Sheriff's Office

investigated.

"There are some things I believe a parent should never have to tell their child," the victim's wife, Mary Wescott, wrote on her Facebook page on April 2. "Please keep our family in prayer as we go through this difficult time. So many people are hurting for so many reasons. A child has lost his father, a mother has lost her son, two sisters have lost their brother, many have lost

their friend, someone has lost their love, and I have lost my friend and their [sic] person I shared my child with. This is a time we need to love each other and lift each other up not condemn, blame, or judge. So many people are being affected by the terrible incidents that have taken place. I believe that even in these most horrible of circumstances we can still come through this if we focus on love and not

hate of any form for anybody."

A Celebration of Life service will be conducted Sunday at 2 p.m. from the Acts the Apostolic Church in Temperanceville. A reception will follow at the New Church Volunteer Fire Department social hall.

Chincoteague: A Town Without a Planner

Director of Planning Ron Marney of Chincoteague was laid off last month and his job was eliminated in what was explained in a prepared statement Wednesday as a "reorganization."

The statement was made after three residents inquired about Marney's departure during a public participation session of the town council Monday. They were told an announcement would be forthcoming.

"The Town of Chincoteague recently selected to implement a reorganization within its general government division," ac-

ording to the statement released by Town Manager Jim West. "This organizational change shifts planning responsibilities to various members of staff and resulted in the loss of a position. The town is confident that citizens will not experience a loss in services or planning expertise with this reorganization. This reorganization was not related to any performance issues or disciplinary actions," the statement noted.

When asked who would be picking up the responsibilities, West answered in an email, "Generally, all of the town's staff." "In all honesty I was not privy to it,"

Chairman Ray Rosenberger of Chincoteague's Planning Commission said Wednesday when reached by telephone. "It was a shock. I don't understand it. I was totally unaware of what was going on until I got an email from Mr. West."

Rosenberger said he was notified March 20 that Marney "was placed in a layoff status. I'm disappointed," Rosenberger continued. "I think we need a planner. The town is growing. The town has issues that we're trying to address."

Rosenberger said he met with Build-

West Is Back As Chincoteague Manager

Chincoteague's new town manager isn't a stranger.

James (Jim) West began doing the job on March 6. But, he previously held the position from 2000 to 2004, and before that was Chincoteague's public works director for nine years.

West was recently employed by LJT & Associates of Columbia, Md. as a program manager. In that role, he provided instruc-

tional support service through a contract with NASA's Wallops Flight Facility.

The contract services provided were very similar in scope and diversity to that provided in support of a town or community, West said in a prepared statement.

He has more than three decades of management experience, is a graduate of the College of William & Mary and a resident of Chincoteague.

Exmore Accepts Grant for New Wells

The holes are in the ground, the preliminary paperwork is being finalized and the Town of Exmore is all set to develop two new wells and a new water treatment facility that will serve the 1,460 residents of the community.

The state recently awarded Exmore a \$500,000 Community Development Block Grant to help fund the infrastructure upgrade, which is targeted for completion by July 2018. The environmental services and engineering firm Draper Arden Associates will direct the project in partnership with town officials.

Included in the new system are two green sand filters that will remove iron and manganese from the water as the water is pumped. "We want to bring the highest quality service of every kind to the people of Exmore," said Mayor Douglas Greer. "Upgrading our water delivery is part of that mission. The existing wells were installed more than 50 years ago."

The total cost of the project is estimated at \$1.5 million. In addition to

the \$500,000 grant, Exmore received \$573,000 in principal forgiveness for the project, easing the financial requirements for the town.

Exmore is one of nine Virginia localities to benefit from more than \$4 million in Community Development Block Grant awards approved by the state. Greer accepted the funds on behalf of the town, noting more infrastructure improvements are in the pipeline for Exmore, including comprehensive plans for a new sewer system serving Exmore residents and businesses.

Accomack Supervisors Approve \$61M 2018 Budget

Accomack supervisors unanimously approved a \$61 million fiscal 2017-18 budget Wednesday without real estate or personal property tax rate increases.

They also voted 8-1 to meet at 8 a.m. Saturday at the new Riverside Shore Memorial Hospital to interview applicants for the county administrator's post. Su-

pervisor Donald Hart was opposed to that move. He did not publicly say why.

Acting County Administrator Mike Mason, who is also the finance director, prepared the budget resolution. It included the phrase, "the local tax supported expenditures of the Accomack County School Board's overall budget of \$52,242,493 shall not exceed

\$17,301,627 of local funds."

Tax rates for the entire county will remain at 49 cents per \$100 of assessed valuation of real estate and mobile homes and \$3.63 per \$100 of assessed valuation of personal property and machinery and tools. Additional tax rates for individual districts will also remain the same.

Northampton Considers Permit for CBBT Dredged Material

The Northampton County Planning Commission postponed a decision this week on a special use permit (SUP) that would allow dredged material from the excavation of the new bay bridge-tunnel to be placed in a borrow pit on property owned by Gary and Julie Wagner, just south of Eastville. Several commissioners said they needed more time to review the materials. They agreed to table the request and hold a special session on April 14, at 10 a.m. There will be a supervisors' session at 5 that evening and the panel will conduct its own public hearing on the request.

The Wagners operate a landscape company and requested the SUP to expand their operation. The Chesapeake Bay Bridge and Tunnel (CBBT) Commission anticipates removing approximately 700,000 cubic yards of spoils. According to Wagner, the sand would fill his borrow pit and result in a gradual mound on 18 acres of his property that would be approximately 30 feet in height. He noted that the plan calls for the mound to be built on a 1:3 ratio meaning that it would be more of a shallow sloped hill than a larger mound. Wagner's business partner, Dan Brown, noted the existing business and borrow pit has been in operation for approximately 20 years and is well buffered by pine, holly, and other trees and would likely be hidden from view from Rt. 13.

Residents James Moore and Trudy Ramer spoke against the request, citing concerns about noise, water quality, odors, property values, and the condition of the road serving the facility.

Long Range Planner Peter Stith read three letters from area citizens regarding the SUP. Eastville residents Lonnie and Ernestine Jones expressed concerns about ground water. Deloris Stanford and Chesapeake Bay Bridge Tunnel representatives Michael Crist and Jeffrey Holland supported the SUP.

Commissioner Dr. Mark Freeze questioned the need to reduce the existing vegetative buffer from 100 feet to 200 feet around portions of the pit. The entire property occupied by the company

covers 37 acres, much of which is to the rear of the borrow pit. Freeze also asked if the dredged materials would be tested for possible contaminants.

Bob Kerr of Environmental Services, of Virginia Beach, said the CBBT did extensive testing of core samples and no contaminants have been found. Materials would be hauled in sealed container trucks preventing any water from escaping from the materials while in transit. Wagner and others present said the permitting process for disposing of spoils at sea could add years to the project before any construction could begin. Kerr added that the Department of Environmental Quality (DEQ) would be monitoring the materials as they are removed in the construction process and if any contaminants were discovered, the spoils would not be allowed to be placed in the county.

Tom Bibb of the Virginia Department of Mines, Minerals and Energy (DMME) discussed the processes associated with mining in Virginia. He noted that placing fill into borrow pits is not unusual and that DMME considers a 100-foot buffer to be sufficient for such an operation. He also noted that the drilling machine would be excavating sand for the most part, thus there should be little or no smell from it.

Charles Hall, of M.S.A. Civil Engineering, addressed water quality, noting that most of the wells for the nearby homes were an average of 300 feet deep, with layers of clay between the multiple aquifers, affording little opportunity for runoff from the deposited sand to reach the wells.

The tunnel project is expected to begin later this year. Should the County choose not to support the SUP, the CBBT Commission will need to locate another option for spoils disposal.

In other business, Supervisor Granville Hogg addressed the commissioners as a private citizen. He said anyone applying for a SUP should be named in the application. In most cases, only one or two applicants are named, even if there is a group such as an LLC that is making the application. He asked for a time limit of 18 months to complete a project under an SUP, with possibility for extension.

11 YEAR OLD, SADDENED BY CANCER DEATHS, RAISES MONEY TO SAVE LIVES

Most 11-year-old boys are thinking about action movies, music, and video games, so imagine Asia Baines' surprise when her son, Kiptopeke 5th-grader Andre Baines, came home from school and asked what he could do to help cure cancer.

"All I could think of was to help raise money for research," she said.

On Saturday, from 8 a.m. until noon, Andre is holding a car wash at the Hardee's in Cape Charles, where his mother works, to raise money for the Riverside Shore Memorial Cancer Center.

This is not his first fundraiser. Andre also headed up a bake sale in November. "I know a lot of people are dying from cancer. It makes me feel sad," he said. Although he personally does not know anyone with cancer, "I wanted to do a bake sale, and now I want to do a car wash."

The bake sale was held in November, and the family raised \$200.

A couple of weeks later he was talking about a car wash, Asia Baines said, but they decided to wait for warmer weather.

Andre said he will have plenty of help from his family, including his father, Albert, 12-year-old sister Adasia, and 8-year-old brother Antonio, though he is not sure how much help his 8-month-old brother Aaron will be. Andre's goal is to raise more than \$500, and he acknowledges he will have to wash a lot of cars to get there.

"It will make me feel sweaty, but I'll be fine. It's worth it," Andre said.

ing Official Kenny Lewis on Tuesday and plans to ask the commission next week to designate Lewis as the panel's secretary, a position that he has held before. Rosenberger said the board elects officers every year and had just done so in March. "How the commission will express its concerns" would likely also be addressed.

The town has had three planners - Jared Anderson, Bill Neville and Marney.

"All three have played a big role in helping our community address important and complicated issues," resident David Johnson told the council Monday. "All three have been widely respected and praised in the community. There are big issues requiring attention by the council, planning commission and other town committees. Expert and sustained staff work is needed for good decisions to be made," he said.

"Make no mistake: even the beach issue is not behind us," Johnson continued. "There's more work to be done on that and many other challenges facing Chincoteague. We need to avoid emotional actions. Chincoteague has recently been through a divisive election for may-

or. One would hope that the emotions of that election would have been left behind by now. Chincoteague needs a town planner. And a capable one like Ron Marney. I hope you will reconsider."

Johnson suggested that Rosenberger "outline present and future issues that require this kind of detailed staff work. I hope he will be able to help you with this big decision ... talk to him. We couldn't have dealt with the water park without the town planner," Johnson said.

Another resident, Pat Farley, questioned why the issue was discussed during a closed session when it was a budgetary not a personnel issue. "Budget issues are not one of the 49 issues under the closed meeting law," she said.

Later in the meeting, it was noted that the closed session had to do with a reclassification of another position not the planning director's job.

Council turned down a conditional use permit for a boat repair facility on Willow Street after a petition opposing it was submitted and the planning commission recommending denial. The application was being sought by Brandon Beall and David Knight.

Neighbors were concerned about noise, traffic and a nearby eagle's nest.

There are "very few places that are still residential and we need to keep that," said Councilman Eddie Lewis. Vice Mayor Denise Bowden agreed. "I don't see this as the ideal place," she said.

"Keep looking," said Councilman Gene Taylor. "We just need it in a commercial zone. We'd love to have a nice boat repair facility."

The council also discussed the proposed dog park and it was disclosed that about \$7,000 in donations are available. Two sites, Donald Leonard Park and property on Hallie Whealton Smith Drive between the elementary and combined schools were suggested.

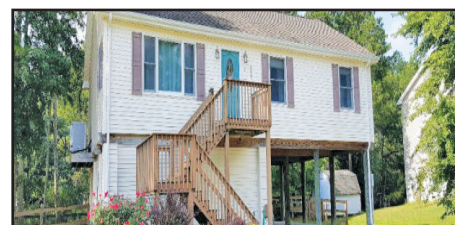

Exmore Council Approves Regs for Use of Town Park

Exmore's town council was presented its proposed \$1.9 million fiscal 2018 budget Monday night by Town Manager Robert Duer. The plan does not require a tax increase.

Council will be seeking grants and other funding to help pay for the new well and septic systems, officials said. The panel voted to support a grant application for up to \$1 million to help fund the \$5.9 million wastewater cost. The first of two public hearings on the budget will be held at 6:30 p.m.,

May 1, in the municipal building.

Members also reviewed proposed regulations for the town park. Duer said when groups want to use the pavilion, stage, or lighting system for large-scale activities, they would need to help defray the costs. He said, while the public is encouraged to use the playground at no cost, the other facilities require additional services such as waste collection or even security, all of which would pose a cost to the town.

The council approved the regula-

tions, which can be obtained, along with an application to use the facilities, at the town office. A ribbon cutting ceremony and dedication of the pavilion and stage will be offered in mid-May.

Officials also reviewed a request to make Commercial Avenue a one-way street. There is a potential traffic hazard when drivers enter the road from Main Street. Mayor Doug Greer Sr. said the request would be forwarded to the Virginia Department of Transportation (VDOT) for its consideration.

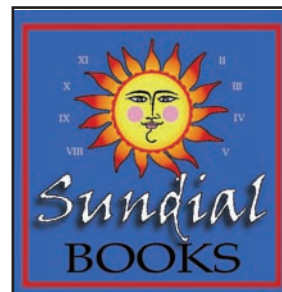

Embezzlement Indictment for Former PTA President

An outspoken former president of the Kegotank Elementary School PTA was indicted Monday by an Accomack Grand Jury on counts of embezzling from the school parent/teacher association (PTA) in 2015.

Jennifer Stapleton, 37, of Temperanceville Road in Atlantic, was indicted on two counts of embezzling more than \$200 from the PTA between Jan. 1 and Dec. 31, 2015. Investigator P. Coulter of the Accomack County Sheriff's Office (ACSO) testified about the case before the grand jury. The accusations came via direct indictments so records did not include any other information.

In another indictment, Jaquan (Buck) Cortez Portier, 25, of Dennis Drive in Parksley, was indicted on a count of assault and battery of Sgt. D. Williams of the ACSO on Dec. 15, 2016. Williams testified to the grand jury about the incident.

Portier, who police say is a local Bloods street gang member, was set to go to trial for 10 charges including shooting four people at a 2014 birthday party. But witnesses didn't come forward and the charges weren't prosecuted. Defense lawyer Carl Bundick previously told the Eastern Shore Post that Portier was at the party, but was long gone before the shooting occurred. At a preliminary hearing, it was stated the shooting started after unfavorable remarks were made about Tyvon (Teddy) Lyncurtis Smith, of Parksley, another reputed Bloods member. Portier and Smith were accused in November 2013 of shooting at a Rolling Acres home, but the charges were dropped after witnesses failed to show up in court or appeared to have amnesia as they repeatedly answered, "I do not remember."

But that case came back to get Smith. In November 2016, a jury convicted him of four felonies including directing other gang members to set fire to a house in order to keep witnesses from testifying against him for 2013 crimes. That panel recommended he

get 30 years. They gave 15 years for ordering the fire and five years each for three counts that involved participating in gang activity and soliciting and inducing others to lie under oath. Smith has not yet been sentenced.

In other indictments, Matthew Anthony Santos, 26, of Stockton Avenue in Greenbackville, was indicted on a count of rape on Dec. 11, 2016. The act allegedly occurred "through the use of the complaining witness's mental incapacity or physical helplessness," according to the court record. The victim's name is being withheld because of the nature of the charge. No other information was available. Investigator C.A. McPherson of ACSO investigated.

Samuel Henry Johnson Jr., 57, of Horsey Road in Oak Hall, was indicted on a count of rape by force, threat or intimidation on July 12, 2016. Coulter investigated.

Evron Terrell Strand, 42, of Mary Nottingham Smith Road in Accomack, was indicted on counts of possession with intent to distribute cocaine and possession of a firearm by a felon in connection with incidents that occurred on Dec. 9, 2016. Eastern Shore Drug Task Force (ESDTF) Agent J. Marsh investigated.

He Was A True and Caring Friend

The broad coastal community of the Eastern Shore of Virginia has lost a true and caring friend with the untimely death of **Mr. Arthur Schwarzschild** on March 15, 2017. The victim of a heart attack, Mr. Schwarzschild will be missed by his family, his many friends on Virginia's Eastern Shore, his colleagues at the University of Virginia (UVA), and many others. His life was characterized by his passion, integrity and compassion for his fellow humans. Whether teaching students, serving as a local elections official or advocating for the important local causes that he held dear, these traits were right up front.

After receiving his bachelor's degree from the University of Delaware in 1988, he matriculated to the Virginia Institute of Marine Sciences and received his master's degree in 1993. Then after working with the Southeast Fisheries Science Center (a part of the National Marine Fisheries Service), in Beaufort, N.C., he entered the doctoral program in UVA, graduating in 2004. He subsequently moved to the Eastern Shore of Virginia to become the founding director of the UVA Anheuser-Busch Coastal Research Center, site director and education/outreach coordinator of the Virginia Coast Reserve Long-Term Ecological Research (LTER) Program in Oyster, where he oversaw the facility and developed a strong education program that combined the expression of coastal science through studio art and the written word.

During this time he also served as a member of the local Climate Action Working Group and as a lifetime member of Citizens for a Better Eastern Shore. In his role as the VCR LTER Education/Outreach Coordinator, he also reached out to local schools of Northampton County to provide students with additional insight into the magnificent beauty of the coastal environment. Never one to turn down a request for help, he has touched the lives of literally thousands of teachers, high school students and undergraduate and graduate students at UVA and other universities. It is through these students that his legacy remains.

Mr. Schwarzschild is survived by his mother and father, Carol and Bill Schwarzschild, his two brothers, Edward and Jeffery Schwarzschild, his longtime girl-friend, Emily Boone, and the many lives he touched throughout his life. As his father wrote after his untimely death, "You can close your eyes and pray that Arthur will come back, or you can open your eyes and see all he left behind. Your heart can be empty because you can't see him, or you can be full of the love you have shared with him."

His cremated remains were returned to the waters of the Eastern Shore he so loved. A memorial service and reception to celebrate his life will be held at the Anheuser Busch Coastal Research Center in Oyster, on Virginia's Eastern Shore, on April 22, 2017, at 5 p.m. Friends and family are invited to share their stories and remembrances at the service.

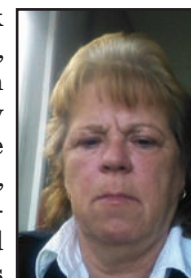

Stripe Rust Found in Northampton; Could Affect 2017 Wheat Harvest

By *Connie Morrison*

According to the Virginia Cooperative Extension Service, stripe rust has been identified on wheat from a field in Northampton County.

The disease was identified in North Carolina earlier in the season and was expected to show up in Virginia. However, showing up this early “constitutes a serious threat to our wheat crop,” according to the notice that was issued April 2.

“The infection is severe and rainy conditions will favor the pathogen’s development.”

The disease was found growing on a variety called Shirley, which, based on observations from previous years, is known to be especially susceptible to stripe rust.

The Cooperative Extension Service says several fungicides are effective on stripe rust, but only if applied before the disease develops,

so farmers are urged to scout fields and apply if stripe rust is observed.

On APRIL 29, 2017 from 10 a.m. to 2 p.m. the Northampton Sheriff’s Office and the Drug Enforcement Administration (DEA) will give the public its 13th opportunity in seven years to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. Bring your pills for disposal to Northampton Sheriff’s Office at 5211 The Hornes, Eastville, Virginia. (The DEA cannot accept liquids or needles or sharps, only pills or patches.) The service is free and anonymous, no questions asked.

Last September, Americans turned in 350 tons (over 702,000 pounds) of prescription drugs at more than 5,000 sites operated by the DEA and more than 3,800 of its state and local law enforcement partners. When those results are combined with what was collected in its 10 previous Take Back events, DEA and its partners have taken in over 5.5 million pounds—more than 2,750 tons—of pills.

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—both pose potential safety and health hazards.

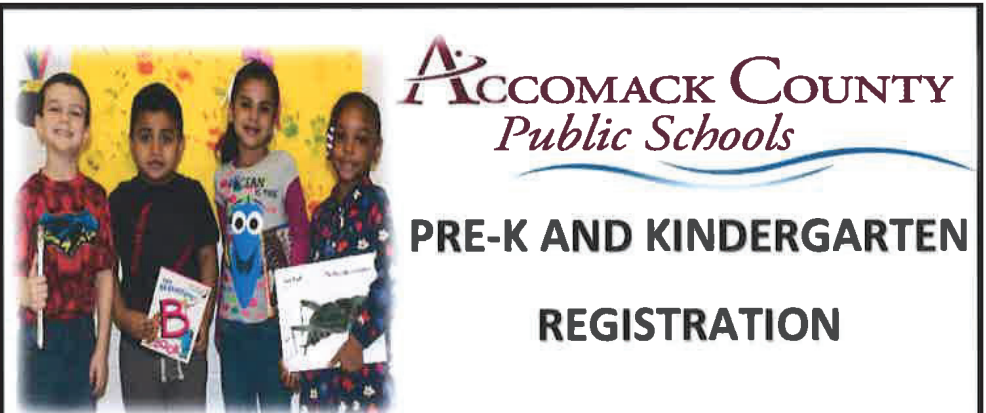

Two Reporters Put Onancock on The Map at The Washington Post

Emily Heil and Steven Ginsberg like to say Onancock, per capita, is the most represented town in the country on the Washington Post staff. Heil, a 1995 graduate of Nandua, and Ginsberg, a 1990 graduate of Broadwater Academy, once had desks within sight of each other at the Post, one of the leading newspapers in the world. Today, Heil is the co-author of "The Reliable Source," the Post's about-town gossip and celebrity column, writing about politicians, Washingtonian VIPs and other personalities. Ginsberg is the senior politics editor for the Washington Post, overseeing 50 staffers including eight editors and about 40 reporters. He twice interviewed then-candidate Donald Trump in the recent campaign.

This two-part series details the remarkable careers of two journalists who got their start and journalistic bearings on the Eastern Shore.

Emily Heil was a first-year student at the University of Virginia when she joined the student-run newspaper, the Cavalier Daily. A 1995 graduate of Nandua High School, she got her first job when she was 16 writing features for a local paper at \$5 an hour.

"I knew right away this was the life for me. Being a reporter satisfied my natural curiosity by asking people questions," said Heil, who joined the Washington Post five years ago and now co-writes a column each weekday.

She had a burning question that first day at the college newspaper: "I noticed that the graphic they used for around-the-state news included a picture of the state of Virginia — but they left out the Shore! I asked who I should go see about getting this fixed, and someone told me to go see this guy named Eric Hoover. I went to his office, met him, and told him why it was a problem — and I was pretty snippy about it. He thought I was pretty obnoxious. Who knew that 10 years later, we'd be getting married in the Onancock Town Hall?"

Heil, 39, laughs when she tells the story. "It worked out pretty well. I think it helps being married to a journalist. He understands when I tell him I have to take this call when we are having dinner."

Hoover is now a senior writer for The Chronicle of Higher Education, a source of news, information and jobs for college and university faculty members

and administrators.

Heil has a coveted position as the co-author of "Reliable Source," the Washington Post about-town gossip and celebrity column. "I write about celebrities, politicians, Washington VIPs and other personalities."

She concedes the new administration in town makes for some interesting subjects. "A Clinton administration would have brought the same cast of characters and would be pretty predictable. With Trump, it is not so predictable and from a media point of view, it is more interesting to write about. I am intrigued right now about Melania Trump and how she takes to her new life. She is intensely private, and not too many people in politics are private."

Heil's co-author for "Reliable Source" is Helena Andrews. "I jokingly call her my work wife," says Heil. "We talk all the time and are great friends. I am going to miss her this summer when she goes on maternity leave."

What appears in print is usually produced by both writers and does not carry their byline. Online columns will have the byline of the primary writer. Recent columns with Heil's byline centered around tweets by President Trump that included fake Abraham Lincoln quotes and Trump's fascination with Arnold Schwarzenegger.

Heil's years in journalism have seen the proliferation of digital media and social media. She says that has never been more true than with the Trump administration. "It's amazing. You get a bunch of reporters together, and we are always checking Twitter to see the latest tweets."

After earning a degree in English from UVA, Heil worked briefly at a local paper before moving to Washington, where she worked for a trade publication covering the telecom industry before being hired to cover the same beat for the Bureau of National Affairs (BNA). Heil covered FCC meetings and Capitol Hill bill markups.

Heil then became the congressional

correspondent for the BNA. "I had so much fun, chasing members of Congress around and writing some of the biggest issues, like the Medicare prescription-bill in 2003."

Heil also was freelancing for the Washington Post, where she dreamed of a job, and other publications. In 2005, the Hill newspaper hired her to write a column called "Under the Dome," a Capitol Hill gossip column. She also wrote about food, books and other features.

She wasn't there very long when the editor of Roll Call newspaper, the oldest of the Hill newspapers, hired her to write "Heard on the Hill," its congressional gossip column. "That column had been a must-read on Capitol Hill for decades, so it was a really beloved institution," says Heil.

And once she got her first job in journalism, she never had to apply for another. In 2011, the Washington Post came calling in the form of Al Kamen, a legendary columnist for the paper.

"He called and asked me to have coffee," recalls Heil. "It turned out he was hiring someone to help him on his column — called 'In the Loop,' and friends of his who knew me had suggested I'd be a good fit."

In an article in the magazine Washingtonian, Kamen said of Heil when asked why she was asked to copilot the Loop: "Clips, experience, right attitude. She's a reporter. And she has a great sense of humor."

Heil says she and Kamen hit it off instantly. "We have the same enthusiasm for the beat. He can be biting, but never mean."

Kamen retired in 2015, but two years earlier, the Post tapped Heil to write "Reliable Source." "It's been quite a journey," says Heil. "Lots and lots of hard work and late nights, but I wouldn't have it any other way. It's intense, and you have to be accurate, but it really is a lot of fun."

Although Heil doesn't travel much be-

cause her beat is Washington, D.C., she sometimes travels as part of the election coverage. She and her husband will sometimes scoot out of the city to a cabin they own in West Virginia, where there is no cell phone nor internet reception.

But her favorite getaway is visiting her mother, Mary Heil, outside of Onancock. "I just love sitting in the Adirondack chair and watch the creek go by. I also get my fix of Corner Bakery doughnuts and Tammy and Johnny's fried chicken."

She also enjoys seeing her sister, Martha, who lives in Greenbelt, Md., about 20 minutes away and works for the University of Maryland in public relations. "She has two of my nieces who I simply adore," says Heil.

Heil recalls that when she was growing up, her father, Nick, a local attorney who died in 2014, and her mother watched the national news every night and always had newspapers around the house. "I have fond memories of driving with my father on Sunday mornings to go to pick up the Washington Post at a local convenience store," she says. "Sometimes he would choose an issue and argue one side, forcing me to take the other side. It served to sharpen my skills and stay on top of current events."

Nick Heil brought his family from New Jersey, where he was chairman of the state parole board. During his nearly four decades on the Shore, he had many jobs: chicken farmer, truck driver, clam-plant manager and country lawyer who was a champion for those in need. Fluent in Spanish, he was given the honorific "Don Nick" in the migrant community. A man of many talents, Heil danced the role of Dosseimeier with Emily in an ESO production of "The Nutcracker."

For all she has done to open up doors in journalism, Heil says her best PR agent is still her Mom. "She follows everything I write and is my biggest fan. It's nice to know there is at least one person out there who is reading your every word. When she really likes something, she will call and say, 'That is so you; I can hear you saying that right now.'"

Next week the second of this two-part series will feature Steven Ginsberg, an Onancock native and senior politics editor for the Washington Post who has twice been part of a team that was awarded the Pulitzer Prize.

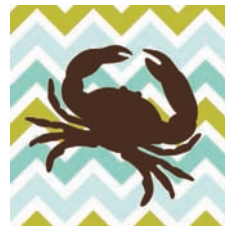

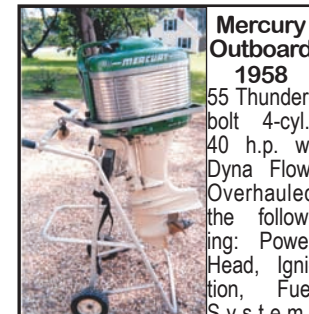



Glossophobia is Nothing to Gloss Over

Glossophobia or speech anxiety, is the fear of public speaking or the fear of speaking in general. The word glossophobia comes from the Greek *glóssa*, meaning tongue, and *phobos*, meaning fear or dread. By definition, phobias are irrational fears; meaning that they interfere with one's everyday life or daily routine. If fears inhibit pleasure, pre-occupy thinking, prohibit work, sleep or freedom, then the fear becomes irrational, and is thereby, a phobia.

Why, Yes! The website Statisticbrain.com, lists "fear of speaking in public" as number one among phobias diagnosed in 6.3 million Americans who are diagnosed with one or more phobias — 74 percent of people have it. The fear of death, necrophobia, follows closely behind at 68 percent, with arachnophobia, the fear of spiders, coming in third at 31 percent.

Feeling a tinge or more of anxiety when it comes to speaking in public is more likely what most of us experience when tasked with "communicating with an audience of ten or more." A public speaker should focus on informing, persuading or entertaining their audience in some way. If ever anxious about speaking "one too many," consider the following.

Don't calm down; pump up: If a topic is worthy of sharing with the public, be excited about the opportunity. Harvard researcher, Alison Woods Brooks, found that instead of saying "I am calm," people gave more compelling speeches when they said, "I am excited." Try converting anxiety into another strong emotion like excitement, rather than working toward calm. Get those butterflies in your belly to fly in formation.

Tailor the address to the audience: Imagine a dietitian tasked with ex-

plaining the New Food Pyramid to various audiences. Though the message would be the same, the language, venue, and visual aids should all be modified for an audience of senior citizens, sixth graders or women in their second trimester. Knowing the audience allows the speaker to find common ground and tailor the message to meet the occasion and the participants. Consider visiting the venue to determine whether it's a lunchroom or a lecture hall. Does the room have a hard or padded seating? Does the audience face the entrance? Is there a lectern, projector, microphone or stage. Knowing this information will get those butterflies moving in the same direction, because there are fewer unknowns. If unable to visit, speak with the person who asked you to speak and fire away with your questions. Chances are he or she will know the answers or know where to find them.

Practice makes effective: The goal

is not to be a perfect public speaker. There is no such thing. The goal is to be an effective public speaker. Like anything else in life, effectively addressing an audience takes practice. Don't focus on the "public" at the expense of the speaking. To become an effective public speaker, you must do just the opposite: focus on the "speaking" and let go of the public. Think of it as a conversation between you and the audience. If you can carry on a relaxed conversation with one or two people, you can give a great speech.

It takes courage (at least at first) to stand and deliver a message to an audience, but by facing your fear and wrangling the butterflies in your stomach to get in formation you become a more confident and courageous person in the process. And, that's nothing to gloss over.

Forestry Oversight Was Provided for Timber Harvests

Dear Editor:

This is written in response to "Logging Companies Inconsiderate," in the March 10 edition of the Eastern Shore Post, regarding several timber harvests that were recently conducted in the Keller/Melfa vicinity.

The writer claims that these harvests were "unchecked by officials responsible for protecting surrounding property owners," which is simply not true. We've conducted 16 inspections on the various harvest operations in this area since October 2016. We found that each harvest followed Virginia best management practice rules to protect water quality, by leaving 50'-wide strips of standing timber buffers (streamside management zones) along the edges of the branch bottoms bordering the harvests, as required by law. Also, the wooden haul mats were placed in the haul roads to prevent rutting and soil compaction, and skid trails were positioned to protect the integrity of the streamside management zones.

Simply stated, these harvests were conducted within the law. Also, it should be understood that timber harvesting has been conducted, in varying degrees, on the Shore for centuries. It is a rural practice just as necessary as harvesting crops and tilling fields. Timber harvesting is a necessary and vital tool used to manage the forest stands on the Shore.

Finally, our office monitors each harvest area after completion to determine reforestation needs and ensure that new forest stands are established

through planting or natural means. We also continue to monitor conditions in each new stand over the years for any growth or health issues that might require intermediate forest management practices such as thinning. Forestry, when combined with agriculture, is Virginia's largest industry, creating an economic impact of around \$70 billion annually.
