**DEFINITION** On this Cargo Receipt, "we", "our", and "us" refer to United Cargo Logistics, Inc. also known as Usa Cargo Express, Inc., its employees and agents. "You" and "your" refer to the sender, its employees and agents.

**AGREEMENT TO TERMS** By tendering your package to Usa Cargo Express, Inc. to deliver, you agree to all the provisions on the Cargo Receipt and our current terms and conditions, which is available on [www.envioscargoexpress.com](http://www.envioscargoexpress.com). If there is a conflict between our terms and conditions and any other bill of lading, the Usa Cargo Express, Inc. terms and conditions will control. No one is authorized to change the terms in this agreement without the written consent of Usa Cargo Express, Inc.

**C.O.D. SERVICE / C.O.D. AMOUNT** C.O.D. Service consists of our carriage of goods to your recipient, collection of check or cashier's check to you. You are responsible for adequately packaging the goods and filling out the Cargo Receipt on the appropriate space provided for C.O.D., including specifying the method and amount on the C.O.D. to be collected.  
 Unless you specify cashier's check or company check, we will accept a business or personal check as payment of the C.O.D. amount. All check and cashier's are collected at your risk, including risk of non-payment, forgery and counterfeits. You agree that form of money order, cashier's check, certified check or traveler's check will be accepted as payment for cashier's check. Cash collection request will not be honored.

**LIMITATION OF OUR LIABILITY AND LIABILITIES NOT ASSUMED** Our liability for loss, damage, non-delivery, failure to collect the C.O.D. amount, failure to collect an instrument specified, or collection of an instrument in the wrong amount in connection with you C.O.D. shipment is limited to your actual damage charges, the C.O.D. amount or the declared value. If you declare a high value and pay the additional charge, our liability will be the lesser of your declared value or the actual value of your package.

Usa Cargo Express, Inc. will not be liable upon Shipper's acceptance of C.O.D funds collected by Usa Cargo Express, Inc., regardless of method of payment. Shipper releases Usa Cargo Express, of any all liability related to the collection of C.O.D. funds.  
 In any event we will not be liable for any damages, whether direct, incidental, special or consequential in excess of the declared value of a shipment, whether or not Usa Cargo Express, Inc. had knowledge that such damages might be incurred including, but not limited to, loss of income or profits.  
 Usa Cargo Express, Inc. will not be liable:

1. For your acts of omissions, including but not limited to improper or insufficient packaging, securing, marking or addressing or for the act of omission of the recipient or anyone else with an interest in the package.
2. If you or the recipient violates any of the terms of our agreement.
3. For loss, damage or delay caused by events we cannot control, including but not limited to acts of God, perils of the air, weather conditions, acts of public enemies, war, strikes, civil, commotion, or acts of omission of public authorities (including customs or quarantine officials) with actual or apparent authority.

Usa Cargo Express, Inc. will not be responsible for loss of profit due to delay. Usa Cargo Express, Inc. will not be liable for delay in any seasonal goods or time sensitive merchandises.

**MAXIMUM LIABILITY** for any shipment is not to exceed 50 cents per pound or \$50 per shipment, whichever is greater. If a declared value is made, the shipper will be charged a greater freight charge for such declared value.  
 Additional coverage may be purchased at 50 cents per every \$100 declared value. Payment for the higher freight charge relating to the declared value must be made by the party responsible for paying the freight charge.

All charges must be paid in order to process your claim, including but not limited to freight charges, declared value charges and storage charges if any exist.

**HIGH DECLARED VALUE SHIPMENT** Additional charge will apply when declared value is higher than \$65 per pound. Higher than \$65 per pound cargo is considered a high value shipment. High value shipment is charged \$1.50 cents per every \$100 declared value.

**FILING A CLAIM** All claims must be filed within 9 months of delivery date in writing to Usa Cargo Express, Inc. When claim is not filed in accordance with foregoing provision, Usa Cargo Express, Inc. shall not be held liable and such claim will be denied. You must send us all relevant information about the claim. Usa Cargo Express, Inc. is not obligated to act on any claim until all transportation charges have been paid in full. You may not deduct or withhold any transportation charge to offset claims filed with Usa Cargo Express, Inc.

**PICKUP AND RETURN CHARGE** If a shipment is pickup at your request and is return to you at your request at no fault of Usa Cargo Express, Inc. prior to placement in the trailer for long haul, your shipment is subject to local pickup and delivery charge. There will be 5 cents per pound charge for pickup and 5 cents per pound for delivery with minimum of \$35.

**ATTMPT CHARGE** If a shipment is refused by consignee at no fault of Usa Cargo Express, Inc. \$35 attempt charge will be added to the second attempt of same shipment. Every attempt will increase the charge by \$35.

**LIFT-GATE CHARGE** if a pickup or delivery of shipment requires the need of a lift-gate, such service will incur additional charge of \$50 per occasion.

**STORAGE CHARGE & LIABILITY** If a shipment is deemed not deliverable or consigned as hold for pickup, storage charge will commence 15 days after the date of shipment. Storage is 15 cents per pound or minimum of \$15 per shipment per day whichever is greater. Usa Cargo Express, Inc. liability will default to that of a warehouseman's liability in the event of non-delivery or non-acceptance of delivery either by shipper or consignee through no fault of the carrier after offer of delivery or notification thereof has been attempted. Liability as a warehouseman begins at the time the property becomes undeliverable and ends when disposition is accomplished. Warehouseman monetary liability is not to exceed 50 cents per pound up to \$50 per shipment.

**RELEASE OF LIABILITY** Signature by the consignee on Usa Cargo Express, Inc. Bill of lading acknowledges the delivery of your shipment is in good order, therefore waiving all subsequent claims for loss or damage.

**OUR RIGHTS** We may, at our discretion open and inspect your packages and also **RESERVE RIGHT TO REFUSE SERVICE.**
