Dry Pasture Turned Into a Rice A Plantation.

In the eastern section of this city, lying between King street and the Waikiki road, just beyond the residence of Hon. John A. Cummins, there is a tract of 140 acres, formerly known as the Pawaa Dairy pasture, which has been leased by Judge McCully to a Chinese company, Messrs. Nin Foy & Co., who are establishing on it a rice plantation. Already, considerable progress has been made in reclaming the water, which is supplied from Judge McCully's new artesian well, called "Lady Agnes," a description on this island, and it is thought will supply sufficient water to irrigate

Australian Mail Service.

There is evidently a very strong attempt being made by the Canadian Pacific Railway Company to establish through steam communication between England and the Australian Colonies via Vancouver, B. C. One of the most recent Australian journals to hand states : "A strong syndicate has been established in connection with the Canadian Pacific line, and it is intended to form a powerful company to open the new route to Australia via the Canadian Pacific Railway. The passage across the Atlantic will only average six days, and the through trip from England to Australia thirty-five days. The Government of the Dominion have already agreed to subsidise the line, and it is hoped that the Australian Governments will do likewise."

From another part of the same journal we also quote the following: "The Postmaster-General of New South Wales intends to renew for twelve months the

contract for the Pacific mail service. which expires shortly. The Canadian Pacific scheme is not yet sufficiently matured to justify the abandonment of the present service to San Francisco, but the Government will probably stipulate that the Oceanic Steamship Company shall dispense with any Asiatic labour still employed on their steamers.'





Again, if ever, as Mr. Spreckels says, this country comes to grow its own sugar. Cuba will be ruined; and all the armies of Spain will not suffice to prevent its inhabitants from begging for annexation. It is thirty odd years since James Buchanan and Pierre Soule issued the Ostend manifesto, in which they advised the United States to give Spain a hundred millions for Cuba, in order to add more slave States to the Union; and now here comes a quiet business like German gentleman, who sets up beet sugar factories and so works things that Spain may presently be offering the island to us for a small consideration. The effect of a cessation of sugar imports into the United States would be felt over the whole commercial world. We pay now to foreigners-without counting the Hawaiian sugar - some \$75,000,000 every year for sugar and molasses. This payment, which passes through the world's clearing-house-London

Harrison is not Opposed to the Infliction of the Extreme Penalty.

Washington, May 4th .- Attorney-General Miller was questioned today in regard to the President's views on the subject of capital punishment, his recent acts of clemency to men under sentence of death in Washington having given rise to the impression that he was opposed to it. Mr. Miller said:

-The President is not opposed to capital punishment, and in the murder cases referred to did nothing more nor less than he should have done. He has none of that maudlin sympathy which will interfere with the just course of law, but he will see that a murderer's guilt is fully established before the extreme penalty is put into operation."

It has become evident at last that the De Desseps canal project is at a standstill and that the power to revive it has passed away forever from its founder and from France. That its affairs at the Isthmus are in a deplorable condition may be assumed, and whether they will ever be straightened out and the great ditch completed cannot be foretold.



I find that the commissions charged by the executors are upon the sum of \$22,889–20, being a half of the firm's ag-gregate receipts. But I have found an overcharge of \$20 in the charge for commissions, for the reason that 71/2 per cent., instead of 7 per cent. was charged on \$4,000.

For the purpose of comparison I find that in June, 1884, Greig's debit to the firm was \$5,702-13. On March 31, 1889, his debit stands at \$2,649 32.

In June, 1884, the date of decedent's death, his debit to the firm was \$4,074-33. On March 31, 1889, the debit stands at \$5,430.33. While in the case of Greig there has been a reduction of his debit there has been an increase of the debit against the estate. The reason of this


