

Dear Friends and Supporters of MHA,

The theme of this year's Annual Report is 'together' – how 'together' we are building a strong foundation of emotional wellness. There couldn't be a more fitting word to describe the events of this last year.

With a successful live appeal at the 2013 Catoctin Affair, personal and corporate gifts to match an Ausherman Family Foundation Challenge Grant, an extremely generous gift from the George Shields Foundation, and two additional State Bond Bills, *together* we completed our \$3.4 million campaign, allowing us to start construction on our Community Services Wing, slated for completion in winter 2014.

On the heels of the terrible Newtown, CT tragedy, we were determined to offer our Mental Health First Aid classes to as many people as possible. Local businesses and individuals agreed to sponsor public classes and, **together** we were able to educate many more people than we otherwise could have on how to recognize and assist someone who is experiencing an emotional crisis.

The board and senior staff engaged in an intensive and extremely helpful strategic planning process, one of the results of which was the need for us to identify additional opportunities to reach out to and collaborate with our community partners, so that **together** we can help to strengthen our community. Our efforts along these lines have lead to new and continuing relationships with organizations such as the Frederick Rescue Mission, Frederick Community College, Frederick County Work Force Services, Hood College, Heartly House and others.

Internally, we completed a two-year process of reorganization. While this new organization structure will not change the quantity or quality of services we provide, it will allow us to continue to grow and expand as the need for more services in our community increases.

With our Capital Campaign completed, our building renovation near to completion, and the economy recovering, we are looking to the future with great optimism that *together* we can build a community where children can grow and thrive without fear, where good mental health is valued, where people of all ages know when and how to seek help for emotional or family problems without shame, and where everyone will have access to mental health services without barriers.
