Policy Statement:

The school in a Youth Development Center (YDC) is operated by the Department and is designated as a school within a special school district. This school shall fulfill the requirements for school approval in accordance with rules and regulations promulgated by the Tennessee State Board of Education for the Tennessee Department of Education (DOE) and public schools.

Purpose:

To ensure that a YDC school operates in accordance with the Tennessee State Board of Education's rules and regulations in order to maintain school approval through the DOE. In doing so, students attending this school may receive academic credits transferable to community schools and, as applicable, may receive state issued high school diplomas.

Procedures:

A. Rules, regulations and minimum standards for the governance of Tennessee schools	 Each DCS school principal must maintain a current copy of the Tennessee Board of Education Rules, Regulations, and Minimum Standards for the Governance of Tennessee Schools. 1. The principal must use the Rules, Regulations, and Minimum Standards for the Governance of Tennessee Schools as a guide for school operation. 2. The Rules, Regulations, and Minimum Standards for the Governance of Tennessee Schools must be used as a reference for planning and implementing educational programs.
B. Reports required for approval	 Reports for the DCS Director of Education All requests and reports required by the Rules, Regulations and Minimum Standards for the Governance of Tennessee Schools for the approval process must be sent to the DCS Director of Education. Reports for the Department of Education The DCS Director of Education must submit the required reports to the Department of Education.
