SEA FISHERIES ACT, 1973 (ACT 58 OF 1973)

**AMENDMENT OF REGULATIONS**

By virtue of the powers vested in me by section 13 of the Sea Fisheries Act, 1973 (Act 58 of 1973), I, John Walter Edington Wiley, in my capacity as Minister of Environment Affairs and Tourism, hereby amend the regulations promulgated in terms of the said Act, as set out in the Schedule hereto.

**SCHEDULE**

**WYSIGING VAN REGULASIES**

Kragtens die bevoegdheid my verleen by artikel 13 van die Wet op Seevisserye, 1973 (Wet 58 van 1973), wysig ek, John Walter Edington Wiley, in my hoedanigheid van Minister van Omgewingsake en Toerisme, hierby die regulasies uitgevaardig kragtens die genoemde Wet, soos in die Bylae hiervan uiteengesit.

**BYLAE**

“commercial line fishing boat” means a boat which is registered and licensed as a fishing boat in terms of the Act and, subject to the provisions of regulation 23B, can be used for the catching of fish by means of a handline or a longline, of which the holder of a licence on a full-time basis, practises the occupation of a *bona fide* line fisherman and is dependent on the catching of such fish for his income; and

“semi-commercial line fishing boat” means a boat which is registered and licensed as a fishing boat but does not qualify for classification as a commercial line fishing boat.

1. Regulation 19 is amended by the substitution of the following paragraph for paragraph (g) in subregulation (1):

“(g) red steenbras (*Petrus rupestris*) and seventy-four (*Polysteganus undulosus*)—1 September to 30 November in any year.”

2. By the insertion of the following regulation after regulation 23B:

“23C. No person shall in any manner for any purpose whatever, catch, attempt to catch or disturb any fish or marine organism in the lagoon at Walvis Bay in the area bounded by the highwater mark and situated southwards from the border of the harbour area as described in the First Schedule of the South African Transport Services Act, 1981 (Act 65 of 1981).”

3. Regulation 24 is amended by the substitution of the following subregulation for subregulation (4):

“(4) use any trawlnet for fishing within the area landwards from a line (084°–264° true) drawn from the middle of the lighthouse at Cape Infanta to the wooden beacon marked K2, situated at Cape Barracouta.”

4. Regulation 39 is amended by the substitution of the words “similar line” in subregulation 4 (iii) for the words and figures “(line, 270° true)”.

5. By the substitution of regulation 45 for the following regulation:

“45 (1) No person shall by any means catch any of the following species of fish of a size smaller than the size prescribed for the species concerned, measured in accordance with the method prescribed in subregulation (2): Provided that any person who has caught any fish mentioned in this regulation which is smaller than the size prescribed, shall be deemed not to have caught such fish in contravention of this regulation if such person forthwith has returned it to the water with as little injury as possible:

- Cape Stumpnose (*Rhabdosargus holubi*): 20 cm;
- Dageraad (*Chrysoblephus cristiceps*): 25 cm;
- Dassie, blacktail or “kolstert” (*Diplodus sargus*): 20 cm;

- Garrick or “leervis” (*Lichia amia*): 70 cm;
- Geelbek (*Atractoscion equidens*): 40 cm;
- Grunter, spotted (*Pomadasys commersonni*): 40 cm;
- Hottentot (*Pachymetopon blochii*): 22 cm;
- Kob, cob or “kabeljou” (*Argyrosomus hololepidotus*): 40 cm;
- Musselcracker (*Sparodon durbanensis*): 40 cm;

“kommersiële lynvissersboot” ’n boot wat ingevolge die bepalings van die Wet as ’n vissersboot geregistreer en gelisensieer is en, behoudens die bepalings van regulasie 23B, gebruik kan word vir die vang van vis deur middel van ’n hand- of ’n langlyn, waarvan die lisensiehouer op ’n voltydse basis, die beroep van *bona fide* lynvisser beoefen en vir sy inkomste afhanklik is van die vang van sodanige vis; en

“semi-kommersiële lynvissersboot” ’n boot wat ingevolge die bepalings van die Wet as ’n vissersboot geregistreer en gelisensieer is maar nie vir klassifikasie as ’n kommersiële lynvissersboot kwalifiseer nie.

1. Regulasie 19 word gewysig deur paragraaf (g) in subregulasie (1) met die volgende paragraaf te vervang:

“(g) rooisteenbras (*Petrus rupestris*) en vier-en-sewentig (*Polysteganus undulosus*)—1 September tot 30 November van elke jaar.”

2. Deur die invoeging van die volgende regulasies na regulasie 23B:

“23C. Niemand mag op enige wyse vir watter doel ook al in die strandmeer te Walvisbaai in die gebied begrens deur die hoogwatermerk en geleë suidwaarts van die grens van die hawegebied soos omskryf in die Eerste Bylae van die Suid-Afrikaanse Vervoerdienstewet, 1981 (Wet 65 van 1981), enige vis of mariene organisme vang, probeer vang of steur nie.”

3. Regulasie 24 word gewysig deur subregulasie (4) met die volgende subregulasie te vervang:

“(4) binne die gebied landwaarts vanaf ’n lyn (geografiese ligging 084°–264°) getrek vanaf die middel van die vuurtoring te Kaap Infanta tot by die houtbaken gemerk K2, geleë te Kaap Barracouta, enige treilnet vir visvang gebruik nie.”

4. Regulasie 39 word gewysig deur die woord “soortgelyke lyn” in subregulasie (4) (iii) met die woorde en syfers “lyn, (geografiese ligging 270°)” te vervang.

5. Deur regulasie 45 met die volgende regulasie te vervang:

“45. (1) Niemand mag op enige wyse enige van die volgende vissoorte wat kleiner is as die grootte wat vir die betrokke soort voorgeskryf is, gemeet ooreenkomstig die metode voorgeskryf in subregulasie (2), vang nie: Met dien verstande, dat enigiemand wat enige vis genoem in hierdie regulasie, wat kleiner is as die voorgeskrewe grootte, gevang het, geag word sodanige vis nie in stryd met hierdie regulasie te gevang het nie indien so iemand dit sonder versuim met so min besering as moontlik in die water teruggeplaas het:

- Dageraad (*Chrysoblephus cristiceps*): 25 cm;
- Dassie, “blacktail” of kolstert (*Diplodus sargus*): 20 cm;
- Elf, “shad” of “chad” (*Pomatomus saltatrix*): 30 cm;

- Geelpens klipkabeljou (*Epinephelus guaza*): 30 cm;

 Red stumpnose (*Chrysoblephus gibbiceps*): 25 cm;  
 River bream (*Acanthopagrus berda*): 25 cm;  
 Scotsman (*Polysteganus praeorbitalis*): 25 cm;  
 Seventy-four (*Polysteganus undulosus*): 25 cm;  
 Silverfish (*Argyrozona argyrozona*): 25 cm;  
 Slinger (*Chrysoblephus puniceus*): 25 cm;

(2) For the purpose of subregulation (1)—

(a) all fish, except snoek, shall be landed in a whole state, and

(b) all fish shall be measured in a straight line along the side from the tip of the snout to the extreme end of the tail or caudal fin.

(3) The provisions of this regulation shall take effect from 1 January 1985."

6. By the substitution of regulation 48 for the following regulation:

"48 (1) No person on any fishing boat which has been prescribed as a semi-commercial line fishing boat (Class B) in terms of the provisions of paragraph 1 of Schedule M, shall on any day catch, attempt to catch or be in possession on any fishing boat or other vessel, the sea-shore or the place where such fish are caught, of more than five (5) fish in total of the following species:

(3) Die bepalinge van hierdie regulasie tree op 1 Januarie 1985 in werking."

6. Deur regulasie 48 met die volgende regulasie te vervang:

"48. (1) Niemand op enige vissersboot wat ingevolge die bepalinge van paragraaf 1 van Bylae M as 'n semi-kommerciële lynvissersboot (Klas B) voorgeskryf is, mag in totaal meer as vyf (5) van die volgende soorte vis op enige dag vang, probeer vang of op enige vissersboot of ander vaartuig, die strand of die plek waar sodanige vis gevang word, in besit daarvan wees nie:

(2) No person on any vessel which is not registered and licensed as a fishing boat in terms of the provisions of the Act or any rock, surf or speargun fisherman shall, during one day, catch, attempt to catch or be in possession on any fishing boat or other vessel, the sea-shore or the place where such fish are caught, of more than five (5) fish in total of the species mentioned in subregulation (1).

(3) No person on any vessel which is not registered or licensed as a fishing boat in terms of the provisions of the Act, or any rock, surf or speargun fisherman shall, subject to the provisions of subregulation (2), on any day catch, attempt to catch or be in possession on any fishing boat or other vessel, the sea-shore or the place where such fish are caught, of more than ten (10) fish in total: Provided that the provisions of this regulation shall not apply to the following species:

Tuna (*Scombridae* spp.)  
 Snoek (*Thyrstites atun*).  
 Marlin (*Istiophoridae* spp.)  
 Cape cob (*Argyrosomus hololepidotus*).  
 Yellowtail (*Seriola lalandi*).  
 Mackerel (*Scomber japonicus*).  
 Marsbanker (*Trachurus trachurus*).  
 Strepie (*Sarpa salpa*).  
 Steentjie (*Spondaliosoma emarginatum*).  
 Mullet/Springer (*Mugilidae* spp.).

(4) No person shall sell or offer for sale any fish caught in terms of subregulations (2) and (3).

(5) Notwithstanding the provisions of subregulations (2), (3) and (4), the Director may in writing grant exemption to members participating in national acknowledged competitions of the provisions of this regulation: Provided that an application for exemption shall be made in writing by the organising body of the competition concerned.

(6) No person, while engaged in spear fishing, shall use any artificial respiratory apparatus, except a snorkel.

(7) For the purposes of subregulation (6), 'spear fishing' means using any spear, harpoon, speargun or any weapon, apparatus or mechanism so constructed as to be capable of being used under water.

(8) The provisions of this regulation shall take effect from 1 January 1985: Provided that this regulation shall not be applicable in the harbour and settlement of Walvis Bay."

7. By the substitution of the following regulation for regulation 56:

"56. No person shall in the settlement Walvis Bay, remove any red bait from its habitat by means of any instrument."

8. By the substitution of subregulations (1), (2) and (3) of regulation 57 for the following subregulations:

"57. (1) Except as provided in subregulation (2), no person shall at any time or at any place, catch, possess or convey more of the following species of fish in any one day for own use than the number or mass stipulated below for each species:

Alikreukel, ten (10).  
 Armadillo, six (6).  
 Black mussel, twenty-five (25).  
 Bloodworm, five (5).  
 Clam, eight (8).  
 Crab, two (2).

Galjoen in the Republic but excluding the settlement Walvis Bay, five (5).

(2) Niemand op enige vaartuig wat nie as 'n vissersboot ingevolge die bepalings van die Wet as 'n vissersboot geregistreer en gelisensieer is nie of enige rots-, strand- of spiesgeweerhengelaar mag op een dag in totaal meer as vyf (5) visse van die soorte genoem in subregulasie (1), vang, probeer vang of op enige vissersboot of ander vaartuig, die strand of die plek waar sodanige vis gevang word, in besit daarvan wees nie.

(3) Niemand op enige vaartuig wat nie as 'n vissersboot ingevolge die bepalings van die Wet as 'n vissersboot geregistreer en gelisensieer is nie, of enige rots-, strand- of spiesgeweerhengelaar mag, behoudens die bepalings van subregulasie (2), op enige dag in totaal meer as tien (10) visse vang, probeer vang of op enige vissersboot of ander vaartuig, die strand of die plek waar sodanige vis gevang word, in besit daarvan wees nie: Met dien verstande dat hierdie subregulasie nie op die volgende vissoorte van toepassing is nie:

Tuna (*Scombridae* spp.).  
 Snoek (*Thyrstites atun*).  
 Marlyn (*Istiophoridae* spp.).  
 Kabeljou (*Argyrosomus hololepidotus*).  
 Geelstert (*Seriola lalandi*).  
 Makriel (*Scomber japonicus*).  
 Marsbanker (*Trachurus trachurus*).  
 Strepie (*Sarpa salpa*).  
 Steentjie (*Spondaliosoma emarginatum*).  
 Haarder/Springer (*Mugilidae* spp.).

(4) Niemand mag enige vis wat ingevolge subregulasies (2) en (3) gevang is, verkoop of te koop aanbied nie.

(5) Nieteenstaande die bepalings van subregulasies (2), (3) en (4), kan die Direkteur skriftelik aan lede wat aan nasionaal-erkende kompetisies deelneem, vrystelling van die bepalings van hierdie regulasie verleen: Met dien verstande, dat 'n aansoek om vrystelling skriftelik deur die organiserende liggaam van die betrokke kompetisie gedoen moet word.

(6) Niemand mag terwyl hy besig is met visjag, enige kunstmatige asemhalingsapparaat, uitgesonderd 'n snorkel, gebruik nie.

(7) Vir die doeleindes van subregulasie (6) beteken 'visjag' die gebruik van enige spies, harpoen, spiesgeweer of enige wapen, apparaat of meganisme so vervaardig dat dit onder water gebruik kan word.

(8) Die bepalings van hierdie regulasie tree op 1 Januarie 1985 in werking: Met dien verstande dat hierdie regulasie nie in die hawe en nedersetting Walvisbaai van toepassing sal wees nie."

7. Deur regulasie 56 met die volgende regulasie te vervang:

"56. Niemand mag enige rooi-aas in die nedersetting Walvisbaai deur middel van enige instrument van sy groei-plek verwyder nie."

8. Deur subregulasies (1), (2) en (3) van regulasie 57 met die volgende subregulasies te vervang:

"57. (1) Behalwe soos bepaal in subregulasie (2), mag niemand te eniger tyd of op enige plek, meer van die volgende soorte vis as die getal of massa hieronder genoem vir elke soort op een dag vir eie gebruik vang, besit of vervoer nie:

All notices and returns rendered in terms of regulation 163 shall be rendered or submitted to the offices of any fishing harbour or Sea Fisheries Inspector or to the Director: Sea Fisheries Research Institute, Private Bag X2, Rogge Bay, 8012, from whom the forms for the purpose of the returns may be obtained on application. If no catches were made, a nil-return must be submitted."
