



ne of the most vibrant cities in the United States, Atlanta, Georgia, welcomes you to the 2012 Global Peace Convention. ### THURSDAY, NOVEMBER 29

Americas Summit: Moral and Ethical Values to Renew Relations between the U.S. and Latin America

Carter Presidential Center

The Americas Summit, organized with Latin America partners, will convene statesmen from Central and South America with their counterparts in the US to discuss key issues of common concern, and the need for improved hemispheric relations. The opening sessions are in the pre-Convention schedule at the Carter Center, and continued as an agenda integrated within the Global Peace Convention. Sessions will discuss ways to promote dialogue and collaboration beyond partisan differences, among both government and civil society leaders, toward shared goals including respect for democracy, religious freedom, economic opportunity, transparency in government, sustainable development and environmental protection.



### International Volunteering: Policy and Capacity Building Points of Light Institute

The significance of volunteerism has not been fully understood or articulated in the development debate. Growing evidence indicates that volunteer engagement promotes civic values and social cohesion which can mitigate conflict, and that it can foster reconciliation in post-conflict situations. This session will explore what steps can be taken to encourage and sustain greater levels of volunteerism across the globe, and how governments, businesses and nonprofits can foster the development of a culture of volunteerism.

### Global Peace Business Forum Atlanta Marriott Marquis Hotel

This forum will focus on the role of the private sector in poverty reduction, sustainable development and regional stability as catalysts for peace and prosperity. These sessions will provide opportunities for business leaders to engage with government and civil society. The direct impact of international trade and investment in peace building will be highlighted.

### Site visit – Leadership Academy Pilot program Martin Luther King Jr. Middle School

The Leadership Academy: Inroads to Success provides mentoring for middle school youth, fosters healthy socialization, encourages educational achievement, and builds skills that can assist young adults in finding and keeping employment. # EDUCATING CHARACTER Enhancing Skills

"Education is the most powerful weapon which you can use to change the world," said South African President Nelson Mandela. Through education, youth discover and cultivate their unique gifts, learn to appreciate the experience of the past, and explore new ideas and innovations that have the potential to change history.


In response to outbreaks of ethnic violence following the disputed 2007 presidential elections in Kenya, the Global Peace Foundation has advanced educational models that emphasize character competency, life skills and good citizenship. With the support of Kenya's Ministry of Education, Ministry of Youth Affairs and Sports, the Catholic Church, and dozens of local partners, GPF educational initiatives have fostered national pride transcending tribal and ethnic identity, respect for diversity, and healthy interaction through sports and cultural events.

GPF Philippines, a state-accredited educational service provider, launched the Alternative Learning System Accreditation and Equivalency program in cooperation with the Department of Education in 2011. The program provides a quality and flexible alternative education for out of school children, youth and adults that is comparable and equivalent to the formal education instruction.

GPF's pilot program, "Leadership Academy: Inroads for Success," at the Martin Luther King, Jr. Middle School in Atlanta aims to empower students to develop their leadership creativity and integrity for success in school, home, workplace and community in a state with some of the highest school dropout rates in the country.

GPF education programs advance a vision for peace grounded in a recognition of the intrinsic value of every human being, and the rights and responsibilities of each person as a member of the human family.

### STRENGTHENING



THE IMPORTANCE OF STRONG FAMILIES as a foundation for peace and social cohesion has been understood for millennia. The family has been called "the nucleus of civilization." It is the primary socializing environment where children learn to mature from a self-centered to an other-centered outlook through parental affirmation and guidance. Crime and gang identification, drug abuse, sexually transmitted diseases and teen pregnancy all arise from stress on increasingly fragile family structures.

Since May 2010, hundreds of organizational partners have joined to establish the Strengthening Families and Communities Coalition (SFCC), now serving Atlanta, Denver, Philadelphia, New York, New Jersey, Washington, DC. Drawing upon schools and businesses, non-profit and faith-based organizations, and federal, state and city human service agencies, SFCC is advancing an integrated approach to revitalizing the family and mitigating negative social trends.

One tragic outcome of family breakdown is the growing incidence of human trafficking. Once thought to be largely confined to underdeveloped nations with lax human rights standards, sex trafficking in the United States has been called "a problem of epidemic proportion" by the FBI.

GPF-USA's Safe Haven Campaign is establishing a national network of faith communities to raise public awareness and provide an environment to enable victims to have the courage to come forward. Ethnic and immigrant faith communities are essential in this effort, because a common culture and language can encourage a victim of trafficking.

Strengthening Families and Communities Coalition have interfaith networks in place and are working to establish Safe Havens today.

# ADVANCING PEACE Through Commerce



THROUGHOUT HISTORY, SCIENTIFIC KNOWLEDGE ADVANCED and culture developed and expanded along trade routes. Trade and commerce has been a force that bridged cultures, nationalities and ethnicities. To expand trade, businesses were required to learn languages and understand and respect different cultures. Trade and investment transactions become bridges of understanding and a foundation for relationships that are conflict-averse.

The Global Peace Foundation is committed to engaging the business community in conversations on regional peace and stability, and seeks to inform all sectors of society about the critical role of private sector business as a catalyst for peace.

Through regional Global Peace Leadership Conferences in East Asia, Africa, Latin America and the United States, business leaders confer with government leaders, development experts, and nongovernmental organizations to build partnerships that leverage business interests with broader goals for peace, economic development and environmental sustainability.

A climate of peace is a precondition for investment, which in turn fosters greater opportunity and prosperity. These cutting-edge collaborative exchanges are supporting development initiatives that draw upon the

resources of the business community, the expertise of government and academia, and the commitment of volunteers and community organizations.



## BUILDING COALITIONS AMONG





Interfaith cooperation is an essential building block of peace in the twenty-first century. Faith traditions differ in approaches to the Divine but share a common mission to advance moral and ethical standards of conduct, cultivate virtue and uplift human character. This "civic mission" forms the common ground of all faiths and is expressed in the Golden Rule, found in virtually all major religions.

The Global Peace Foundation has engaged faith leaders around the world in efforts to bridge divisions and promote peace. In Mindanao, the Philippines, festivals and economic development initiatives have brought Christian, Muslim, and indigenous peoples together in a region where some 200,000 people have lost their lives in religious and ethnic conflict.

In Nepal, GPF played a major role bridging divisions among Buddhists, Hindus and rebel factions in that county's historic transition from a Hindu monarchy to a democratic republic. In the United States faith leaders are mobilizing to restore the nation's founding principles through GPF's Coalition for American Renewal.

The voice of faith leaders in the public square is not only permissible but essential in reminding both leaders and citizens of the importance of values and personal integrity in the welfare of the republic.

# a commitment to Korean Unification

Nowhere is the NEED FOR A RADICALLY NEW CON-CEPT of world peace more evident than on the Korean peninsula, where a people of a single ethnic, linguistic and cultural background remains divided by Cold War ideologies.

Recognizing the impasse in efforts to achieve a stable and secure peace on the Korean peninsula, the Global Peace Foundation has called for a concerted, collaborative grass-roots effort, in conjunction with state and global support, to advance the process of reunification of North and South Korea.

The 2012 Global Peace Leadership Conference in Seoul, "The Vision for the Unification of the Korean Peninsula and Building a World of Peace," drew scholars, parliamentarians, and leaders from business, nongovernmental organizations and the religious community from more than 25 countries.

The Global Peace Foundation has advanced many initiatives to bridge political and social divisions between the two Koreas, including partnerships with over 400


different civic organizations. GPF's Korea United, a nation-wide campaign for reunification, significantly avoids framing the division as a political or ideological confrontation, but instead proposes a new approach based on the spiritual principles and values expressed in Korea's own historic philosophy of living for the benefit of mankind.

A new framework for peace rooted in shared spiritual aspirations, principles and values can form the common ground for cohesion within society and the guiding vision for a united Korea that can be a model for transcending the forces of division and conflict worldwide.

# Speakers

### LATIN AMERICAN PRESIDENTS



H.E. JAIME PAZ ZAMORA served as the President of the Republic of Bolivia from 1989 to 1993 and previously served as Bolivia's Vice President. During his presidency, he was able to build a coalition of disparate political parties into what was called a "Patriotic Accord," which helped Bolivia through the fragile process of democratization. He is also one of the founders and current leader of the political party

Movimiento de la Izquierda Revolucionaria - Nueva Mayoría (MIR).



H.E. CARLOS MESA served as President of the Republic of Bolivia from 2003 to 2005. He is a Bolivian historian, journalist, writer and politician and is currently Chairman of the Fundación Comunidad [Foundation Community], an organization committed to help strengthen democratic institutions. He has published a number of books including De Cerca: una década de conversaciones en

democracia (1993), a transcription of a series of interviews with several prominent Latin American politicians on the democratization process of the region.



H.E. HIPÓLITO MEJÍA served as President of the Dominican Republic from 2000 to 2004. During his tenure as President, he instituted government programs aimed at reducing poverty, reviving various economic sectors as well as modernizing the country's infrastructure and public services. He also served as Minister of Agriculture. His private agricultural and business ventures have

contributed to the development and modernization of agricultural technologies. He is currently one of the leading figures of the Partido Revolucionario Dominicana PRD.



H.E. GUSTAVO NOBOA served as
President of the Republic of Ecuador from 2000 to 2003. He was Equador's Vice President and Governor of the province of Guayas. A law professor, H.E. Noboa Bejarano served as Chancellor of Catholic University of Quayaquil, where he was also the dean of faculty. He has also served as Vice President of the Esquel Foundation, an organization dedicated to

democracy and sustainable economic development.



H.E. ÁLVARO COLOM served as President of Guatemala from 2008 to 2012. He was the founding General Director of Fondo Nacional para la Paz (FONAPAZ) [National Found for Peace], an institution that develops and implements projects to eradicate poverty and extreme poverty in Guatemala. He was also previously a deputy Minister of Economy and a

deputy of PARLACEN (Central American Parliament), a regional forum that works for peace, democracy and the regional integration of Central America.



H.E. Vinicio Cerezo Arévalo

served as president of Guatemala from 1986 to 1991, he was the first democratic and civilian elected after more than 30 year of dictatorial governments. He established the democratic system and institutions. He also served as national and Central American deputy. He is the creator and one of the signatory of Peace and Democracy Agreements in Central America,

Esquipulas I and II. He is the co-creador of Central American Parlament and a convinced promoter of Central American Integration. He is currently the president of the Esquipulas Foundation for Central American Integration. He is also a member of The Carter Center's Council of Presidents and Prime Ministers of the Americas.



H.E. NICOLÁS ARDITO BARLETTA

served as President of Panama from 1984 to 1985. He has served as Vice President of the World Bank for Latin America and the Caribbean and Director of the Department of Economic Affairs of the Organization of American States (OAS). He was an initiator and founder of the Latin American Export Bank, a multilateral entity of Latin American

countries. He is also a member of The Carter Center's Council of Presidents and Prime Ministers of the Americas.

### PLENARY SPEAKERS



H.E. JUAN CARLOS WASMOSY served as President of Paraguay from 1993 to 1998. During his term, he played an active role in the creation and early development of Mercosur, a major South American trade bloc. A civil engineer and businessman, H.E. Wasmosy Monti also served as Minister for Integration and as the head of the Paraguayan consortium

that built the Itaipu Dam, one of the world's largest hydroelectric dams.




H.E. LUIS ALBERTO LACALLE served as President of the Republic of Uruguay from 1990 to 1995. During that time, he helped negotiate the creation of Mercosur, an economic and political trade bloc, with the presidents of Brazil, Argentina and Paraguay. He was also a Senator and Vice President of the Senate. He is currently a member of the Club de Madrid and

the Carter Center's Council of Presidents and Prime Ministers of the Americas.



H.E. MARTÍN TORRIJOS served as President of Panama from 2004 to 2009. Center for Peace Development. He received the 2010 International Jurists Award from the Vice President of India at the Indian Parliament.





children, families and communities. She has been recognized for her accomplishments with numerous awards including the Presidential Rank Award for Meritorious Service.




