SOURCE OF ADMISSION

Section 97222

(a) Effective with discharges on or after January 1, 2017, in order to describe the patient's source of admission, it is necessary to address two aspects of the source: first, the point of patient origin for this admission; and second, the route by which the patient was admitted. One alternative shall be selected from the list following each aspect:

(1) The point of patient origin. Use the appropriate code from the list below:

Per NUBC, these codes are meant to be taken literally.

Code Point Of Origin for patients with Type of Admission other than "Newborn"

1 Non-Health Care Facility Point of Origin

DISCUSSION

Includes:

- patients coming from home or workplace and patients receiving care at home (such as home health services)*
- patients admitted from an outpatient drug or alcohol treatment program, whether or not health care services are provided*
- patients from Residential Care Facilities **that are not health care facilities** (For healthcare facilities, see 5 and 6 below)*

- Group Homes and Foster Homes*
- homeless patients*

2 *Clinic or Physician's Office*

In order to be included in this category, the patient must have come directly from the office or clinic.

Includes:

- patients admitted from an Urgent Care clinic within a hospital (yours or another facility's)*
- a free standing medical clinic *
- other type of clinic or physician's office*

4 *Transfer from a Hospital (Different Facility)*

DISCUSSION

Includes patients admitted from another acute care facility's ED or other outpatient programs

Excludes transfers from hospital inpatient within the same facility (see code D).*

5 *Transfer from a Skilled Nursing Facility (SNF), Intermediate Care Facility (ICF), or Assisted Living Facility (ALF)*

DISCUSSION

Includes:

- patients admitted from a licensed SNF, ICF, ALF or other nursing facility where he or she was a resident and receiving healthcare*

This category does not include Residential Care that is not licensed as an ALF or does not provide health care. See codes 1 and 6

6 *Transfer from another Health Care Facility*

DISCUSSION

In order to be included in this category, the facility must provide health care.

Includes:

- Patients from another type of health care facility not defined elsewhere in this list*
- Residential Care setting that provides health care but is not licensed as an ALF*
- Patients from a drug or alcohol treatment (health care) facility that is not a hospital, SNF, ICF or ALF*

8 *Court/Law Enforcement*

DISCUSSION

Includes patients who:*

- are under arrest
- are incarcerated
- are ordered by a court judge to present to your facility
- are admitted upon the request of a law enforcement agency representative
- present from a correctional hospital or medical clinic

This category **does not** include patients that are simply transported by law enforcement.*

9 *Information Not Available*

DISCUSSION

The patient's point of origin is not known.*

D *Transfer from One Distinct Unit of the Hospital to another Distinct Unit of the Same Hospital Resulting in a Separate Claim to the Payer*

DISCUSSION

Please refer to OSHPD's definition of a discharge to determine if a discharge took place when transferring within your facility. Not all claims will qualify as a discharge per OSHPD's definition.

E *Transfer from Ambulatory Surgery Center*

This category **does not** include patients admitted from a hospital-based ambulatory surgery unit.*

For patients admitted from your facility's AS, the point of origin would be dependent on where the patient came from before presenting to your facility's AS.*

F Transfer from a Hospice Facility

This category only includes patients coming from facility-based hospice.

This category **does not** include hospice patients that are in your facility and occupying a bed on your hospital license. See definition of a discharge on page 7A.

G Transfer from Designated Disaster Alternate Care Site

DISCUSSION

NEW Effective July 1, 2020: The National Uniform Billing Committee released guidance that a new Point of Origin Code is being added: Point of Origin Code G -- Transfer from a Designated Disaster Alternate Care Site.

Use of the new code, "G" is encouraged when appropriate for discharges on and after July 1, 2020. OSHPD will work to formally adopt the use of this code via the rulemaking process.

For surge planning purposes in California, a government-authorized Alternate Care Site is defined as:

A location that is not currently providing healthcare services and will be converted to enable the provision of healthcare services to support, at a minimum, inpatient and/or outpatient care required after a declared catastrophic emergency. These specific sites are not part of the expansion of an existing healthcare facility (i.e., extensions of general acute care hospitals, clinics, or long term care facilities), but rather are designated under the authority of the local government.

A government-authorized Alternate Care Site DOES include mobile field hospitals, schools, shuttered hospitals, stadiums, arenas, churches, and other facilities not currently licensed to provide healthcare services that, under the authority of local government, are designated as an Alternate Care Site to help absorb the patient load after all other healthcare resources are exhausted. [Although not specifically listed here, for OSHPD reporting purposes, we consider the Mercy Ship to fall into this category.]

A government-authorized Alternate Care Site DOES NOT include sites that are established as part of an expansion of existing healthcare facilities, such as tents set up for patient care in the parking lot of a hospital or sites set up for patient triage by Emergency Medical Services, such as field treatment sites.

Code Point of Origin for patients with Type of Admission “Newborn”

GENERAL DISCUSSION

Any person should only have Type of Admission “Newborn” once in their lifetime and it pertains to initial care. A first hospital encounter is not necessarily for initial care.*

In cases of a baby transferring from one hospital to another, code 4 should be used.

5 *Born Inside this Hospital*

DISCUSSION

Use this code when an infant is born anywhere inside your hospital which could include your ED, elevators, lobbies, waiting rooms, etc. *

6 *Born Outside of this Hospital*

DISCUSSION

Use this code when an infant is born anywhere outside of a hospital and then brought directly to a hospital for initial care. This could include a baby born in a car, an ambulance, or at home. *

(A) Your Emergency Department. Any patient admitted as an inpatient after being treated or examined in this hospital's emergency department.

DISCUSSION

Patients who are transferred from another facility's ED to your ED before becoming an inpatient should be reported as (1).

(B) Another Emergency Department. Any patient directly admitted as an inpatient after being transferred from another hospital's emergency department.

DISCUSSION

Only patients directly admitted from another facility's ED should be reported as (2).

(C) Not admitted from an Emergency Department.

EXAMPLES OF SOURCE OF ADMISSION (SOA)

REHABILITATION HOSPITAL CARE

15. Sally was receiving inpatient physical rehabilitation care in your hospital. She is transferred to acute care at your hospital.

Q. What was the Source of Admission on Sally's acute care record at your hospital?

A. Sally's **Point of Origin** would be *One Distinct Unit to another Distinct Unit of the Same Hospital* and the **Route** would be *Not admitted from an ED*.

A. Jack's **Point of Origin** would be *One Distinct Unit to another Distinct Unit of the Same Hospital* and the **Route** would be *Not admitted from an ED*.

17. An acute inpatient psychiatric hospital transferred Ralph to your hospital where he was directly admitted to acute care.

Q. What was the Source of Admission on Ralph's acute care record at your hospital?

A. Ralph's **Point of Origin** would be *Hospital (Different Facility)* and the **Route** would be *Not Admitted from an ED*.
