It contained several EMS issues were passed by the legislature including:</li> <li>The clear obligation that hospitals and nursing homes to create a policy to make sure the EMS crew transferring at- risk patents (those that might be violent) is notified about the patient.</li> <li>Emg Dept docs can now place certain patients under a legal hold prior to the implementation of the classic 96 hour hold. This new temporary legal hold is for the express purpose of getting thepatient transferred to the psych facility.</li> <li>Also passed:</li> <li>EMS Regional Medical Directors will have 4 year terms and will also be a voting member of their EMS Regional Committee.</li> <li>Stroke Center reviews had caused some hospitals to build fences around helipads.
